(57) **CLAIM**

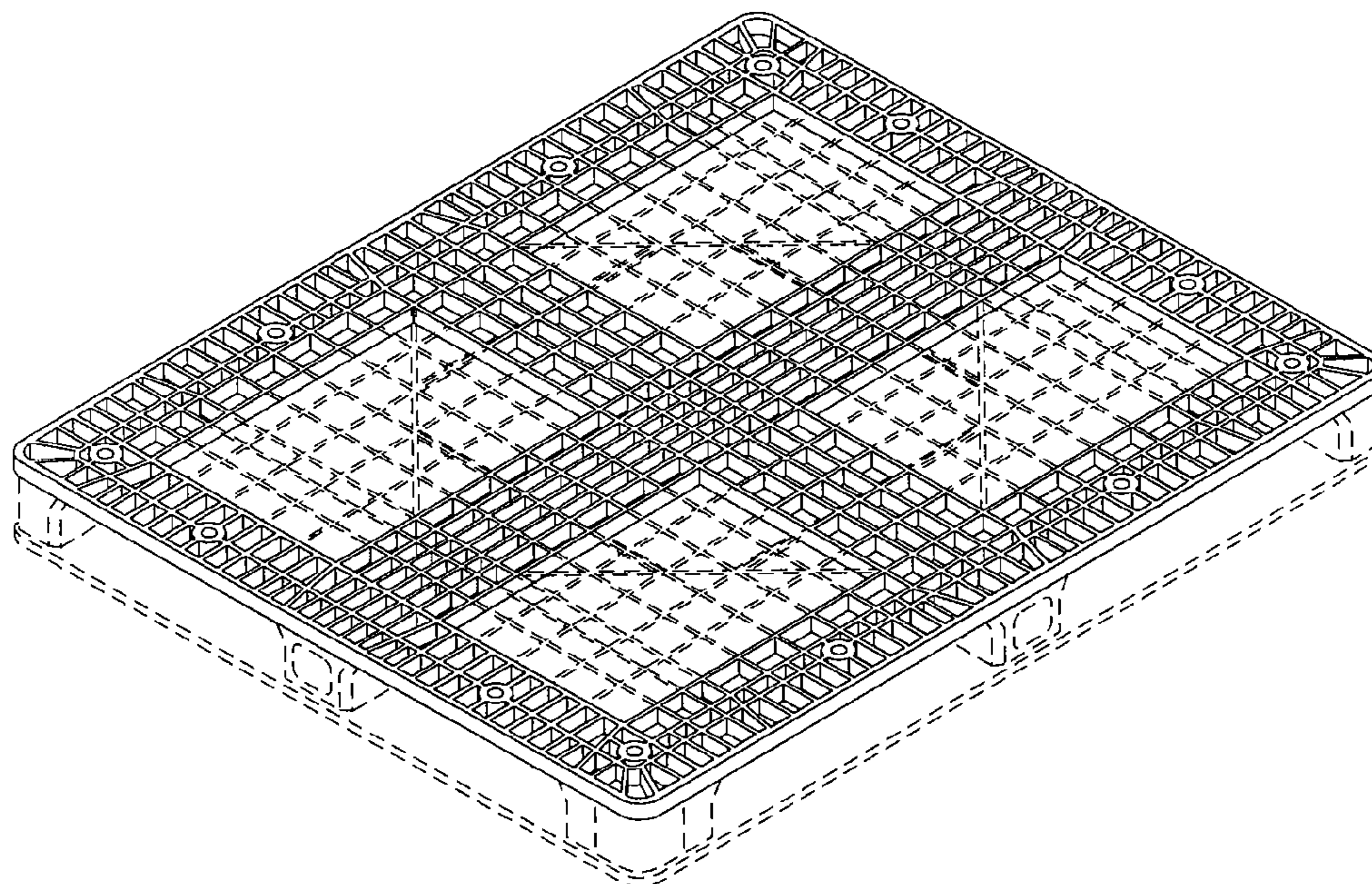
The ornamental design for a pallet, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of our pallet in accordance with our first new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a left-side view thereof, the right side-view thereof being identical to the left-side view;
 FIG. 4 is a front view thereof, the rear view thereof being identical to the front view;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a top perspective view of our pallet in accordance with our second new design;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a left-side view thereof, the right side-view thereof being identical to the left-side view;
 FIG. 9 is a front view thereof, the rear view thereof being identical to the front view; and,
 FIG. 10 is a bottom view thereof.

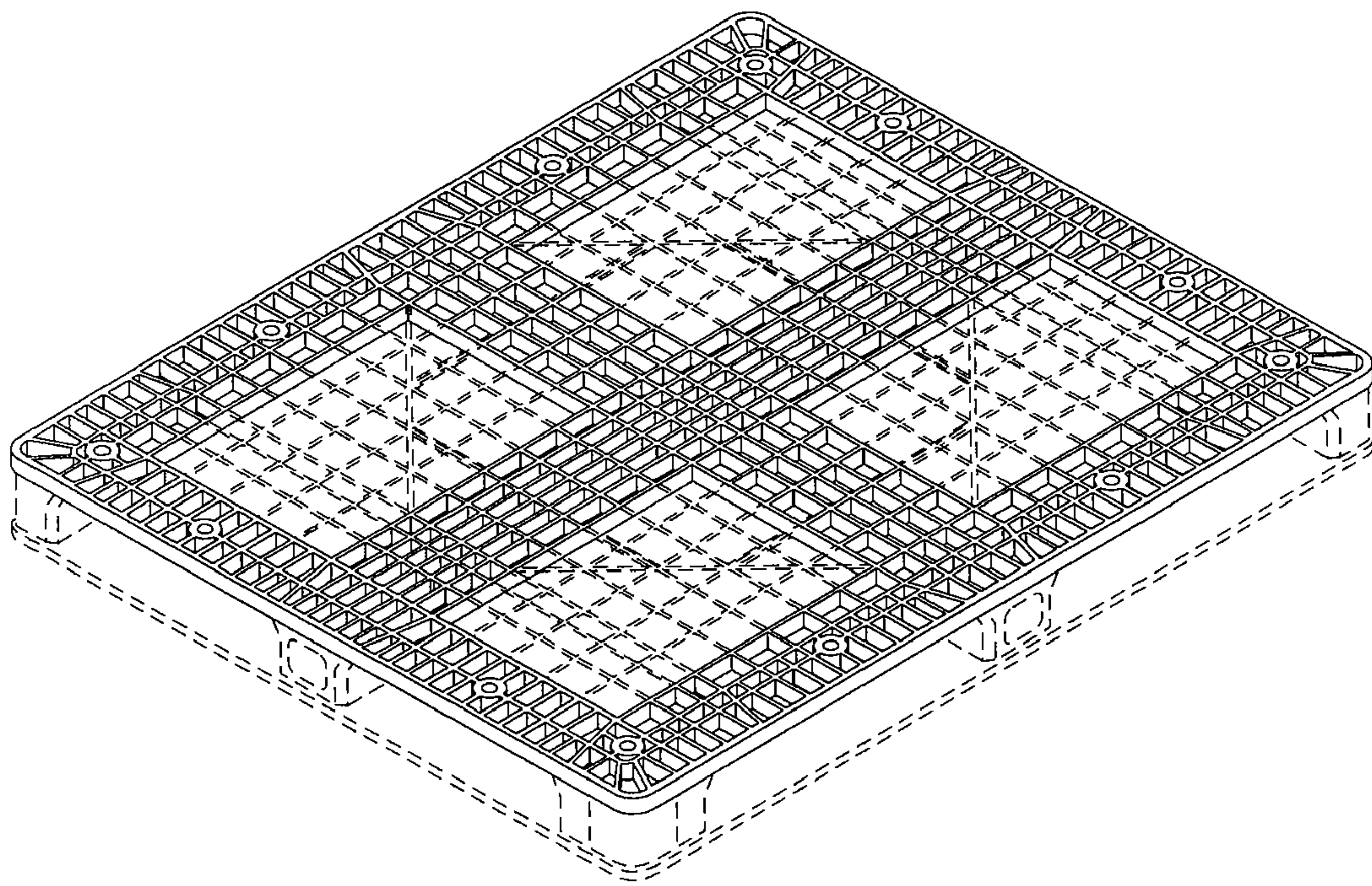

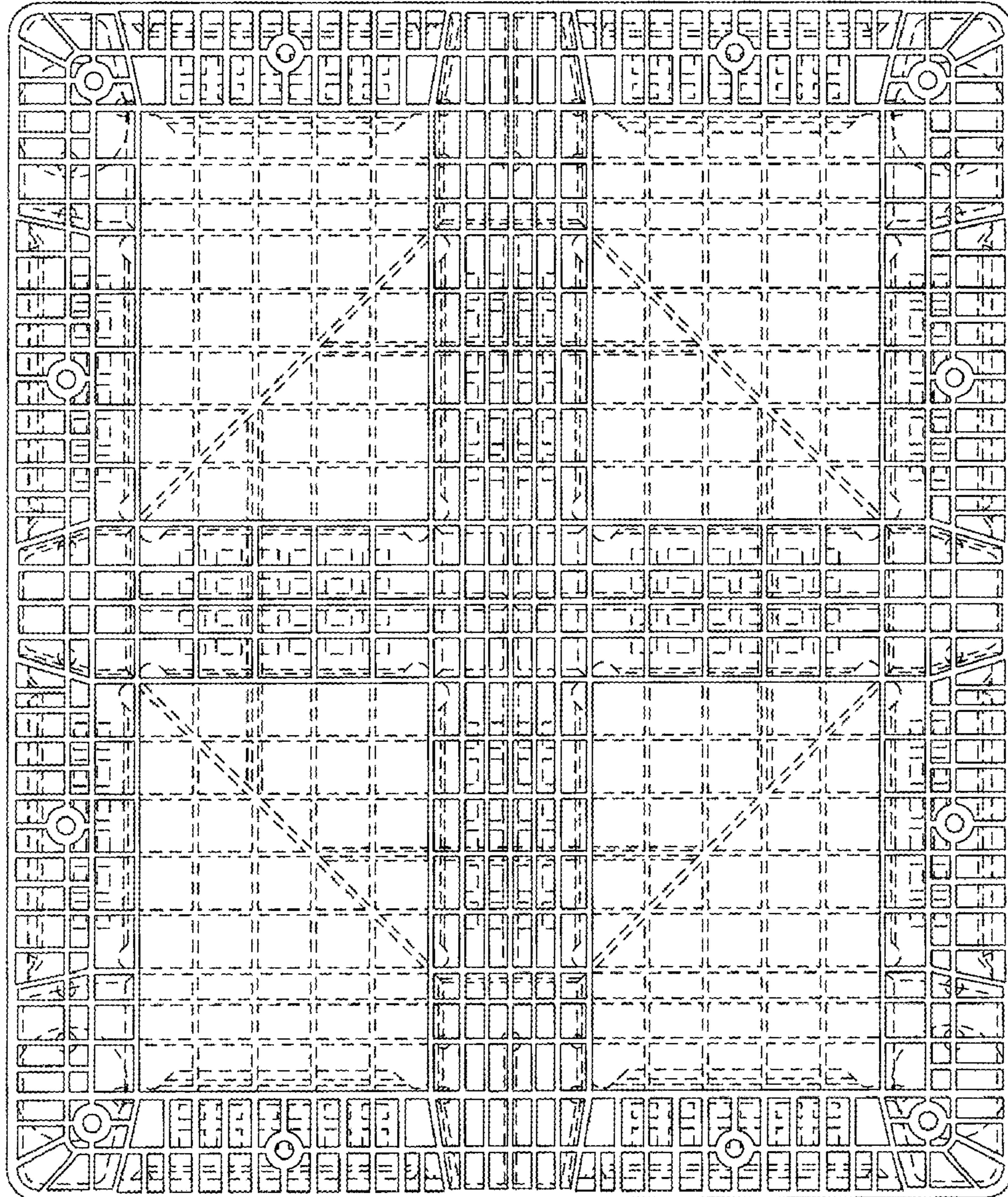

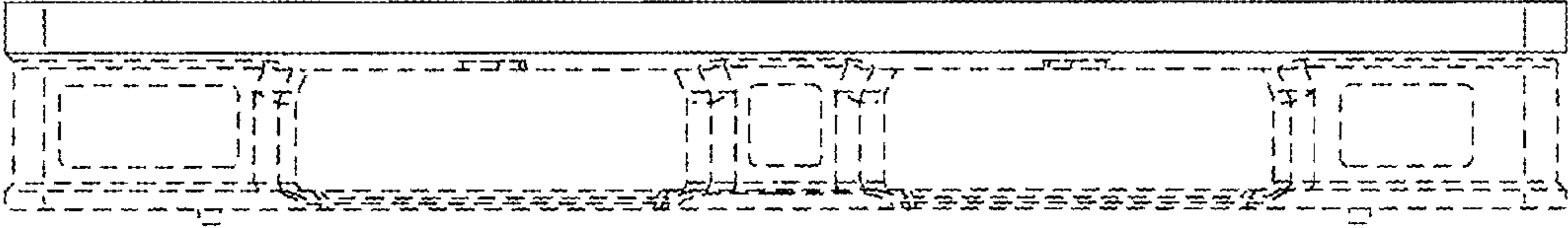

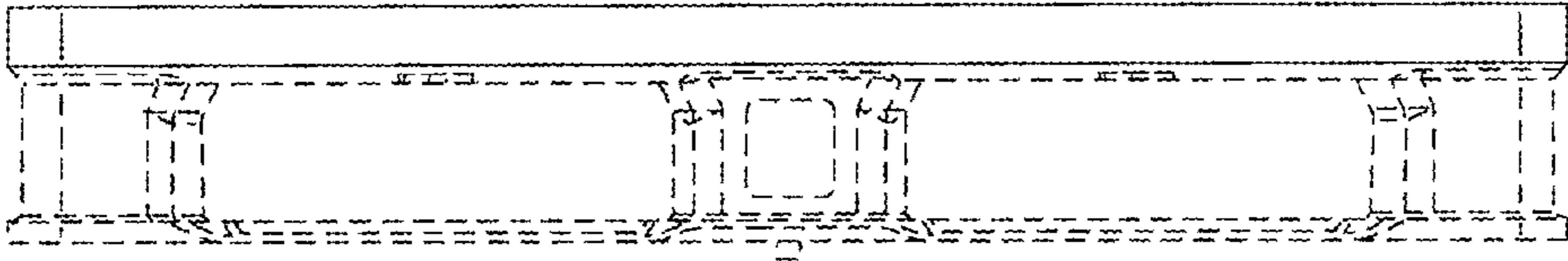

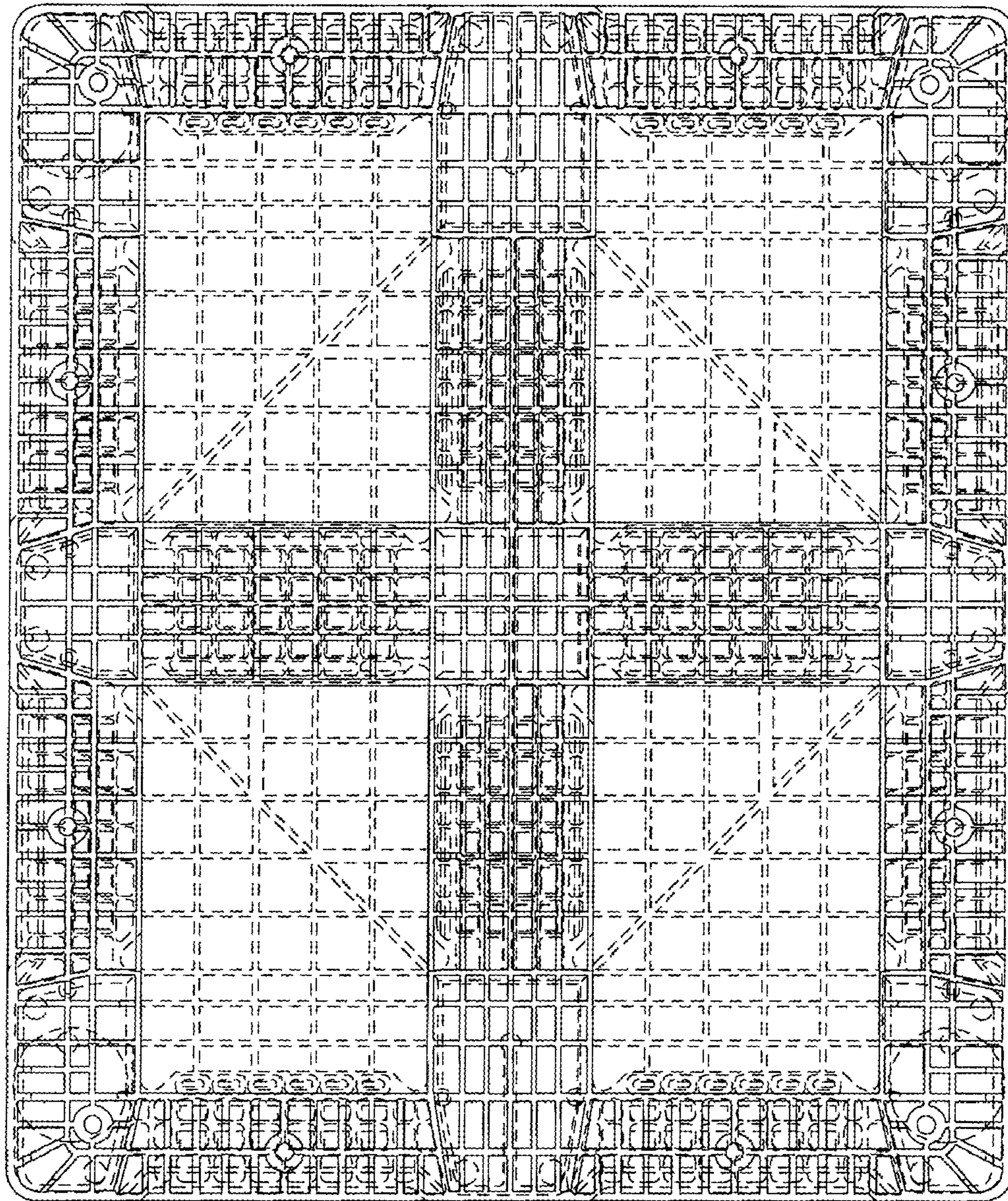

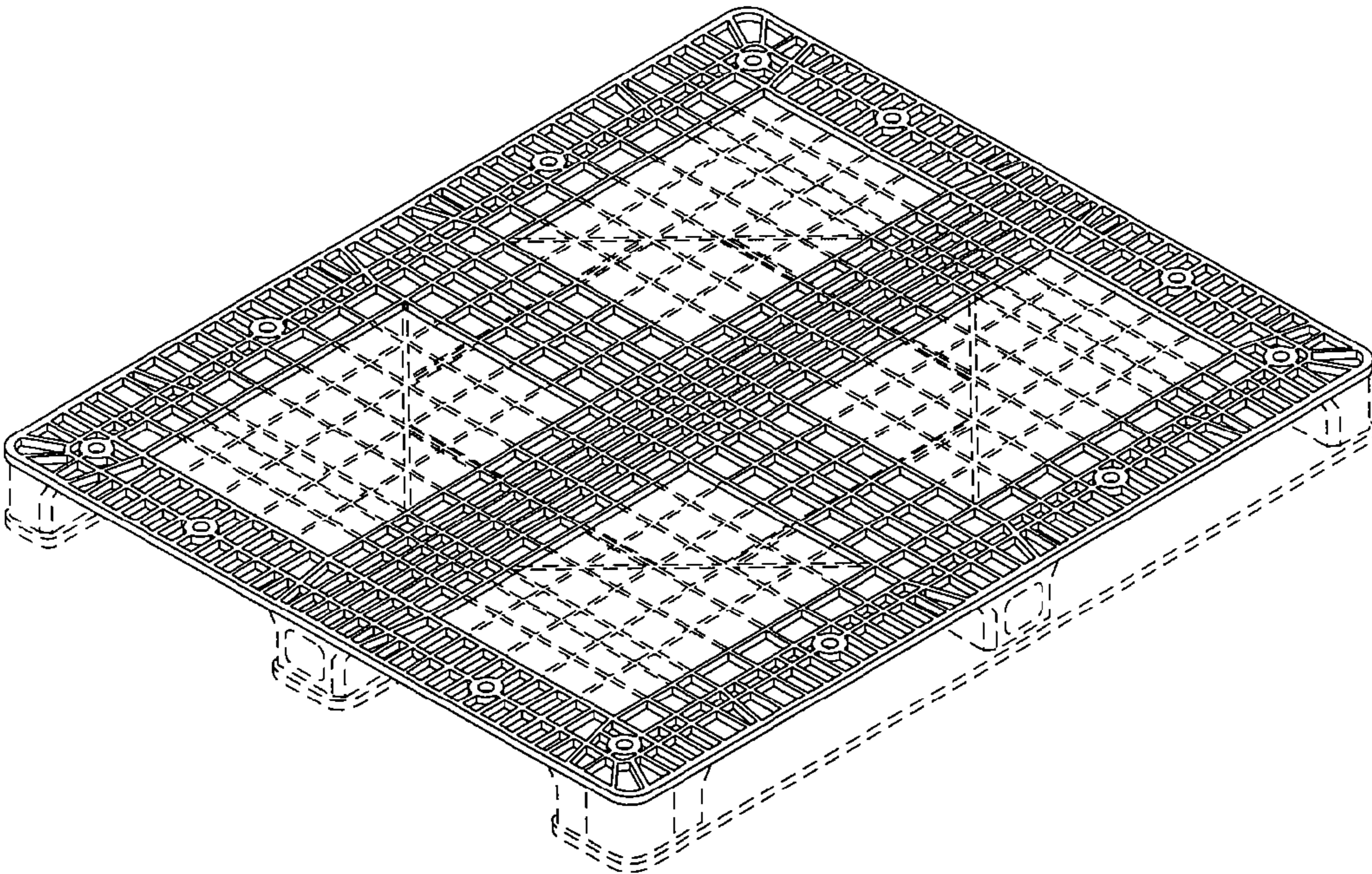

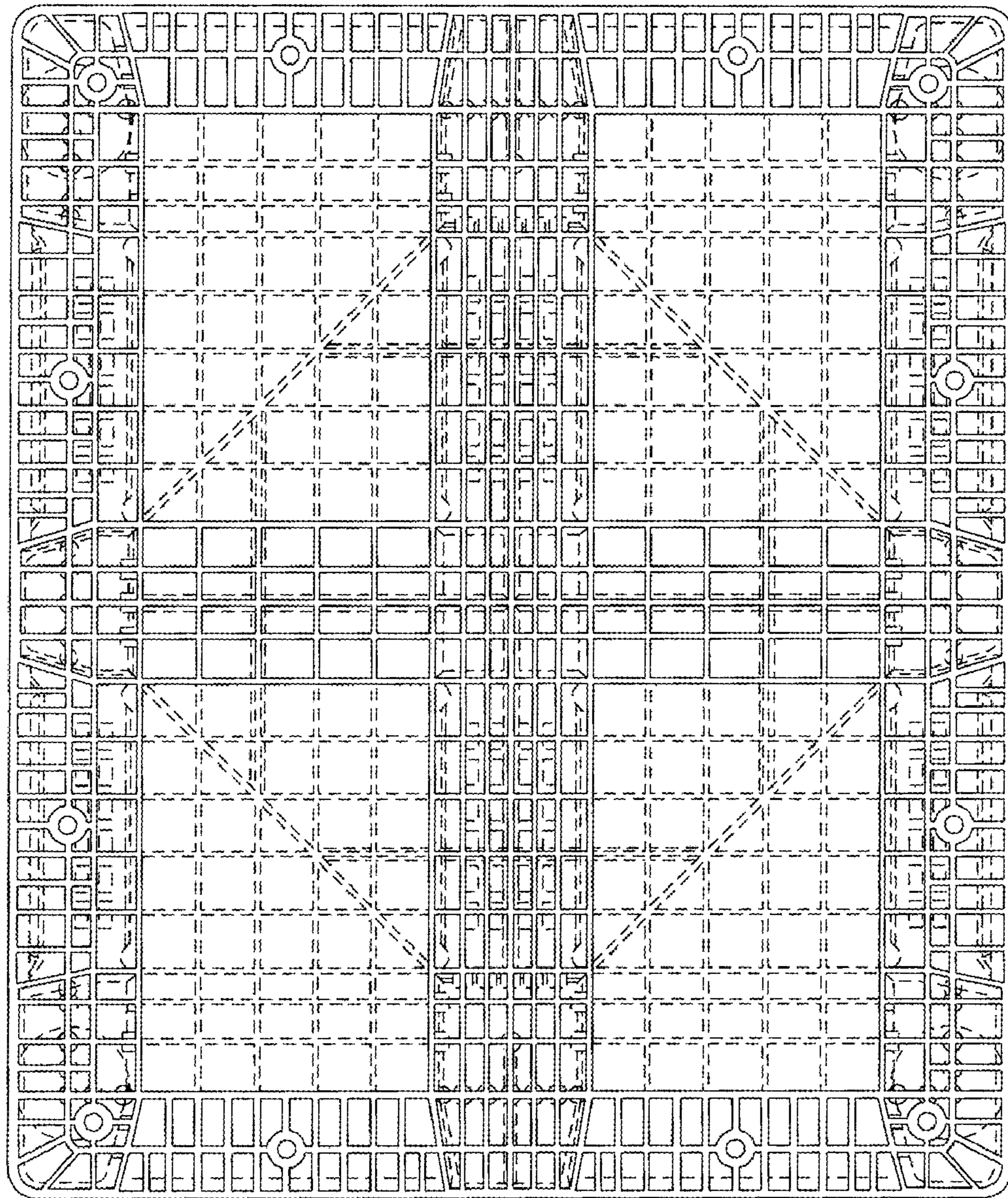

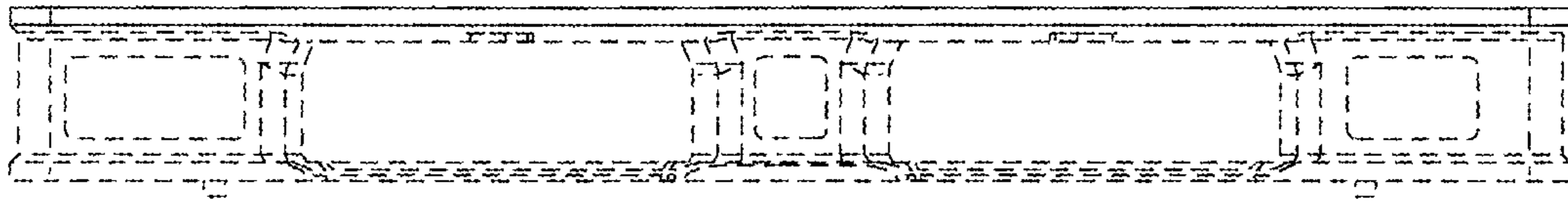

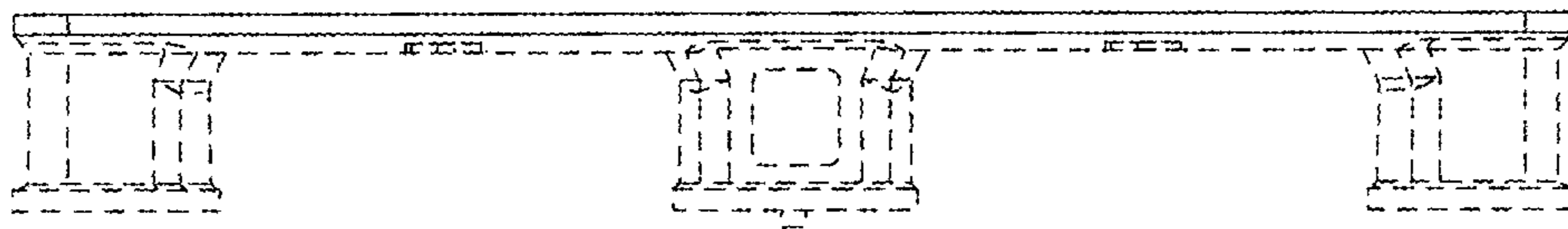

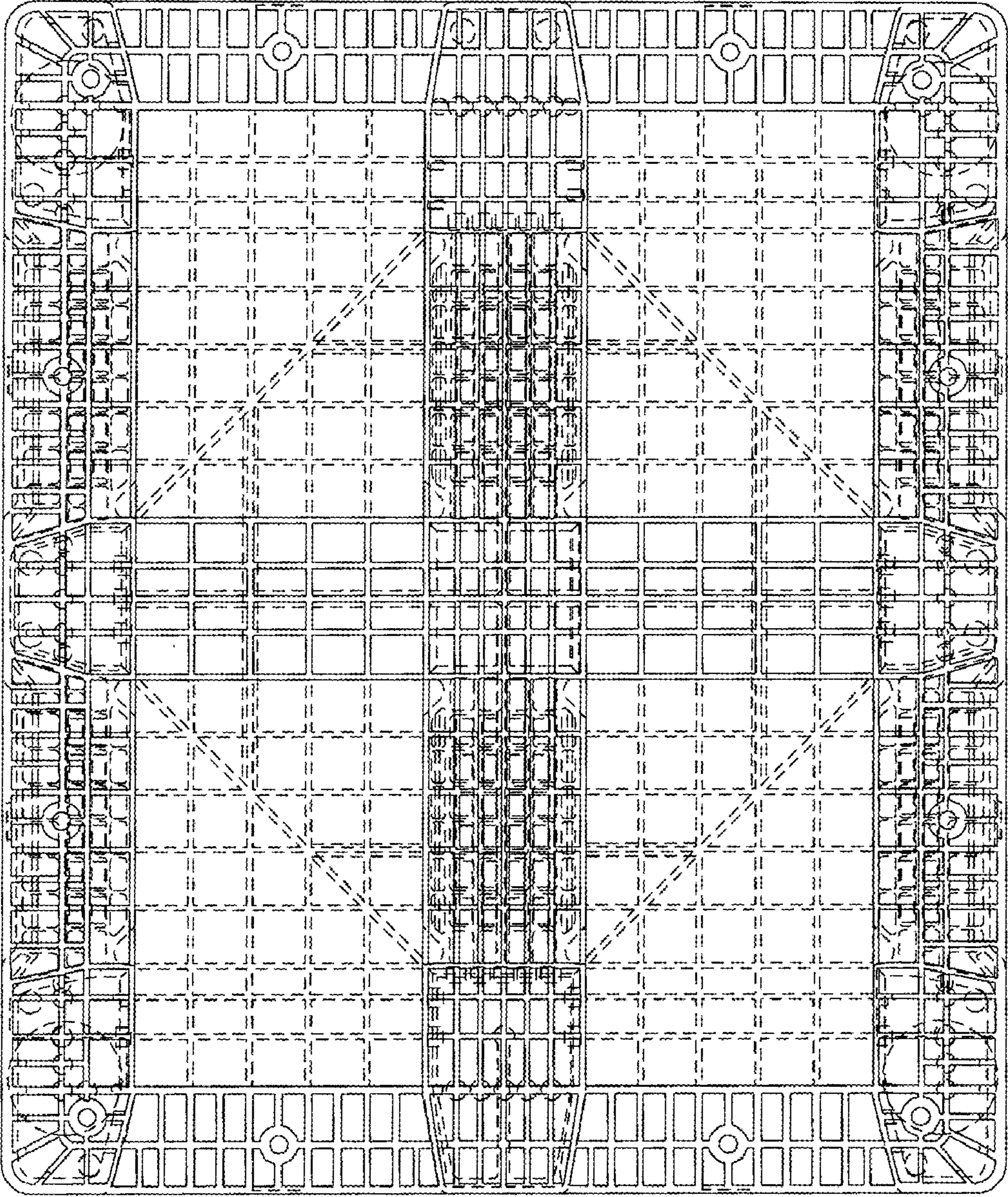
