(57) **CLAIM**

The ornamental design for a baked foodstuff, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a baked foodstuff in accordance with our new design;

FIG. 2 is a top plan view of the baked foodstuff shown in FIG. 1;

FIG. 3 is a bottom plan view of the baked foodstuff shown in FIG. 1;

FIG. 4 is a front elevational view of the baked foodstuff shown in FIG. 1;

FIG. 5 is a rear elevational view of the baked foodstuff shown in FIG. 1;

FIG. 6 is a right-side elevational view of the baked foodstuff shown in FIG. 1;

FIG. 7 is a left-side elevational view of the baked foodstuff shown in FIG. 1;

FIG. 8 is a front perspective view of a second embodiment of a baked foodstuff in accordance with our new design;

FIG. 9 is a top plan view of the baked foodstuff shown in FIG. 8;

FIG. 11 is a front elevational view of the baked foodstuff shown in FIG. 8;

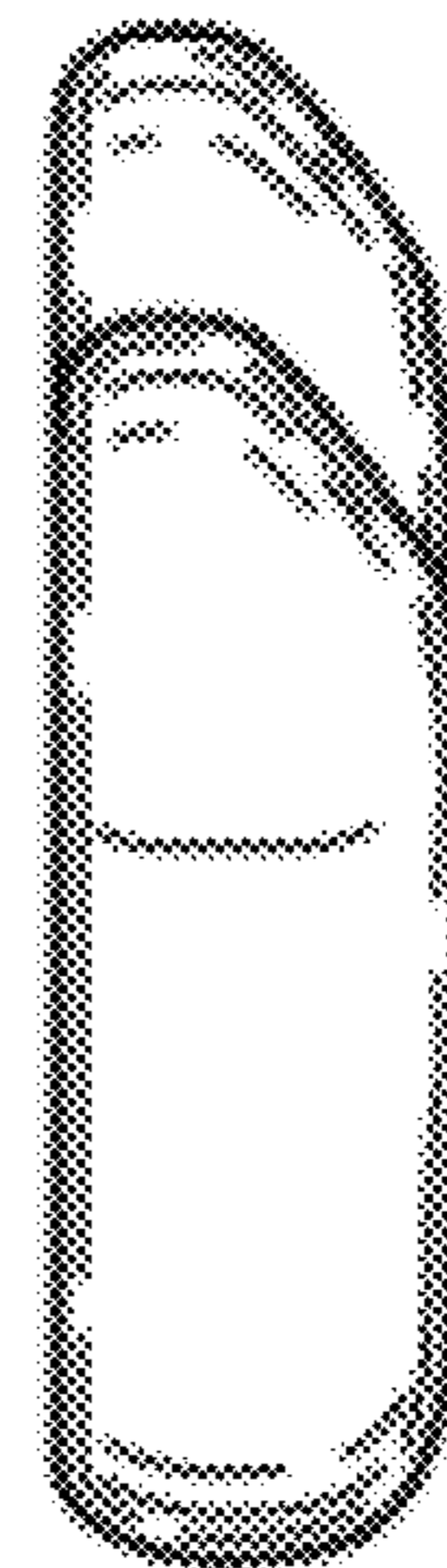
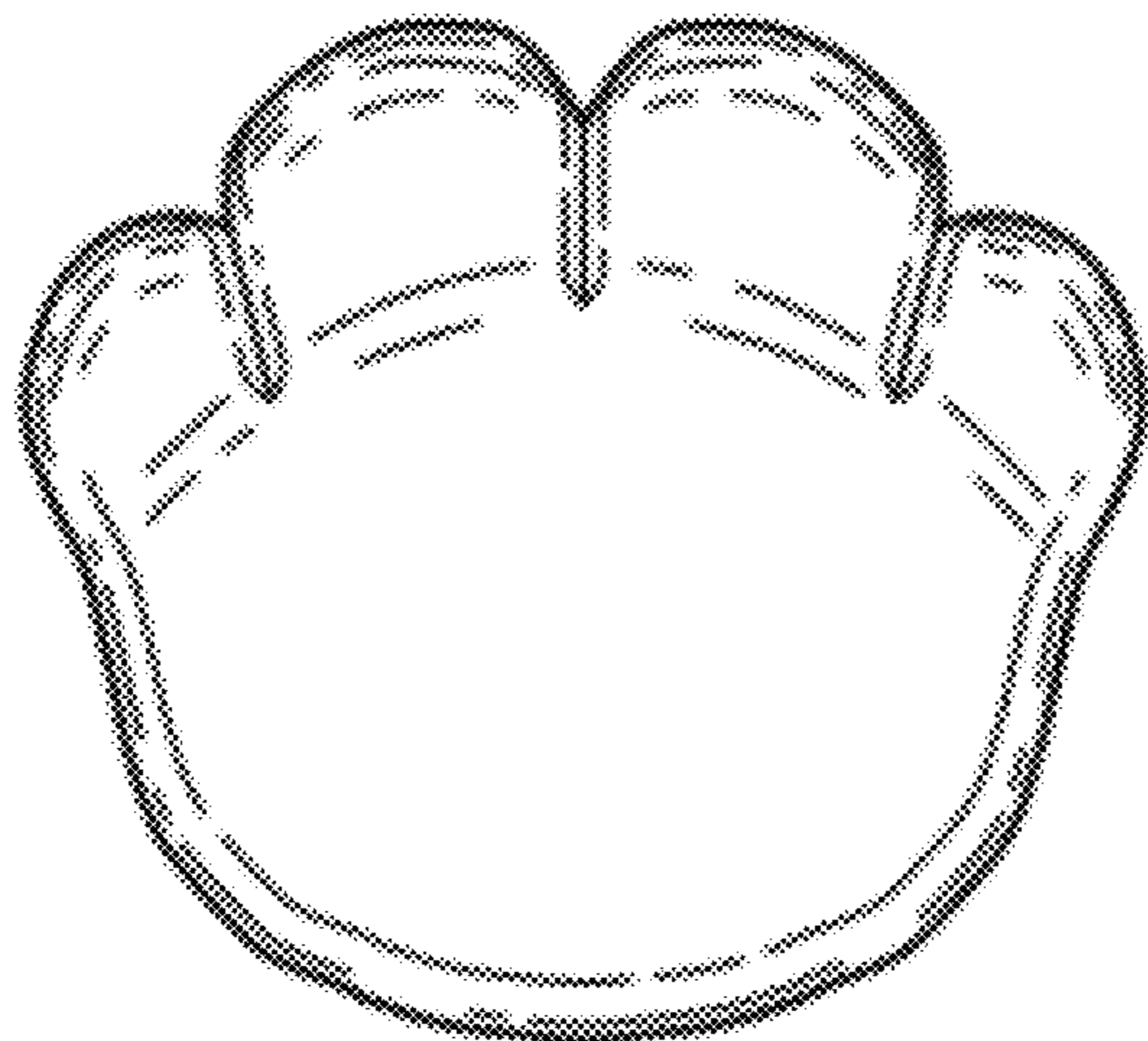
FIG. 12 is a rear elevational view of the baked foodstuff shown in FIG. 8;

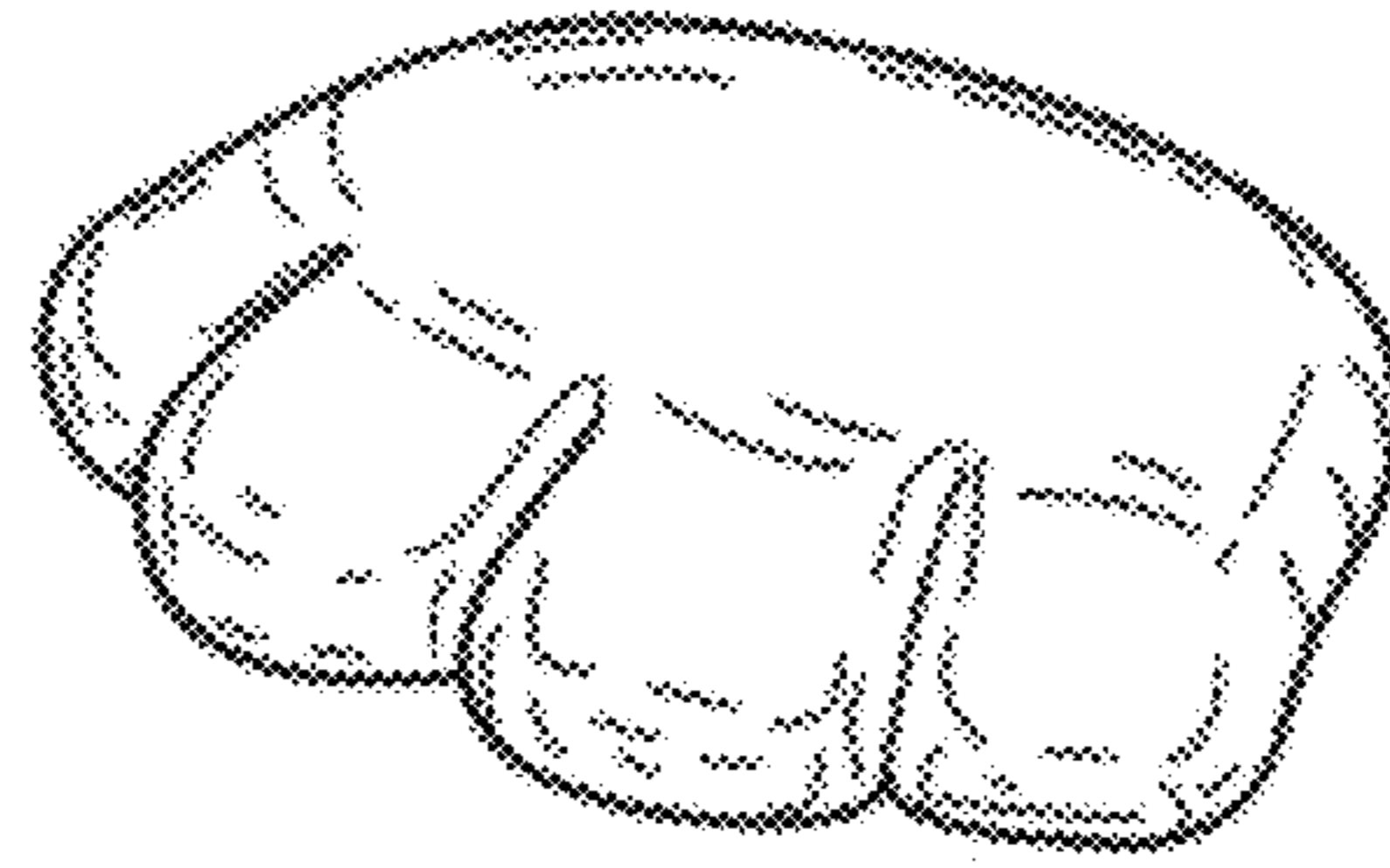

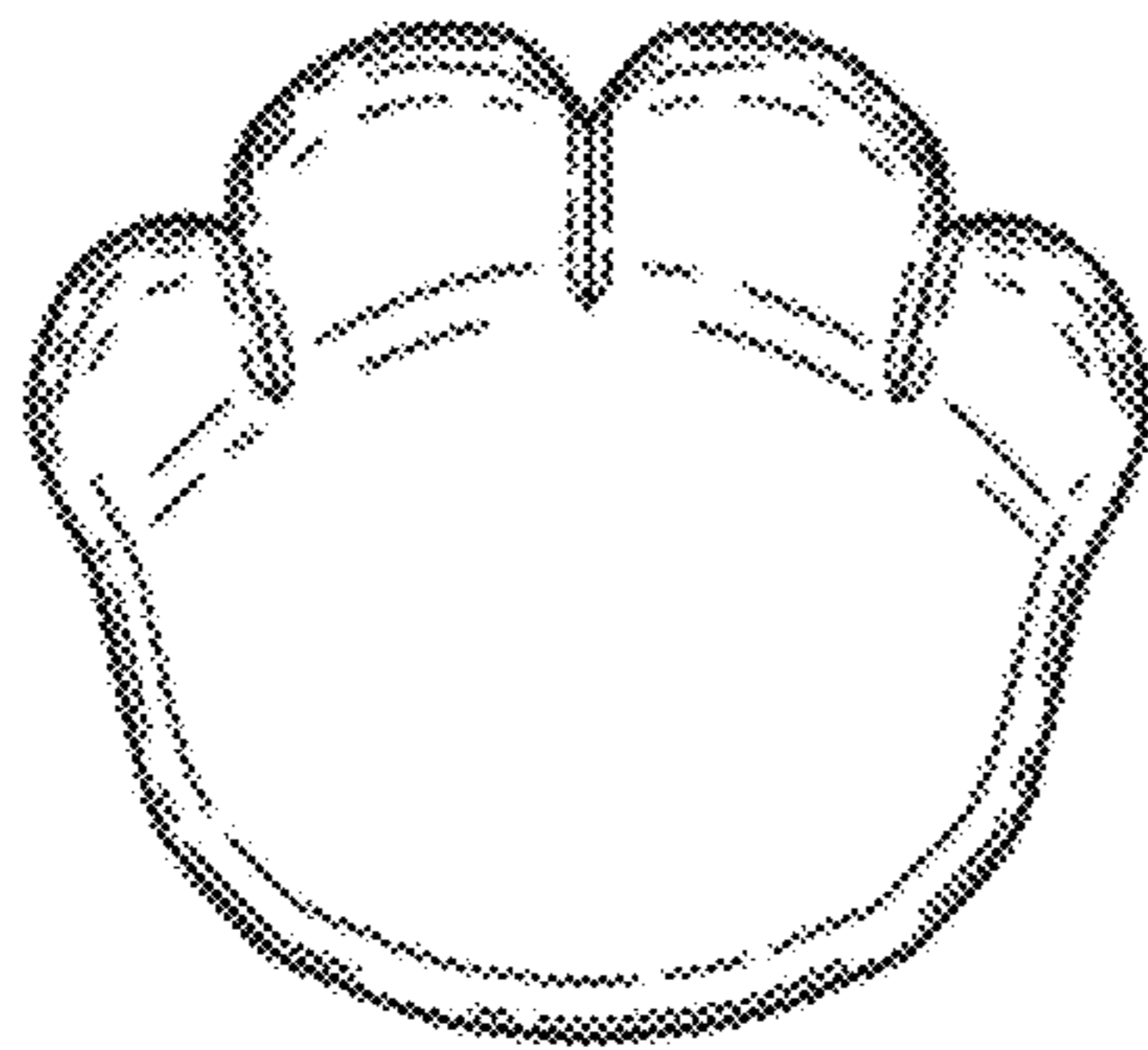

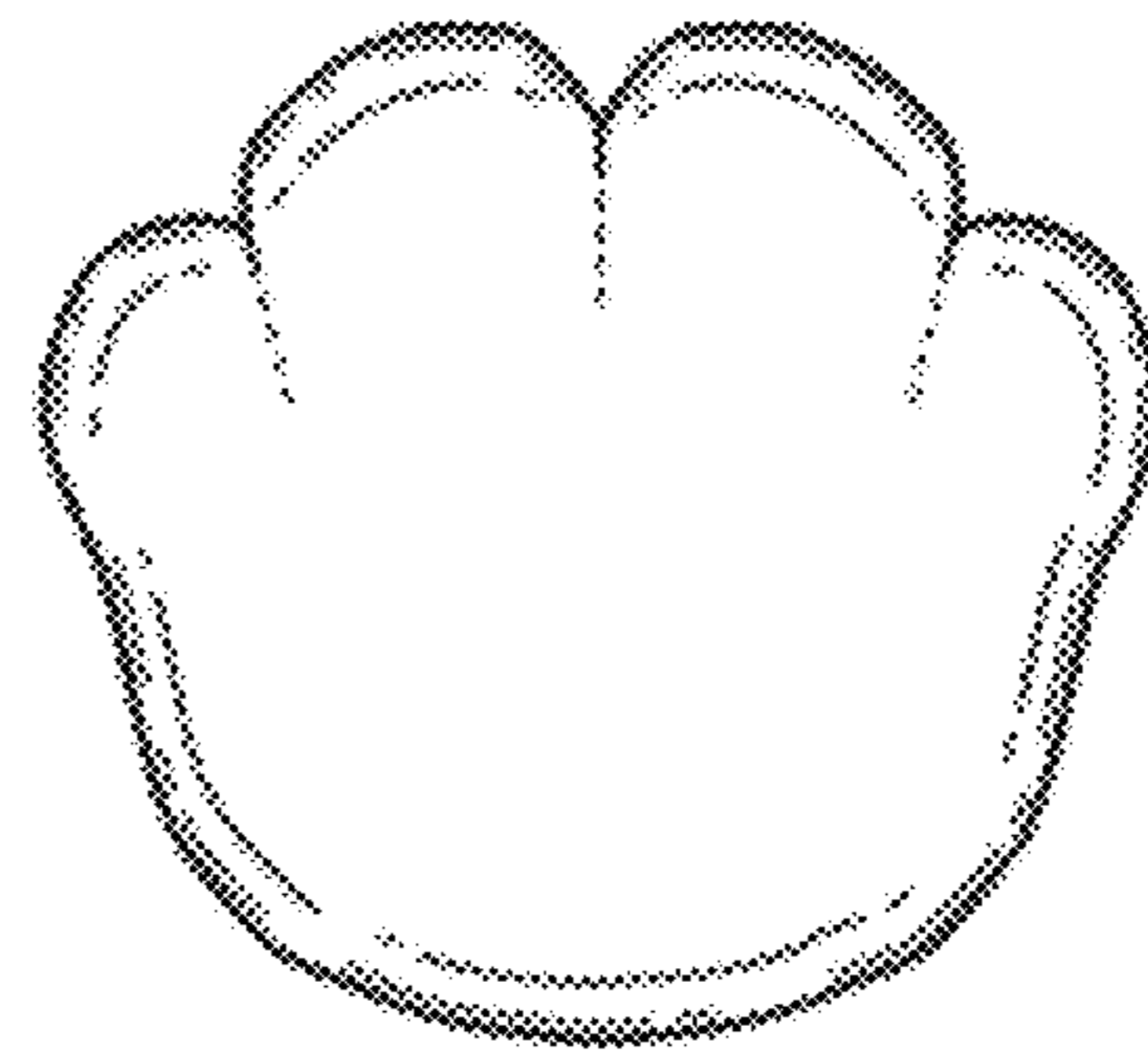

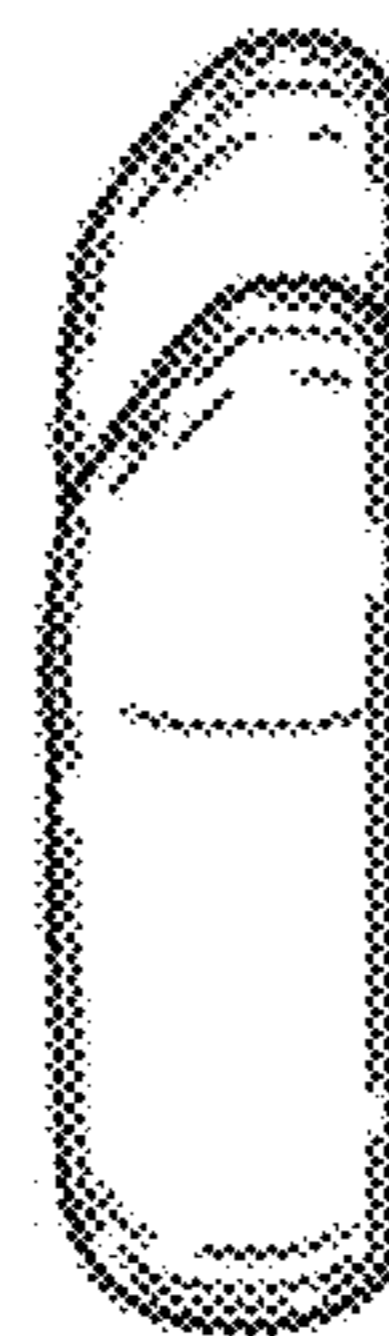

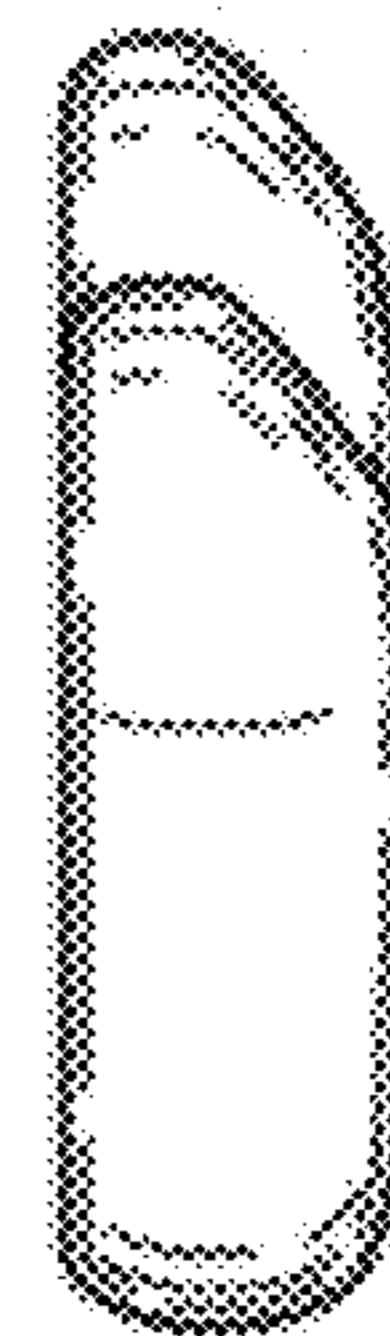

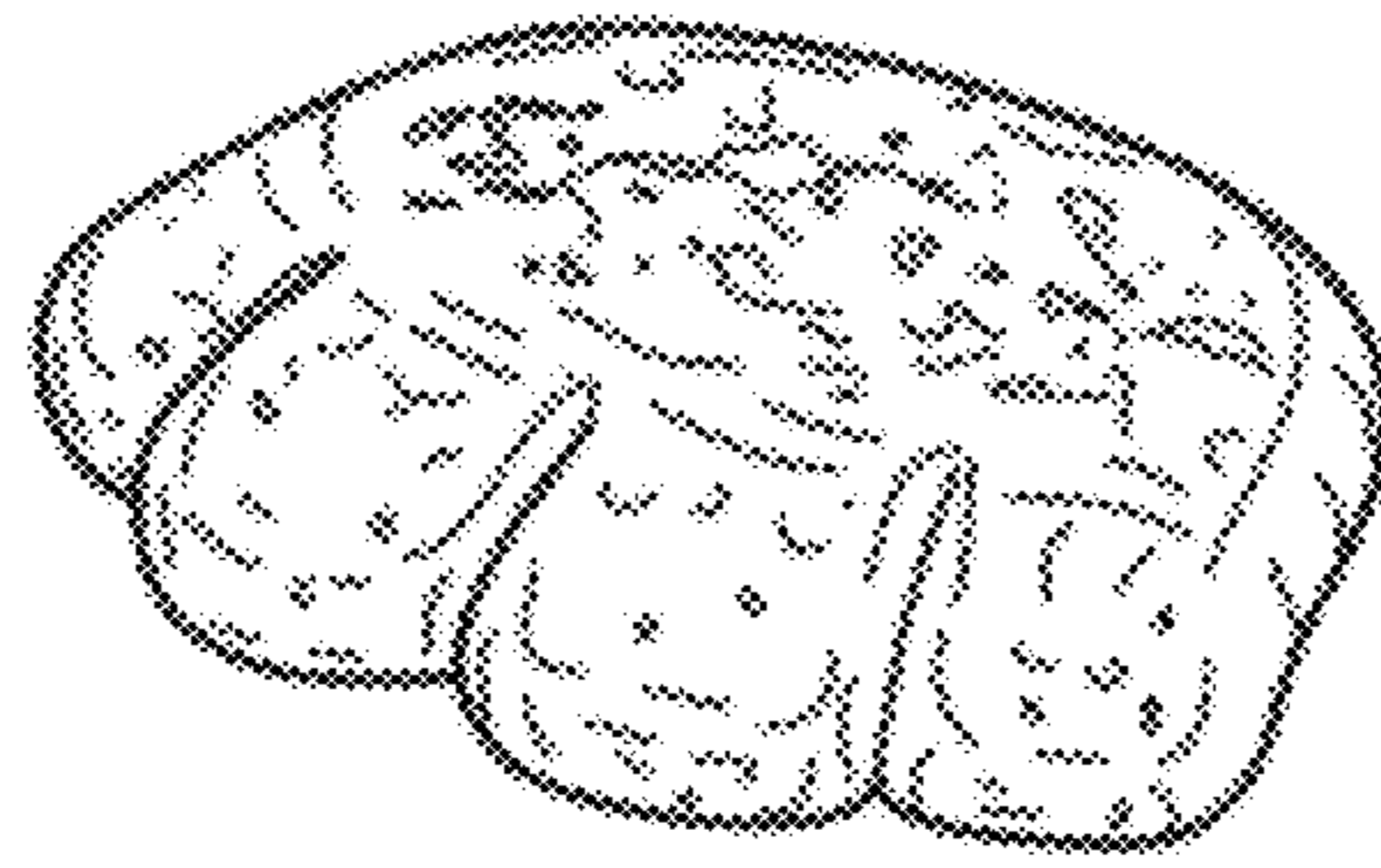

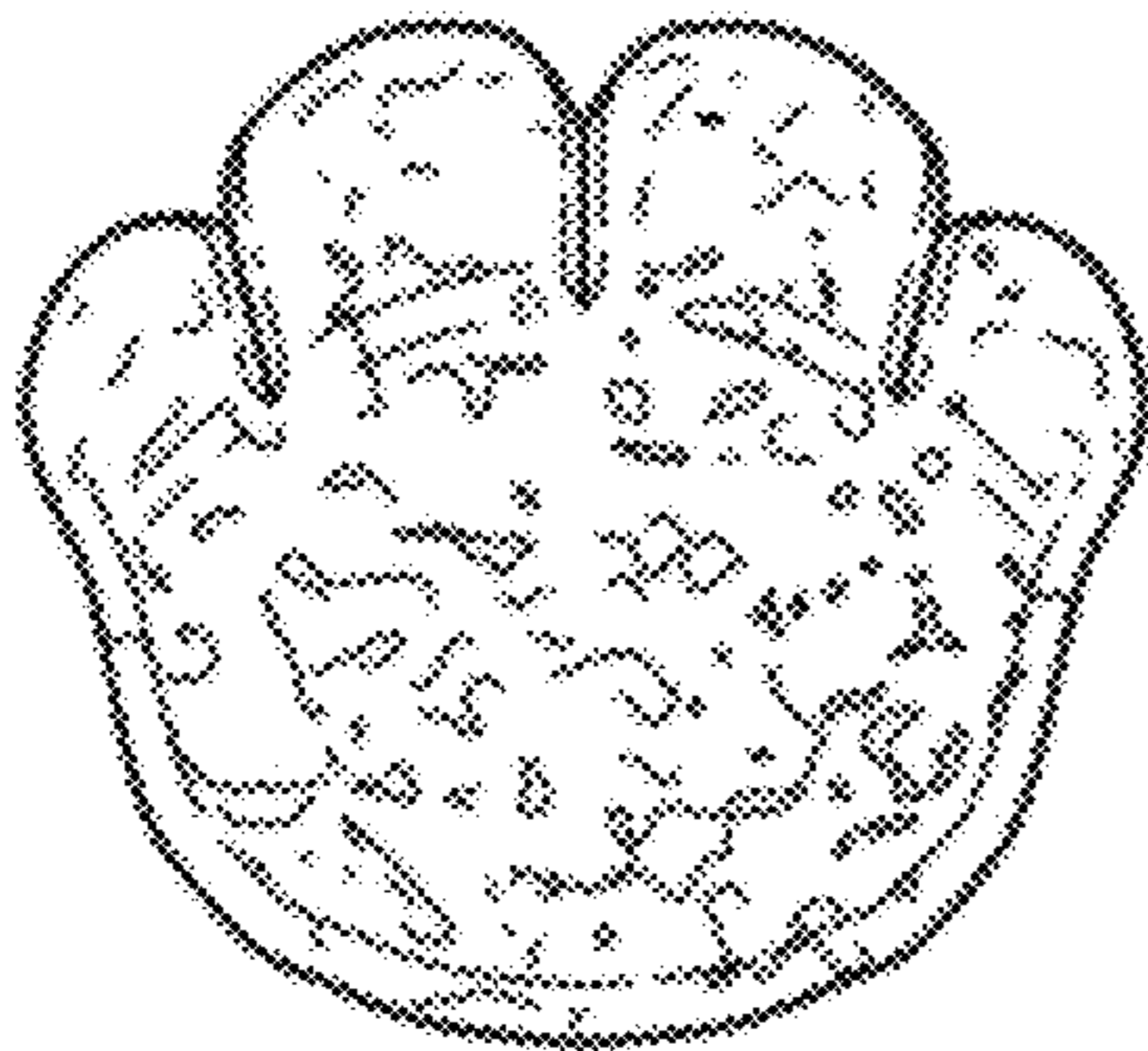

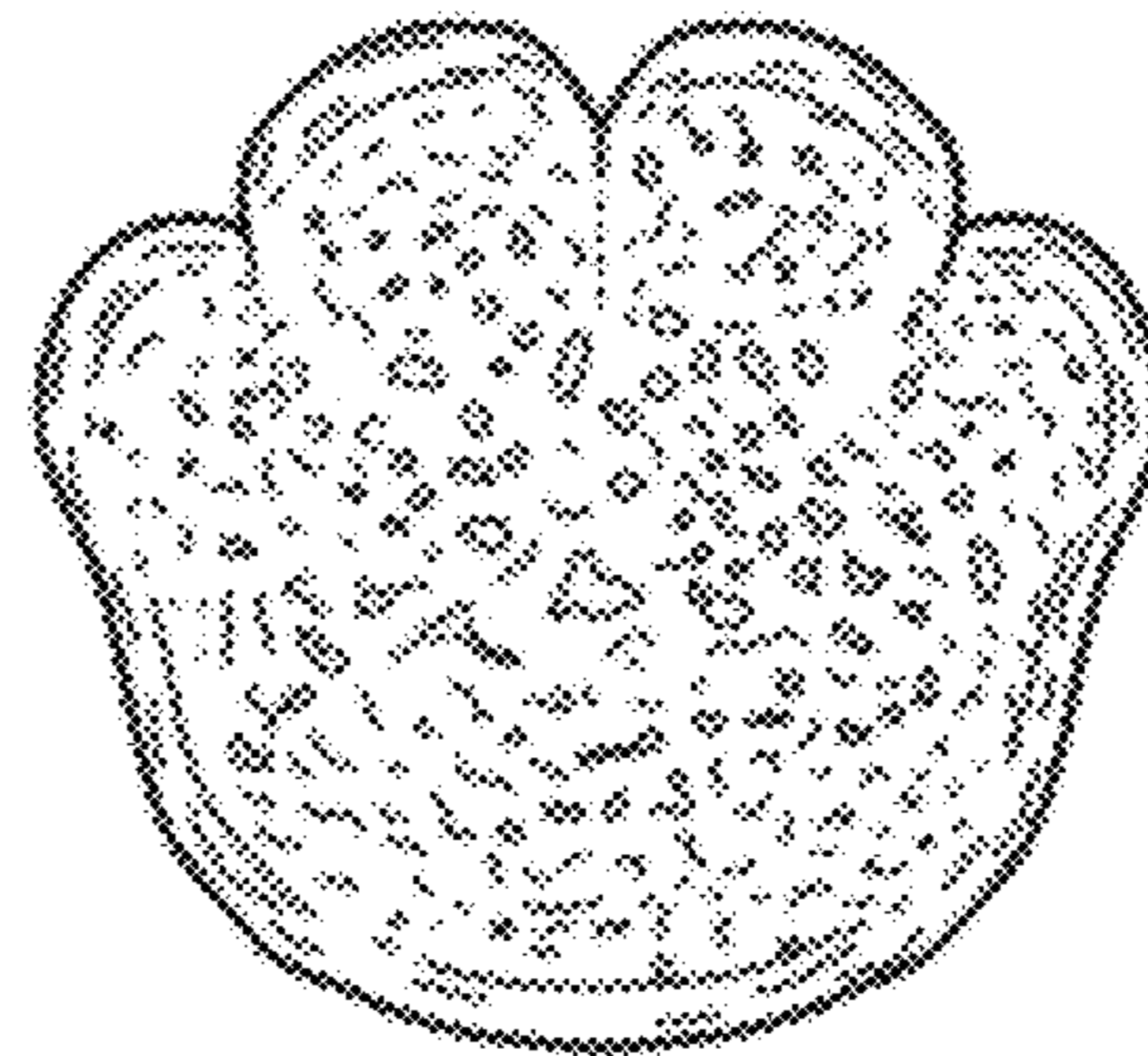

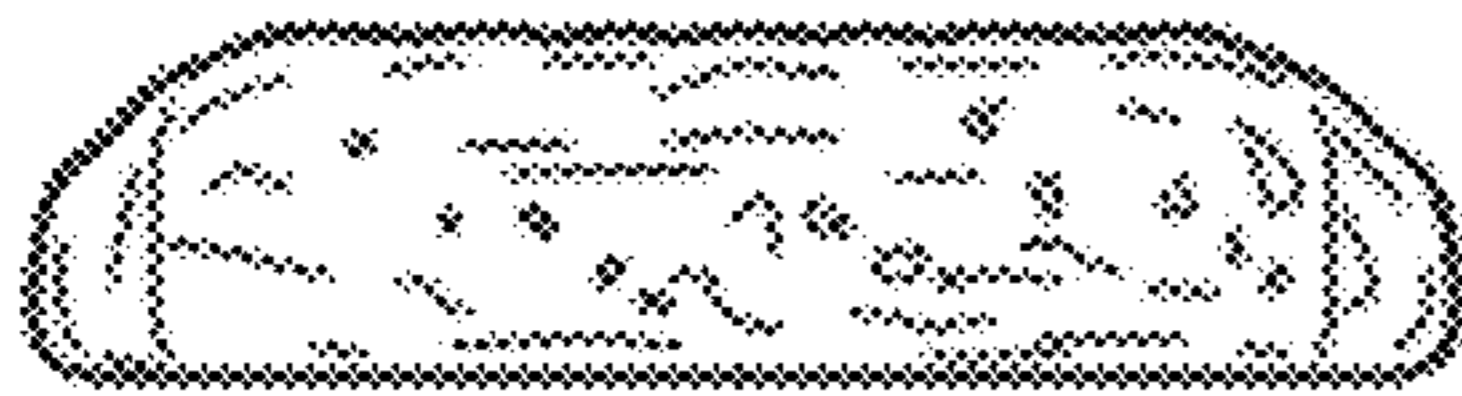
