(57) **CLAIM**

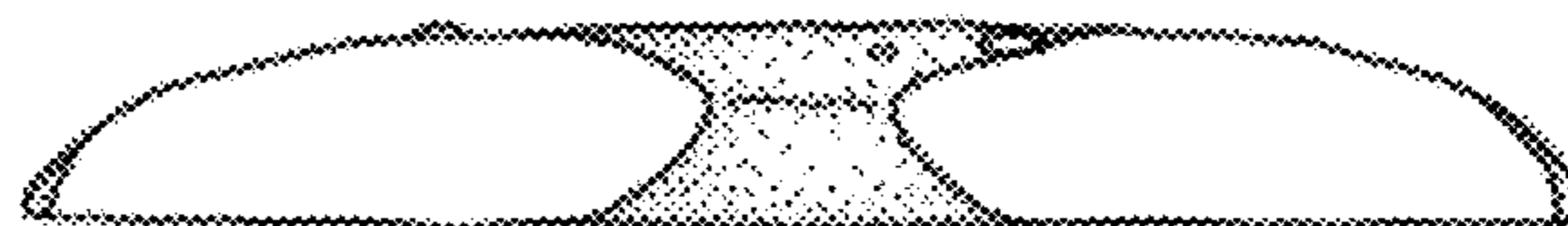
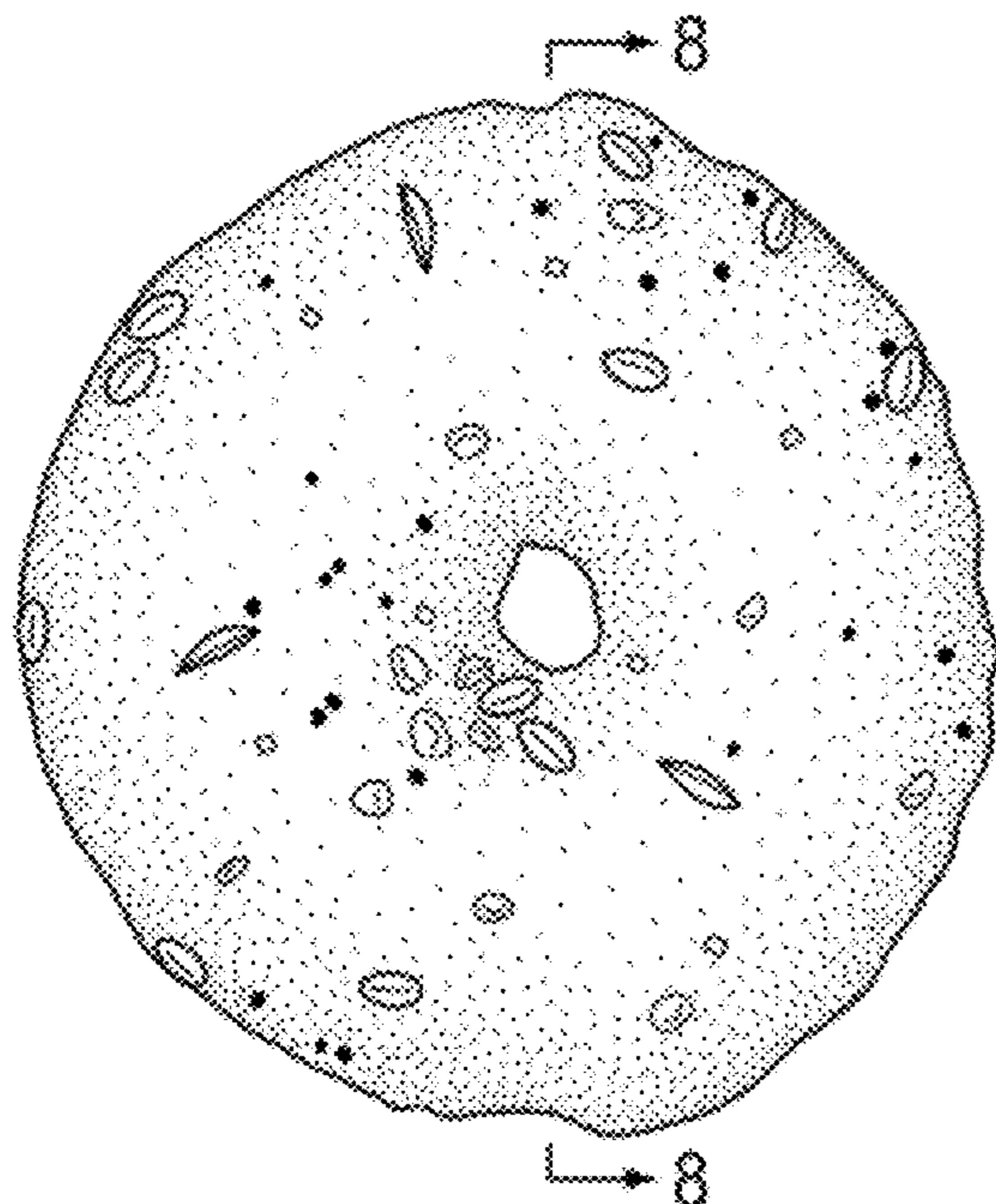
We claim the ornamental design for a snack cracker food product, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of the claimed design; FIG. 2 is a top view of the claimed design of FIG. 1; FIG. 3 is a rear view of the claimed design of FIG. 1; FIG. 4 is a front view of the claimed design of FIG. 1; FIG. 5 is a left side view of the claimed design of FIG. 1; FIG. 6 is a right side view of the claimed design of FIG. 1; FIG. 7 is a bottom view of the claimed design of FIG. 1; and, FIG. 8 is a cross-sectional view of the claimed design of FIG. 1 taken along the line 8-8 in FIG. 2.

The broken lines shown in the drawings represent portions of the snack cracker food product that form no part of the claimed design.

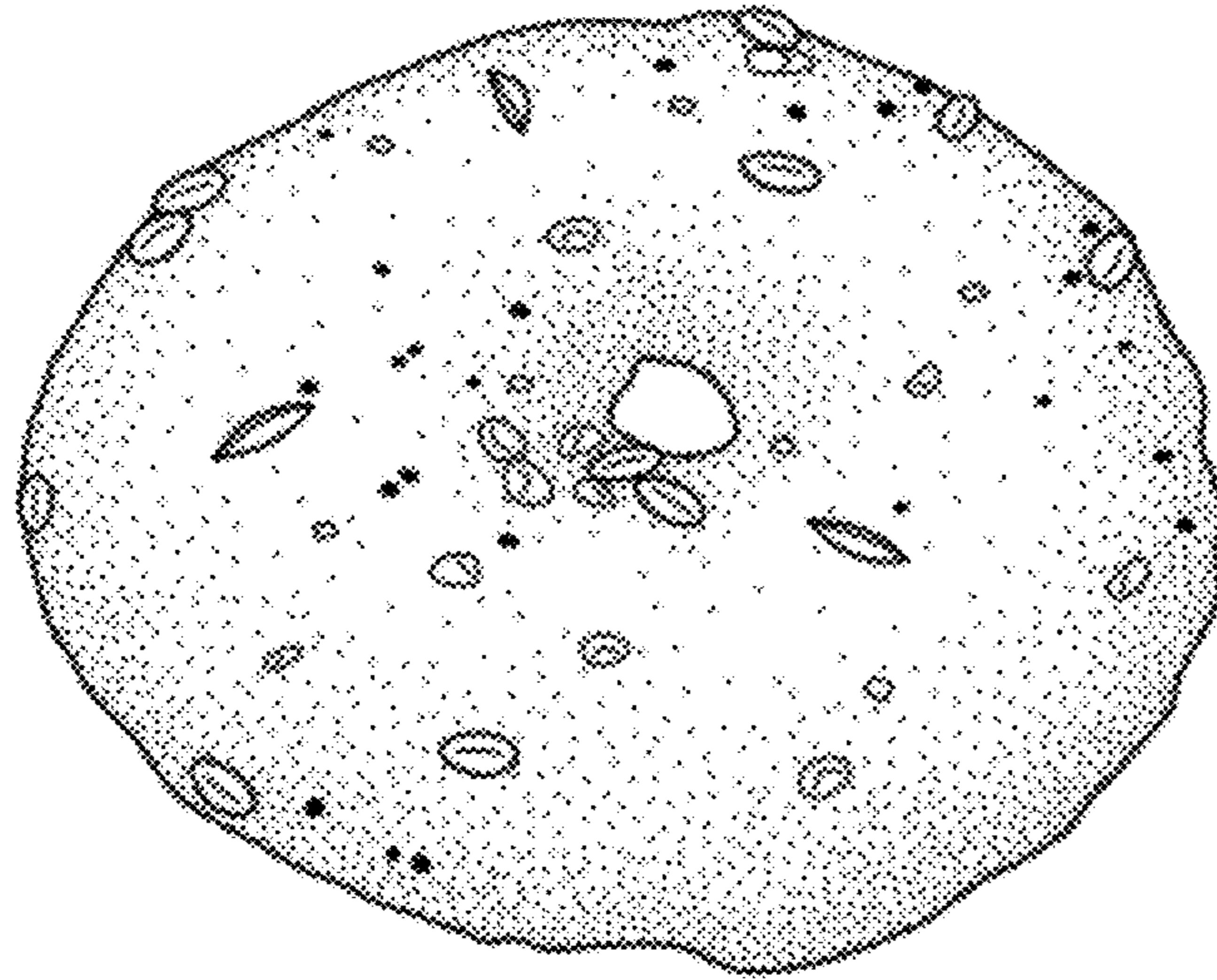

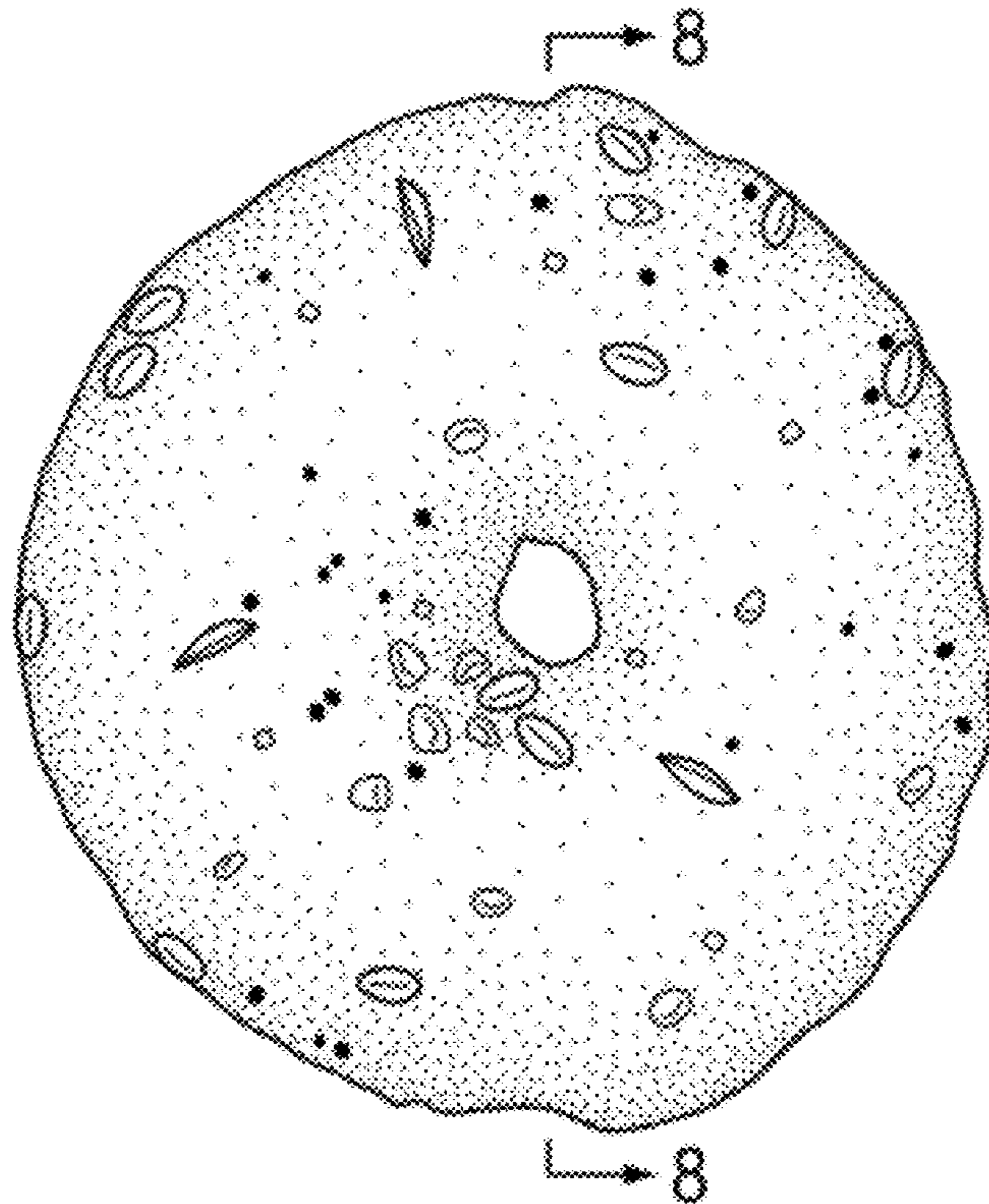

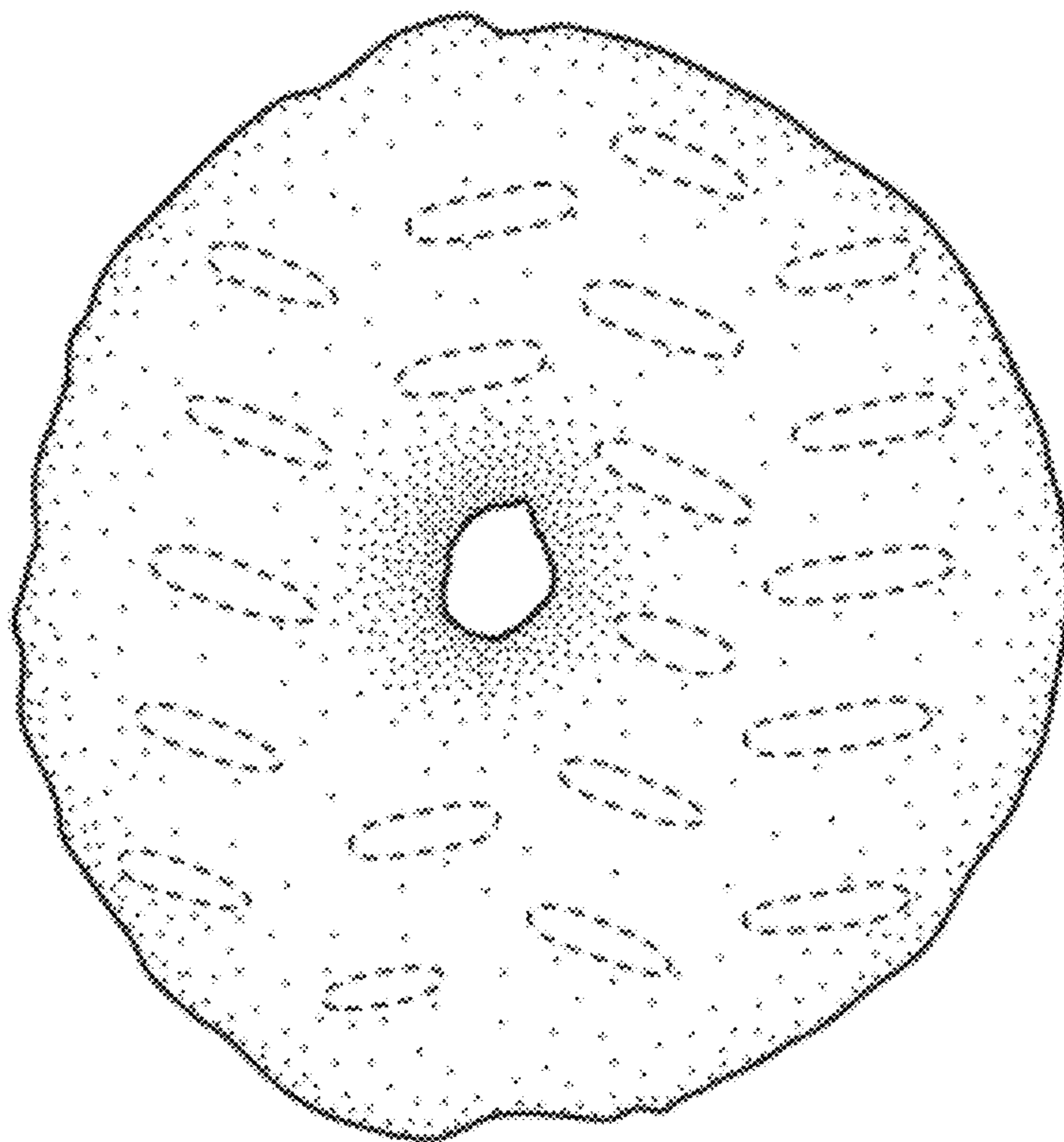
