DESCRIPTION

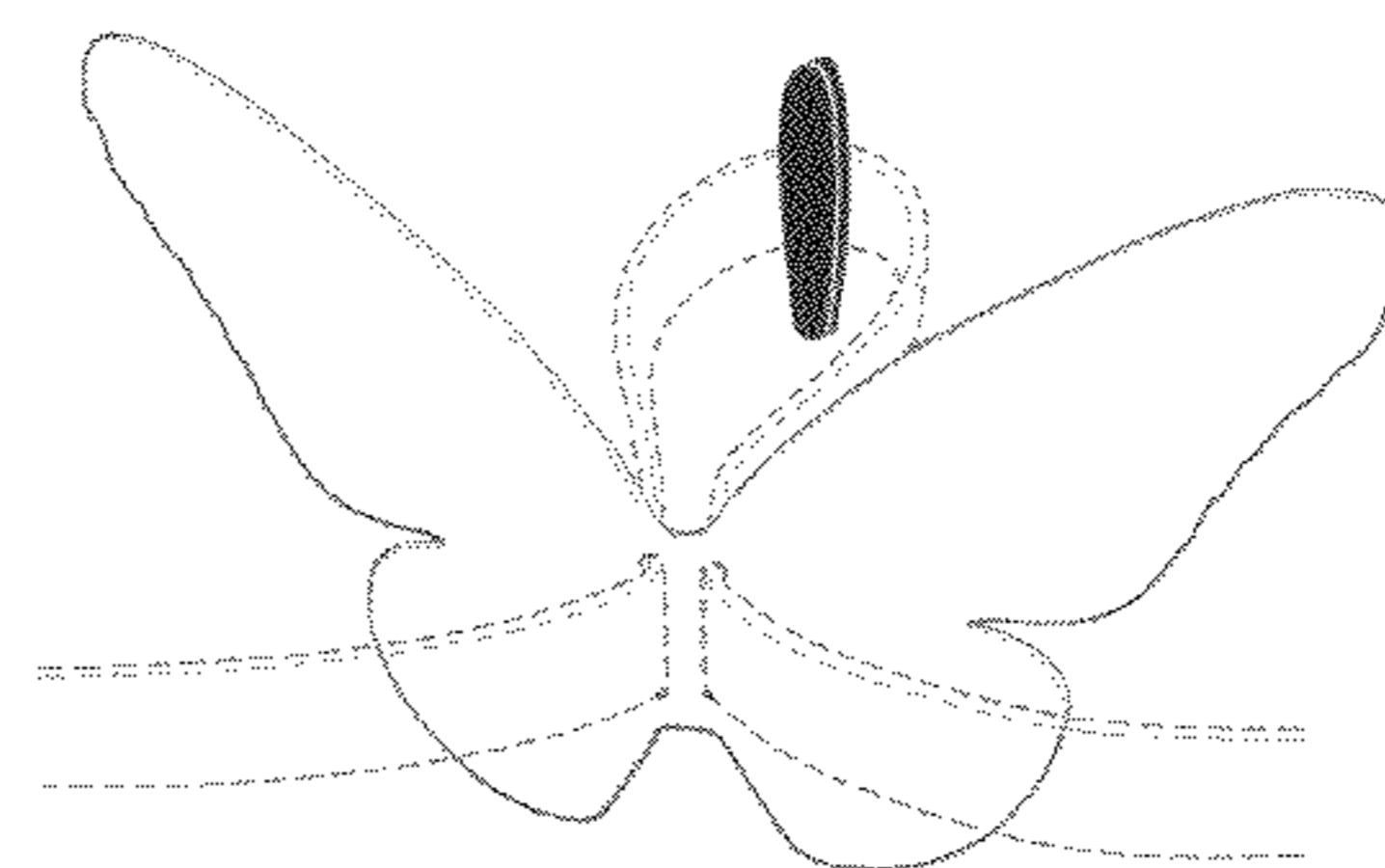
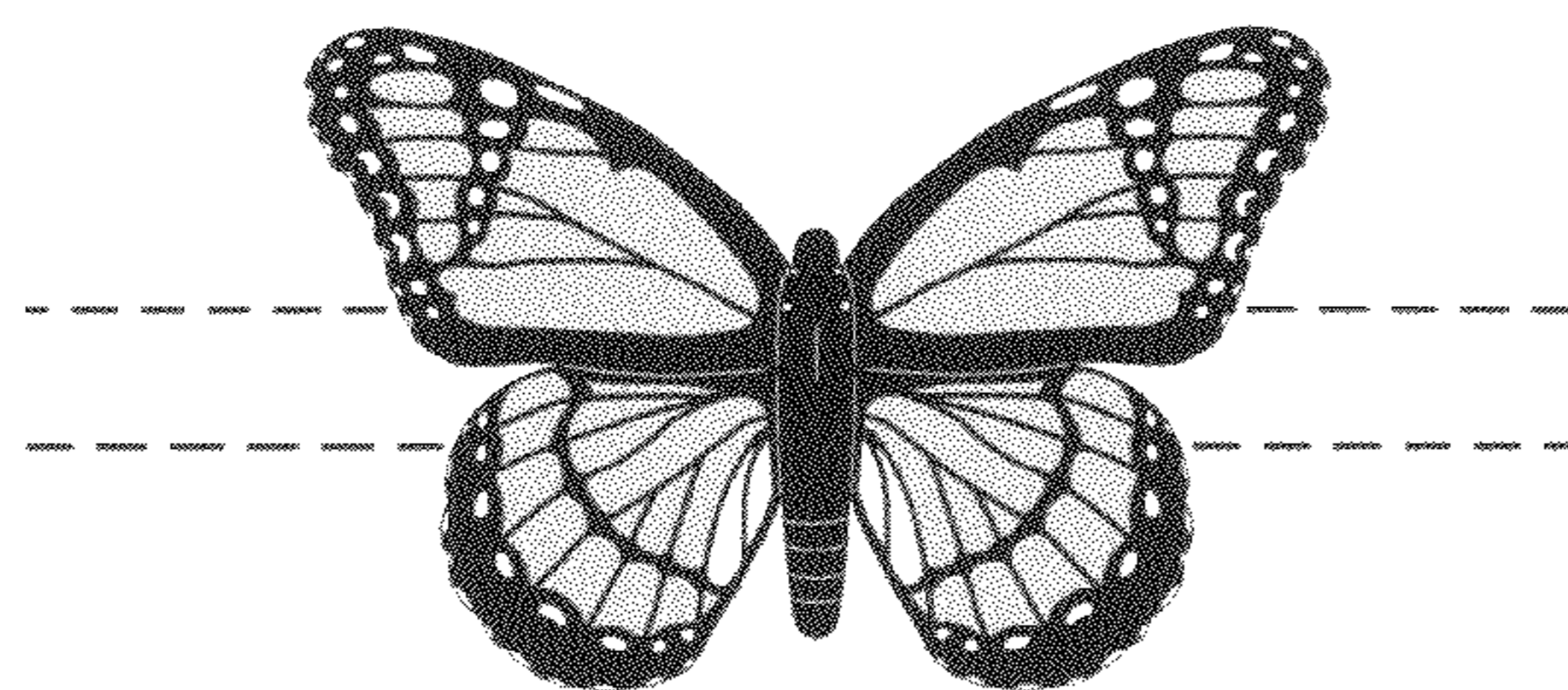
FIG. 1 is a front elevation view of the butterfly bowtie, the strap not being shown for clarity of illustration.

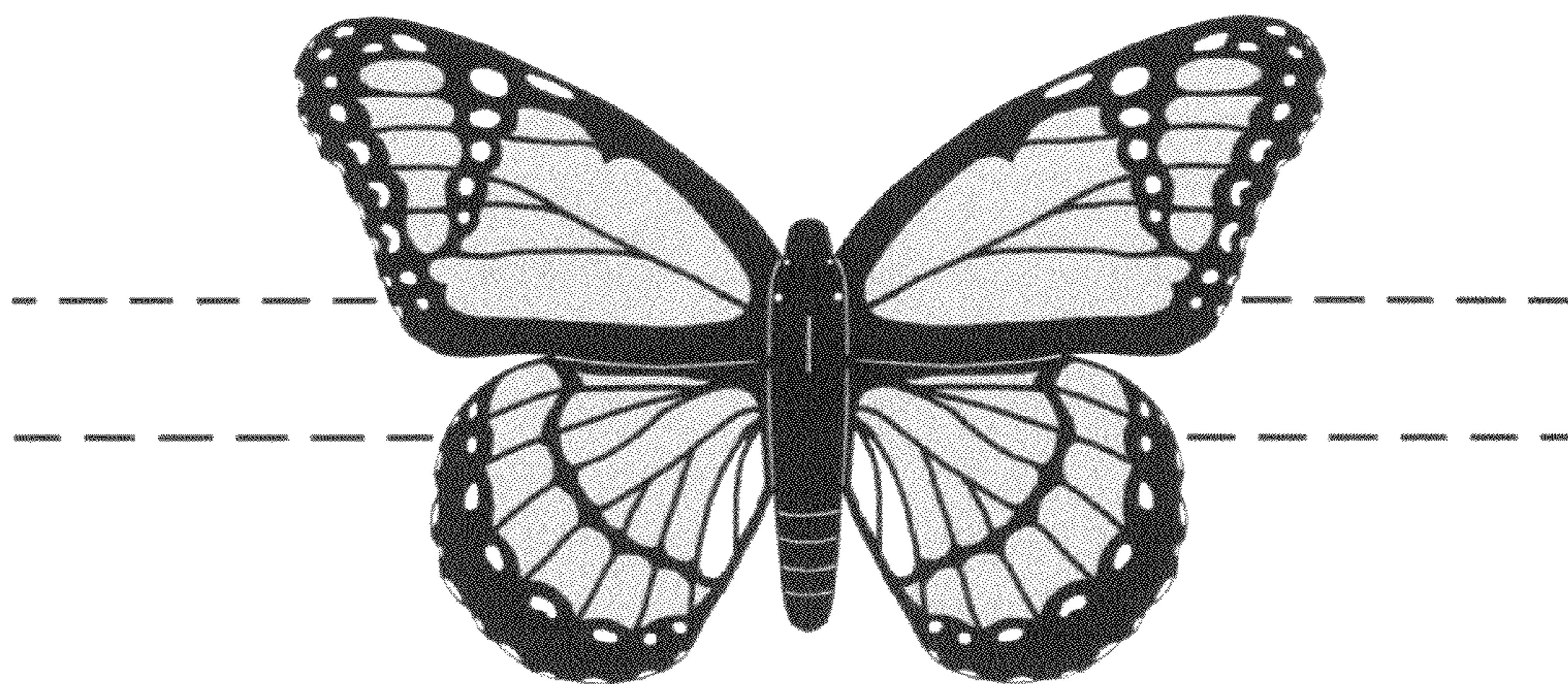

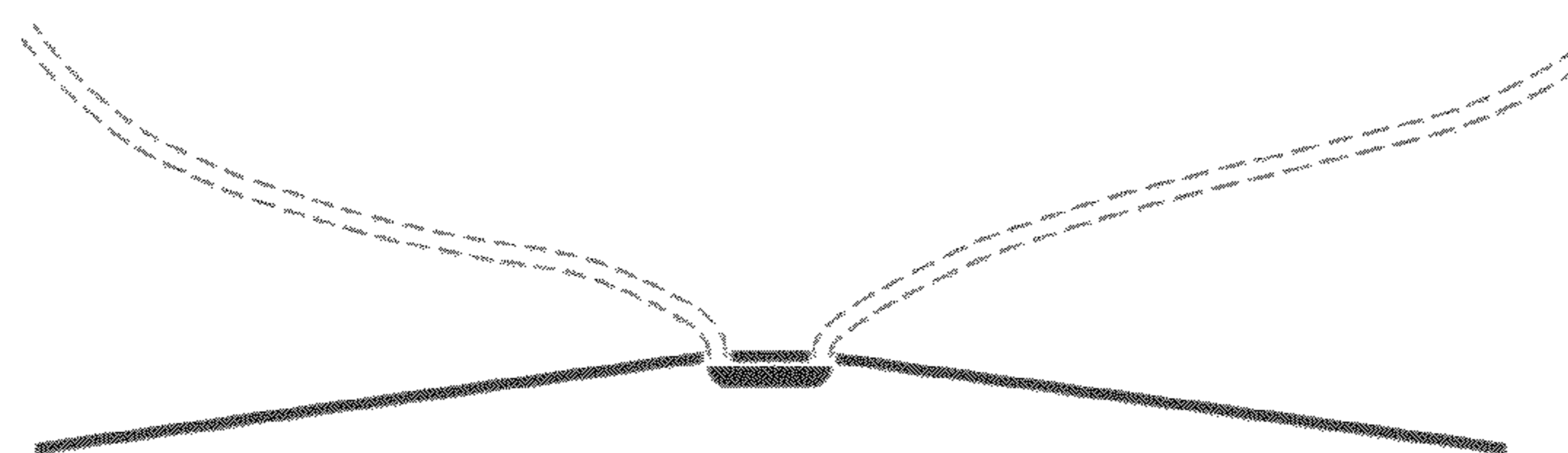

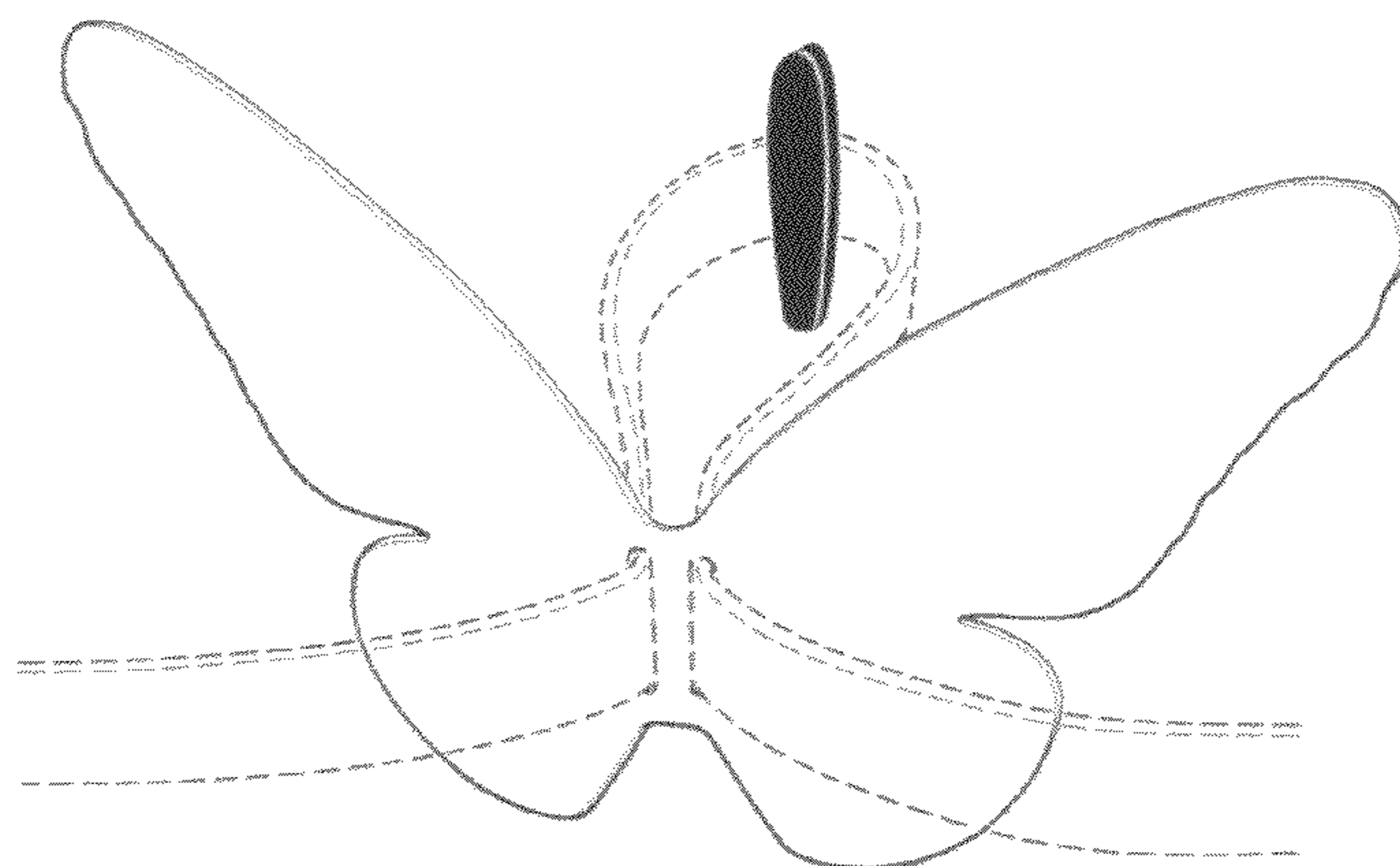
