(57) **CLAIM**

The ornamental design for pants having removable inserts, as shown and described.

DESCRIPTION

FIG. 25 is an opposite side view of the pants having removable inserts of FIG. 22, with both inserts attached to the pants.

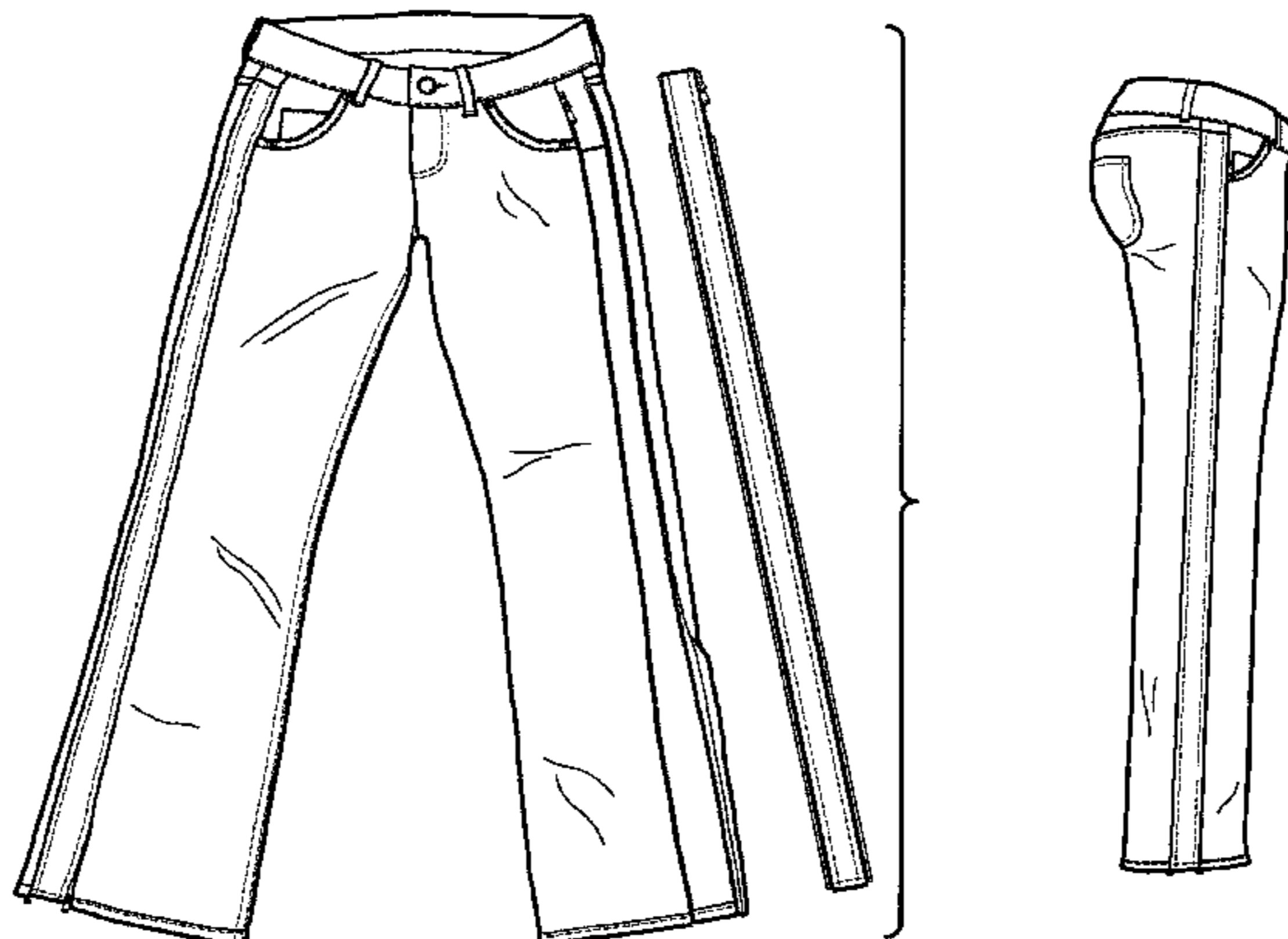
FIG. 26 is a rear view of the pants having removable inserts of FIG. 22, with both inserts attached to the pants.

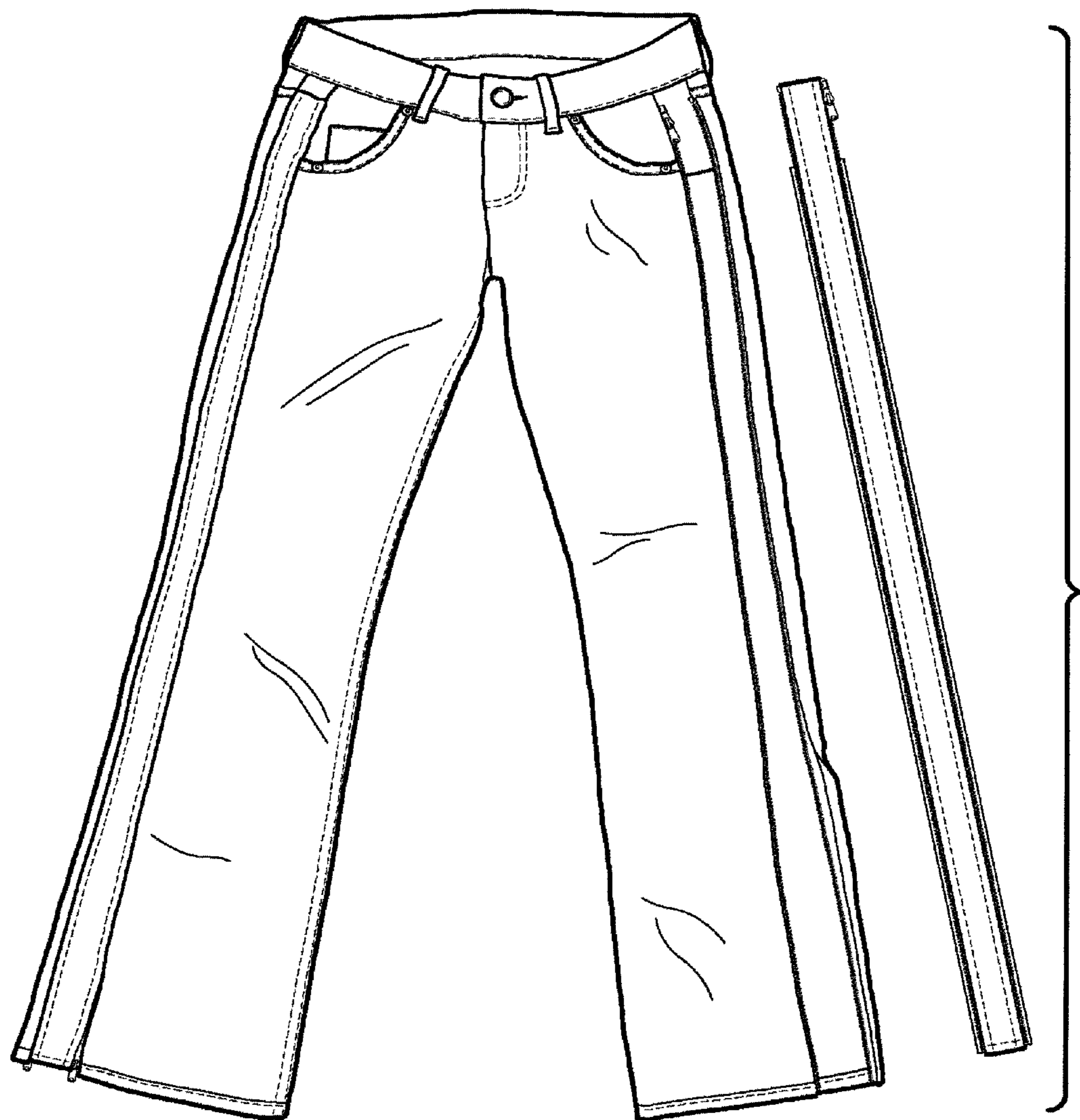

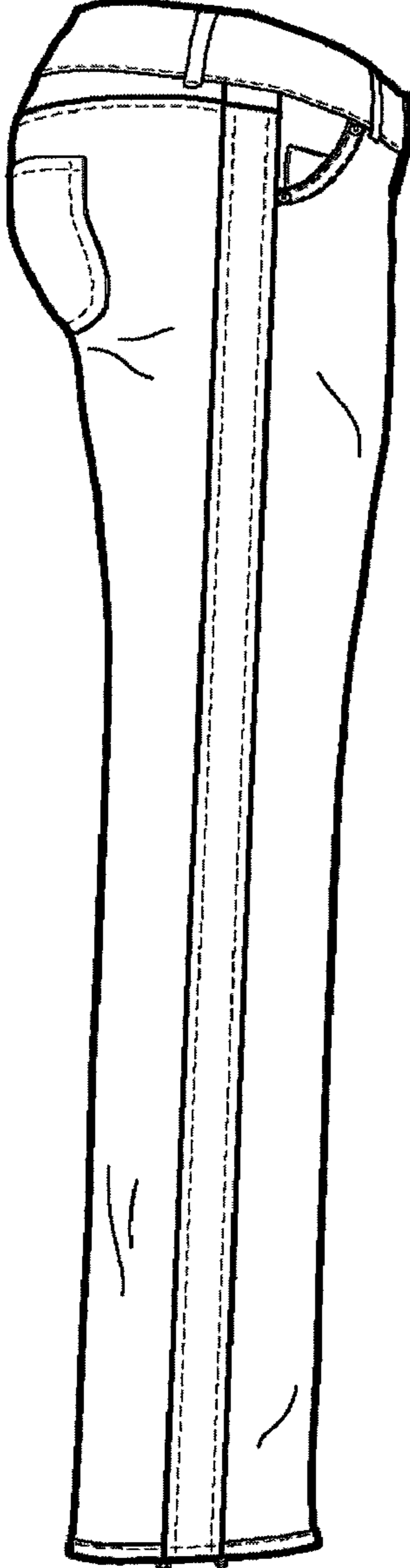

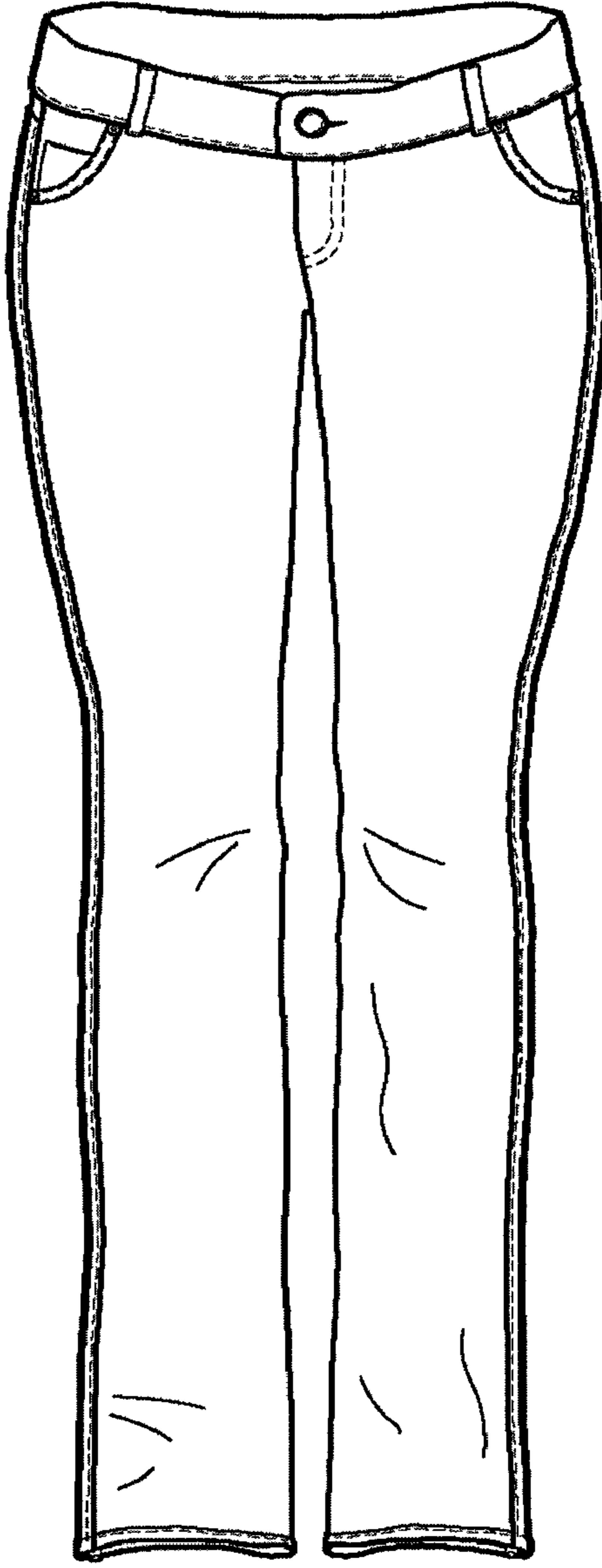

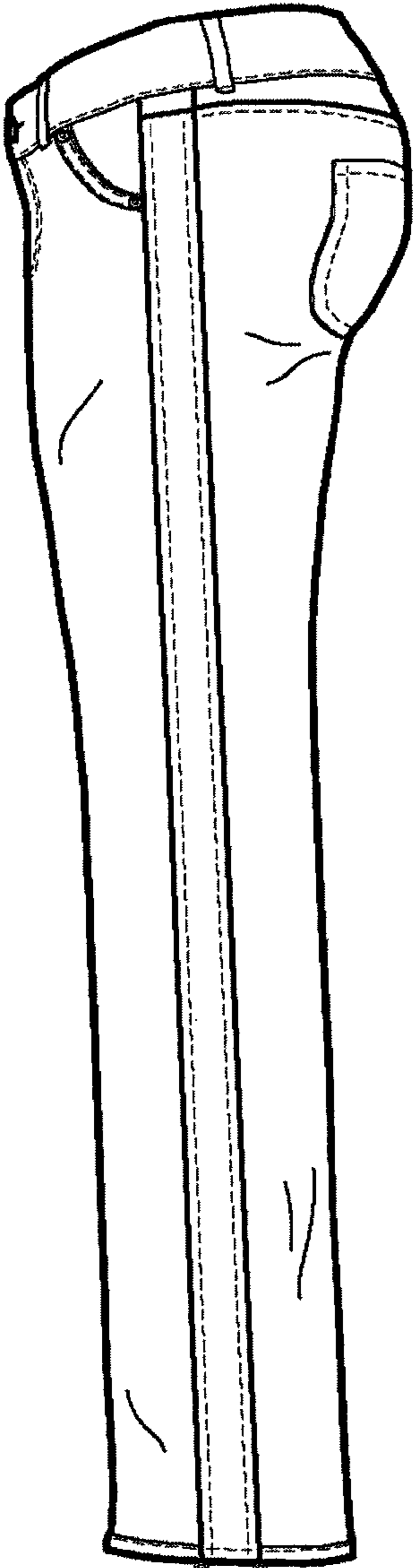

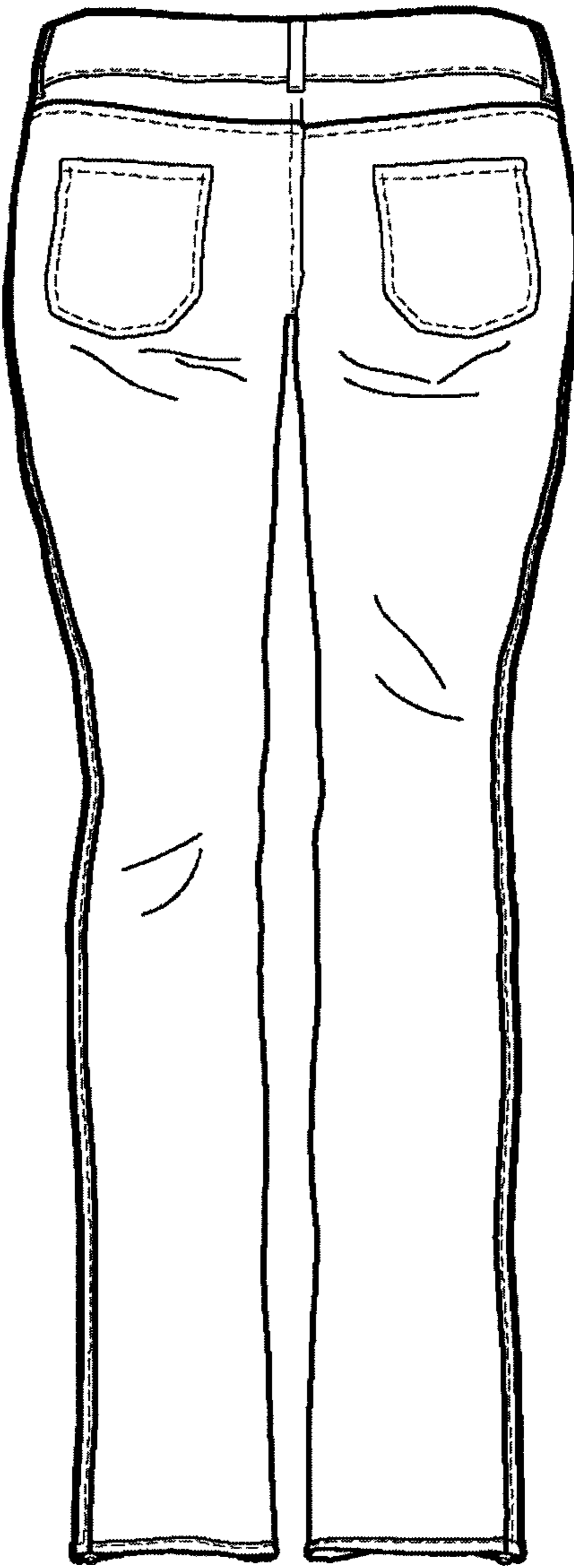

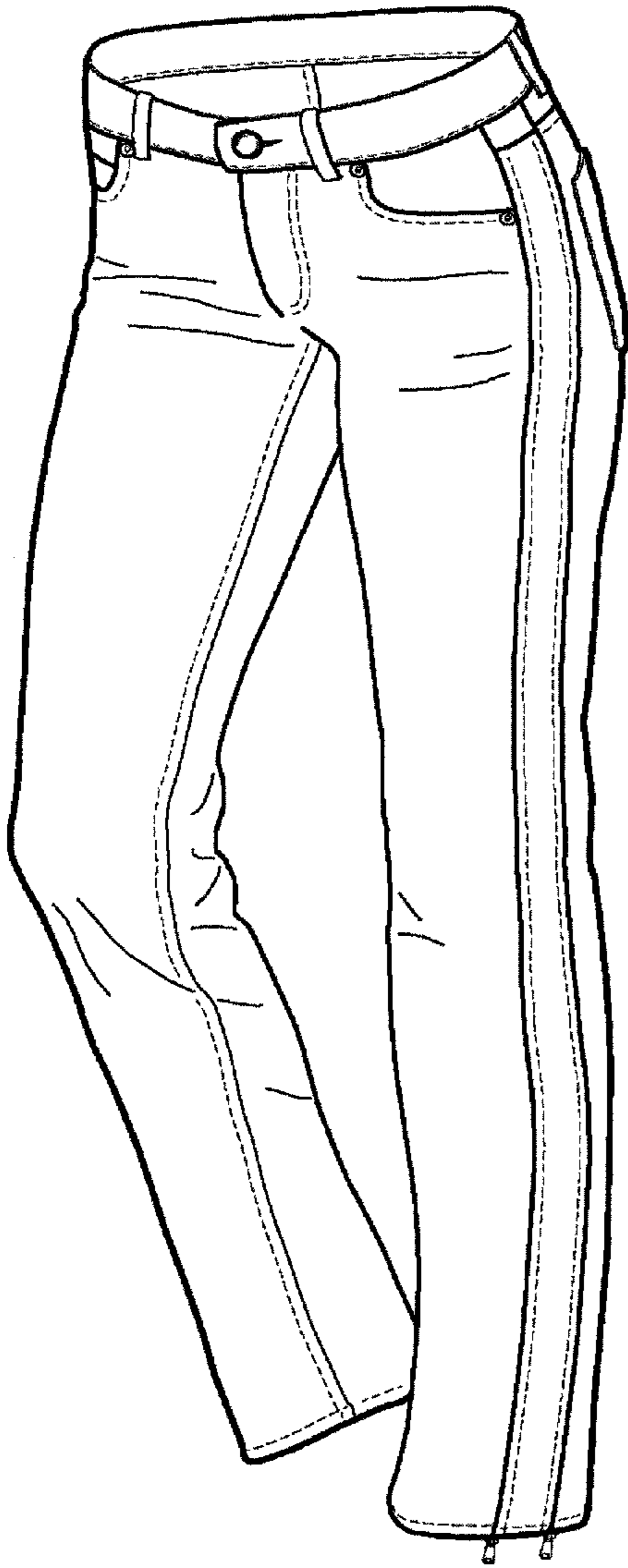

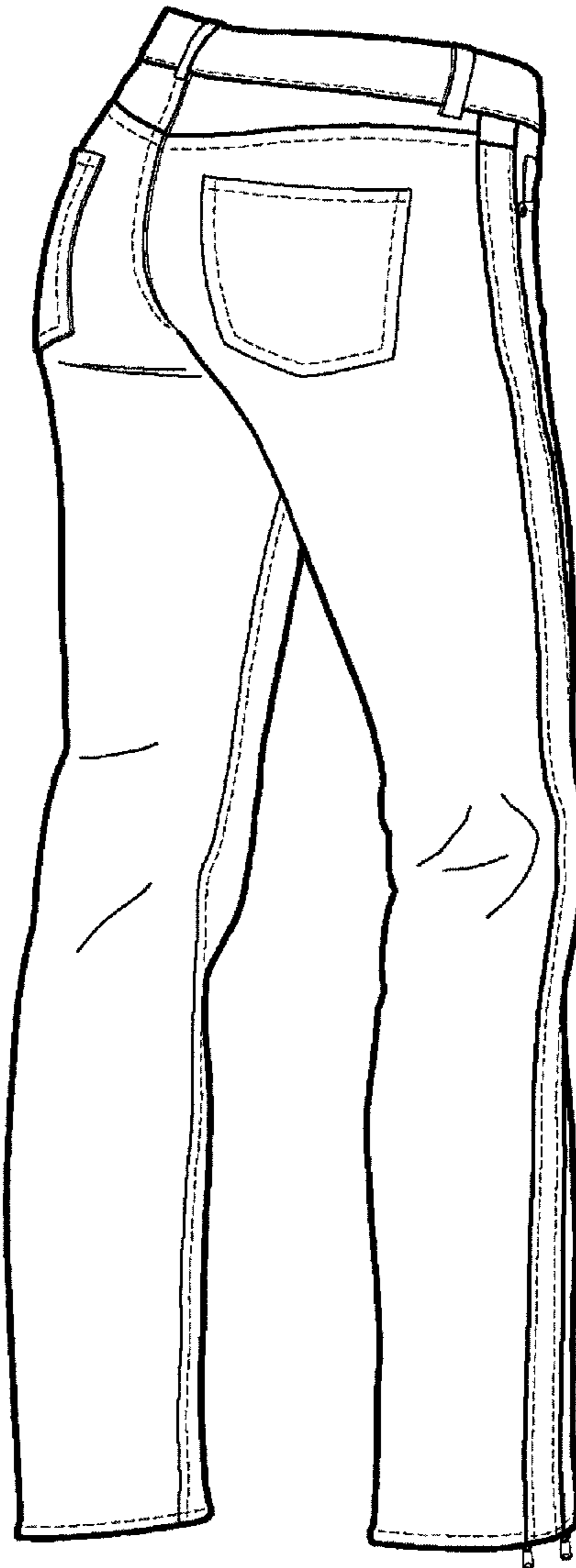

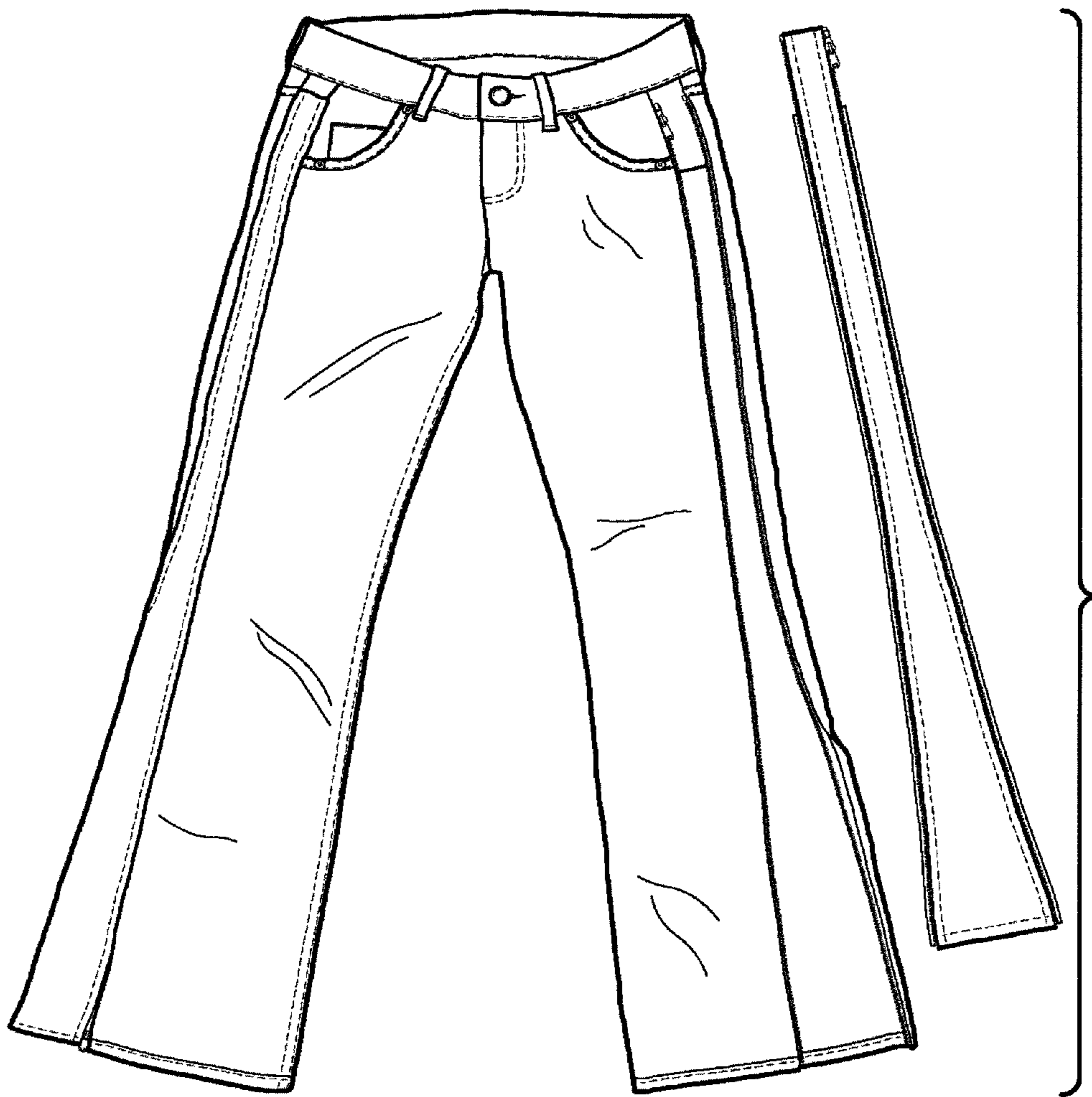

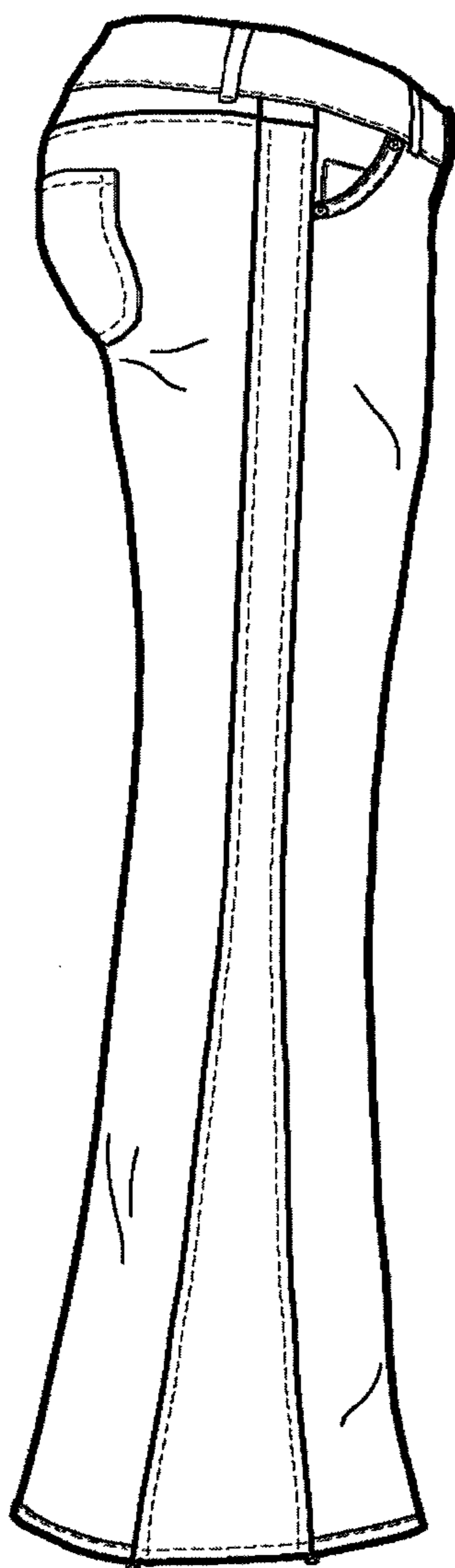

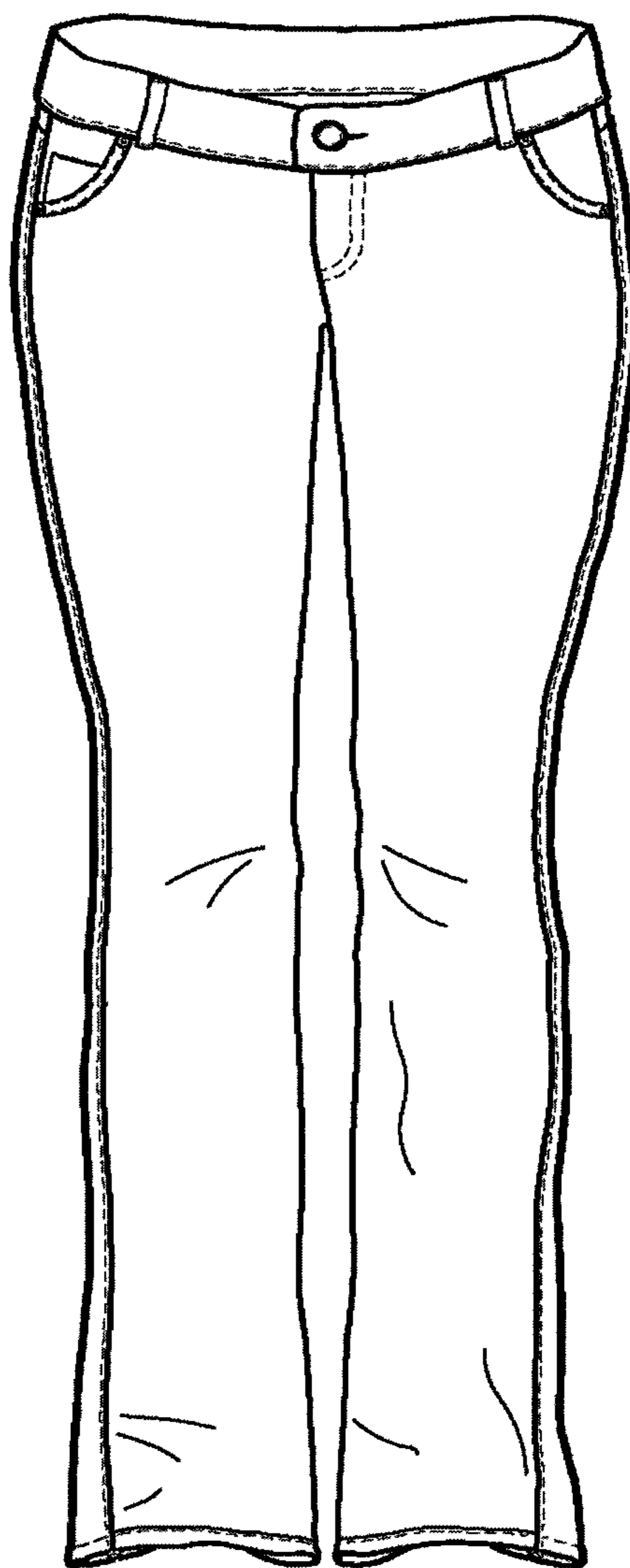

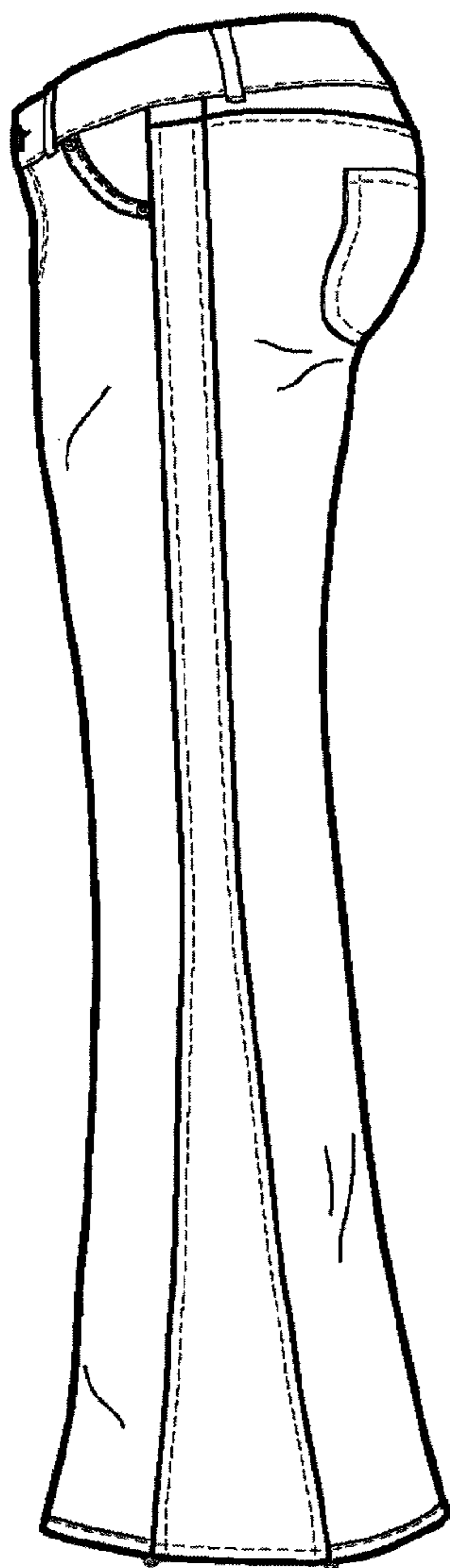

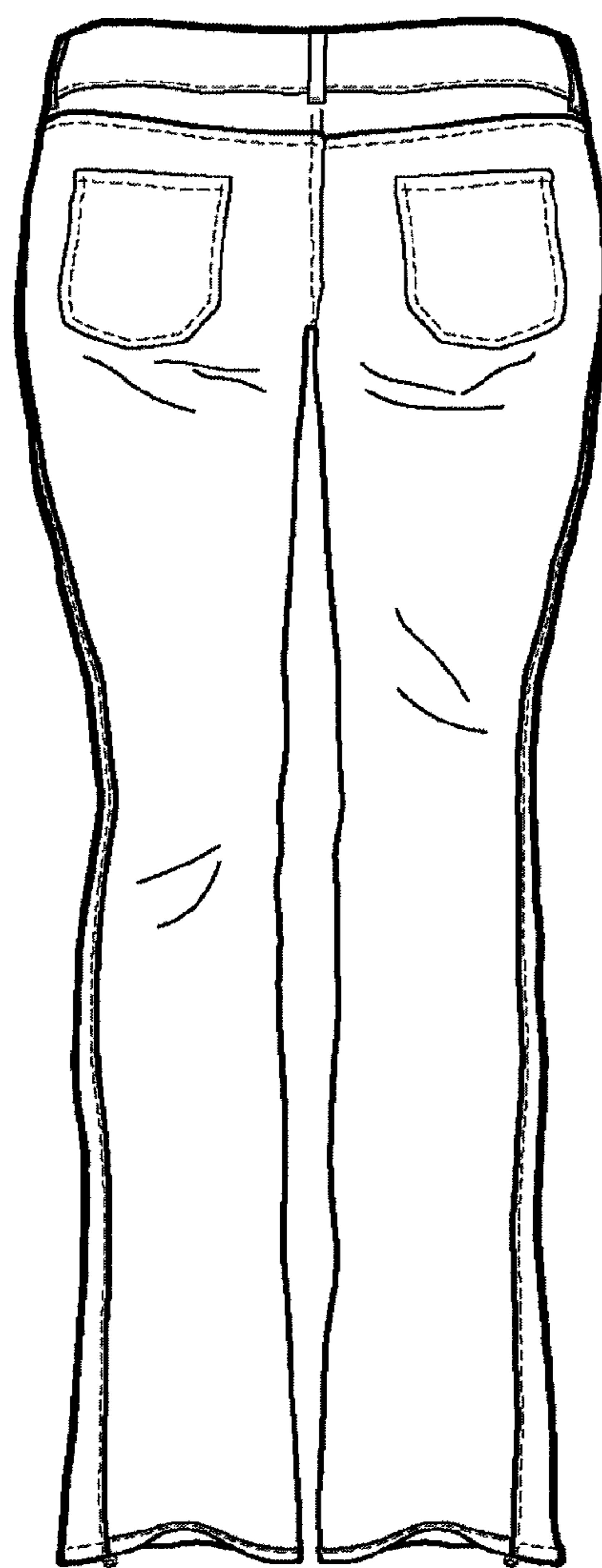

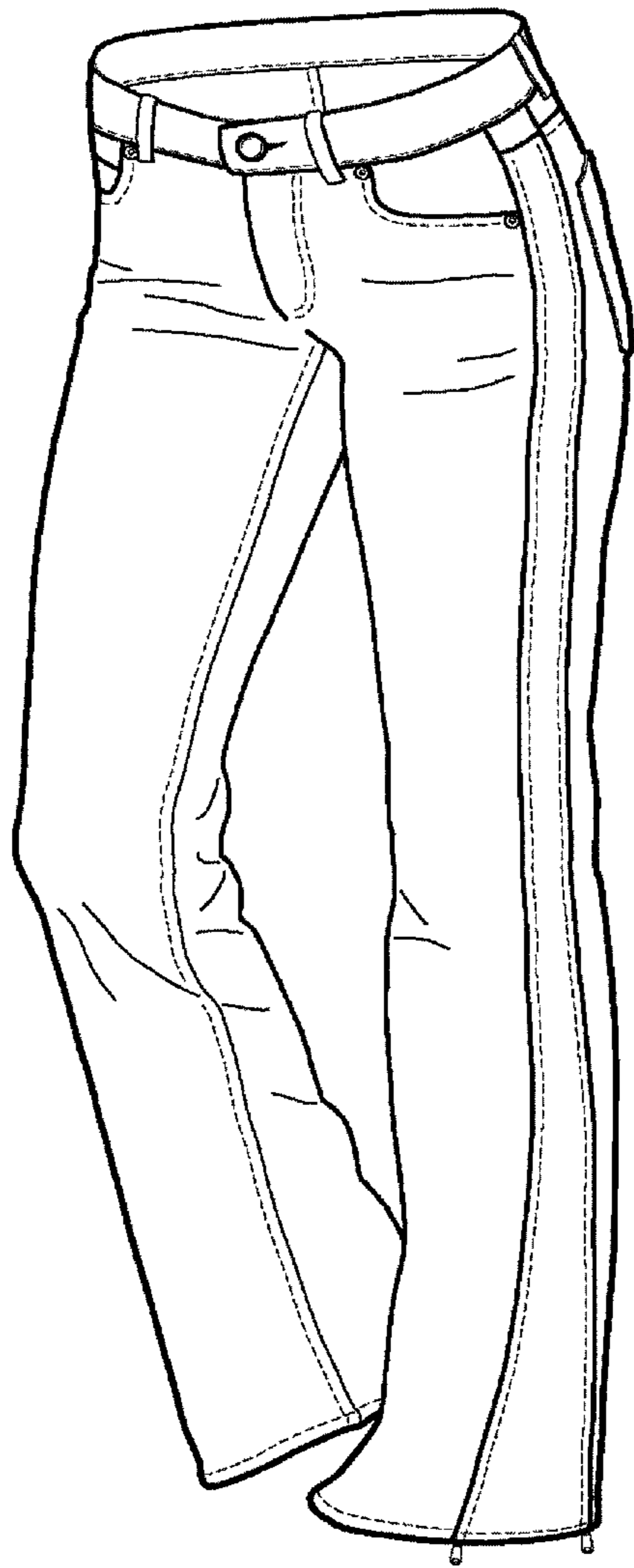

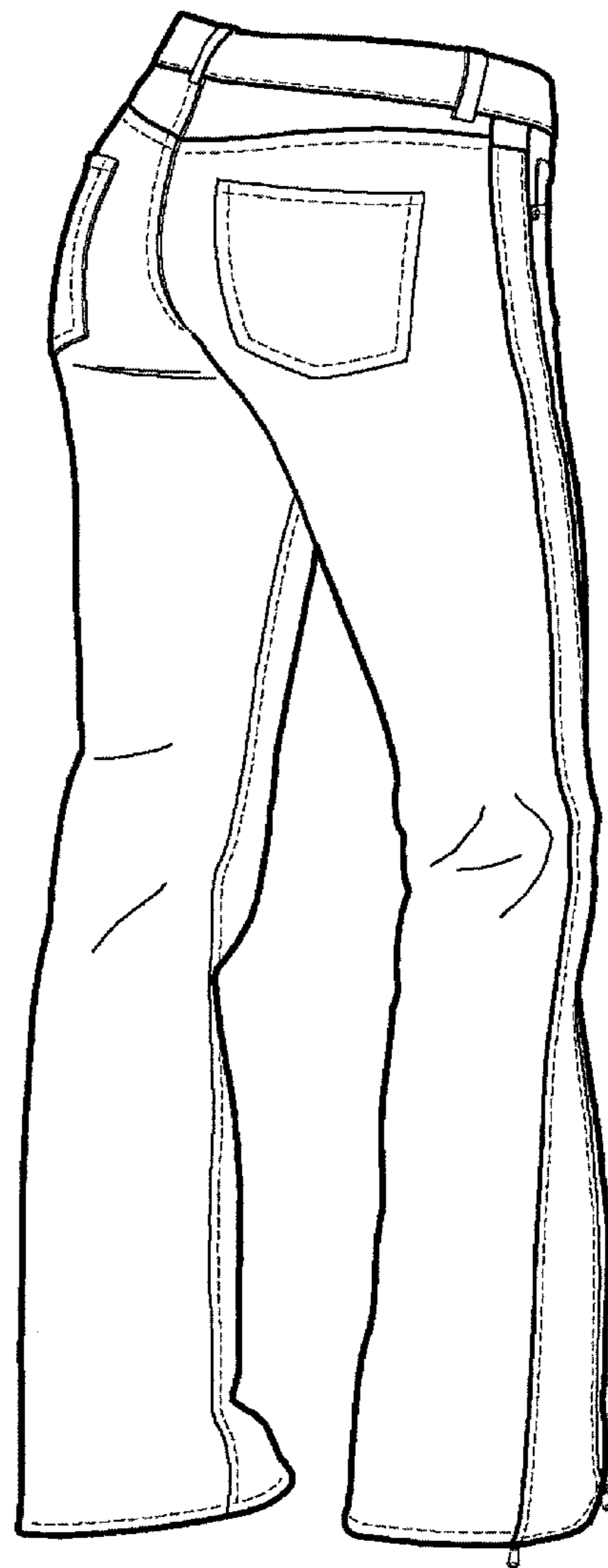

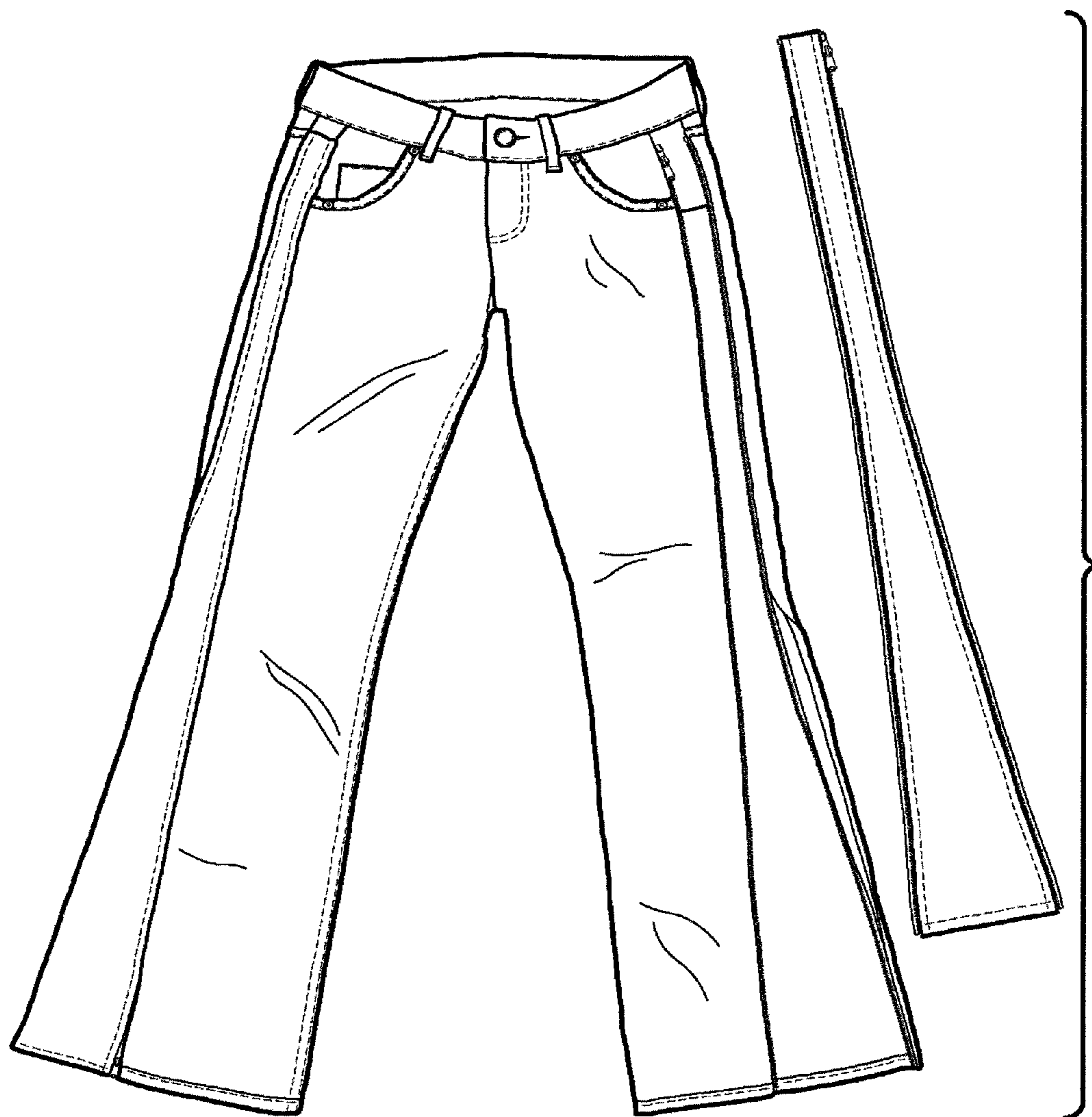

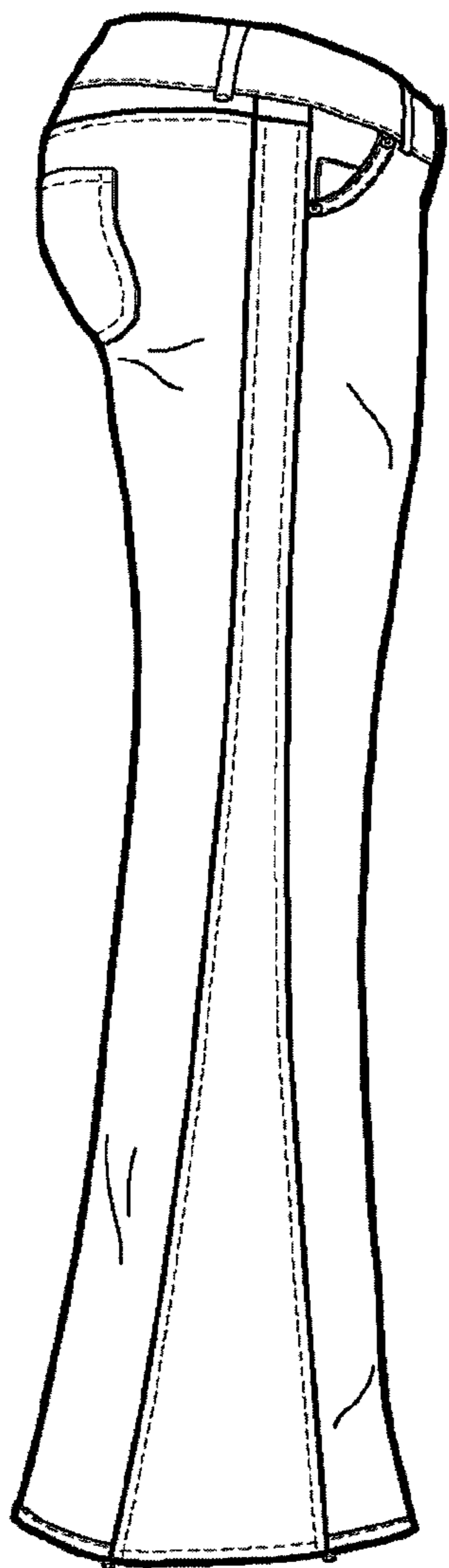

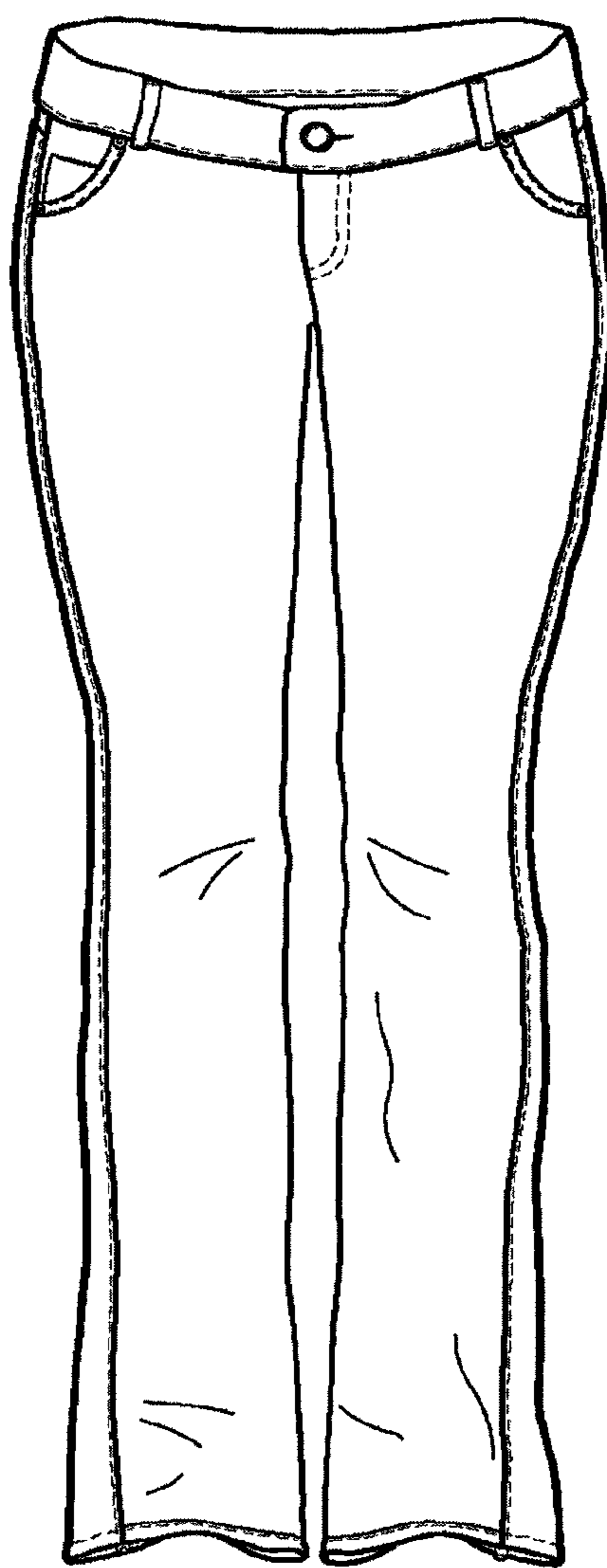

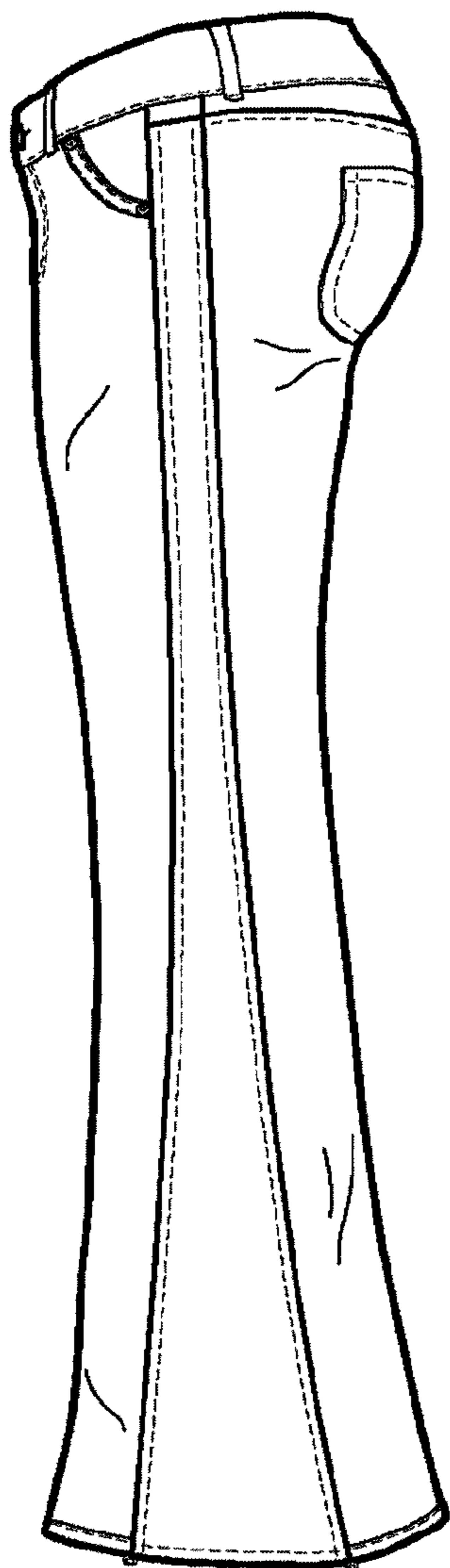

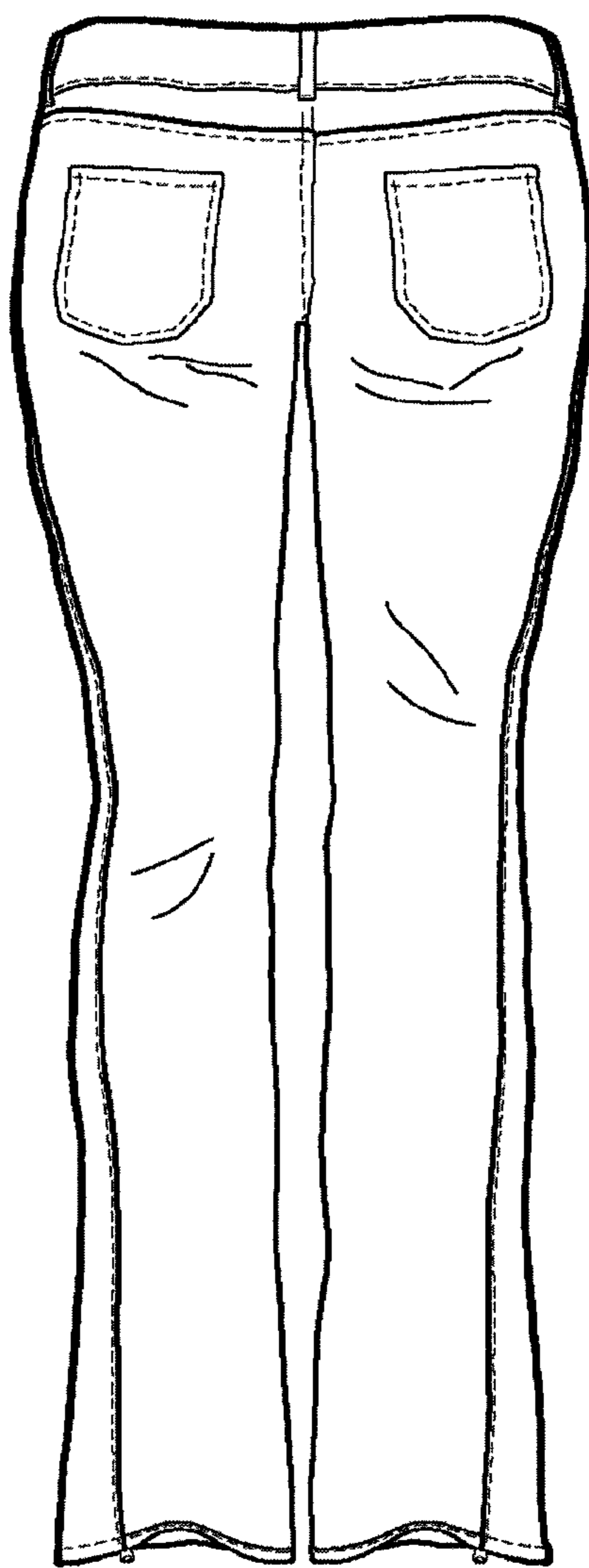

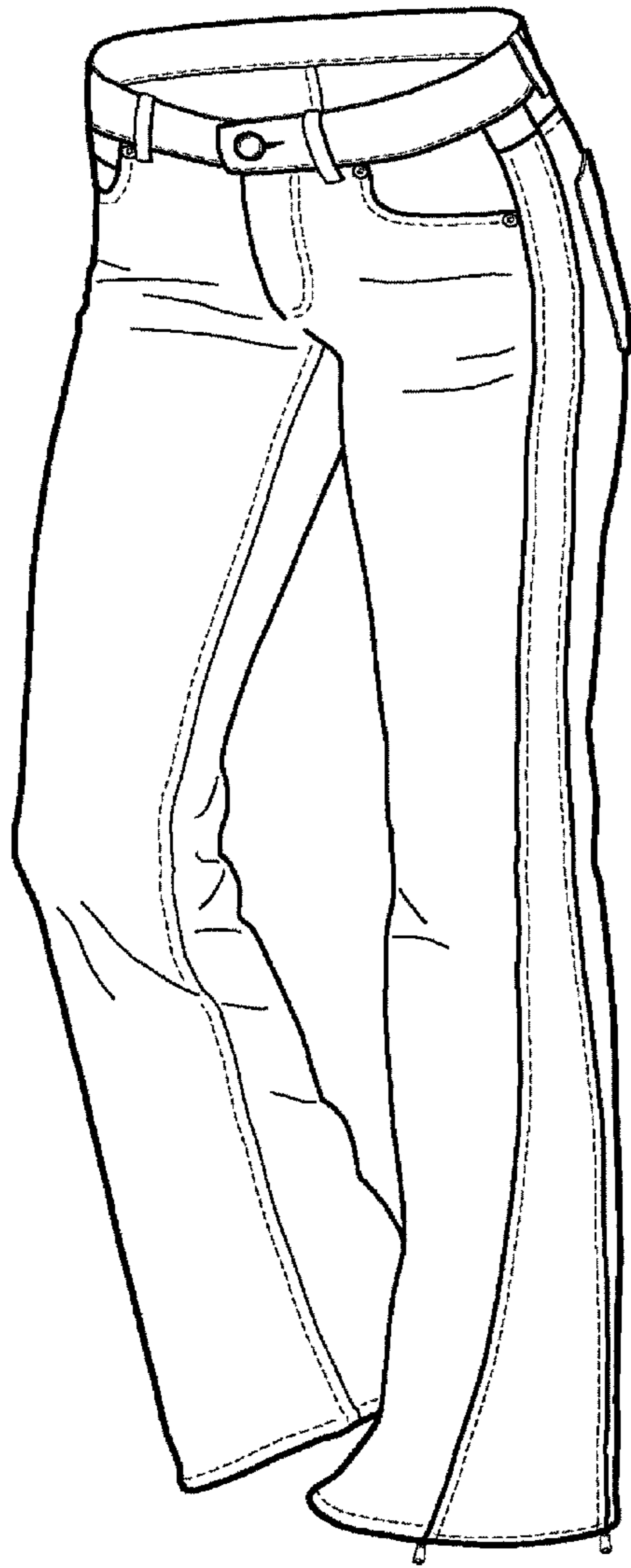

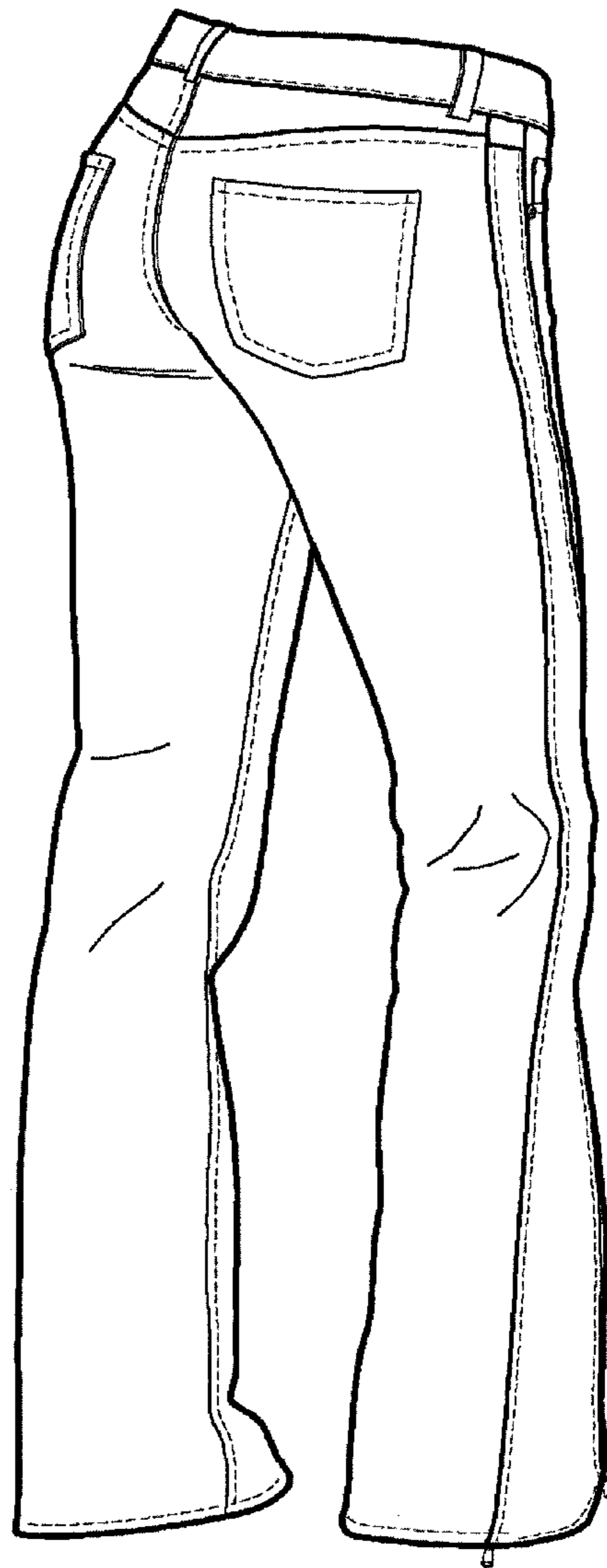

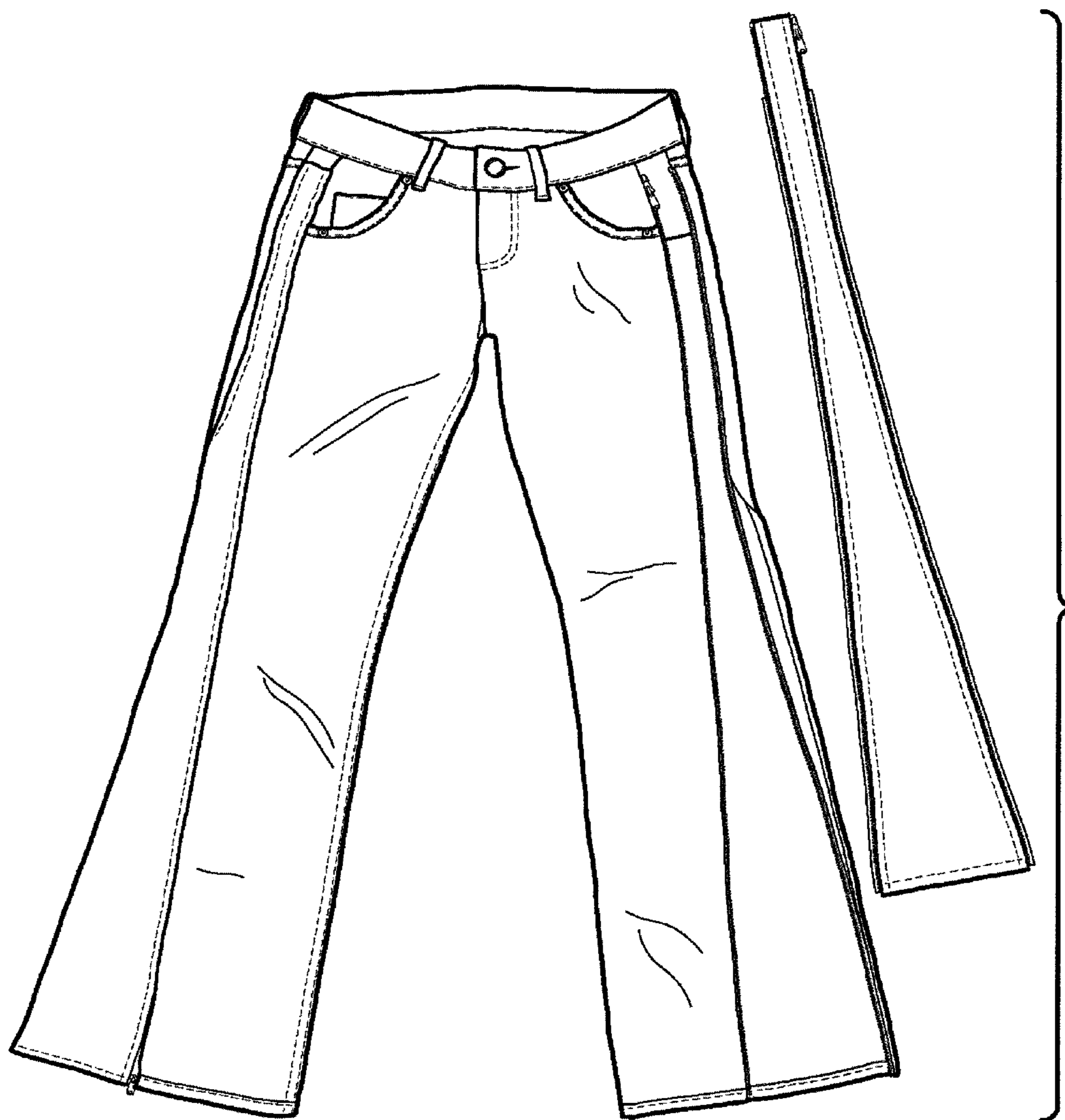

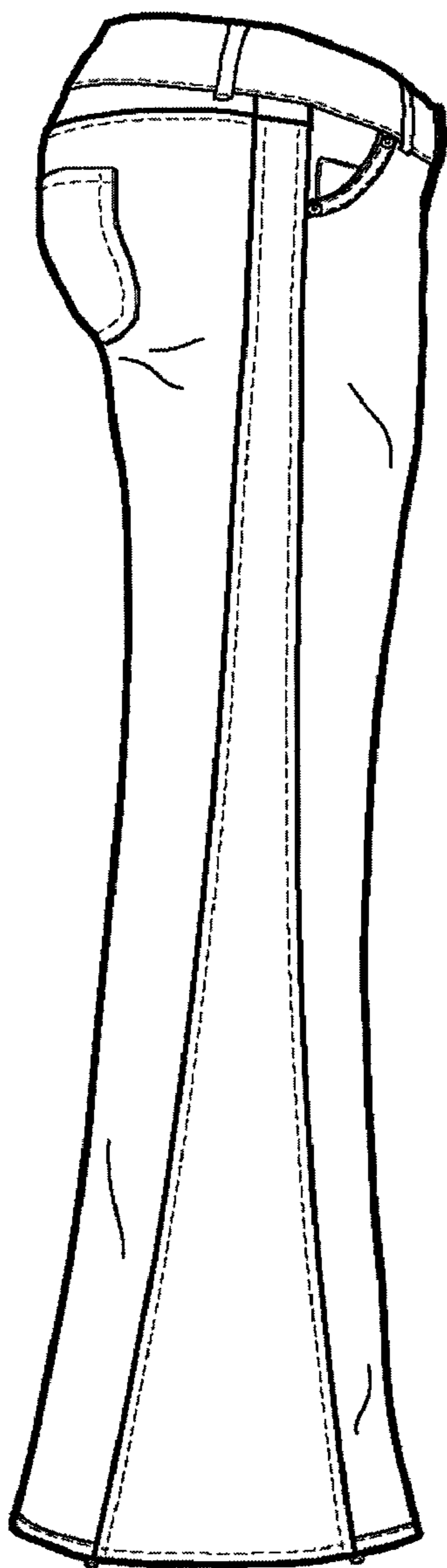

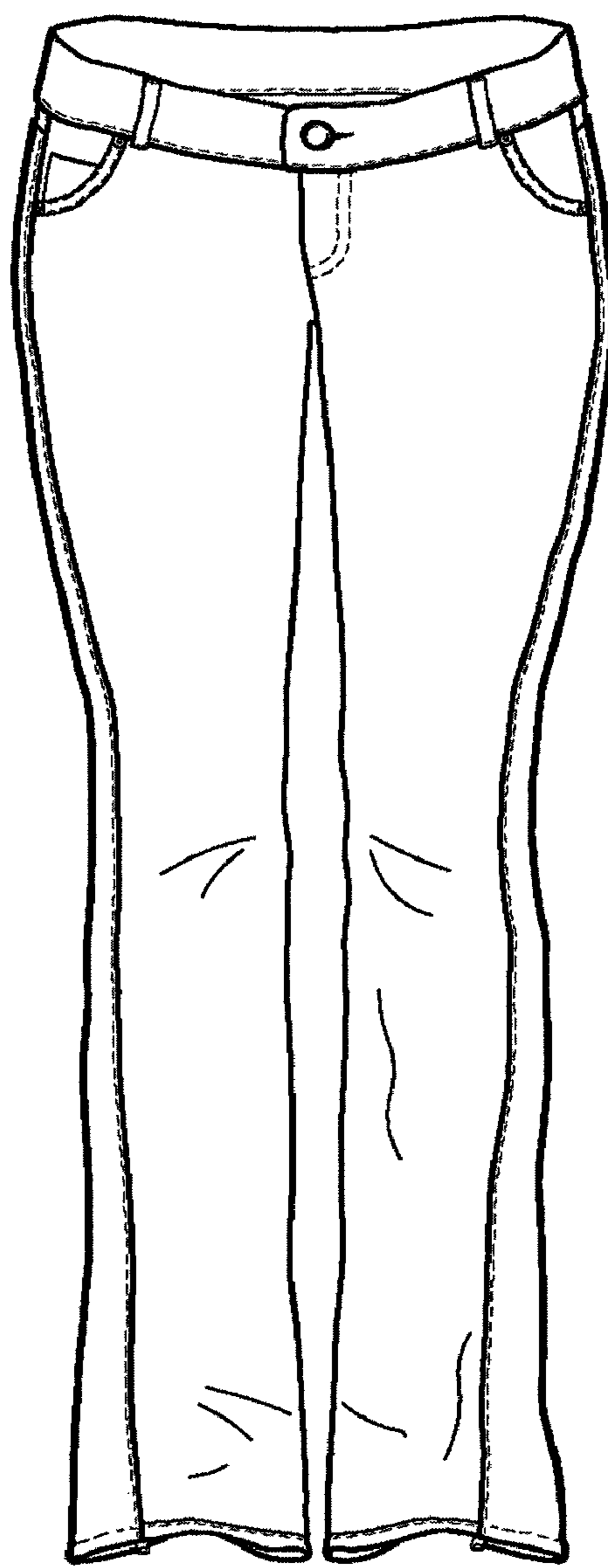

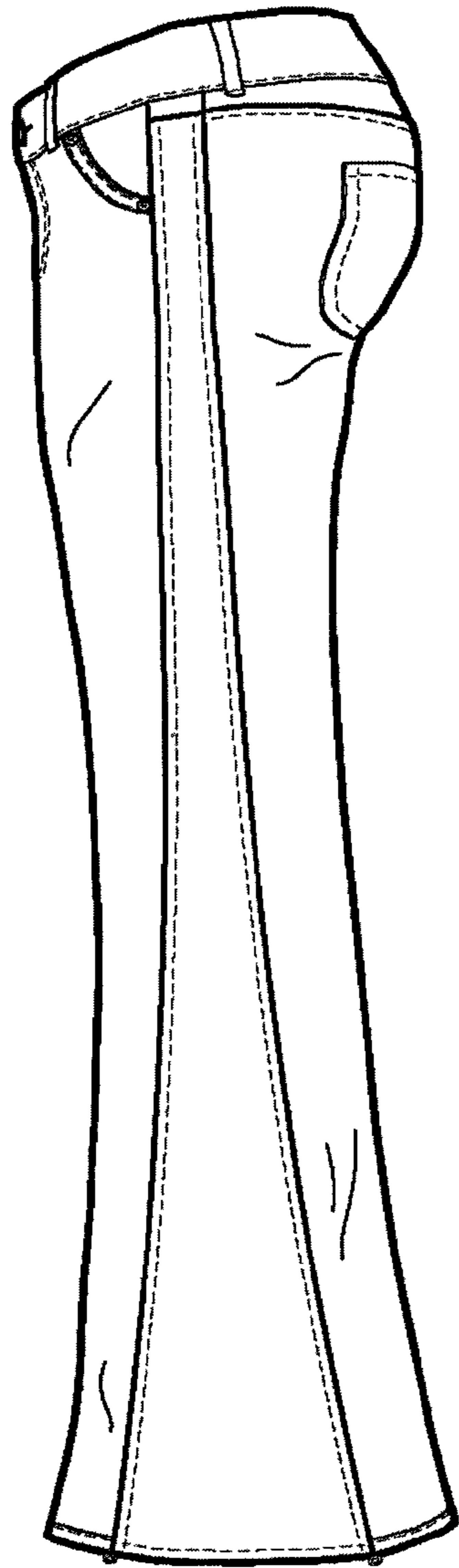

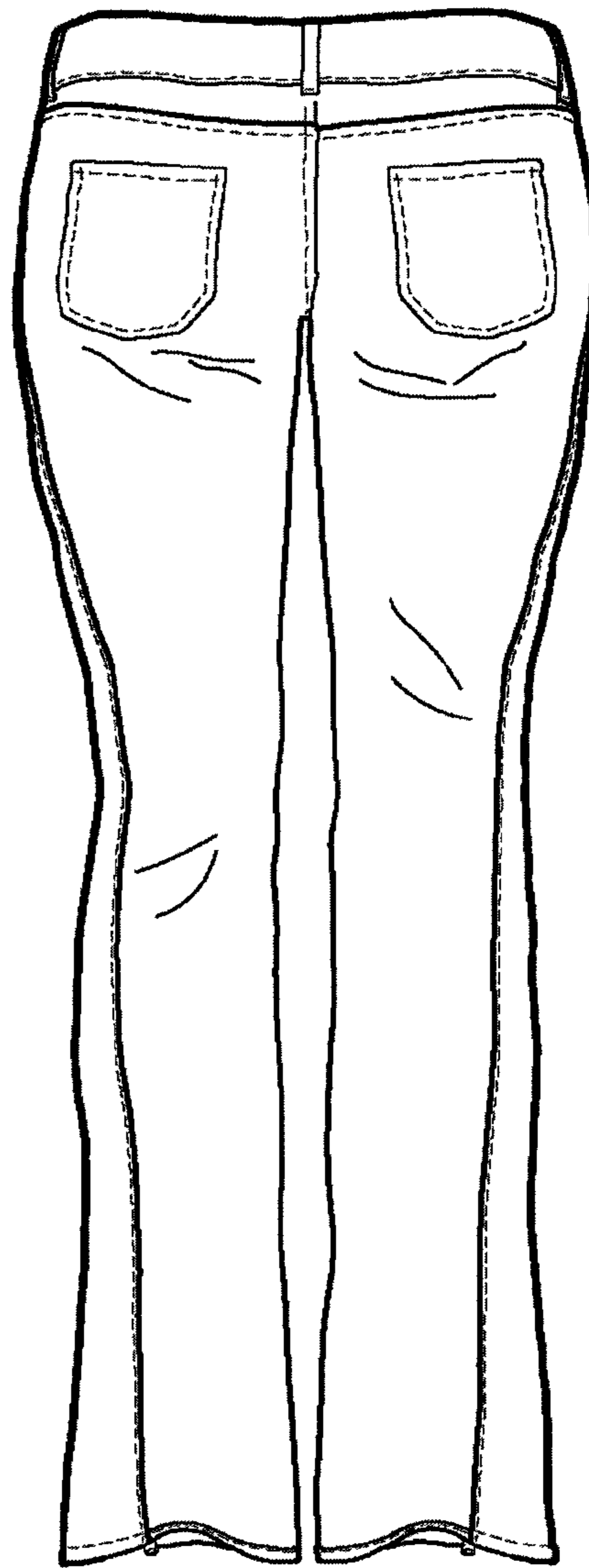

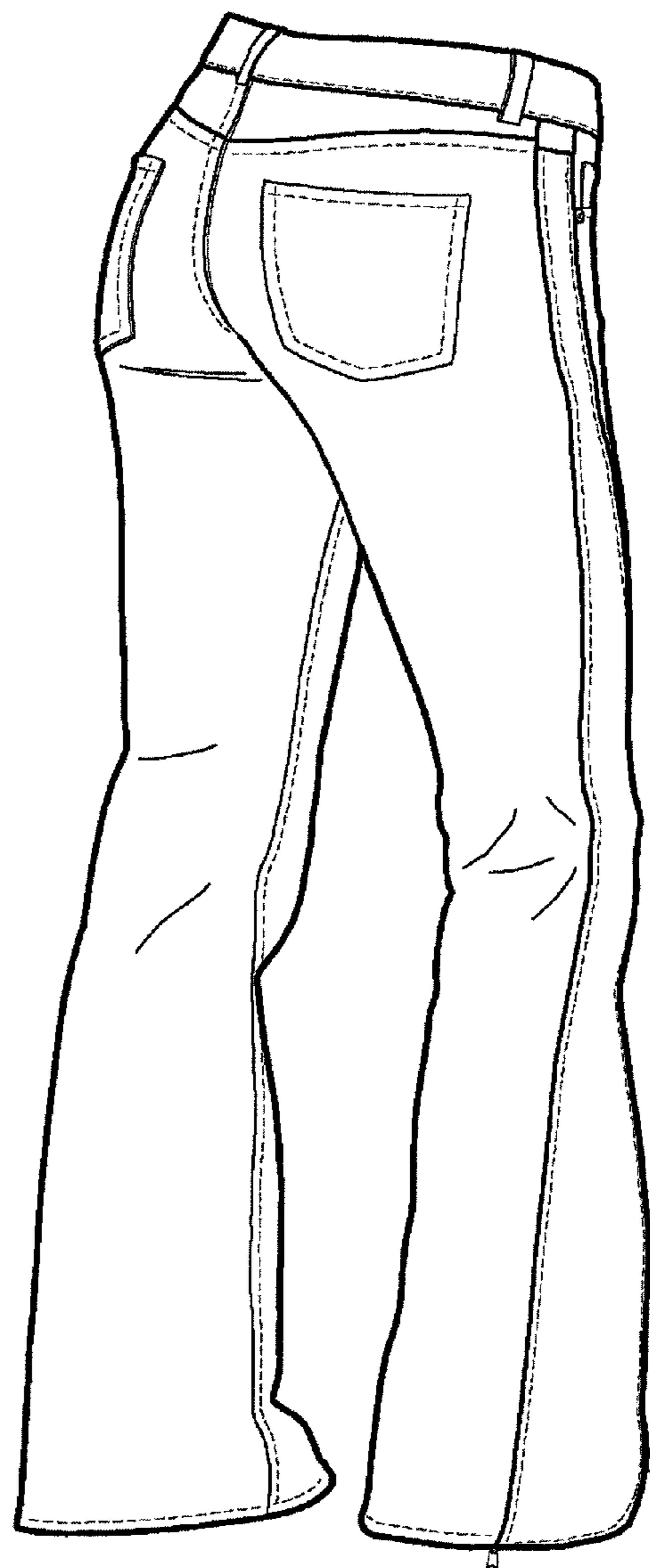
