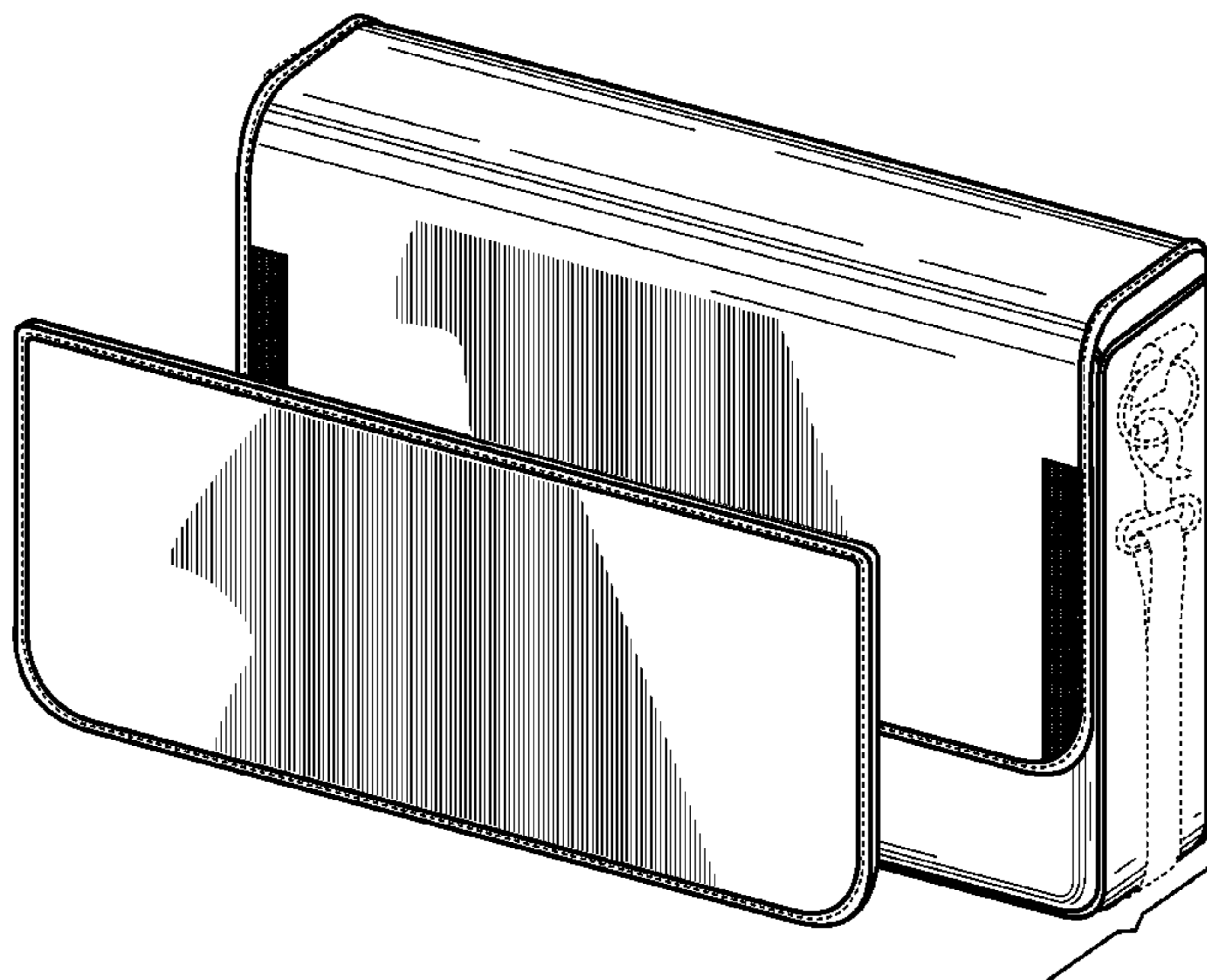
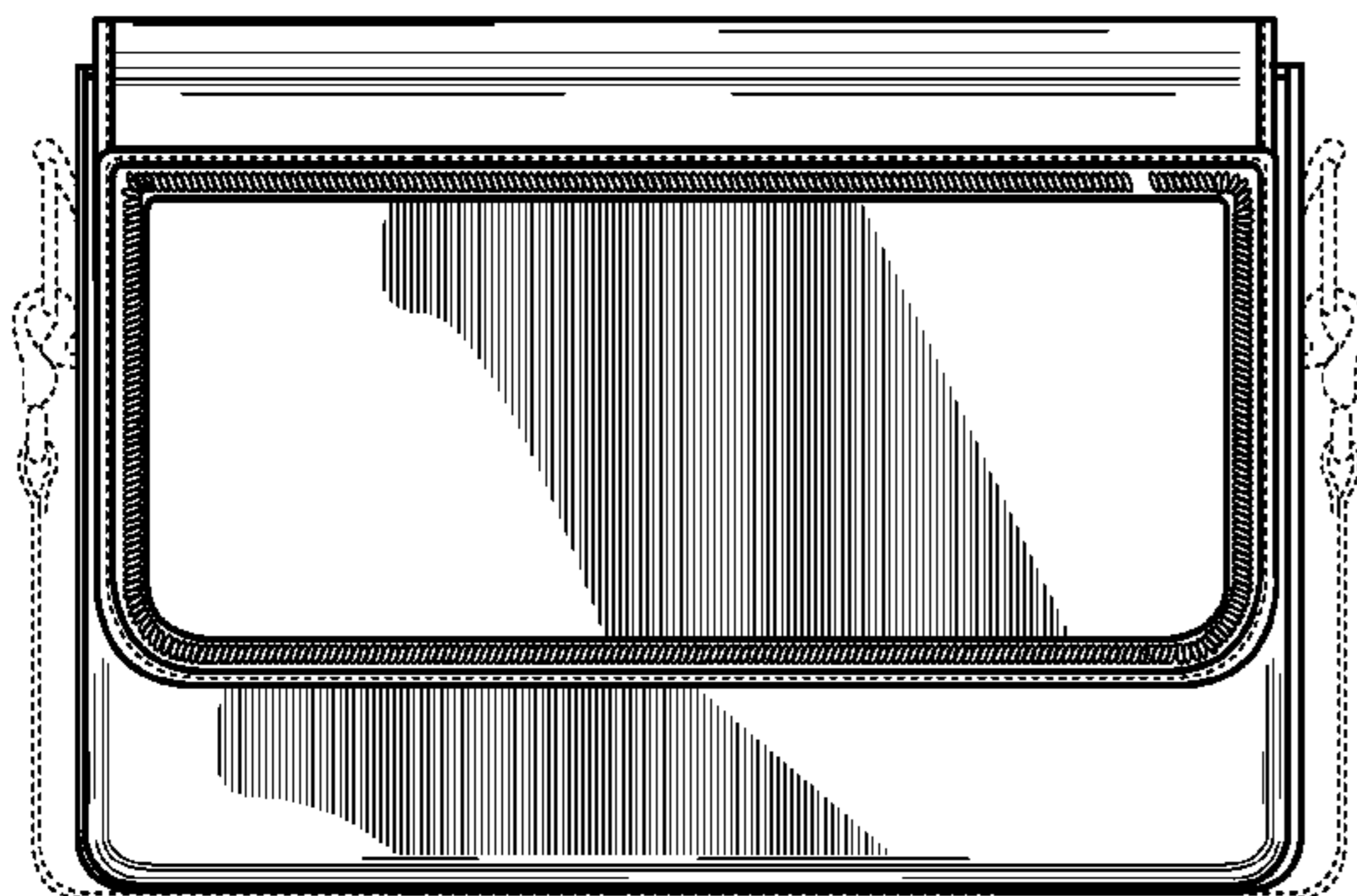
(57) **CLAIM**

We claim the ornamental design for a handbag with interchangeable decorative panels, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the “handbag with interchangeable decorative panels” showing our new design;
 FIG. 2 is a front view of the handbag with interchangeable decorative panels shown in FIG. 1 showing a panel with a houndstooth design panel affixed to the flap of the handbag;
 FIG. 3 is an upper front exploded view of the handbag with interchangeable decorative panels shown in FIG. 1;
 FIG. 4 is a front view of the handbag with interchangeable decorative panels shown in FIG. 1 with the flap opened up;
 FIG. 5 is a top view of the handbag with interchangeable decorative panels shown in FIG. 1;

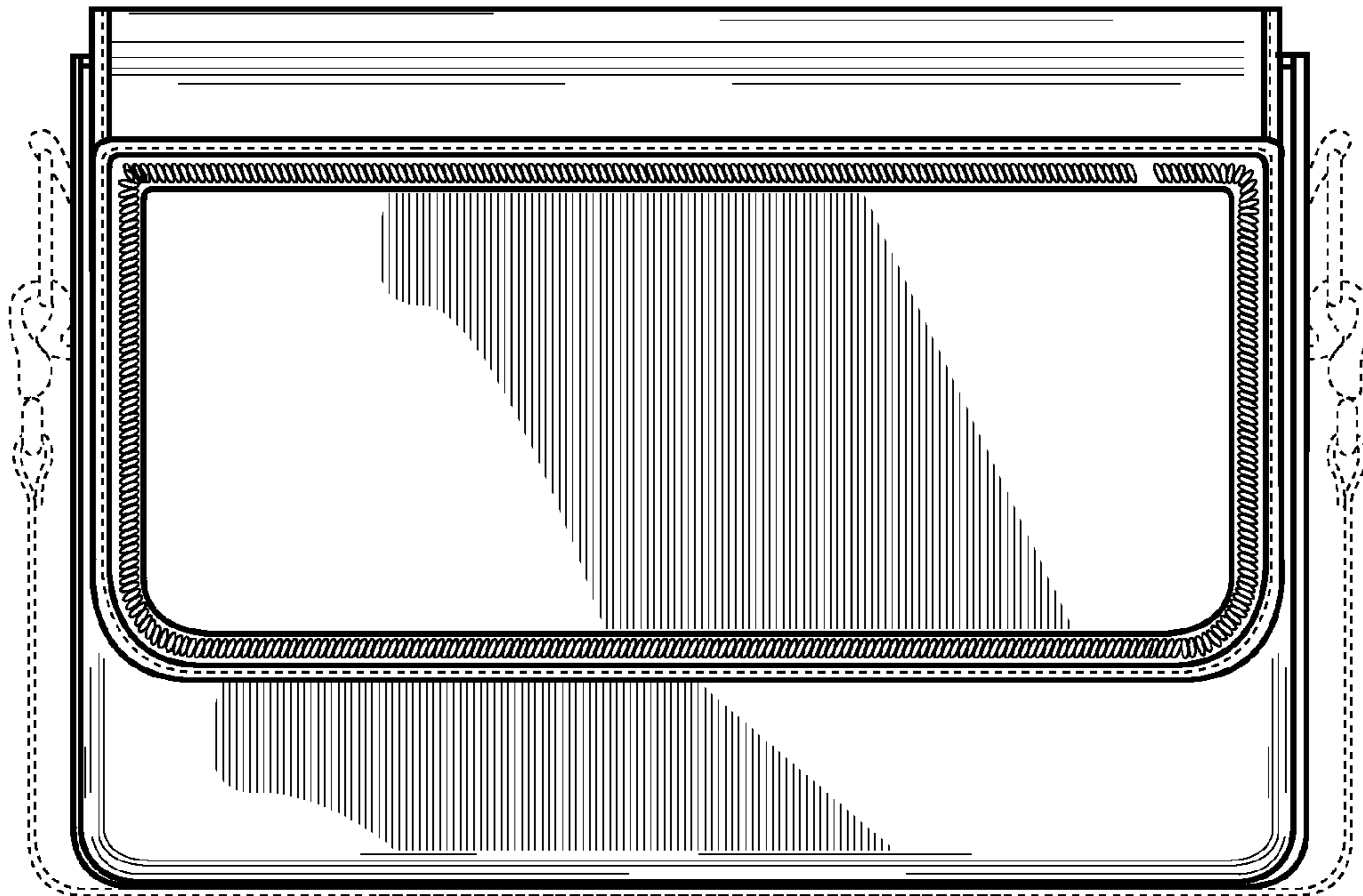

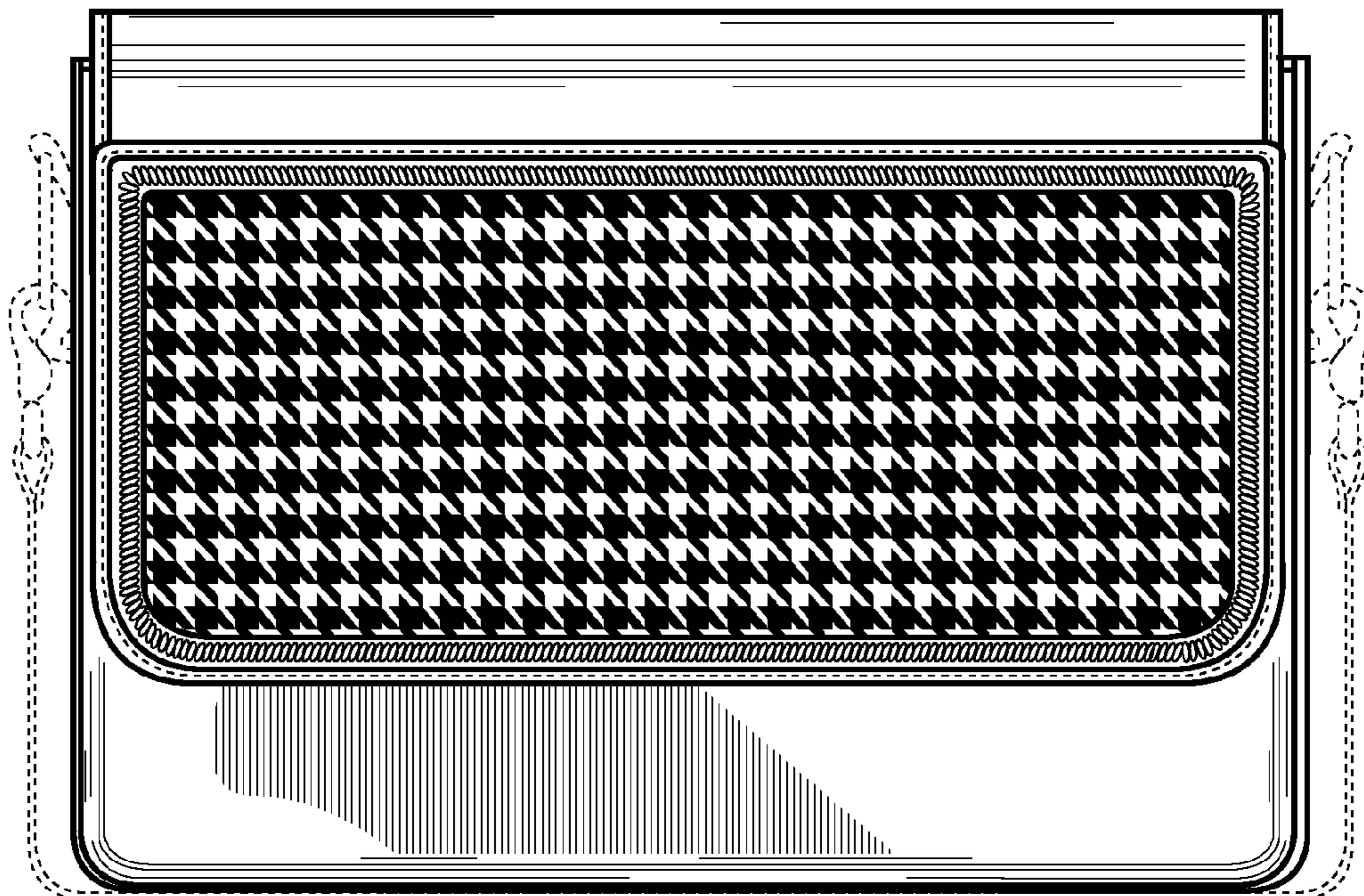

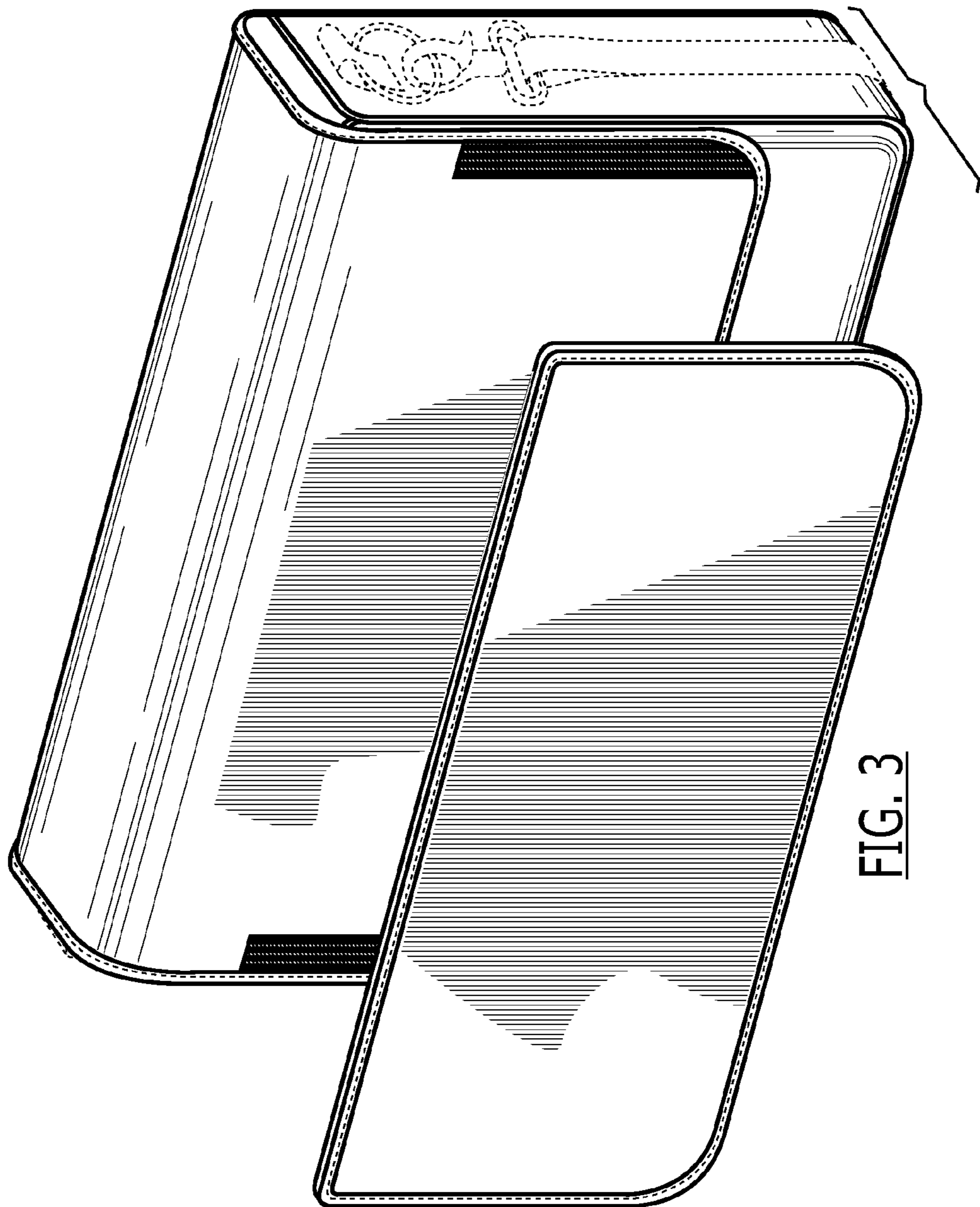

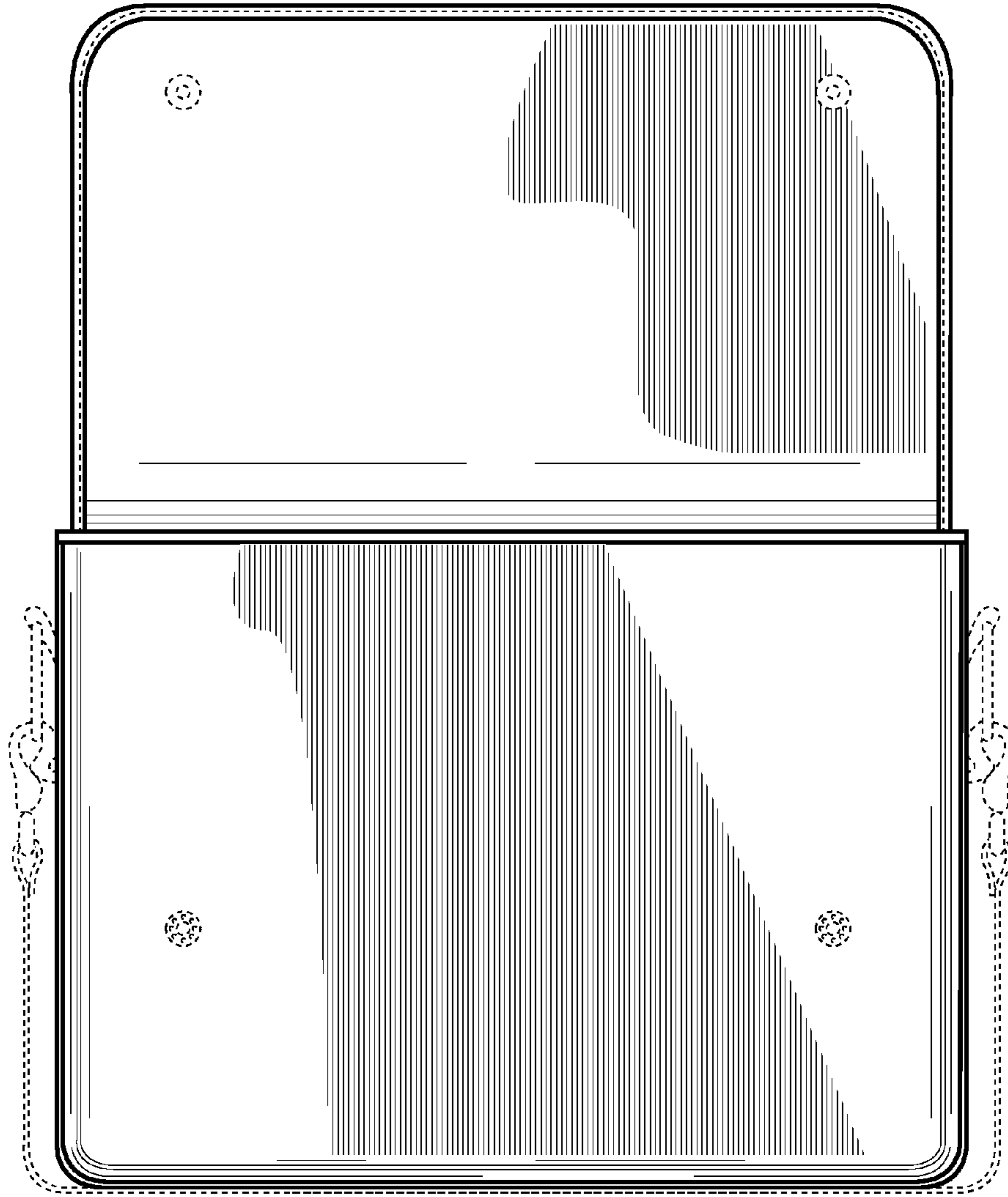

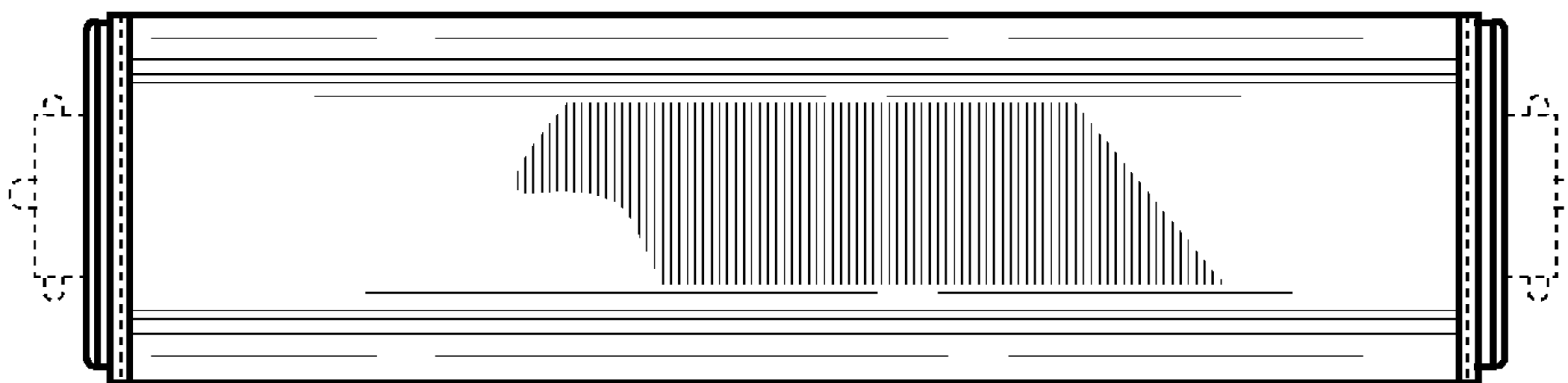

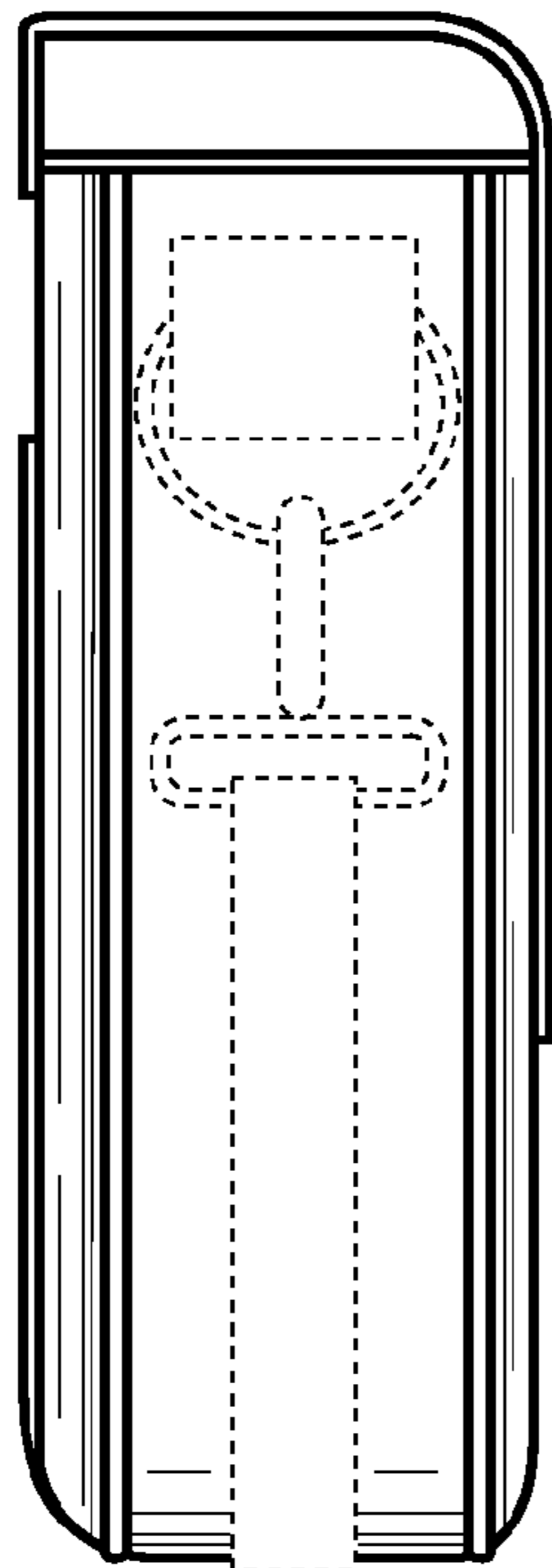

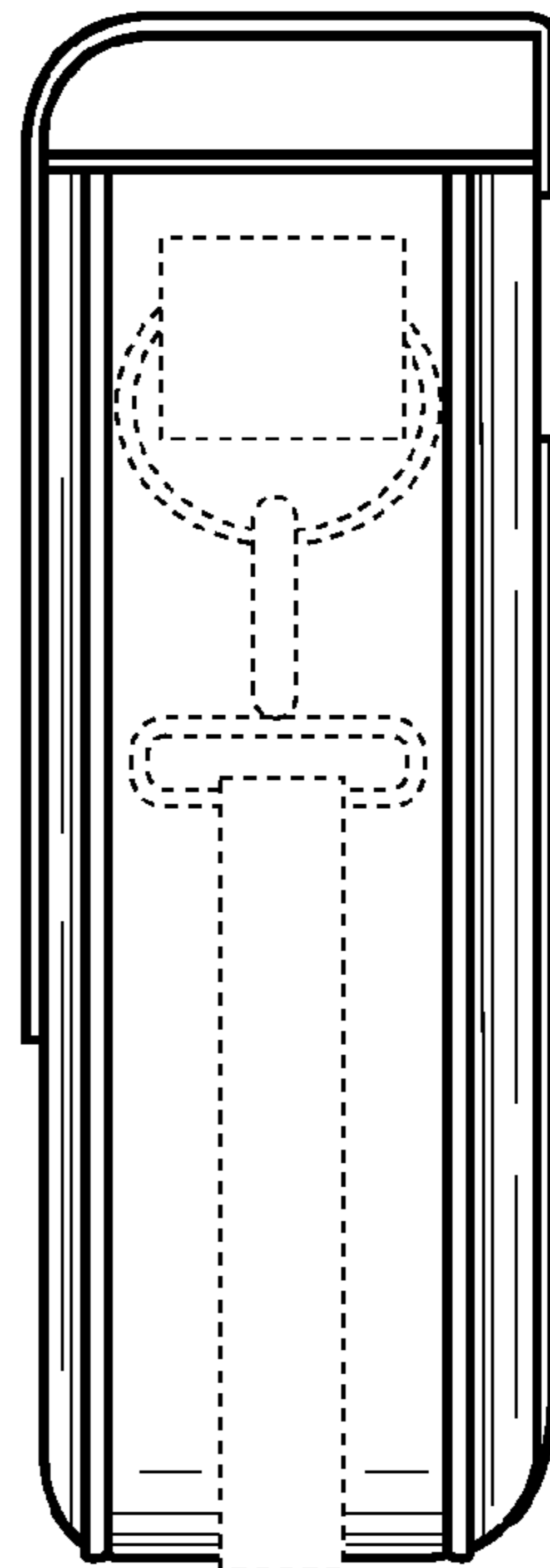

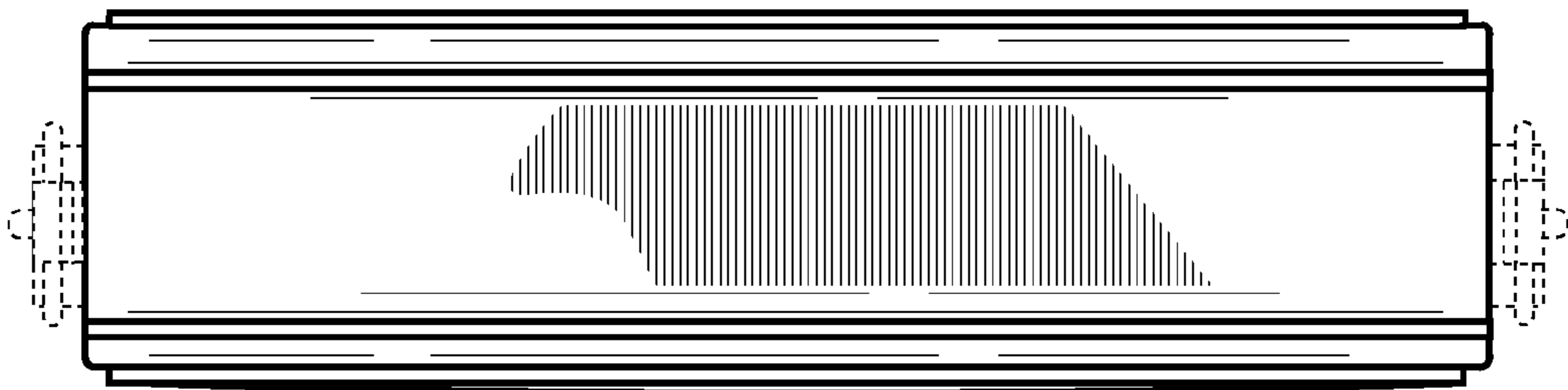

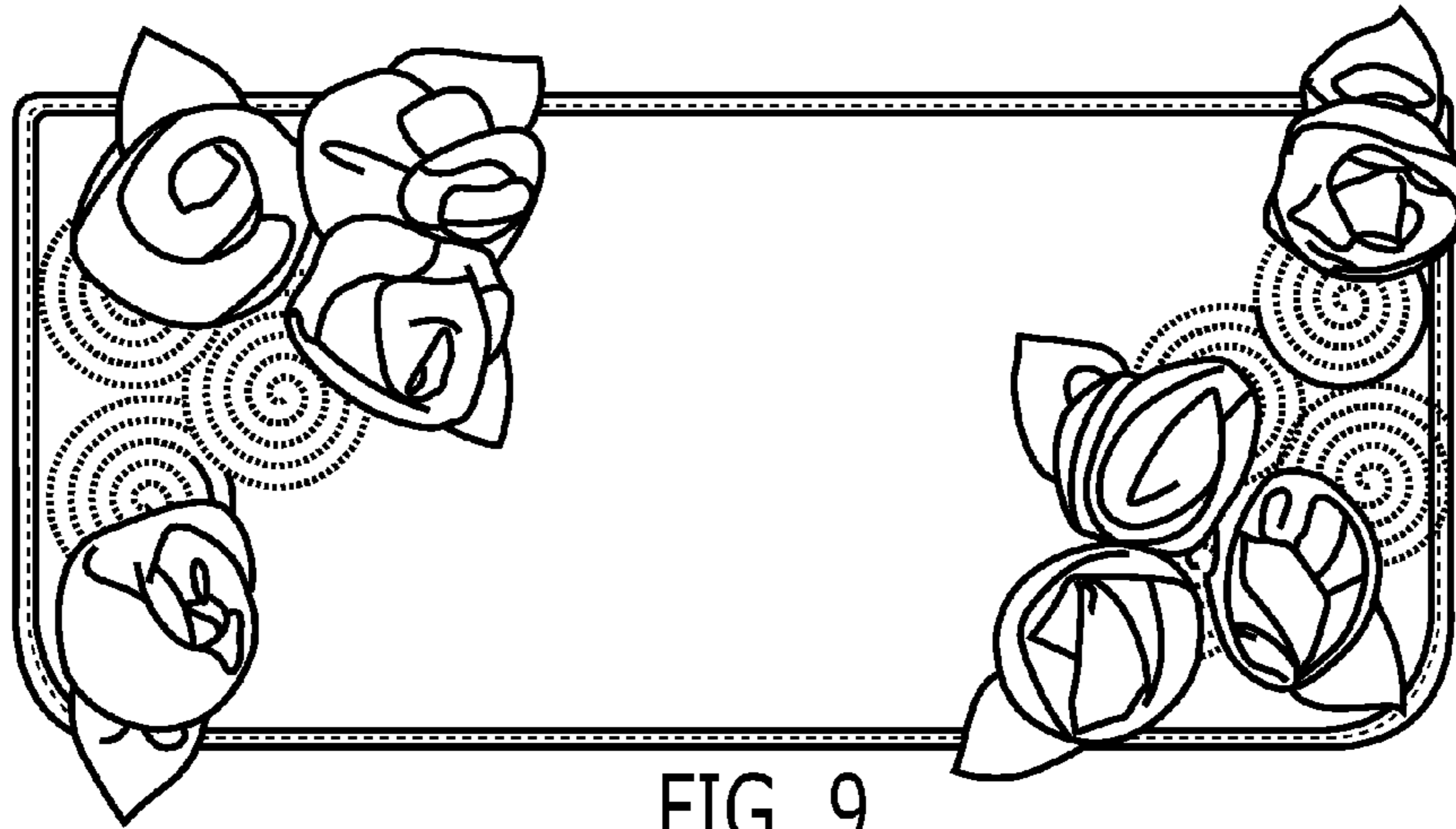

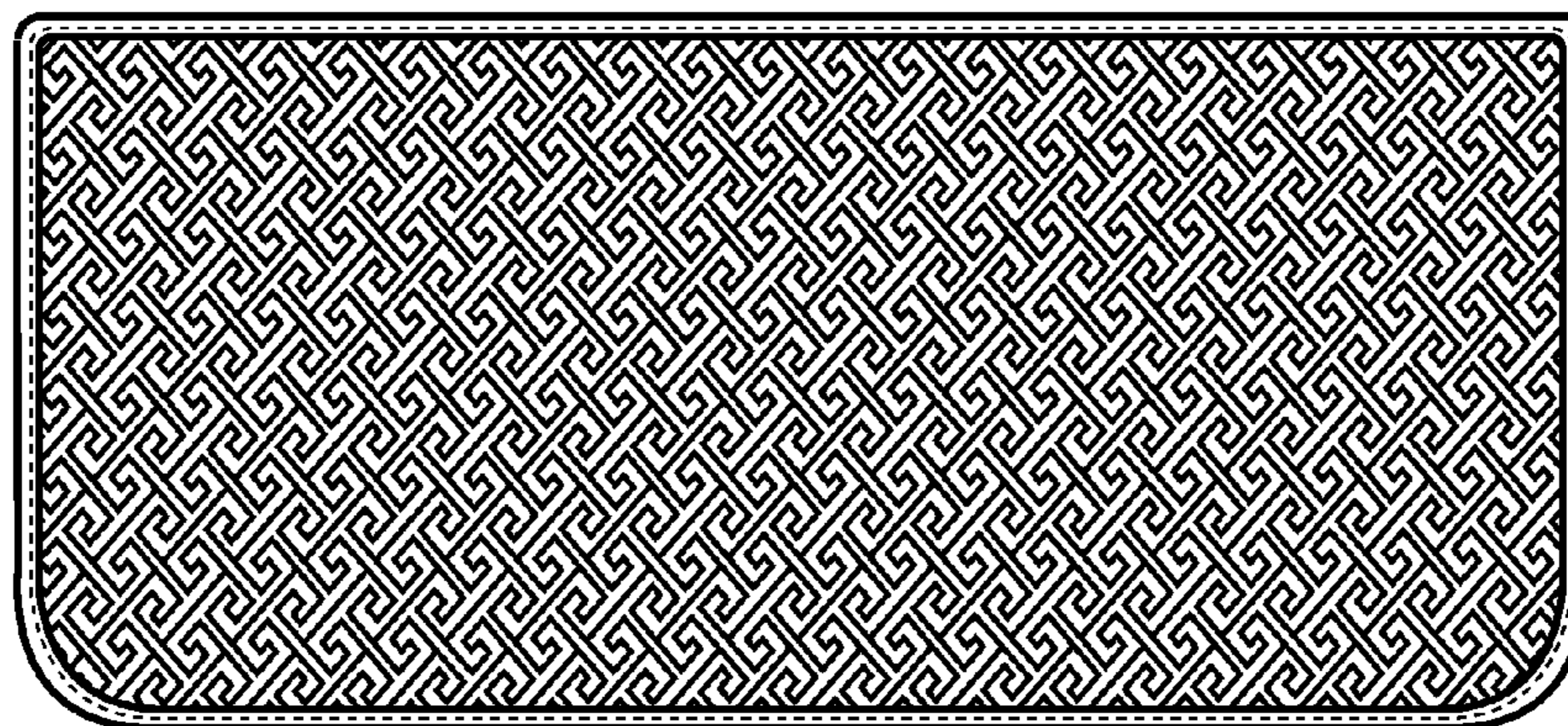

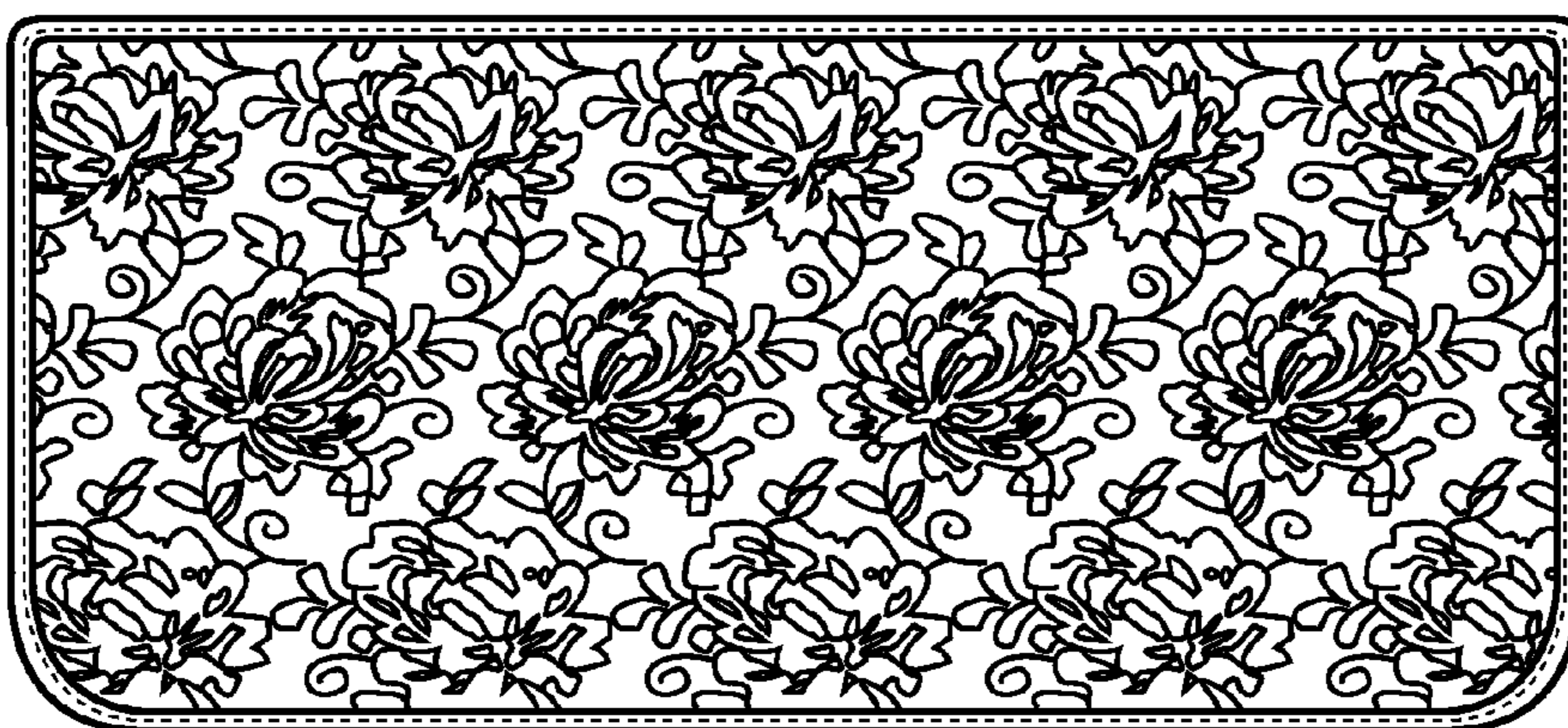

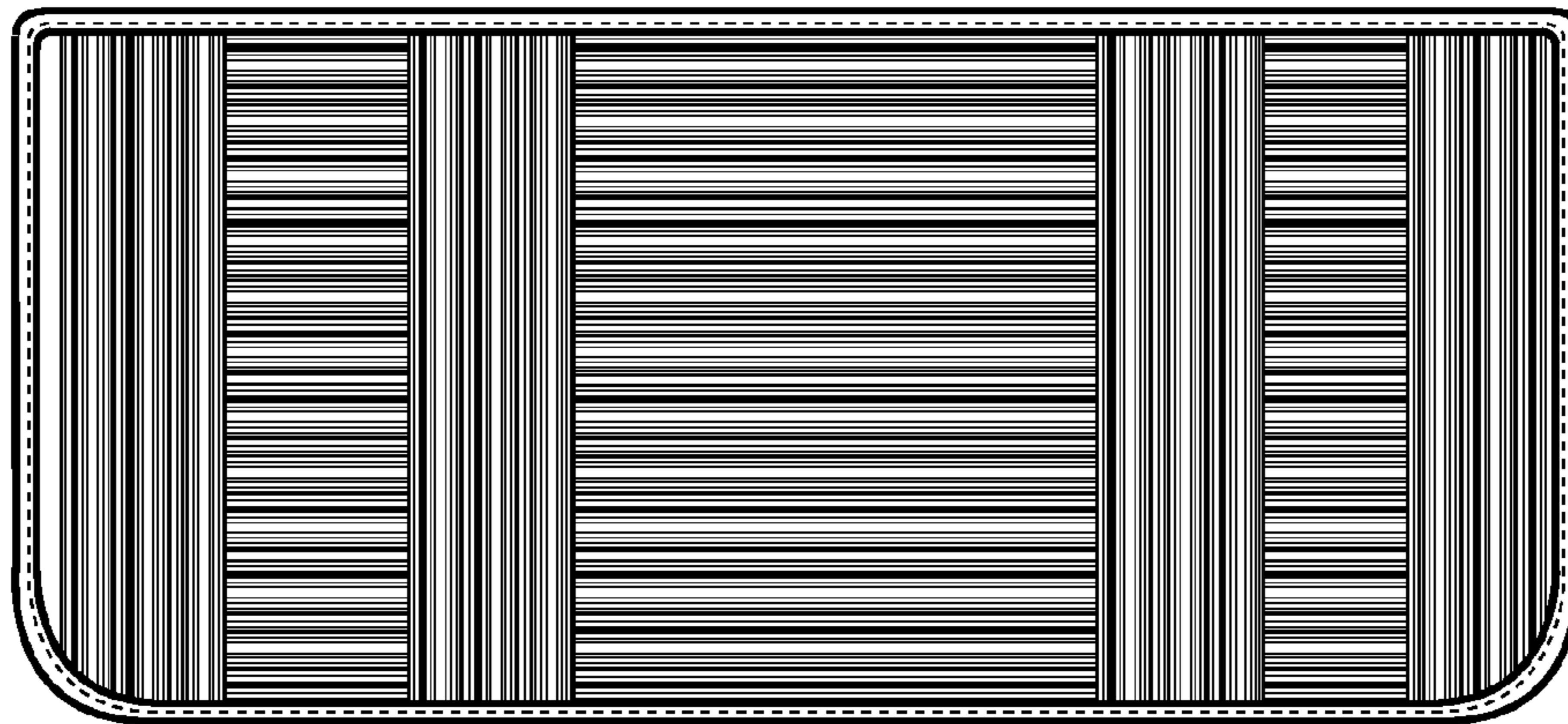
