The sole FIGURE is a plan view of a patterned textile fabric showing our new design, wherein the different shading represents color contrast.

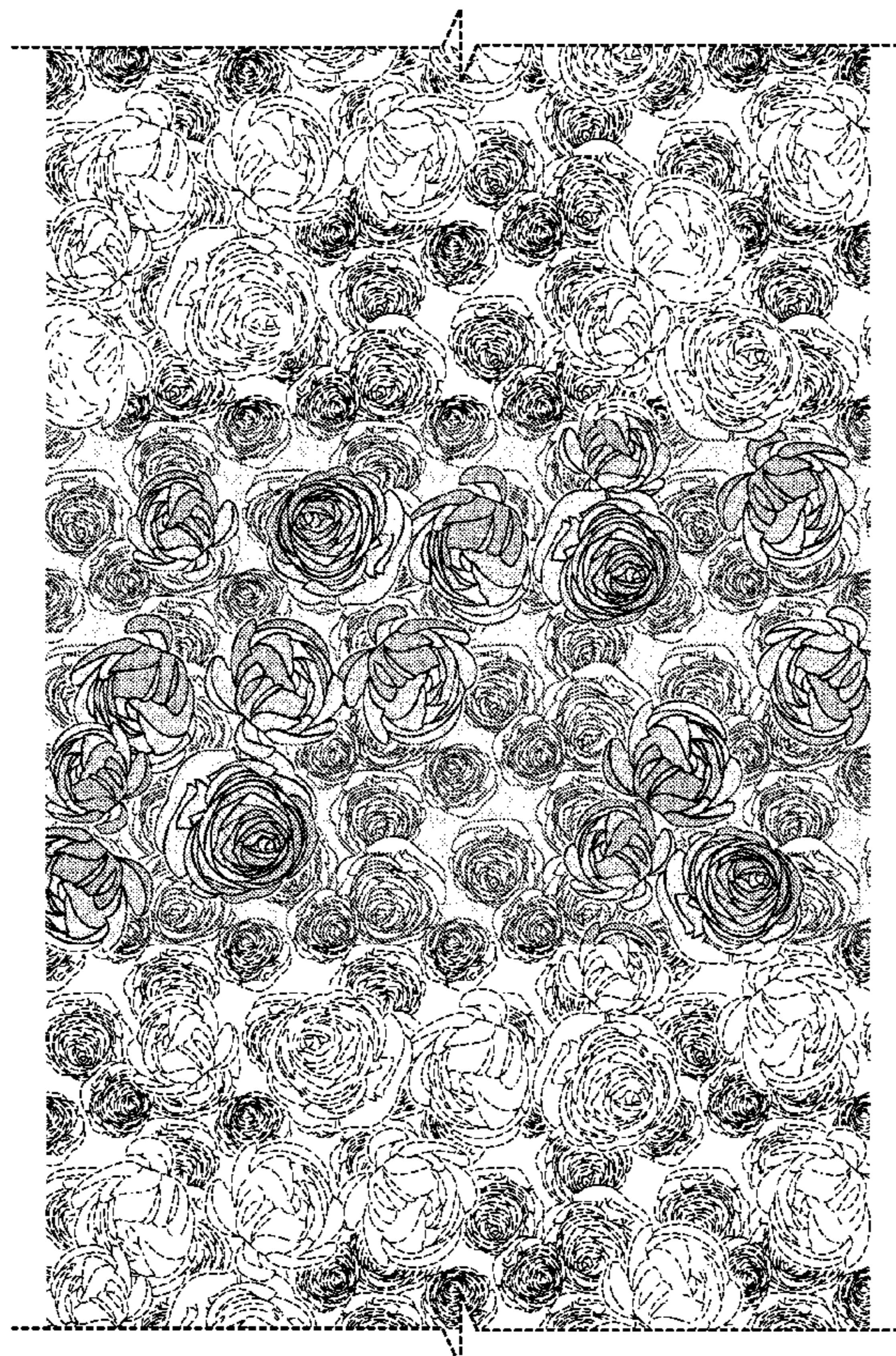
The broken lines in the drawing represent environmental subject matter that forms no part of the claim.

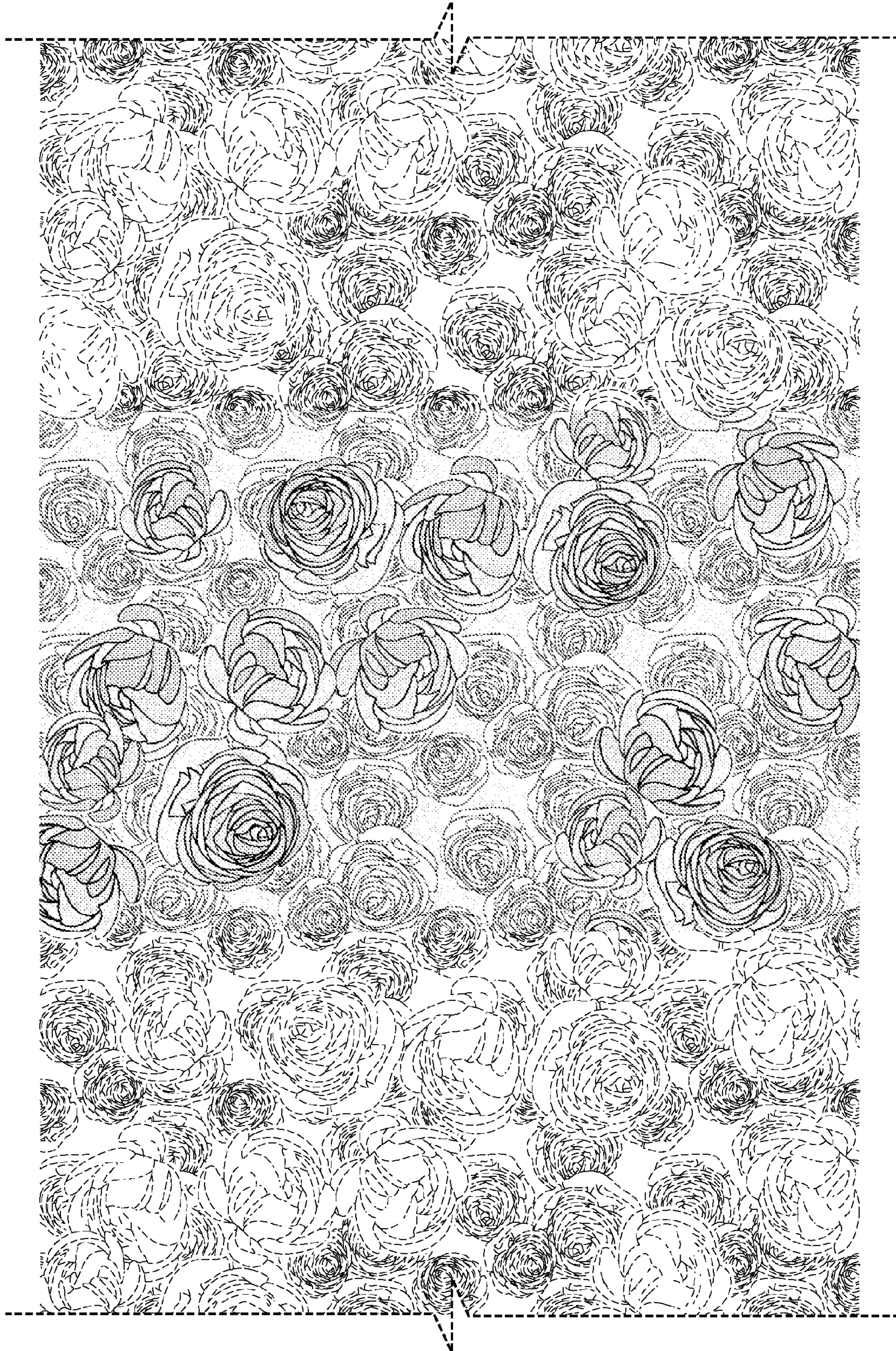
