(57) **CLAIM**

The ornamental design for an apparatus for baking food products, as shown and described.

**DESCRIPTION**

FIG. 1 shows a top view of a first piece of a baking apparatus according to a first exemplary embodiment of the invention; FIG. 2 shows a bottom view of the first piece of a baking apparatus according to FIG. 1; FIG. 3 shows a bottom perspective view of a first piece of a baking apparatus as viewed at from an angle according to FIG. 1; FIG. 4 shows a front view of the first piece of a baking apparatus according to FIG. 1; FIG. 5 shows a left side view of the first piece of a baking apparatus according to FIG. 1; FIG. 6 shows a top view of a second piece of a baking apparatus according to a first exemplary embodiment of the invention; FIG. 7 shows a bottom view of the second piece of a baking apparatus according to FIG. 6; FIG. 8 shows a bottom perspective view of the second piece of a baking apparatus as viewed at from an angle according to FIG. 6; FIG. 9 shows a front view of the second piece of a baking apparatus according to FIG. 6;

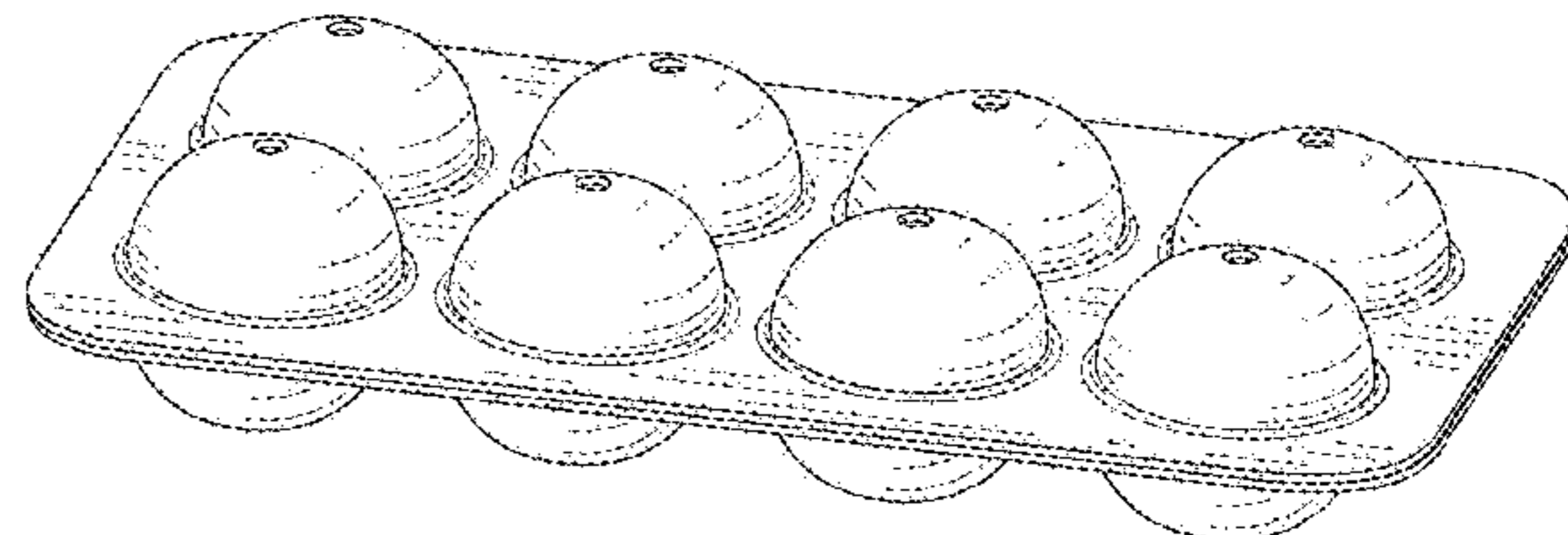
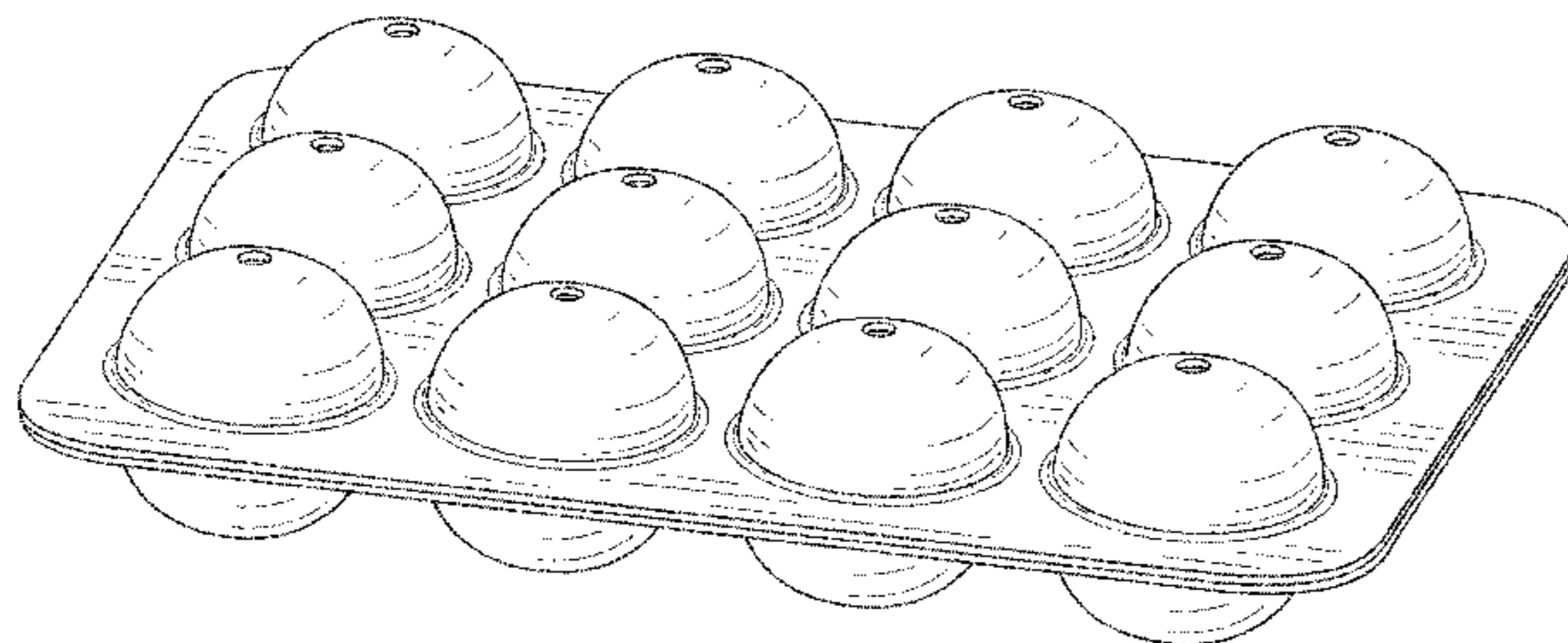


FIG. 10 shows a left side view of the second piece of a baking apparatus according to FIG. 6;

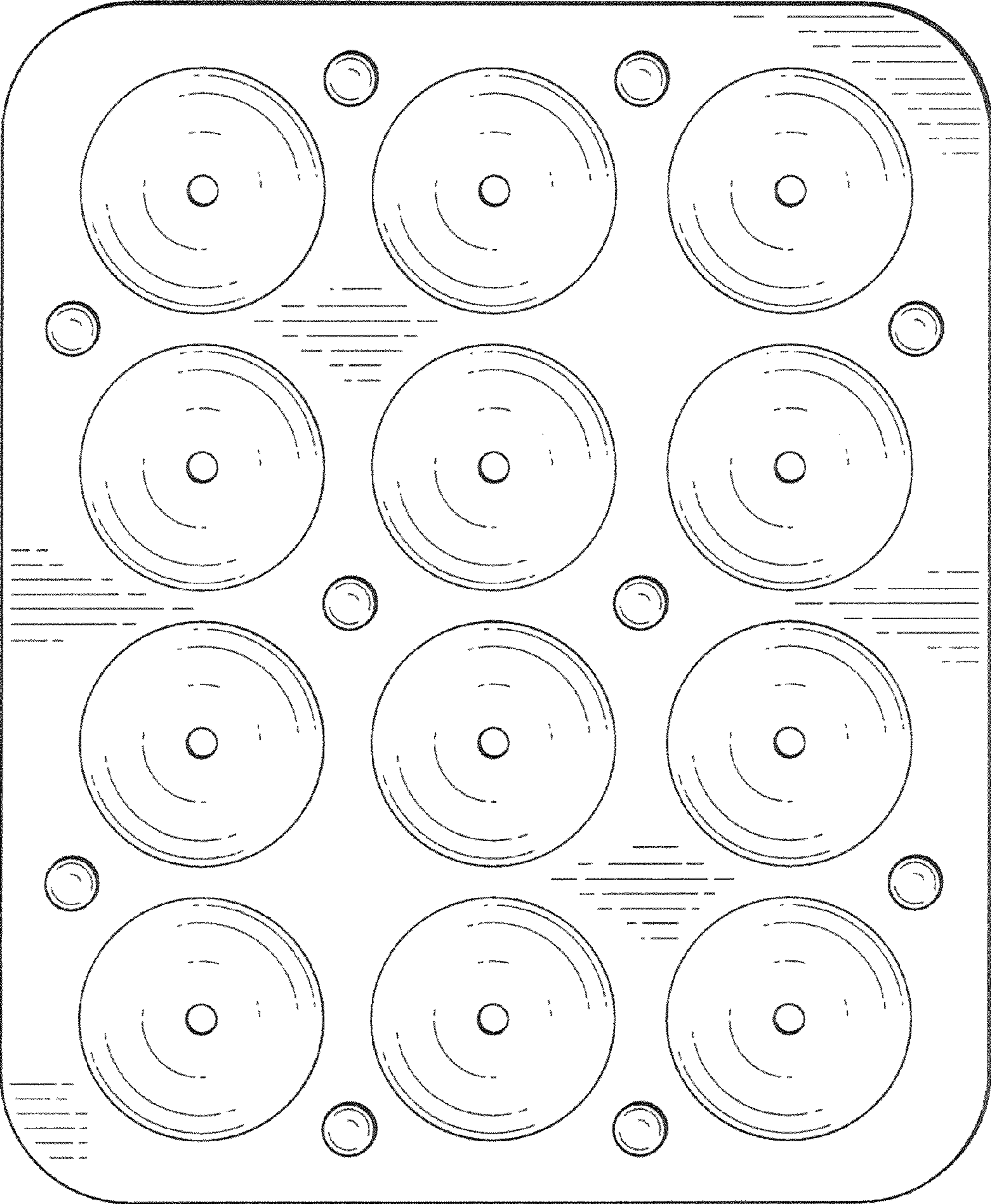

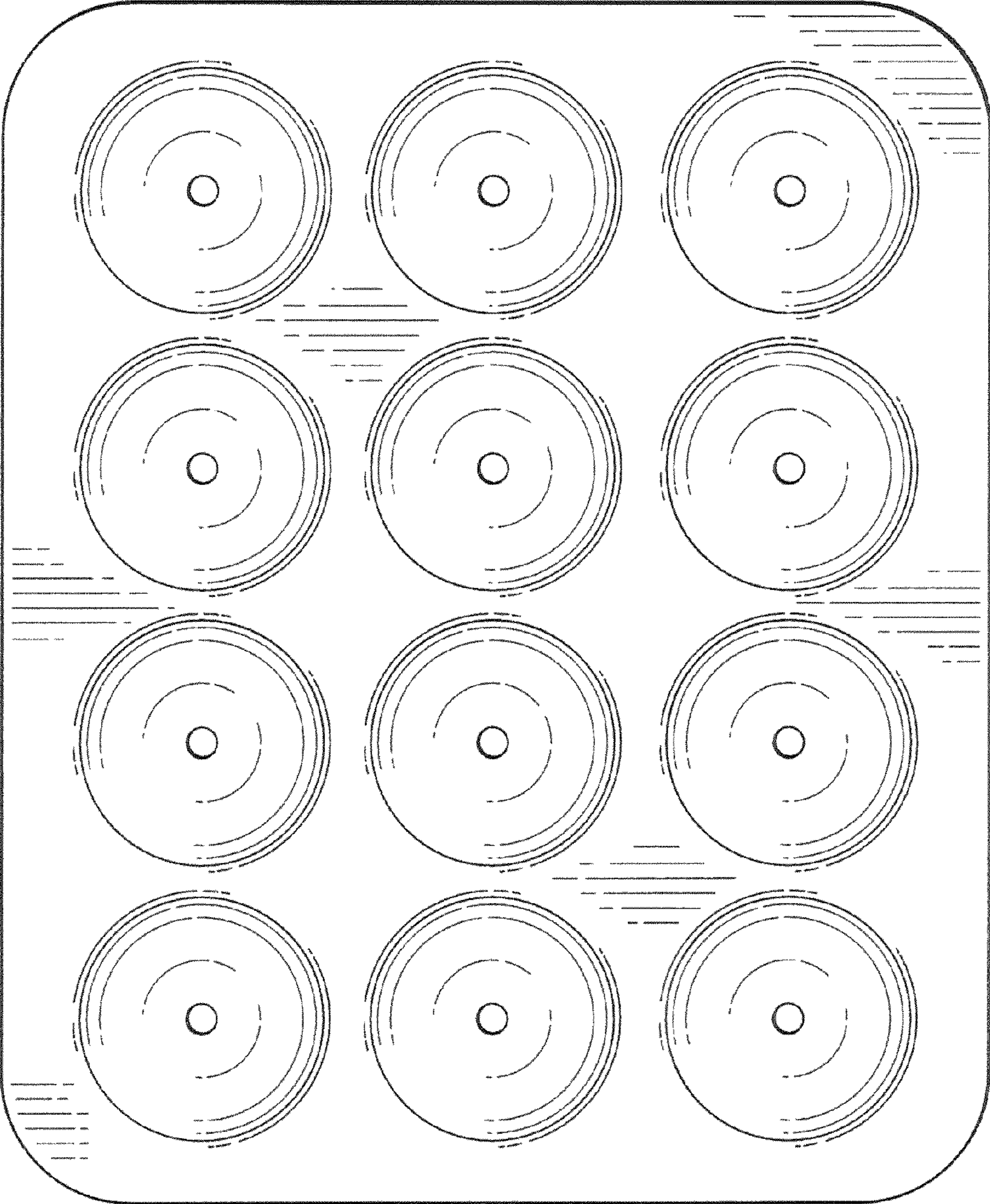

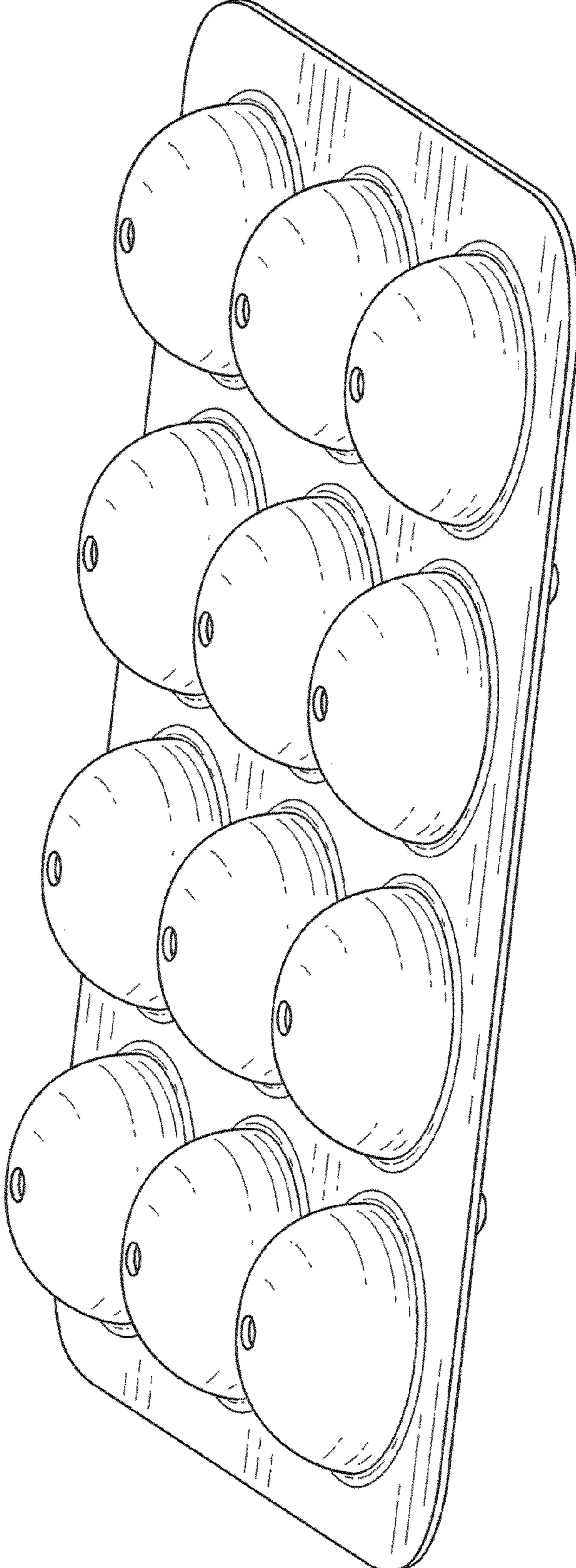

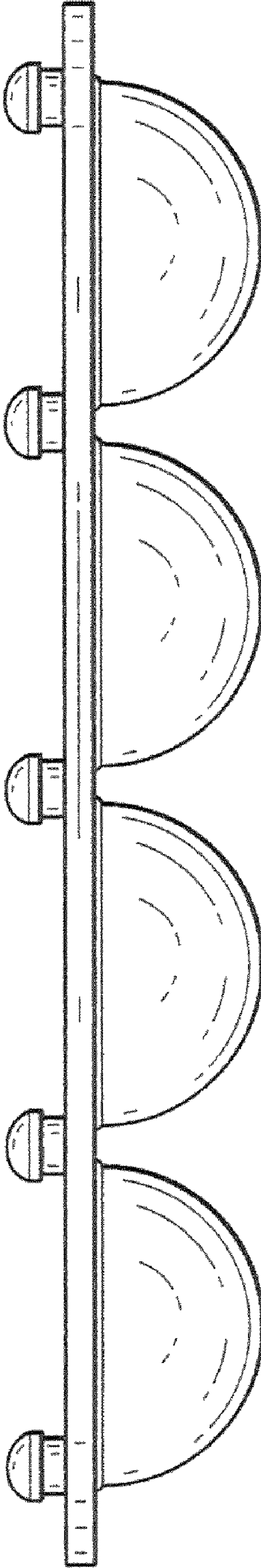

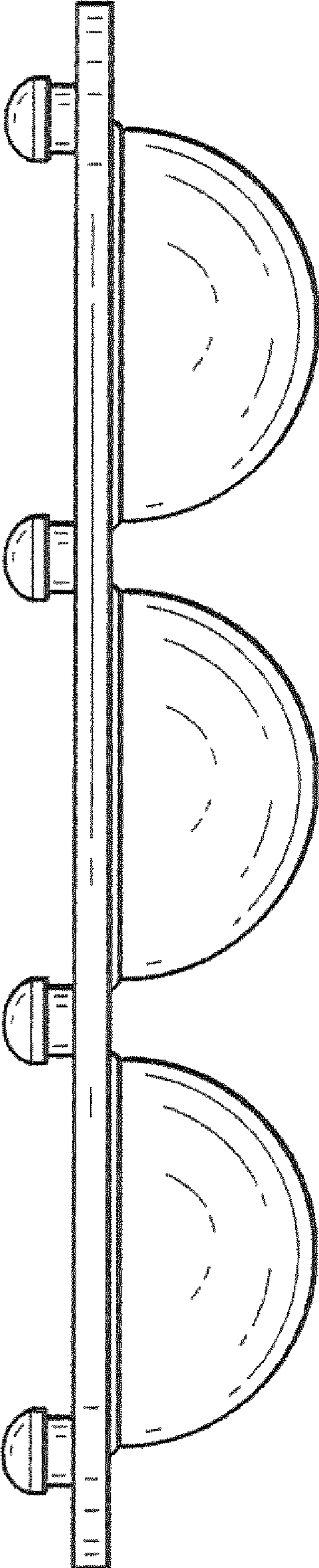

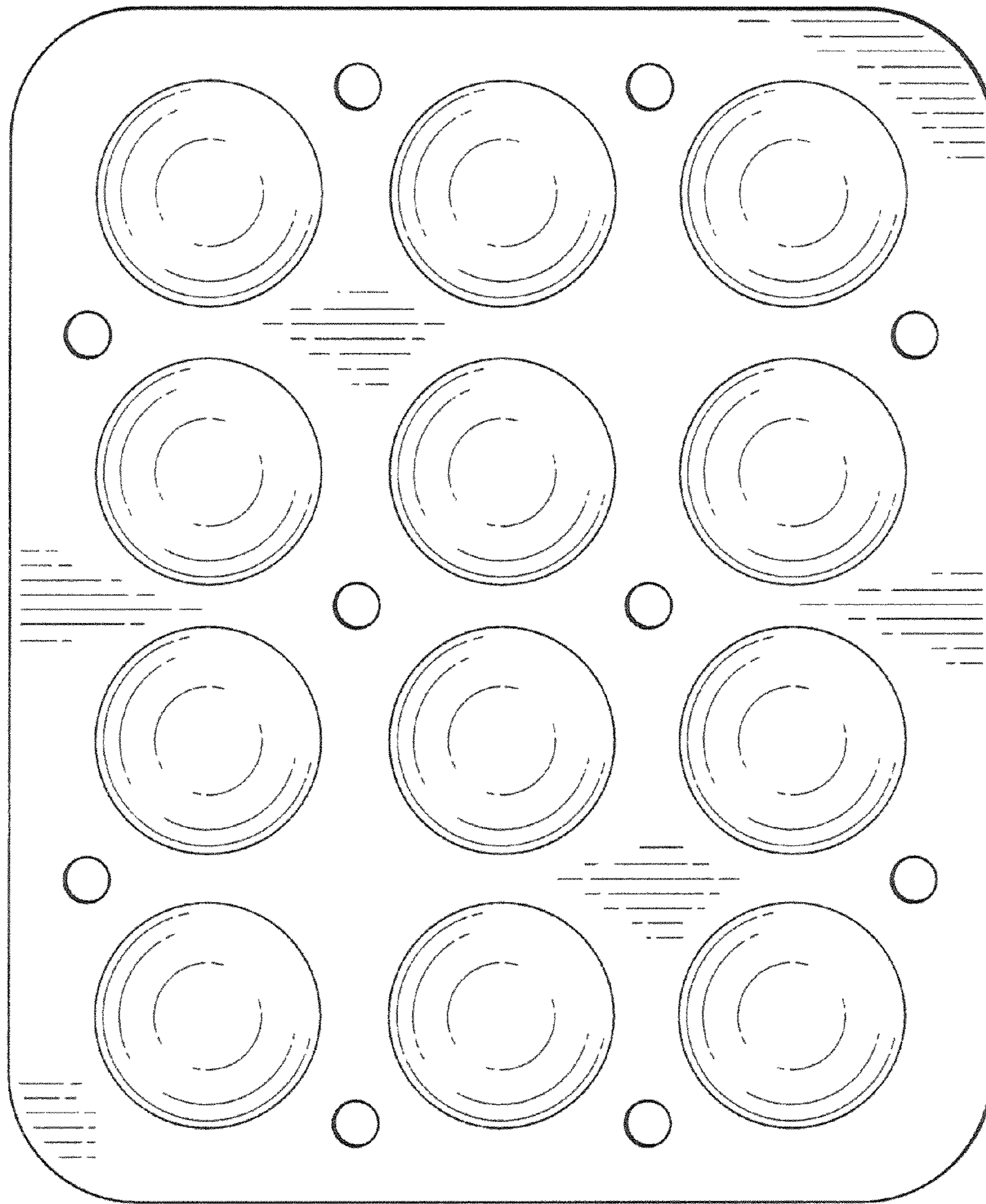

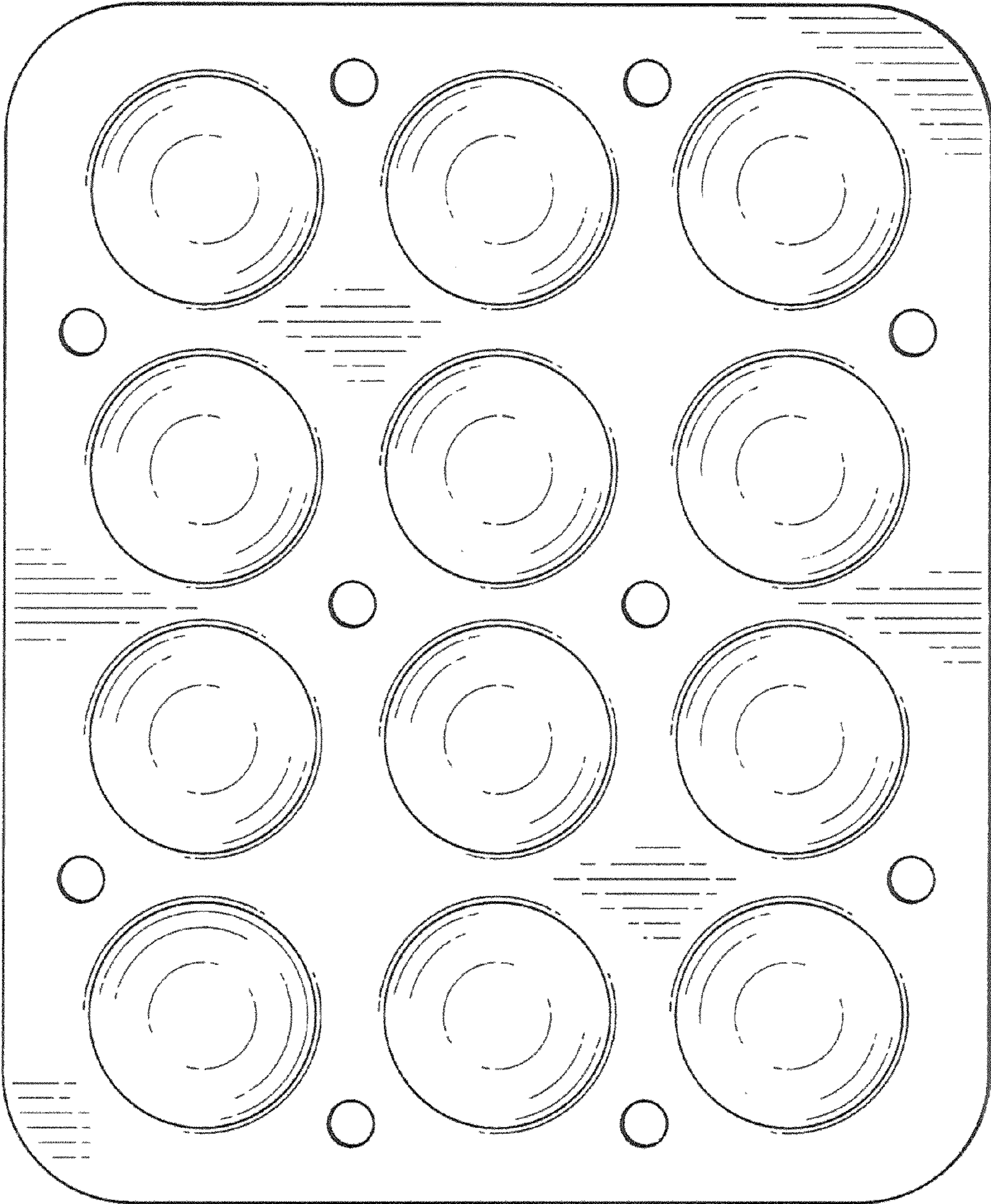

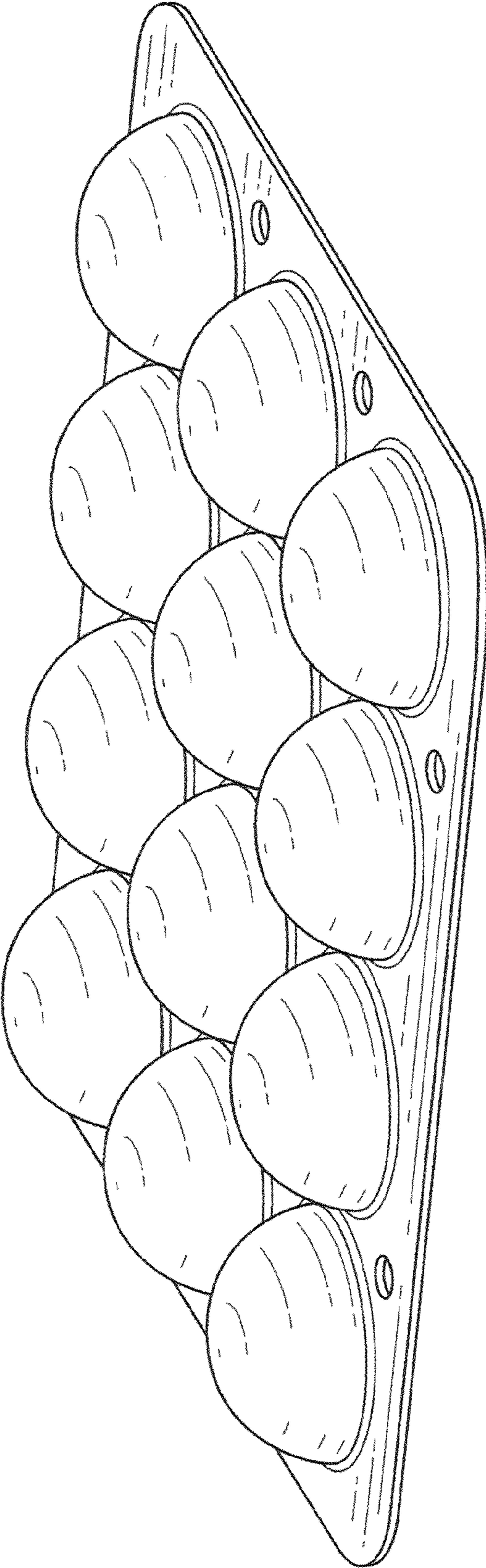

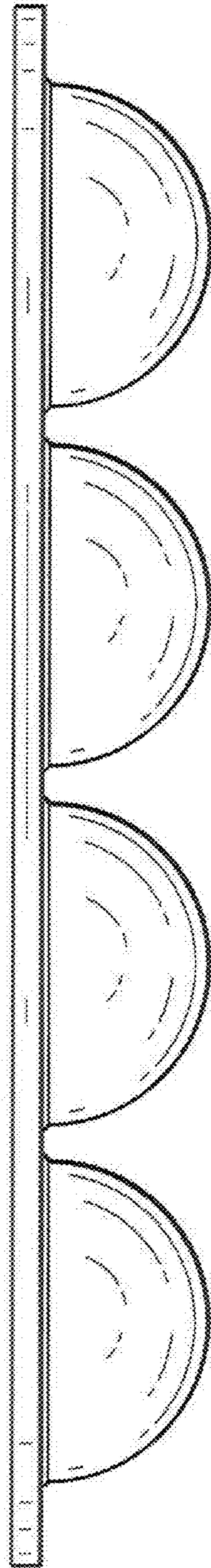

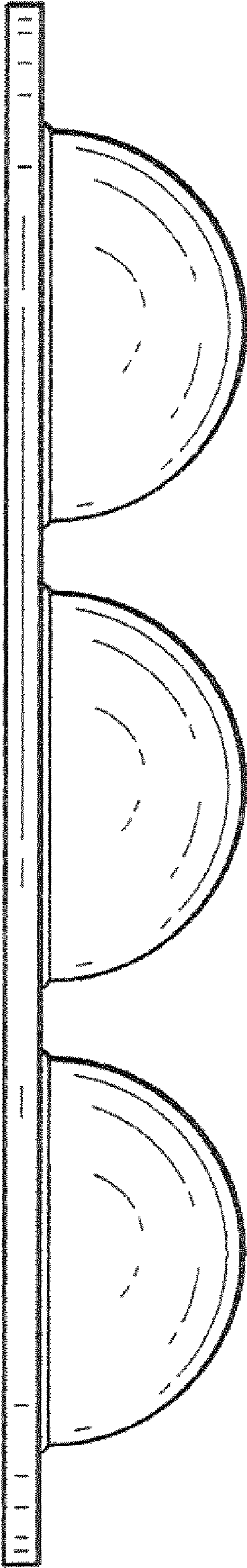

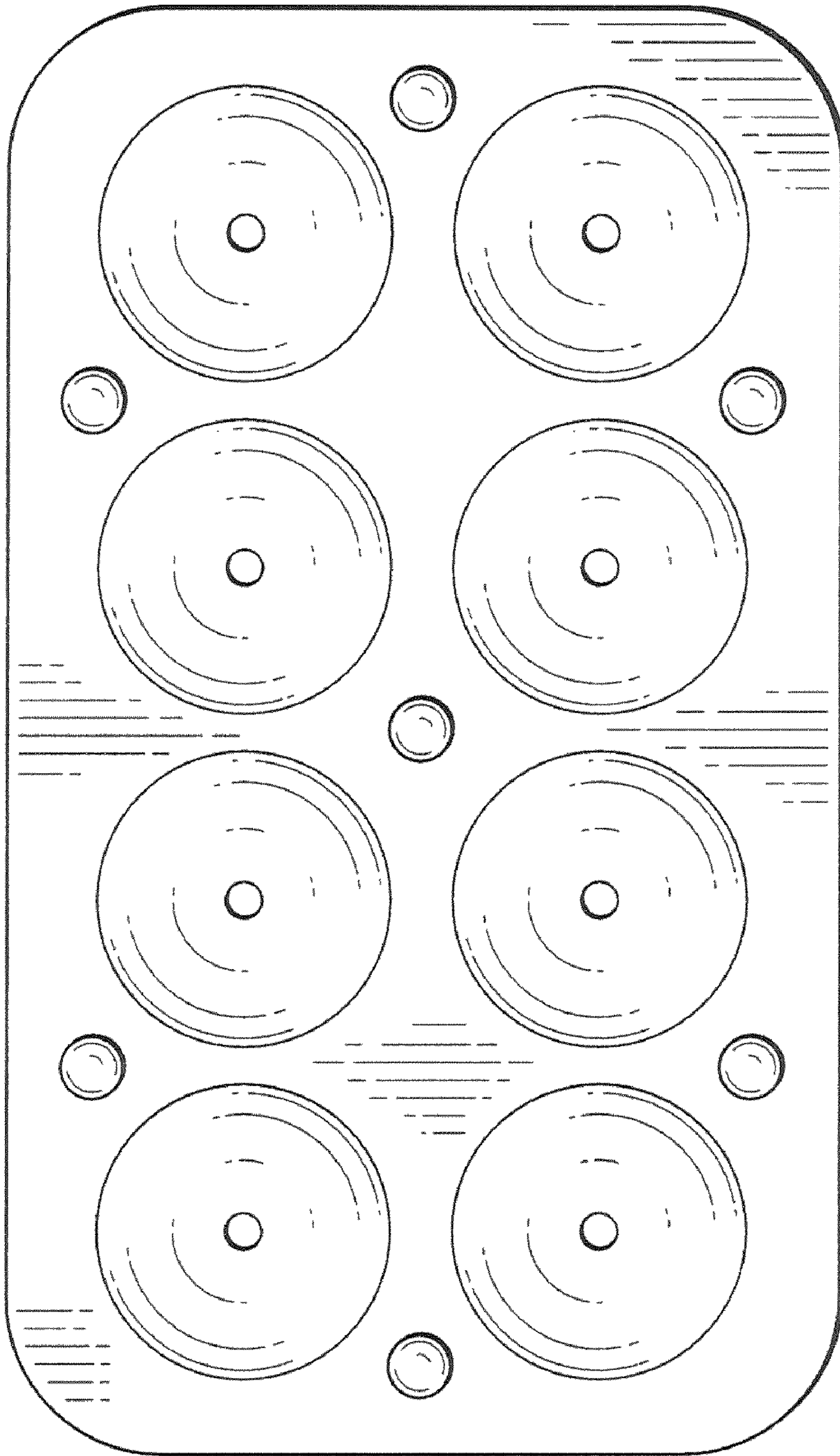

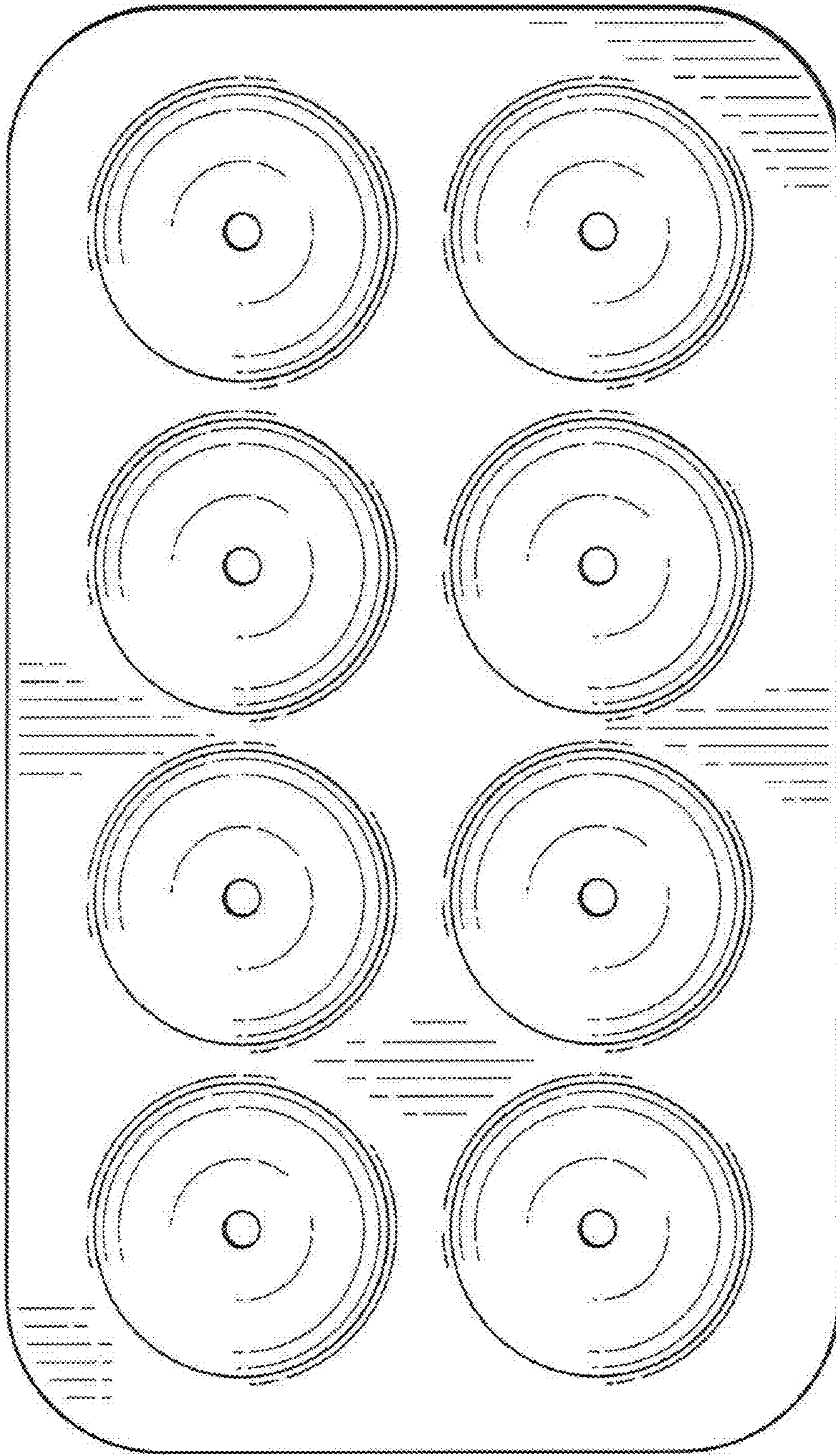

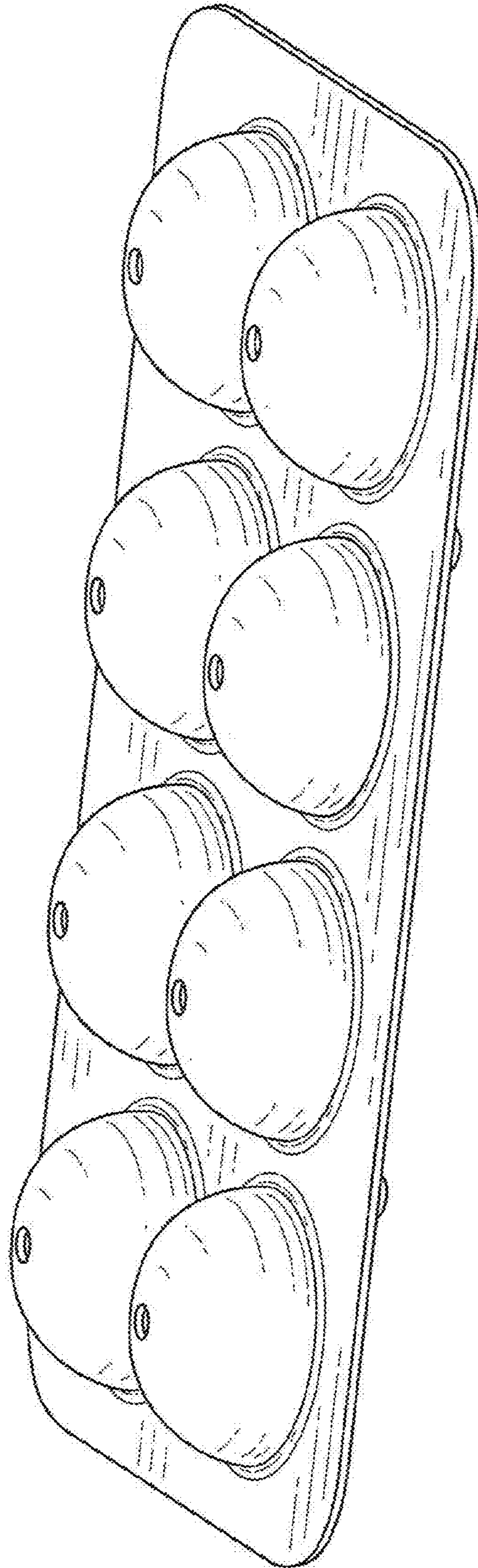

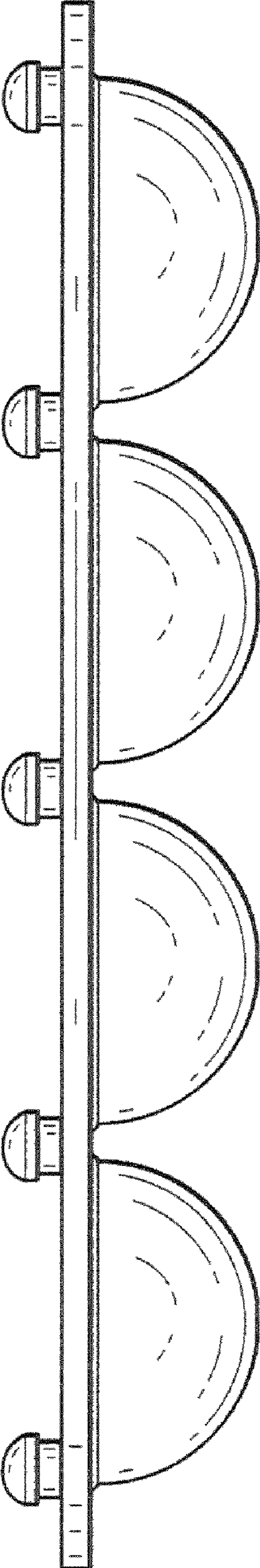

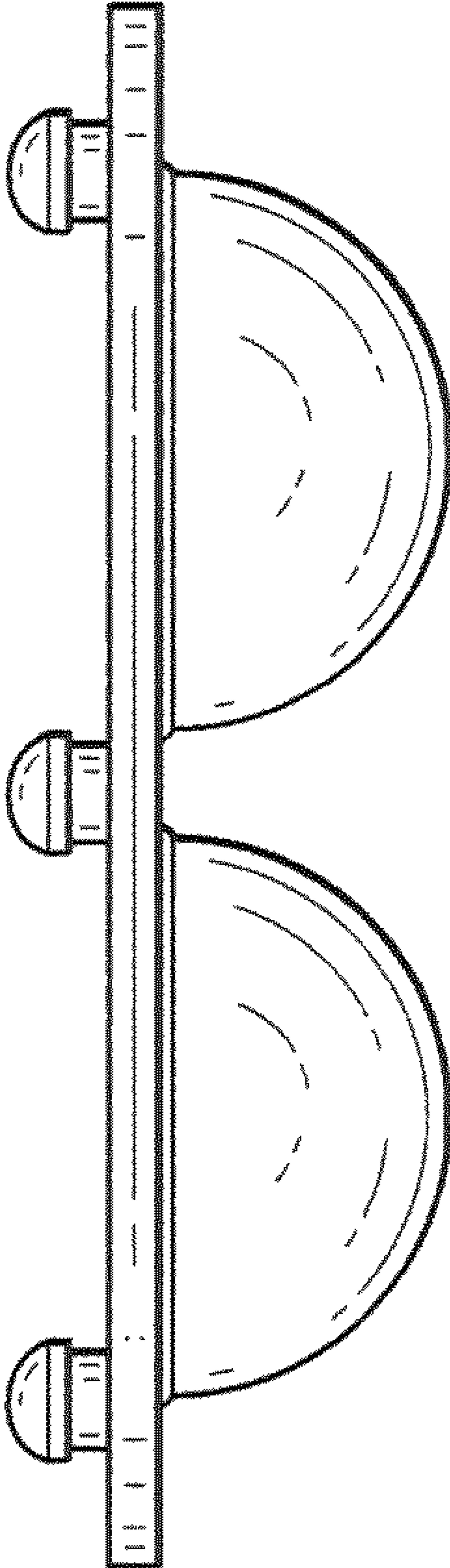

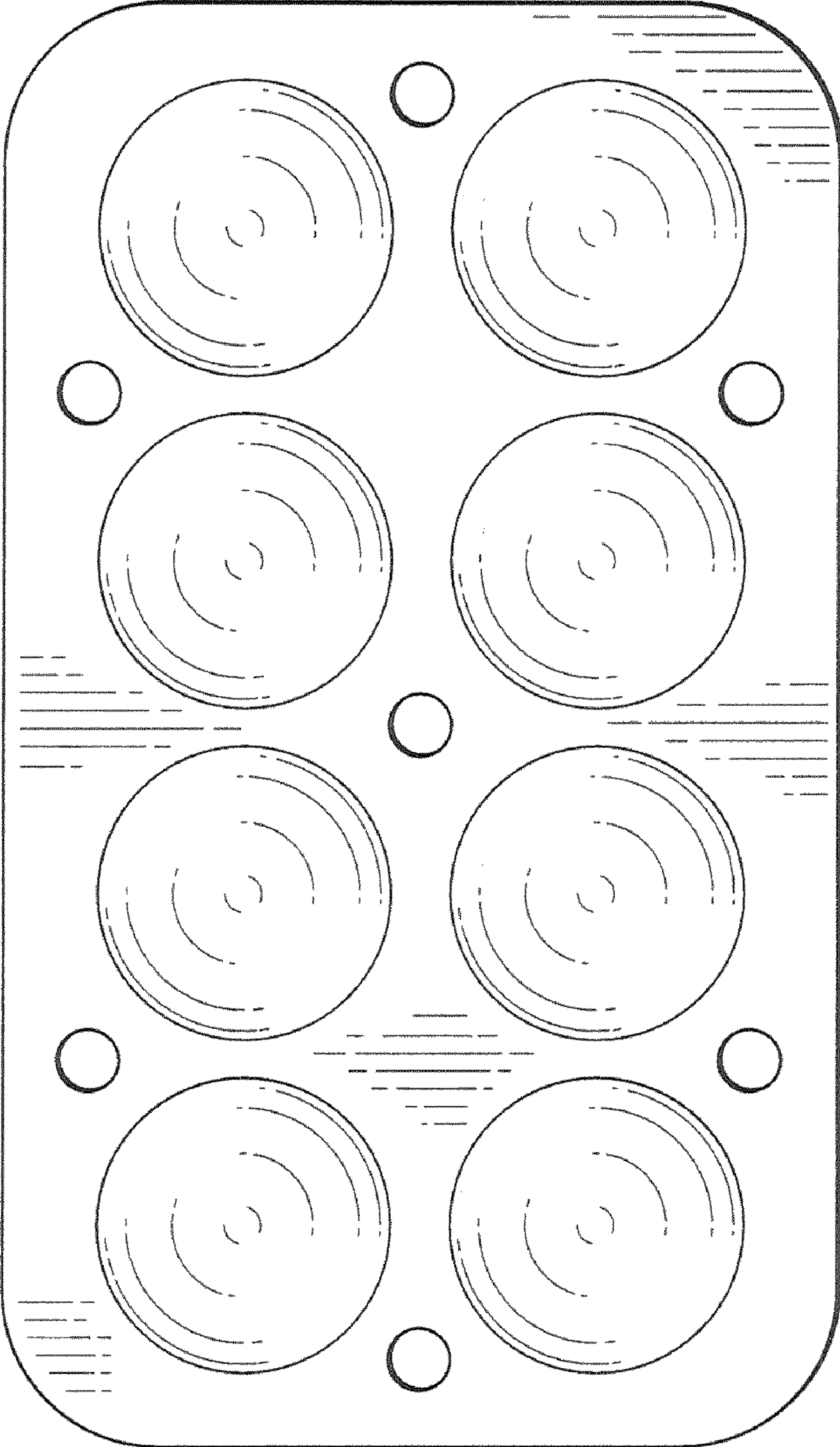

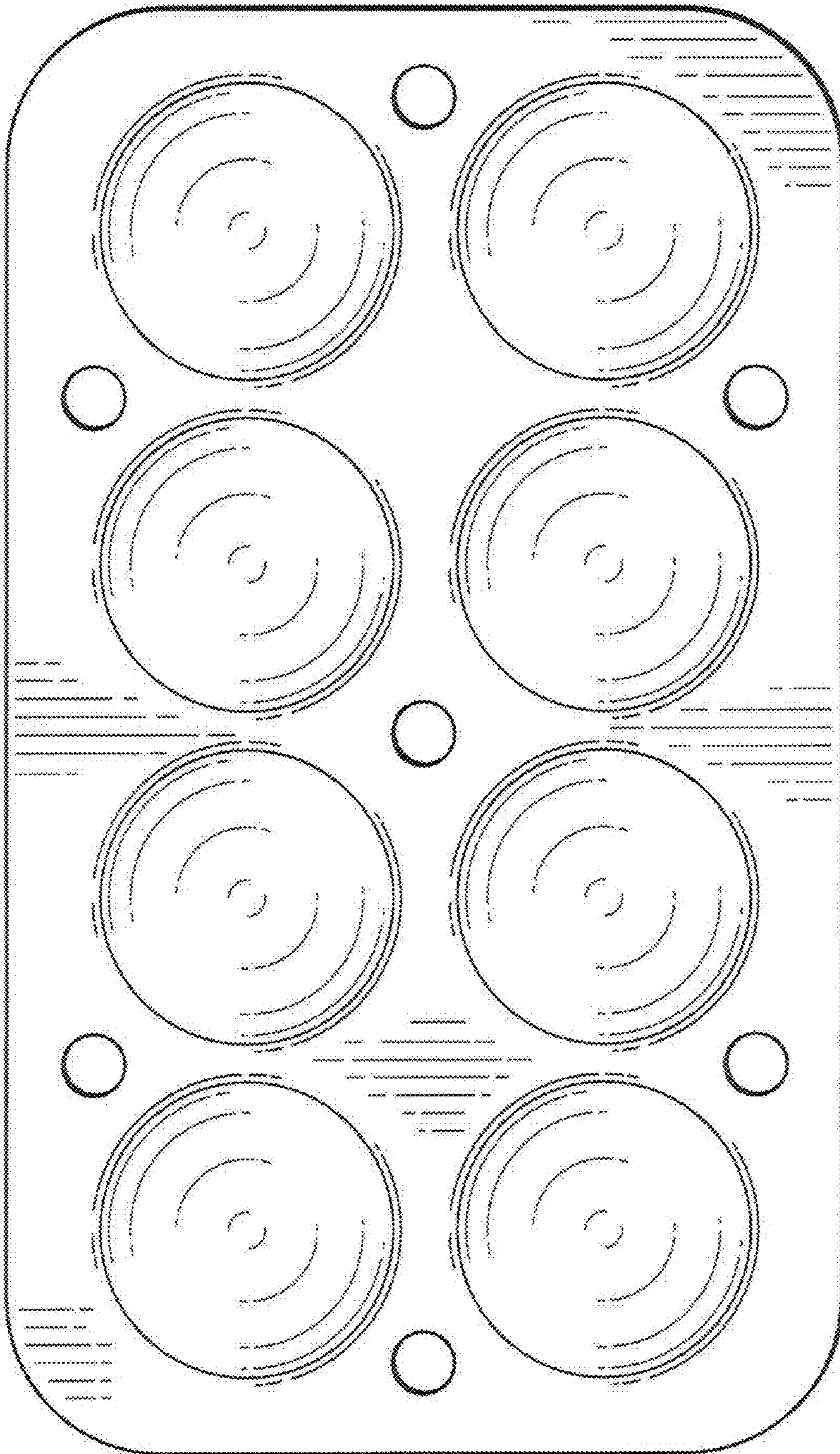

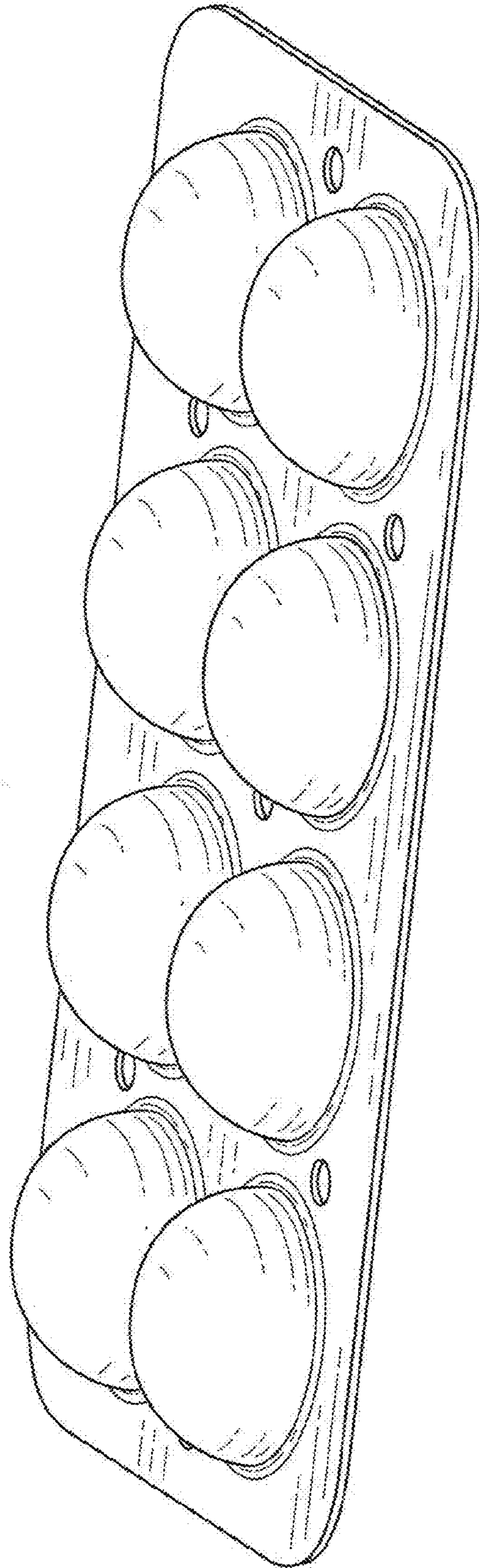

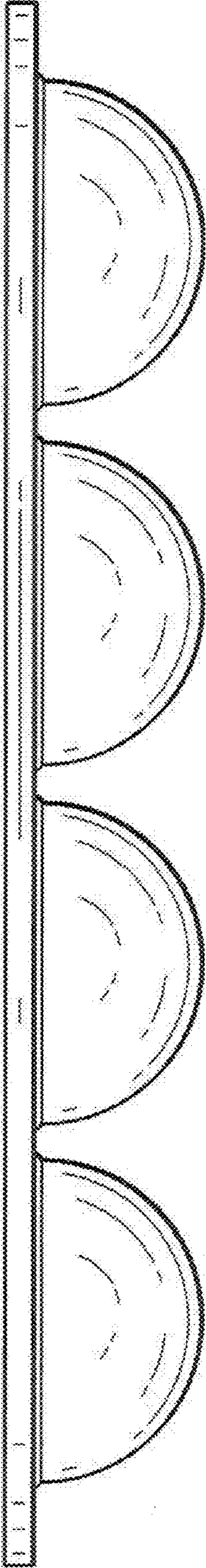

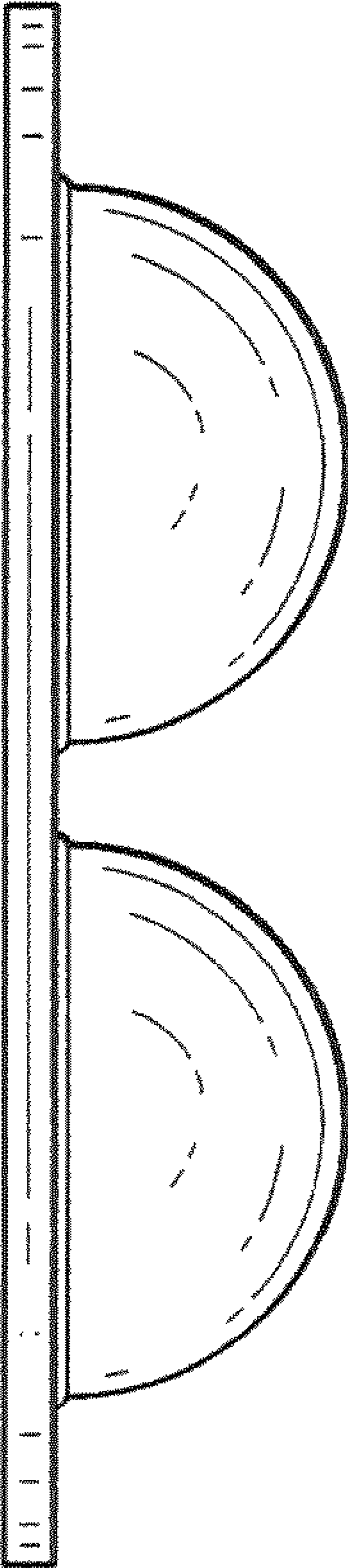

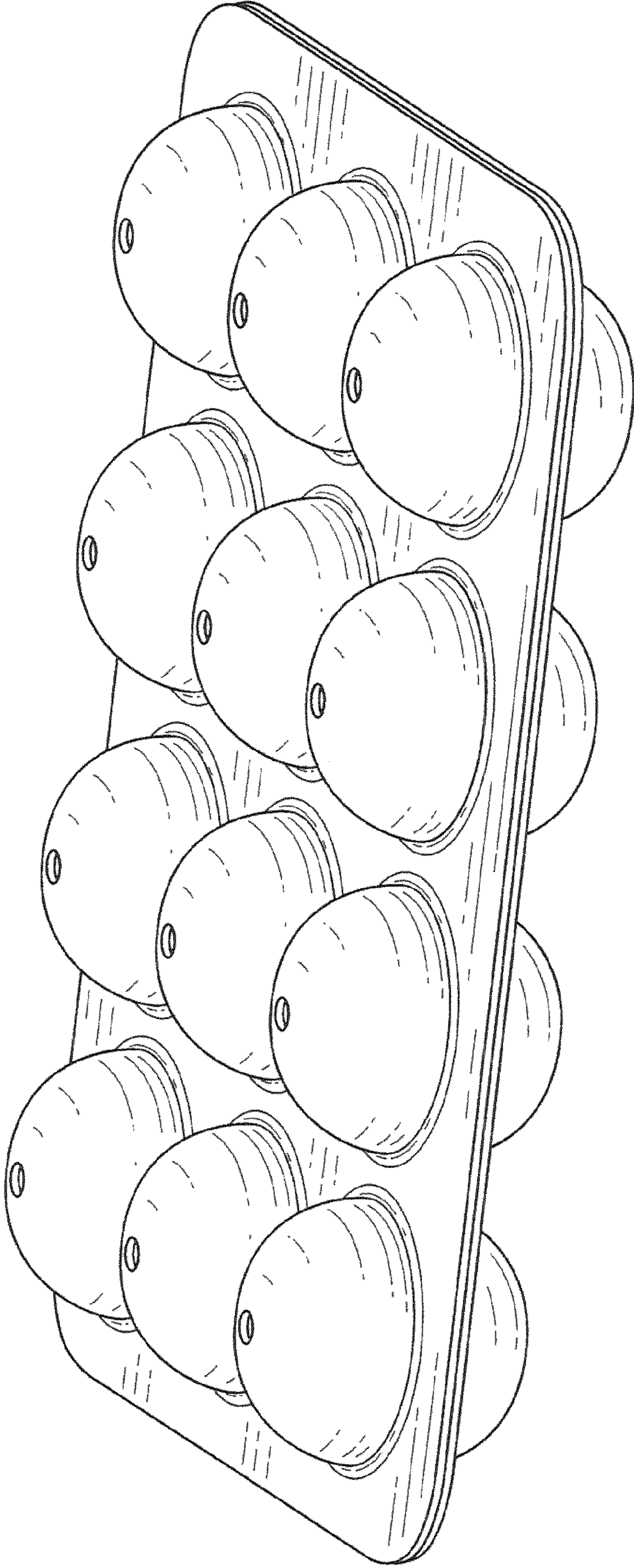

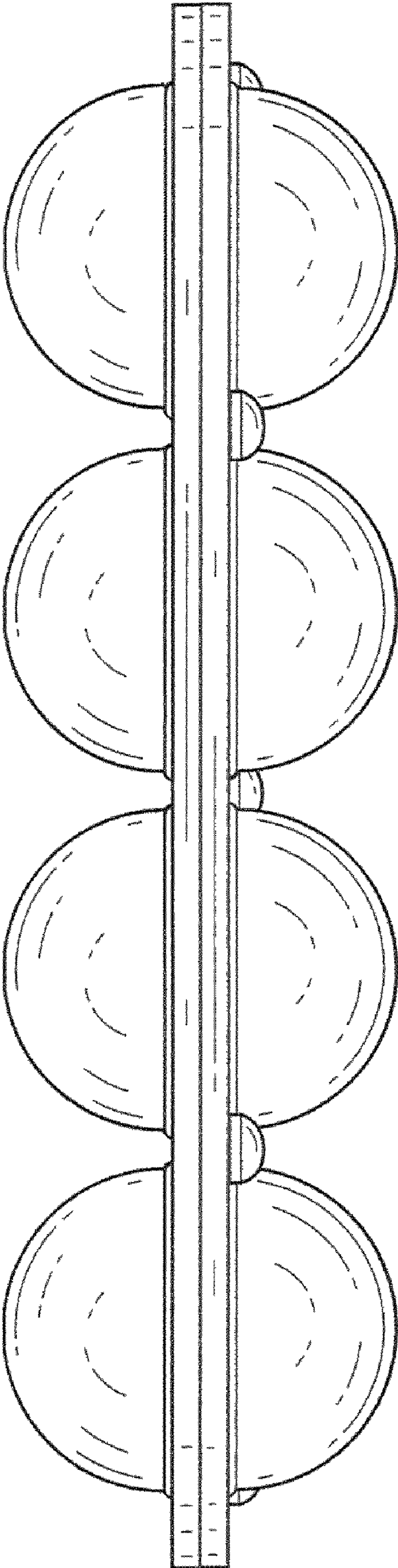

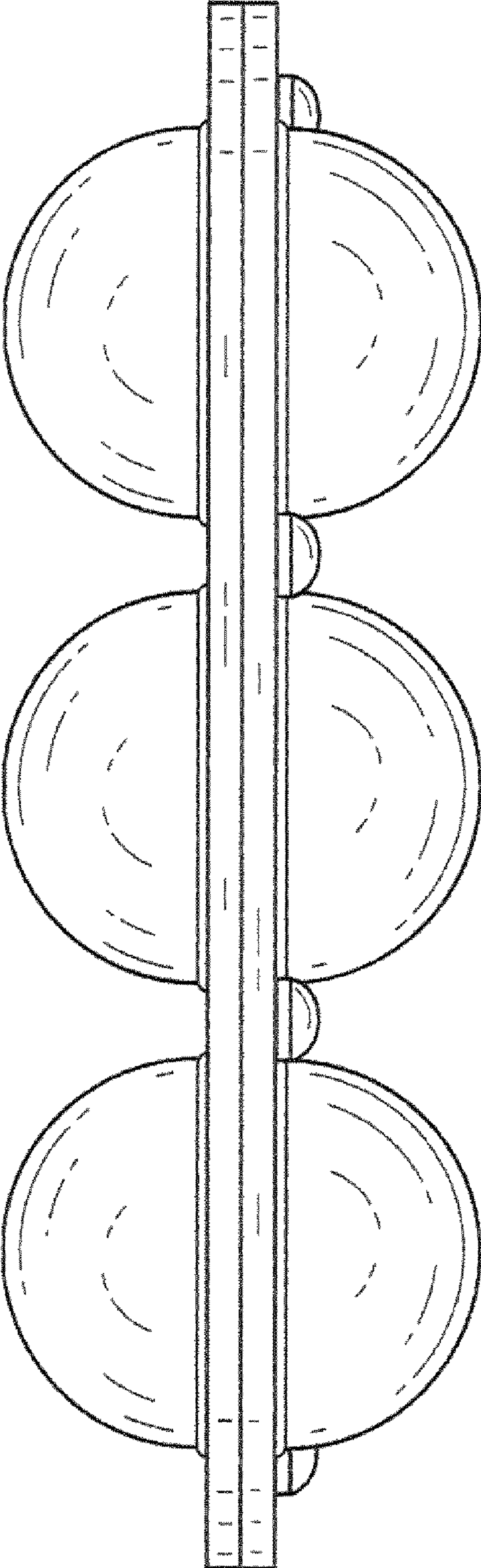

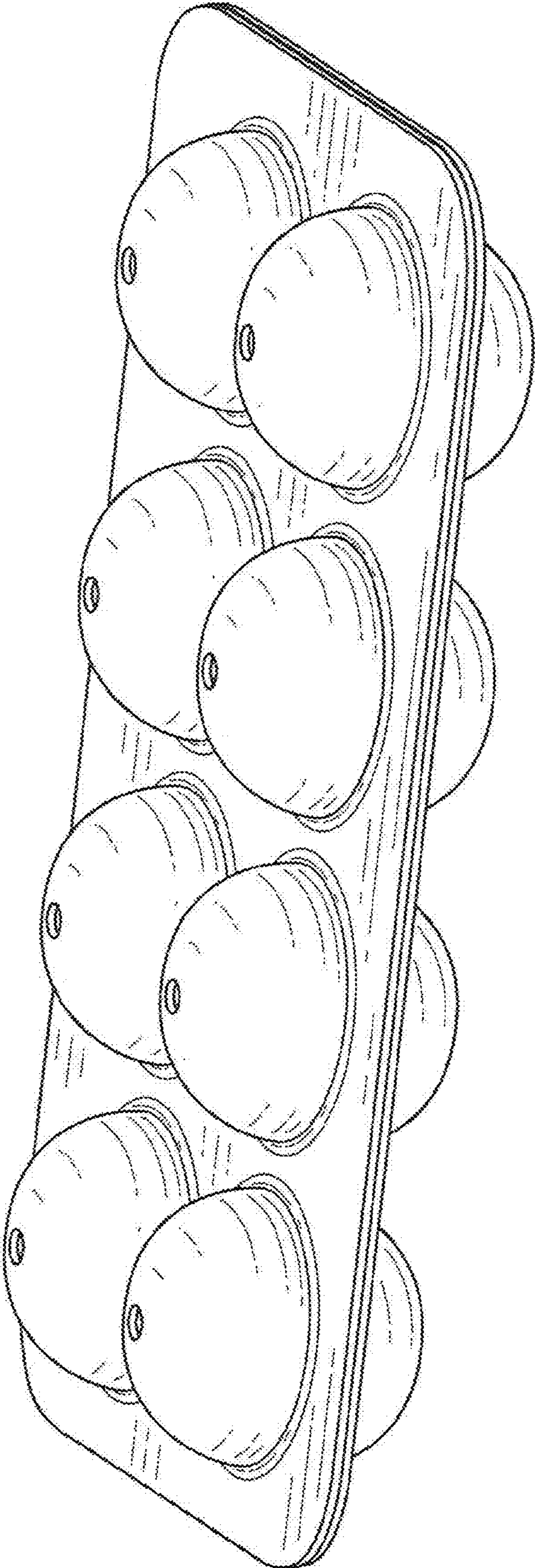

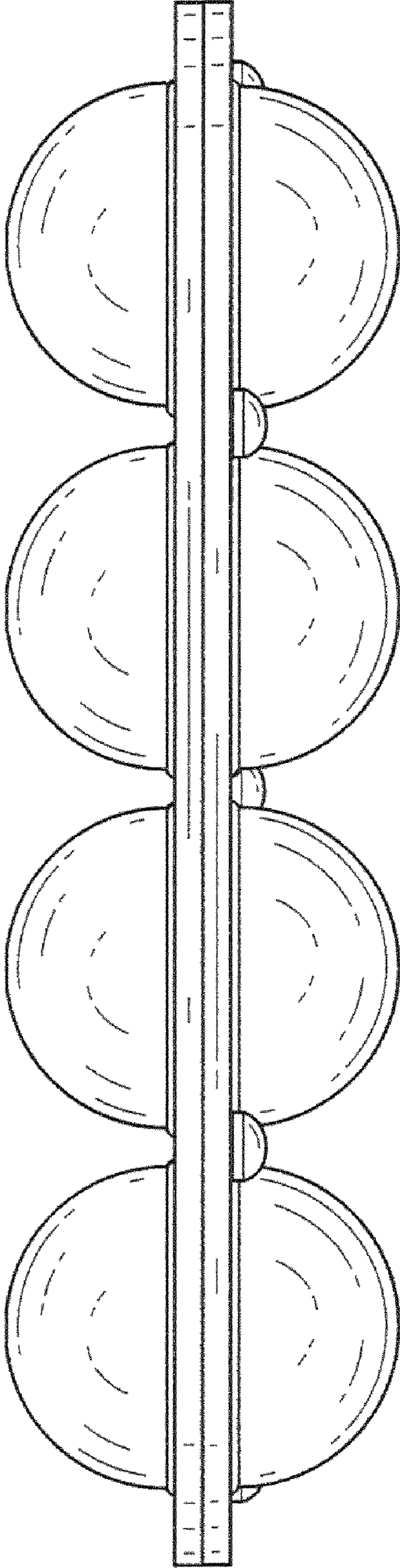

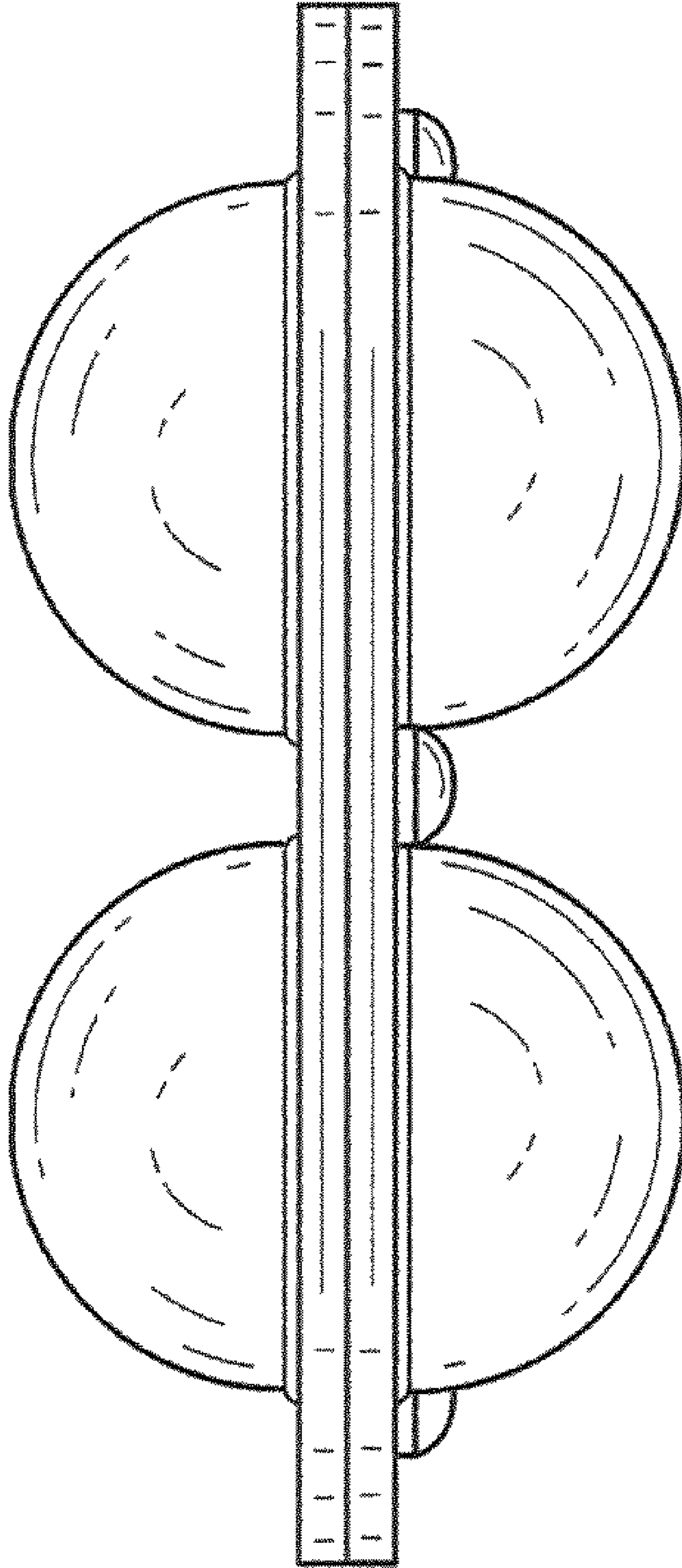
