FIG. 11 is a front view of FIG. 8.

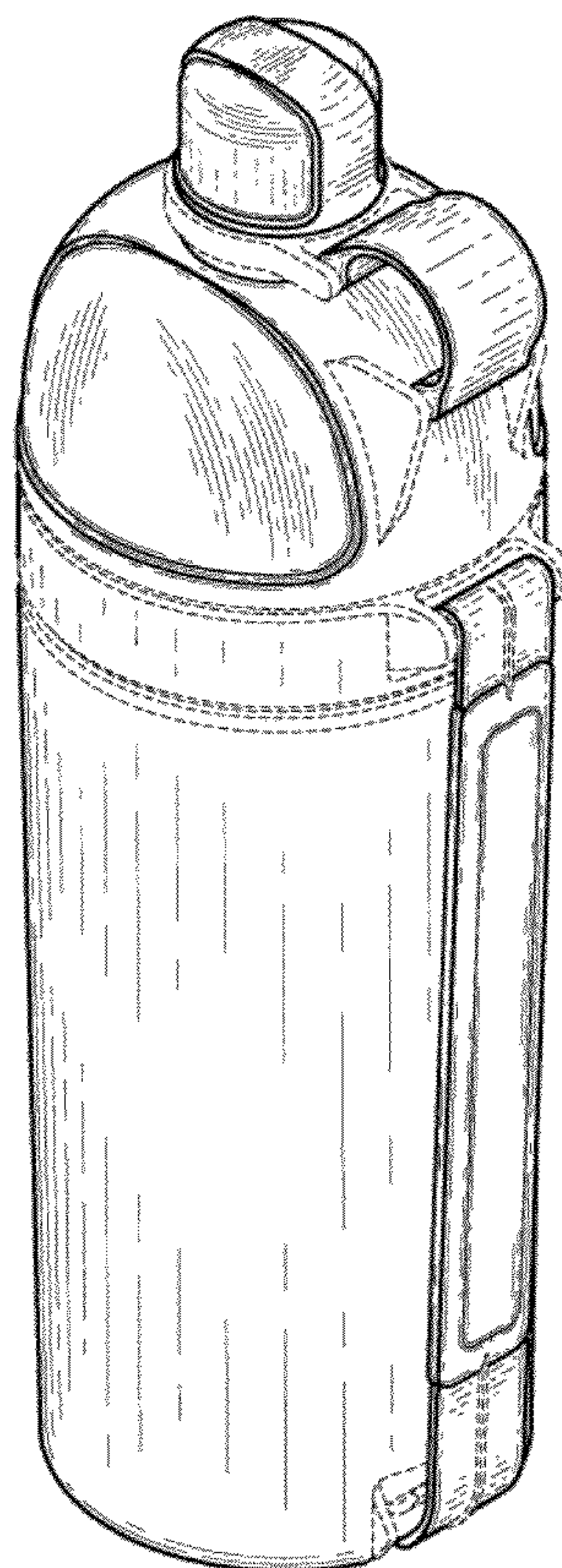
FIG. 12 is a rear view of FIG. 8.

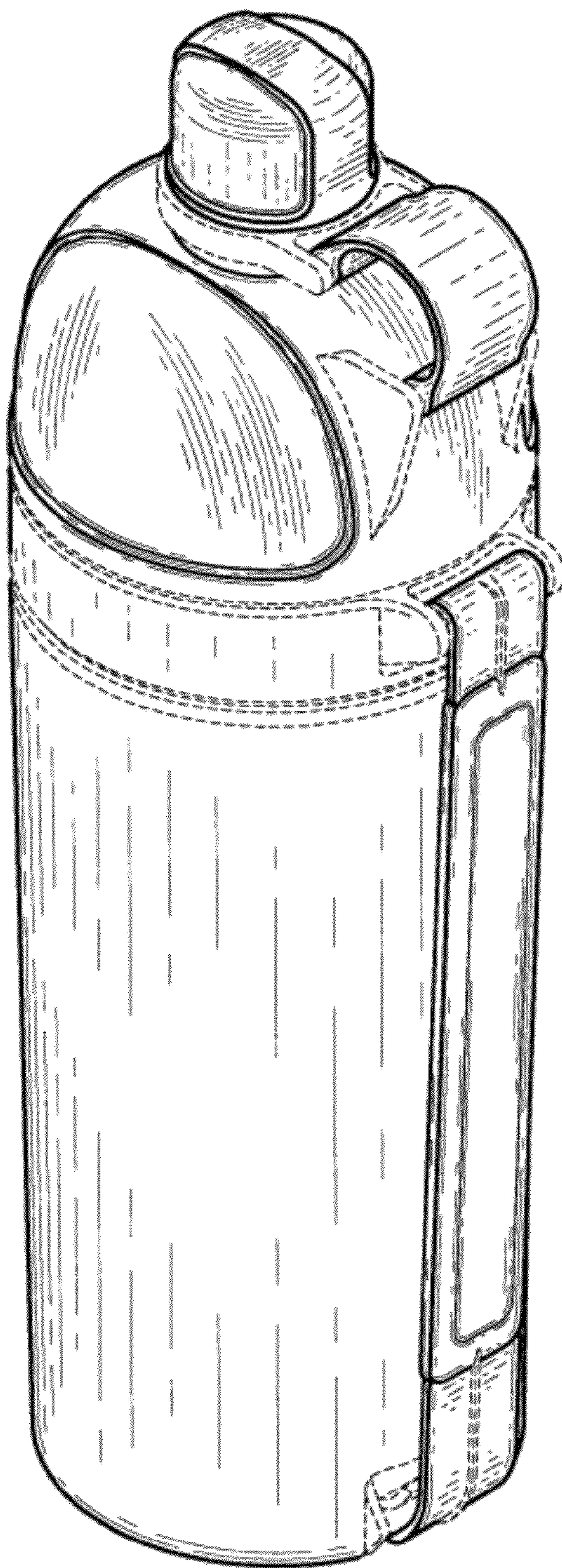

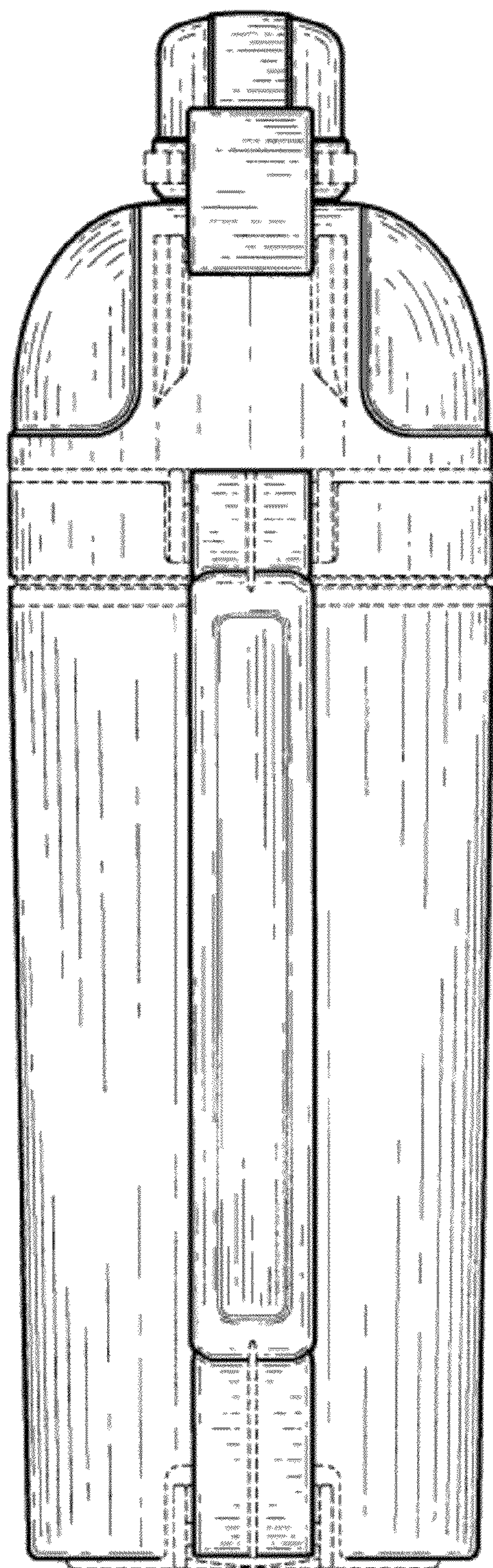

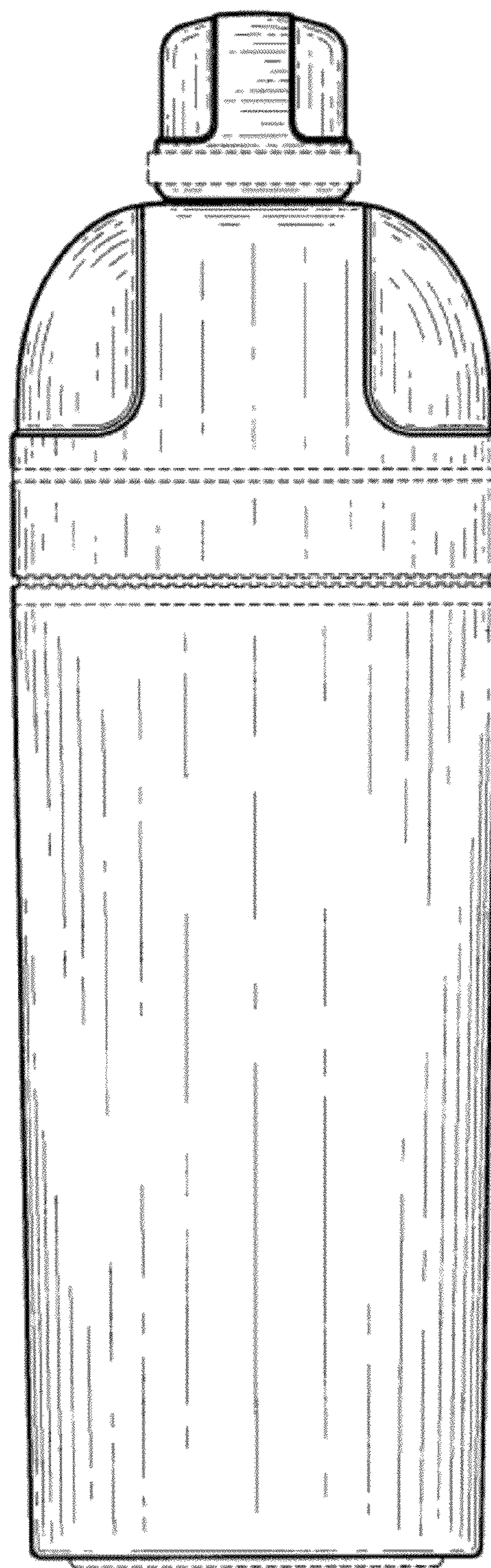

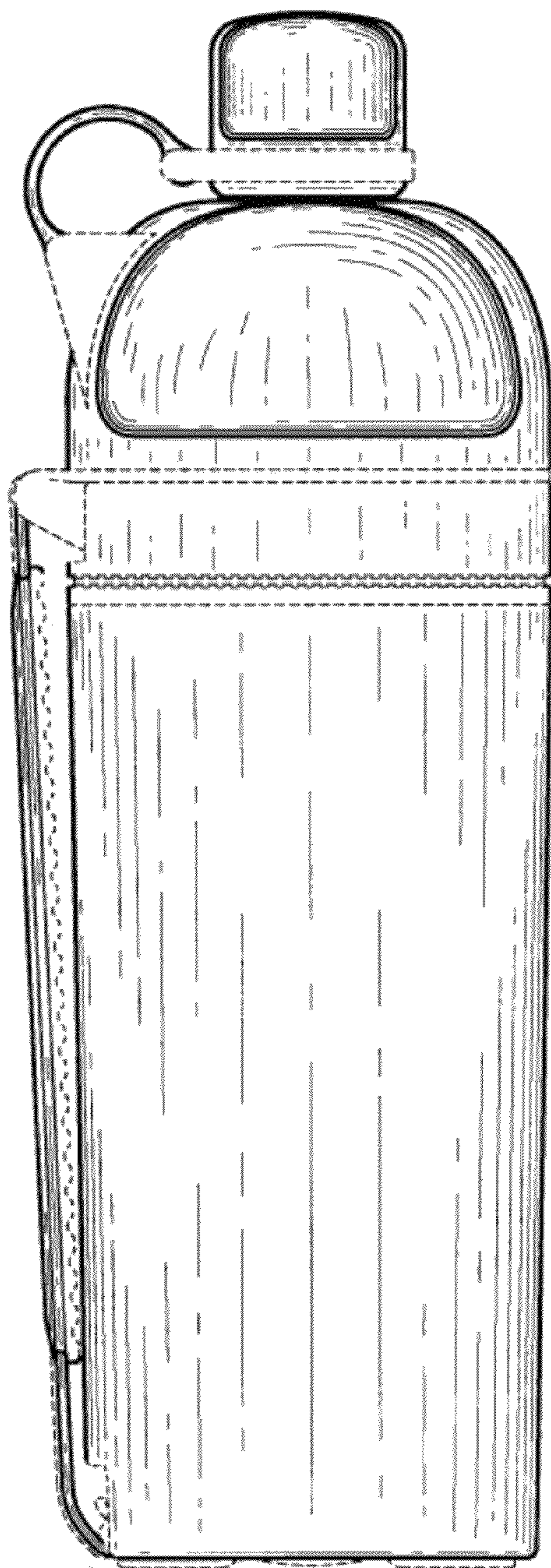

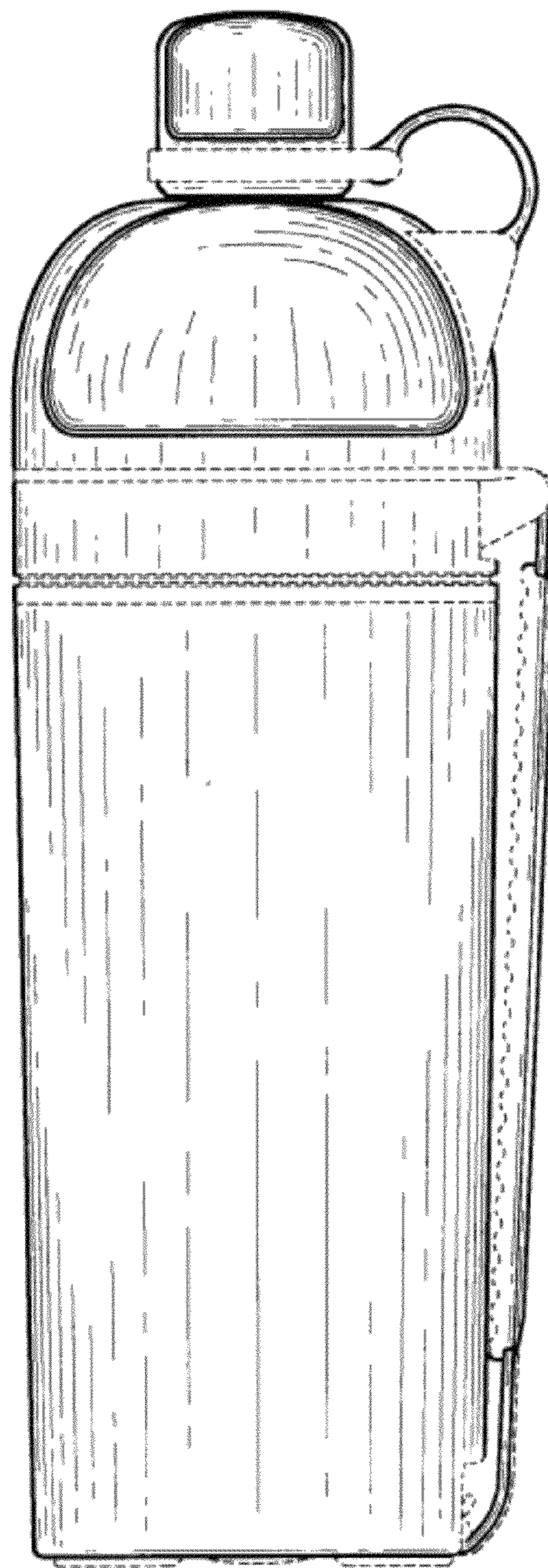

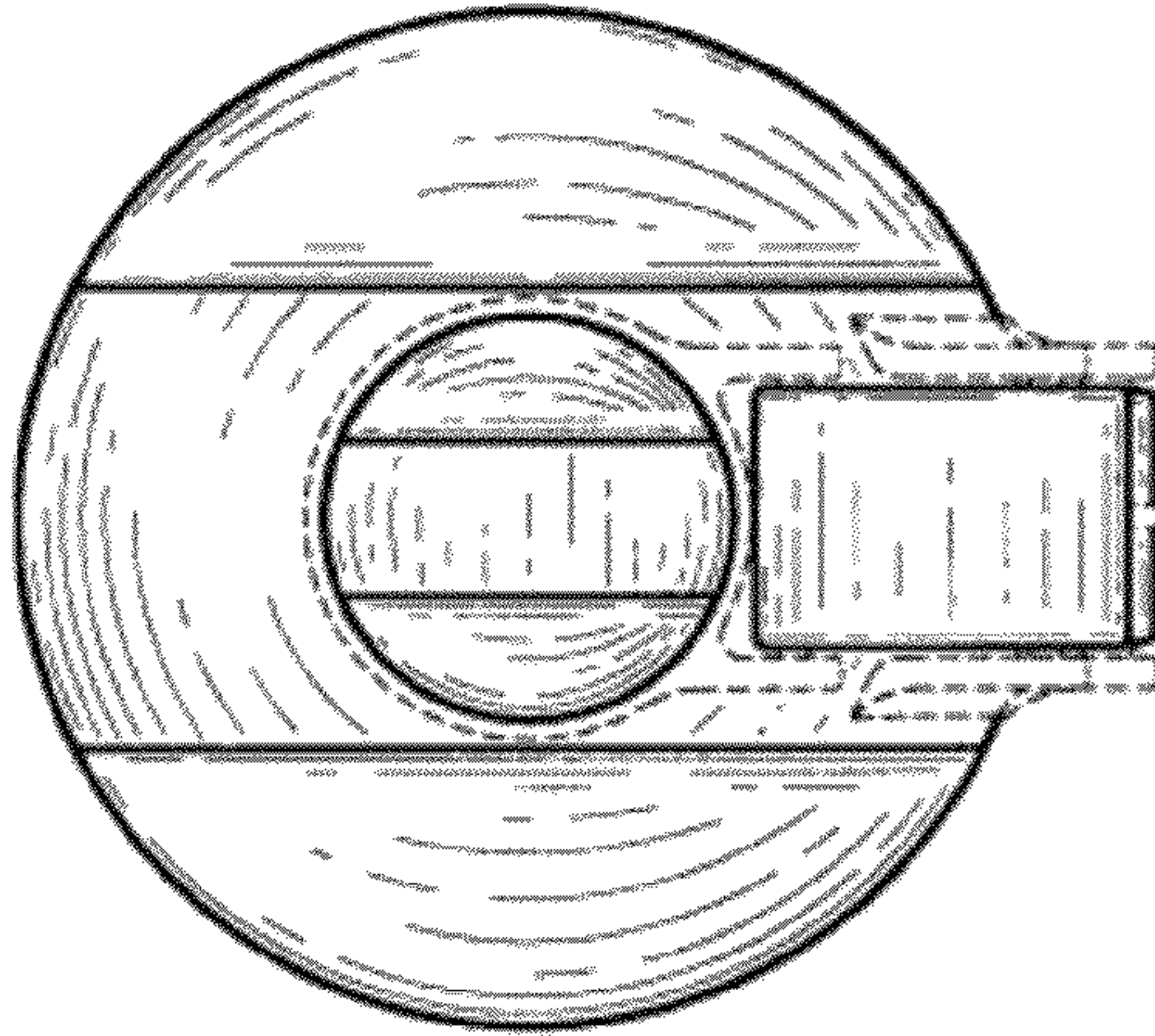

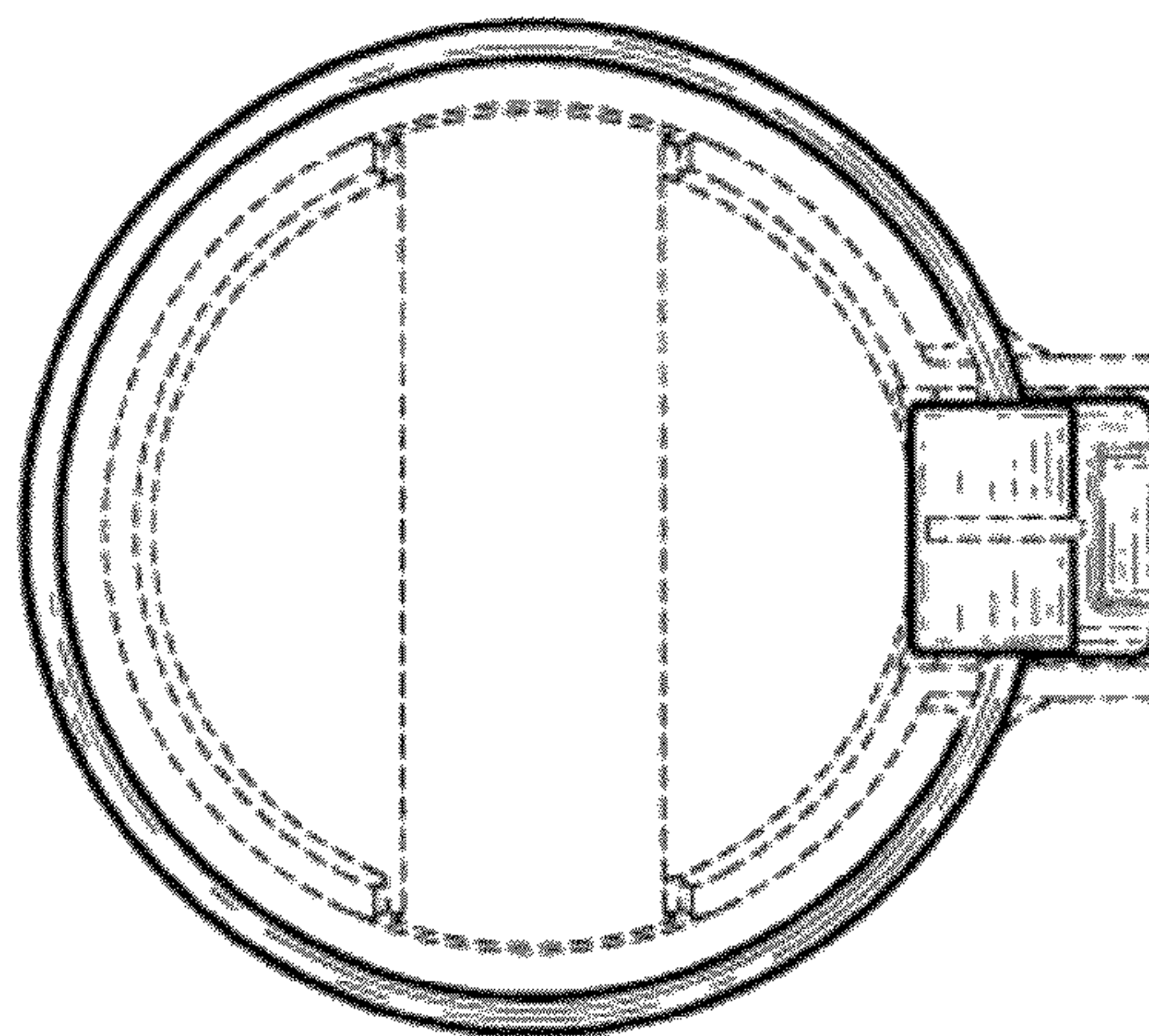
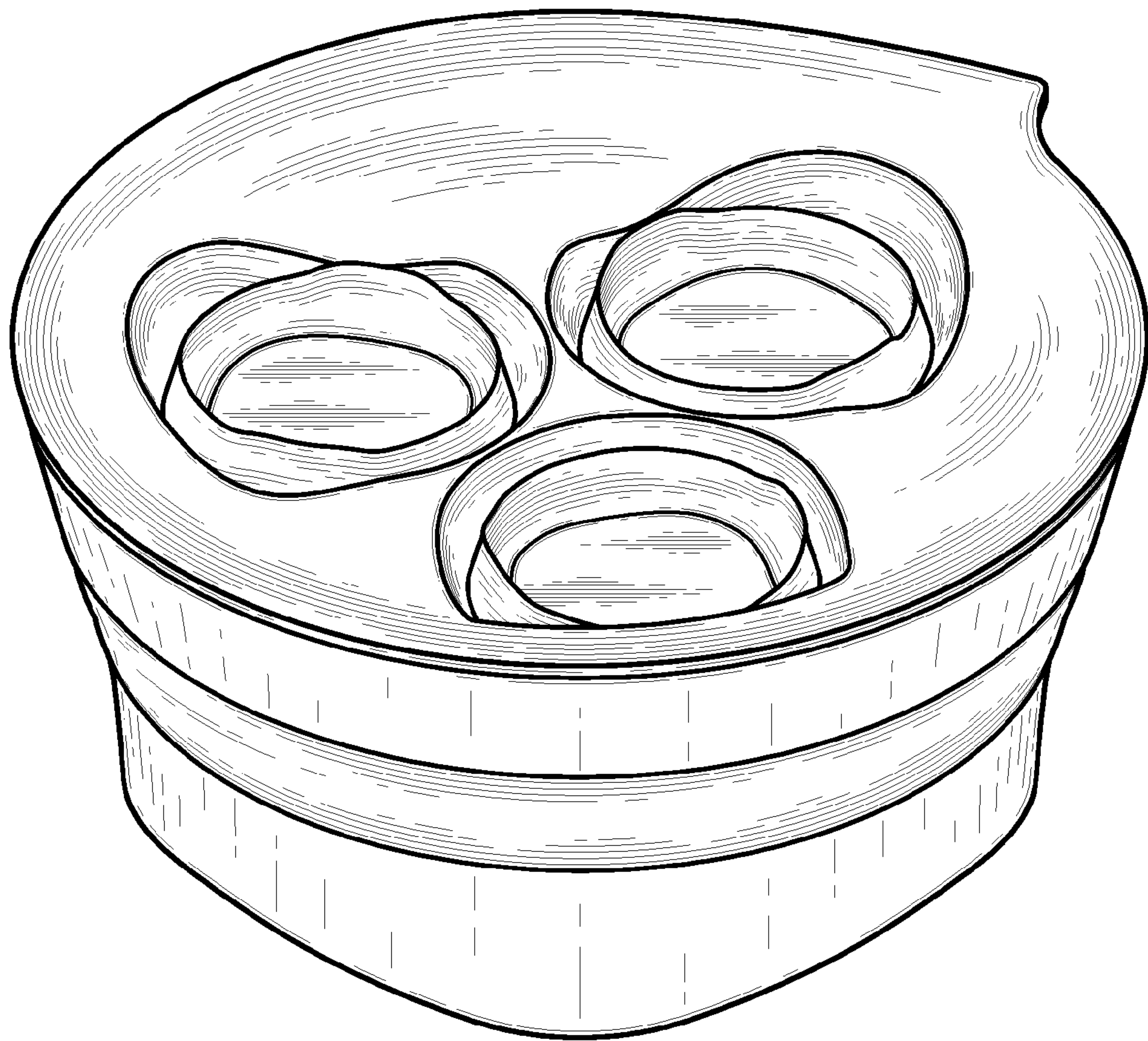
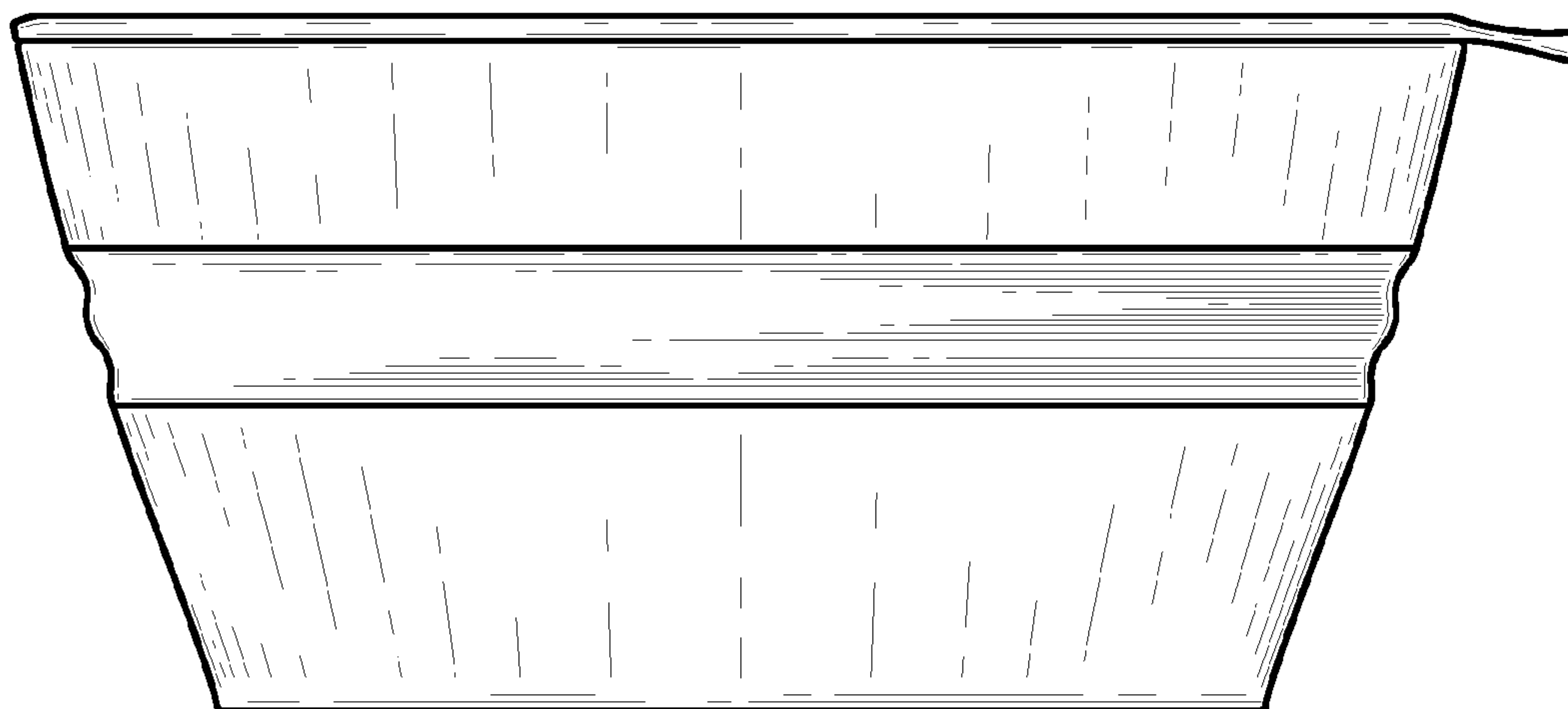


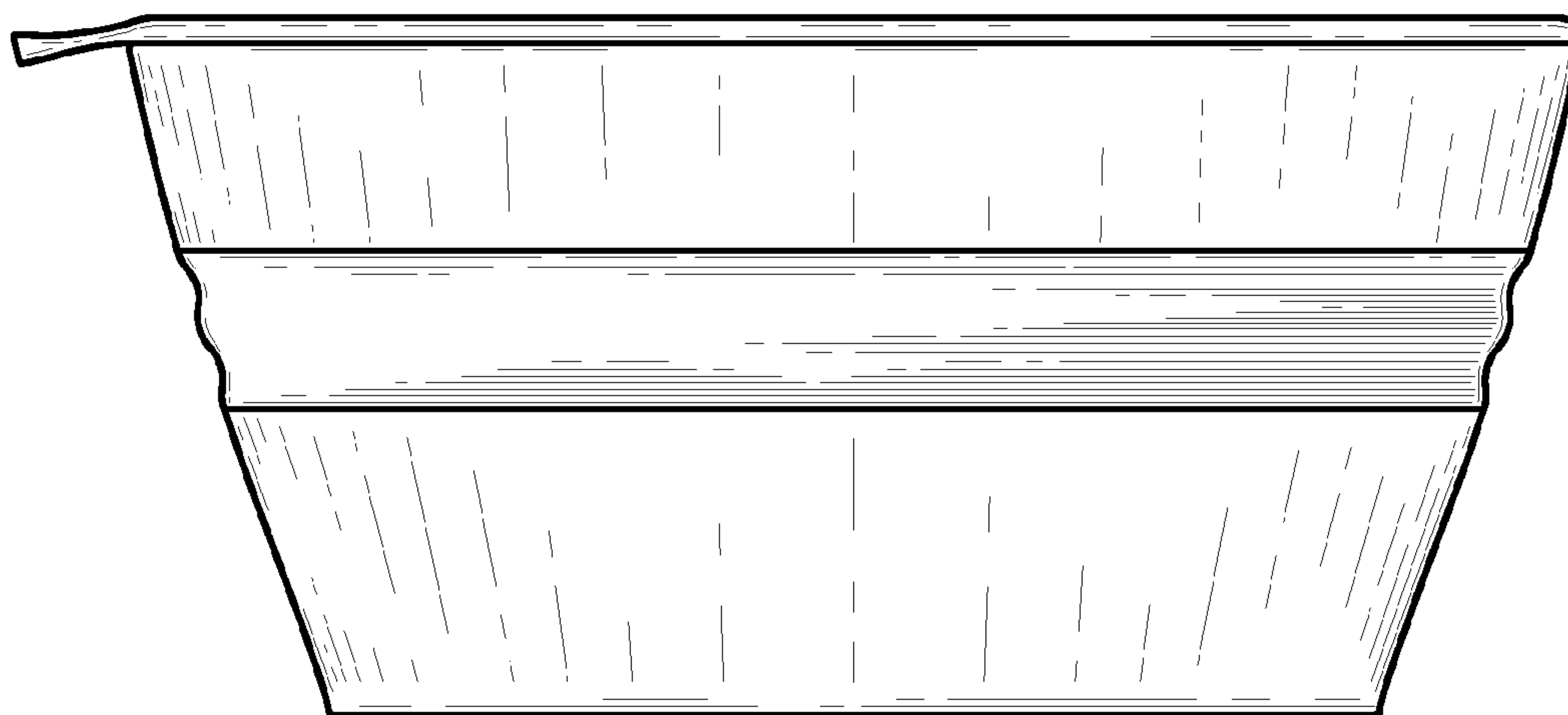

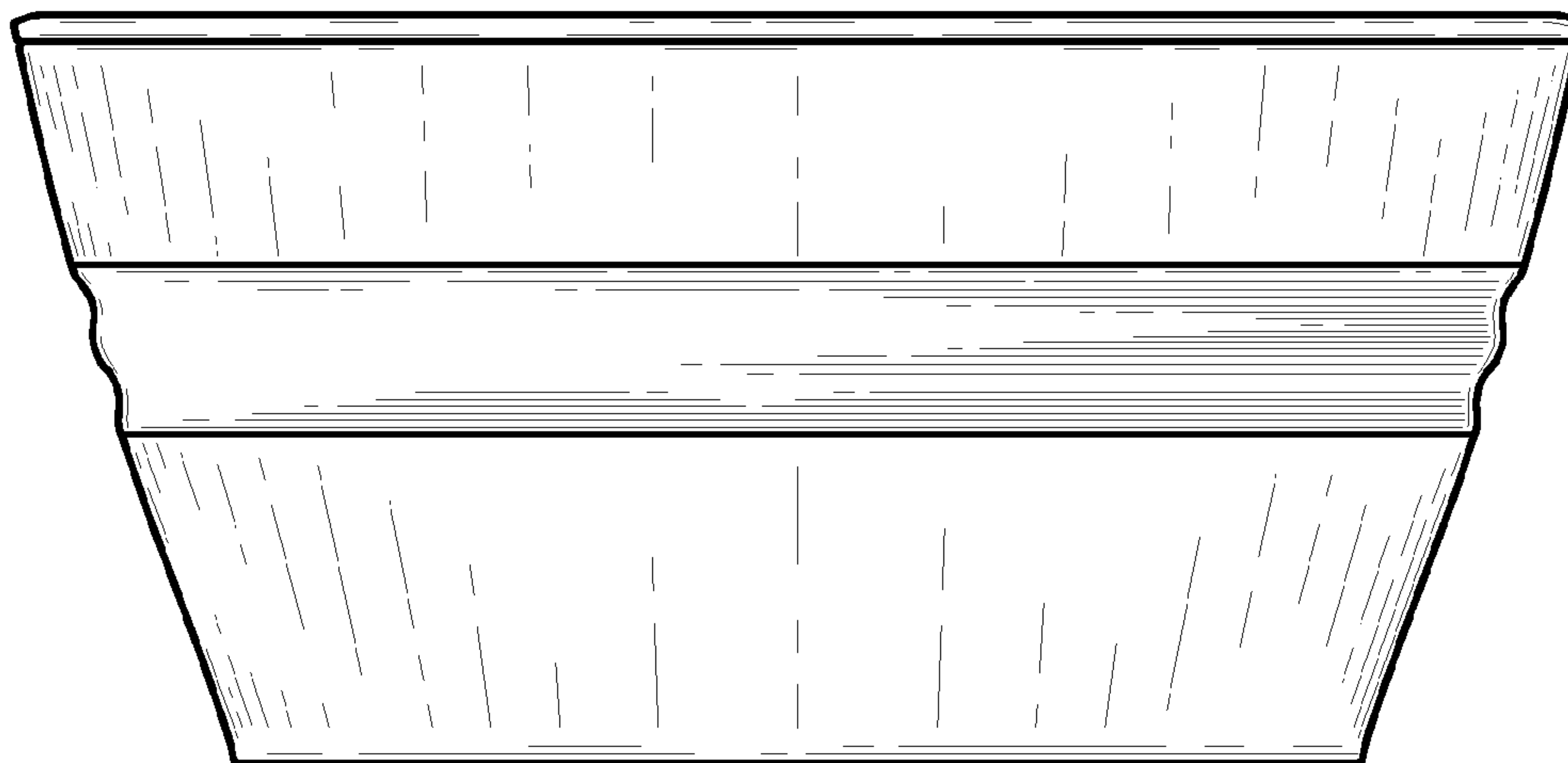

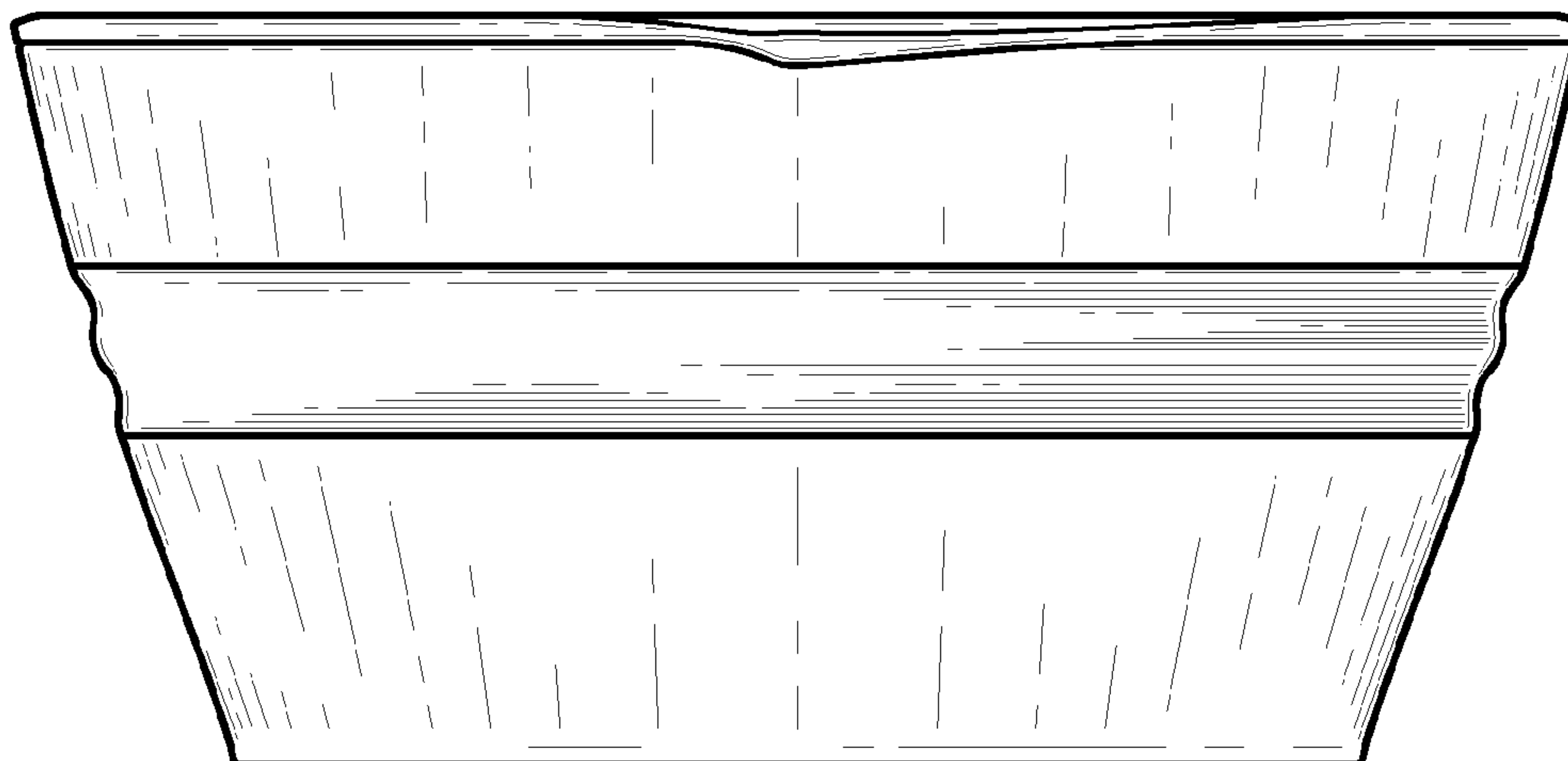

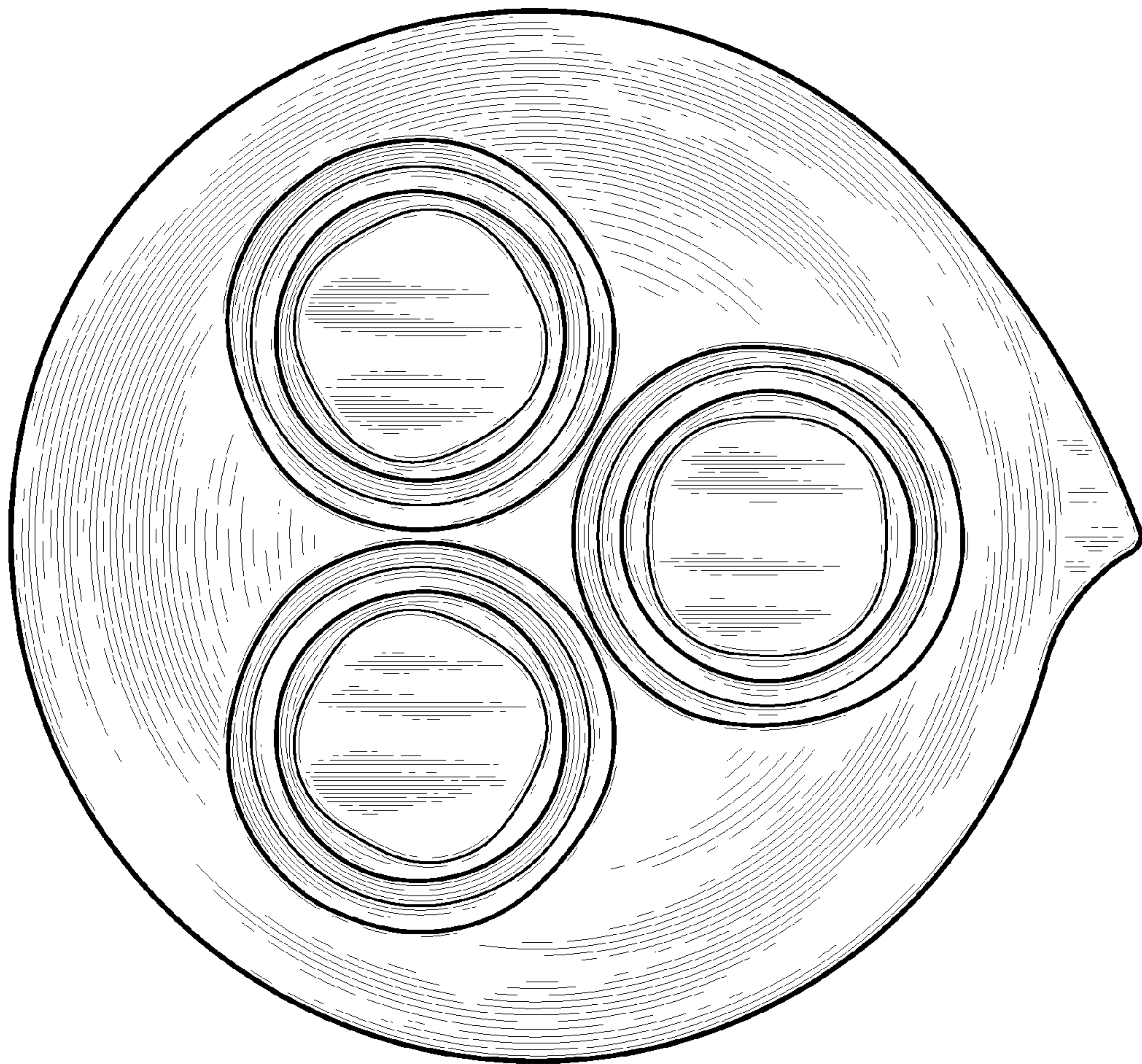

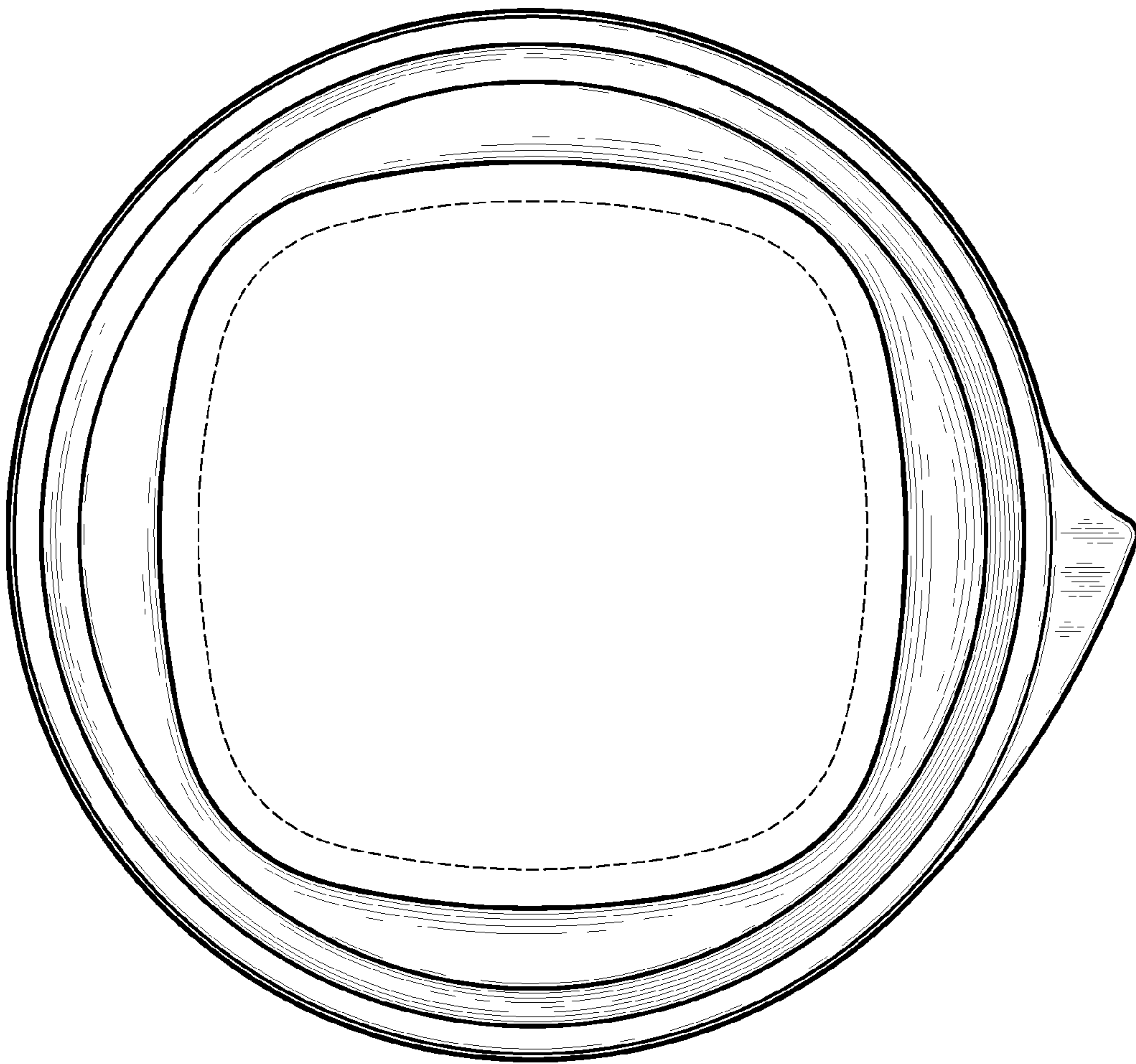

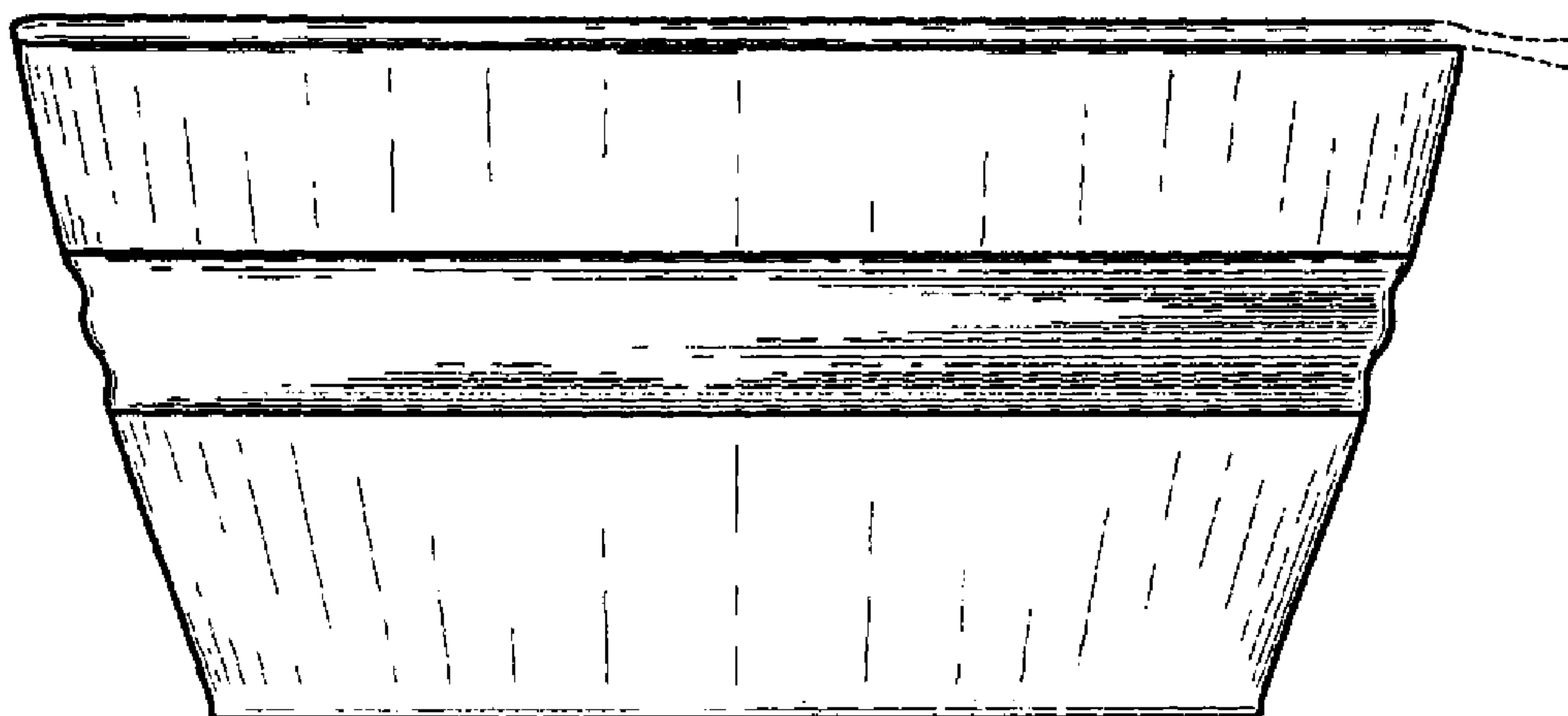

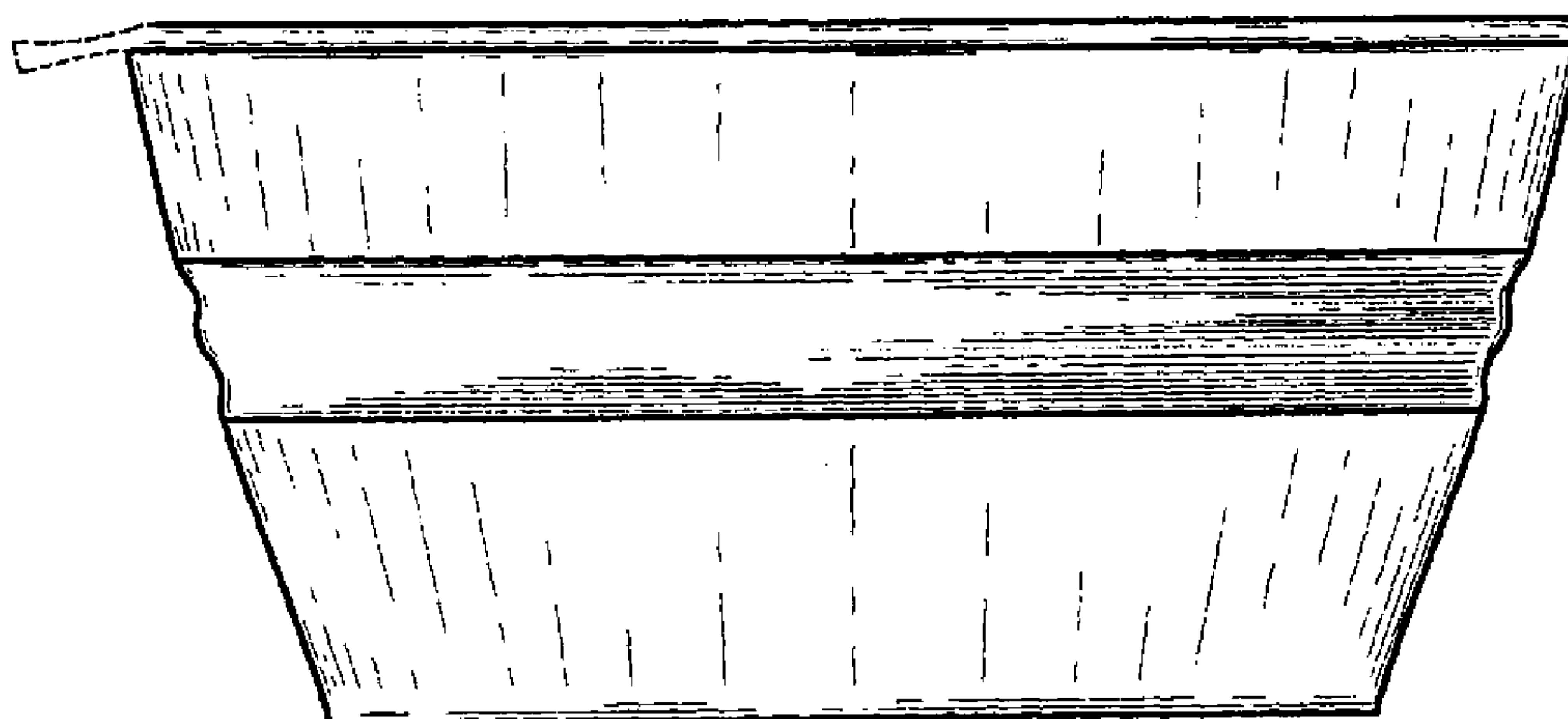

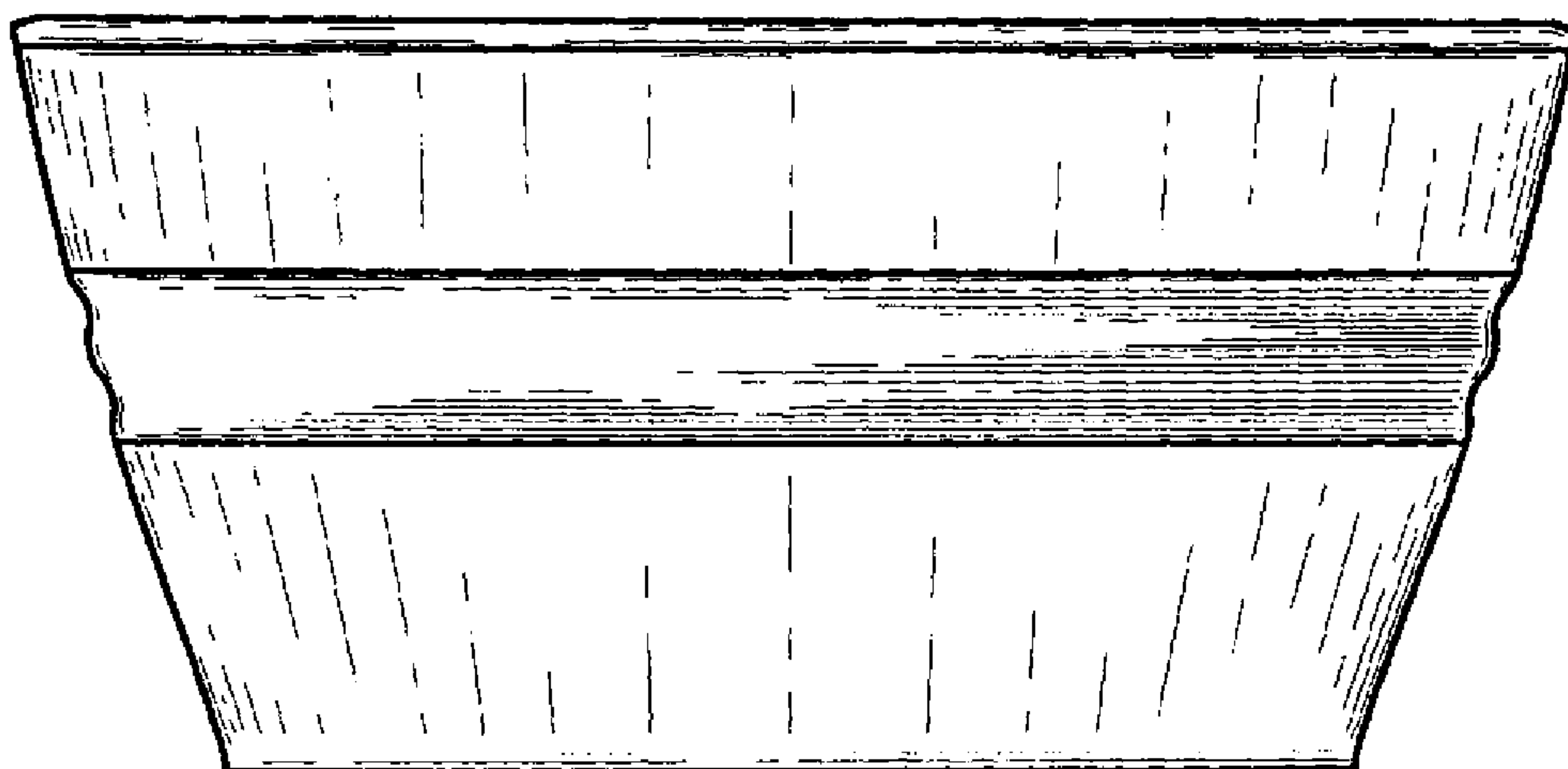

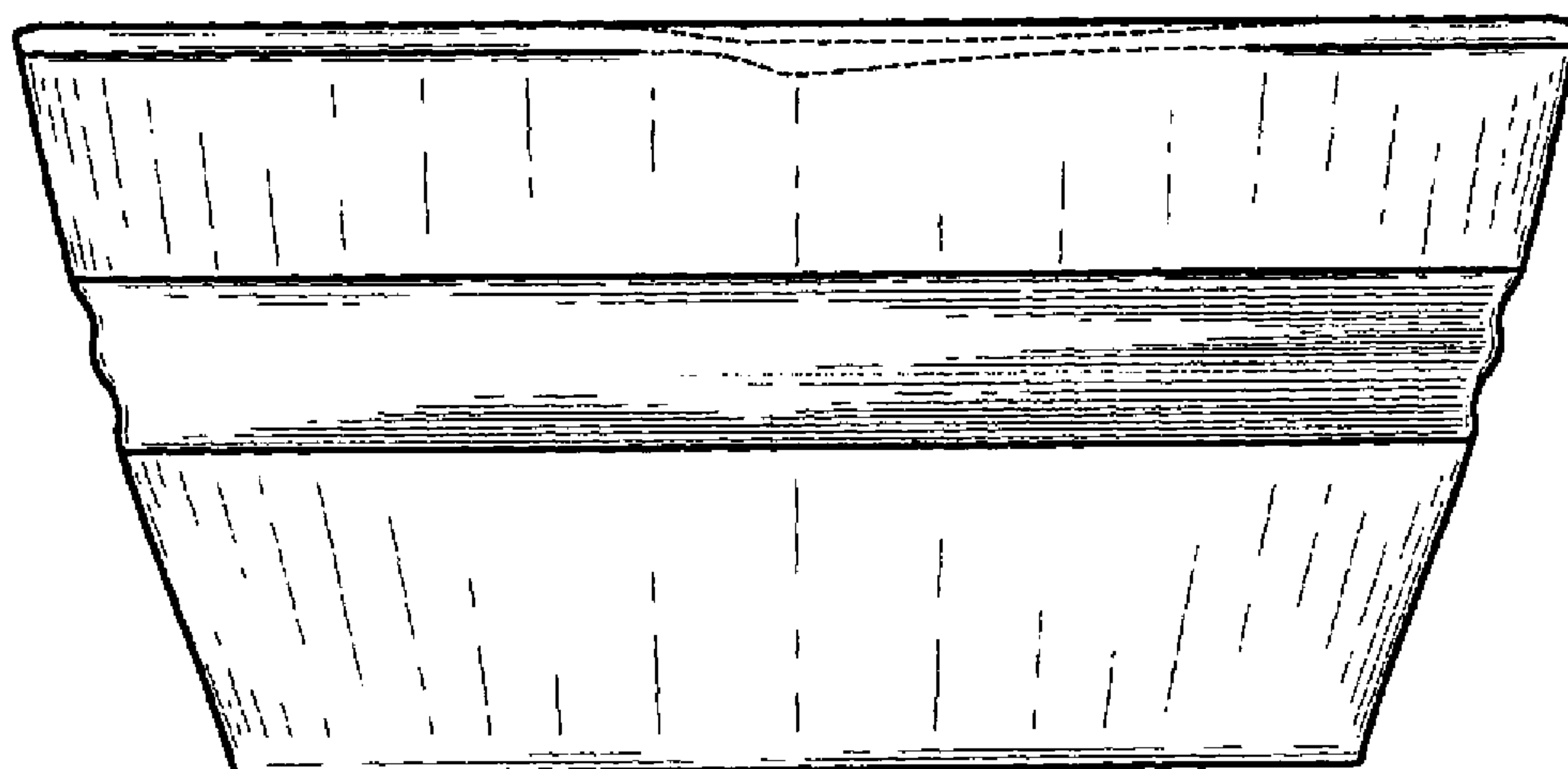

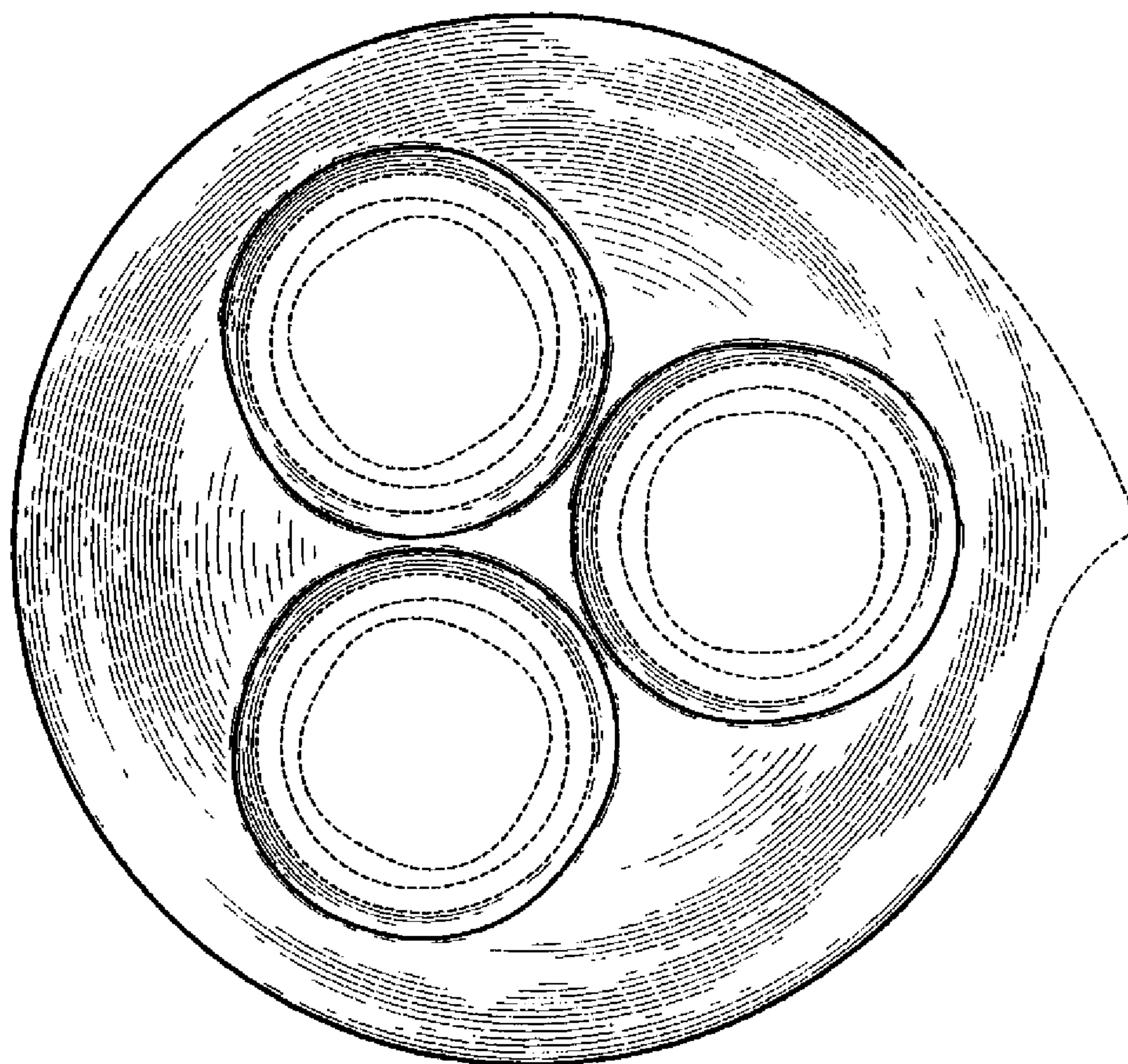

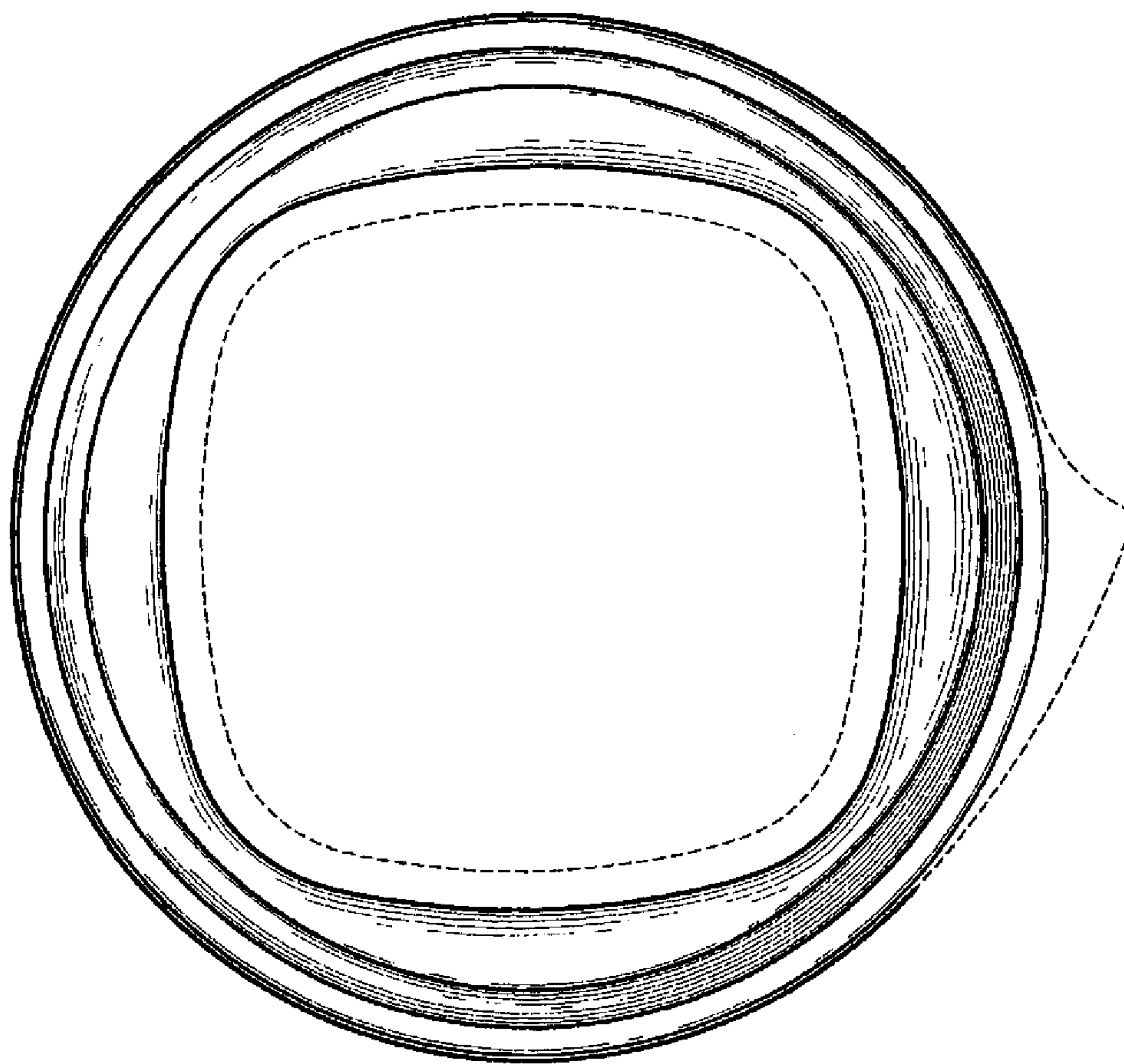

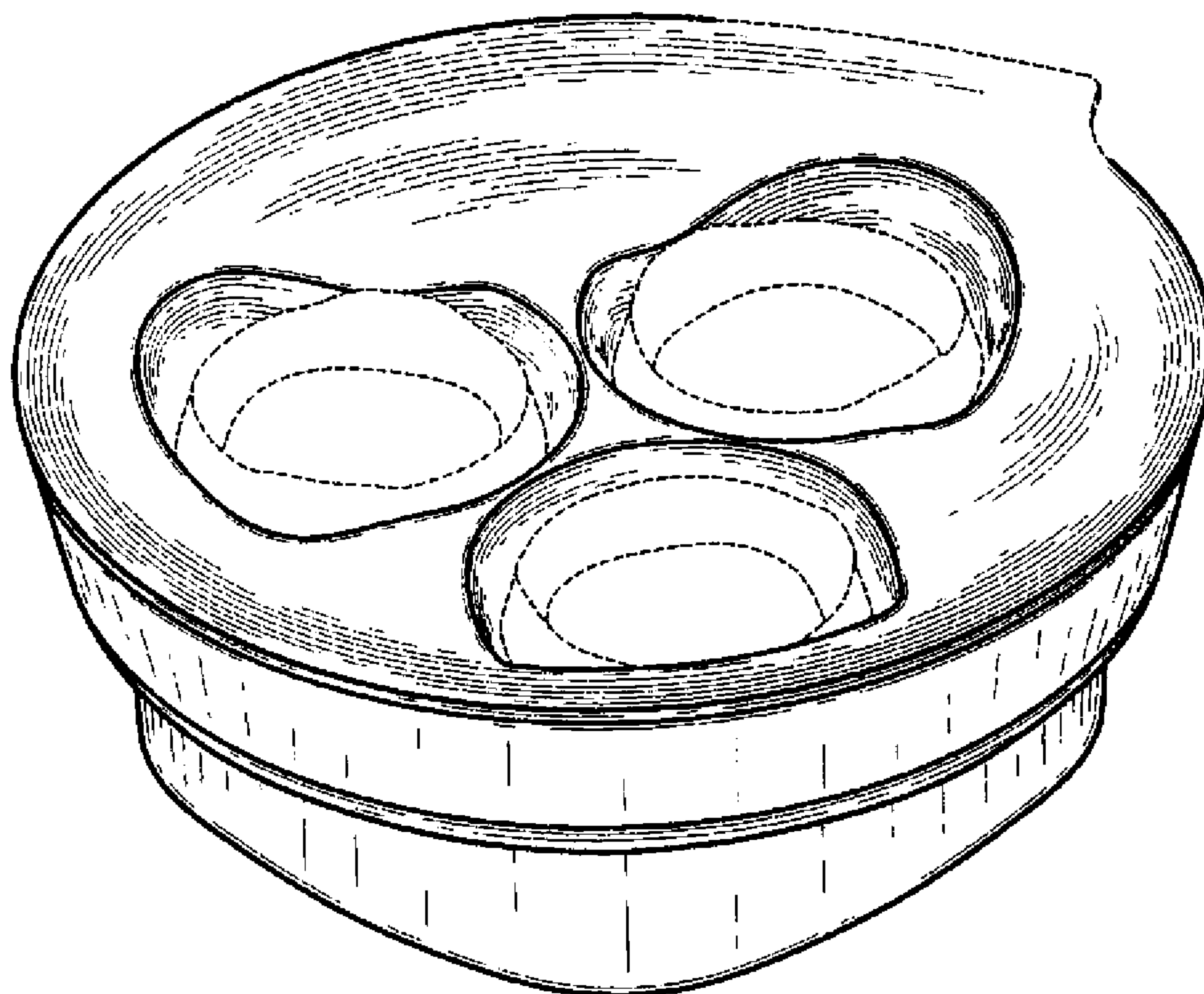

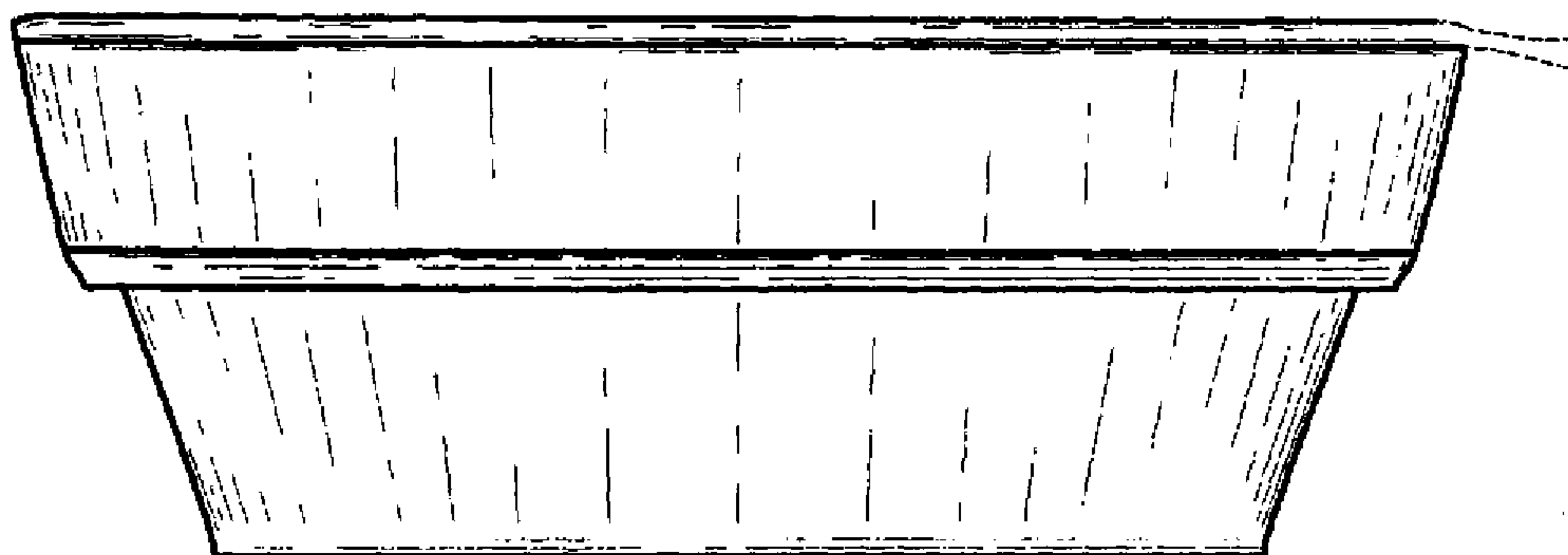




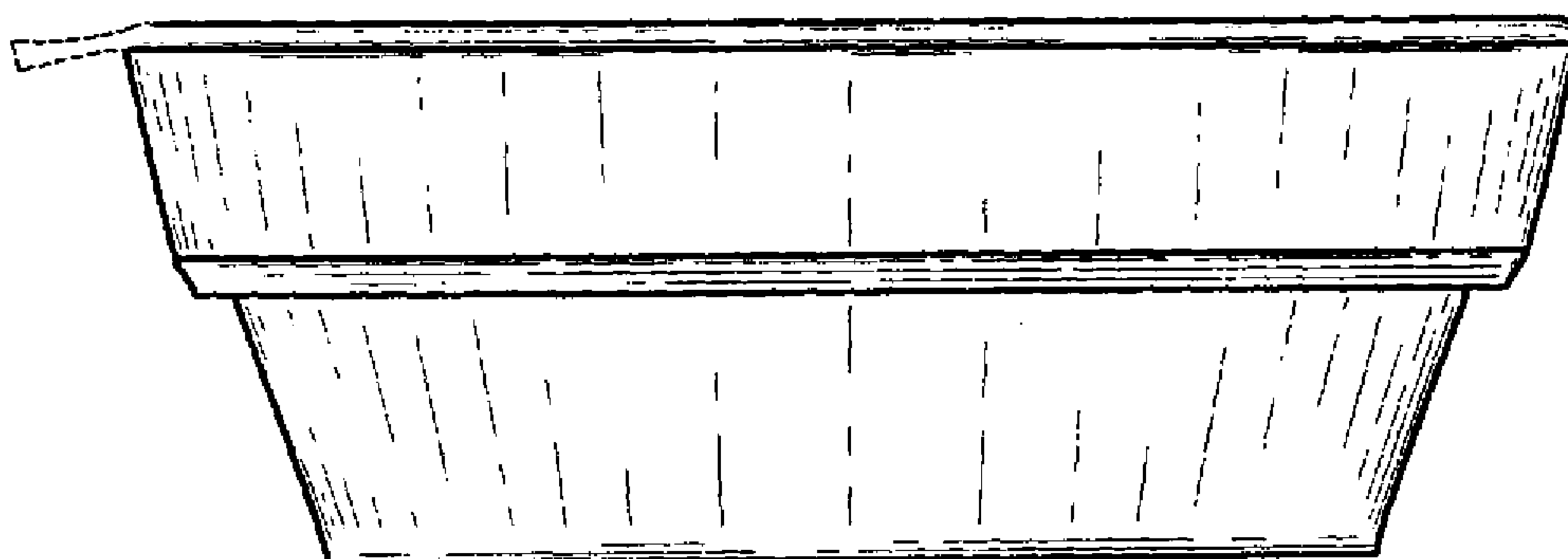

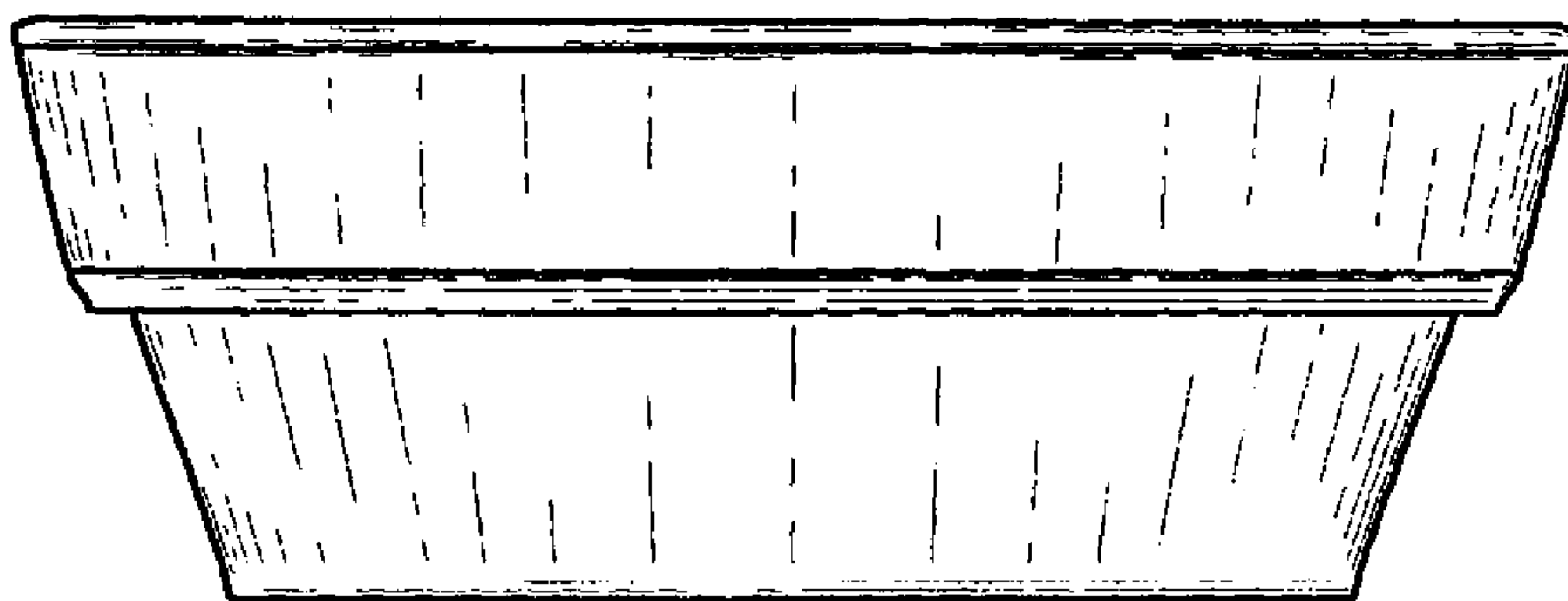

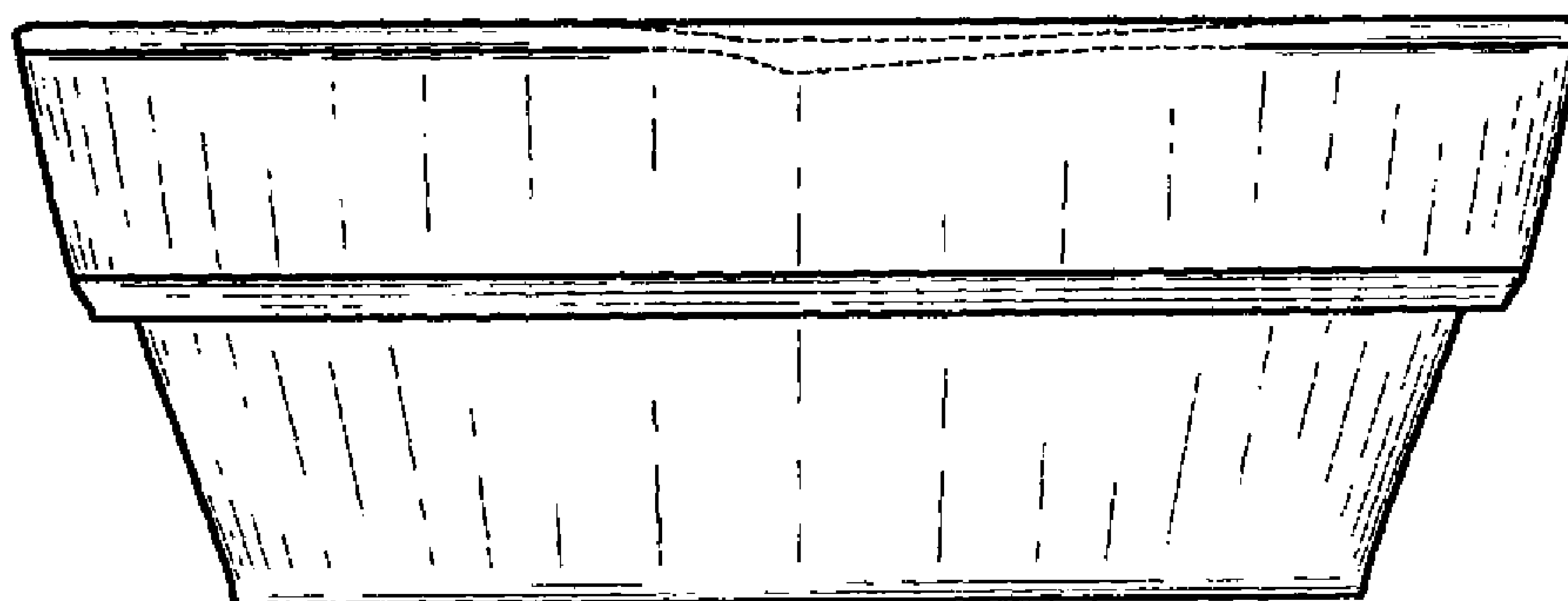

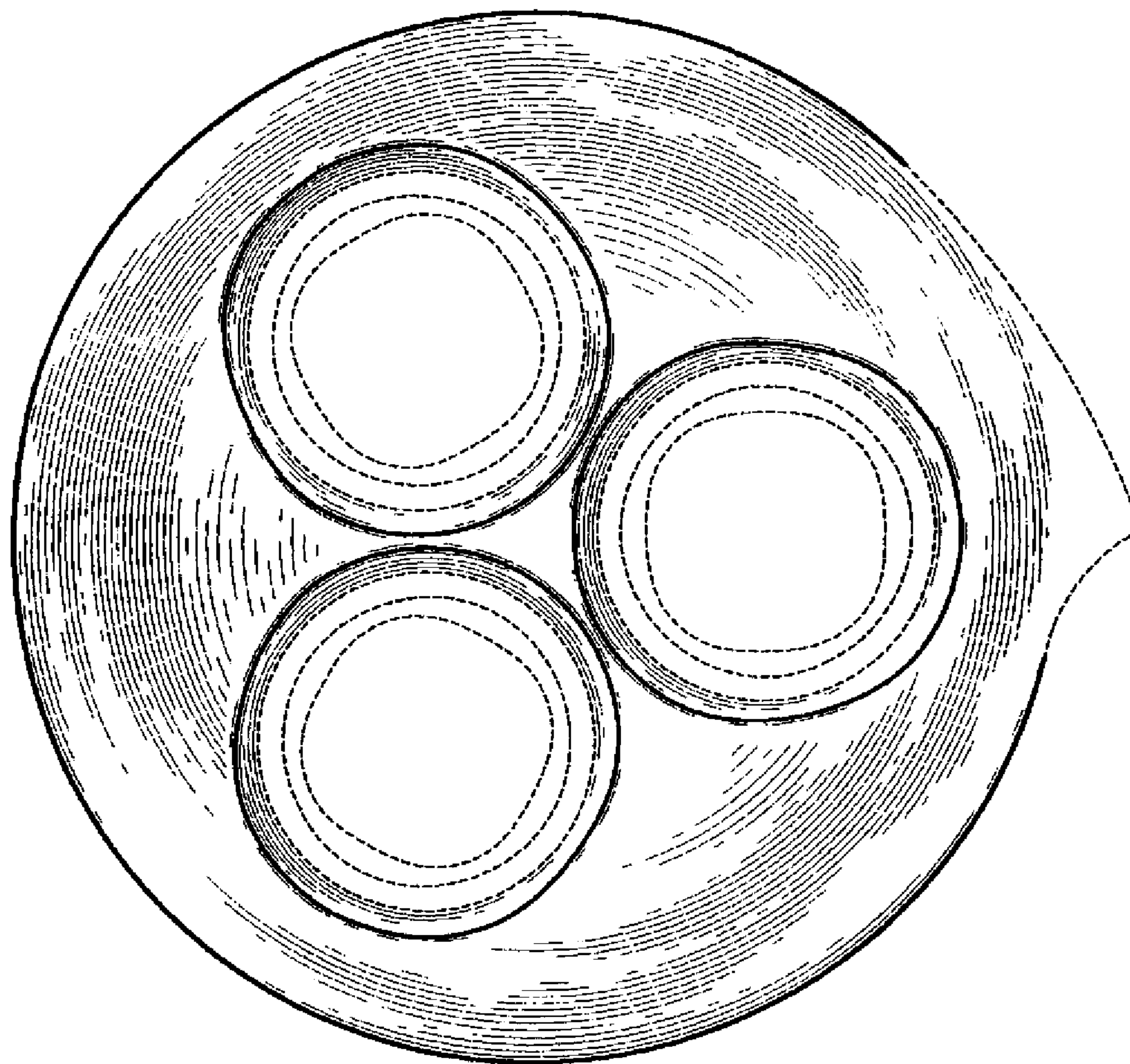




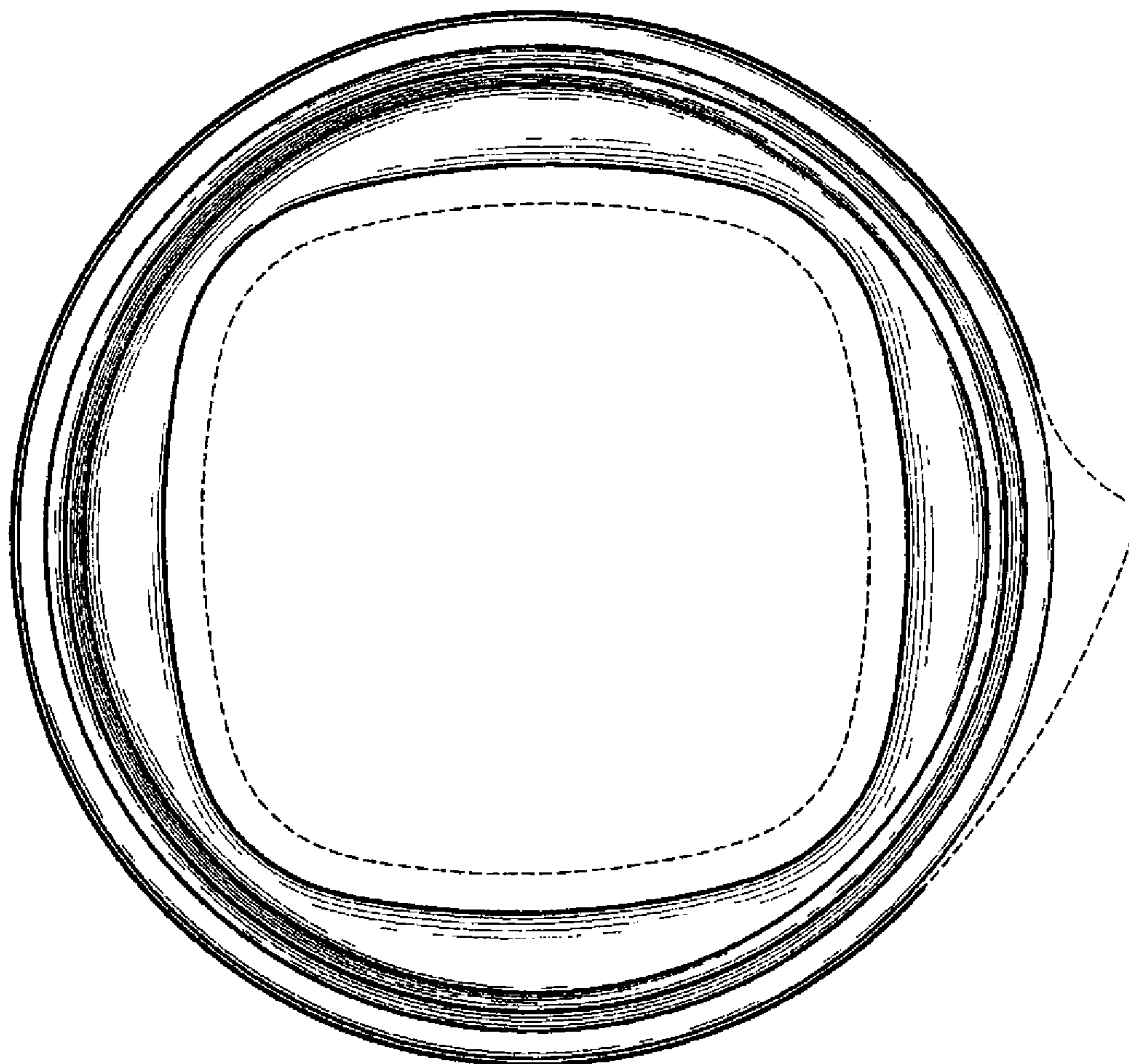
