**DESCRIPTION**

FIG. 5 is a side view of the cable organizer shown in FIG. 1, wherein the opposite side view is a mirror image thereof.

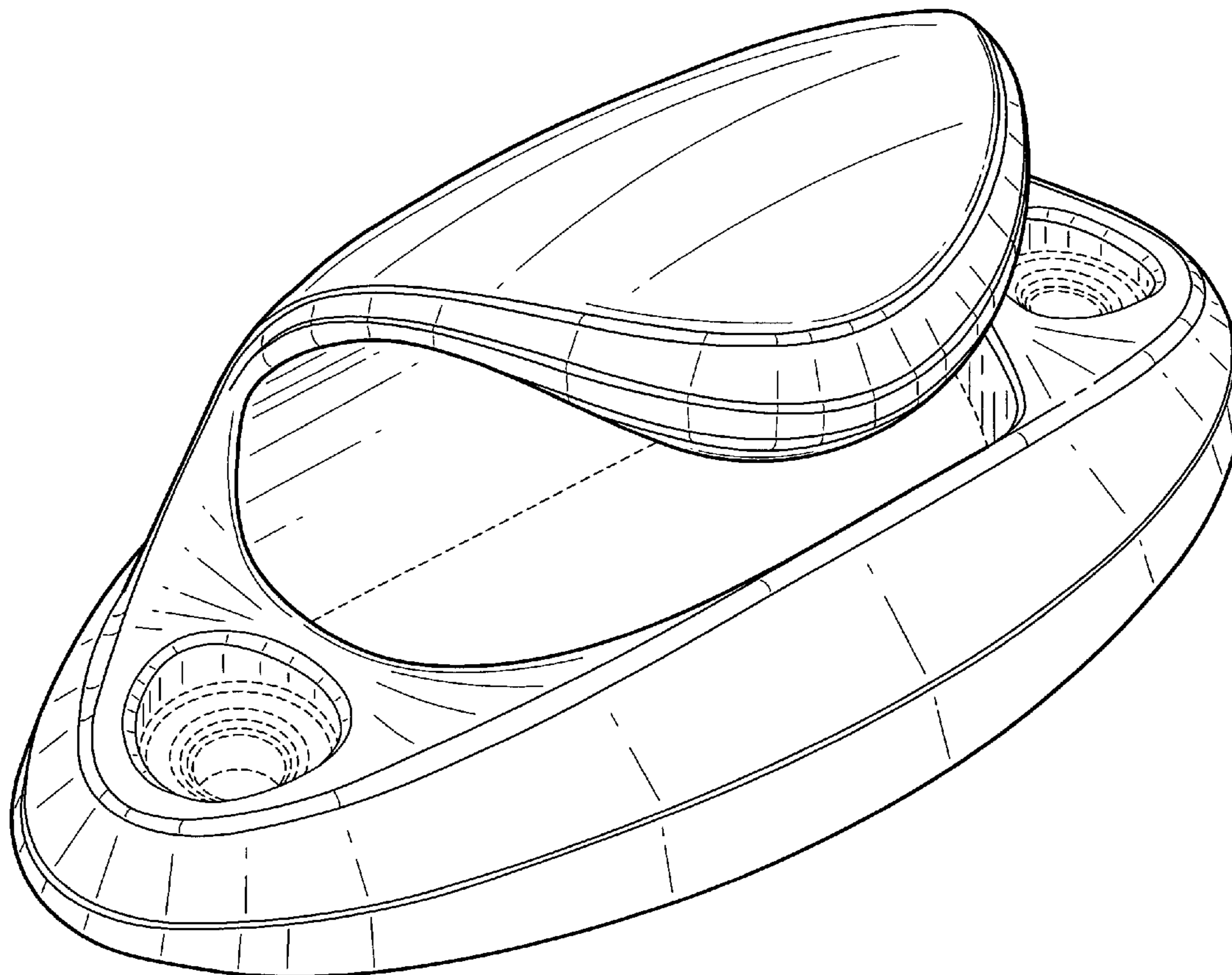
FIG. 6 is a rear view of the cable organizer shown in FIG. 1; and,

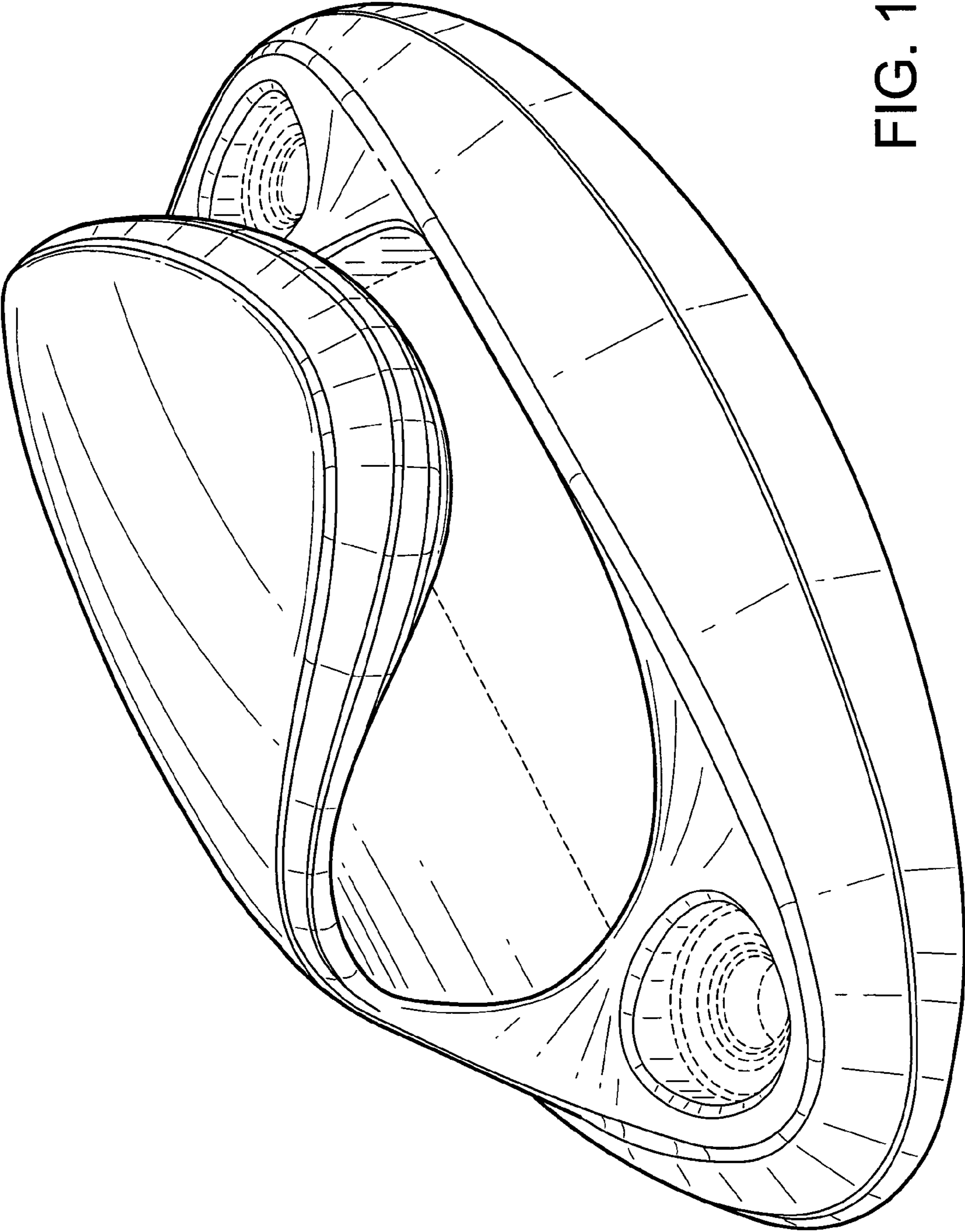

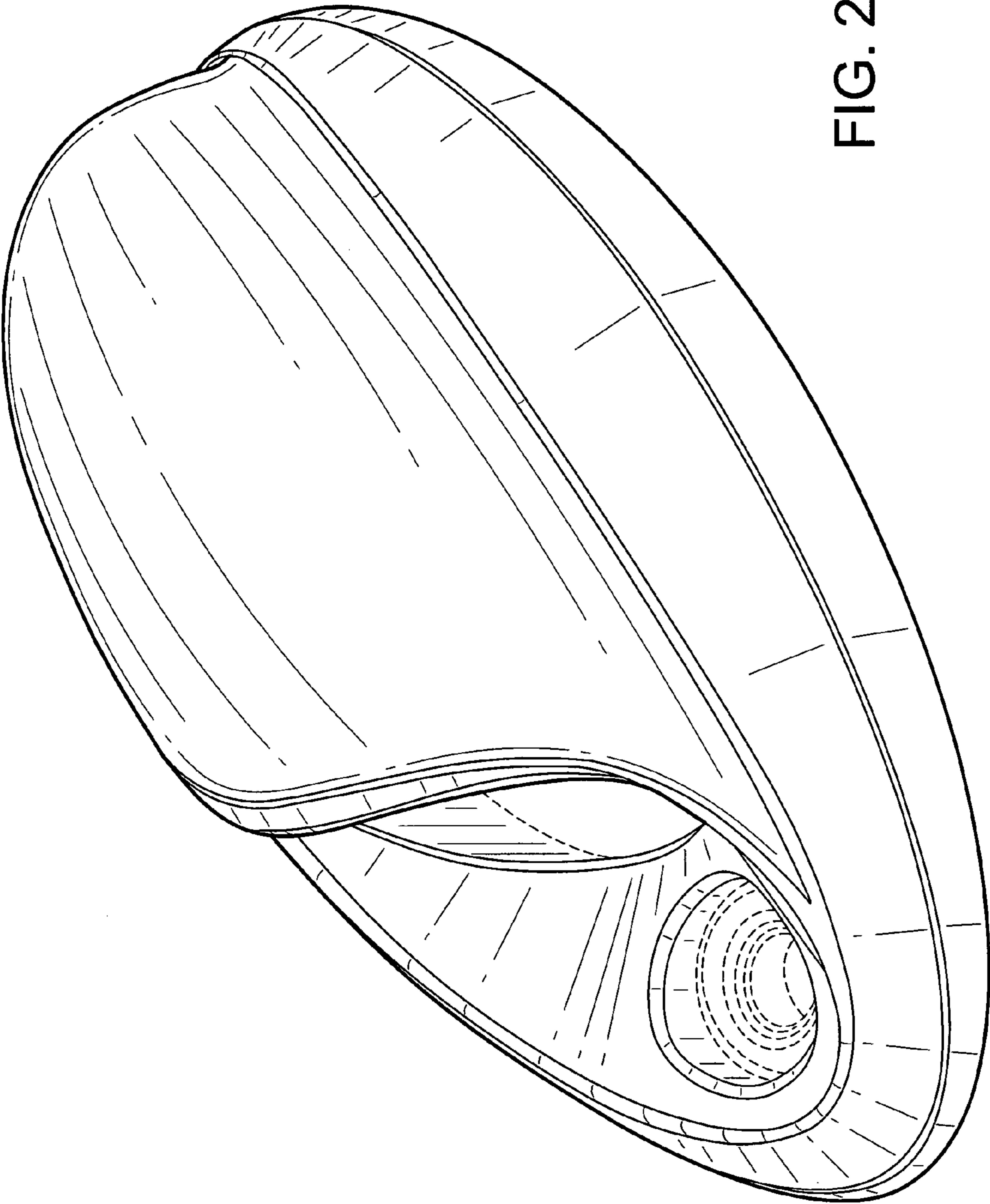

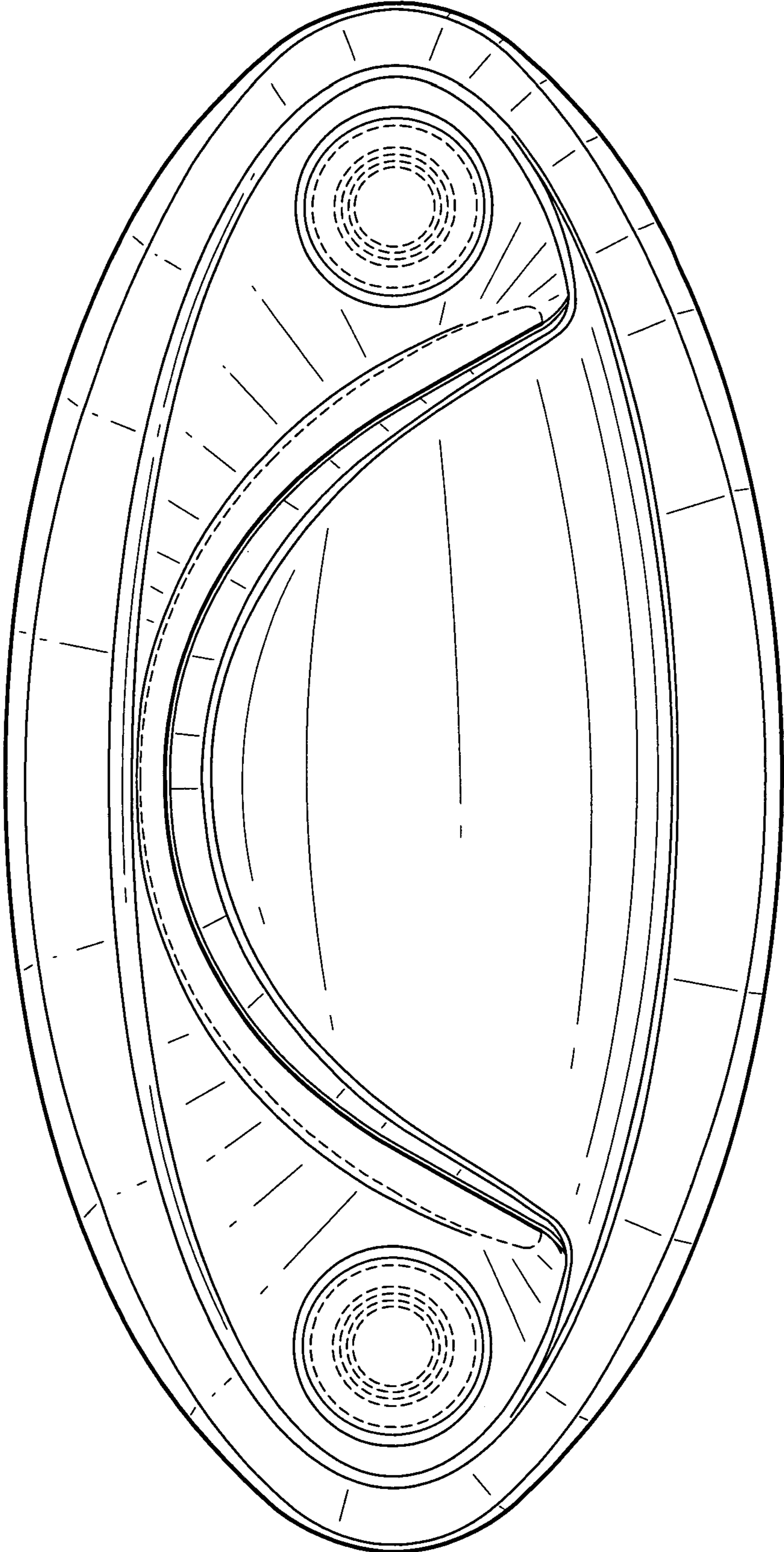

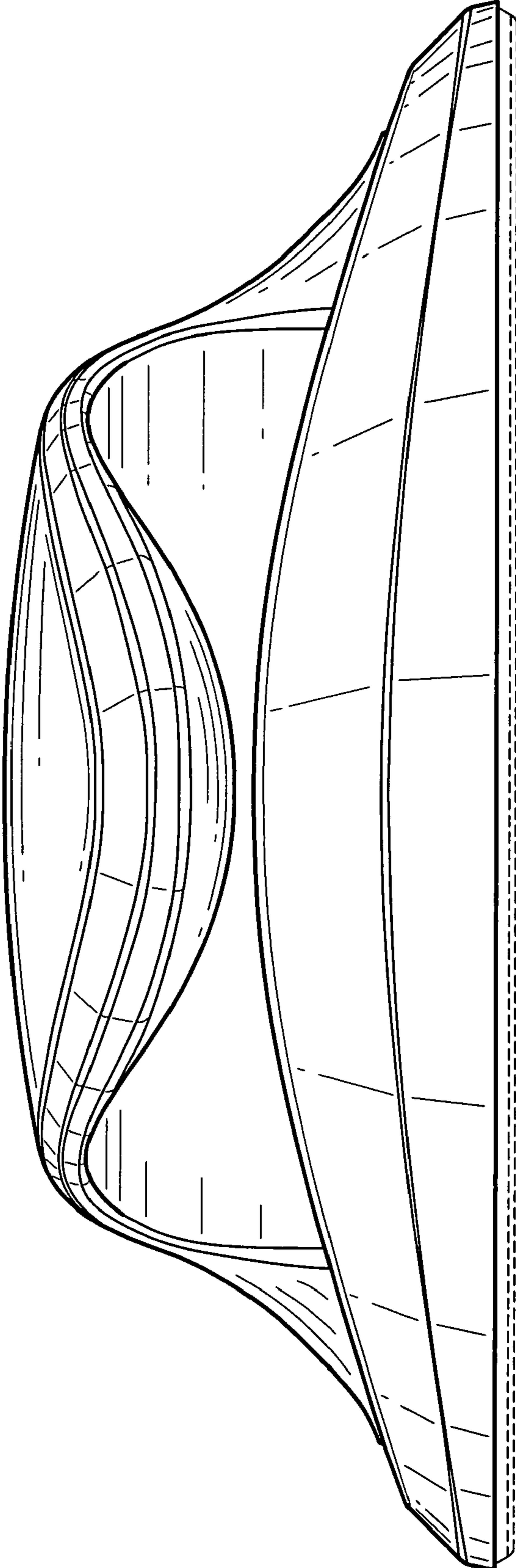

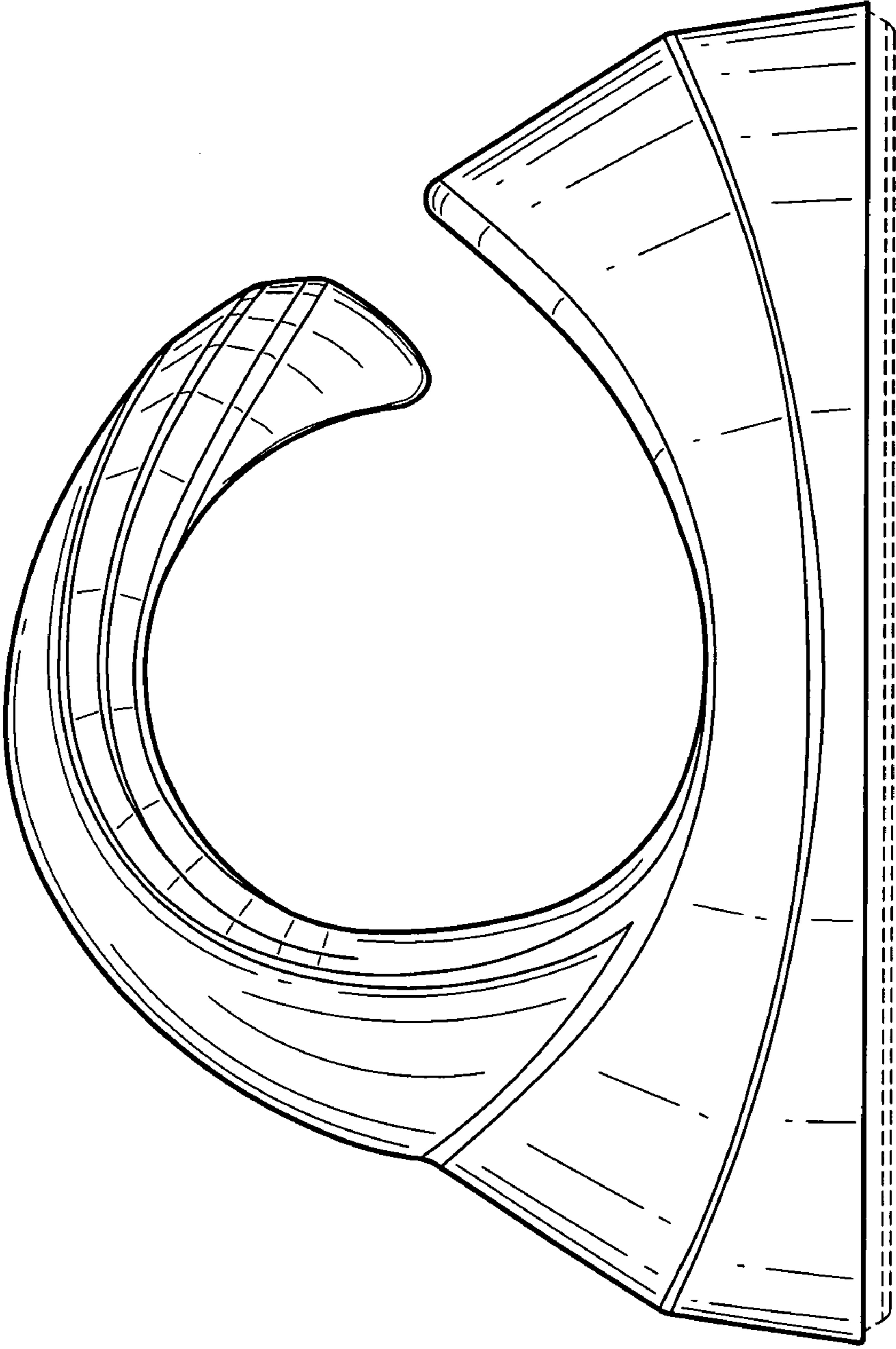

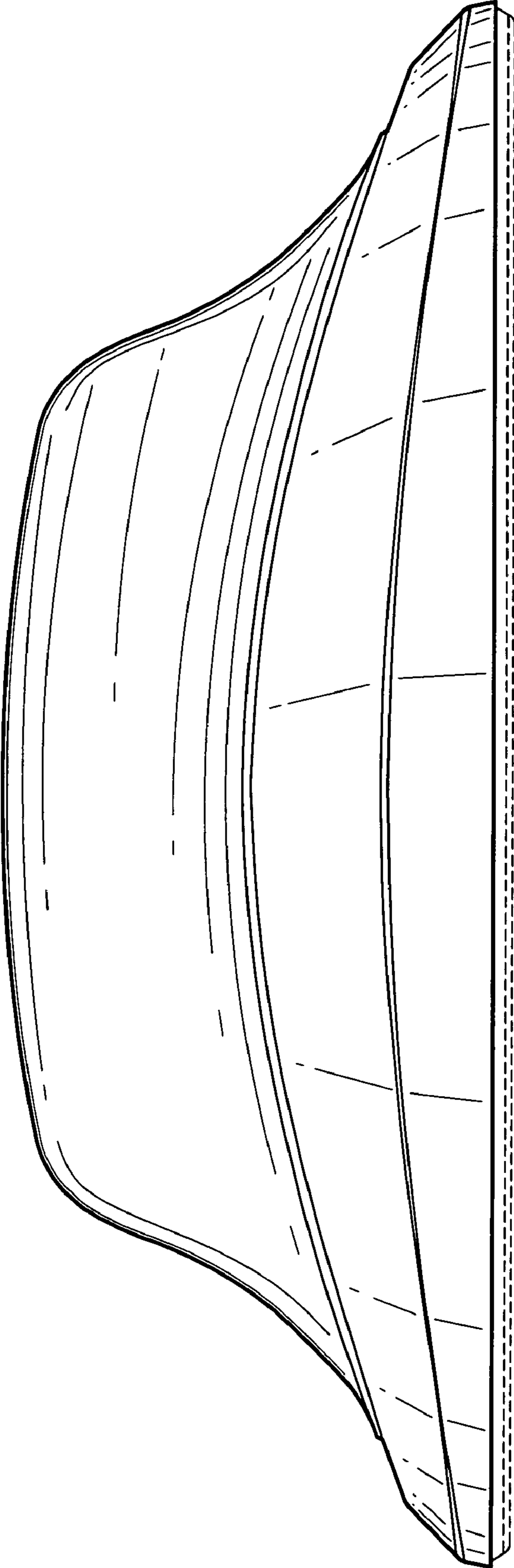

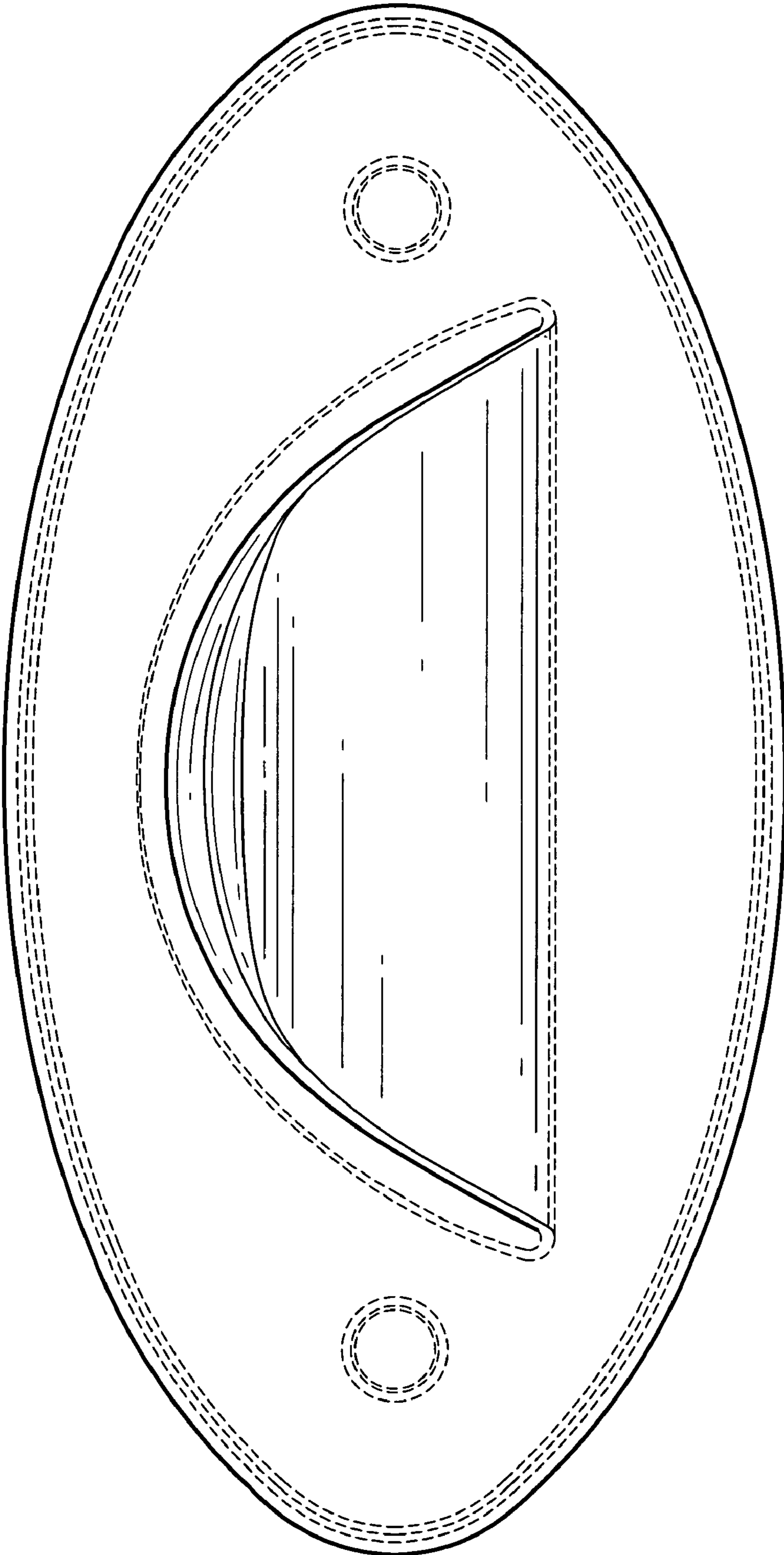
