FIG. 11 is a side view of the bottle shown in FIG. 8;

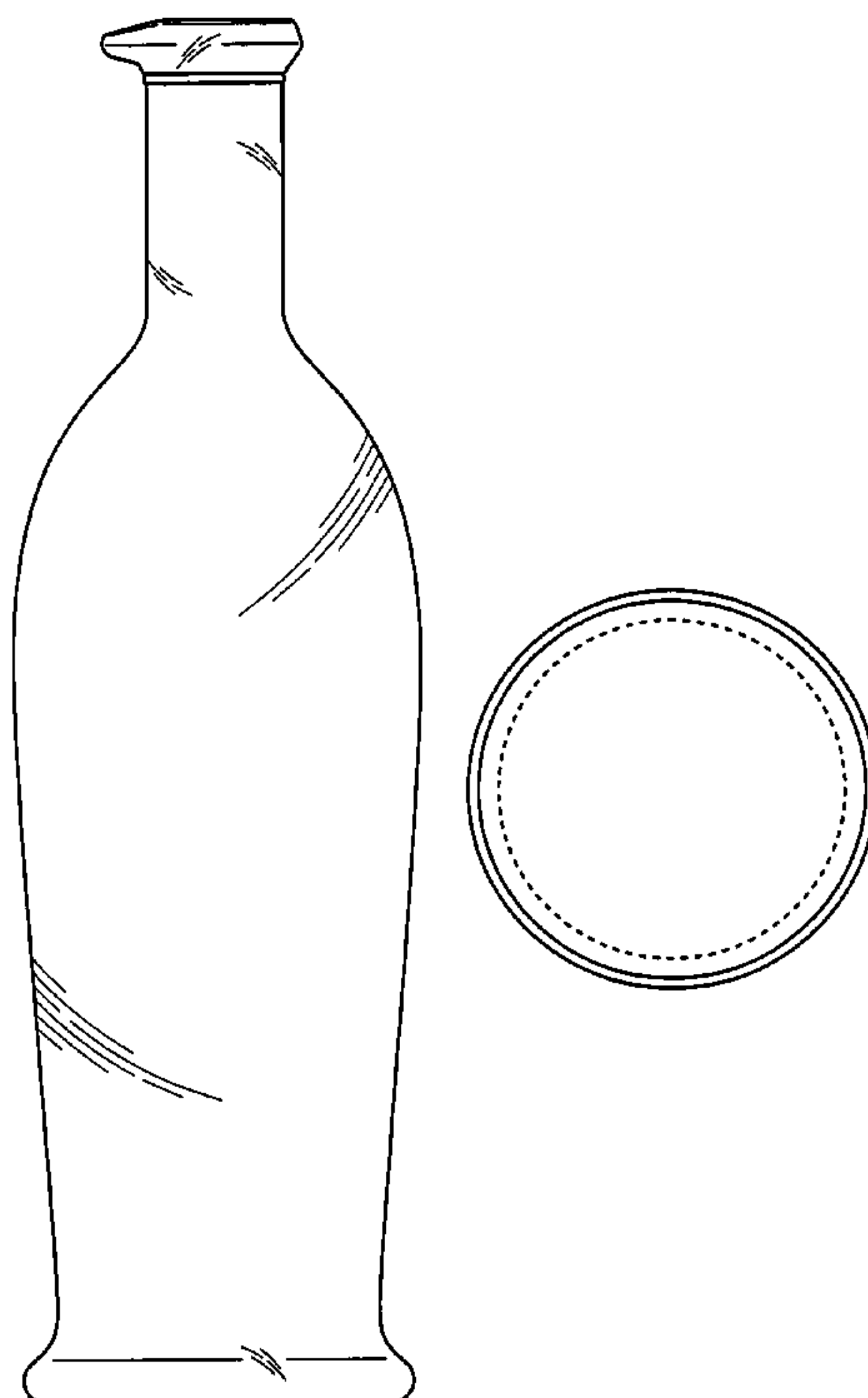
FIG. 12 is another side view of the bottle shown in FIG. 8;

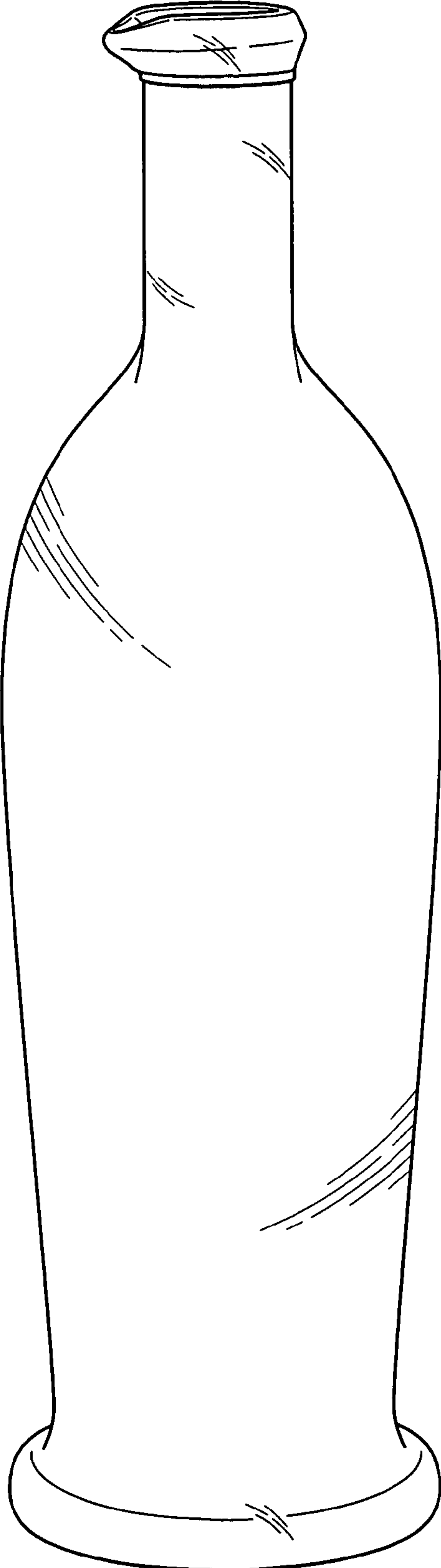

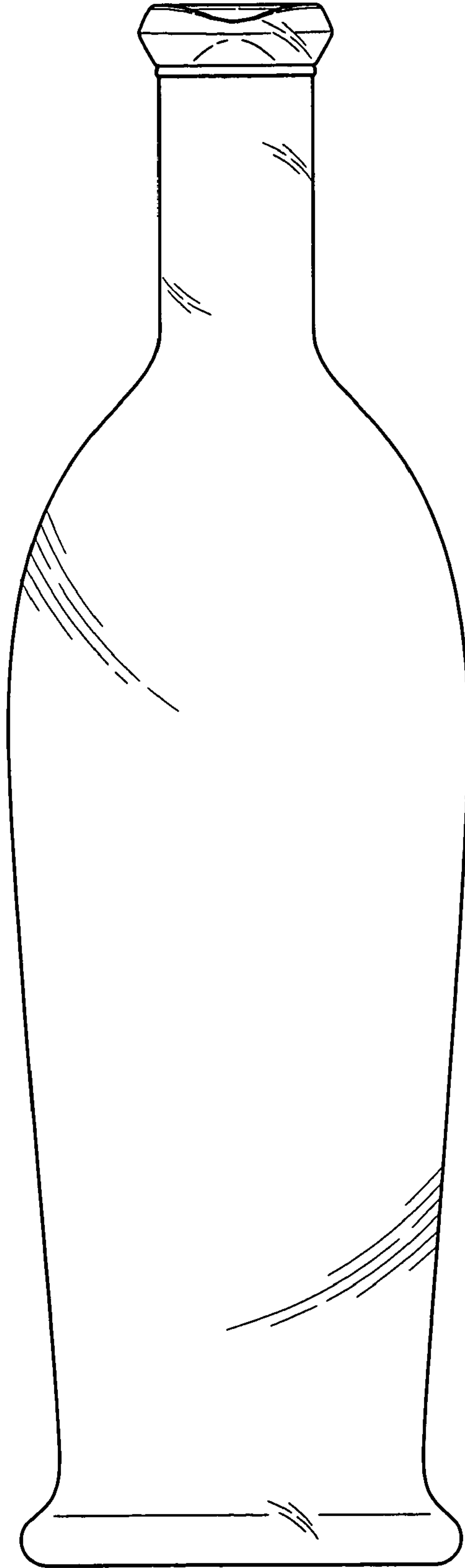

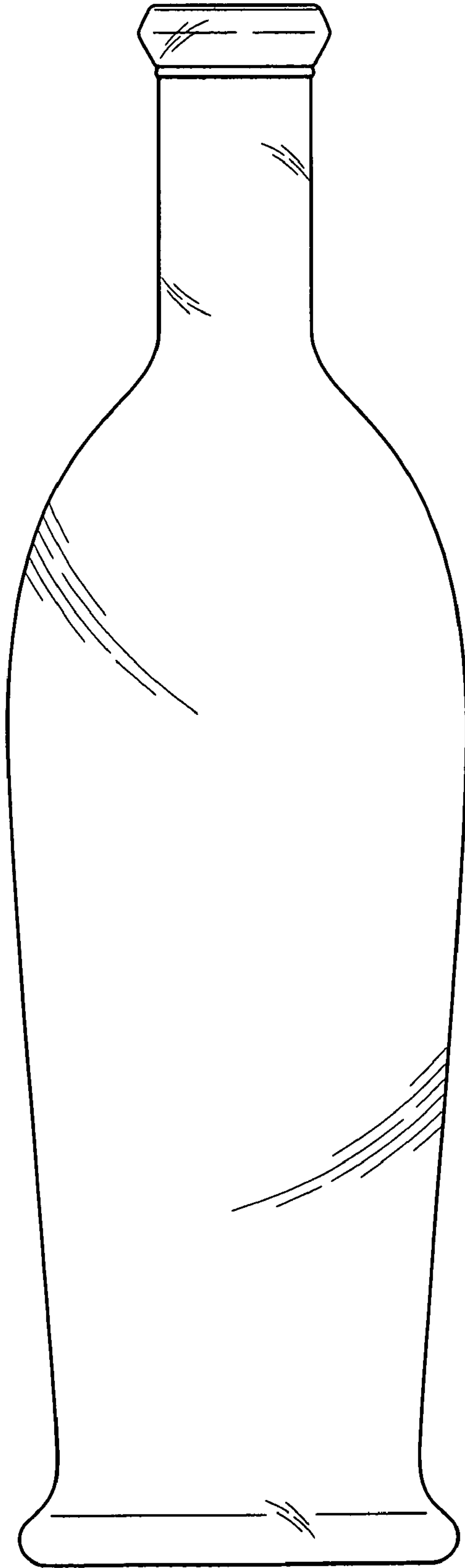

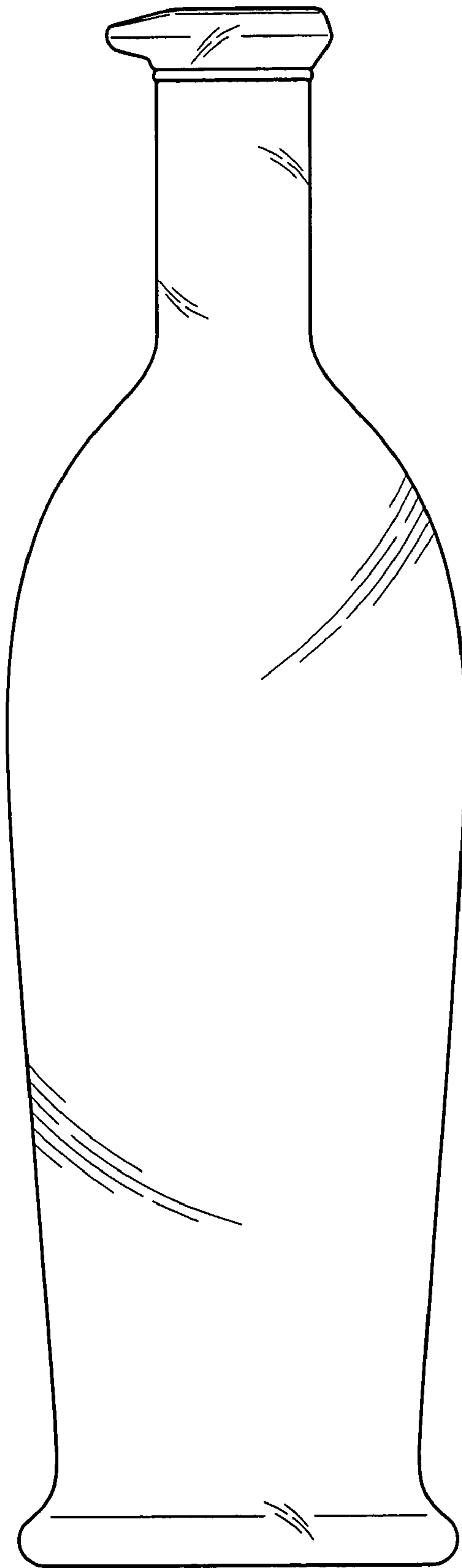

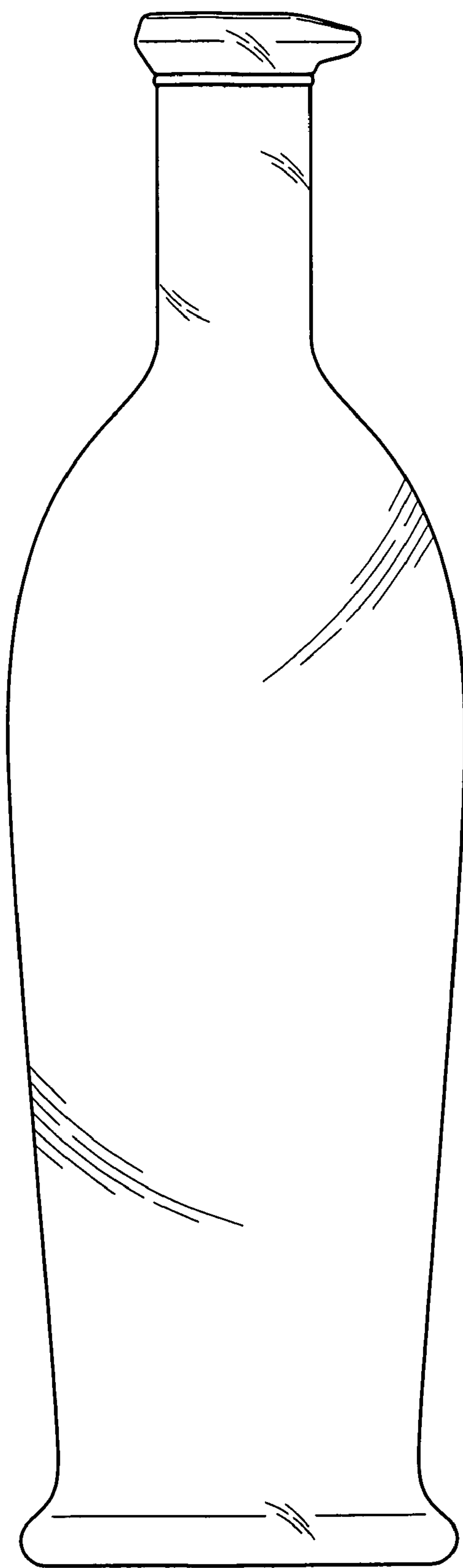

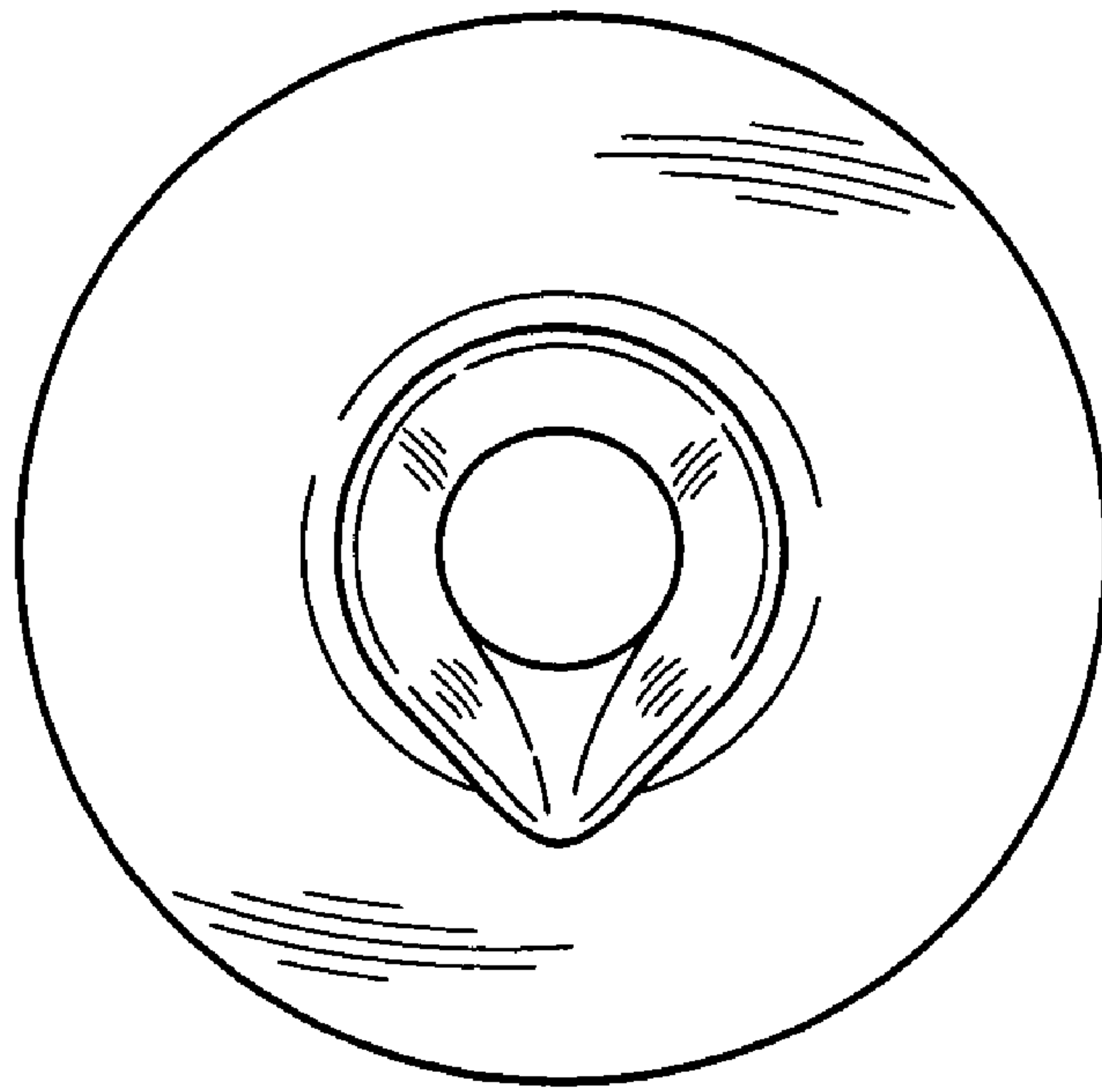

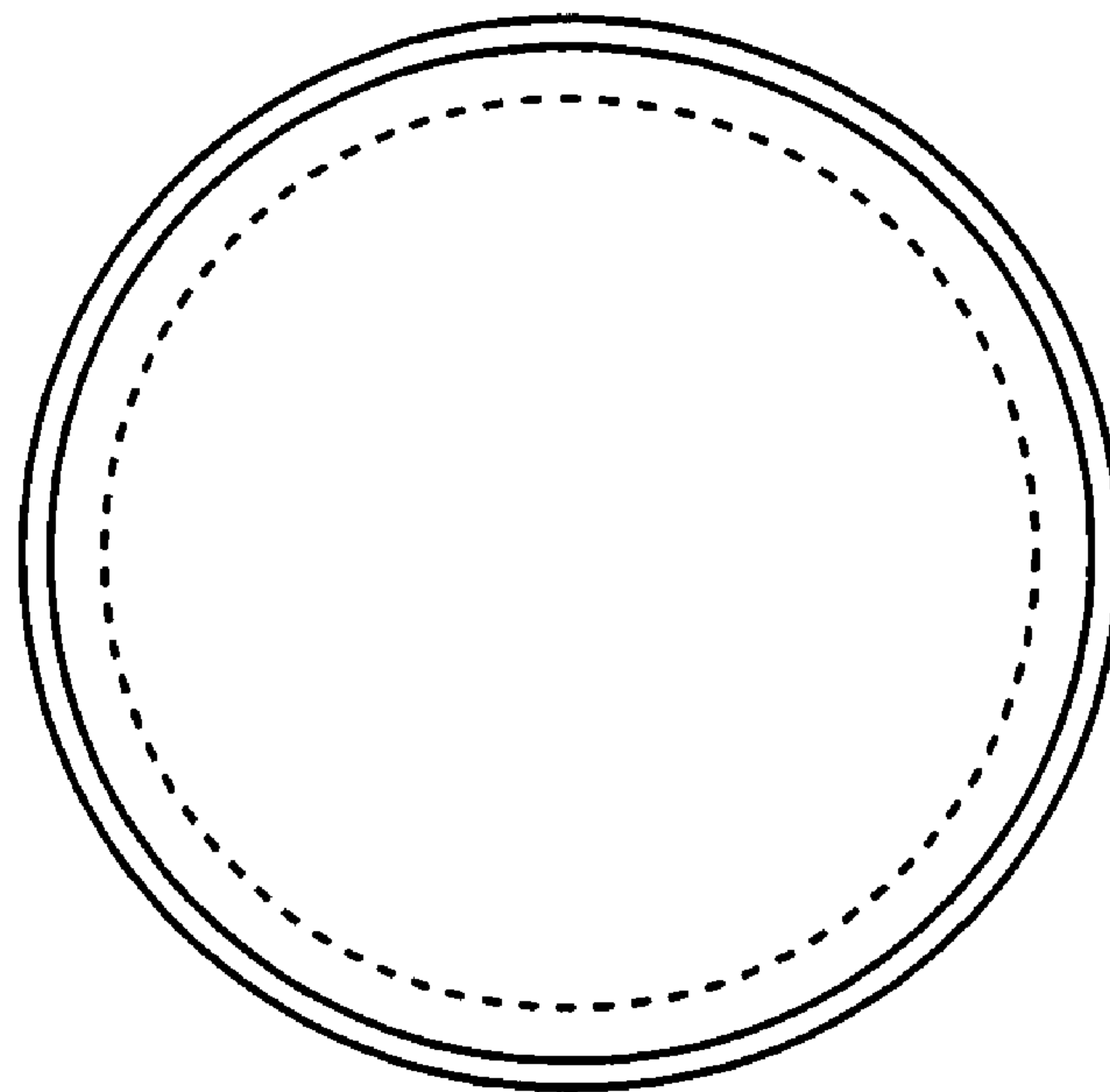

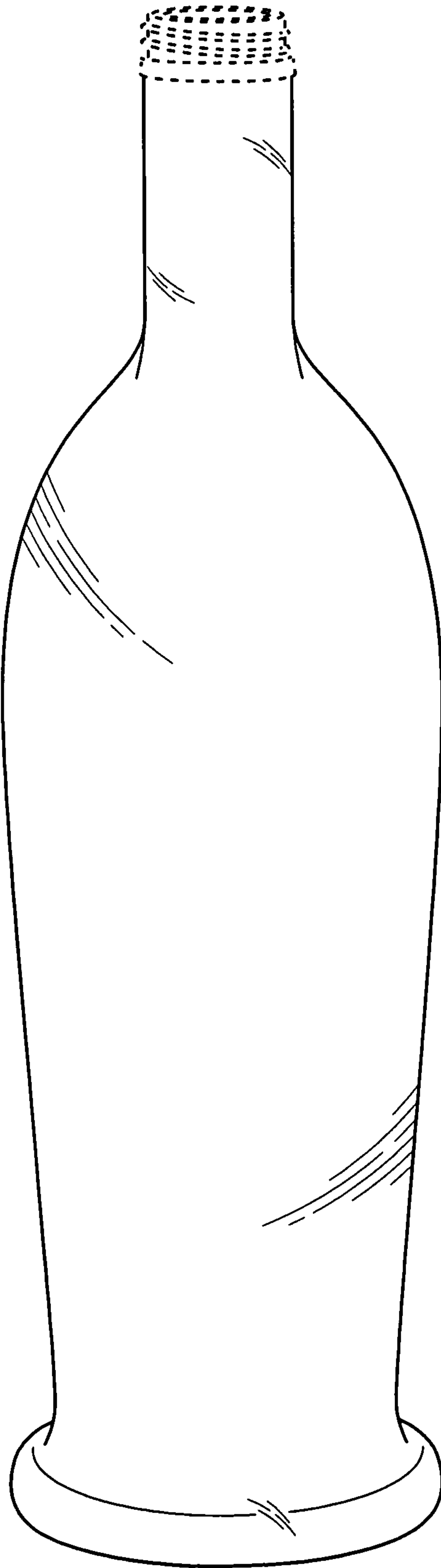

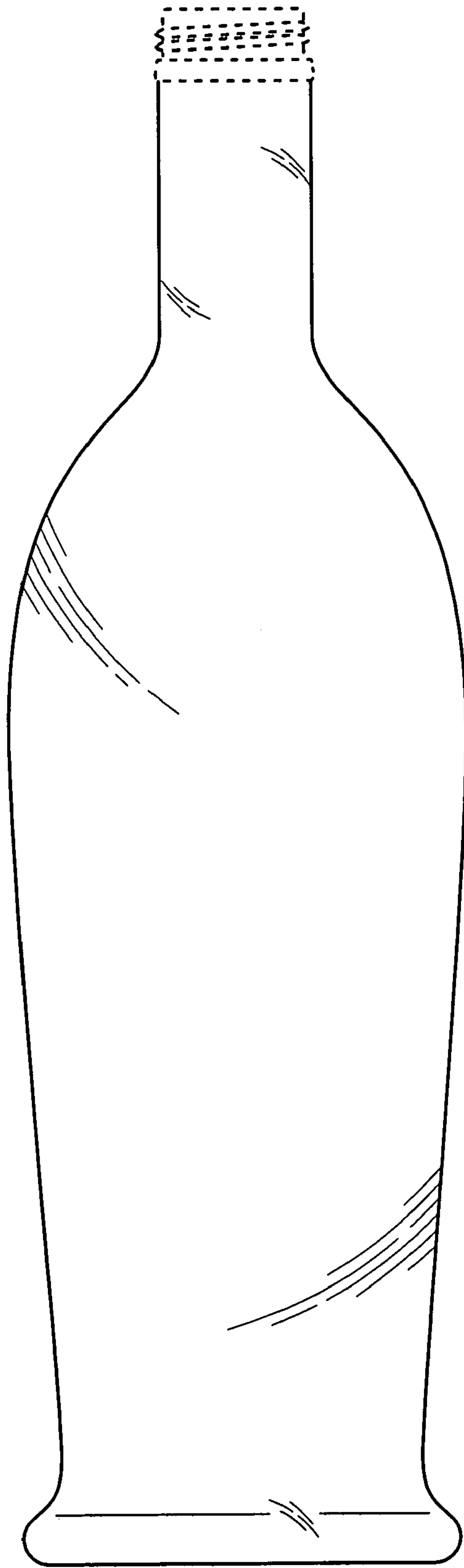

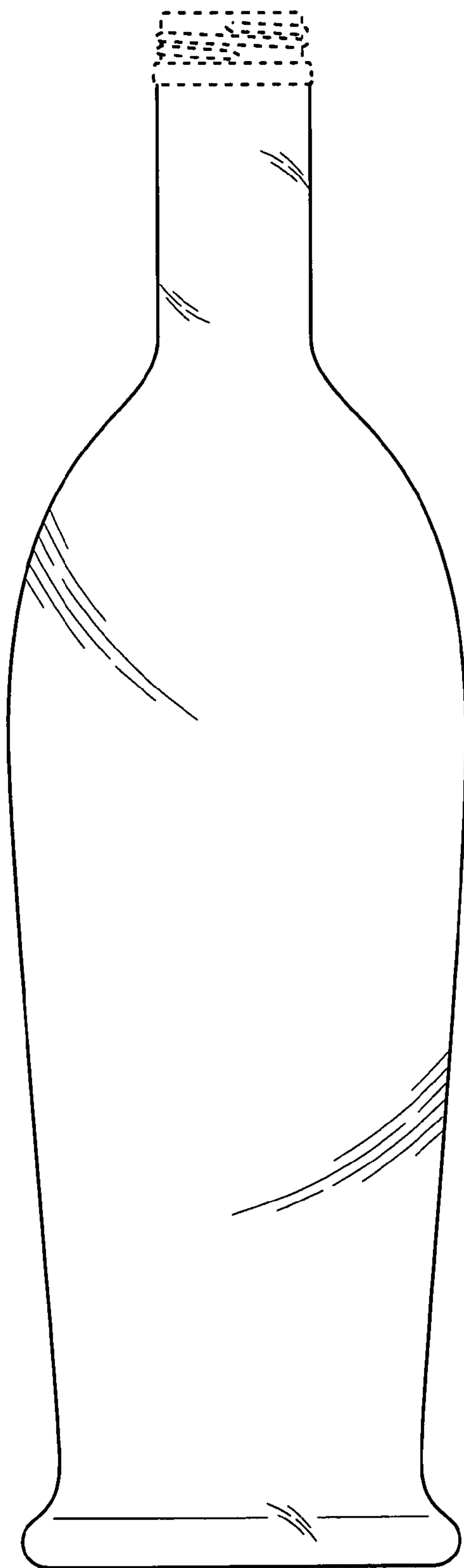

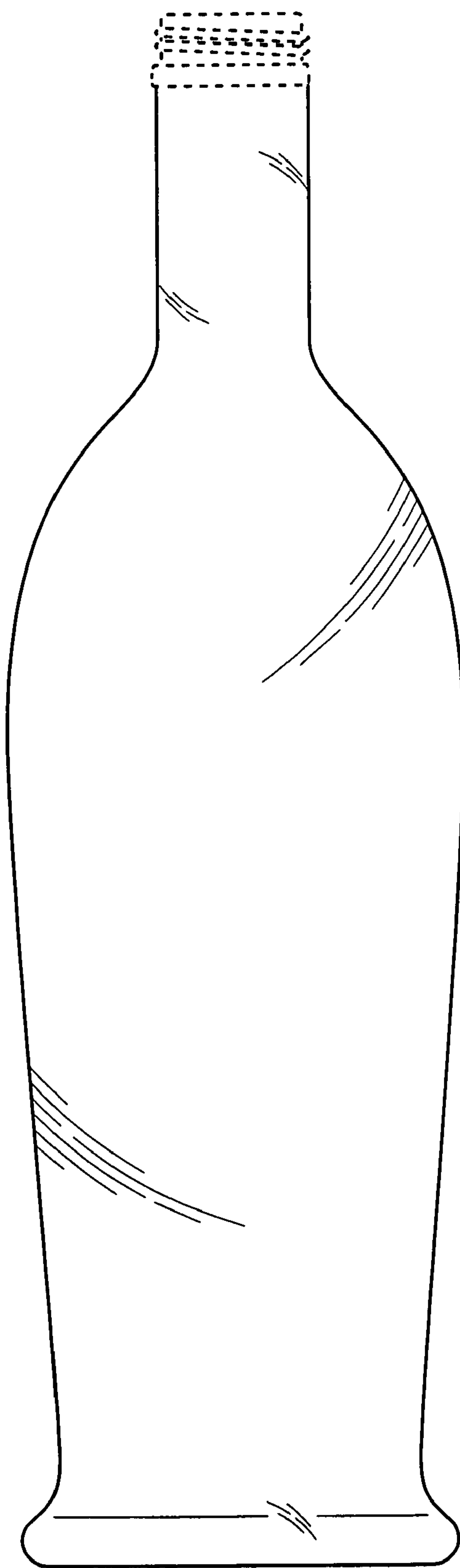

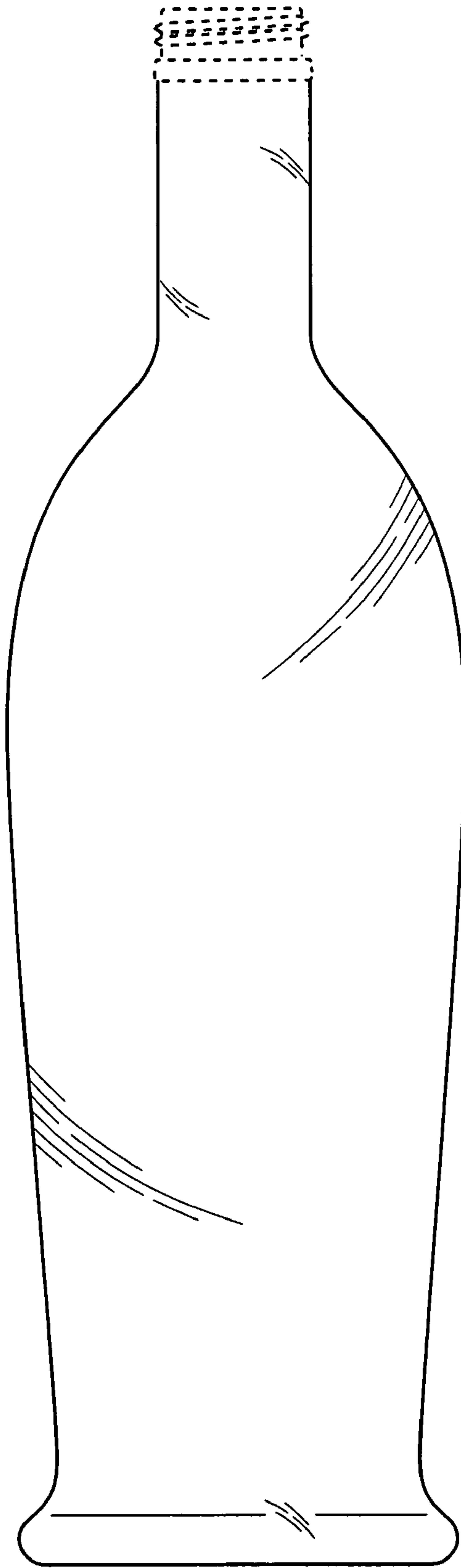

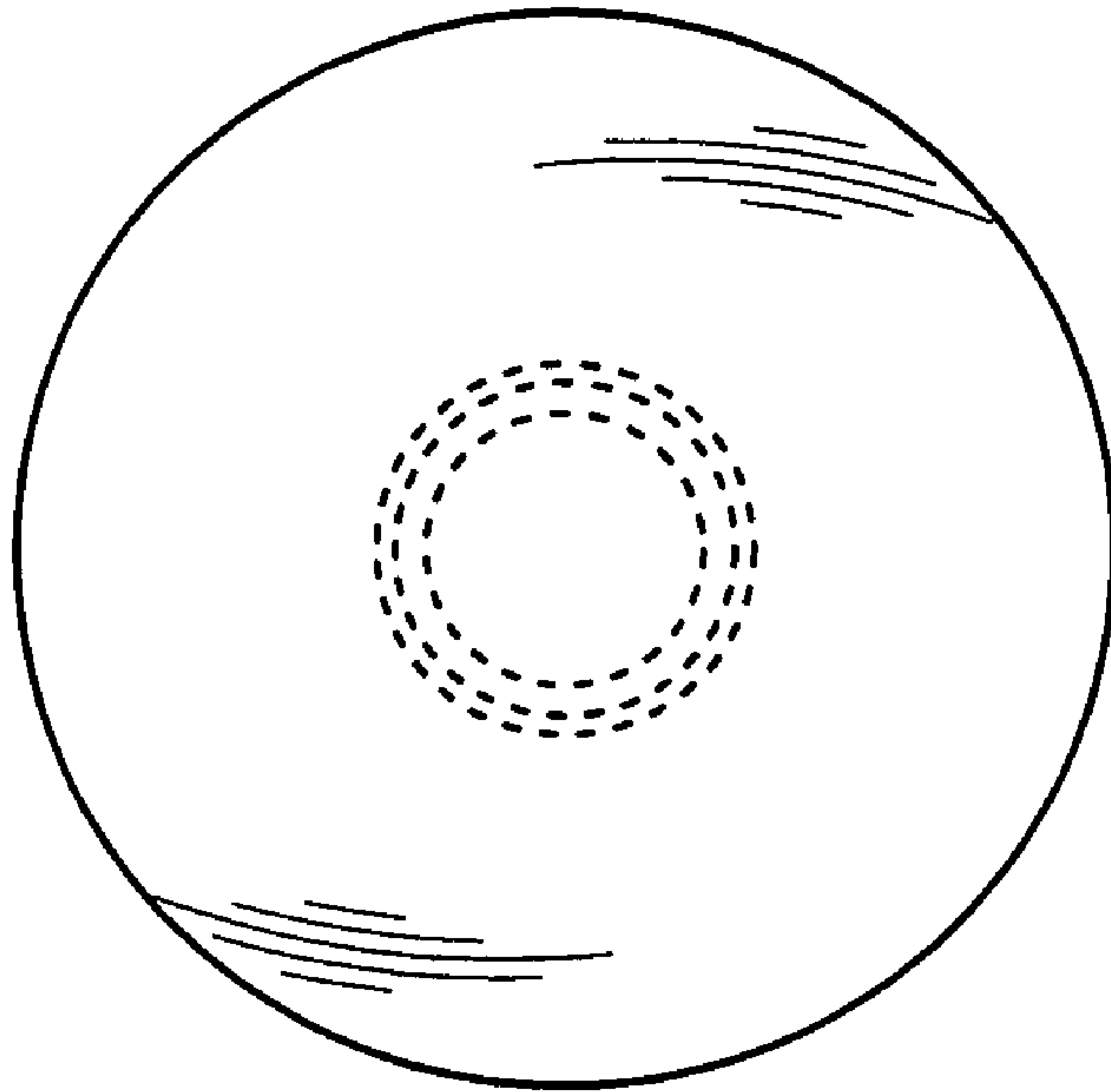

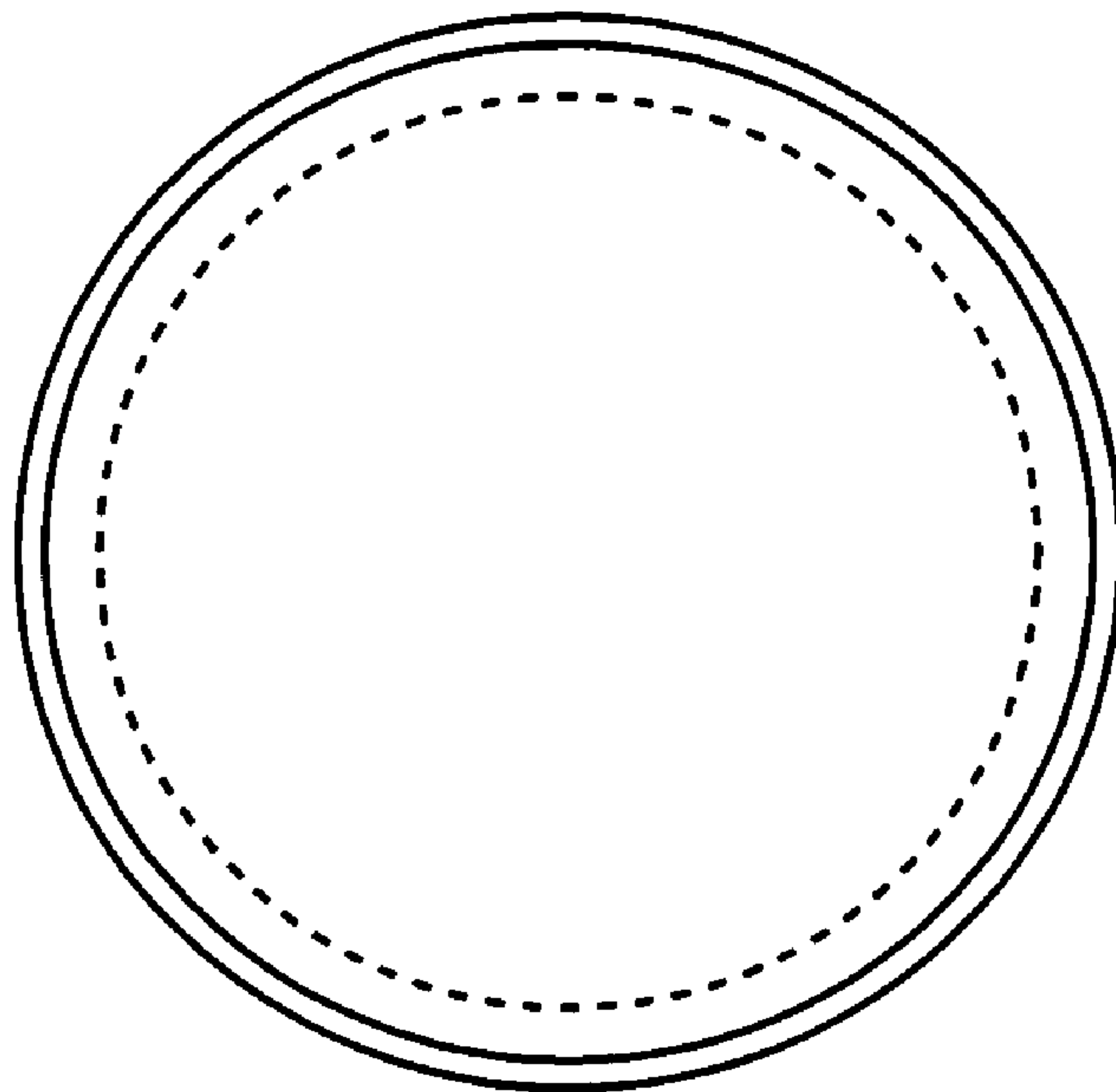
