(57) **CLAIM**

The ornamental design for a combined comb and brush with case, as shown and described

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front, and left side of a combined comb and brush with case in accordance with the present invention;

FIG. 2 is a perspective view of the combined comb and brush with case of FIG. 1, taken from the top, rear, and right side; FIG. 3 is a front elevational view of the combined comb and brush with case of FIG. 1;

FIG. 4 is a bottom view of the combined comb and brush with case of FIG. 1;

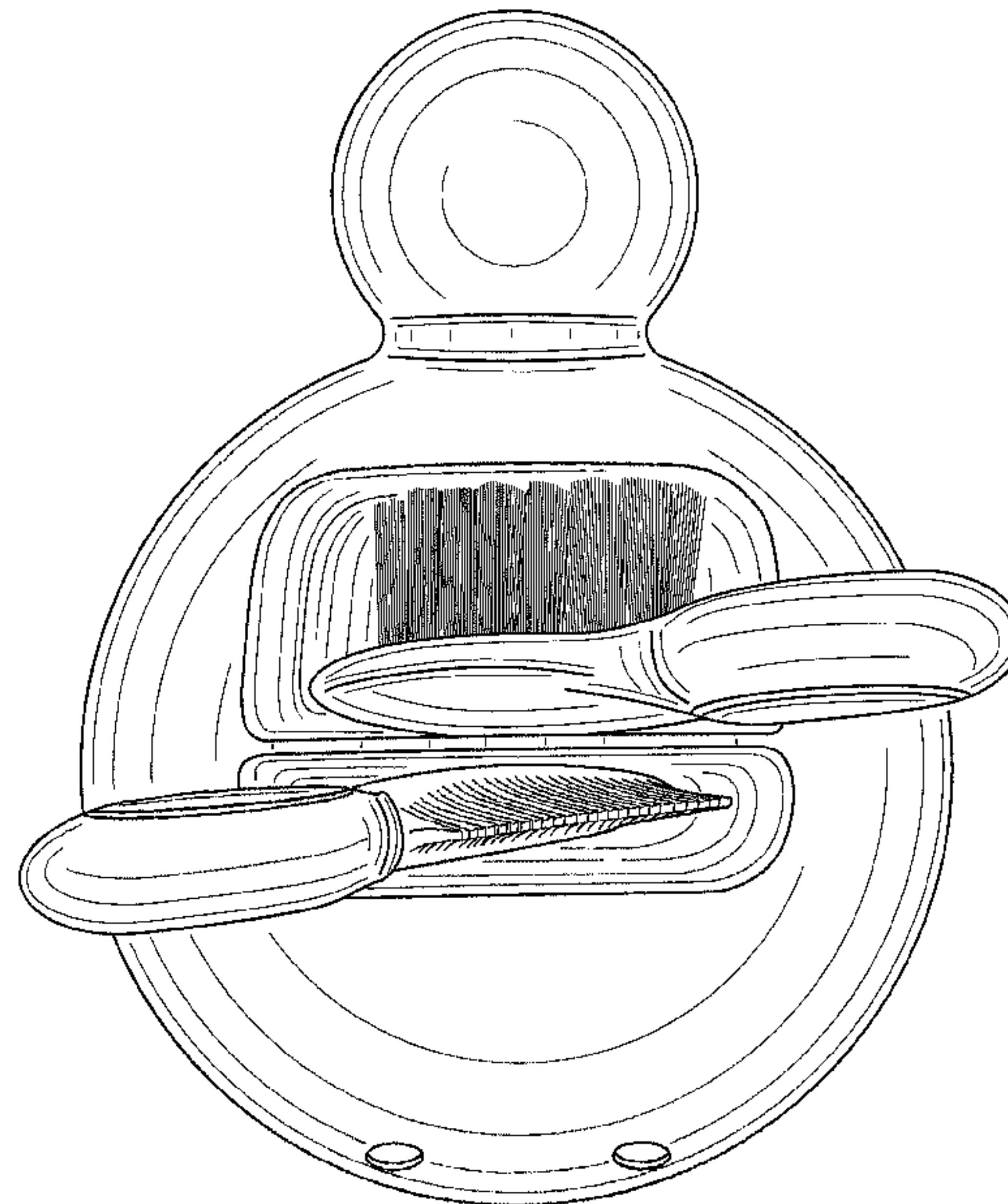
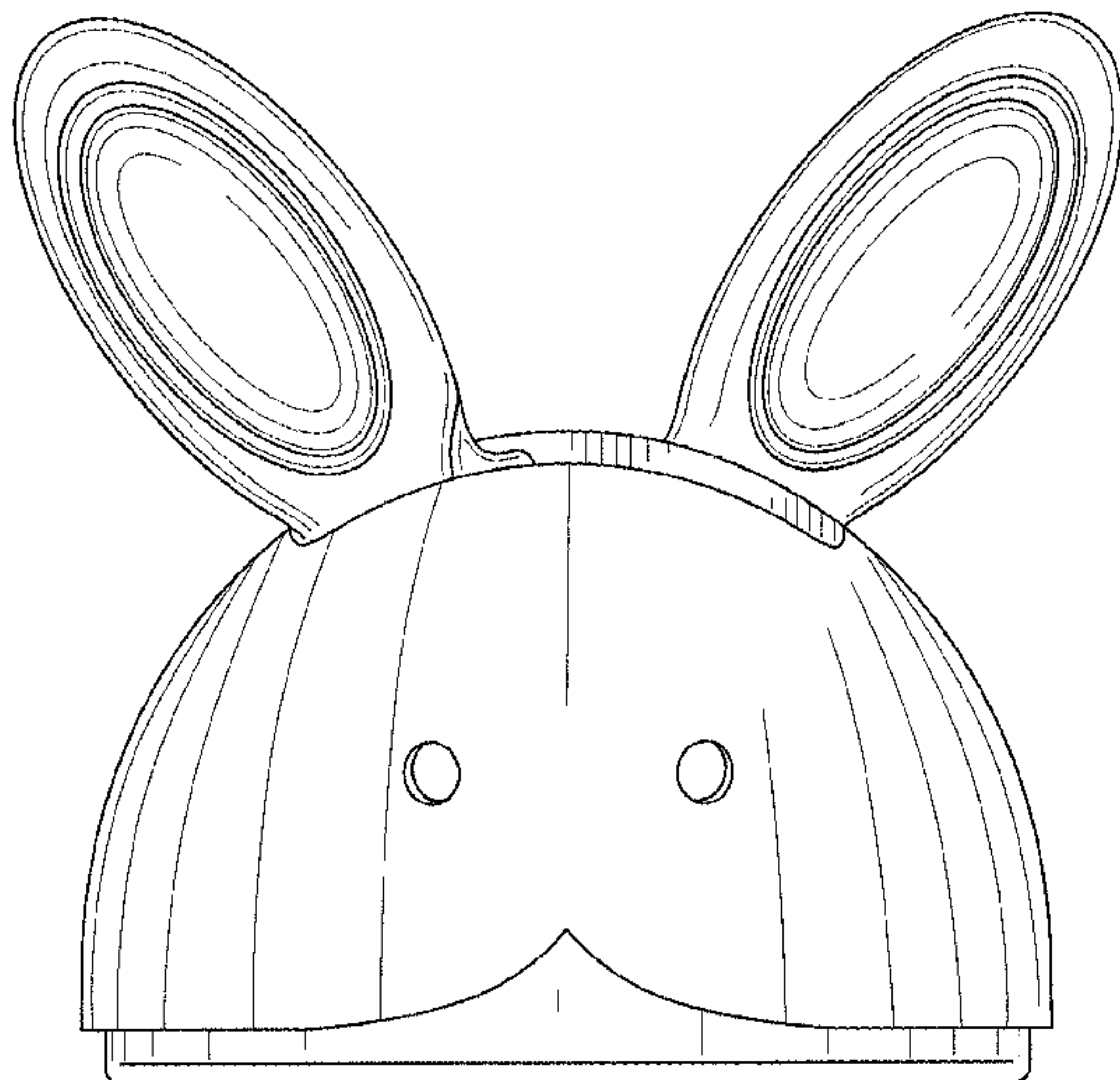
FIG. 5 is a top view showing the combined comb and brush with case of FIG. 1;

FIG. 6 is a left elevational view of the combined comb and brush with case of FIG. 1, the right side being nearly a mirror image thereof; and,

FIG. 7 is a rear elevational view of the combined comb and brush with case of FIG. 1.

The dash-dot-dash broken line defines the bounds of the claim and forms no part thereof while the dashed broken lines illustrate portions of the base that form no part of the claimed design.

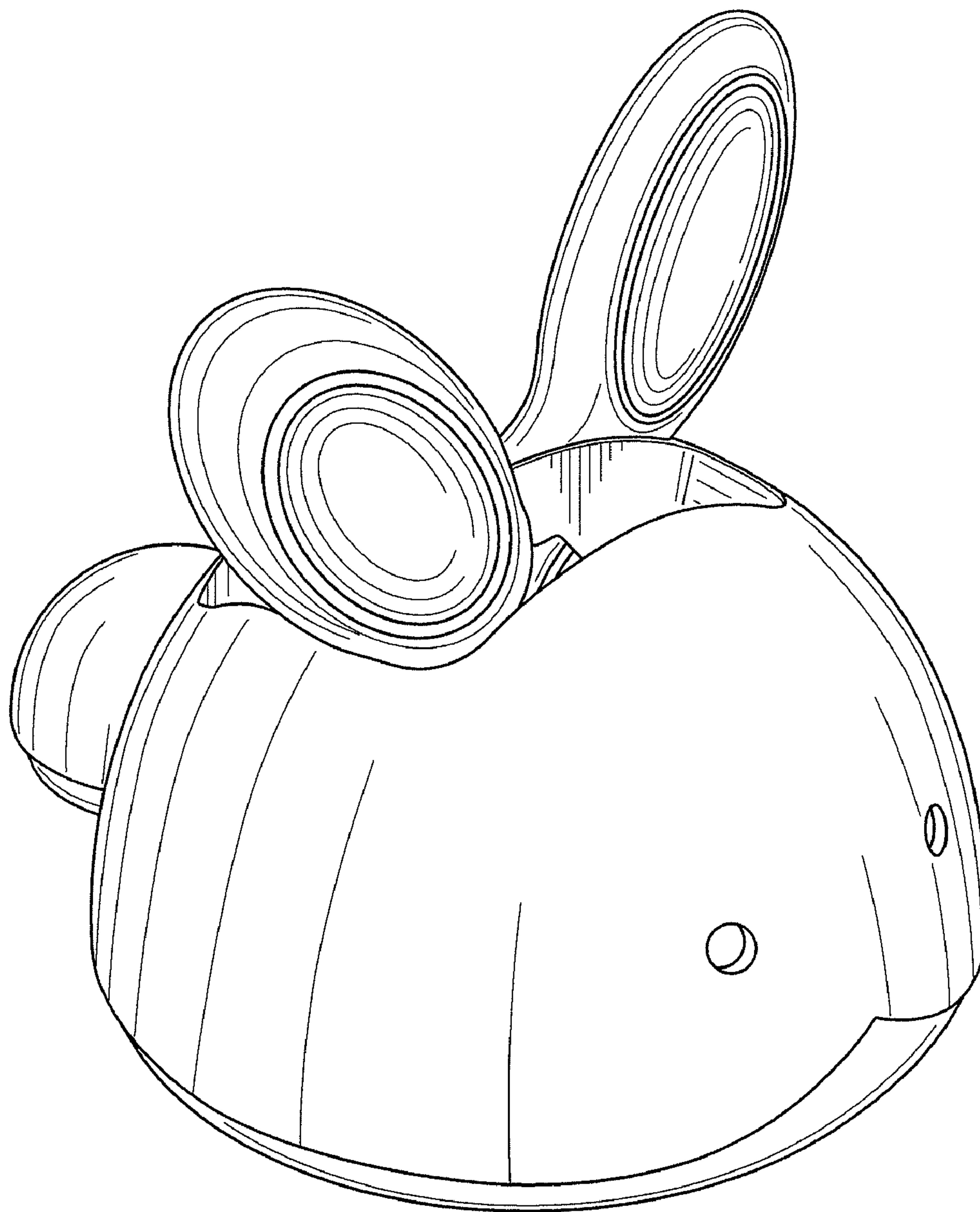

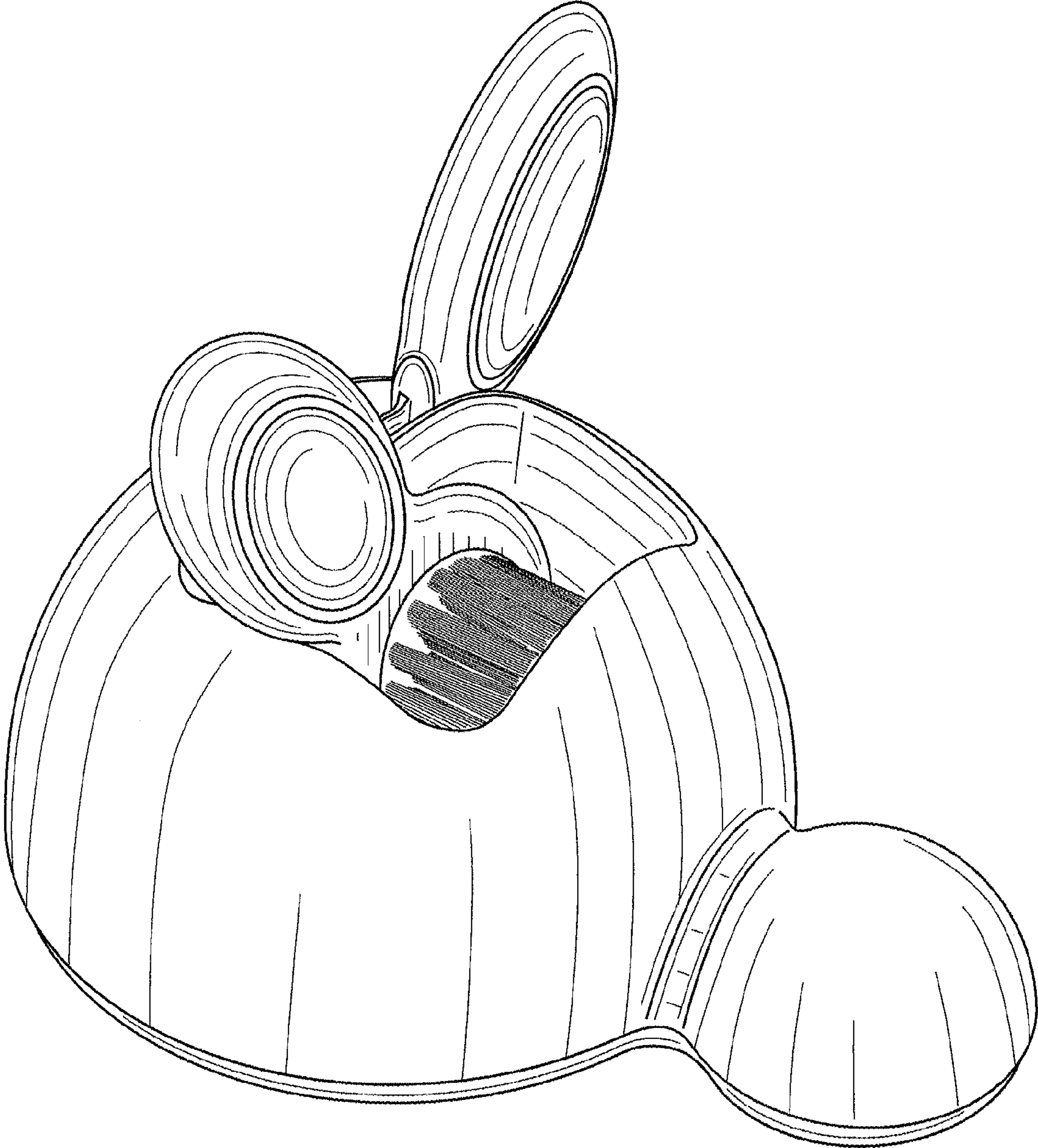

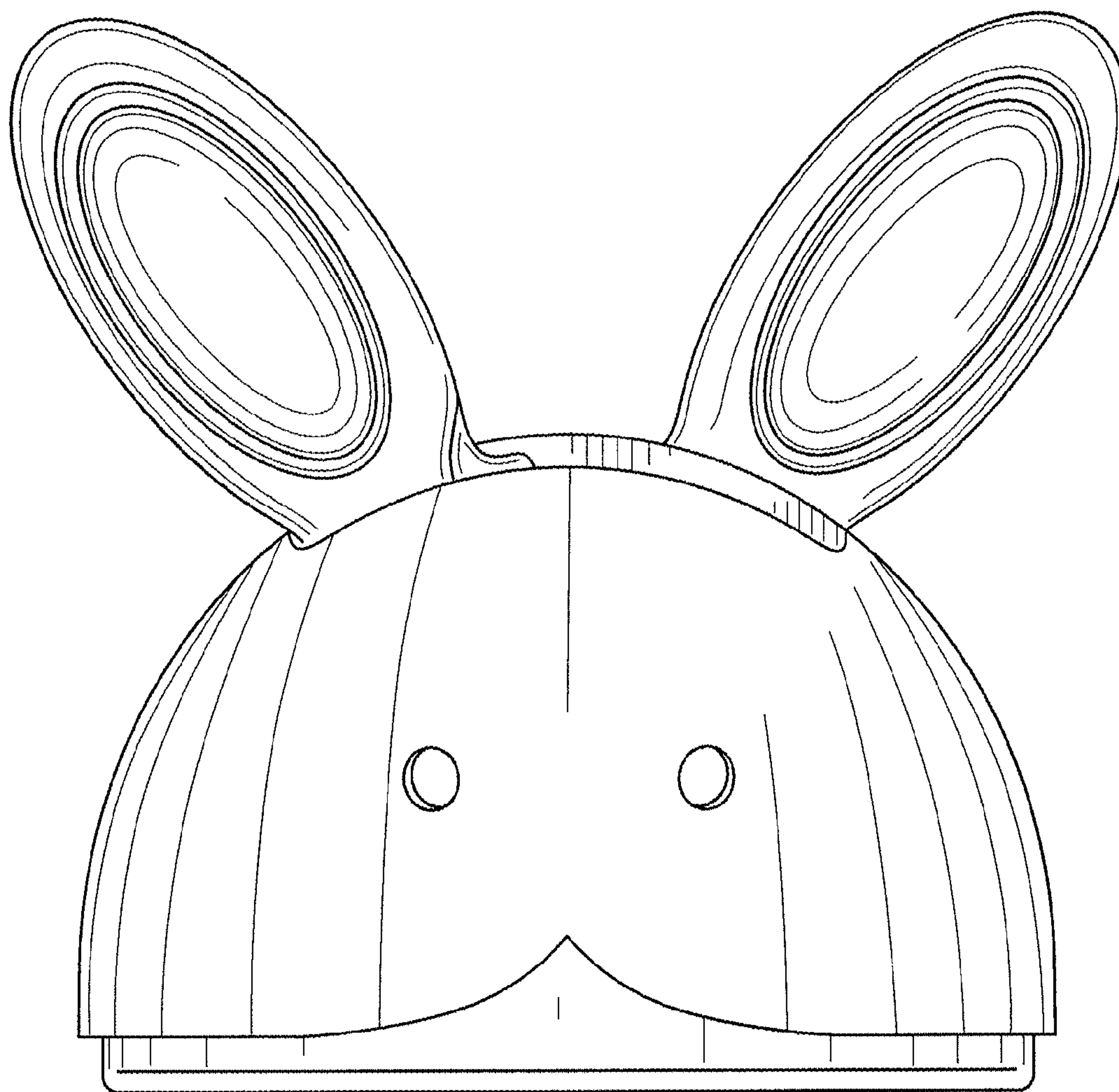

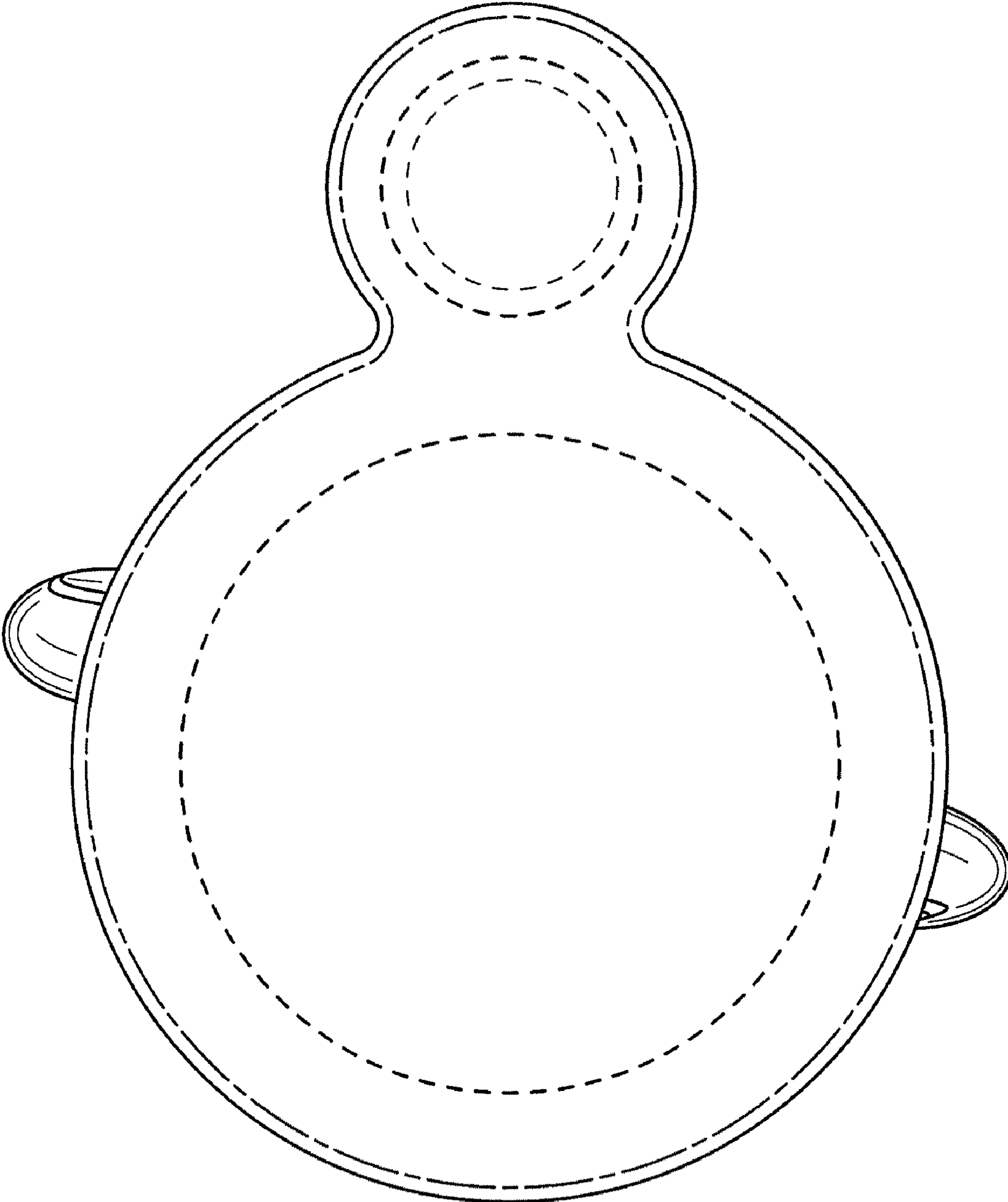

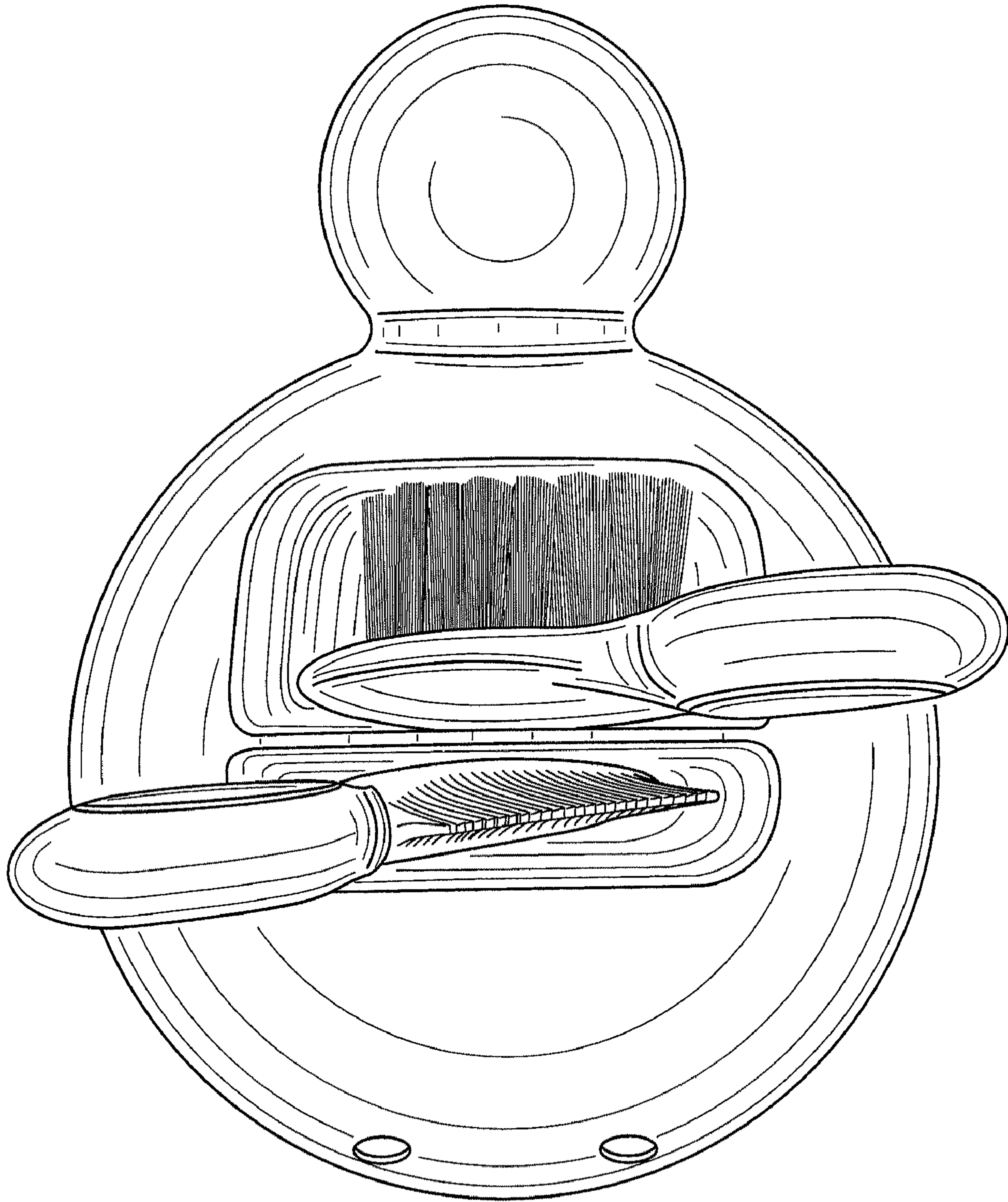

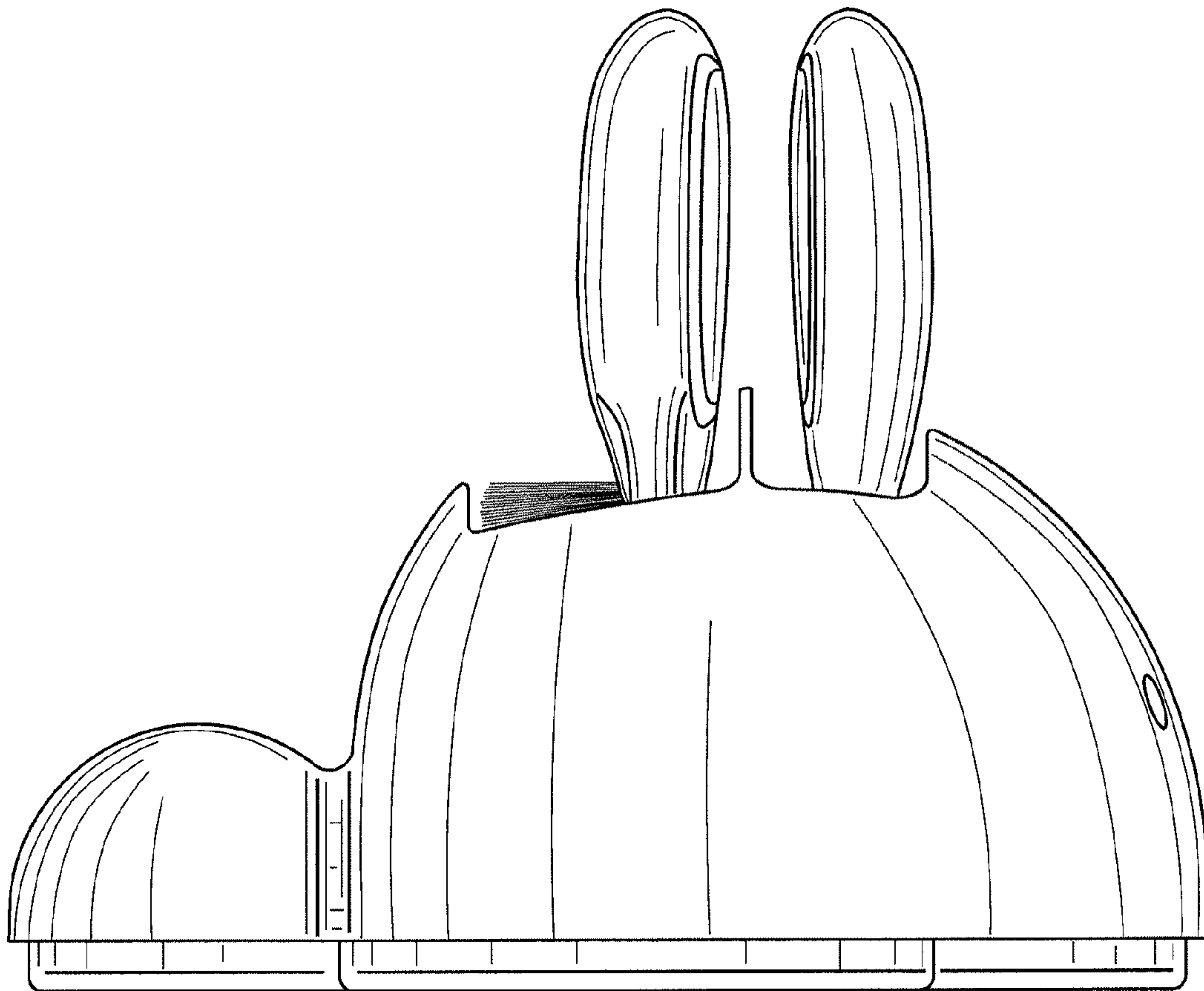

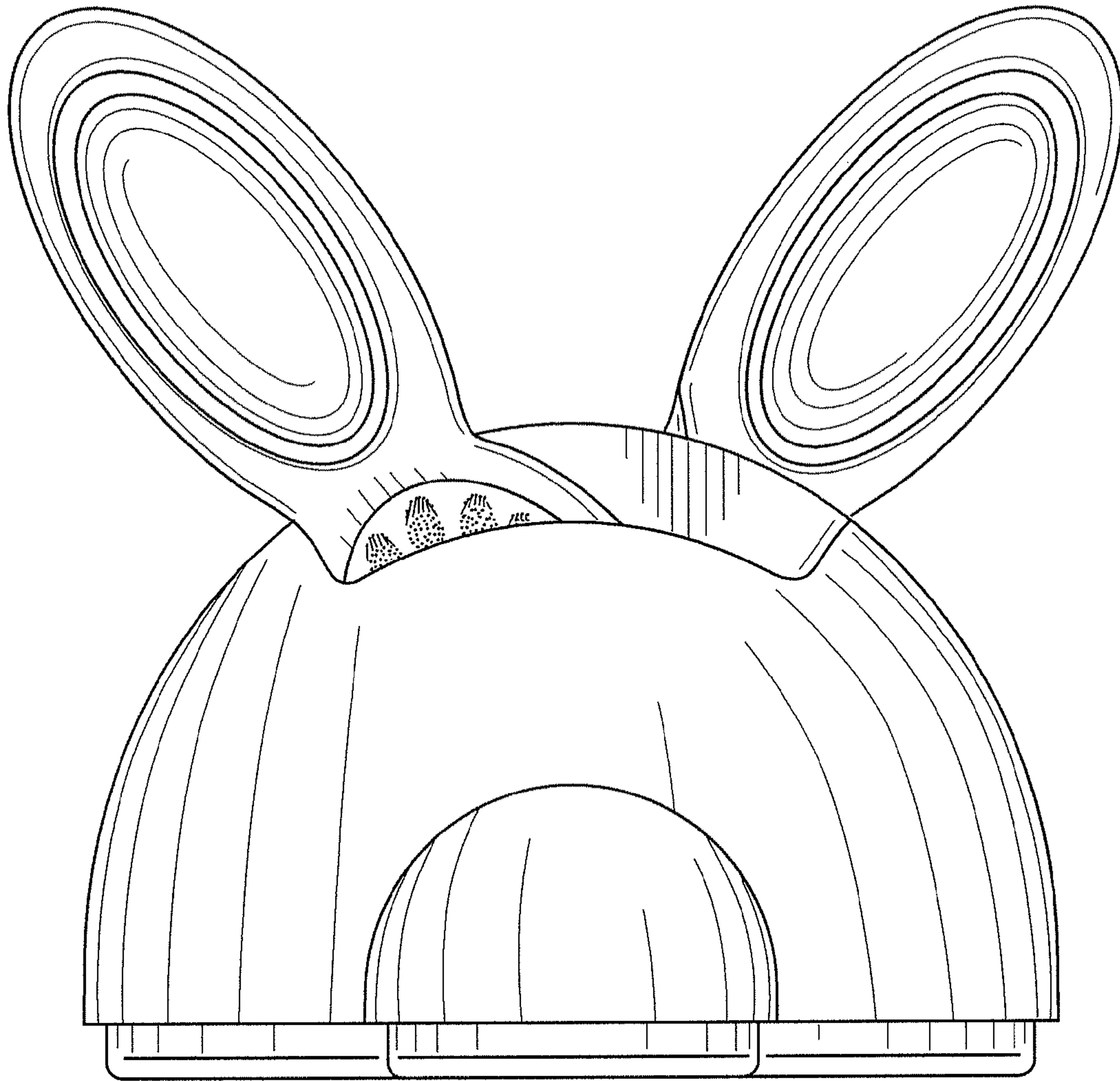
