The ornamental design for headphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of headphones according to my design, the perspective from the opposite side being mirror symmetrical;

FIG. 3 is a front view thereof;

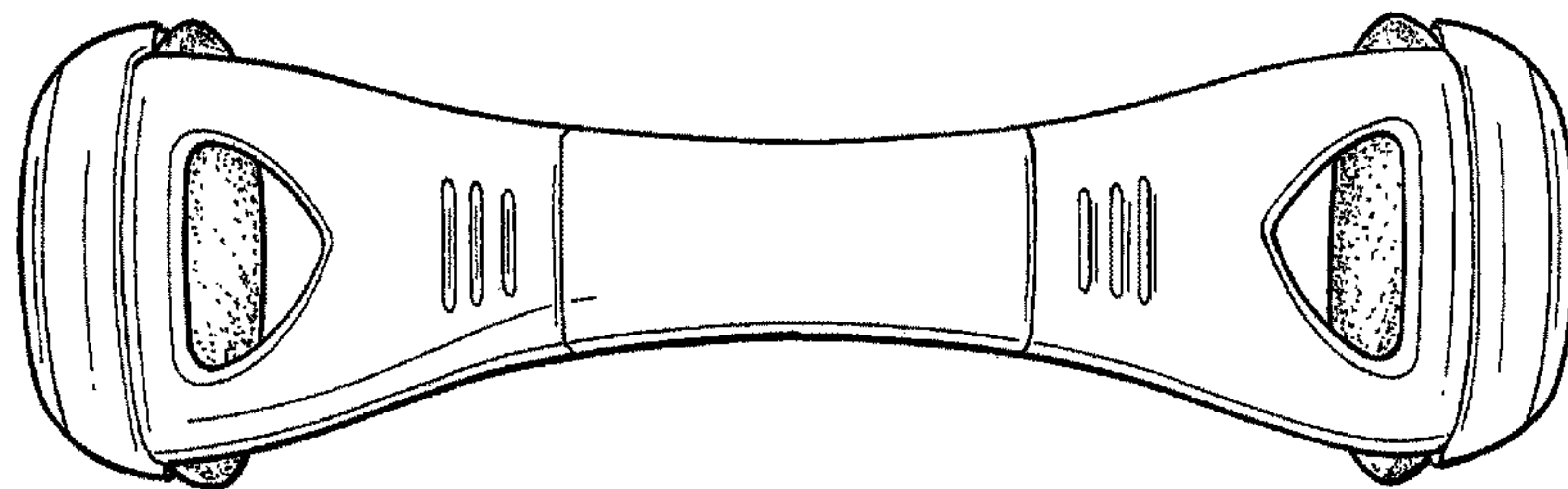
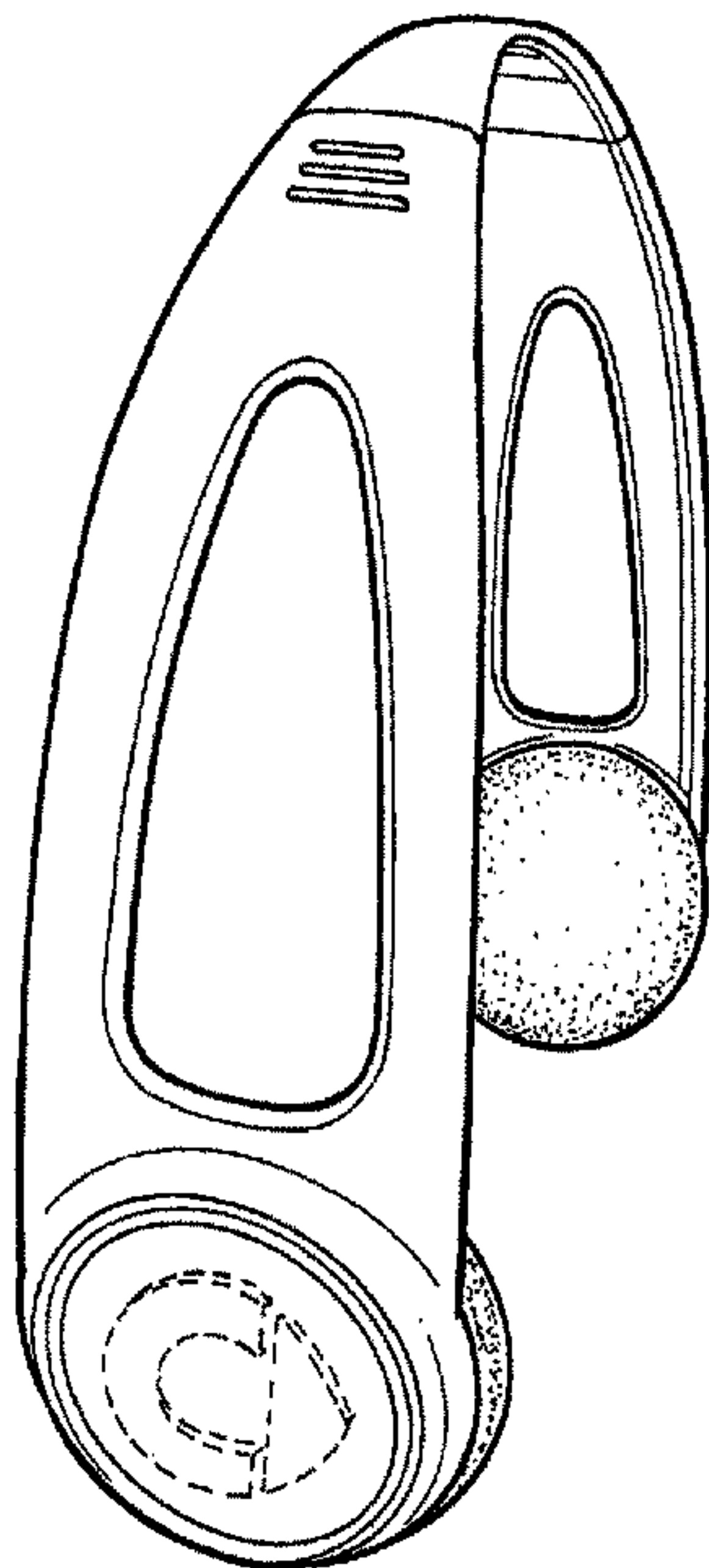
FIG. 4 is a rear view thereof;

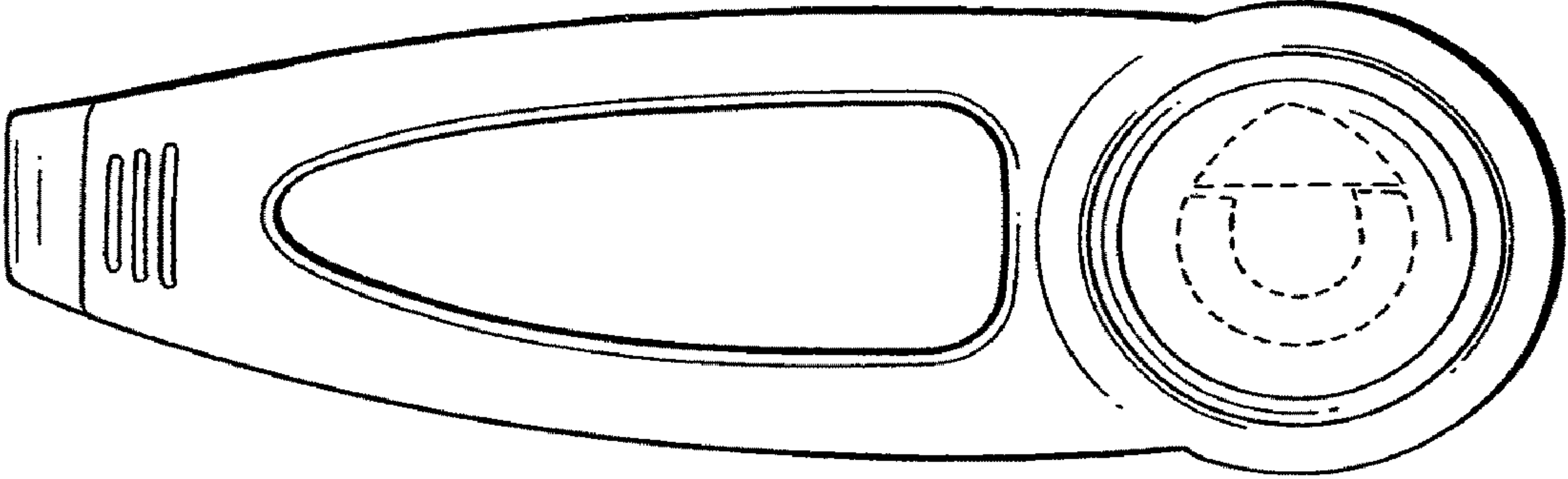

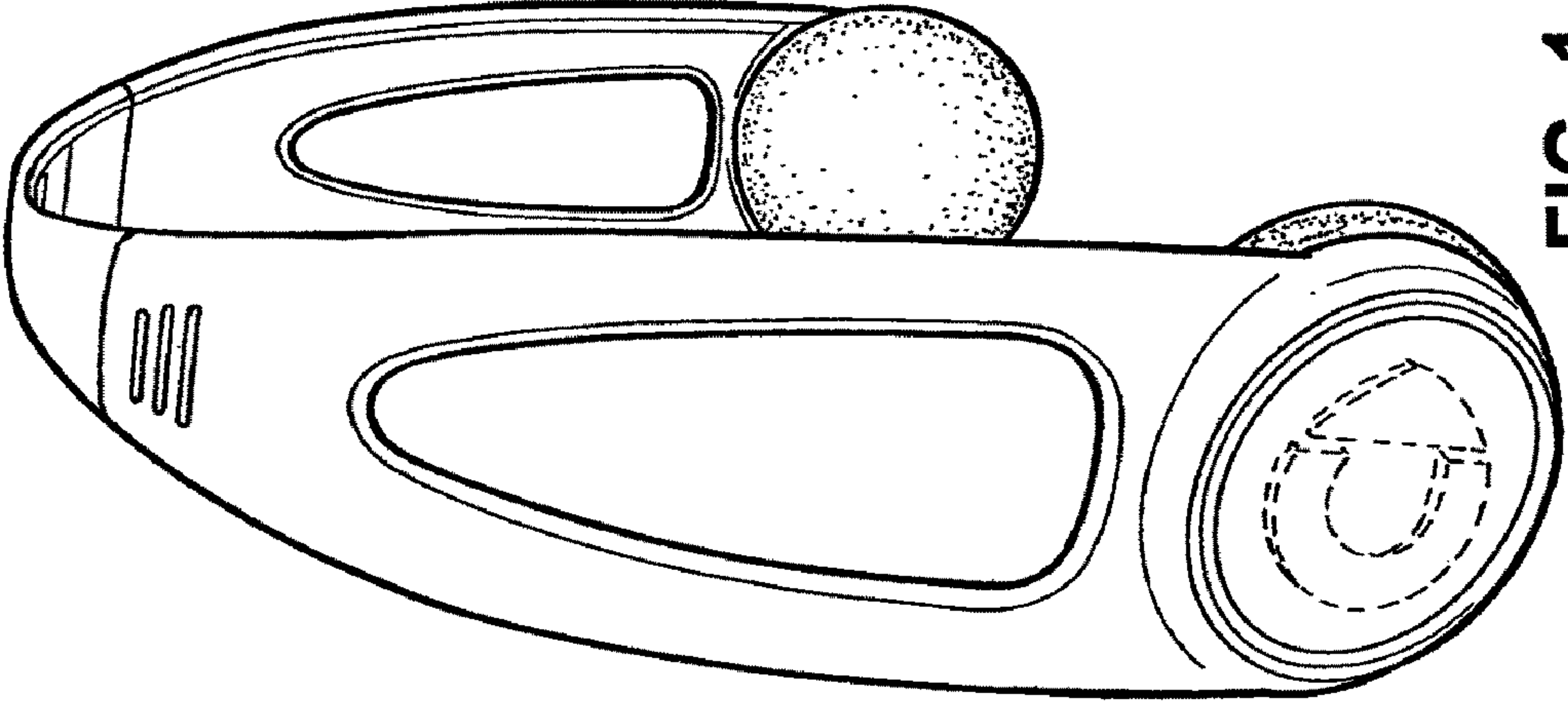

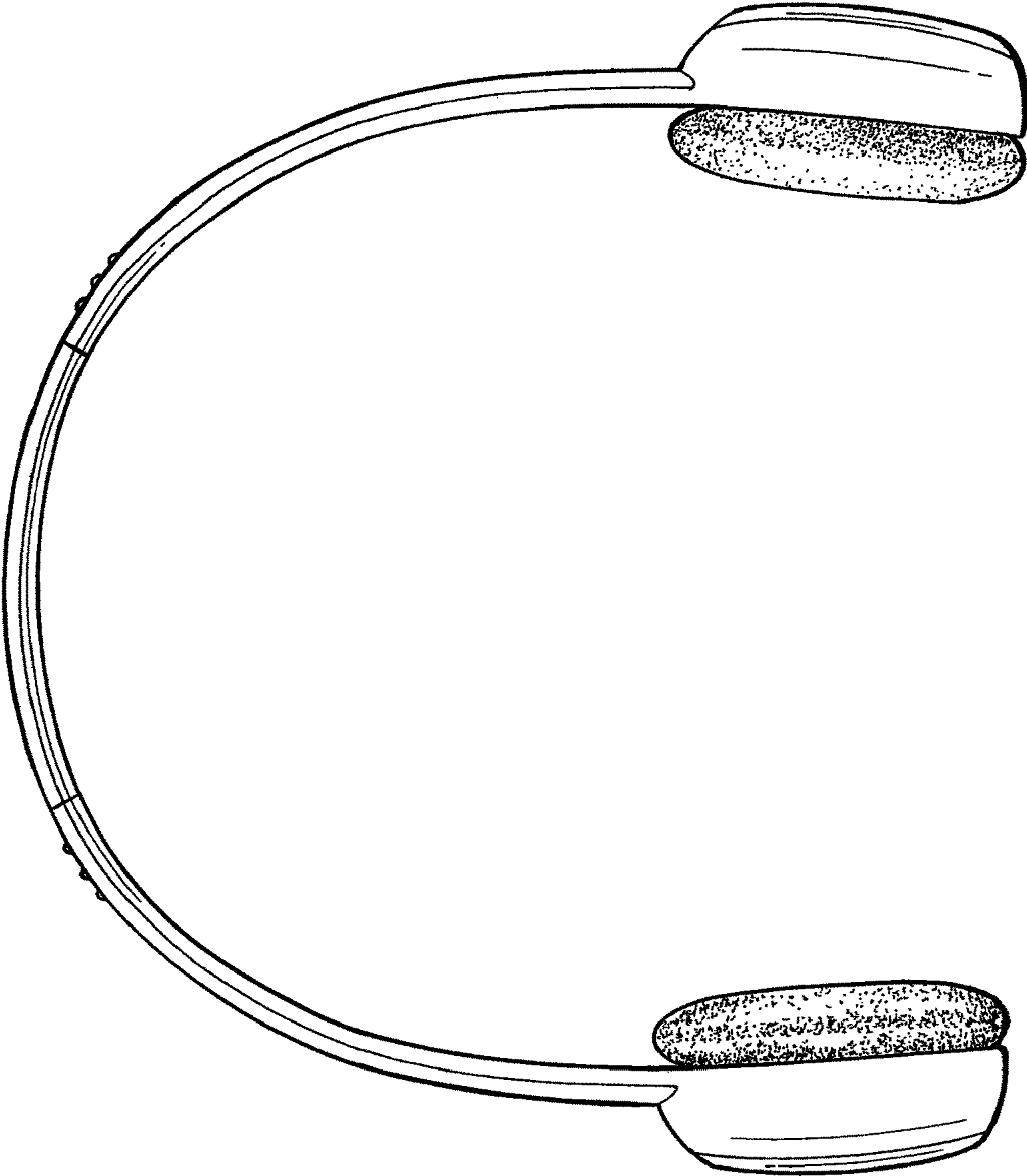

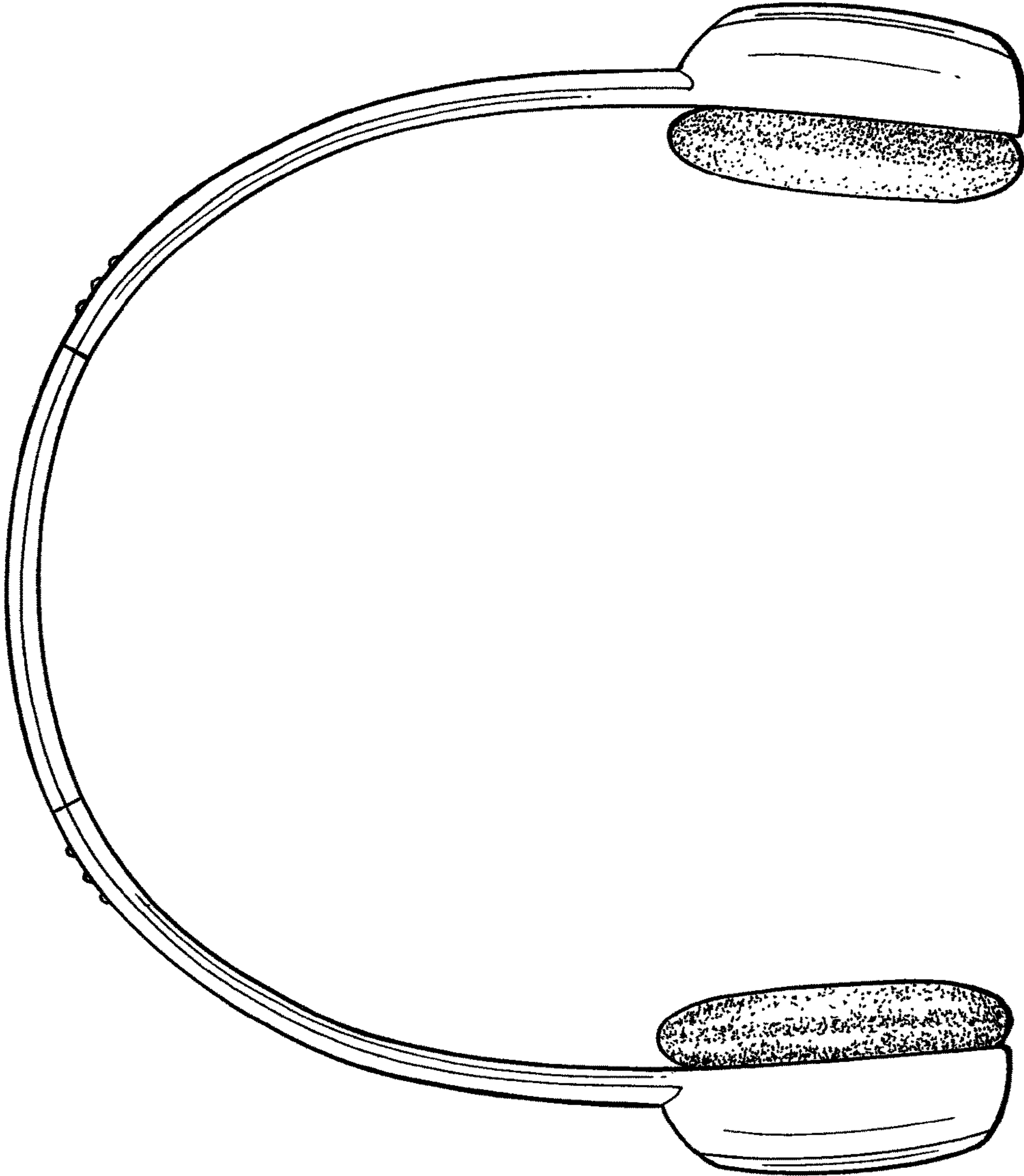

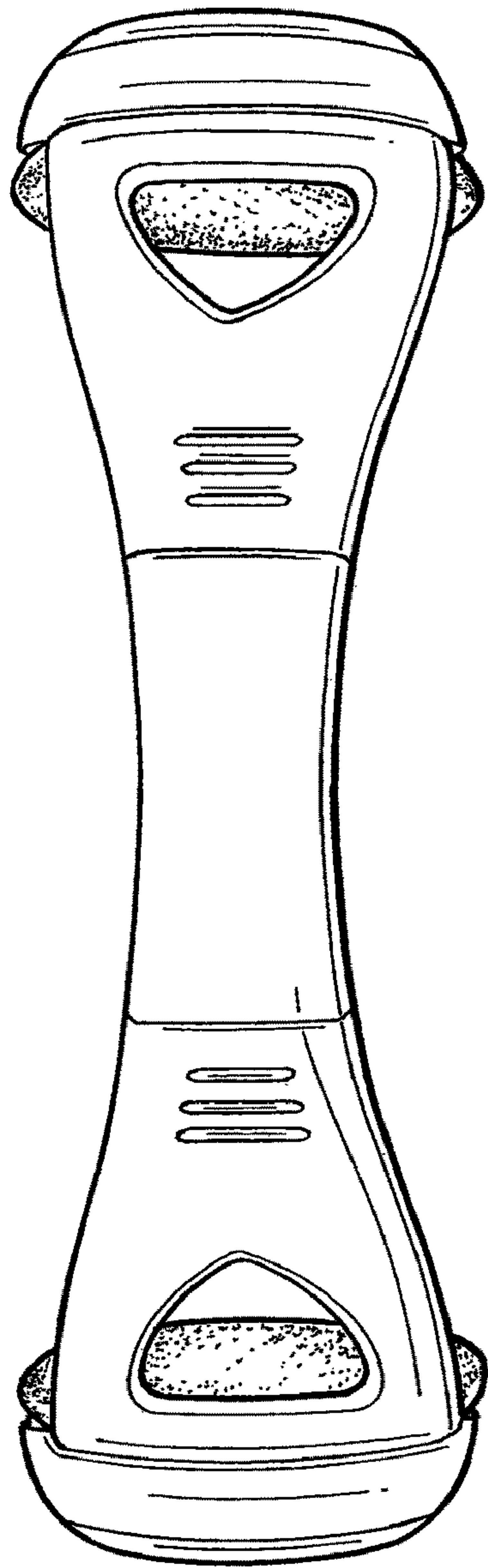

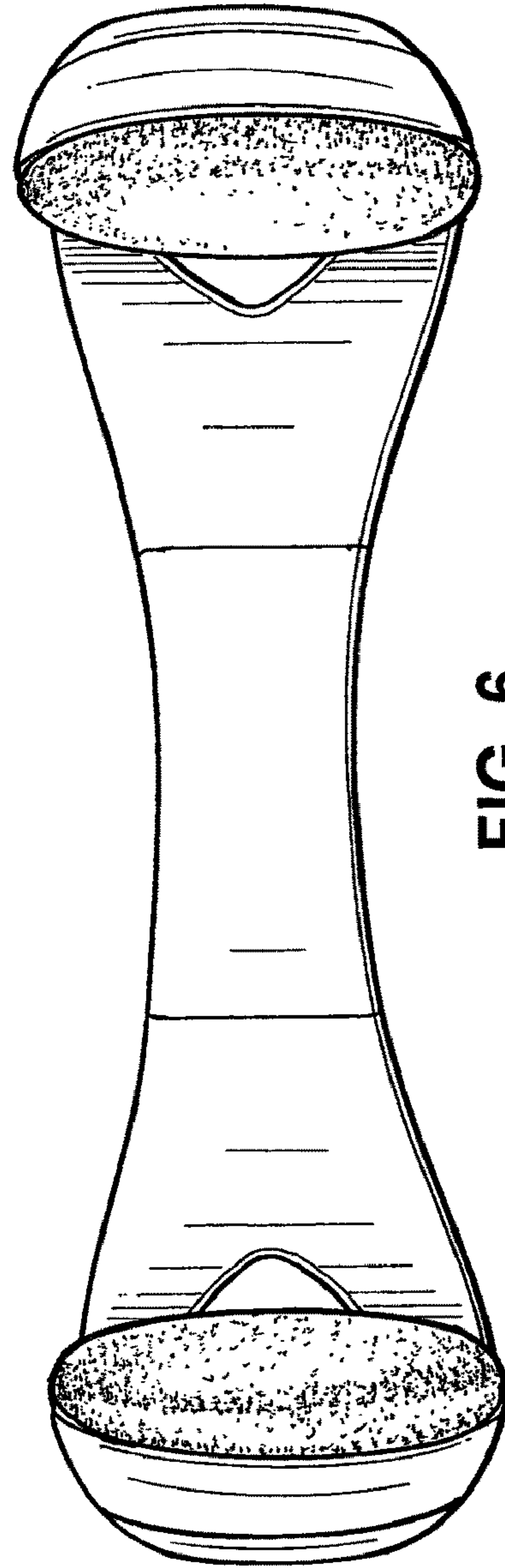
