DESCRIPTION

FIG. 1 is a side view of headphones according to my design, the opposite side view being mirror symmetrical;

FIG. 2 is a perspective view thereof, the perspective from the opposite side being mirror symmetrical;

FIG. 3 is a rear view thereof;

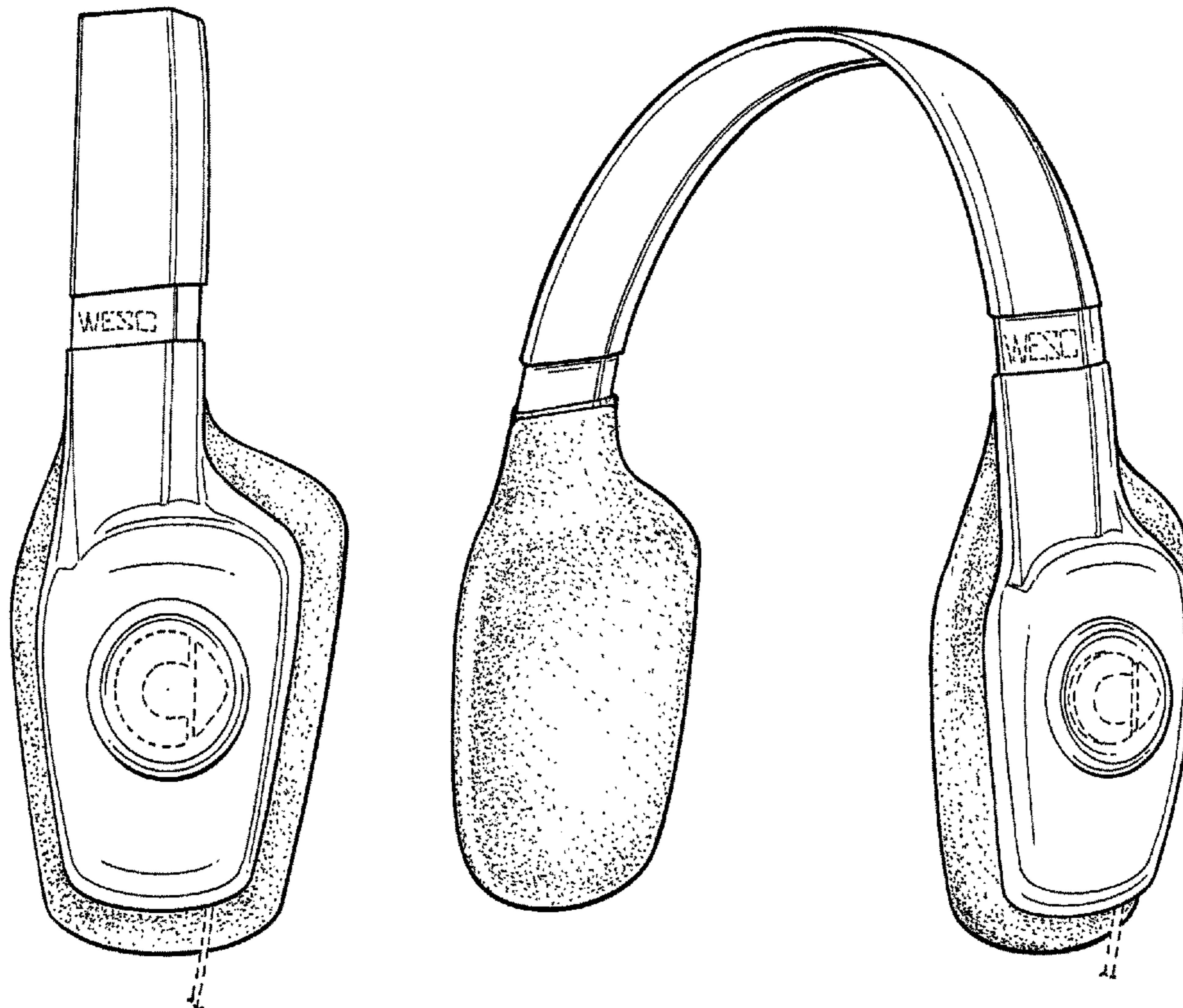
FIG. 4 is a front view thereof;

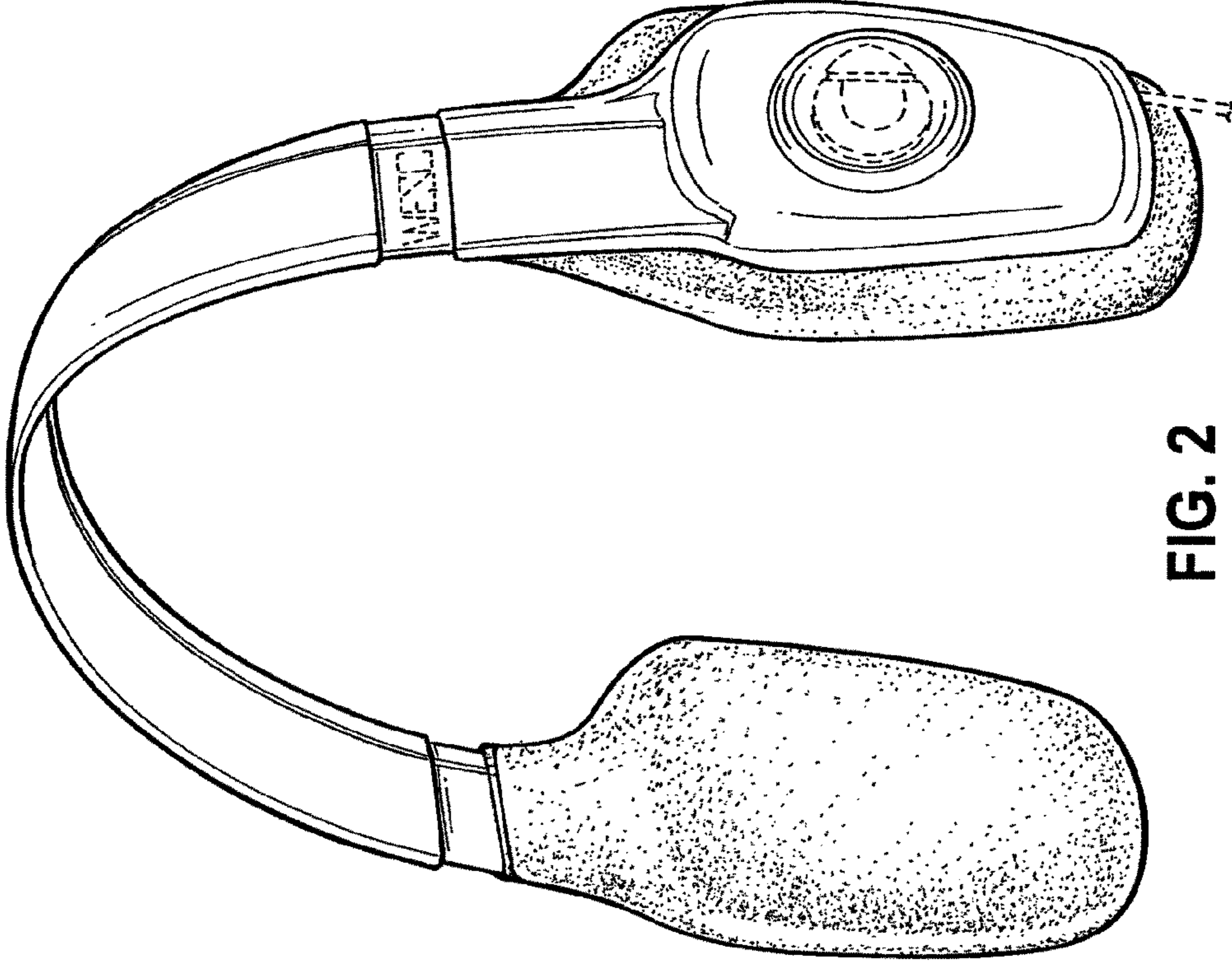

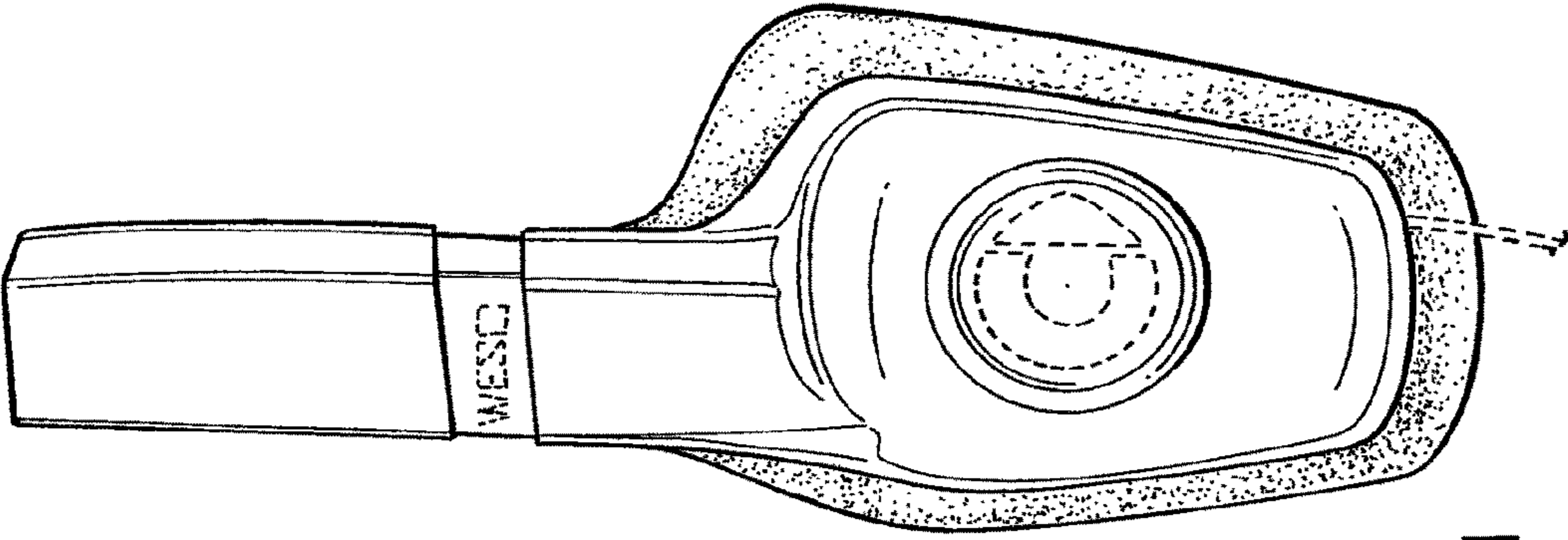

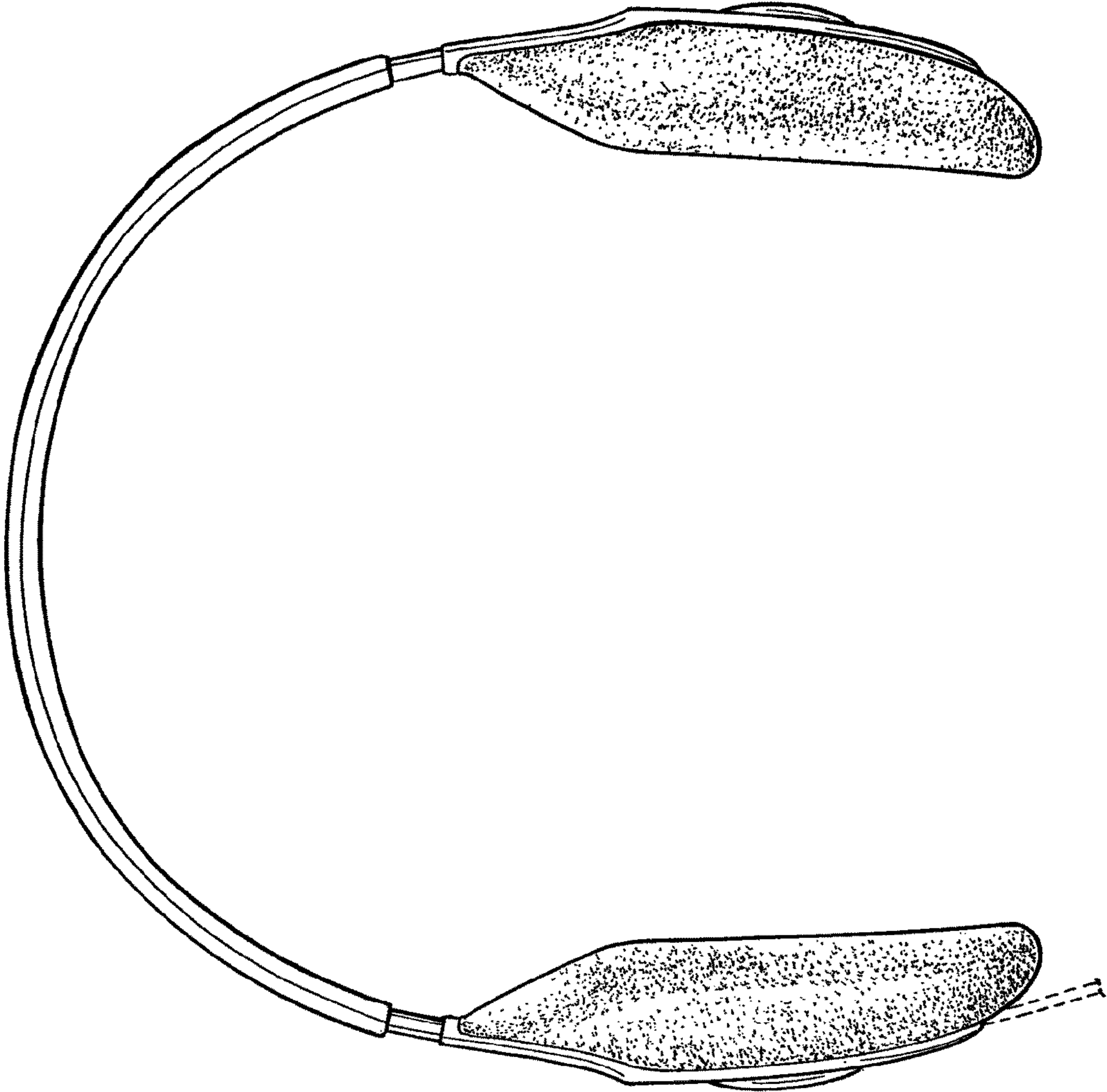

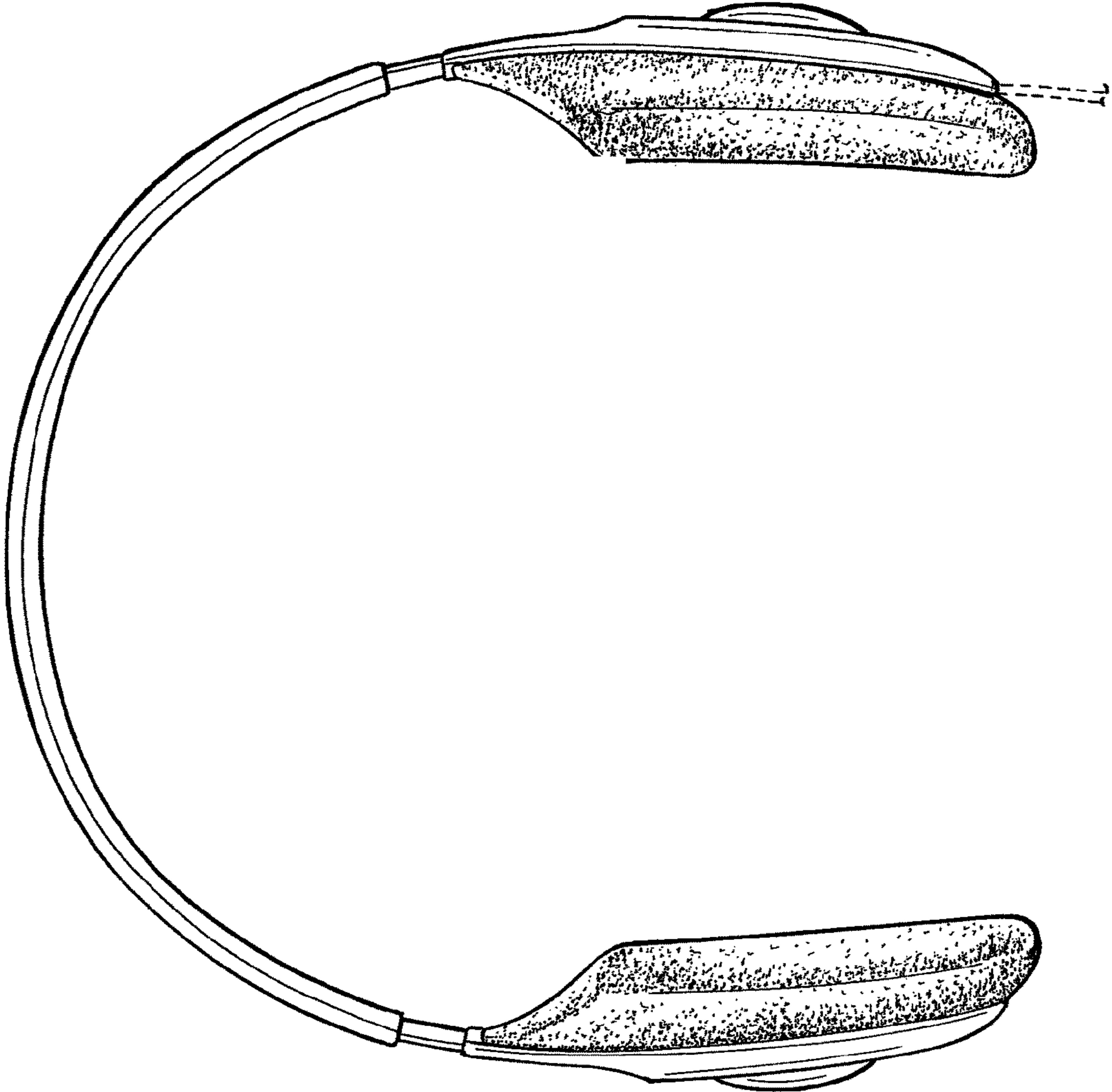

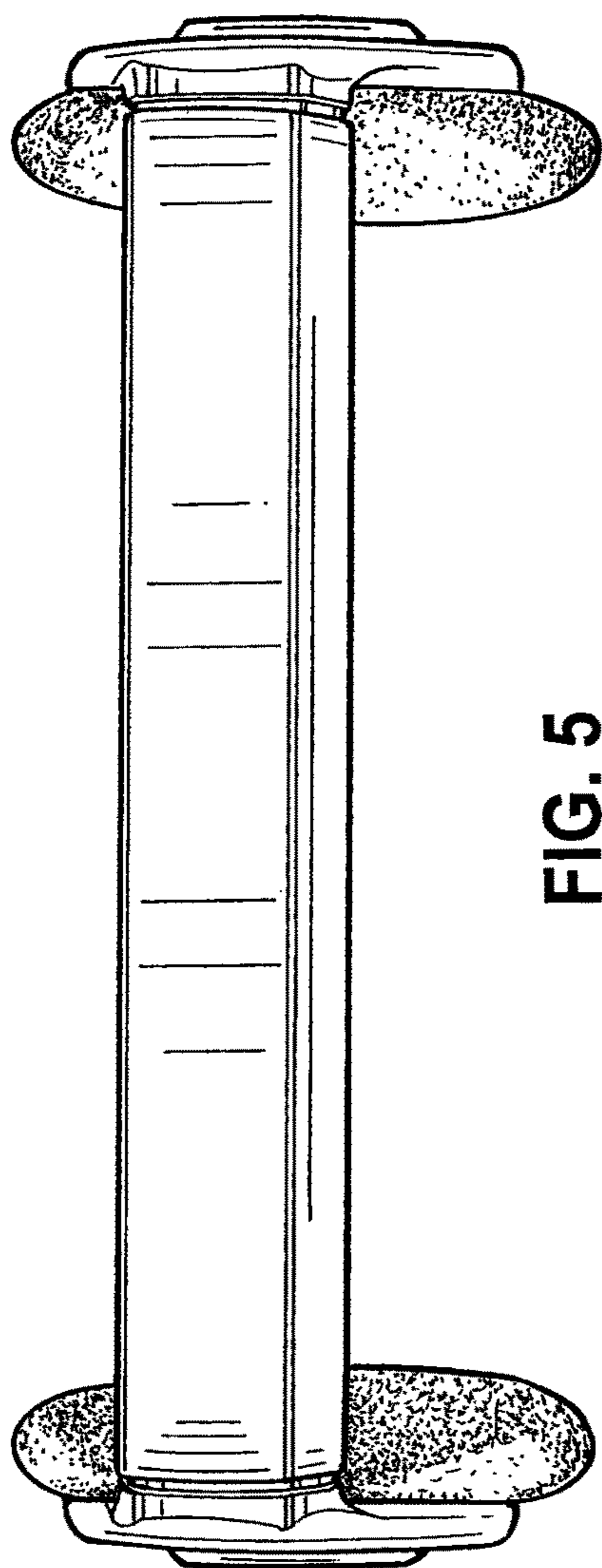

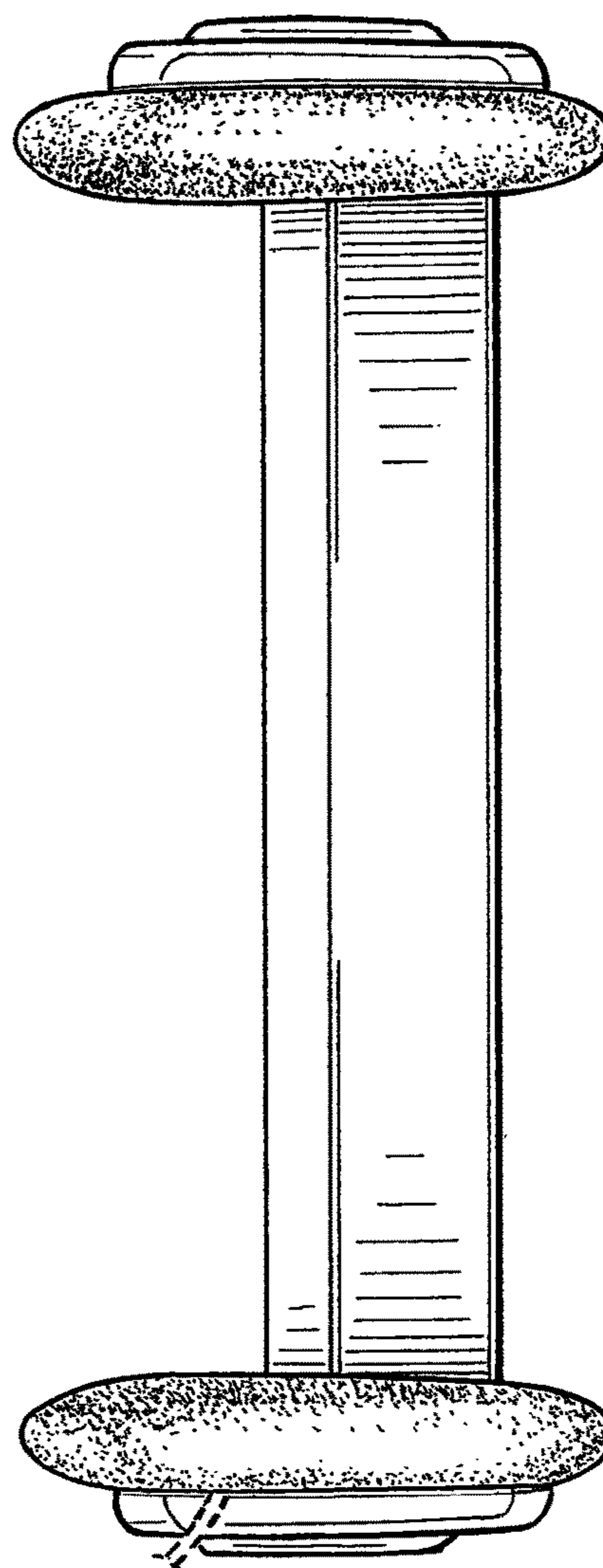
