(57) **CLAIM**

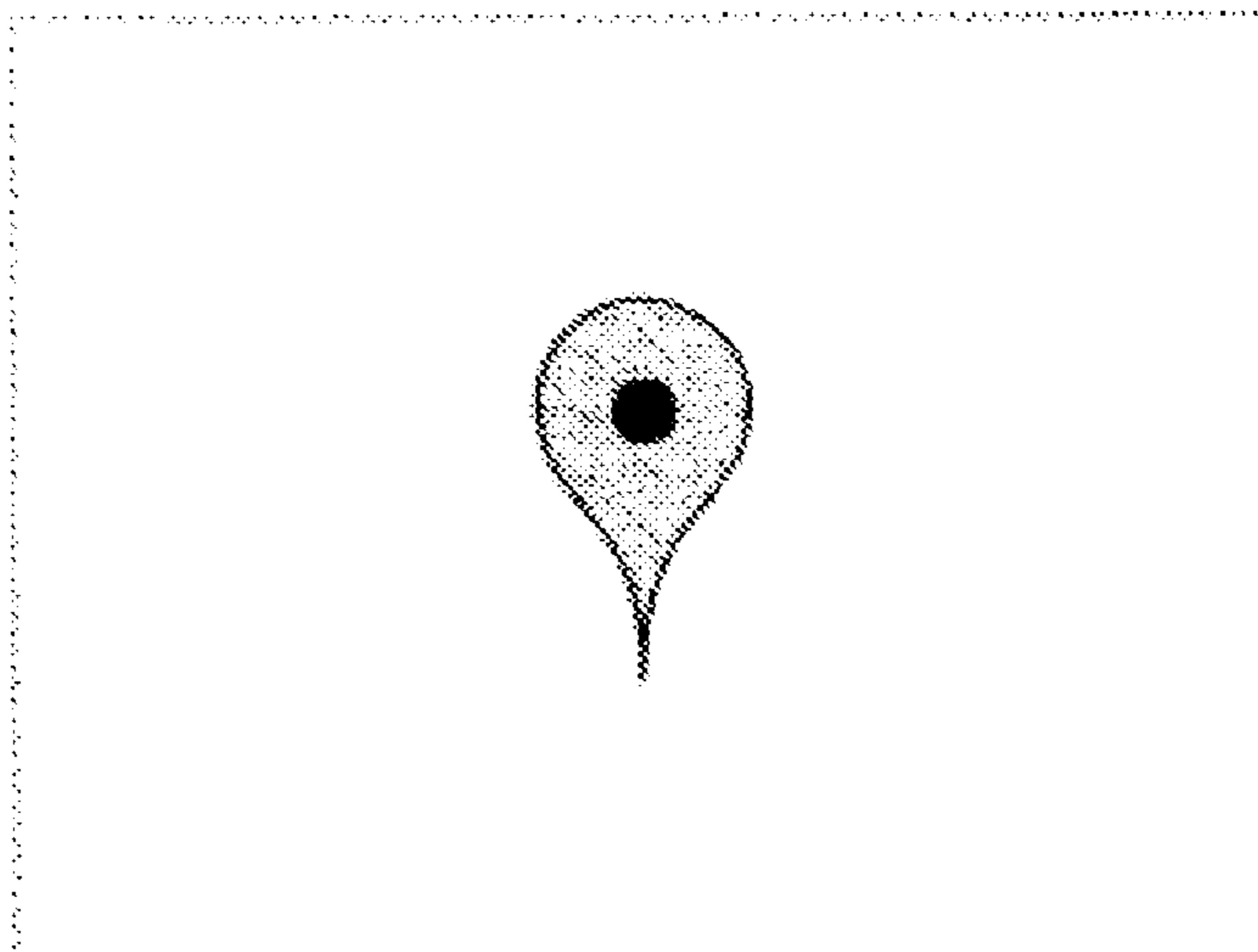
The ornamental design for a display screen of a communications terminal with a teardrop-shaped marker icon, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen of a communications terminal with a teardrop-shaped marker icon including a solid circle in an embodiment of the present invention; and, FIG. 2 is a front view of a display screen of a communications terminal with a teardrop-shaped marker icon having a red interior in an embodiment of the present invention.

The broken lines showing of a display screen of a communications terminal in the figures is for the purpose of illustrating environmental structure and forms no part of the claimed design.

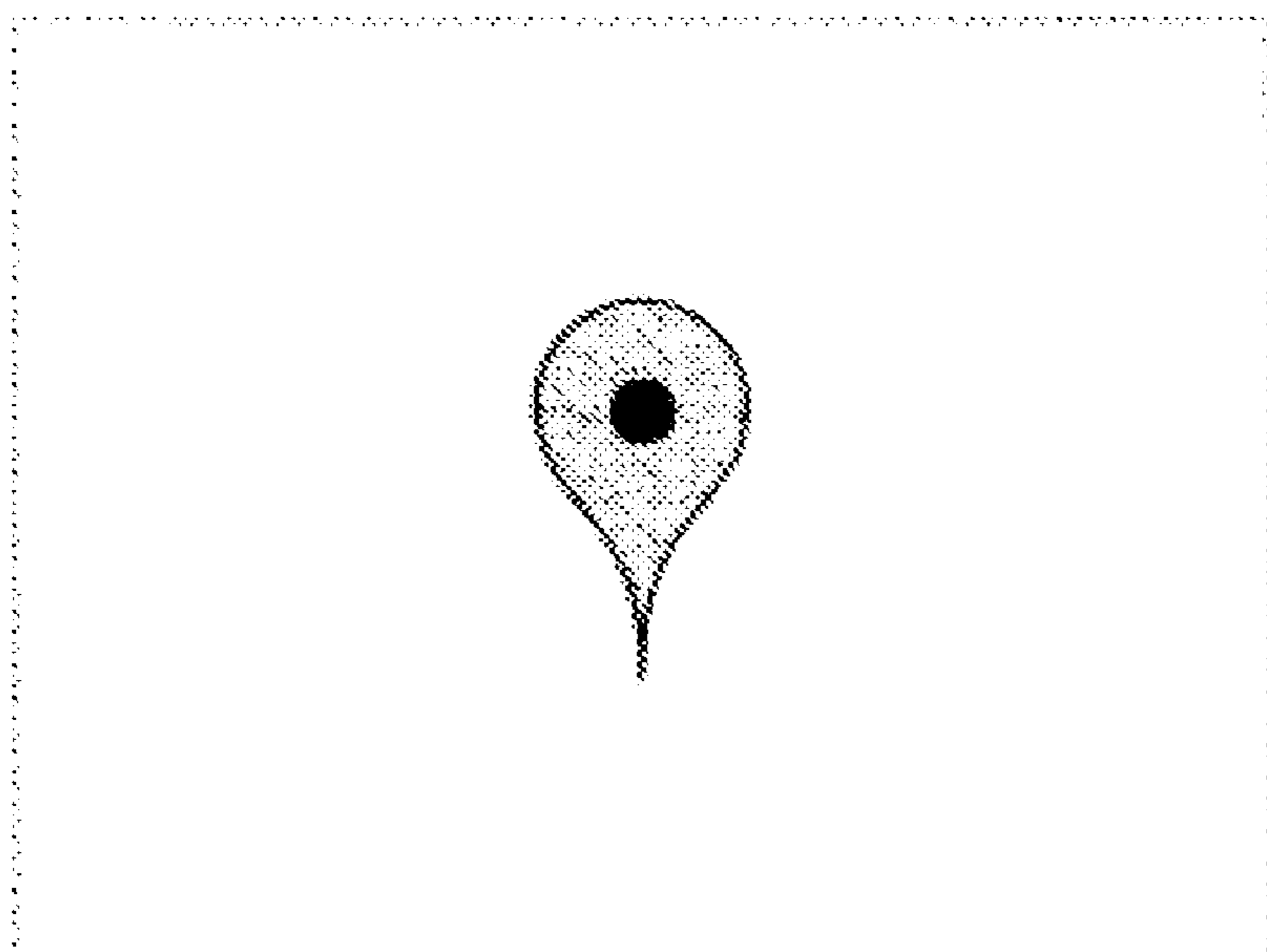

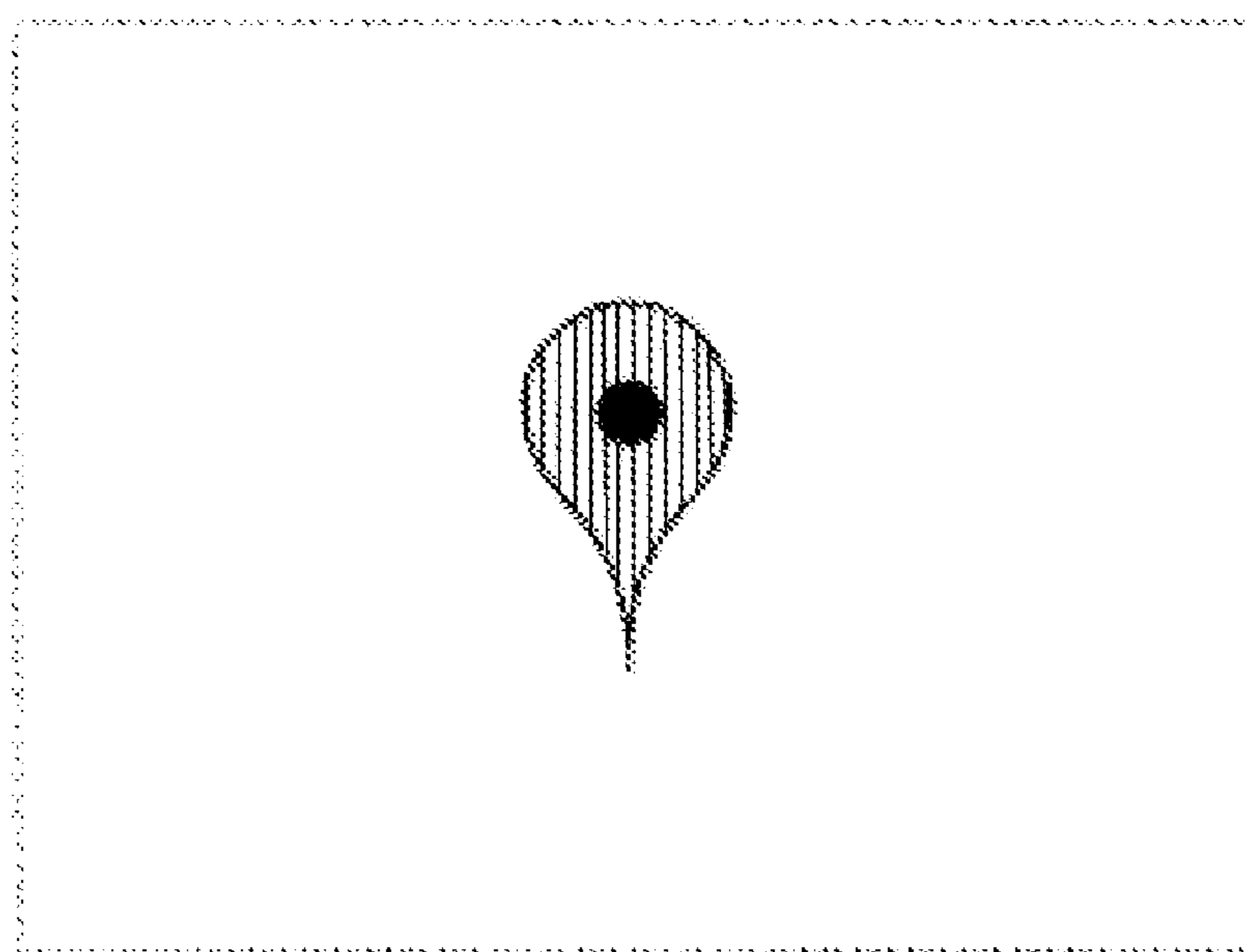
