(57) **CLAIM**

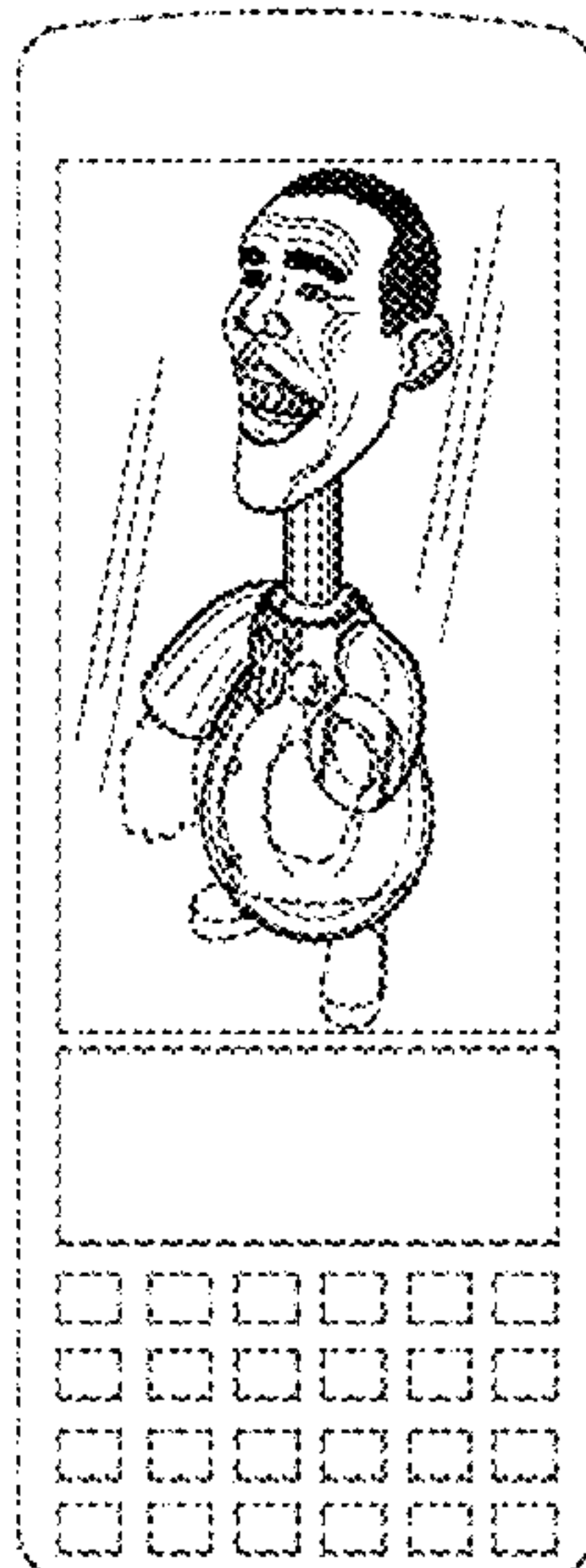
The ornamental design for a display screen showing a virtual doll icon, as shown and described.
