**DESCRIPTION**

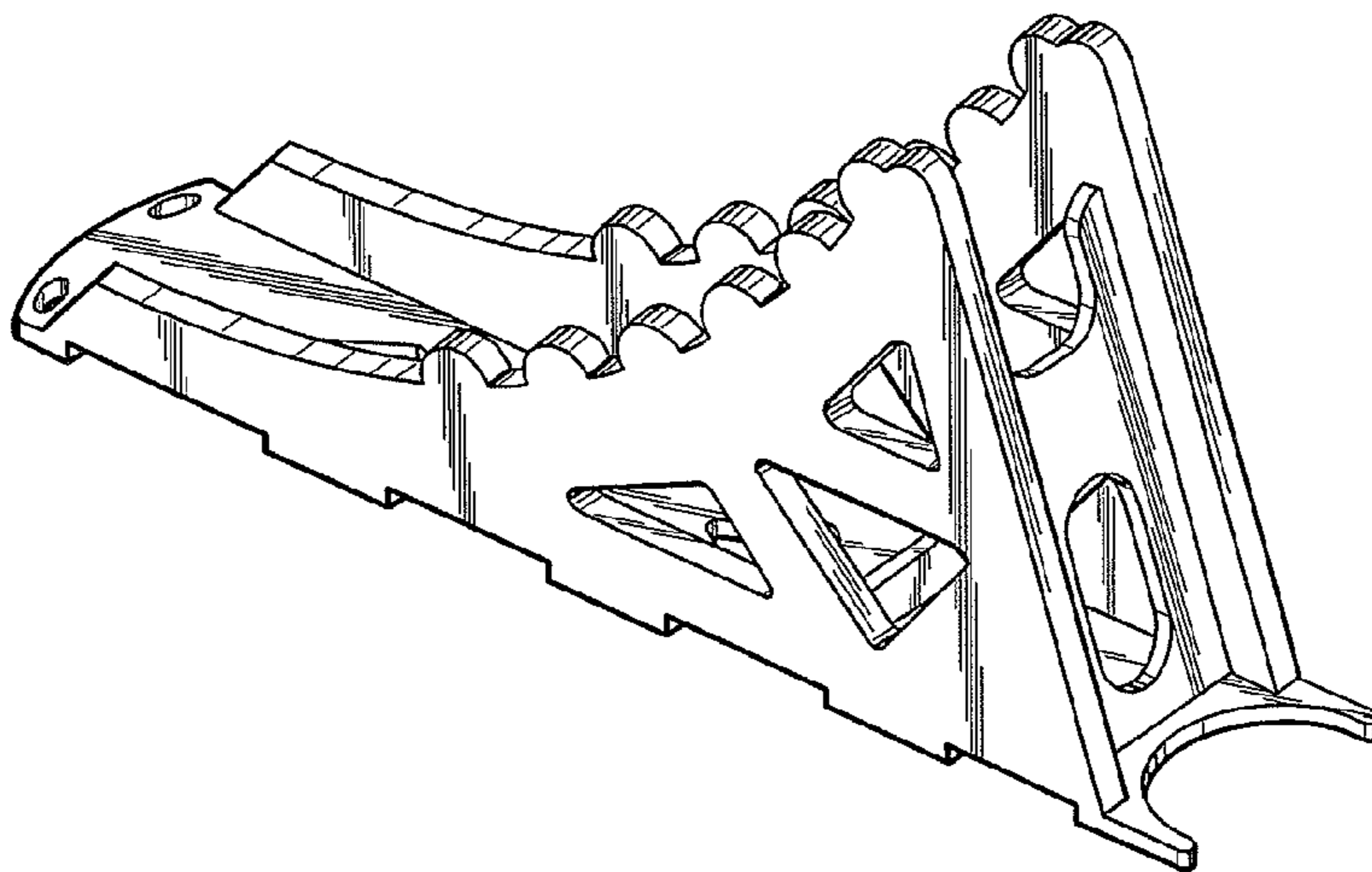
FIG. 1 is a perspective view of a gripping attachment for backhoe or excavator showing my new design.

 FIG. 7 is a bottom plan view of the embodiment of FIG. 1.

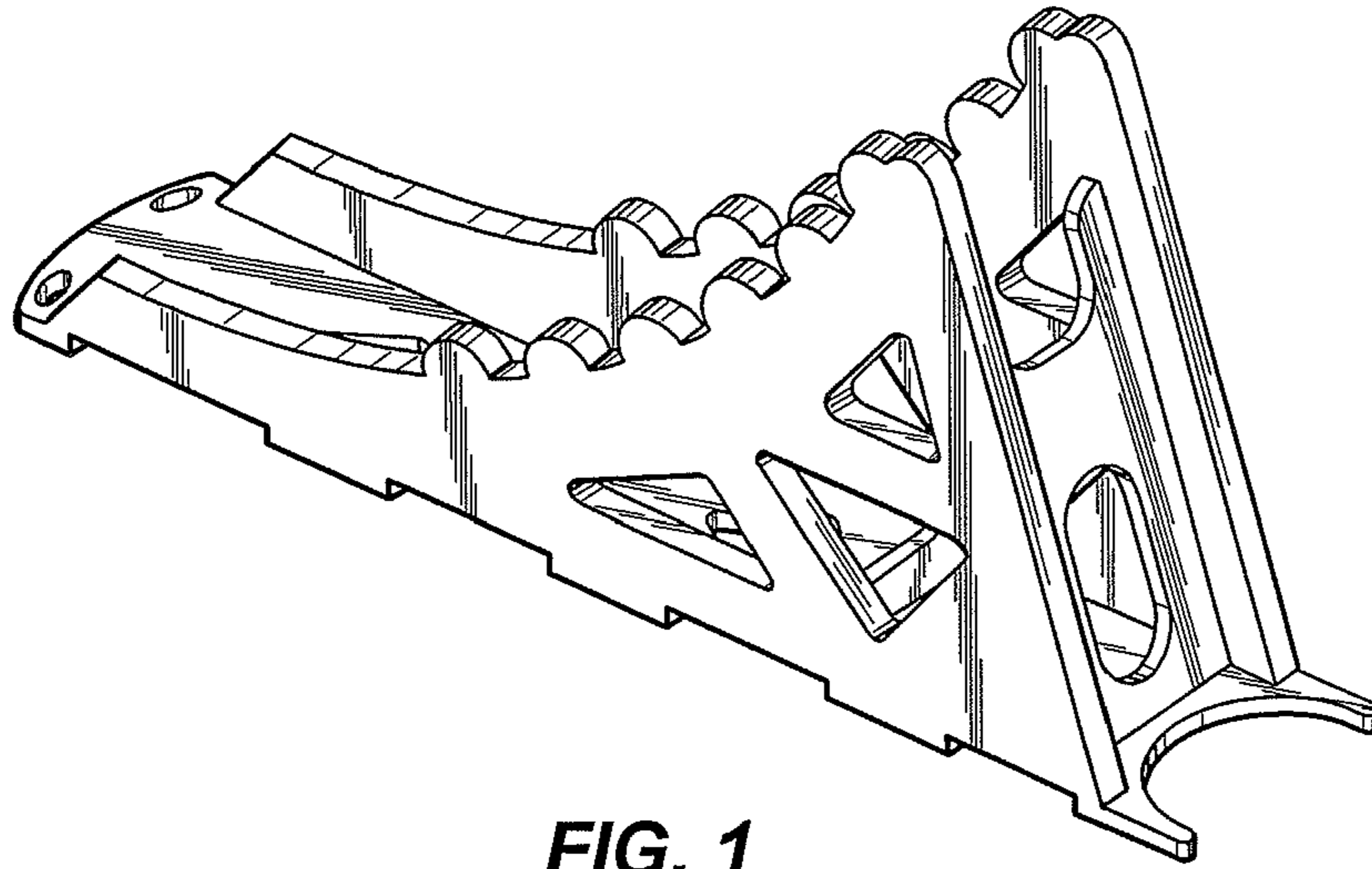

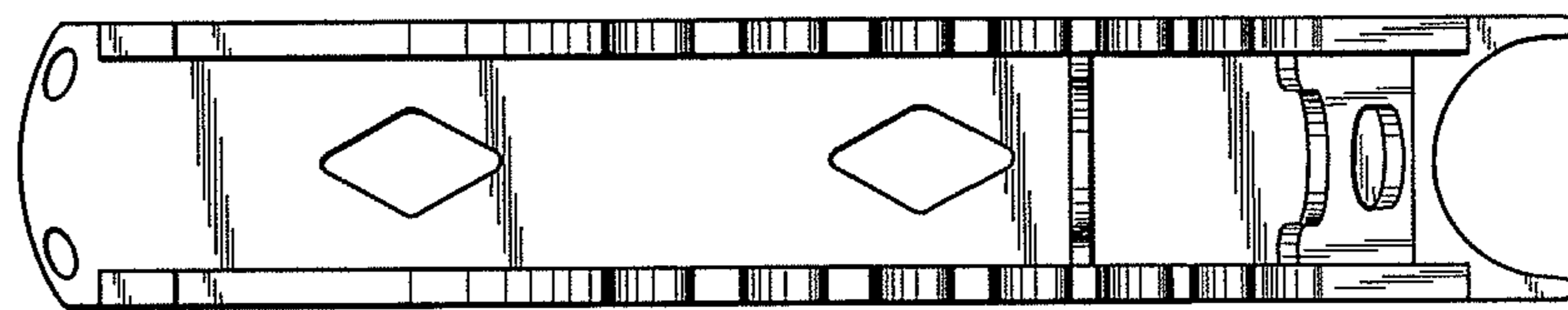

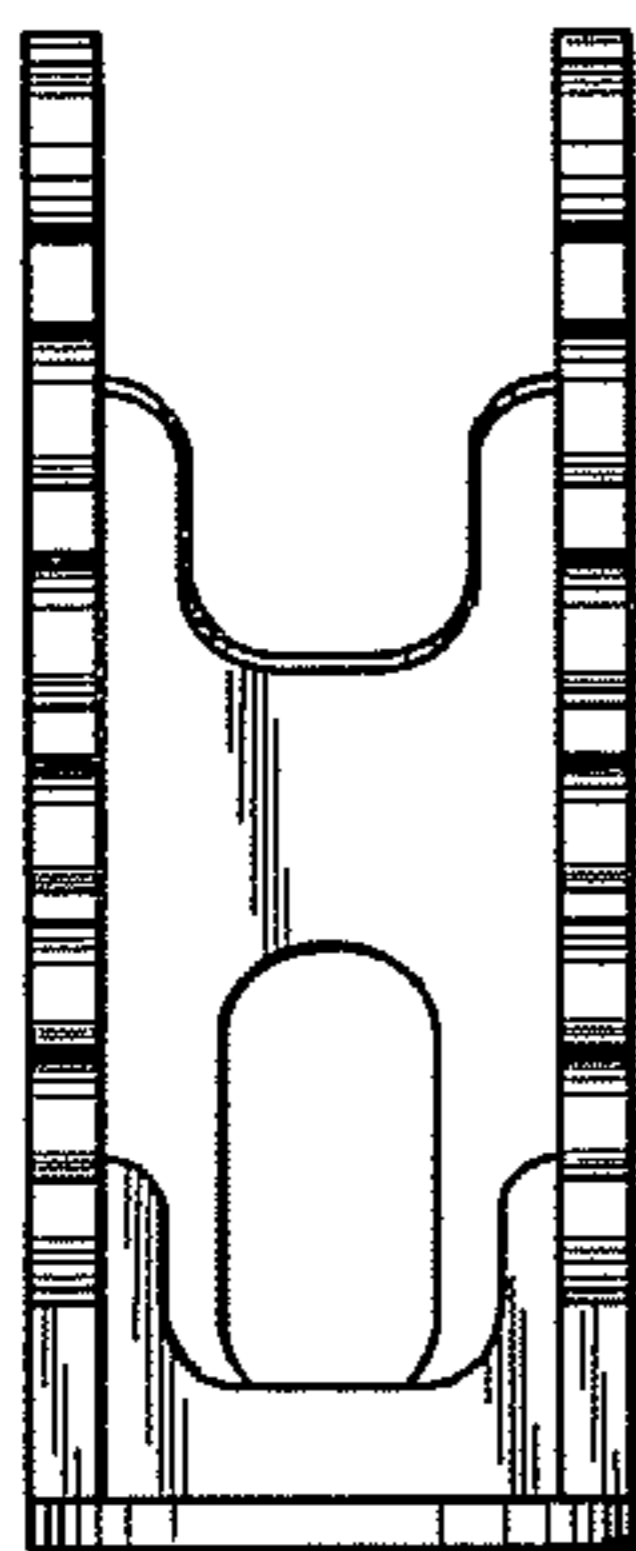




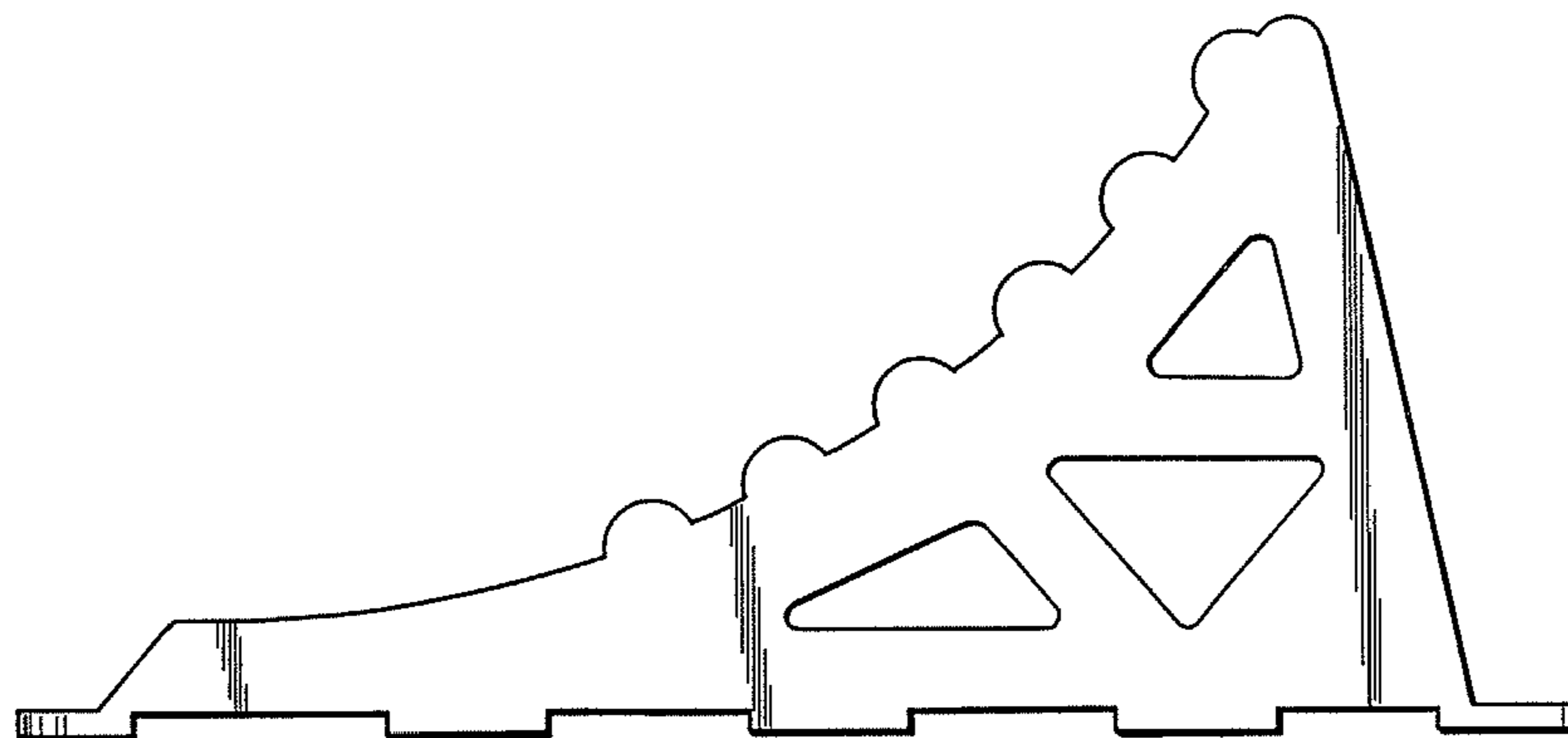

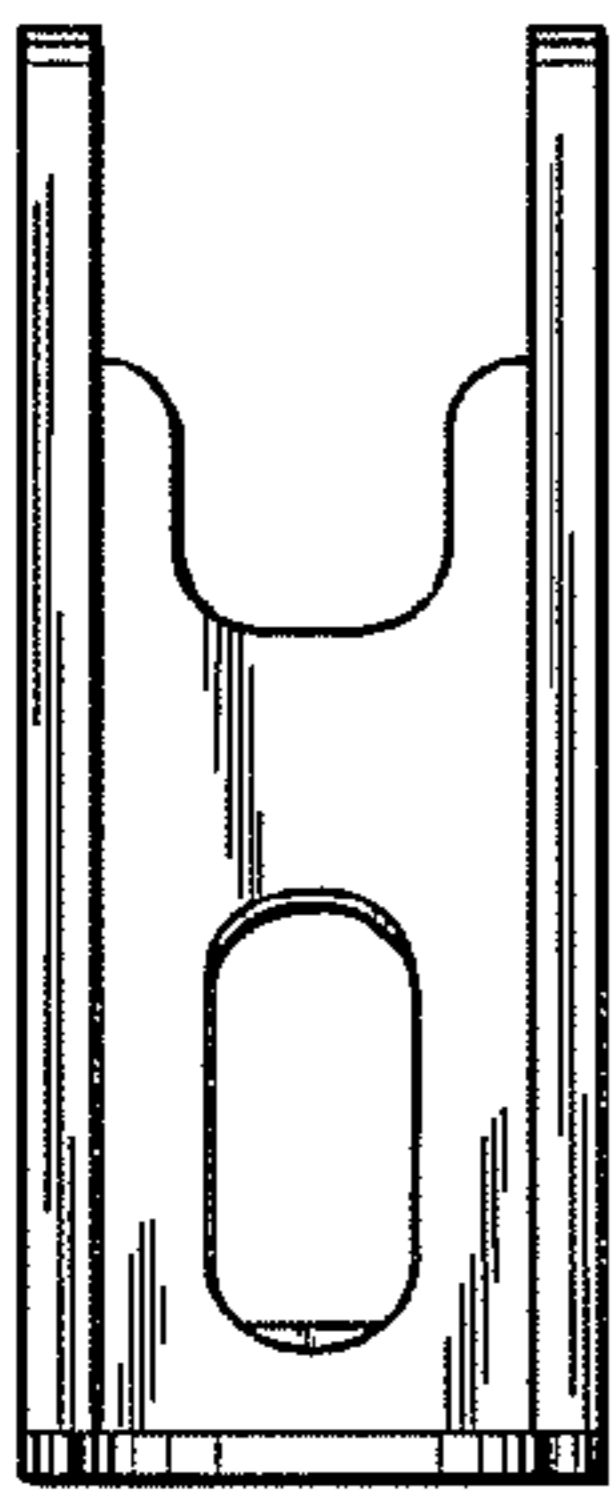

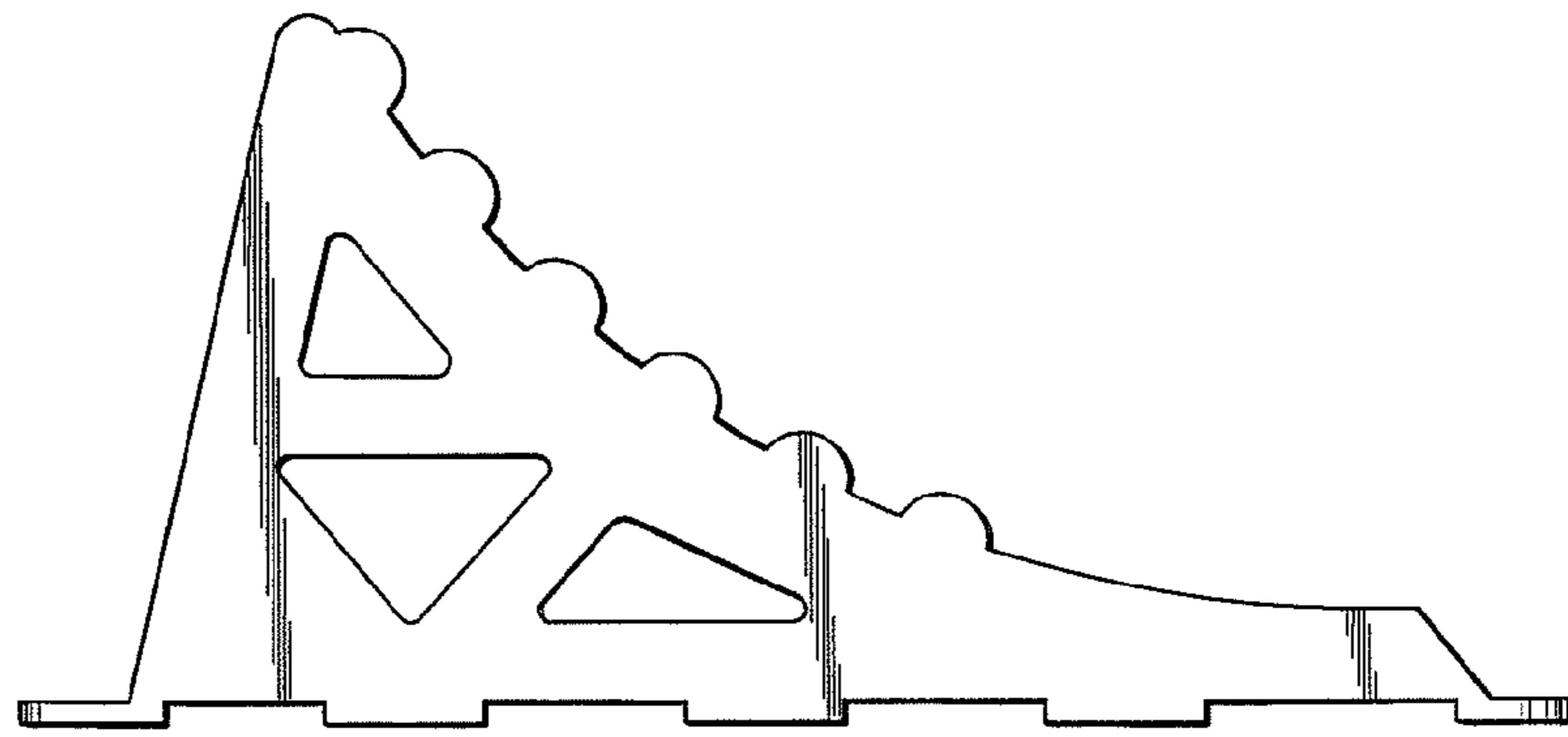

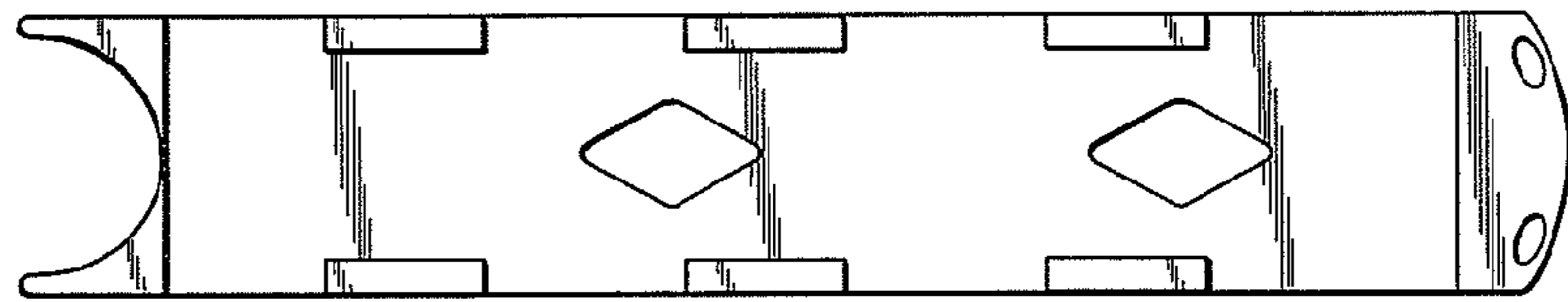
