FIG. 1 is a perspective view of eyeglasses showing my new design;

FIG. 7 is side elevation cross-section view thereof taken along line 7-7 in FIG. 4.

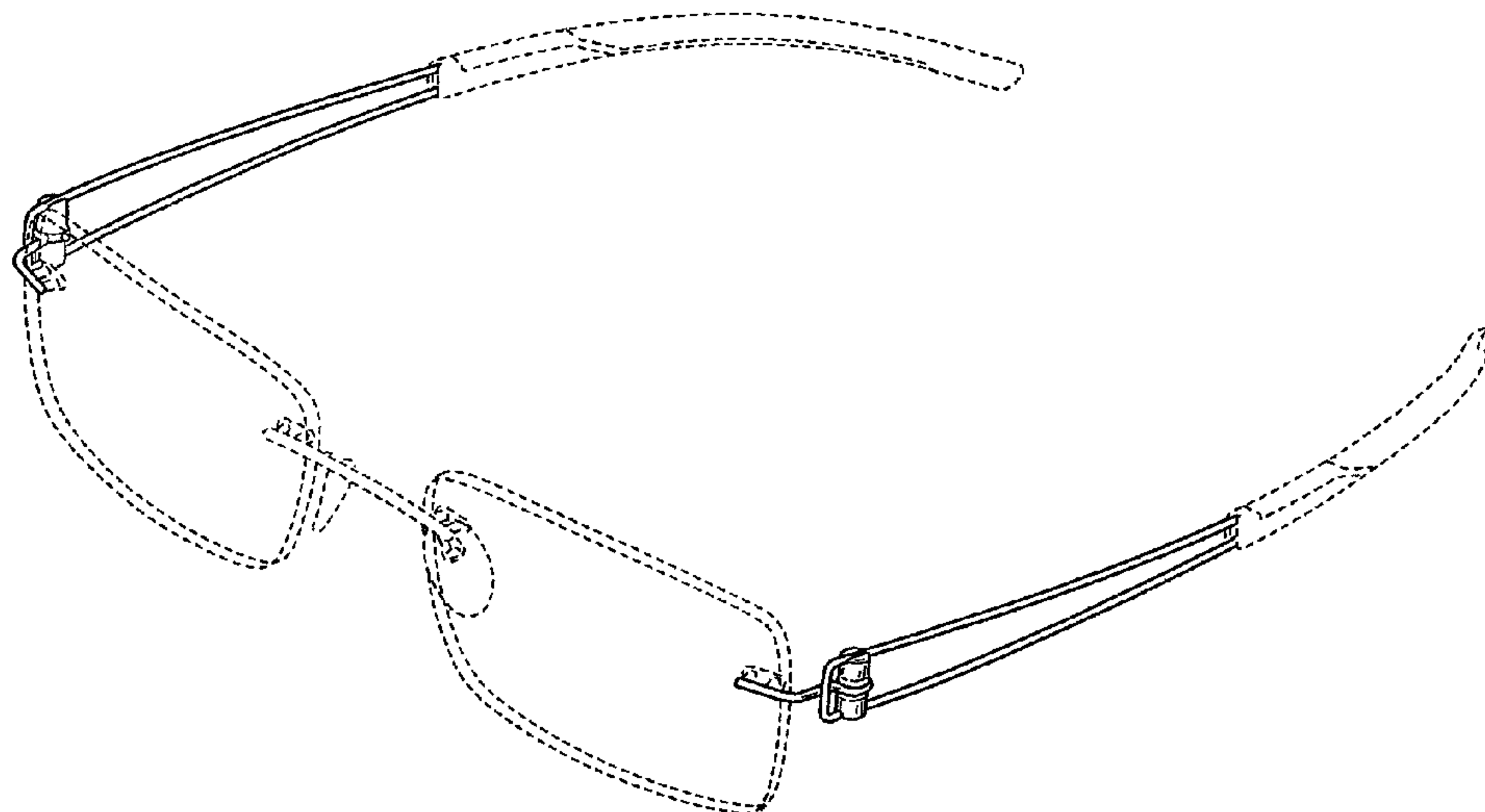

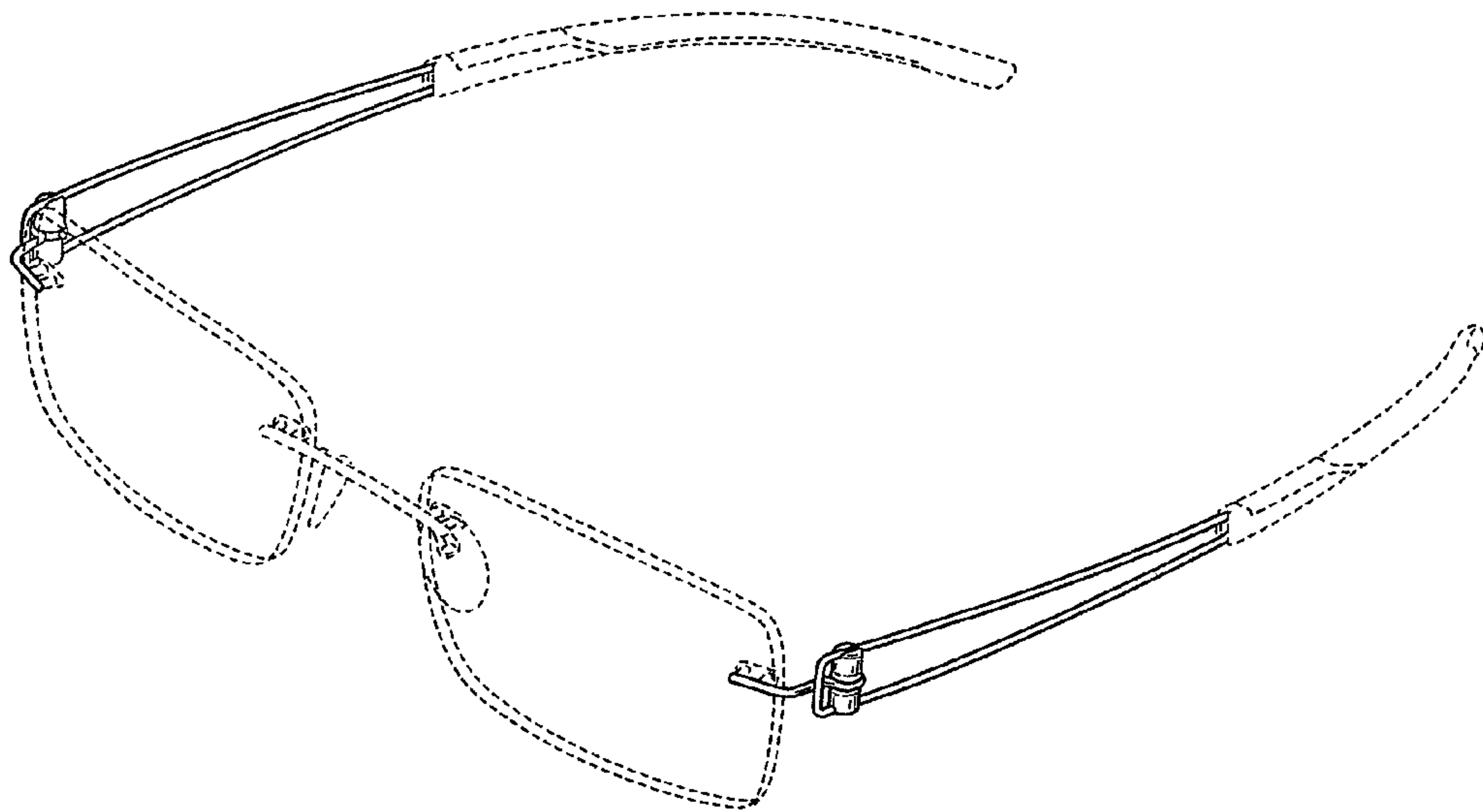

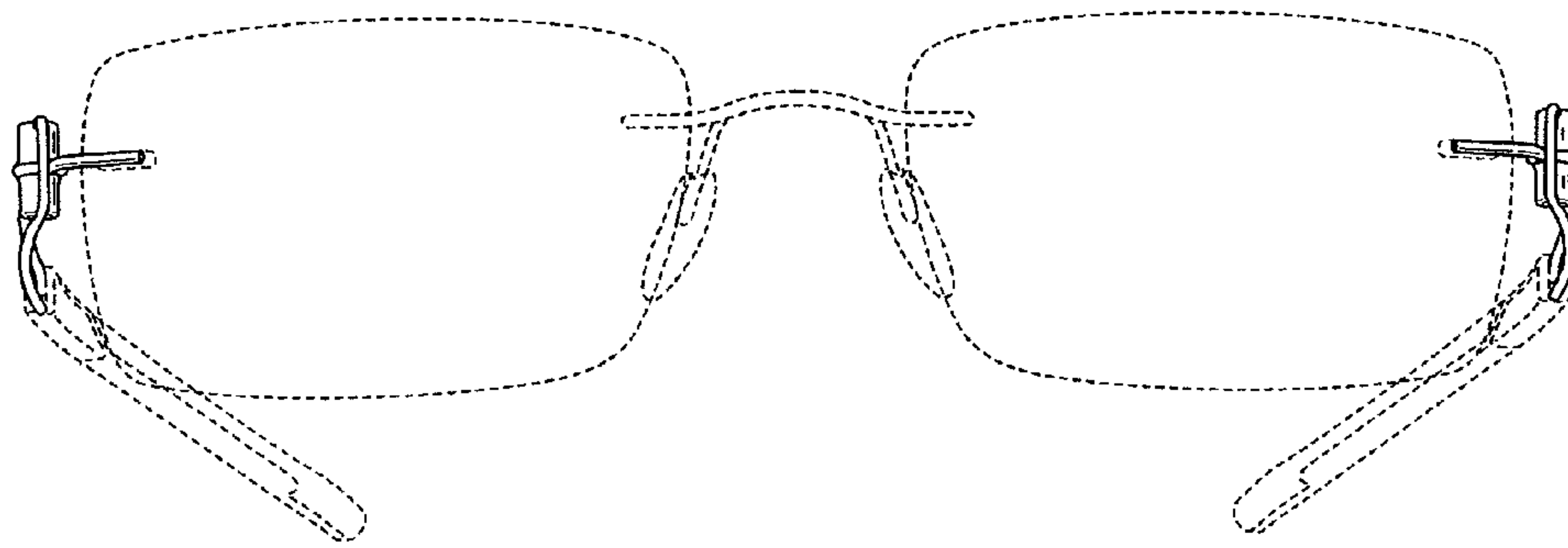

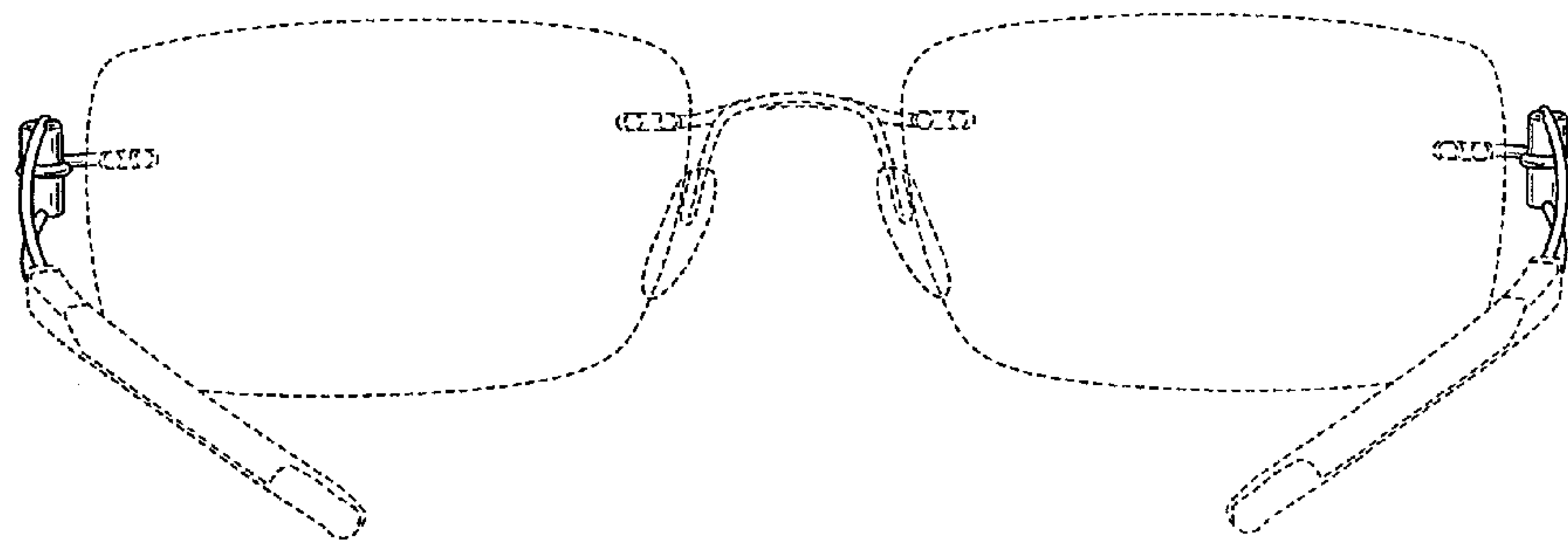

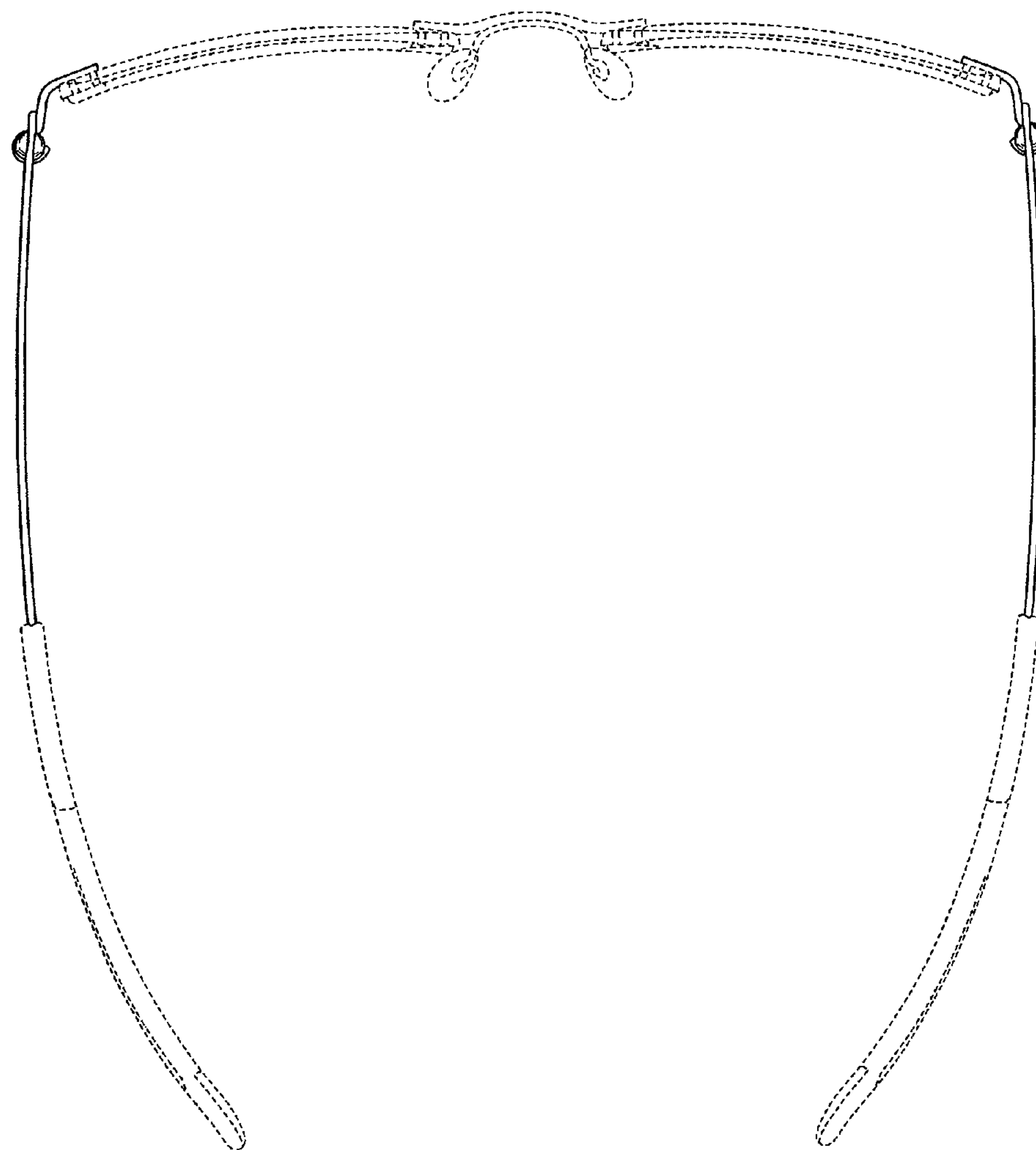

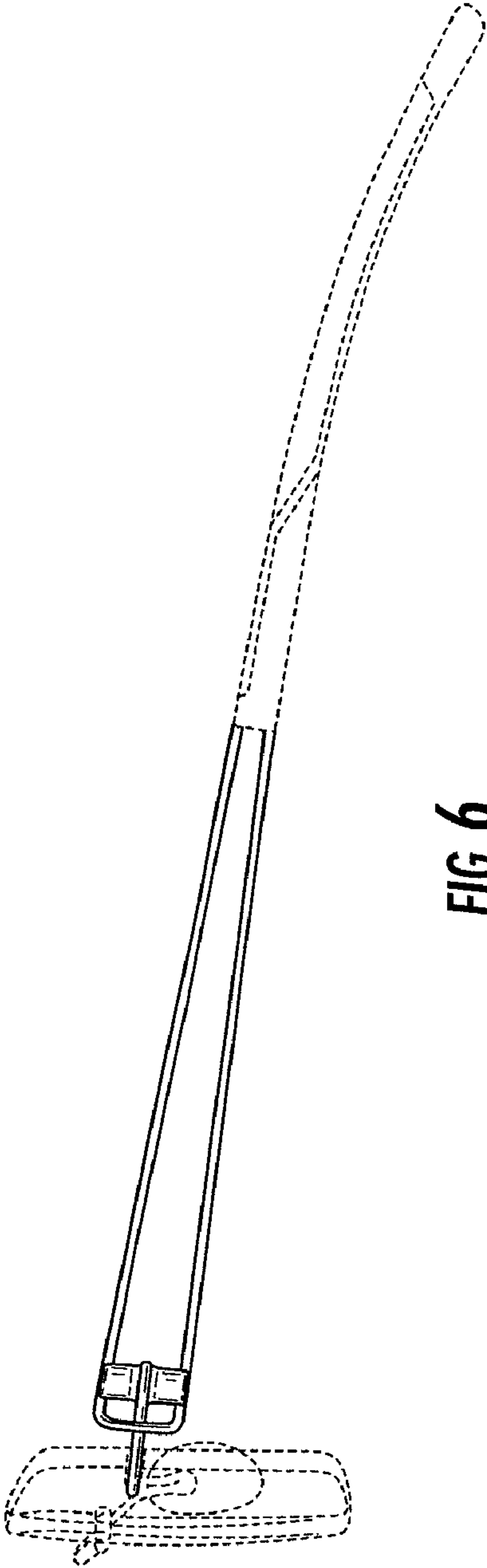

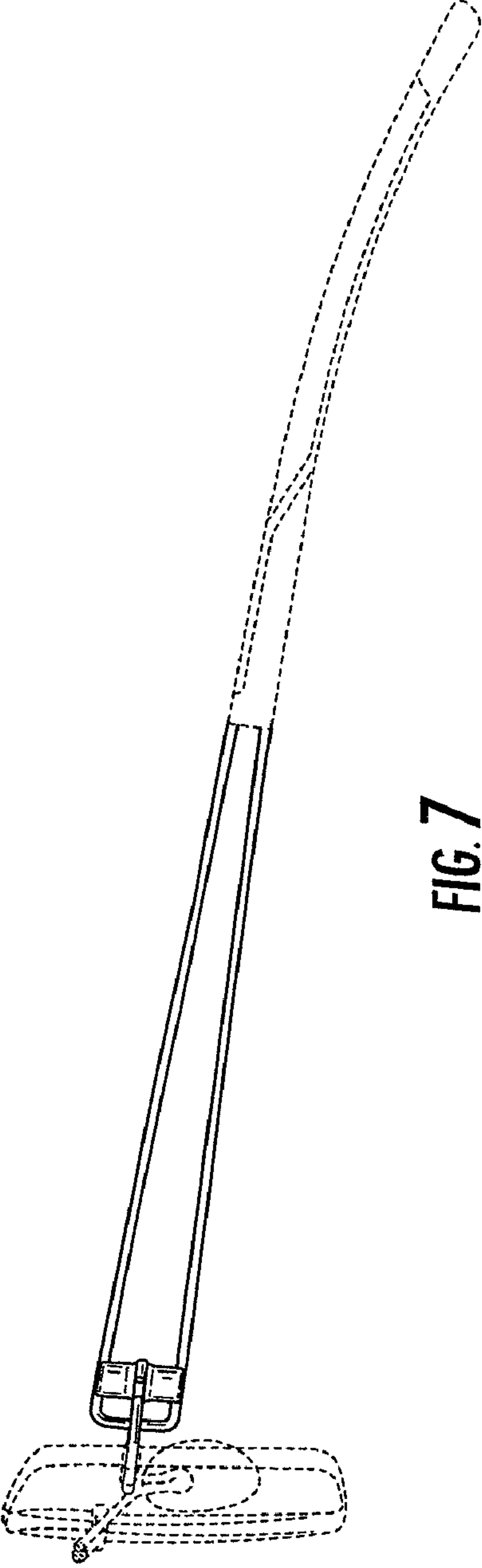
