**DESCRIPTION**

FIG. 1 is a perspective view of a counting machine showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a left side view thereof, the right side view is a mirror image of the left side view;

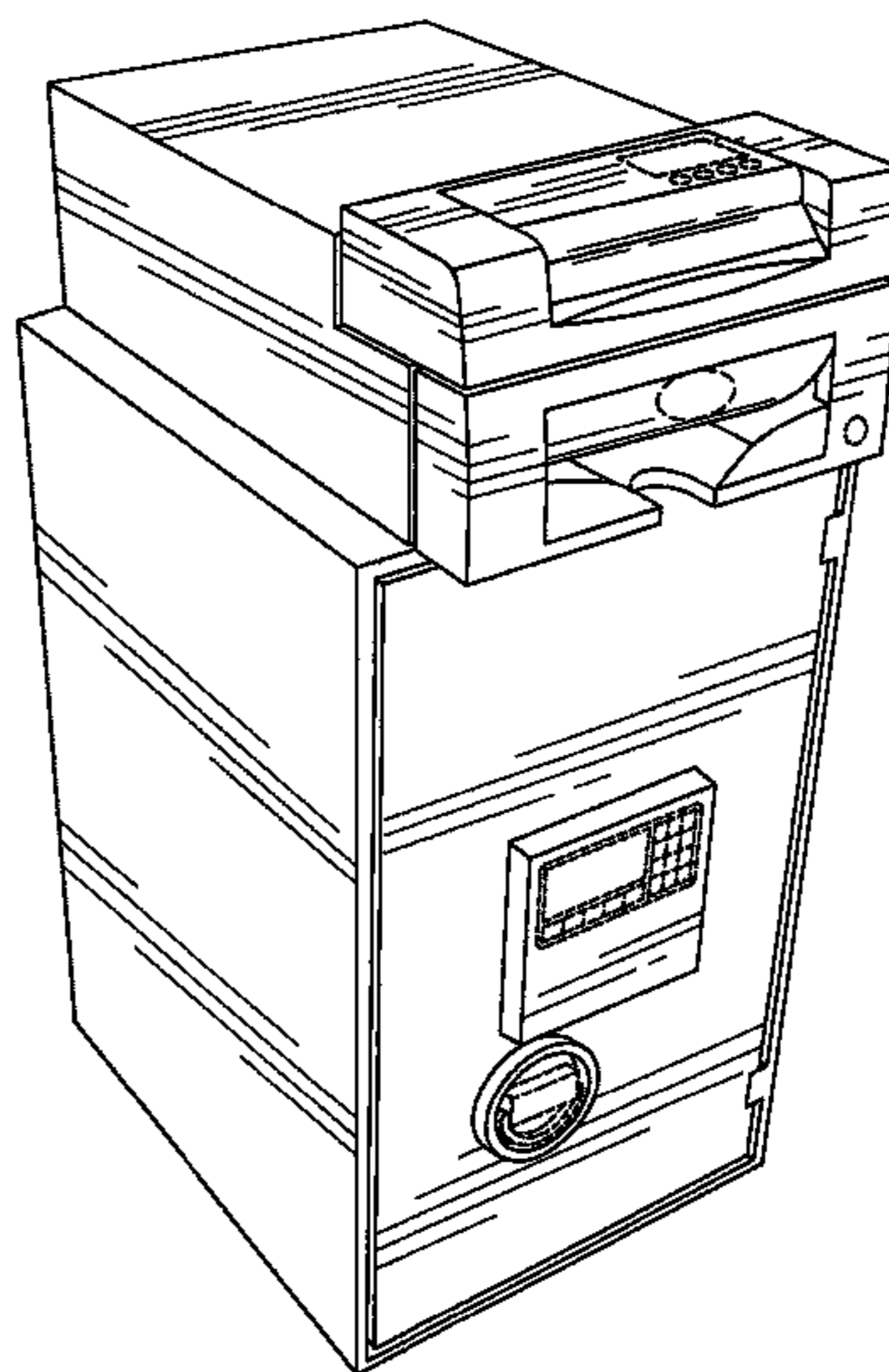
FIG. 4 is a top view thereof;

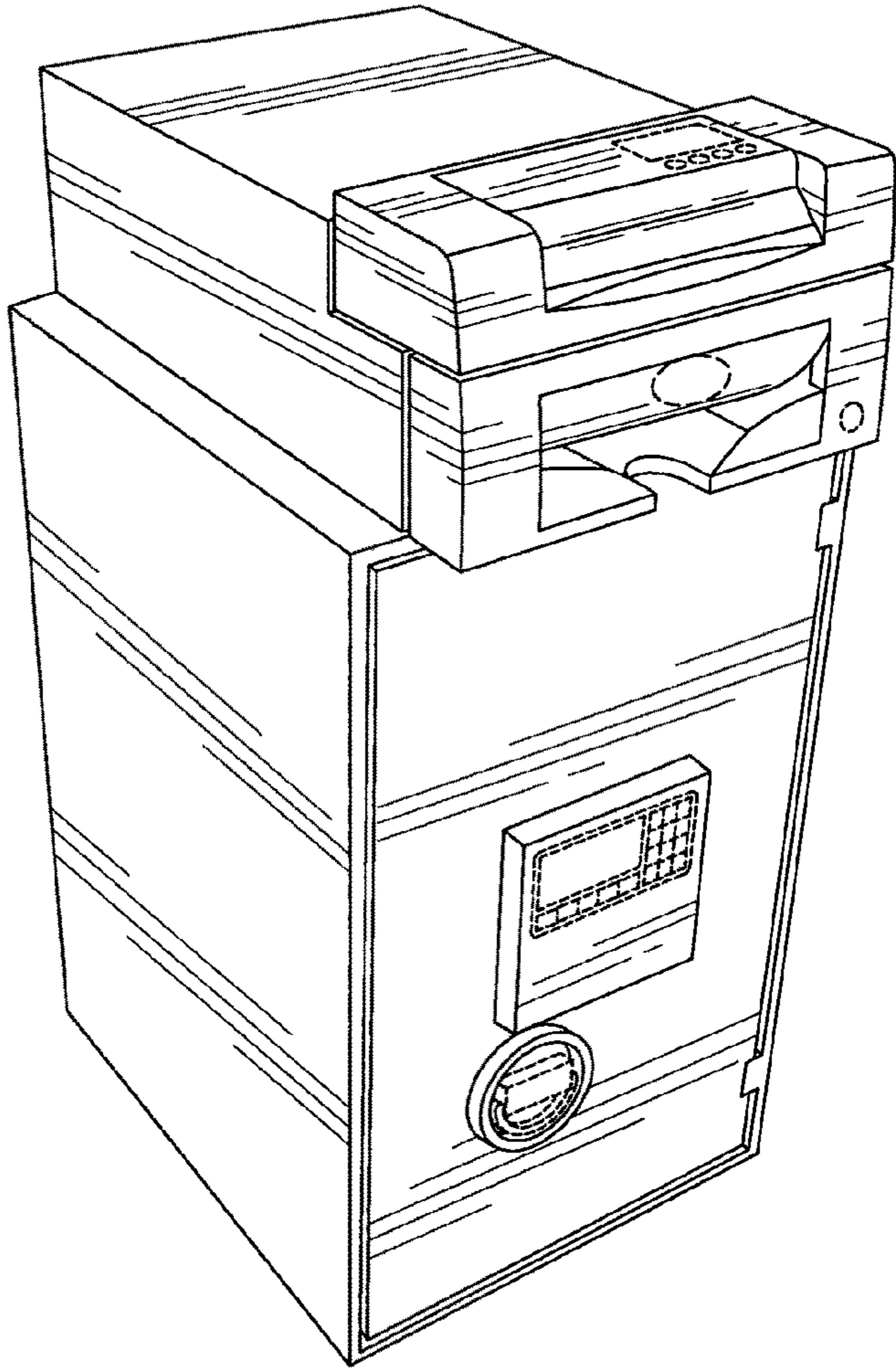

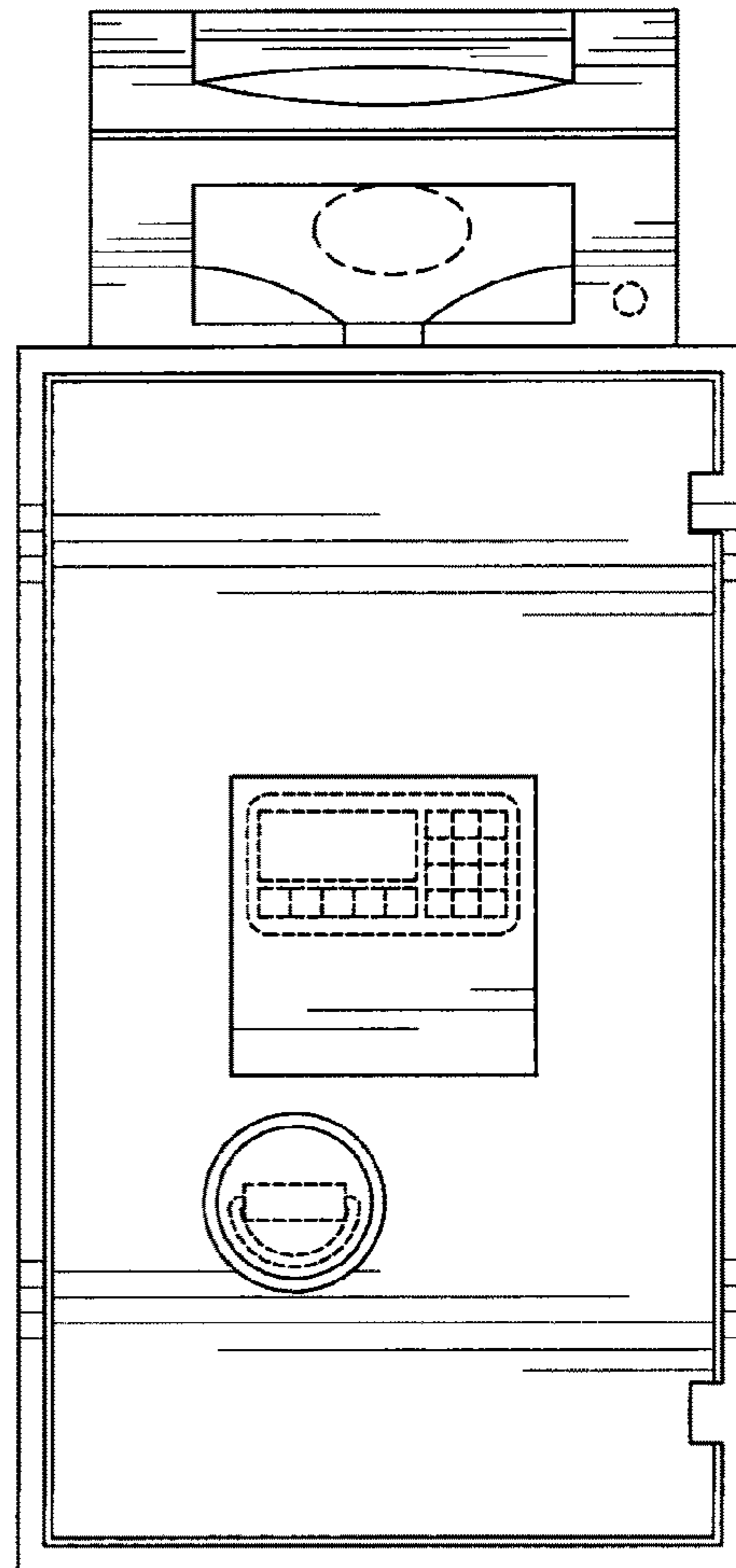

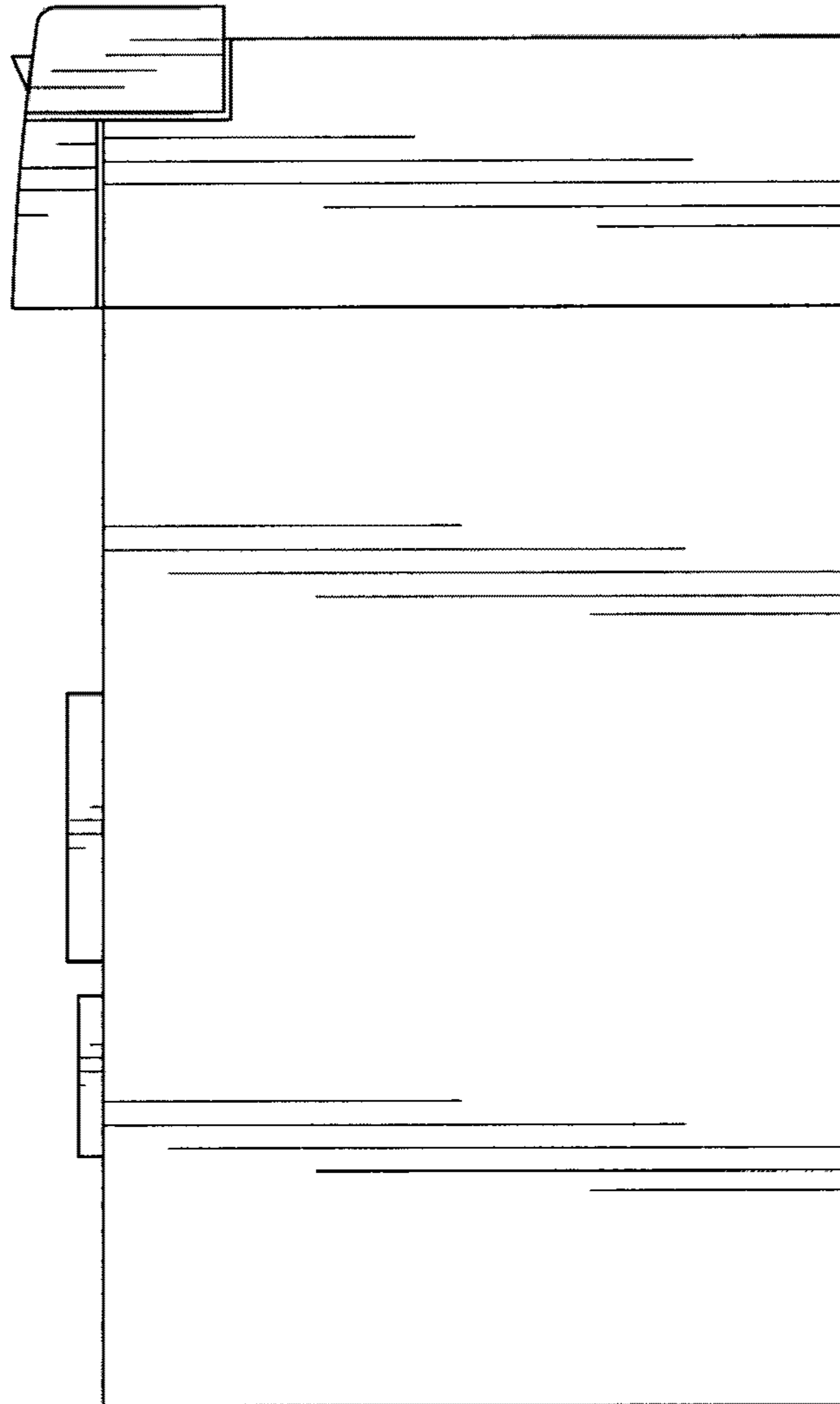

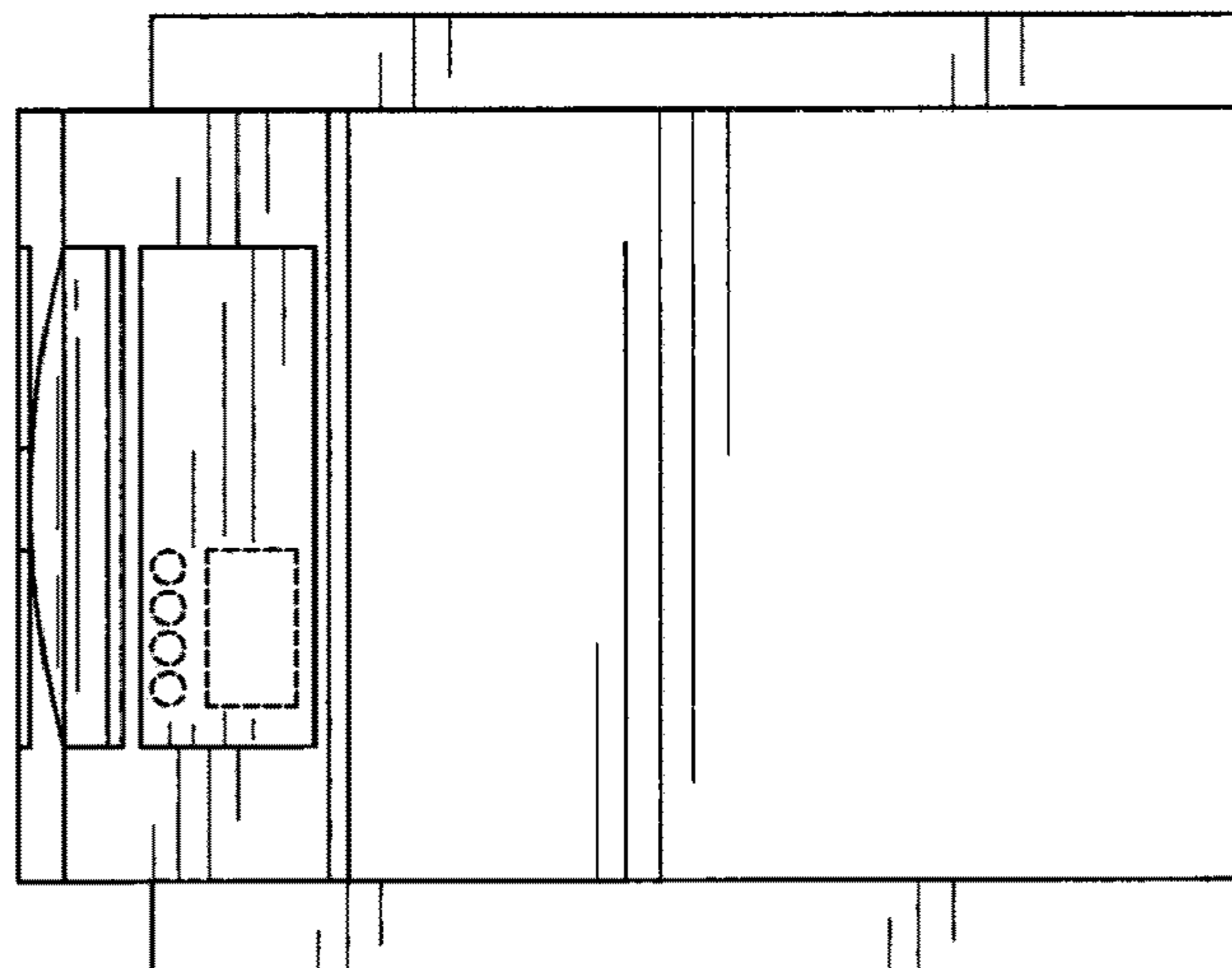

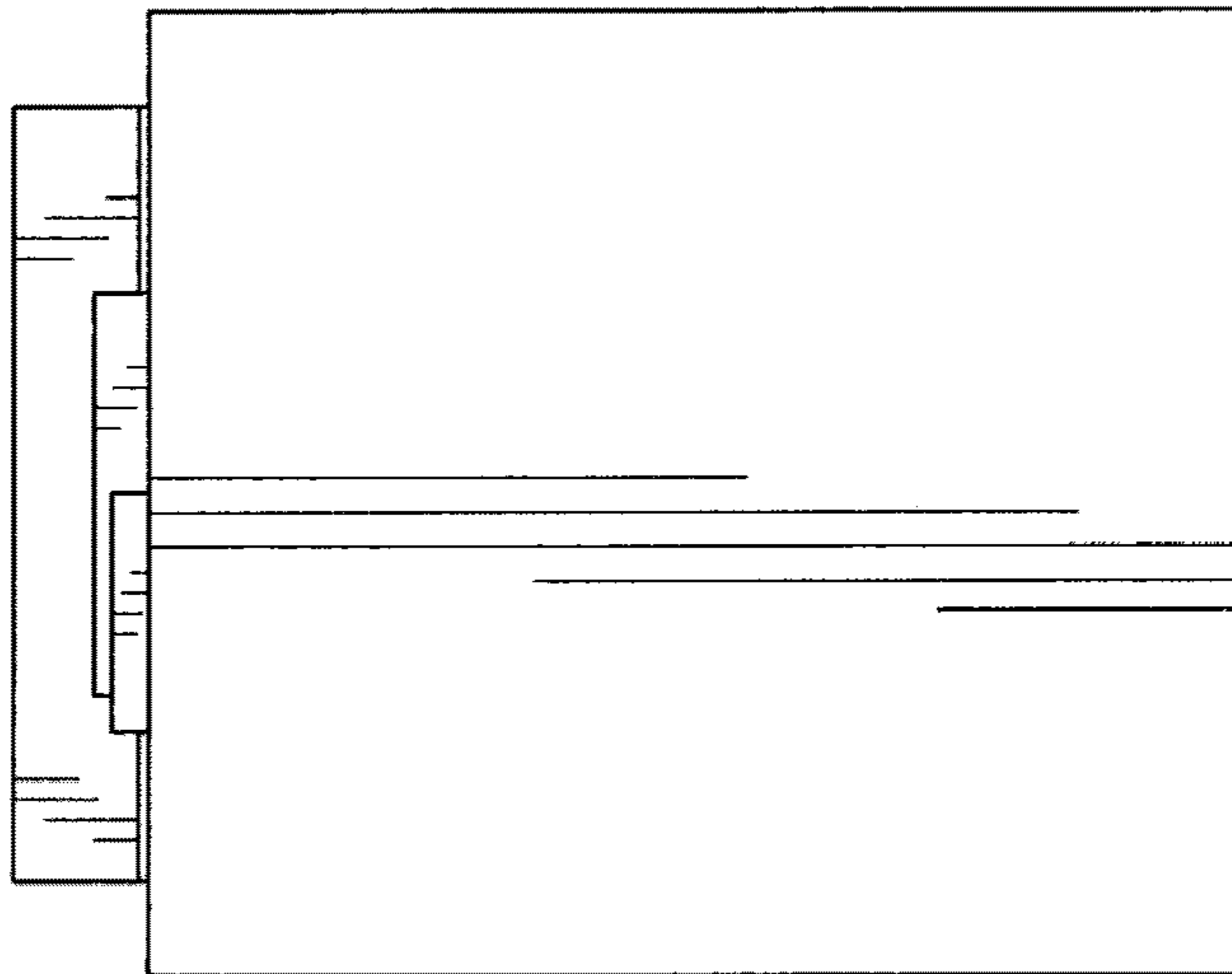

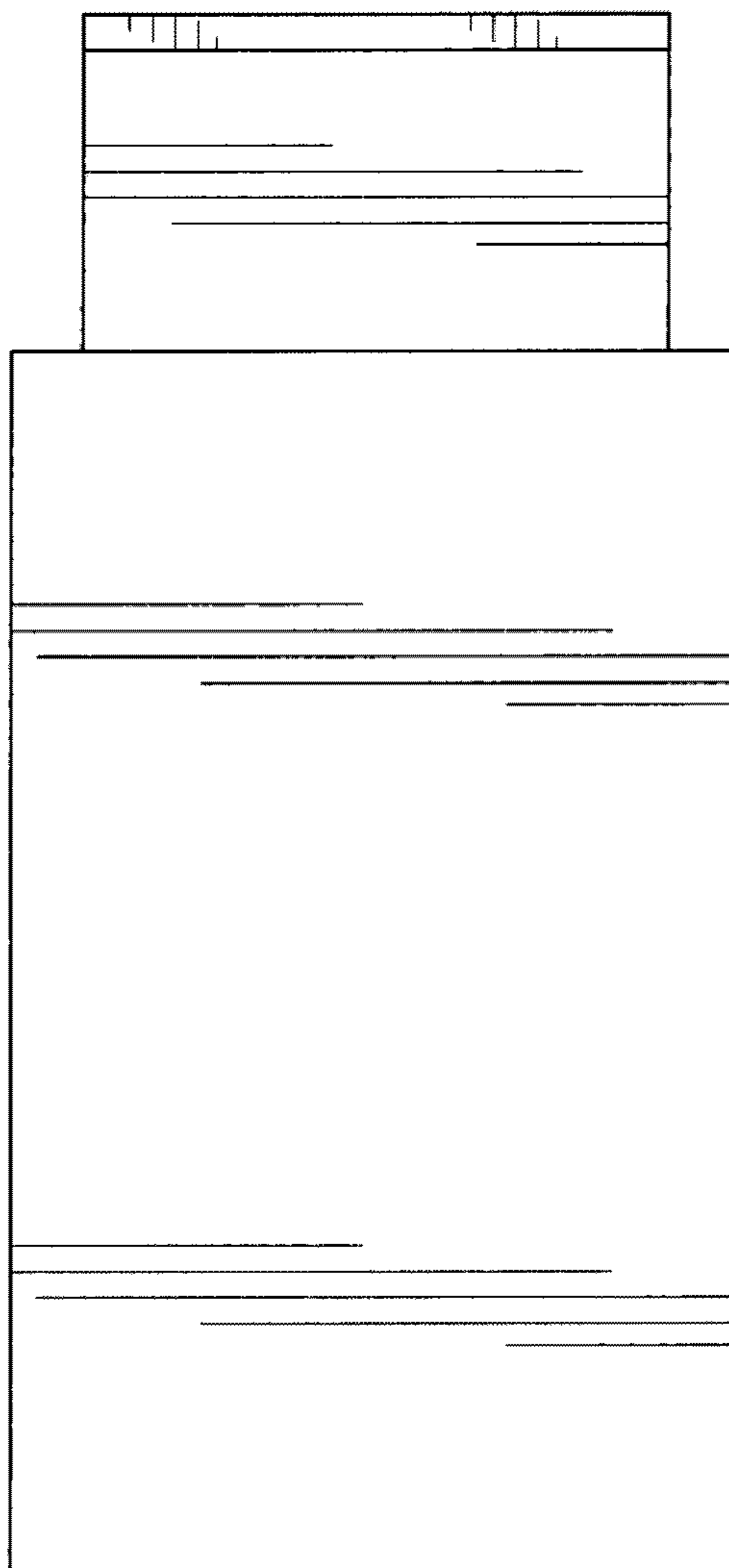
