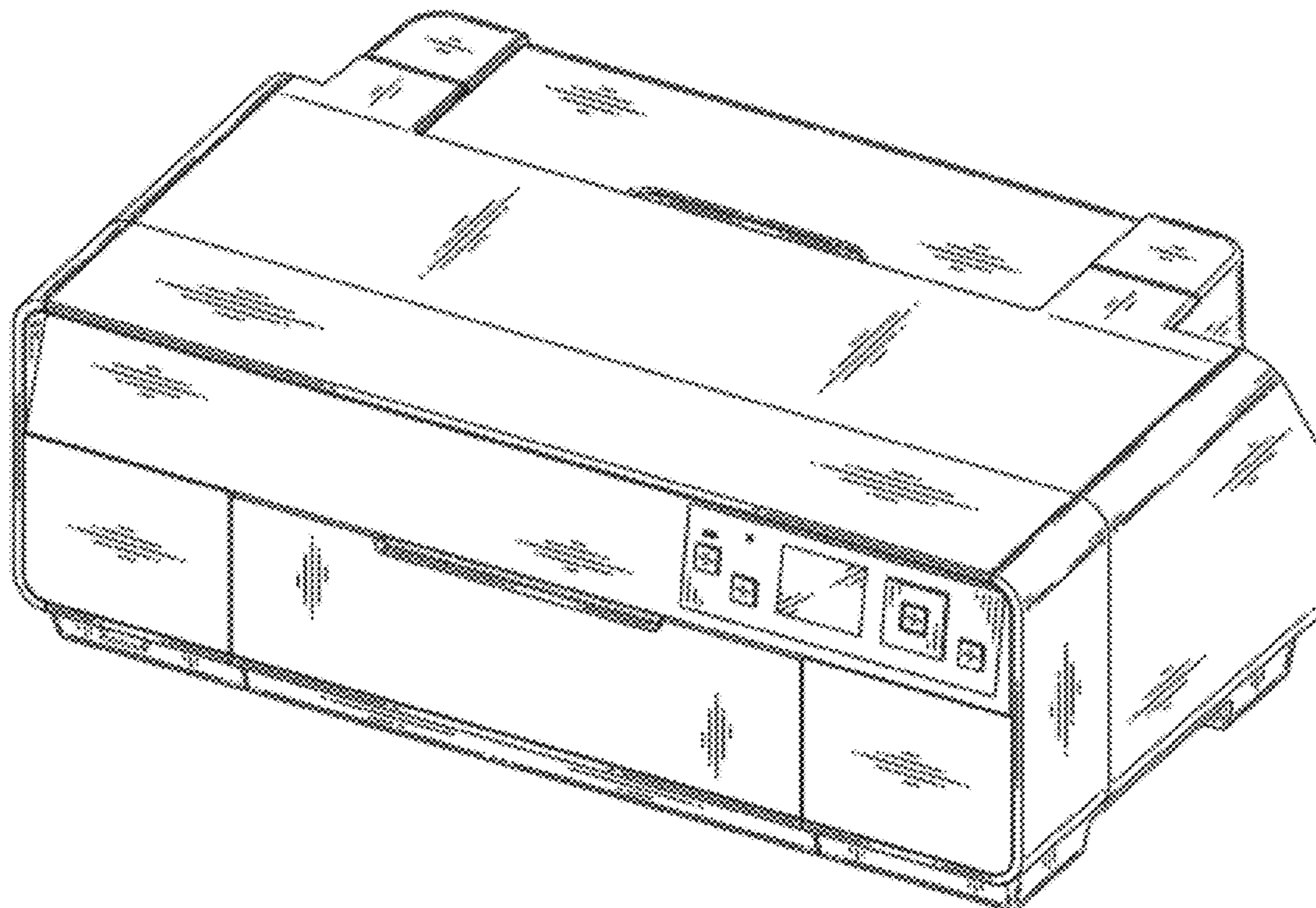
(57) **CLAIM**

The ornamental design for a printer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our new design for a printer, viewed from the top front and right side; FIG. 2 is a front view of the printer shown in FIG. 1; FIG. 3 is a rear view of the printer shown in FIG. 1; FIG. 4 is a left side view of the printer shown in FIG. 1; FIG. 5 is a right side view of the printer shown in FIG. 1; FIG. 6 is a top view of the printer shown in FIG. 1; and FIG. 7 is a bottom view of the printer shown in FIG. 1. The broken lines shown in the figures are for illustrative purposes only and form no part of the claimed design.

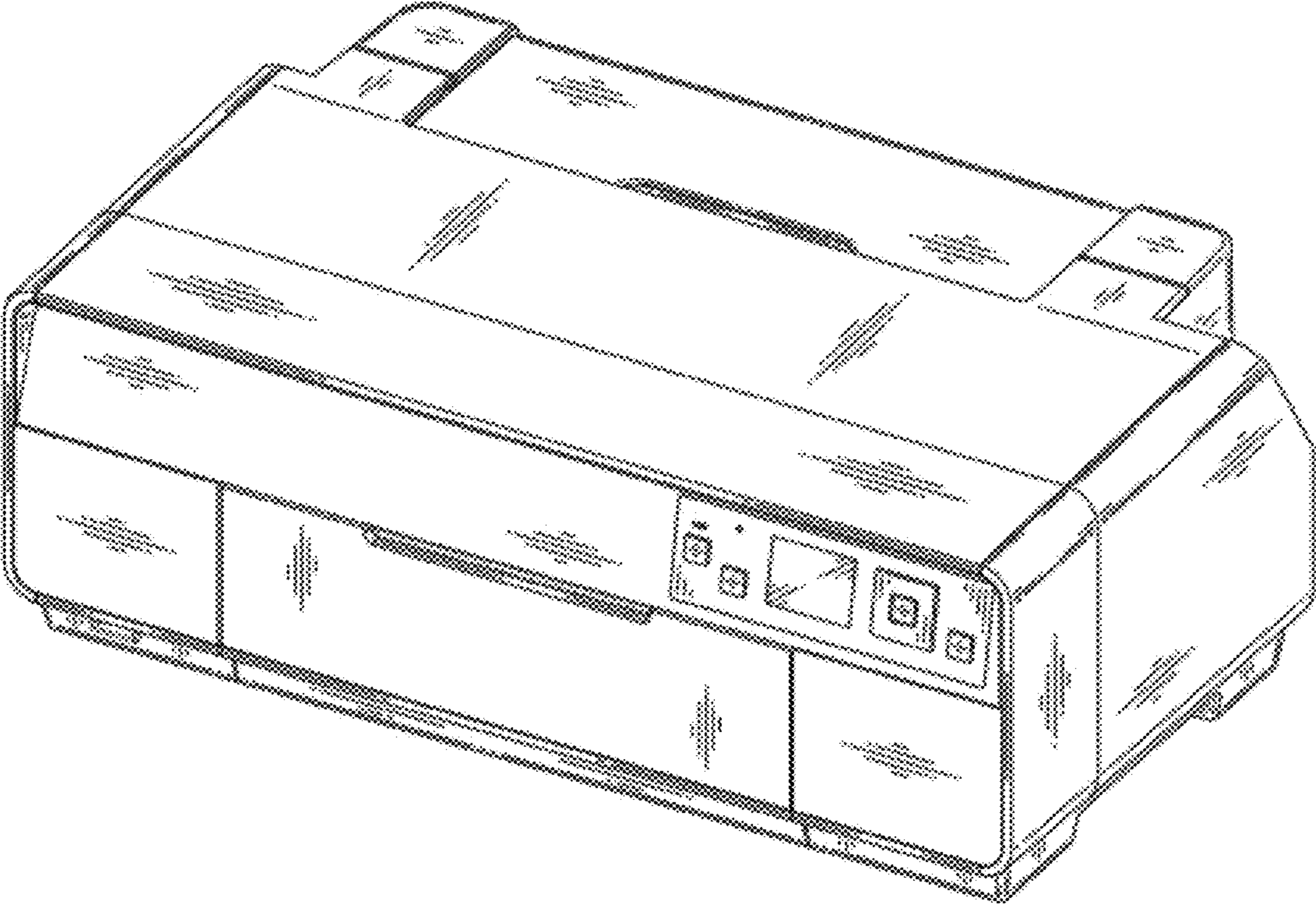

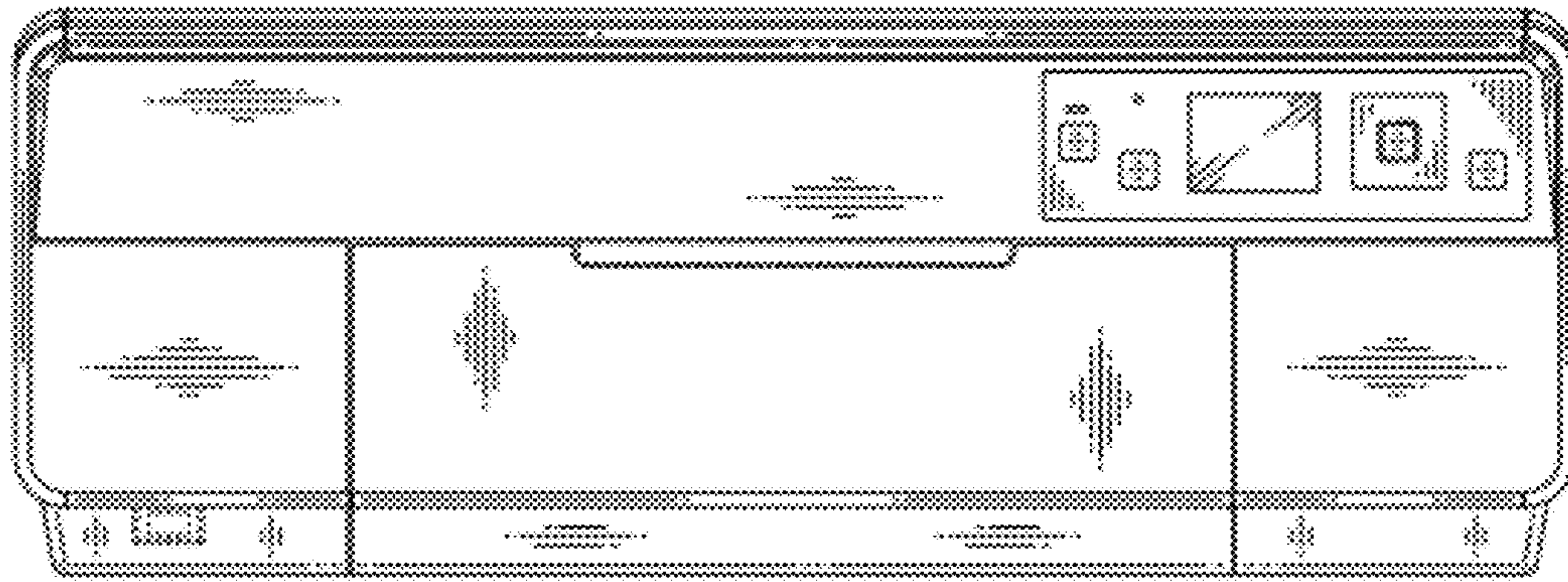

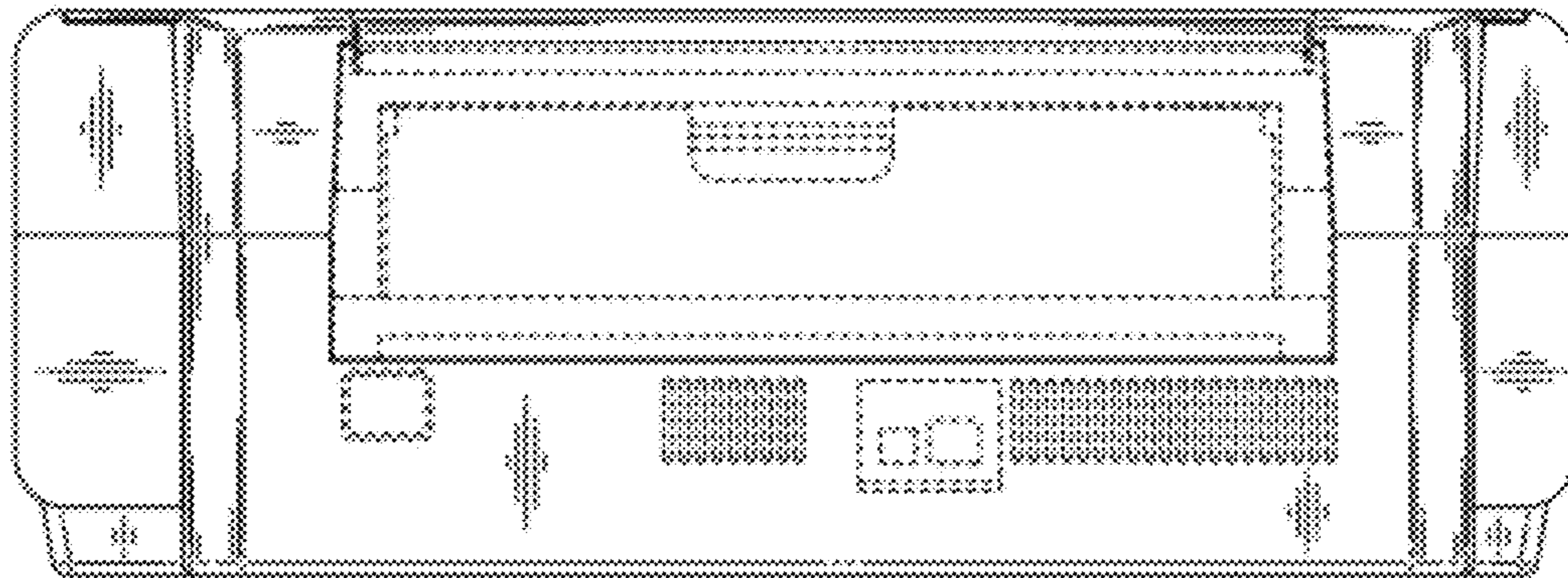

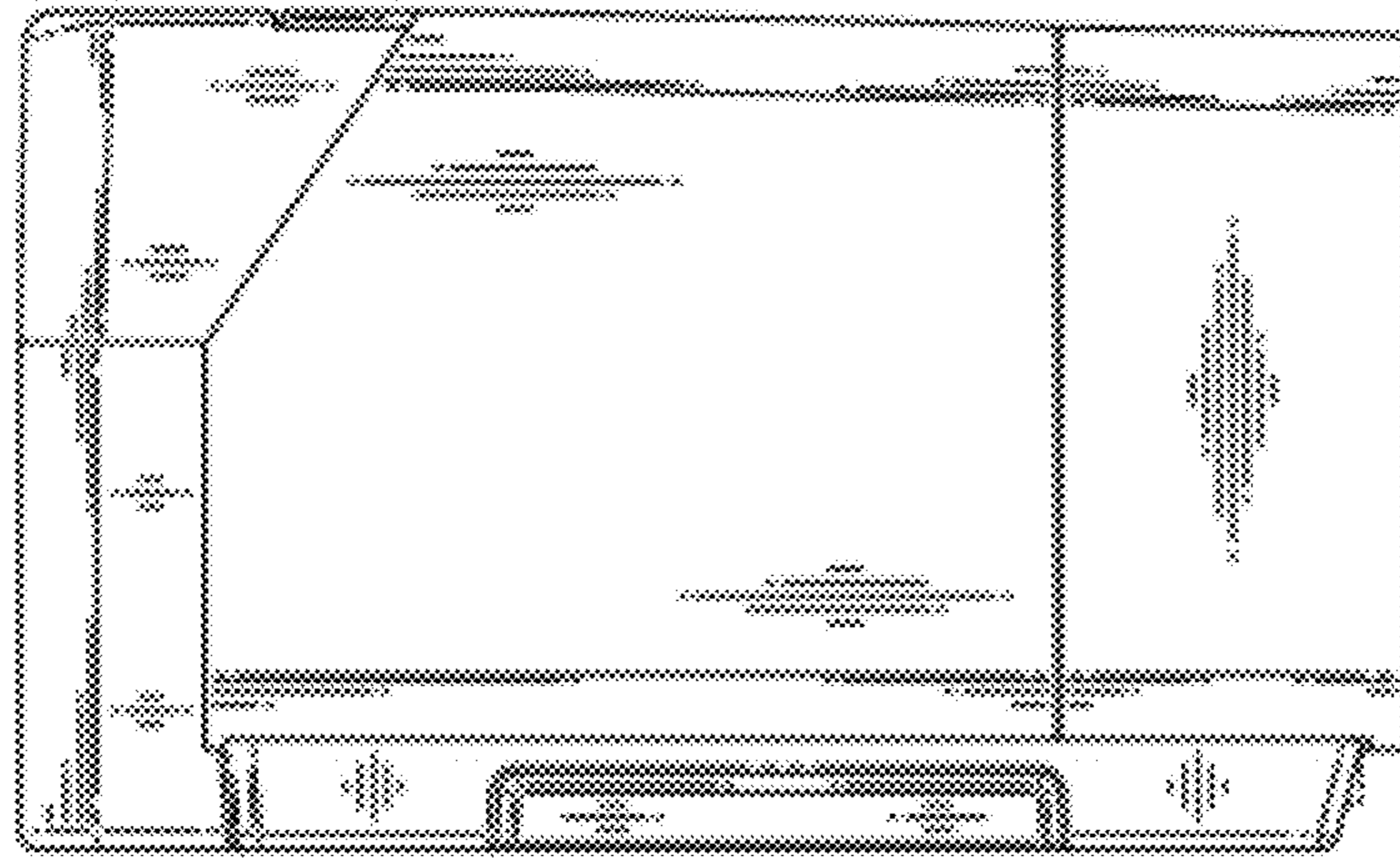

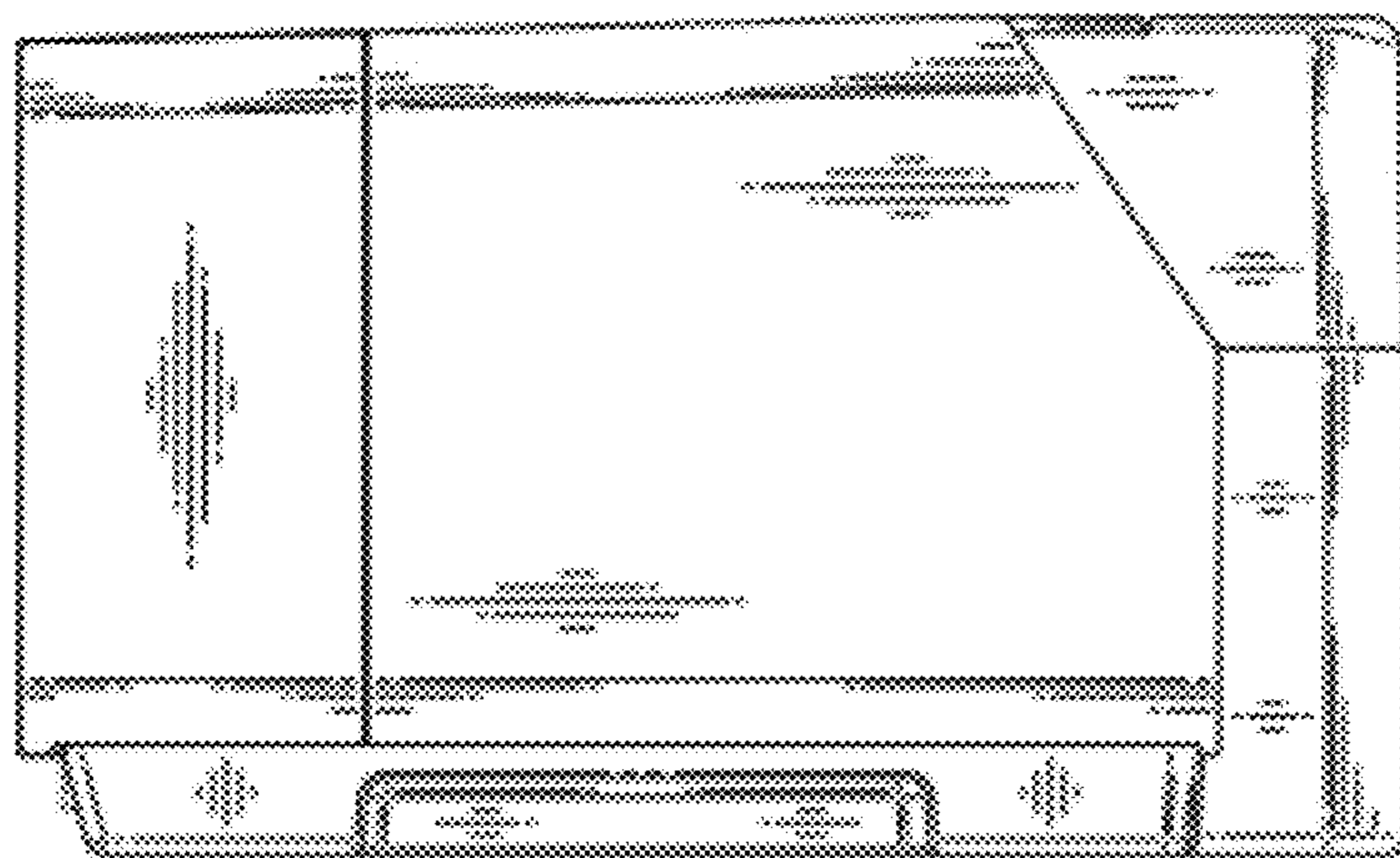

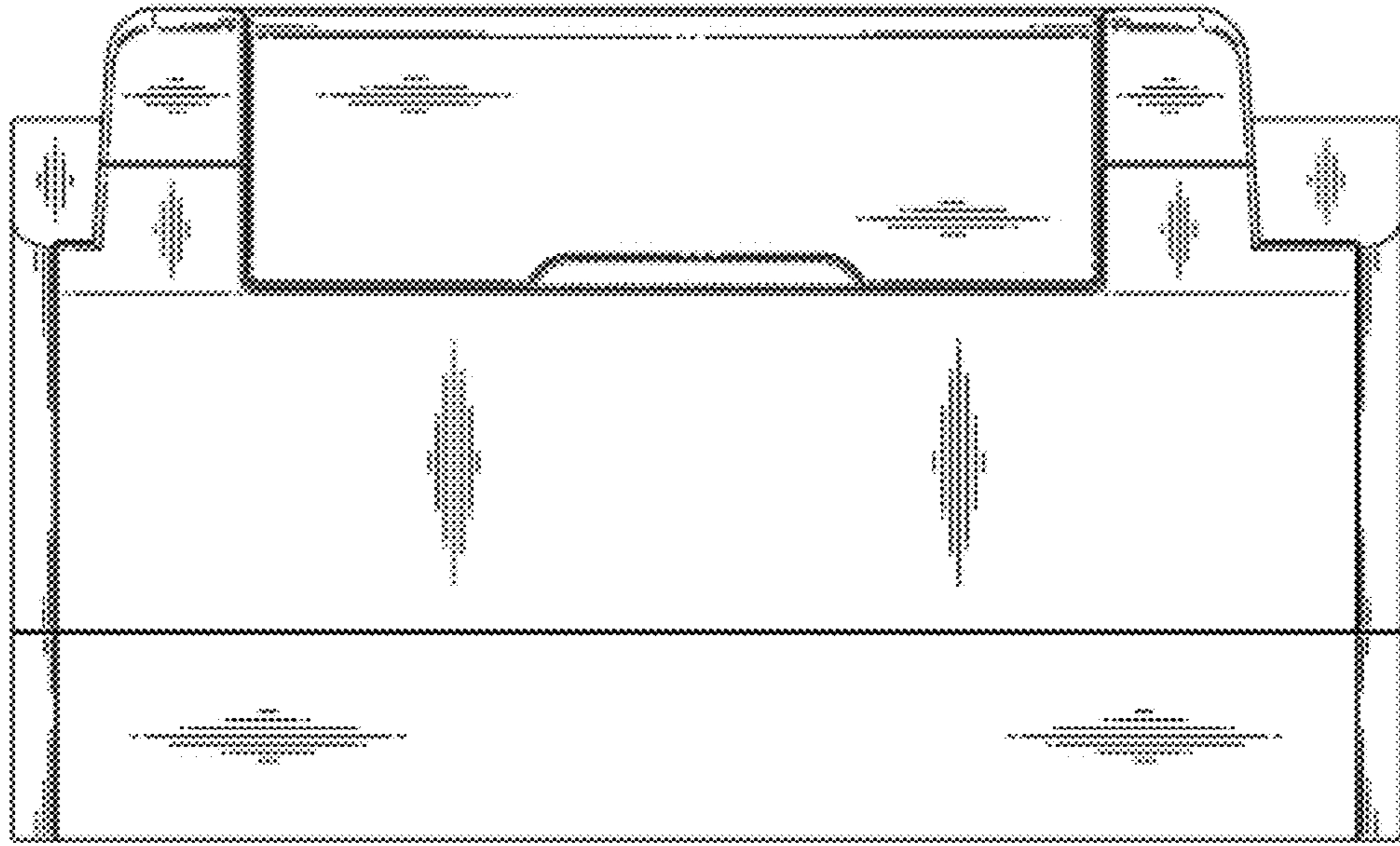

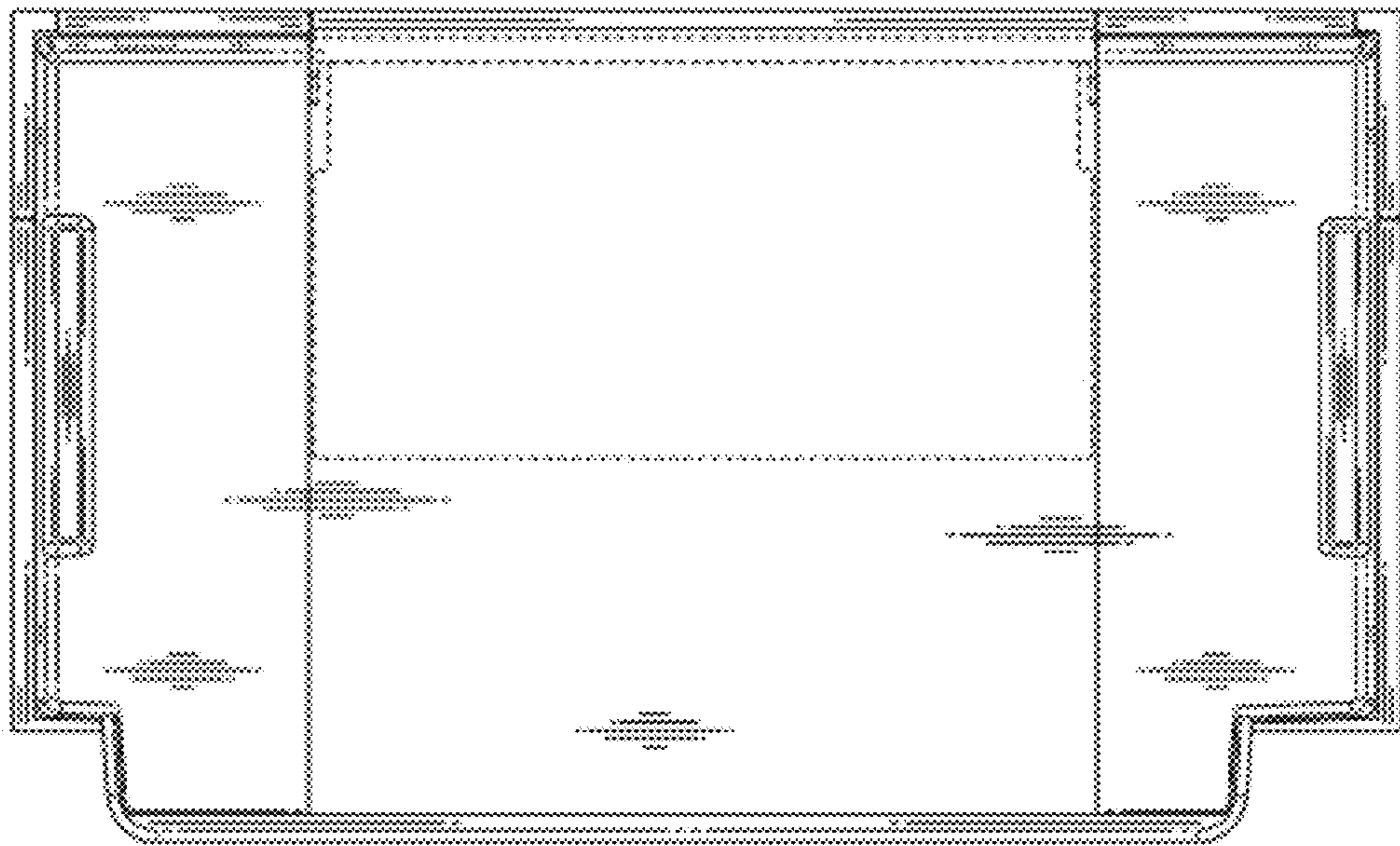
