DESCRIPTION

FIG. 1 is a top, front, left side perspective view of the gift card holder showing my new design;

FIG. 3 is a back plan view thereof.

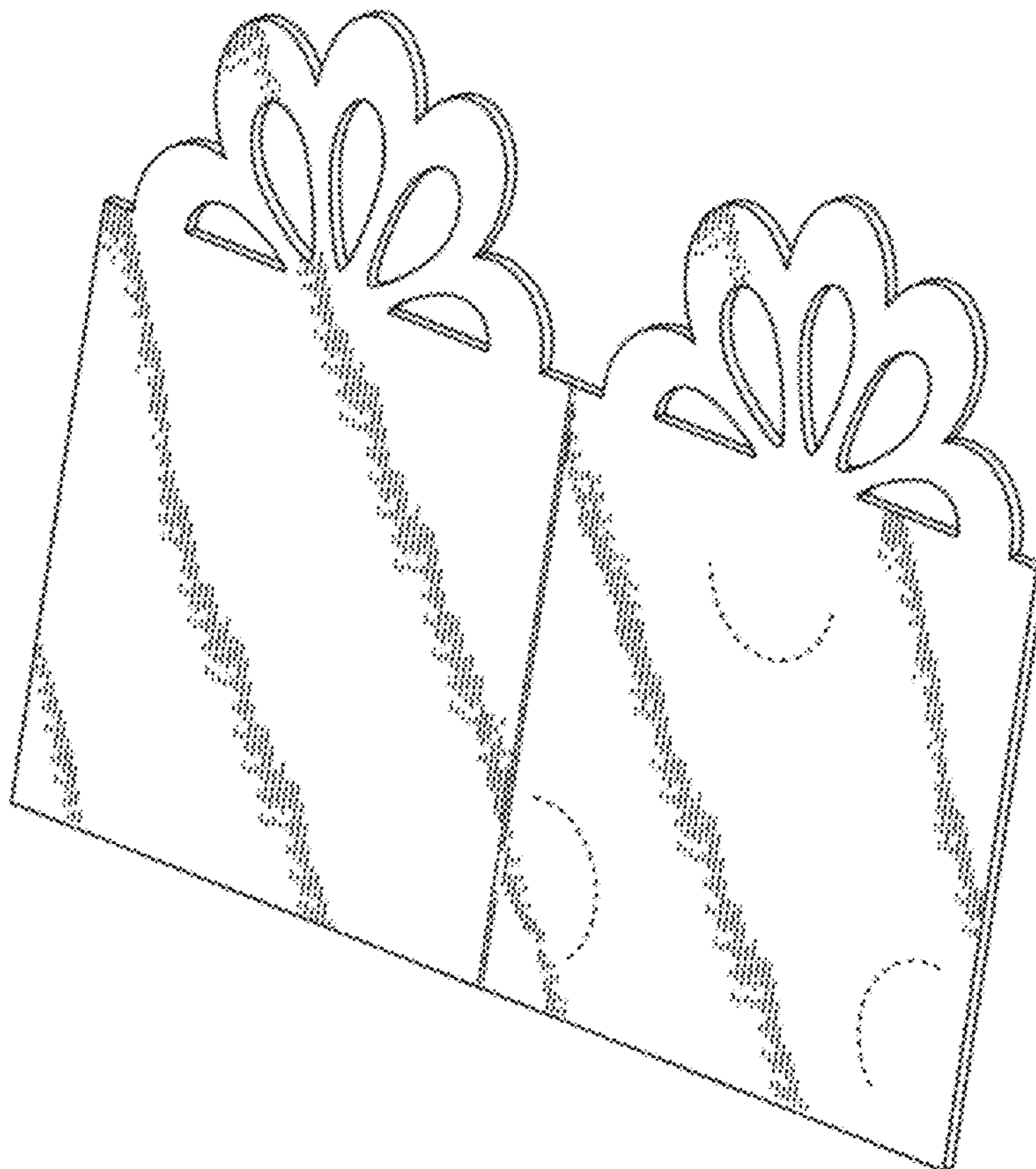
FIG. 4 is a top plan view thereof.

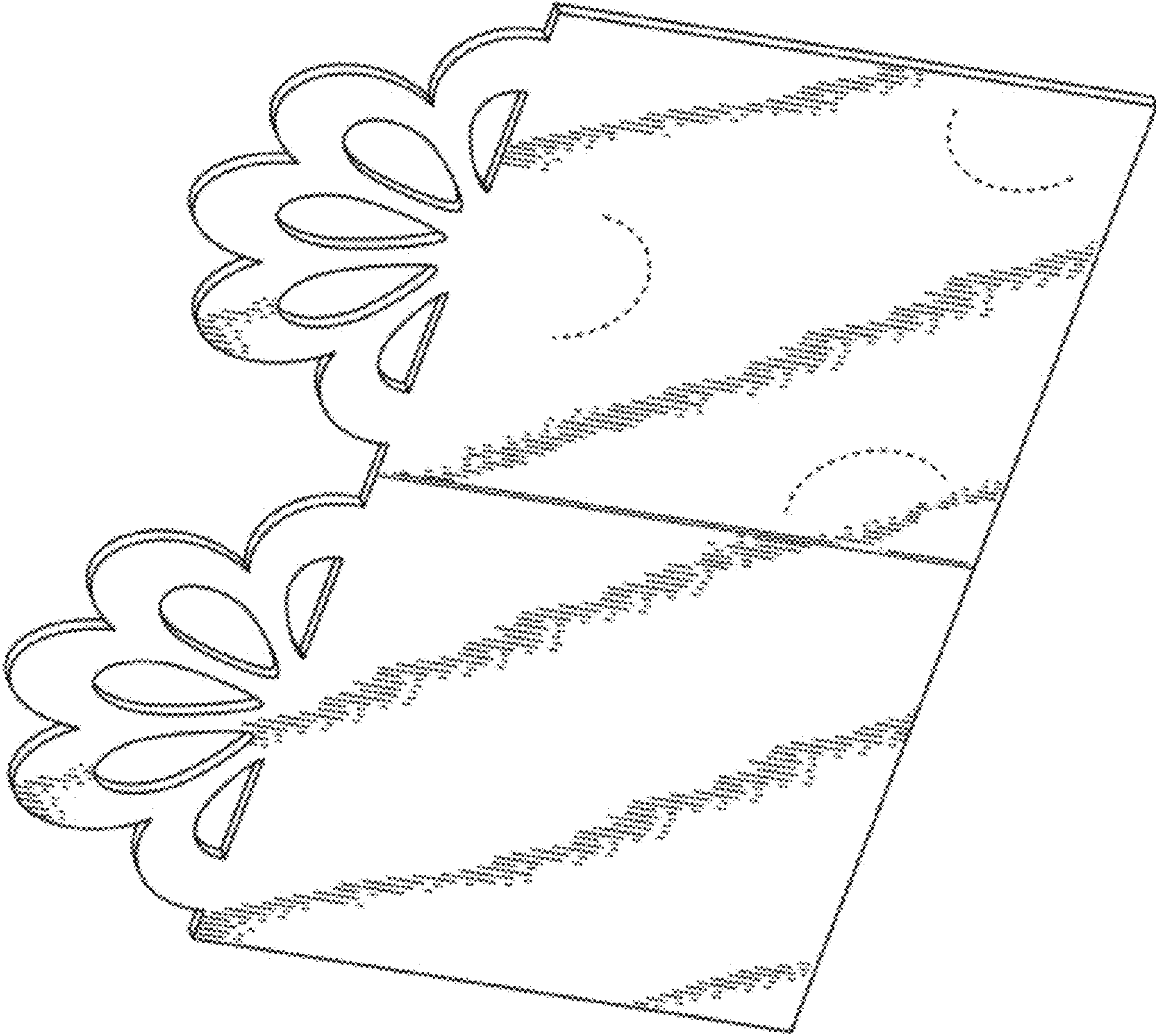

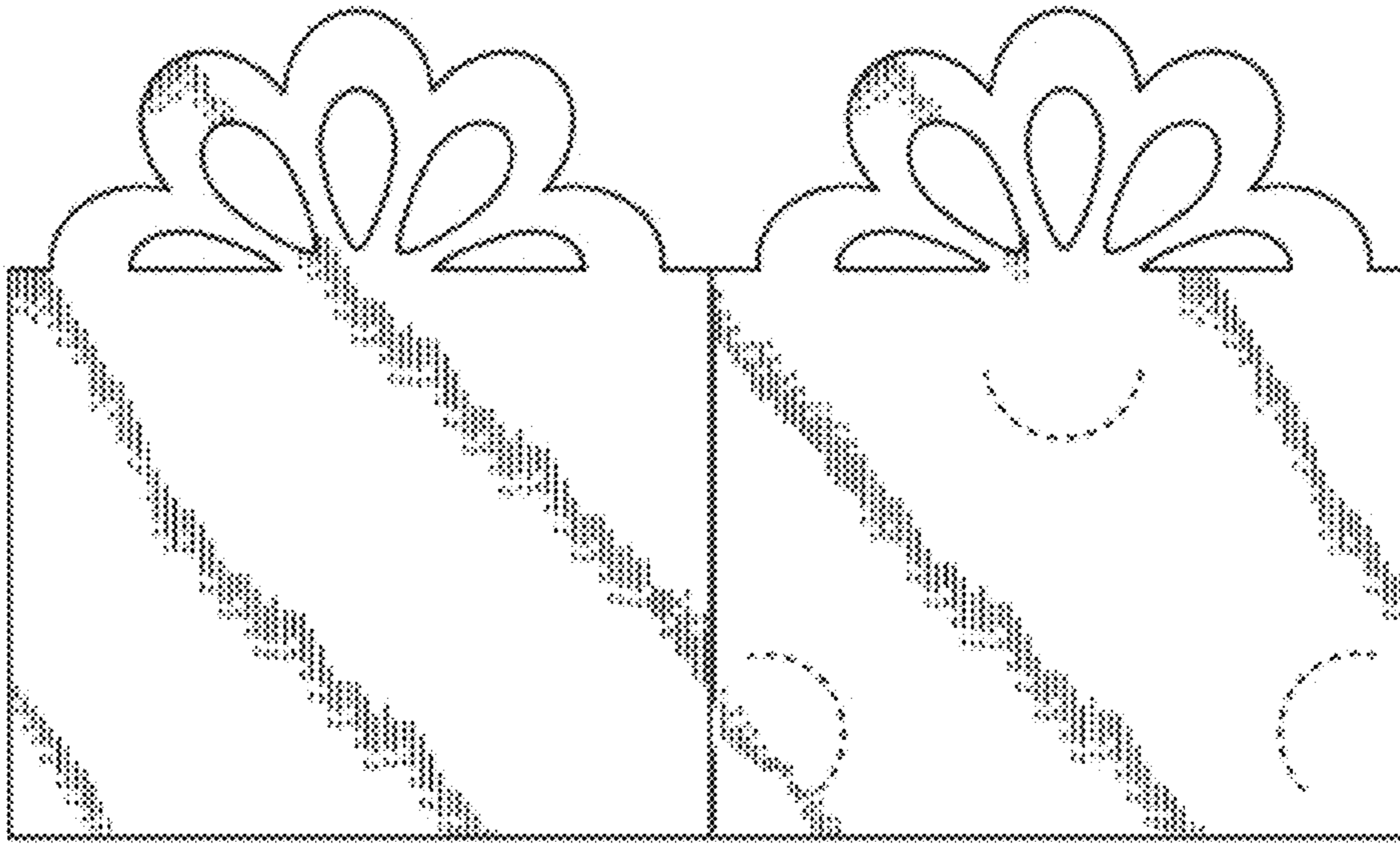

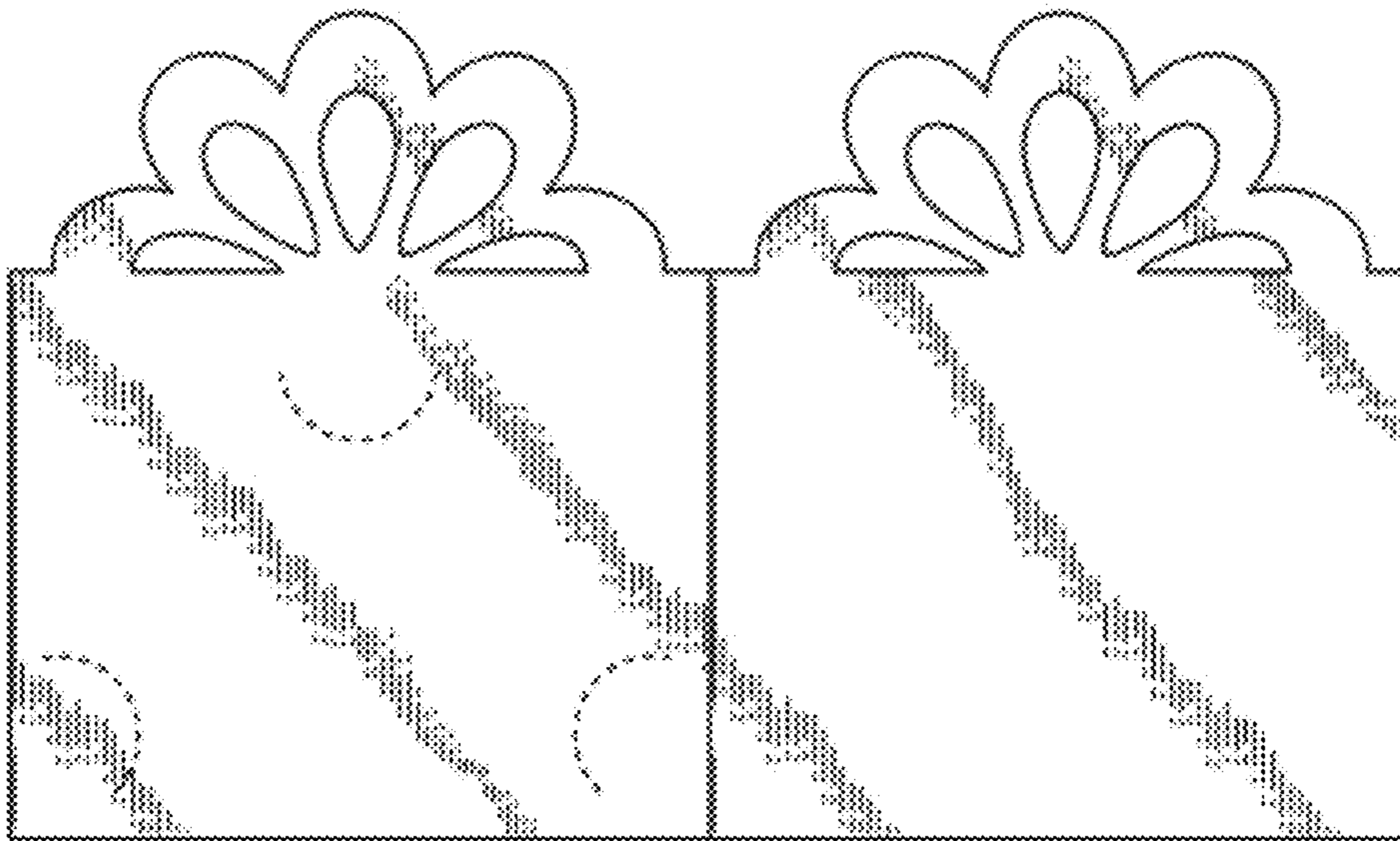
