This application is related to U.S. design patent application titled "Label" filed on the same date with the same inventors under Ser. No. 29/392,987.

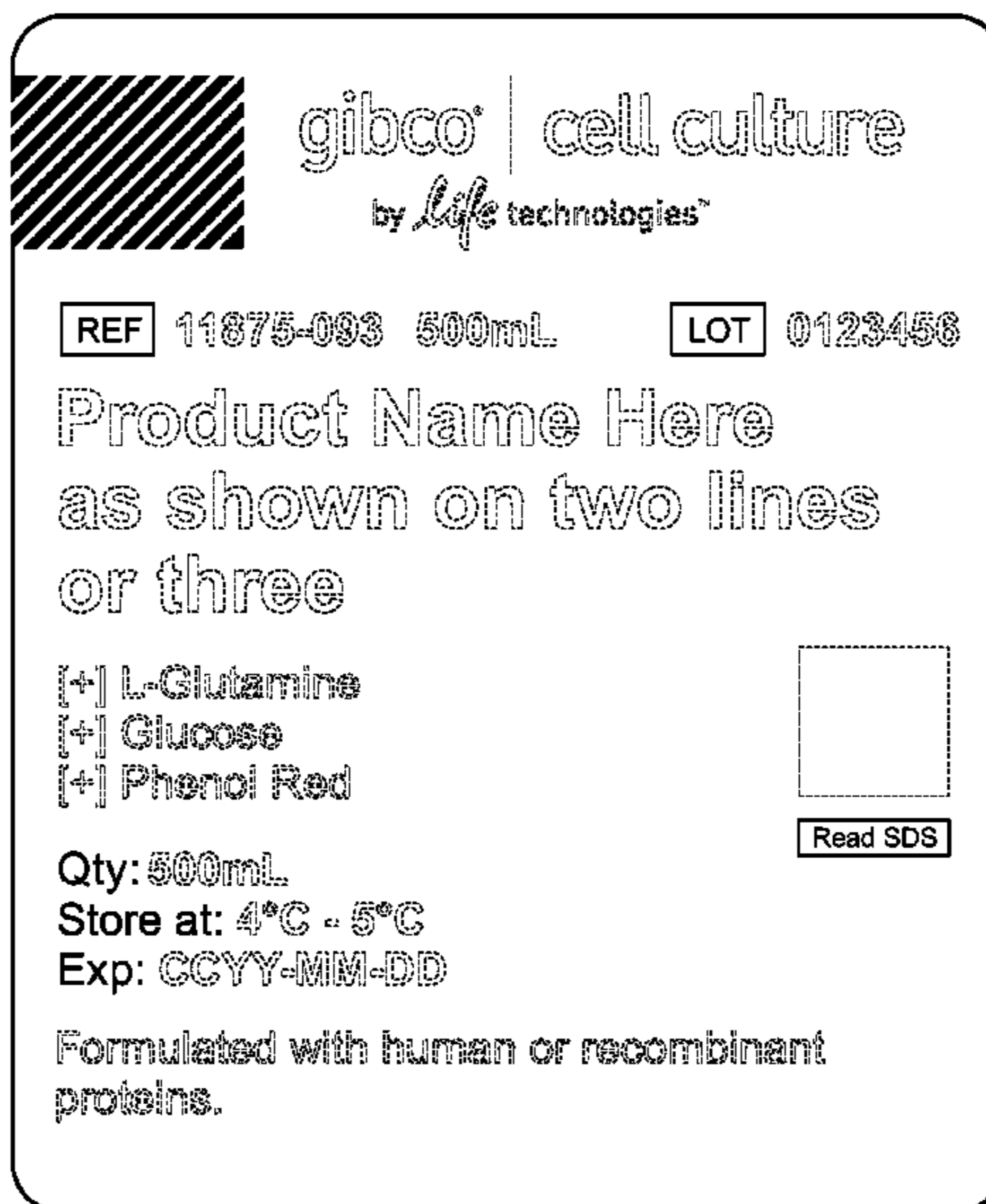
FIG. 1 is a view of a first embodiment of a label according to our new design; and,

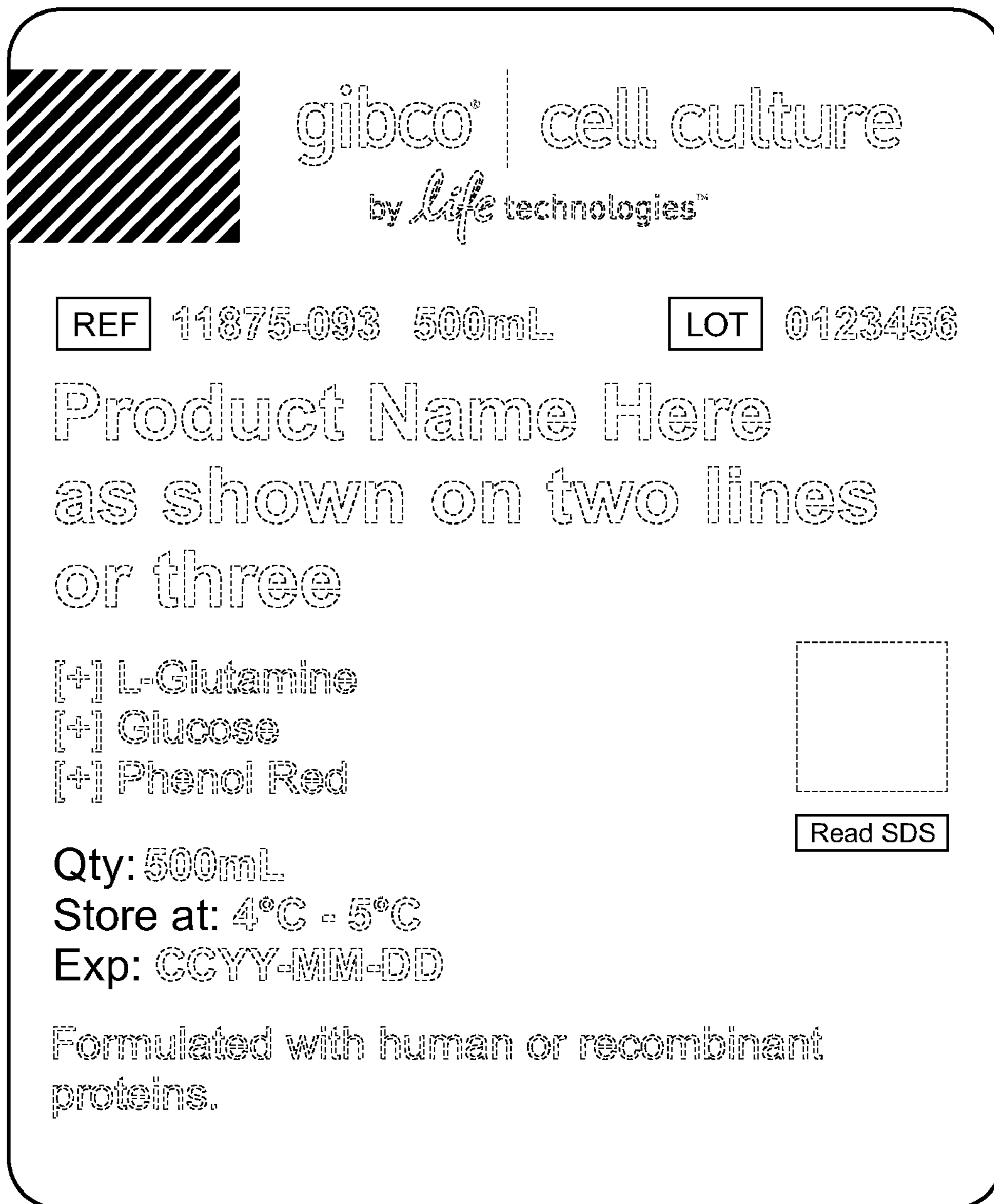

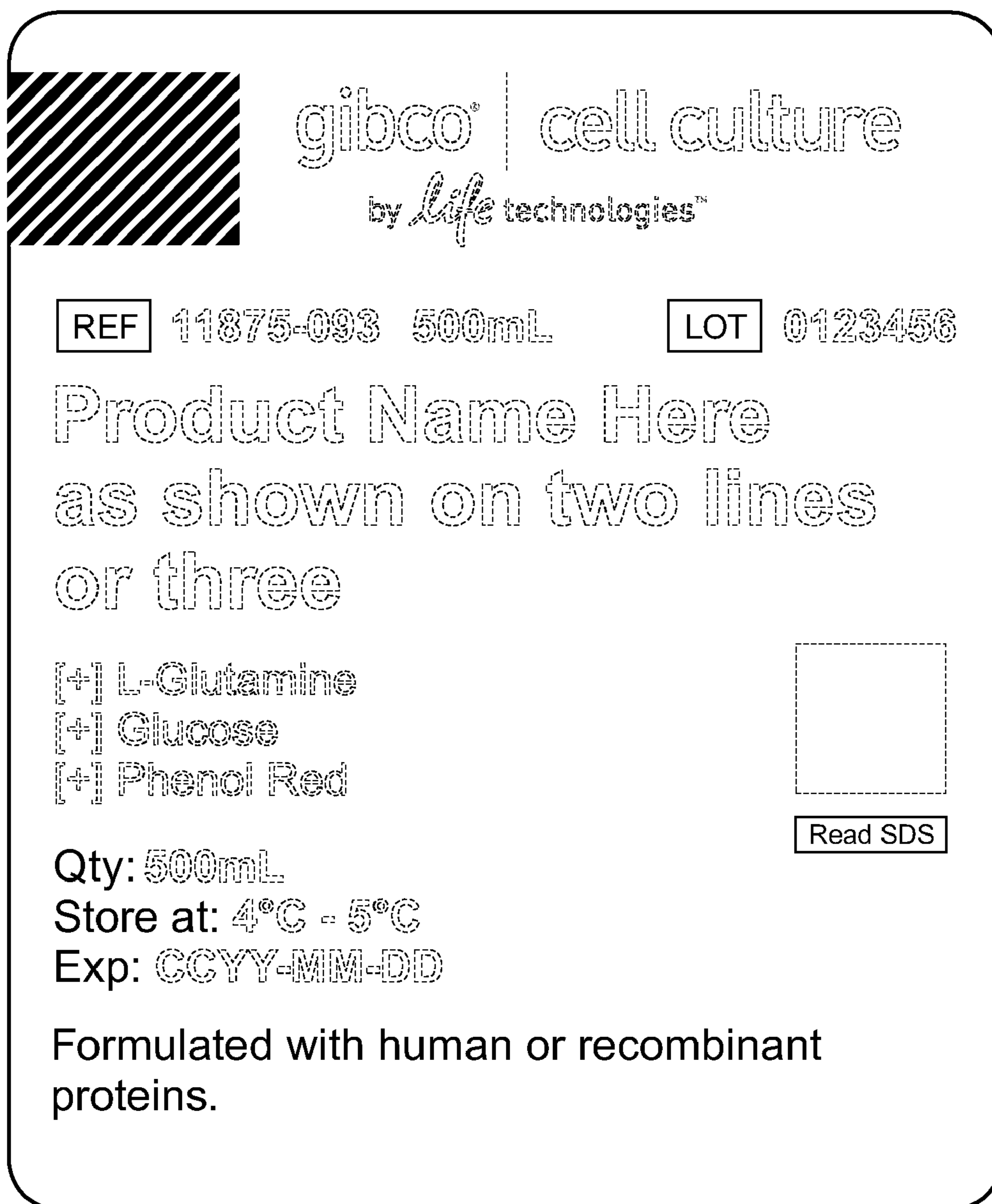
