DESCRIPTION

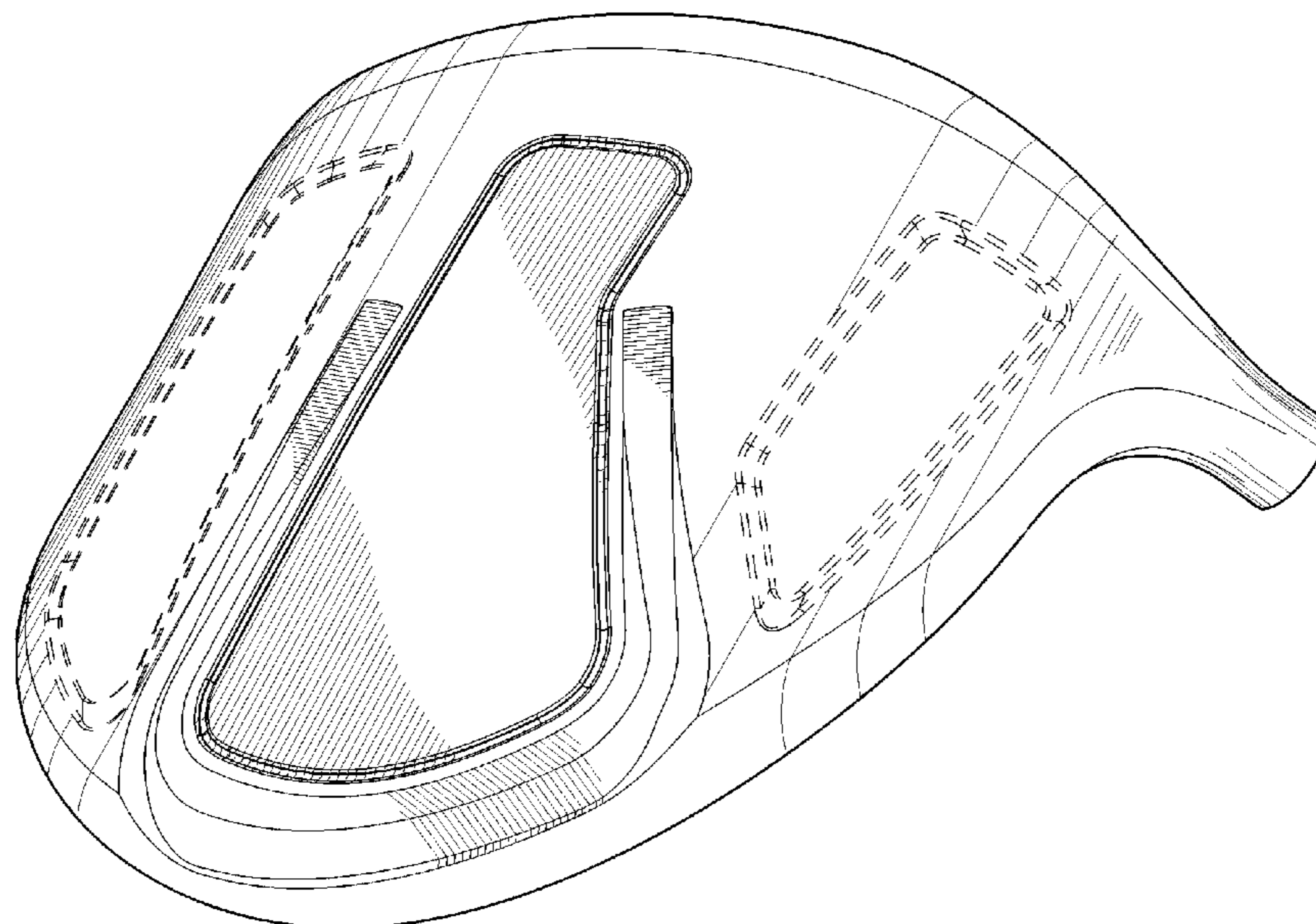
FIG. 1 is a top perspective view of a golf club head;

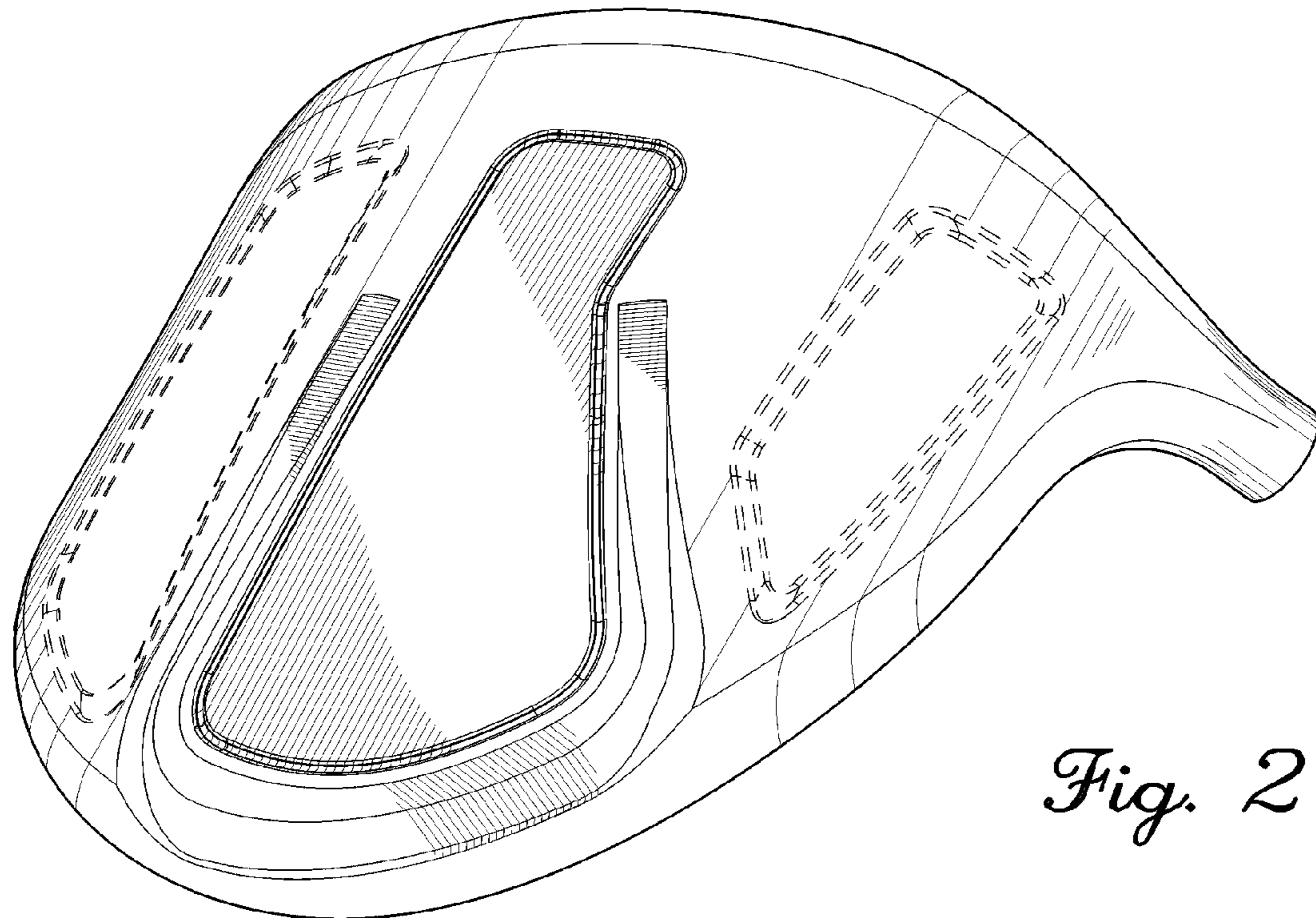
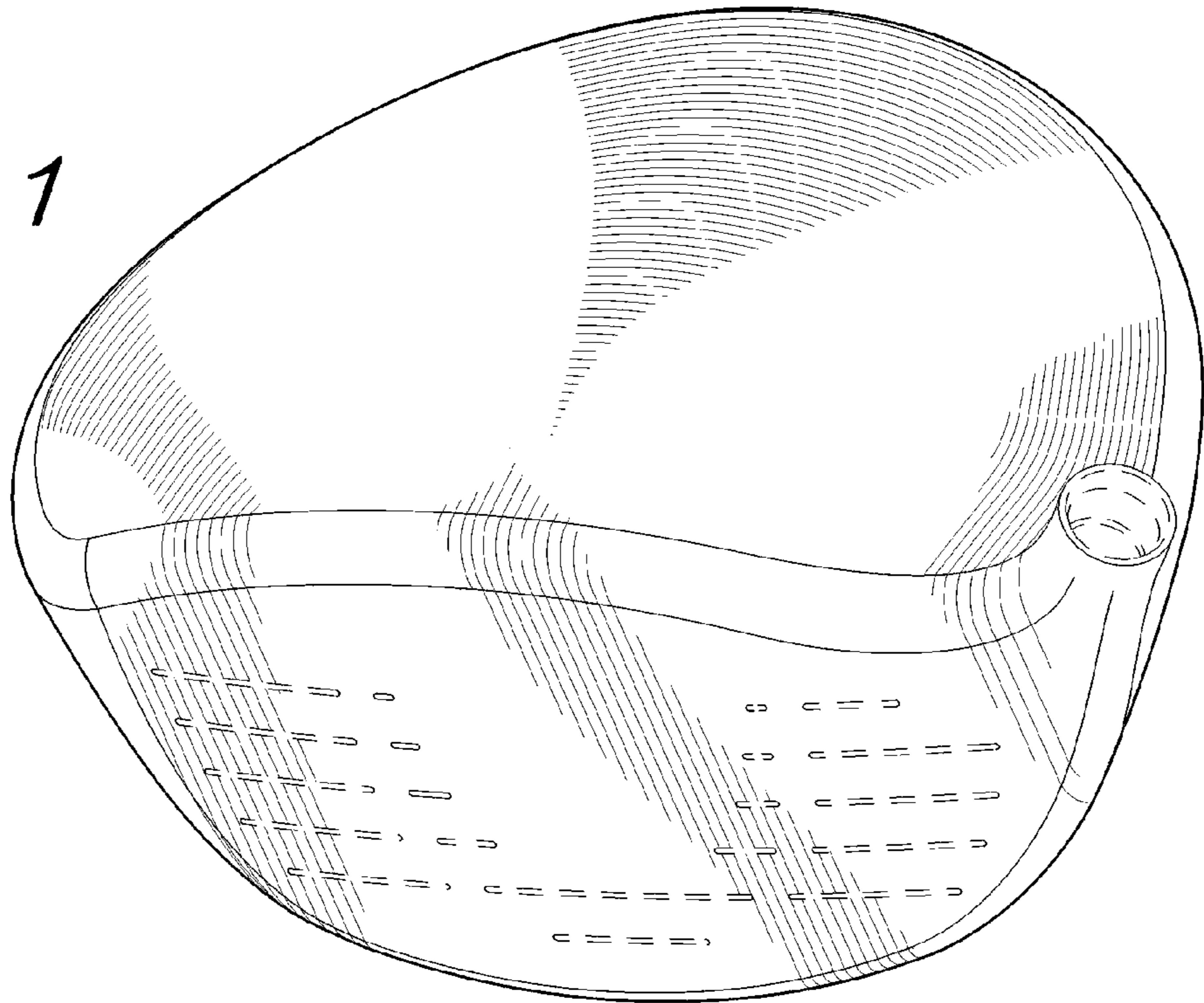

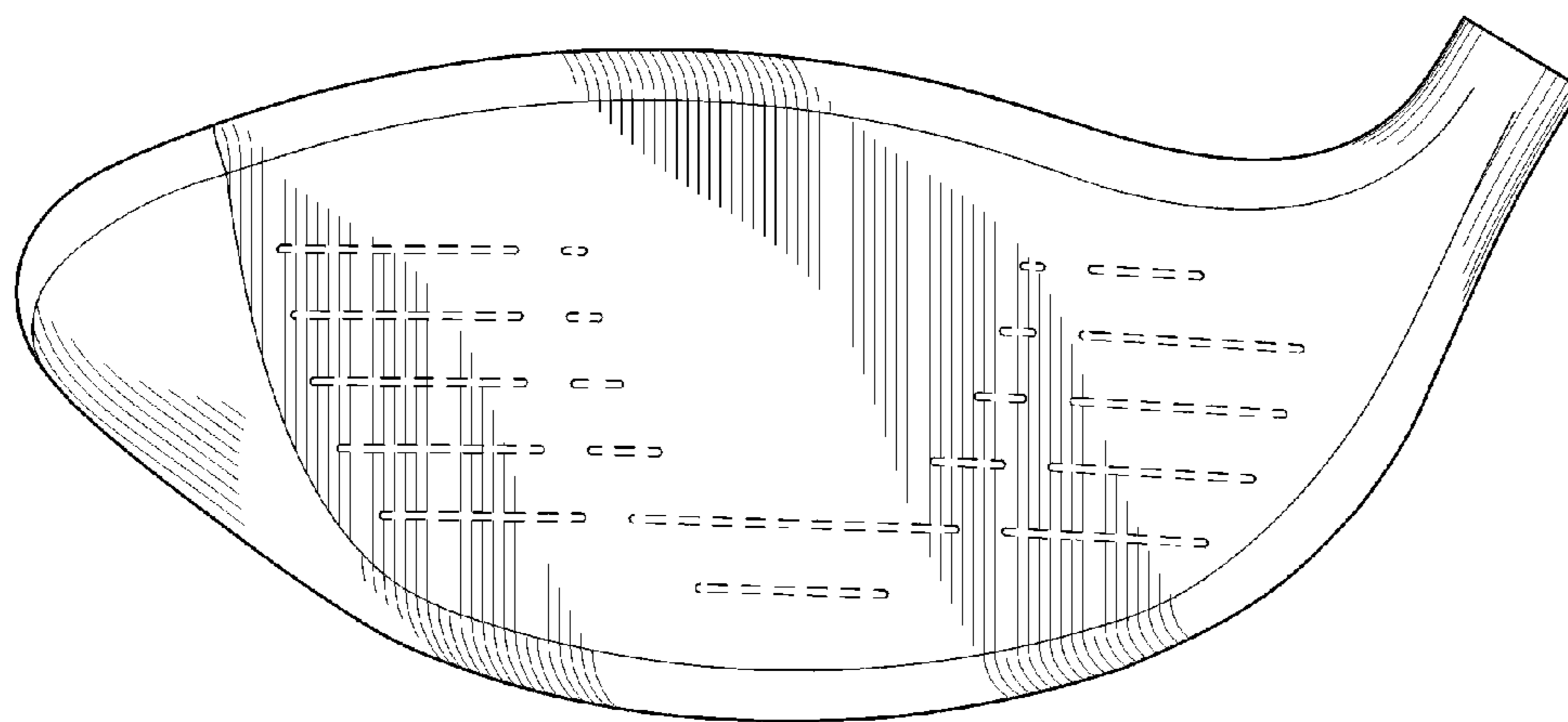

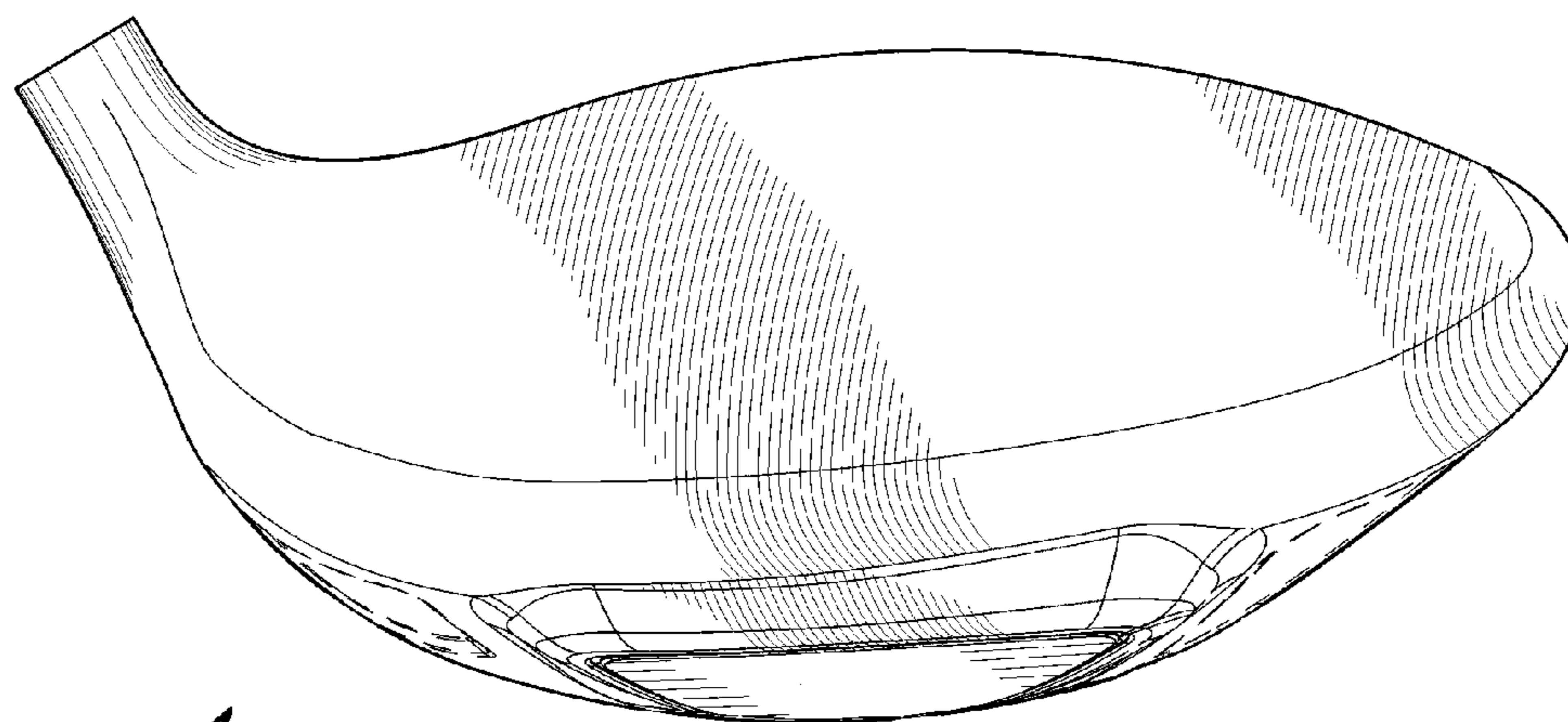

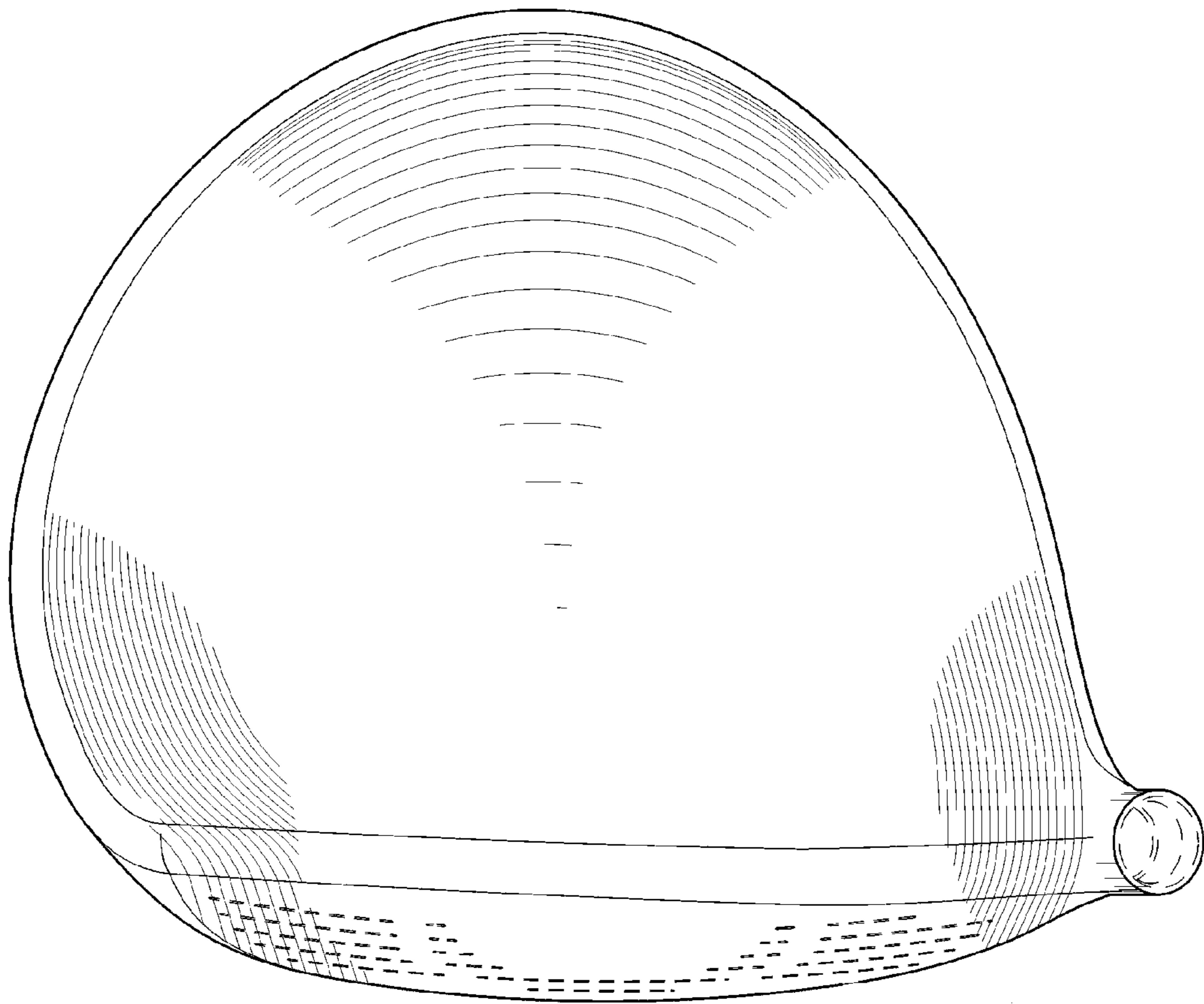

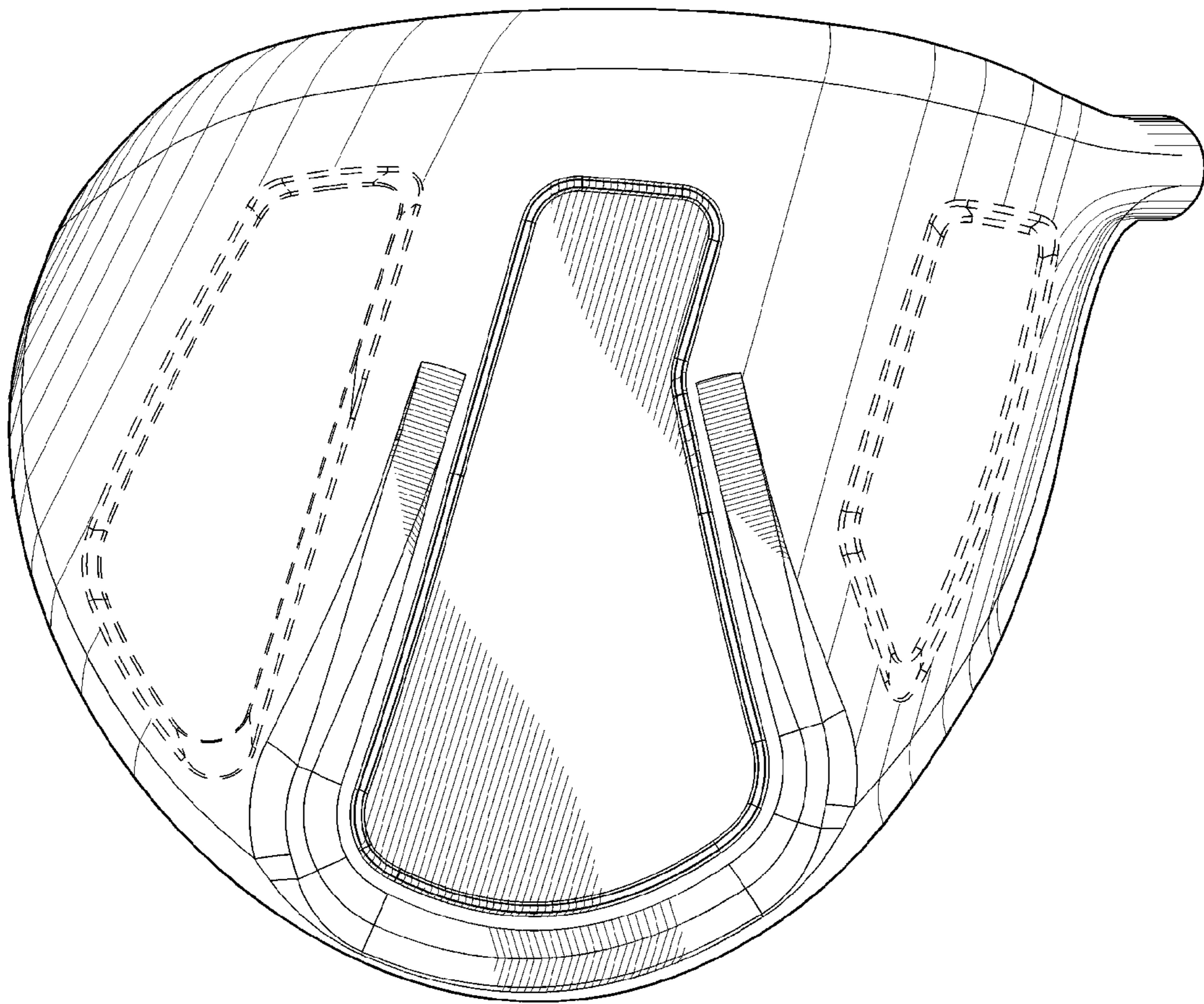

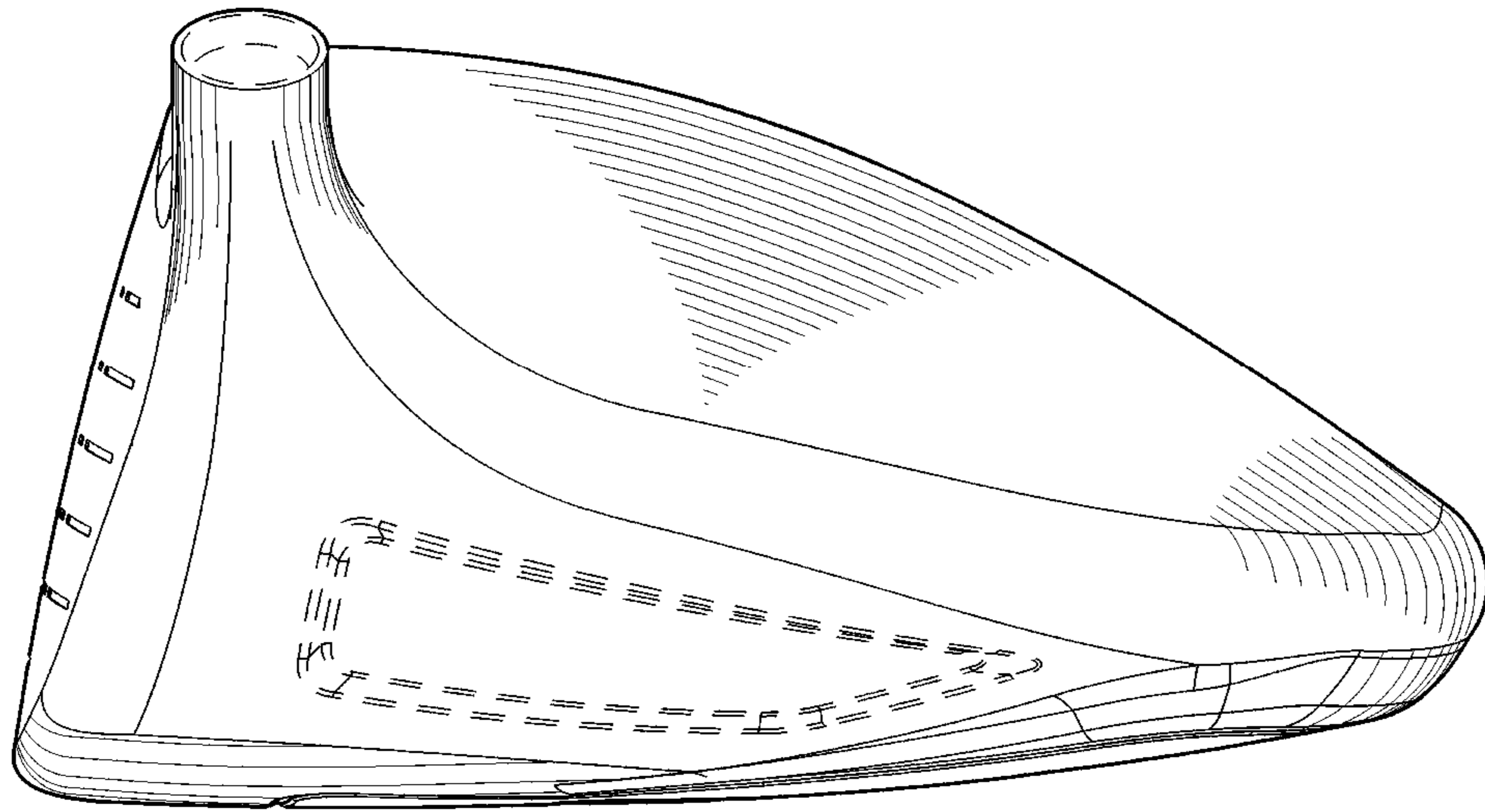

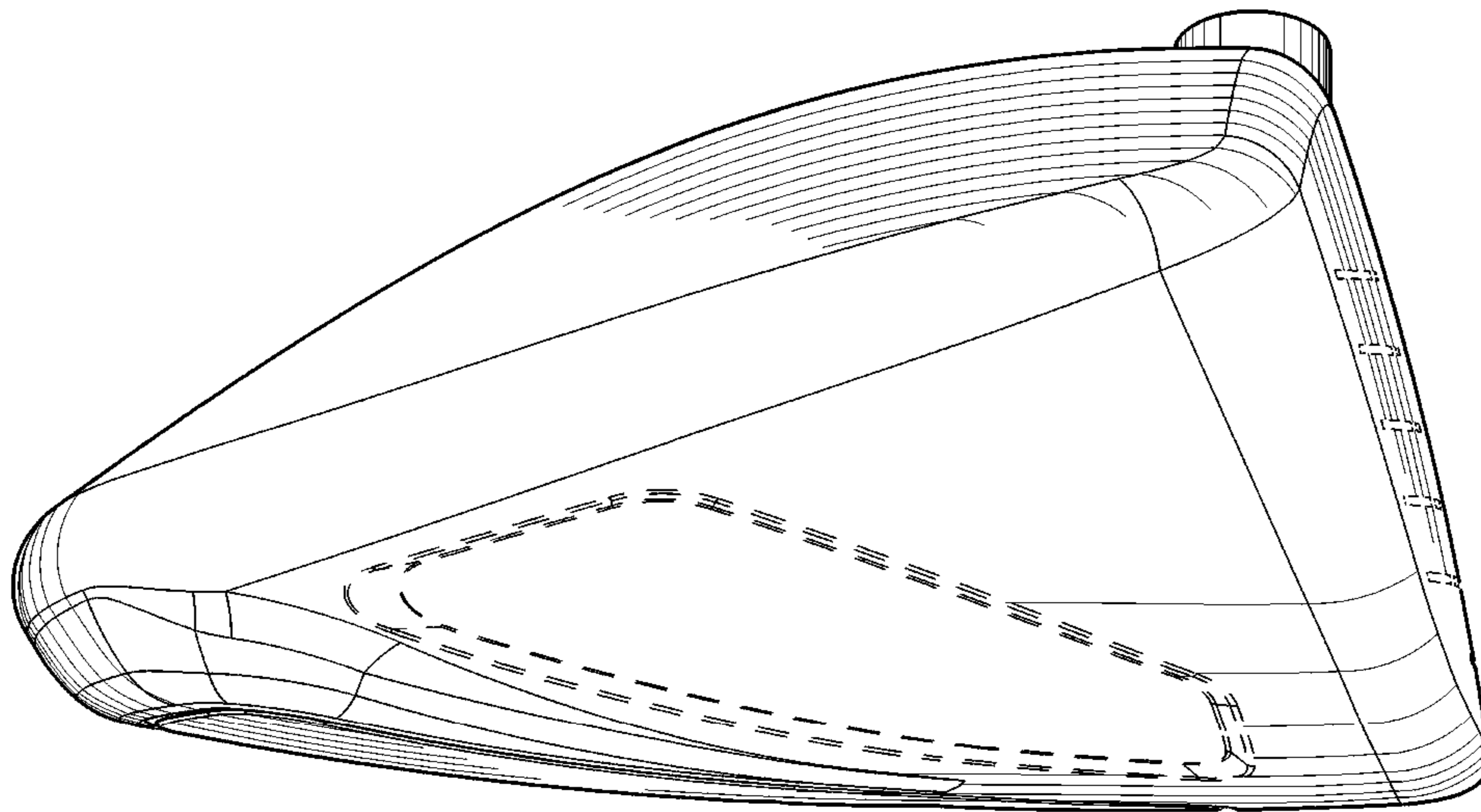
