FIG. 2 shows a front view of an emergency vest showing my new design;

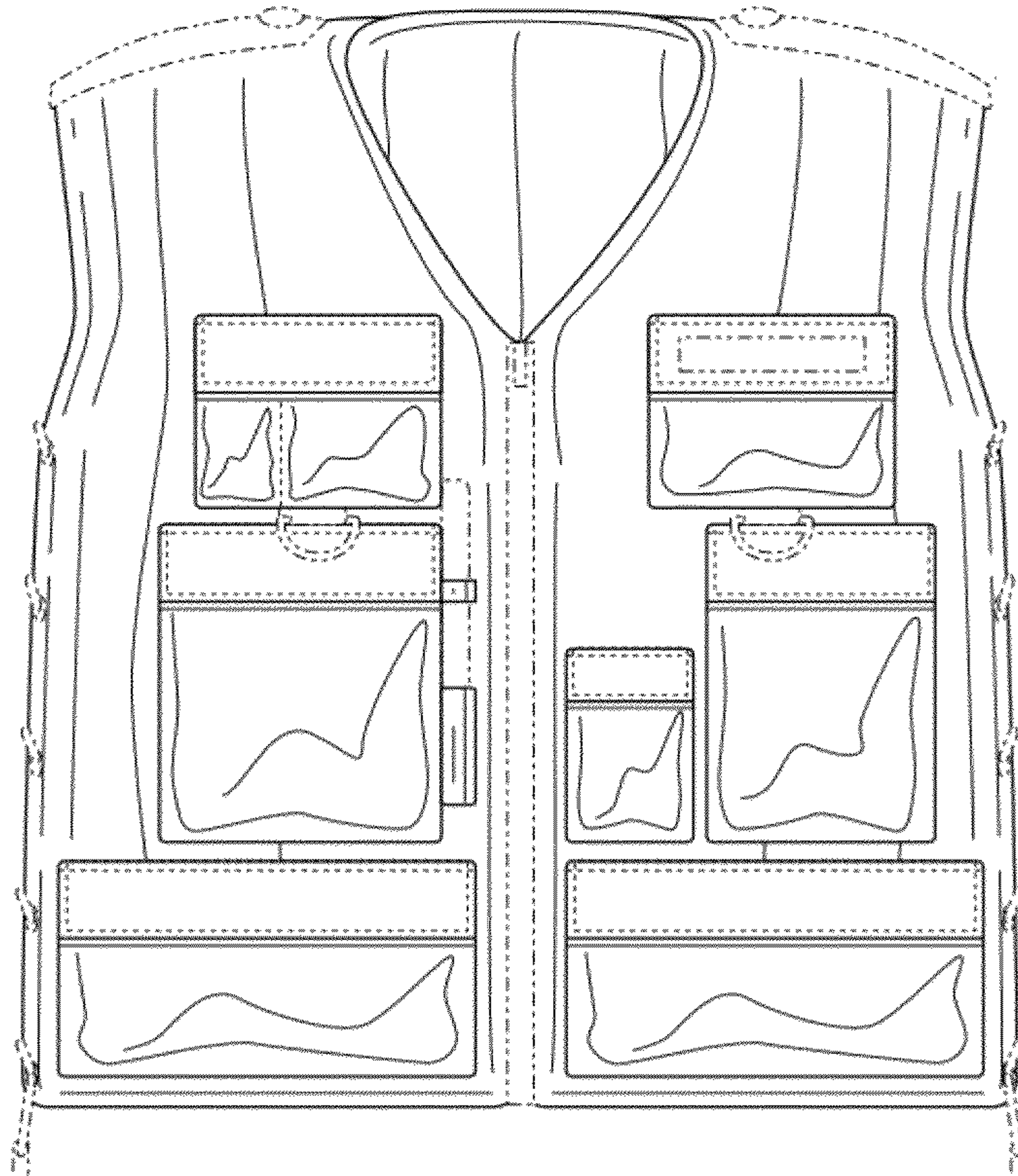
FIG. 3 shows a rear view of an emergency vest showing my new design;

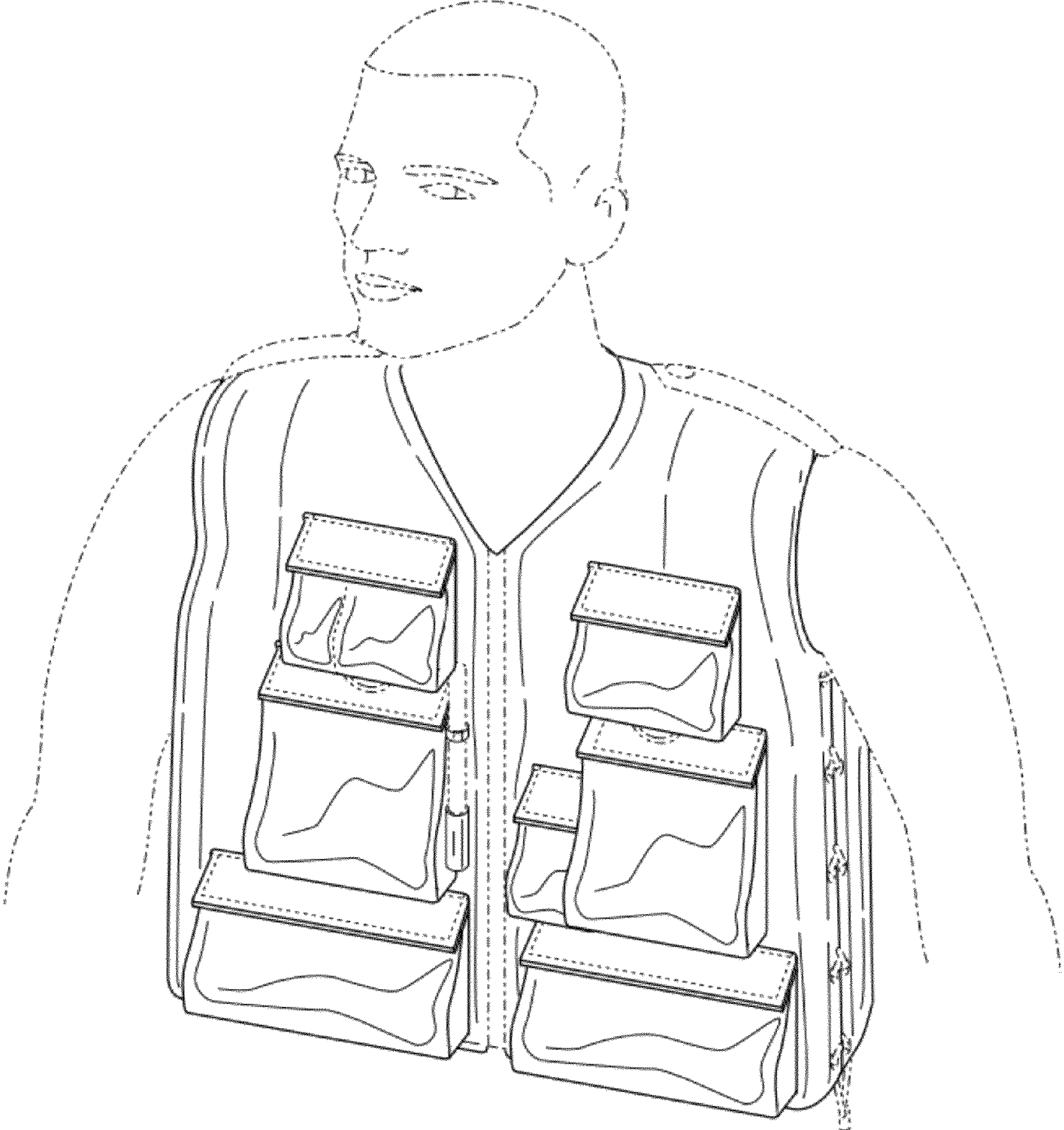

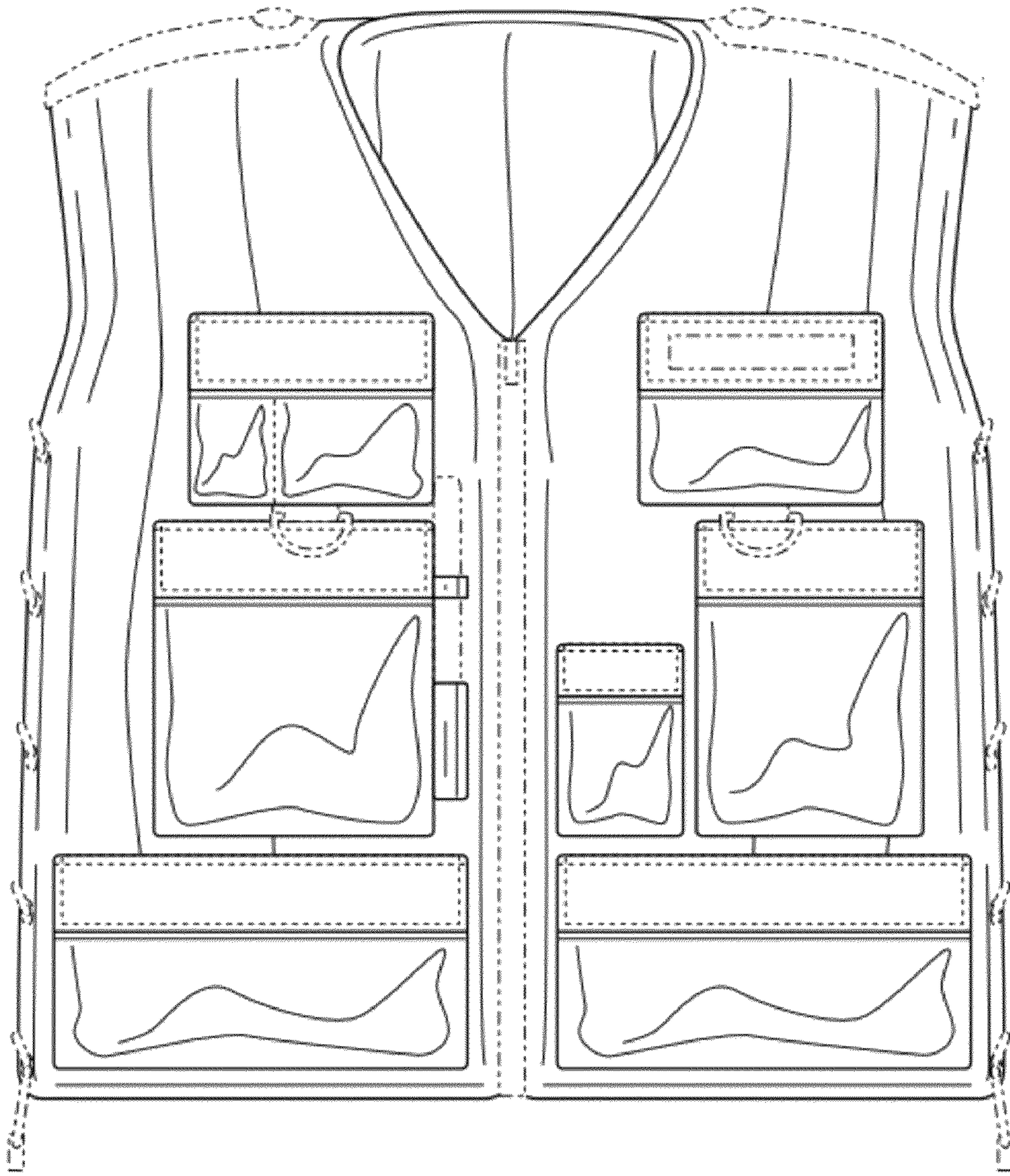

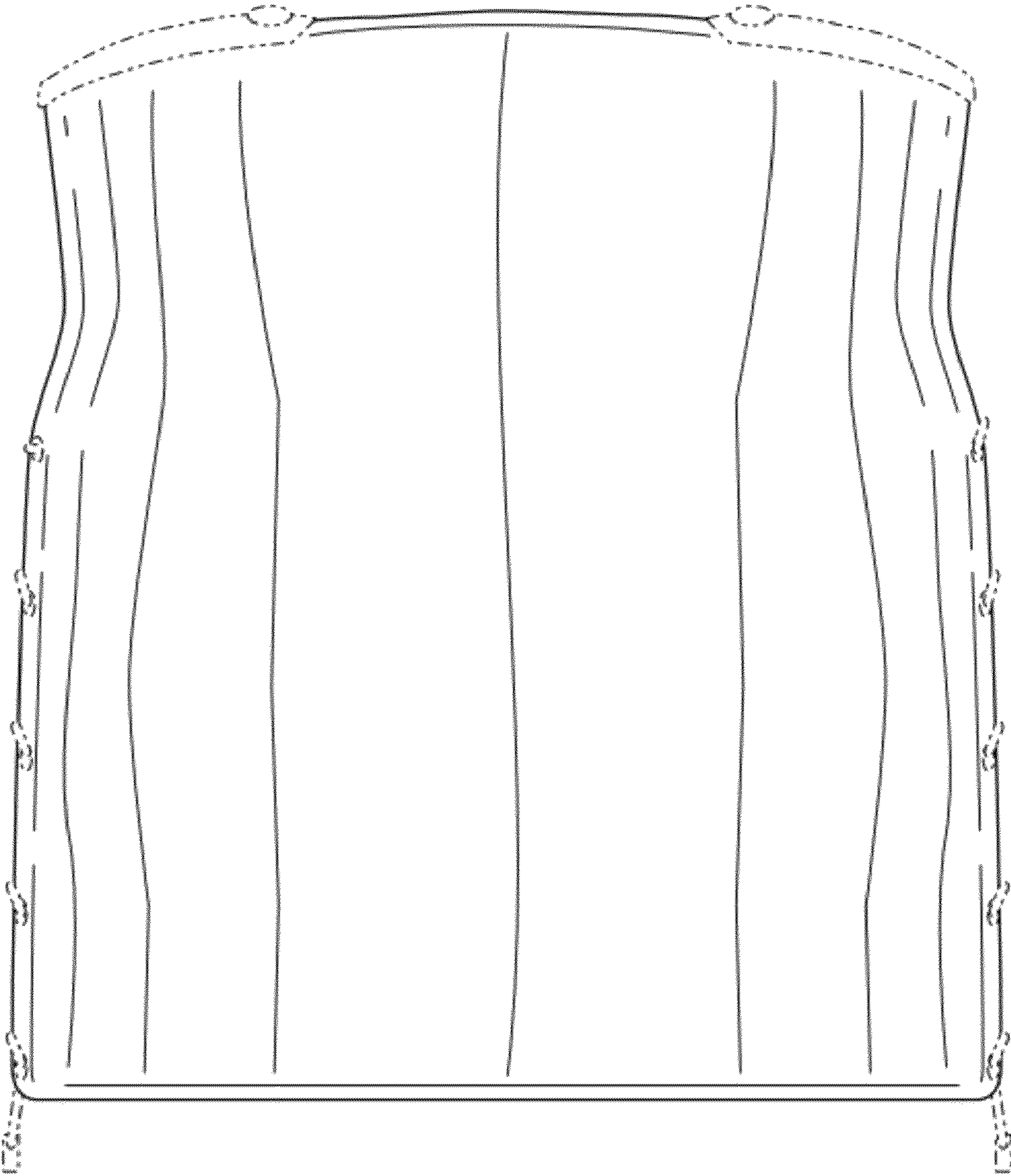

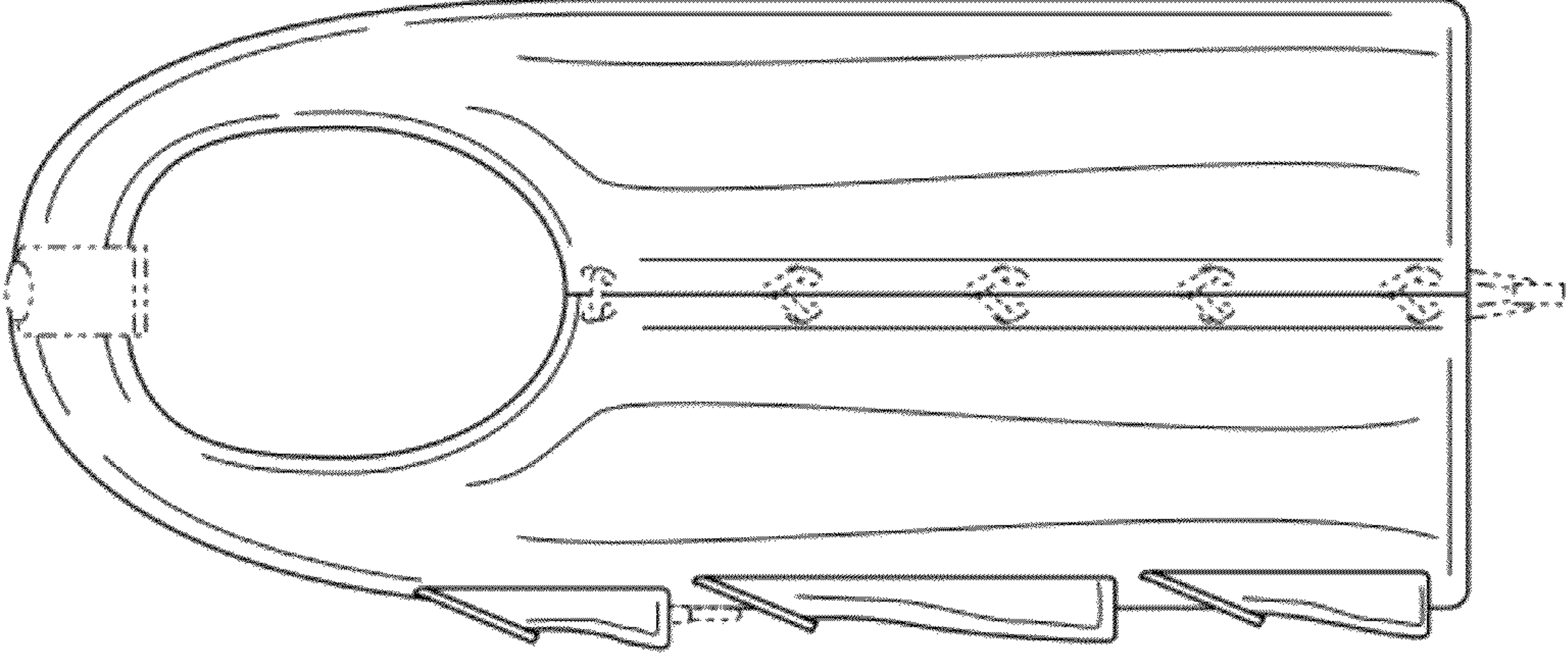

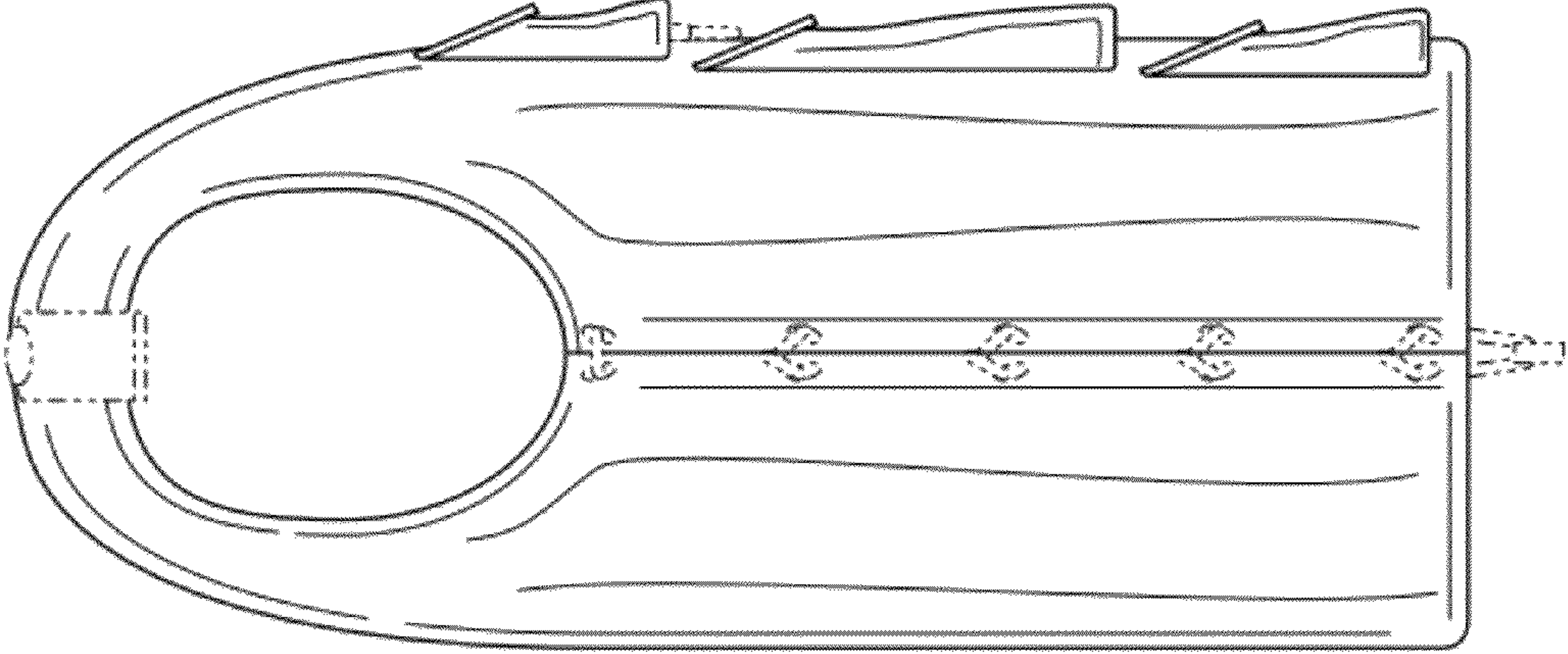
