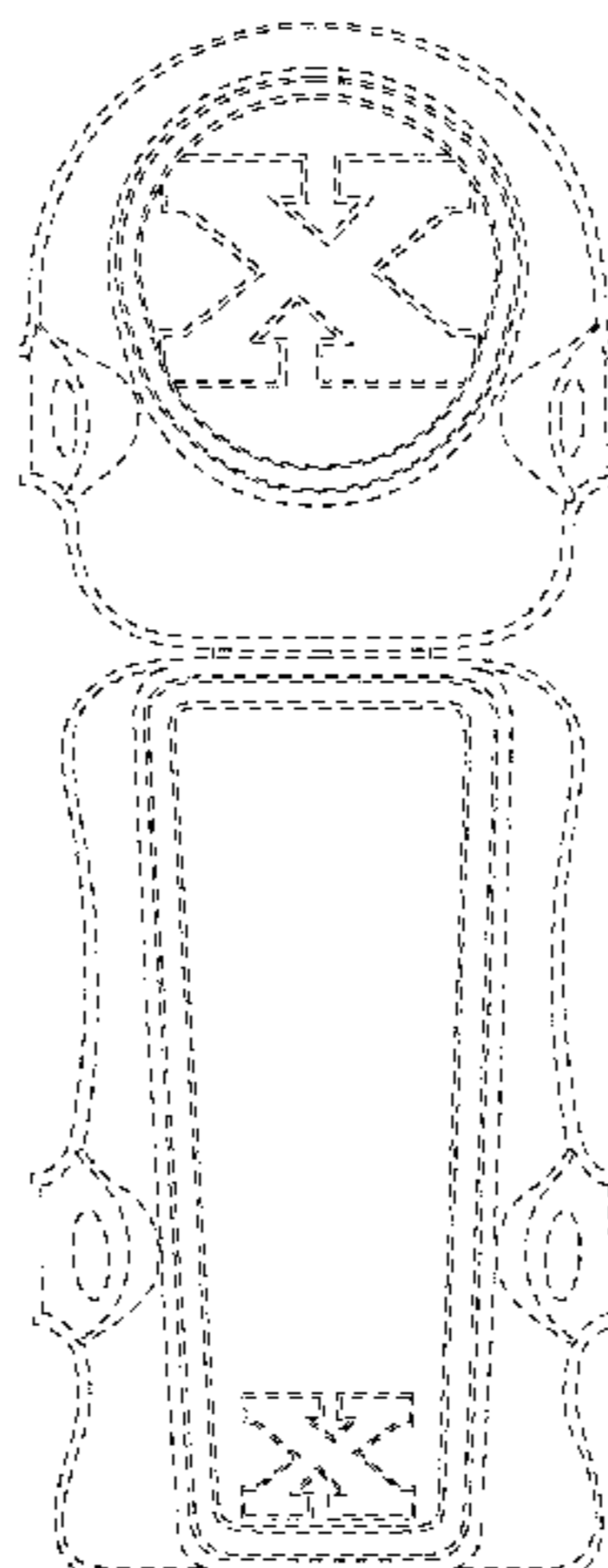
(57) **CLAIM**
The ornamental design for a knee and shin protector, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a knee and shin protector, showing my design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a front view of the knee portion of the knee and shin protector of FIG. 1;
 FIG. 8 is a rear view thereof;
 FIG. 9 is a right side view thereof;
 FIG. 10 is a left side view thereof;
 FIG. 11 is a top view thereof;
 FIG. 12 is a bottom view thereof;
 FIG. 13 is a front view of the shin portion of the knee and shin protector of FIG. 1;
 FIG. 14 is a rear view thereof;
 FIG. 15 is a right side view thereof;
 FIG. 16 is a left side view thereof; FIG. 17 is a top view thereof; and,
 FIG. 18 is a bottom view thereof.

The knee and shin portions of the knee and shin protector are shown separately for ease of illustration.
 The broken line showing of portions of the knee and shin protector forms no part of the claimed design.

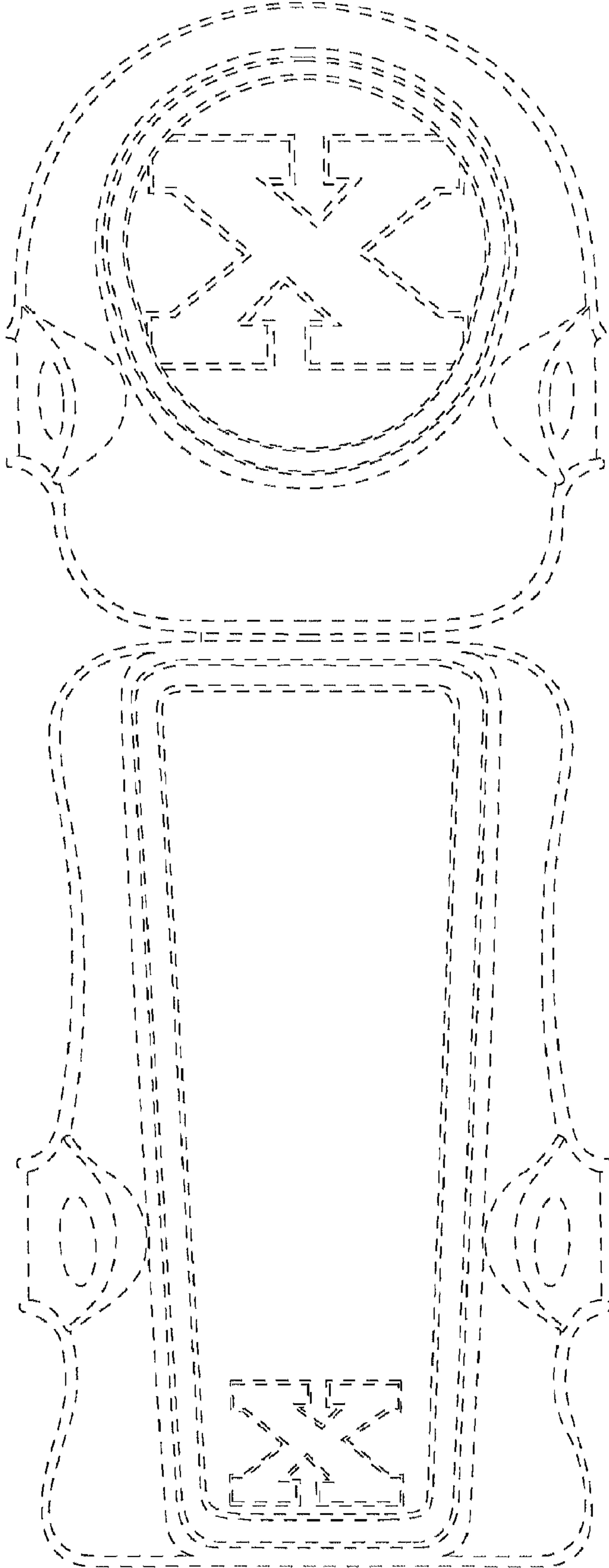

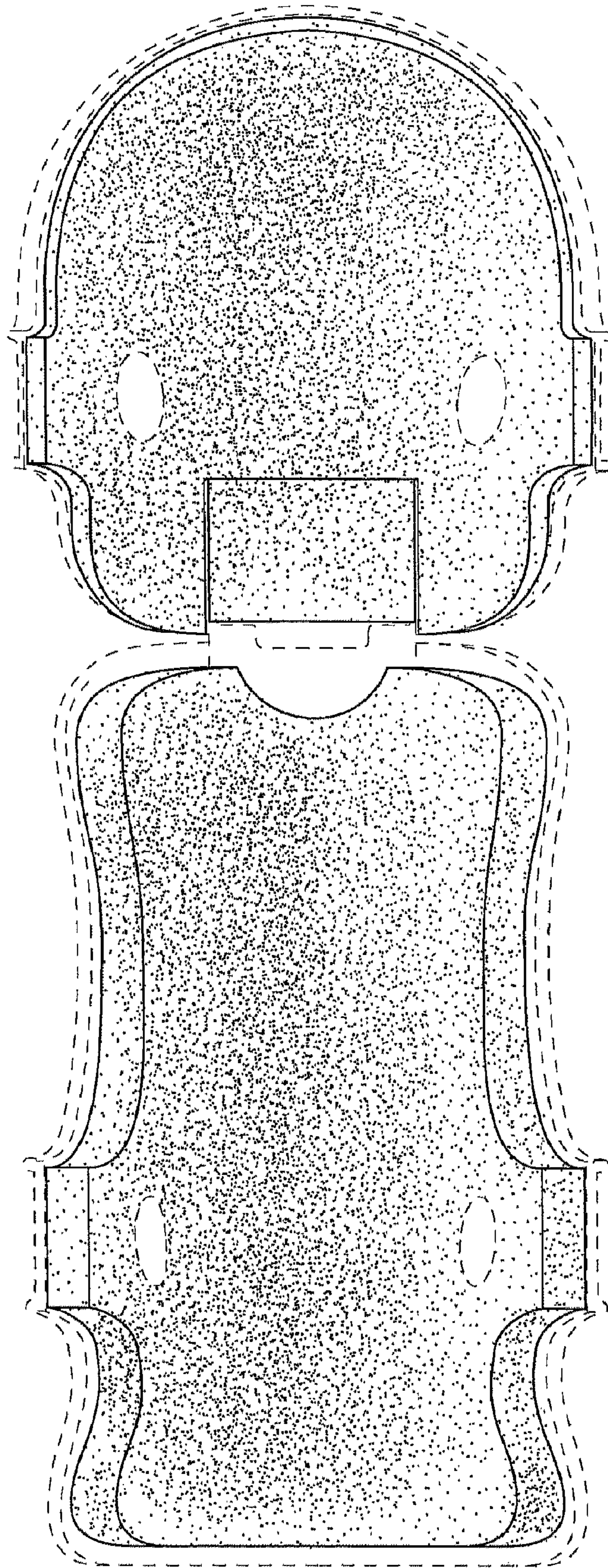

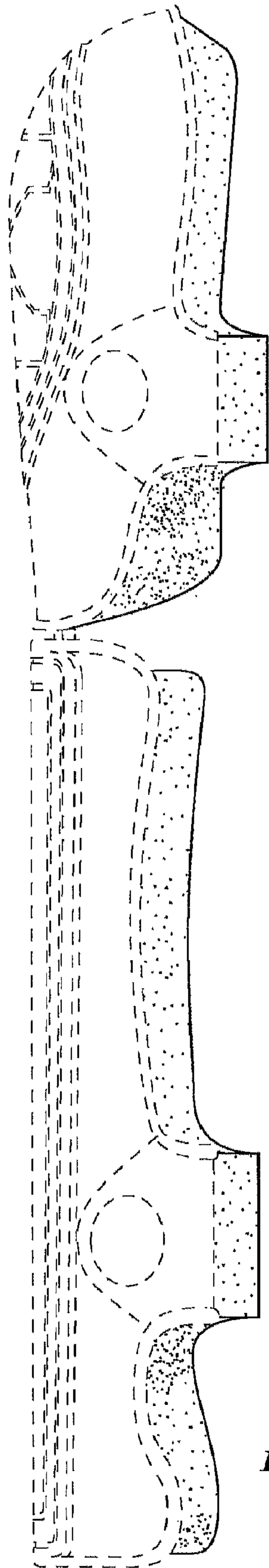

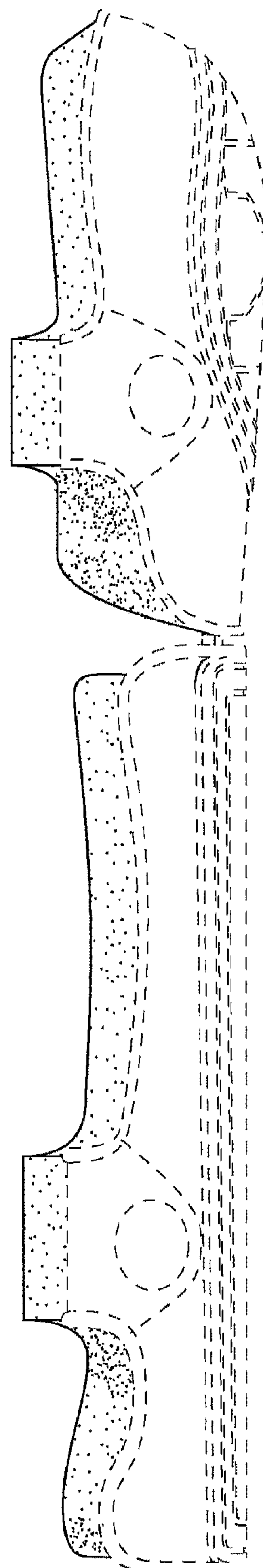

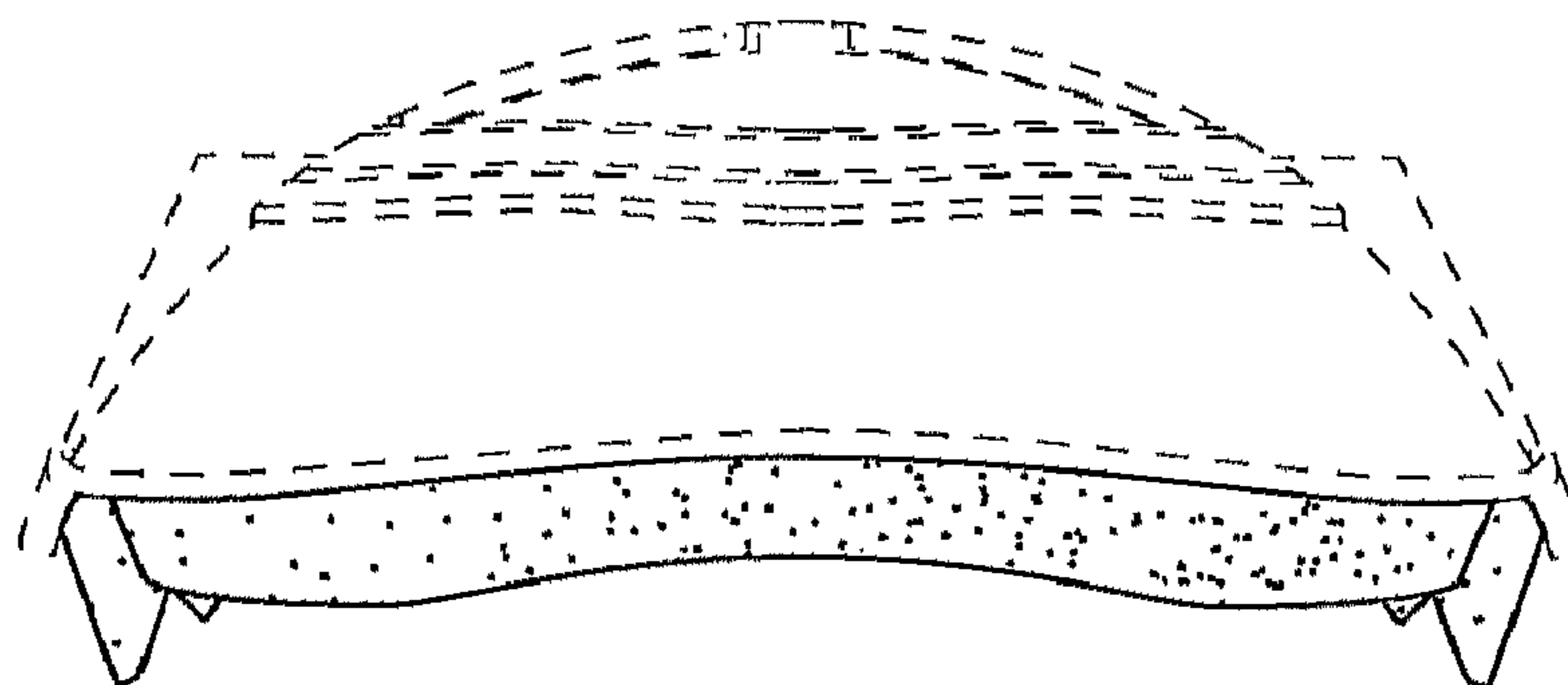

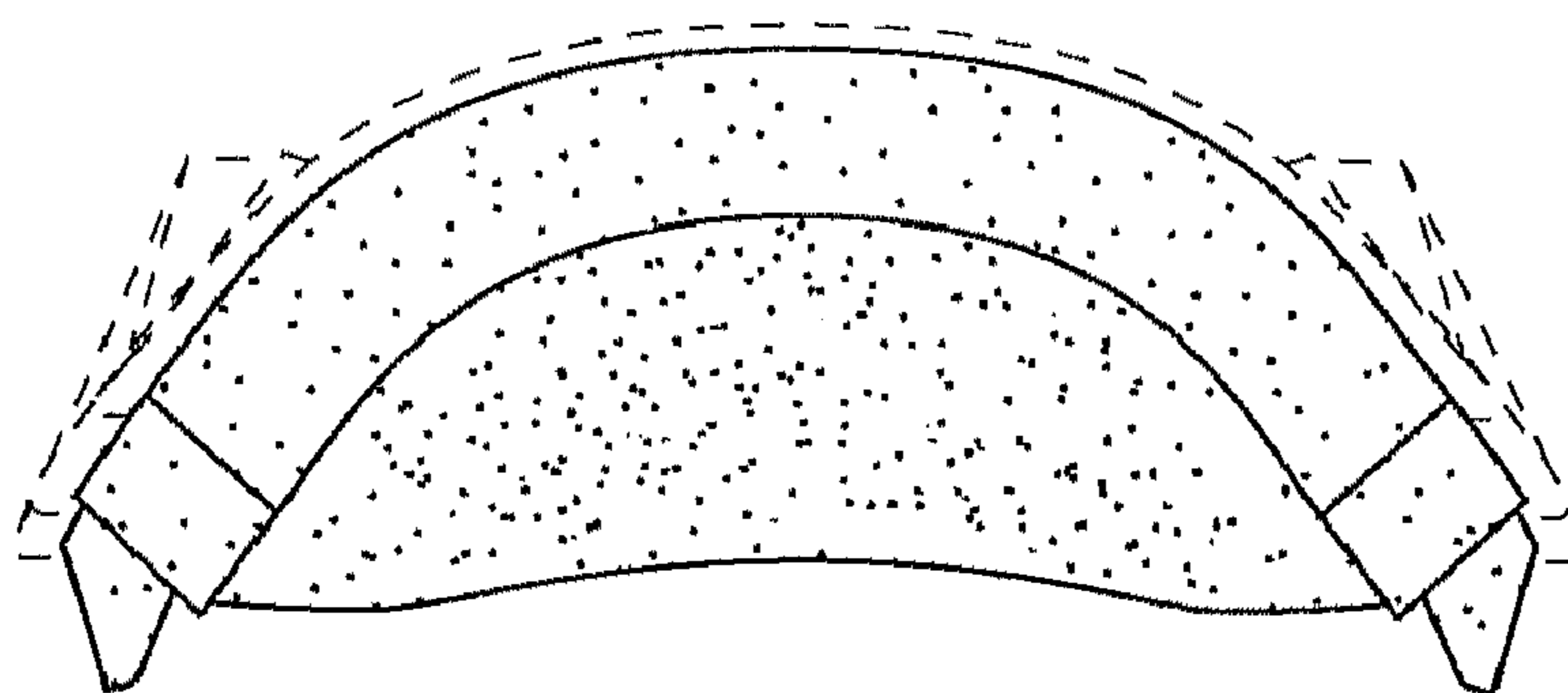

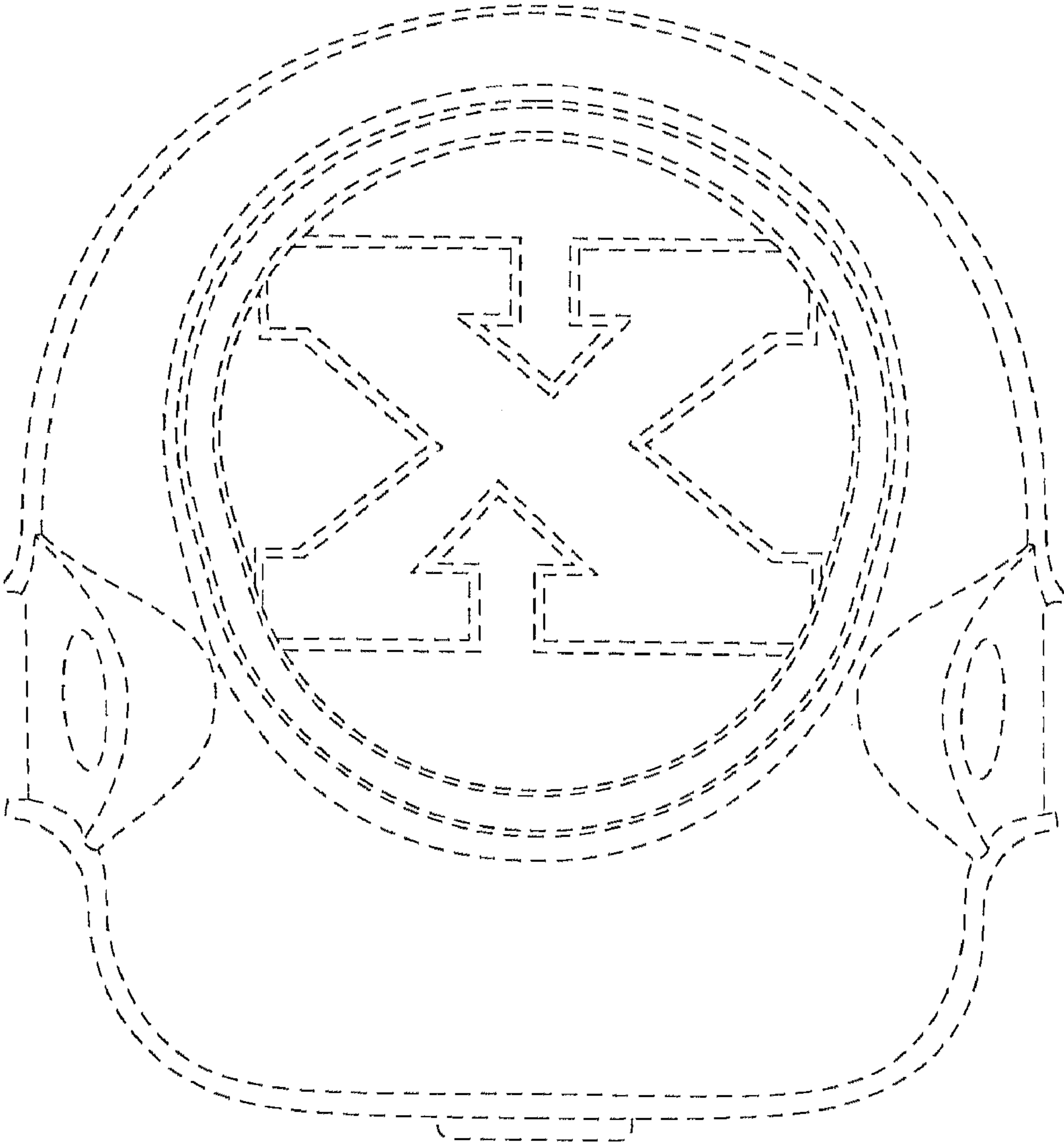

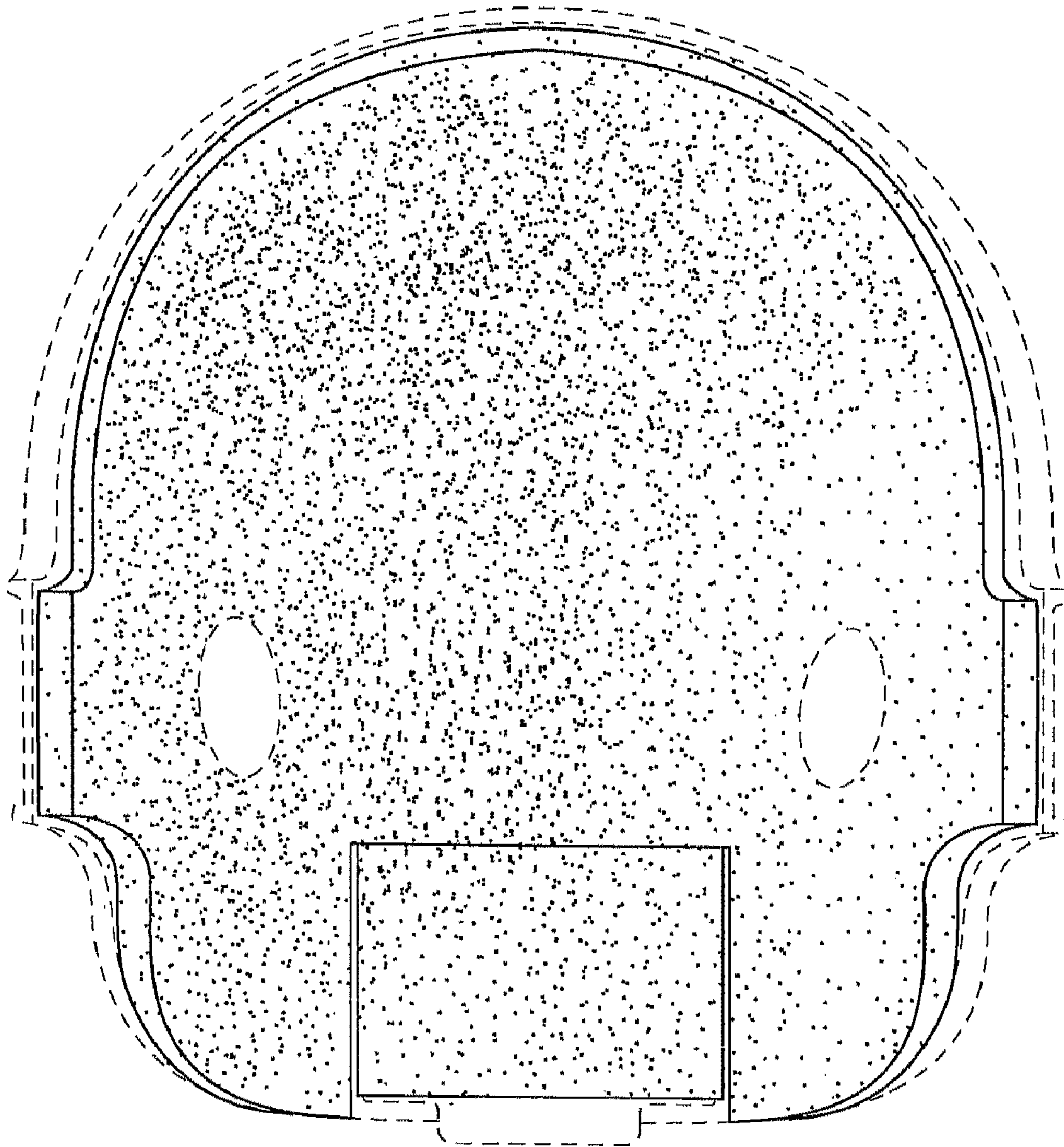

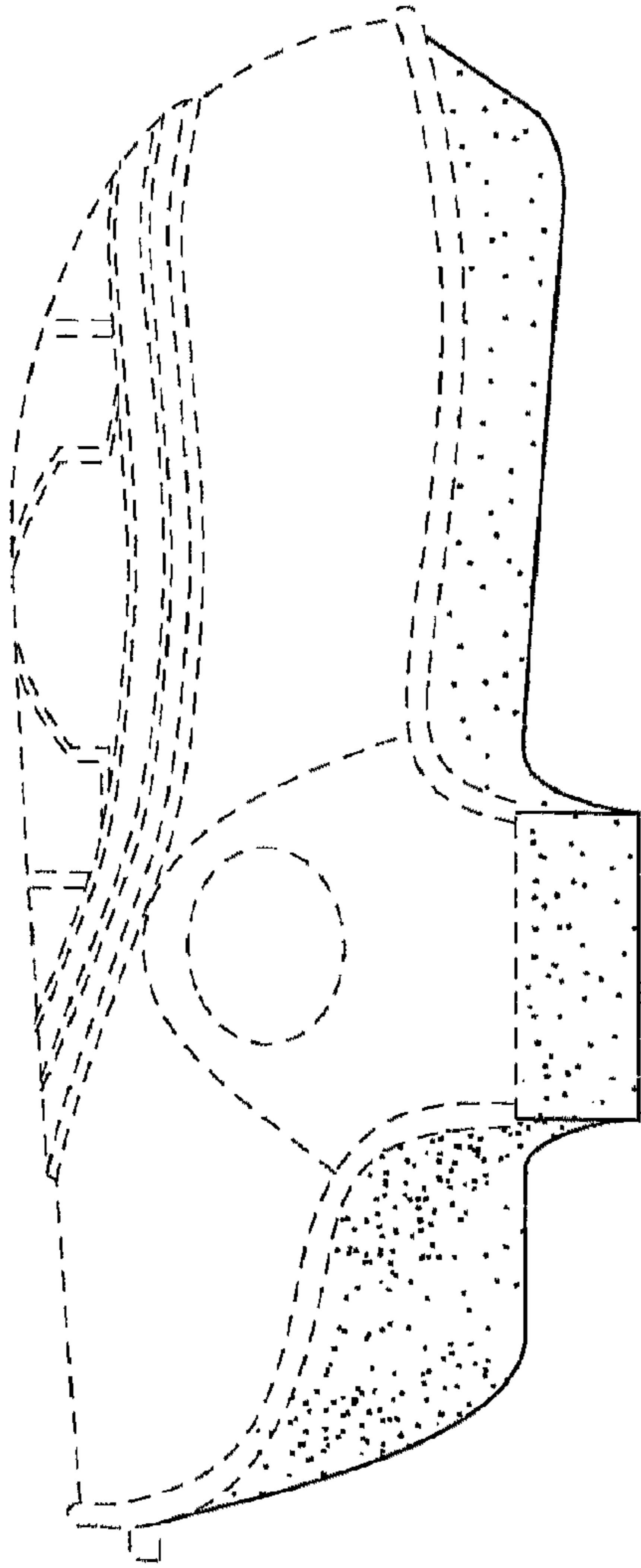

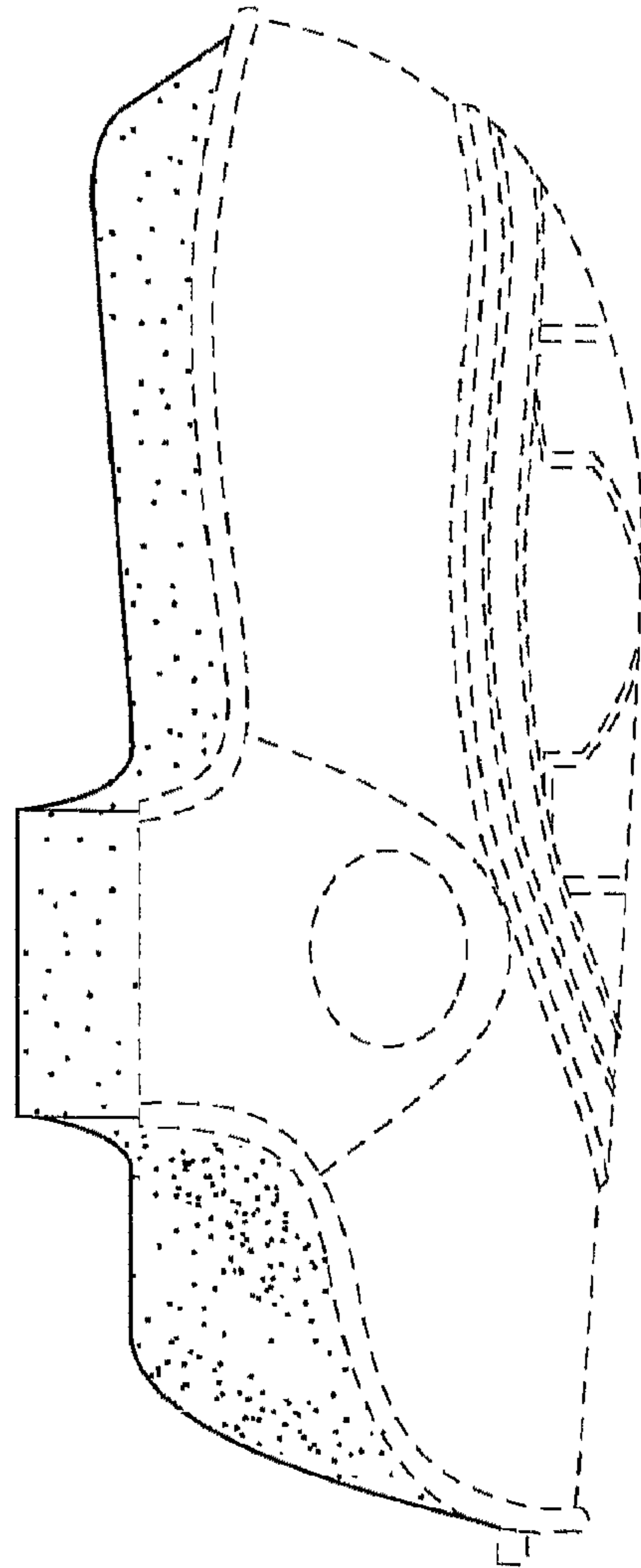

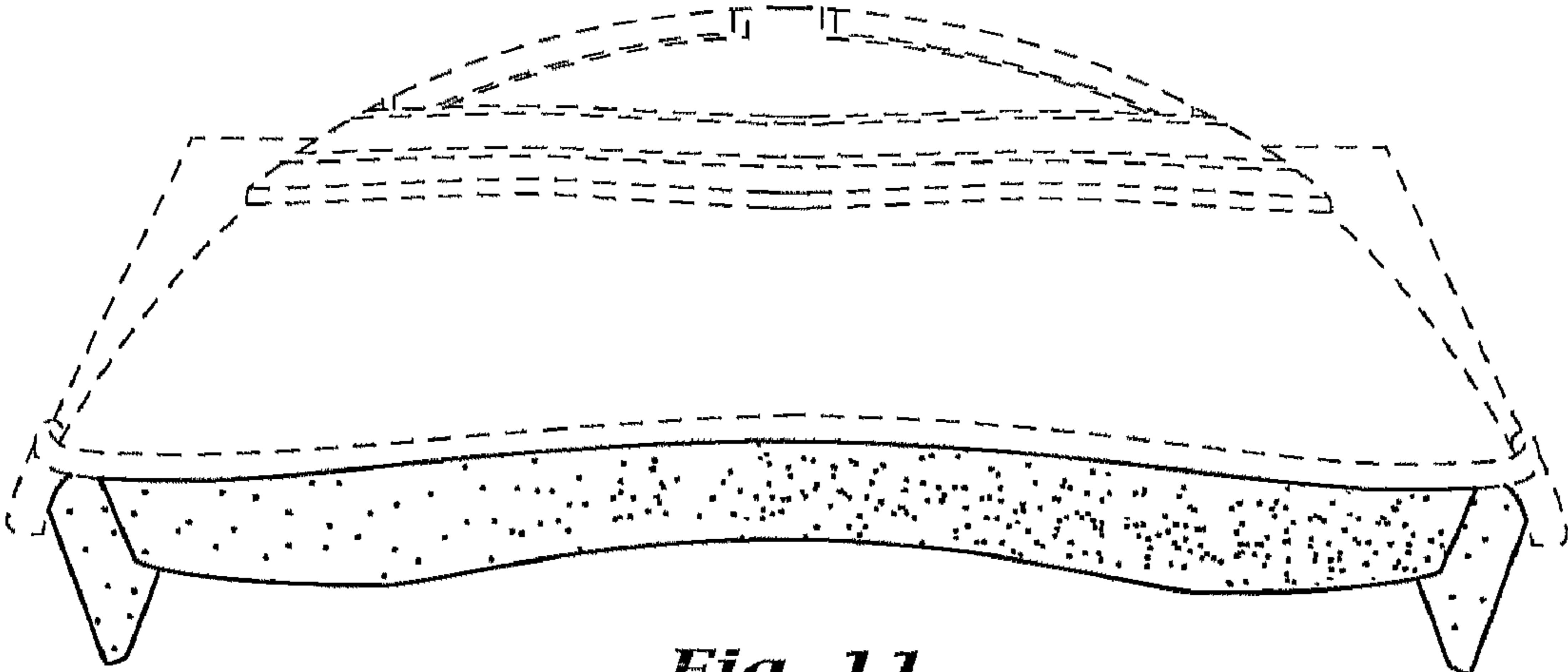

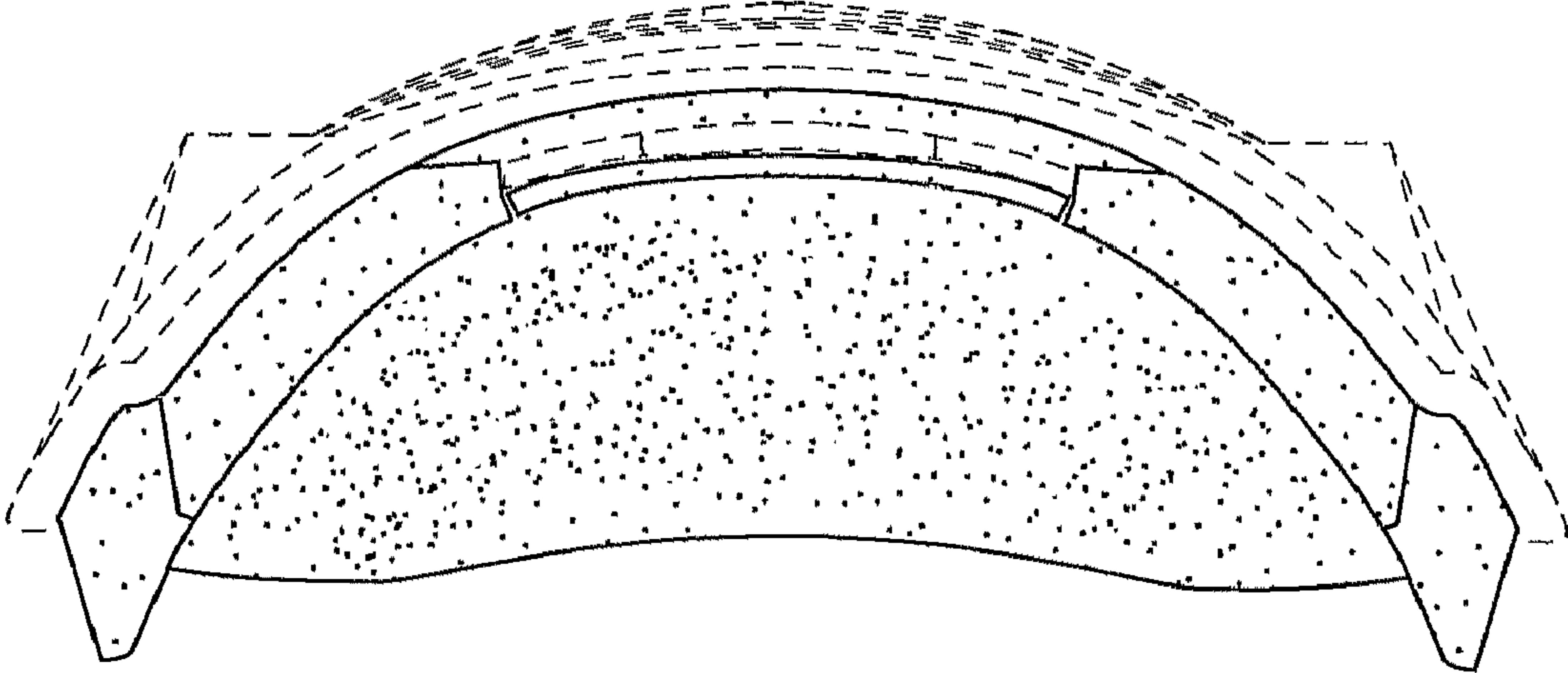

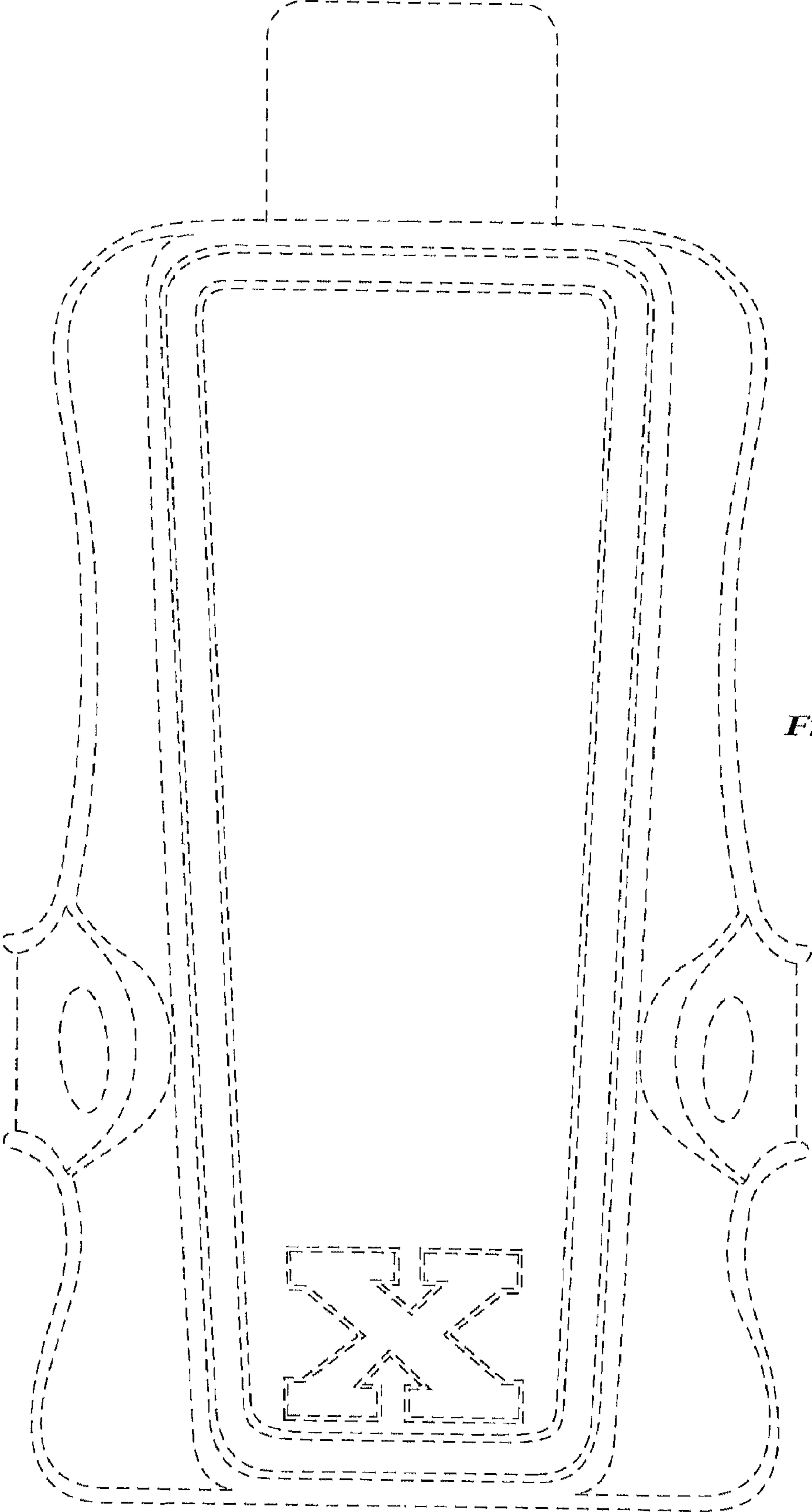

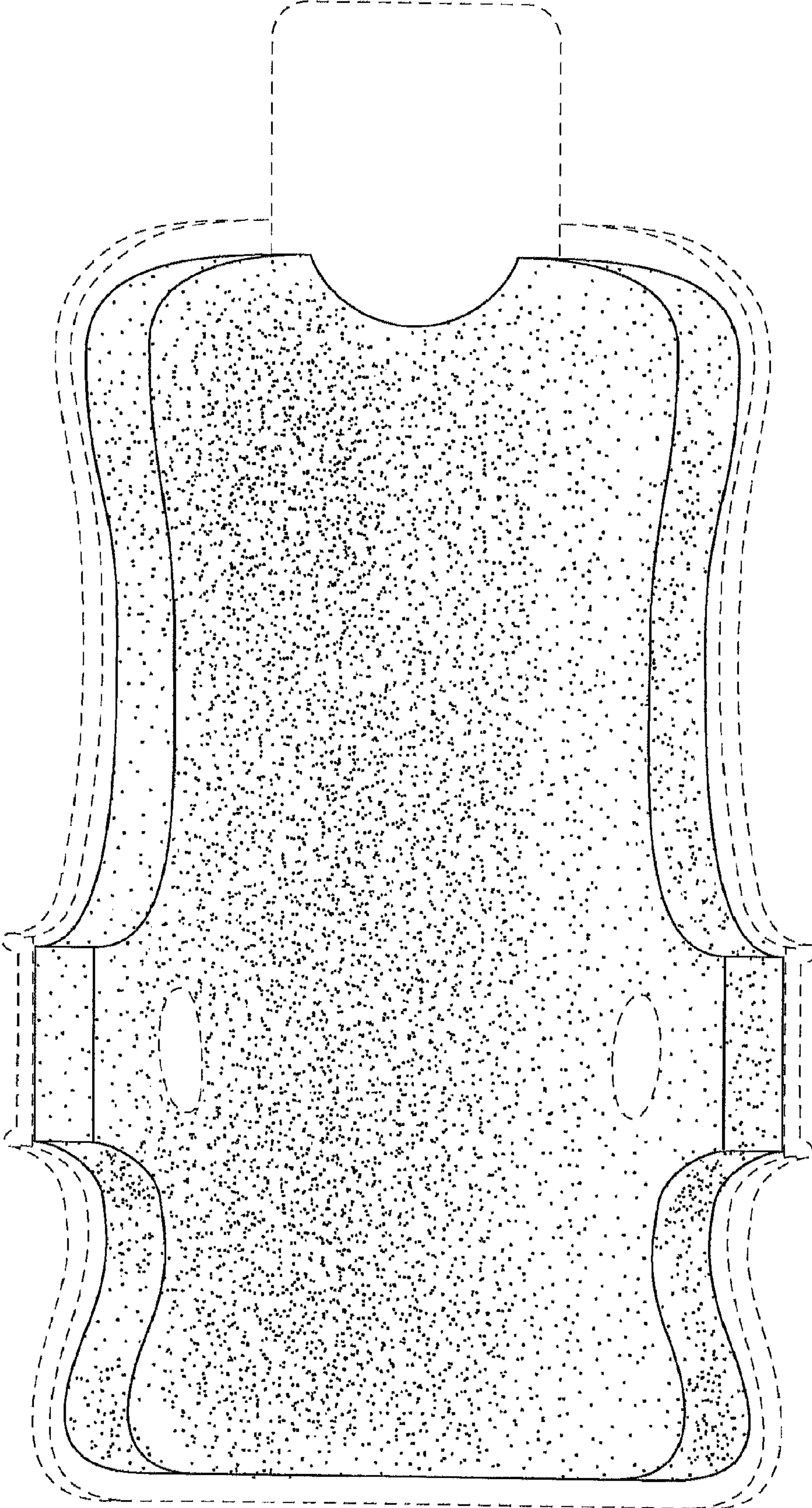

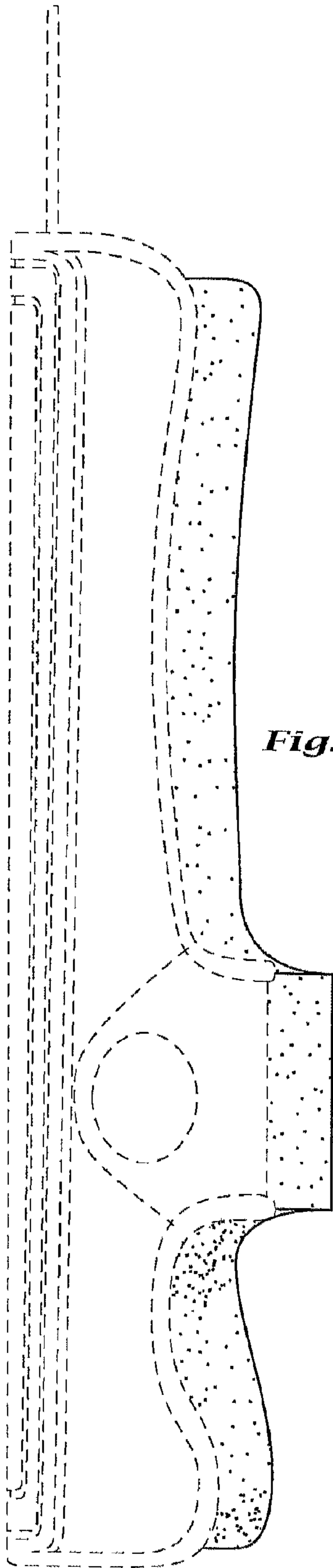

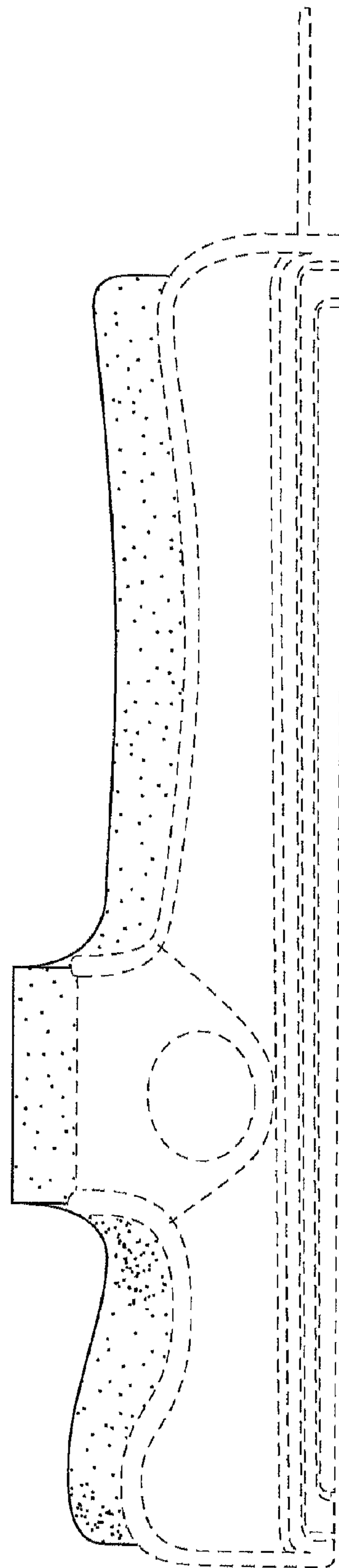

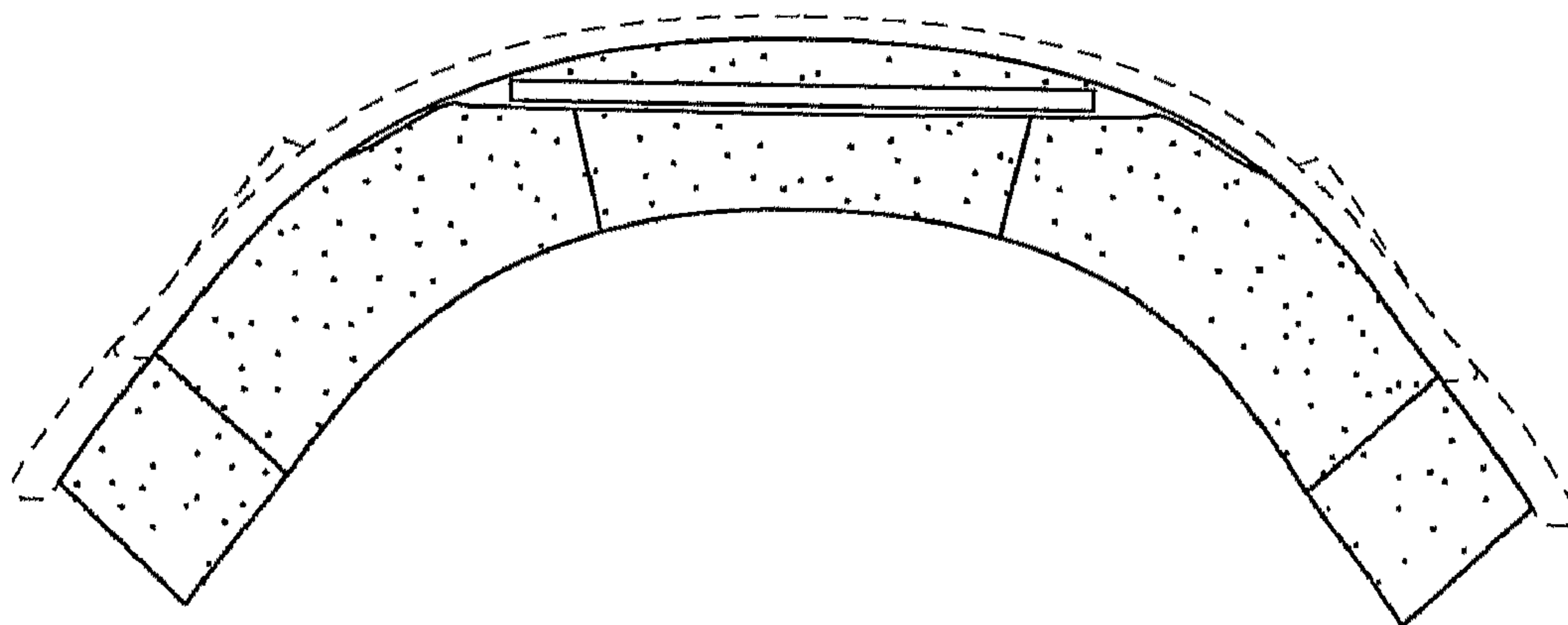

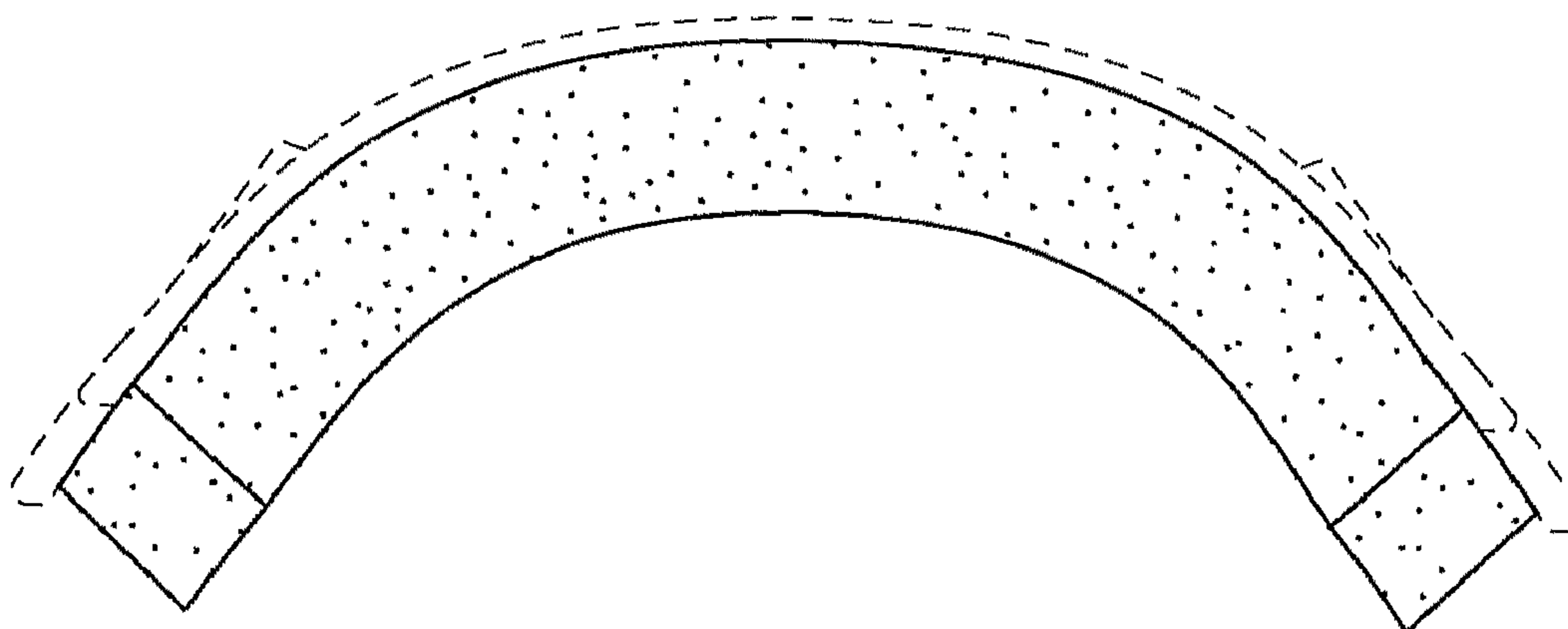
