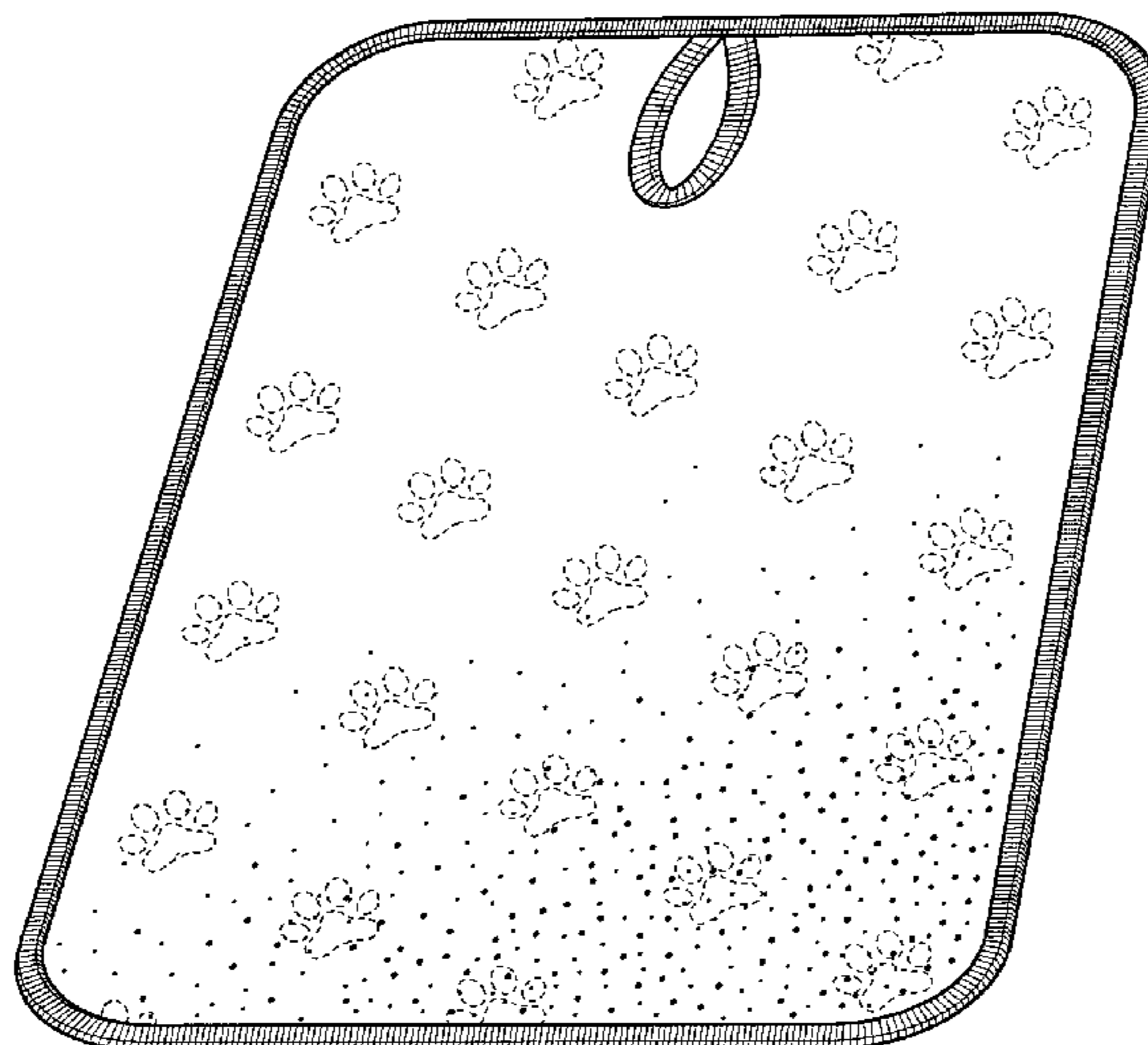
(57) **CLAIM**

The ornamental design for a pet towel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pet towel in accordance with the present invention;  
FIG. 2 is a front elevation view of the pet towel of FIG. 1;  
FIG. 3 is a back elevation view of the pet towel of FIG. 1;  
FIG. 4 is a first side elevation view of the pet towel of FIG. 1;  
FIG. 5 is a second side elevation view of the pet towel of FIG. 1;  
FIG. 6 is a top view of the pet towel of FIG. 1; and,  
FIG. 7 is a bottom view of the pet towel of FIG. 1.

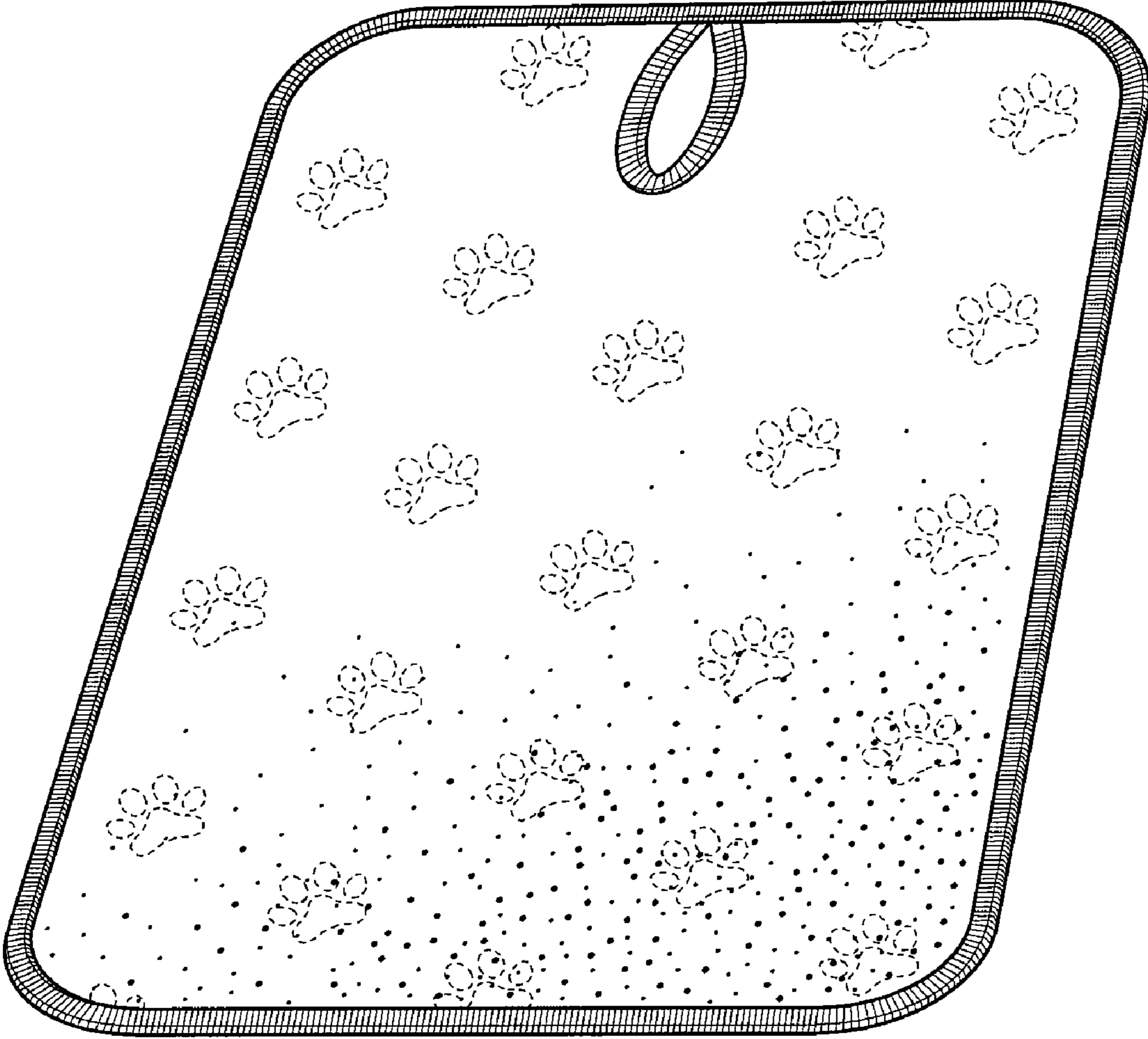

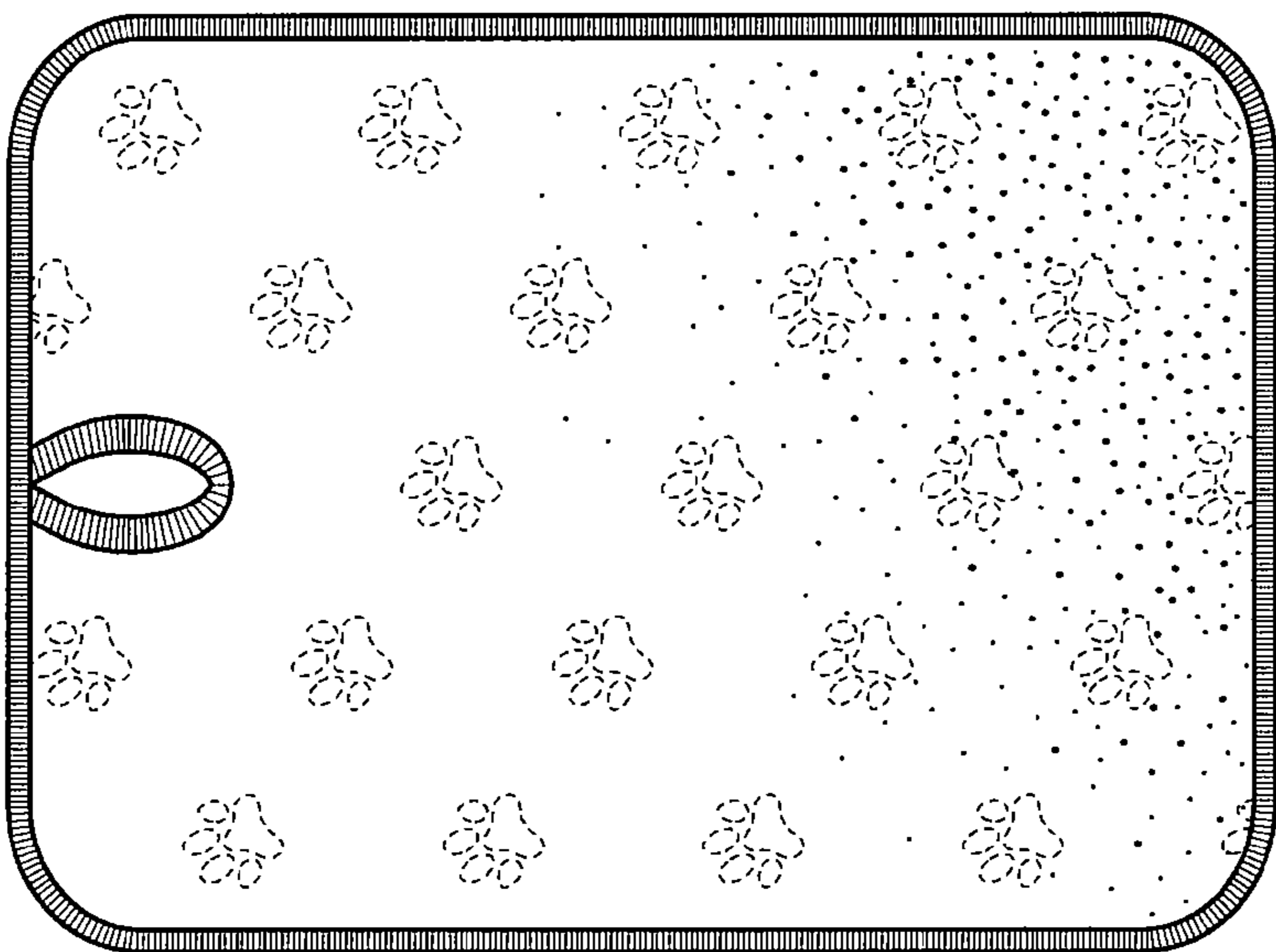

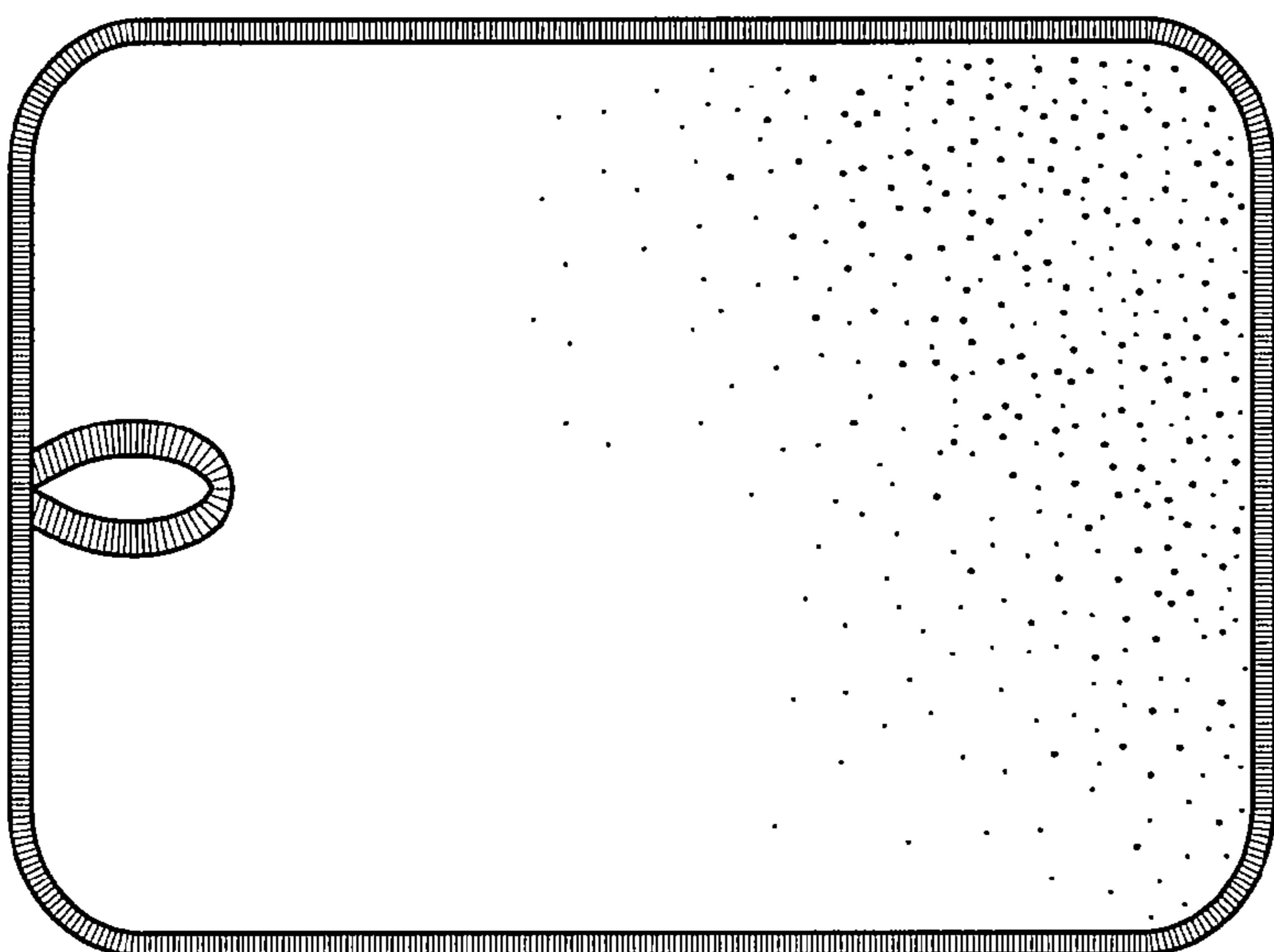
