DESCRIPTION

FIG. 1 is a front and side perspective view of a pet throw/chew toy embodying my new design;

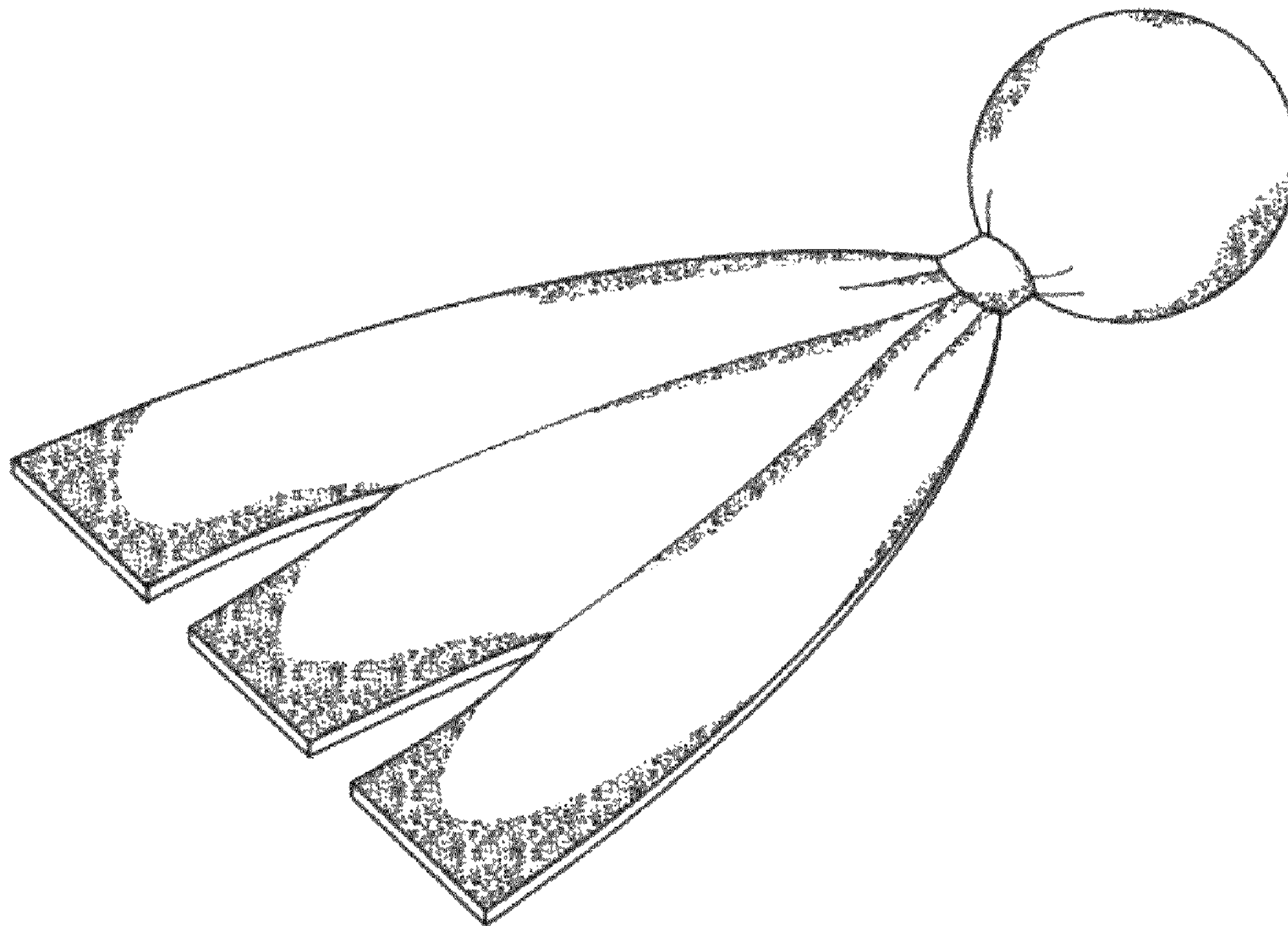

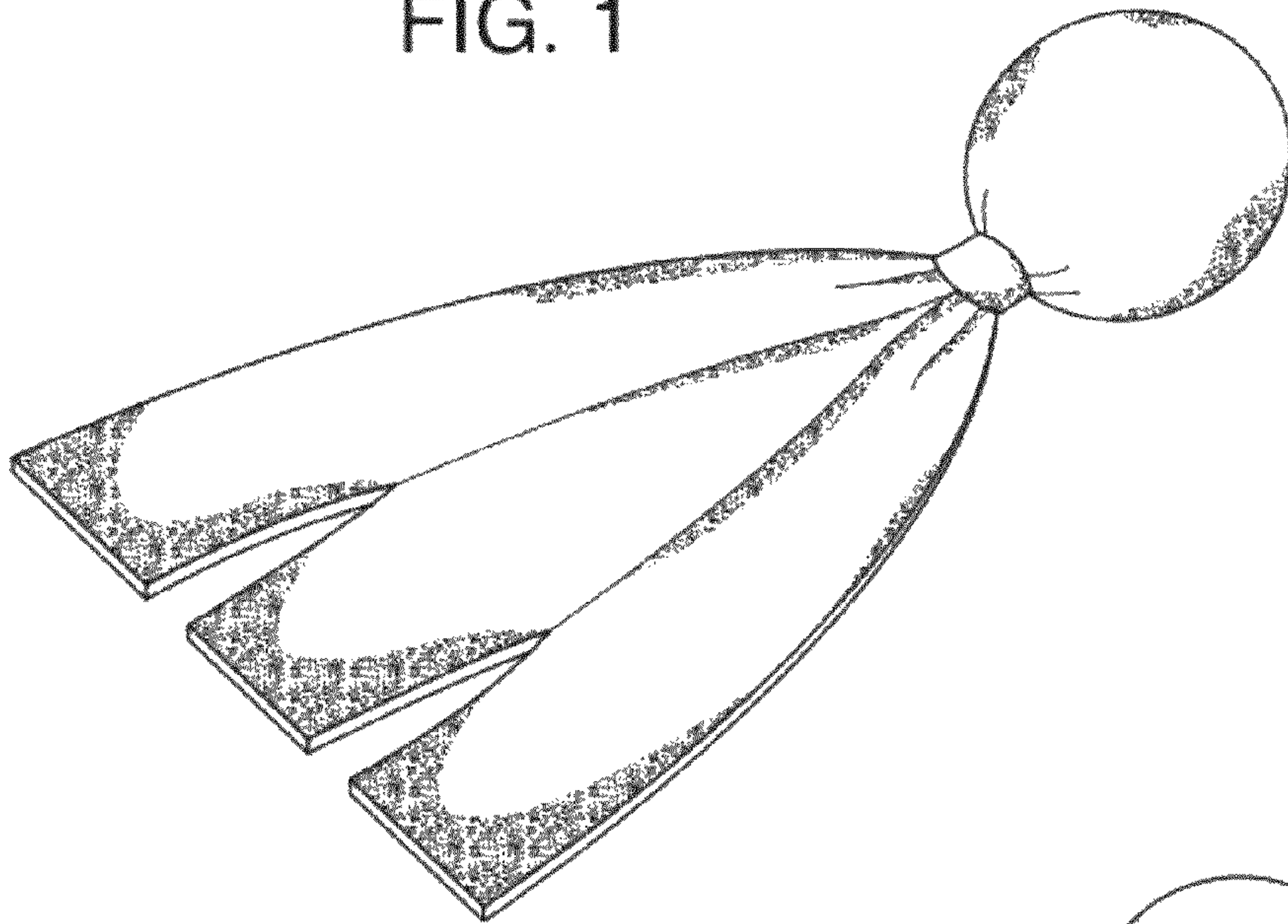
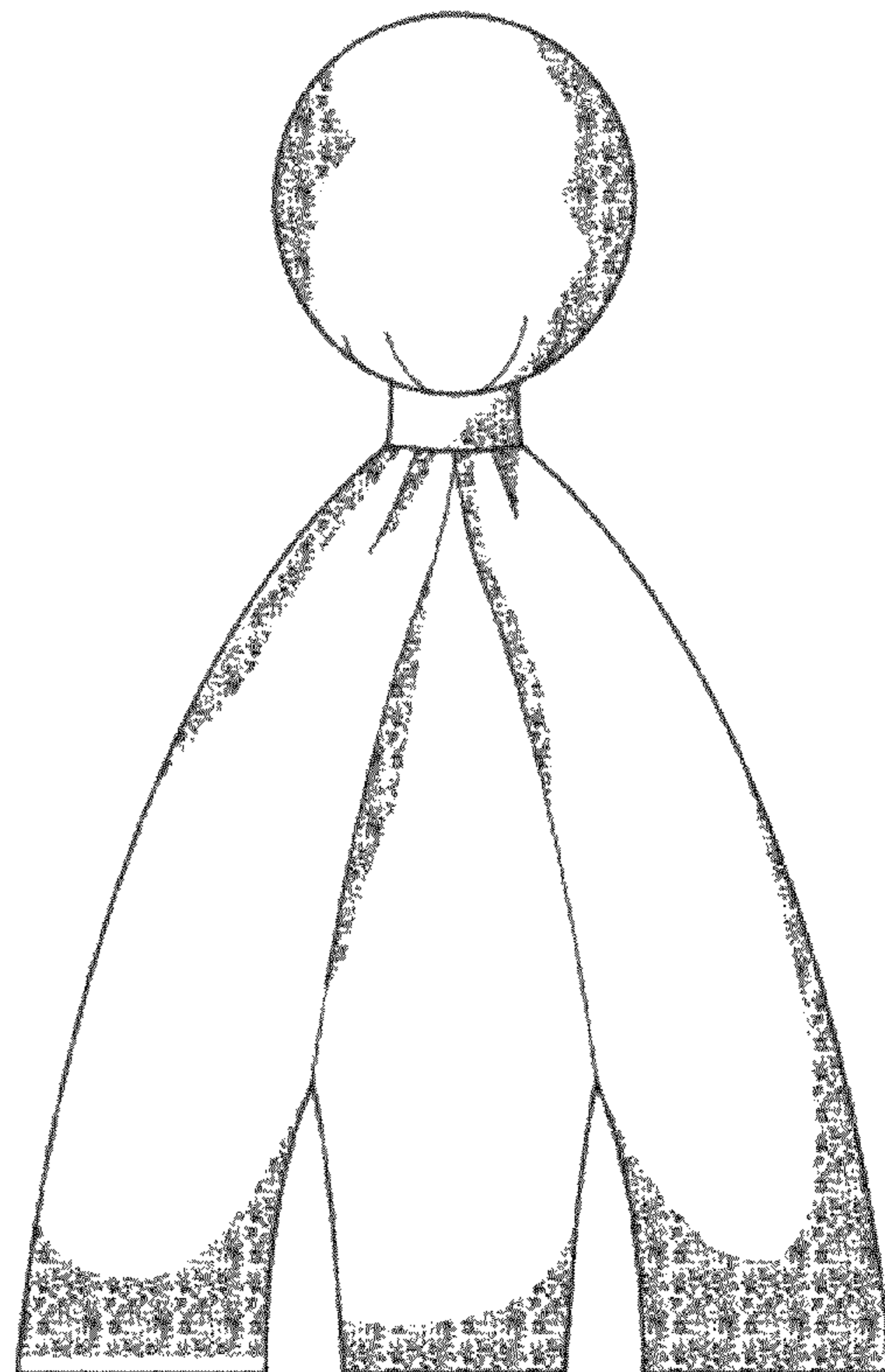

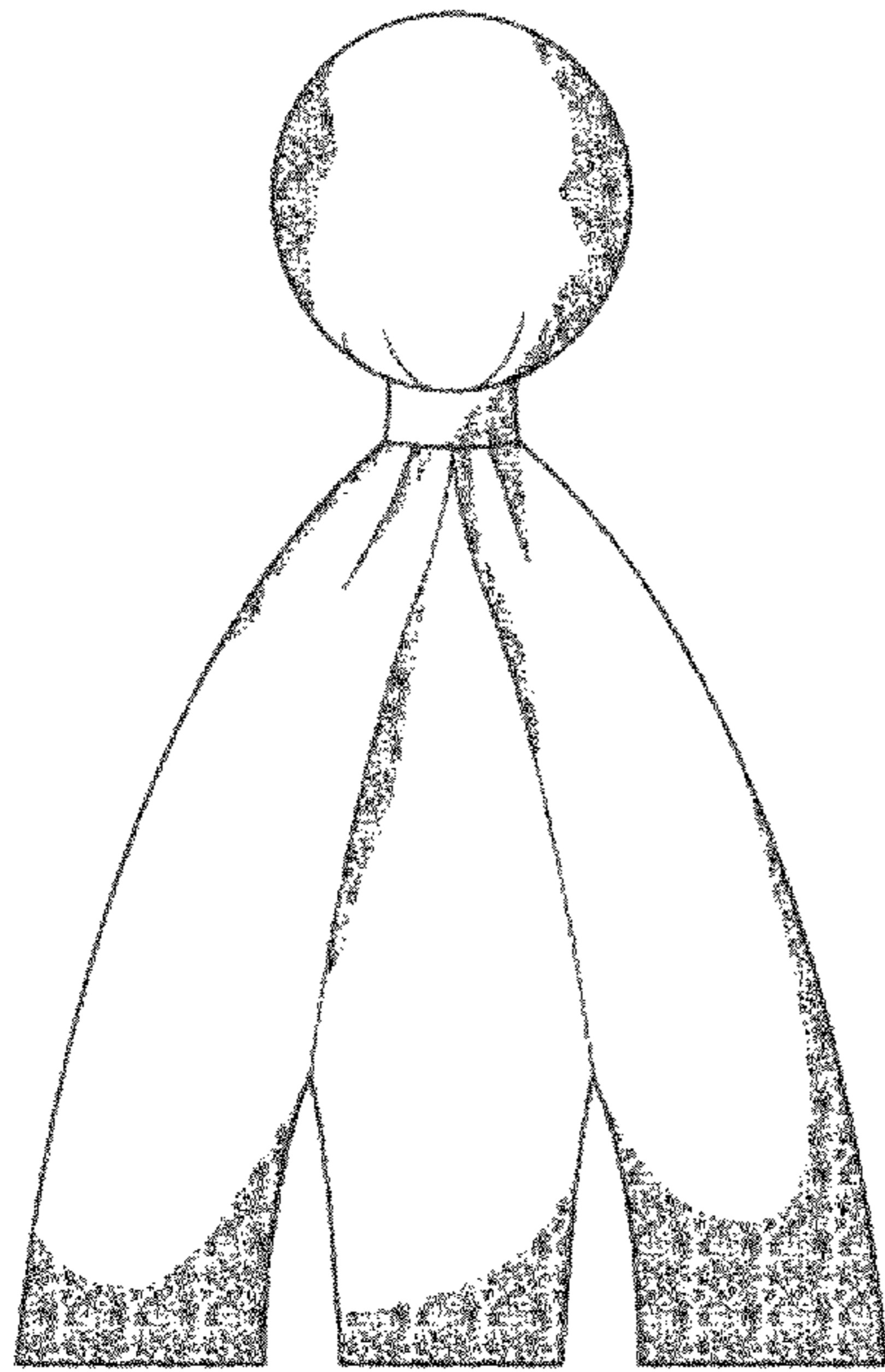

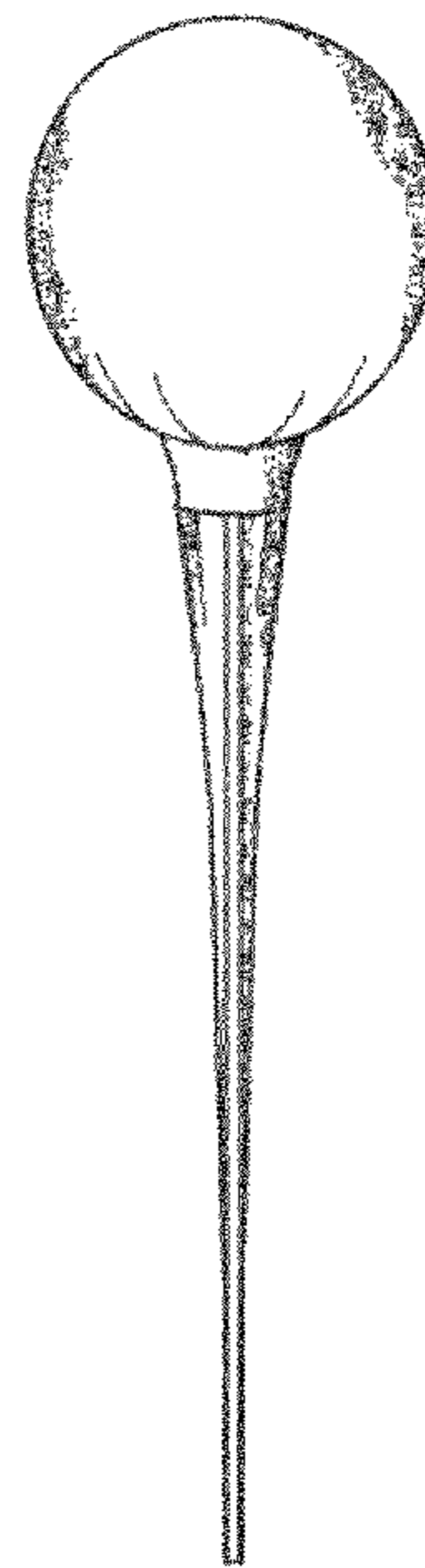

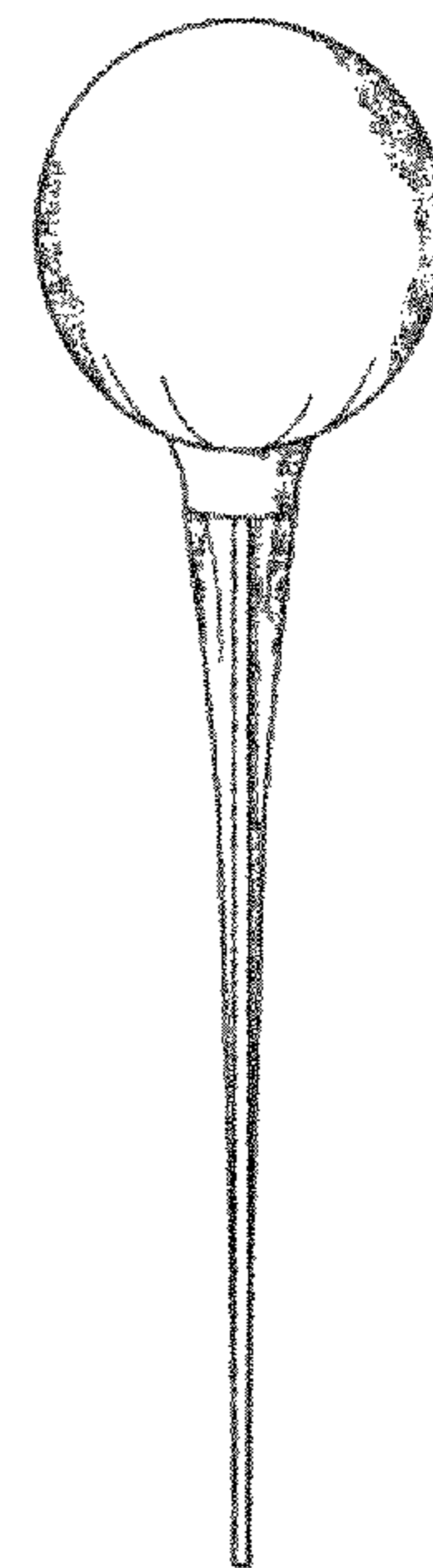

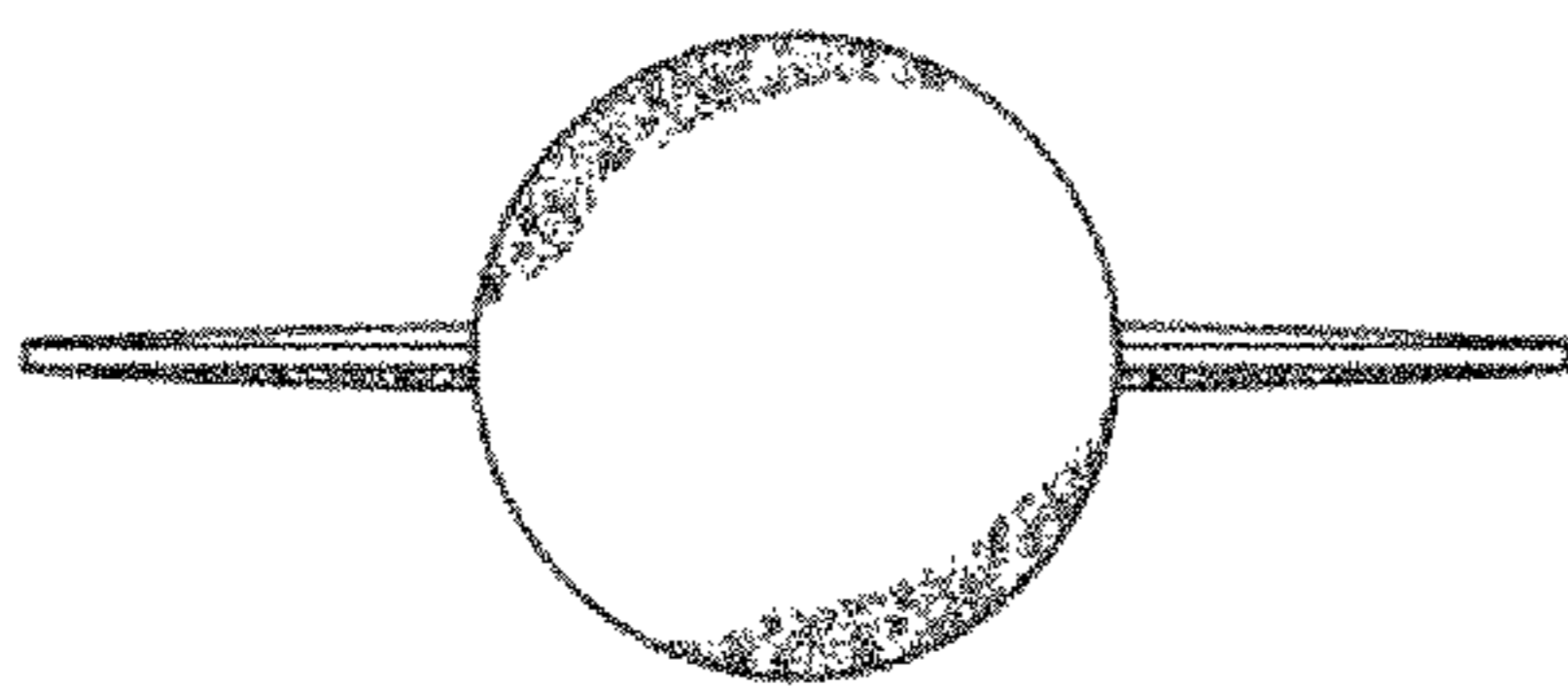

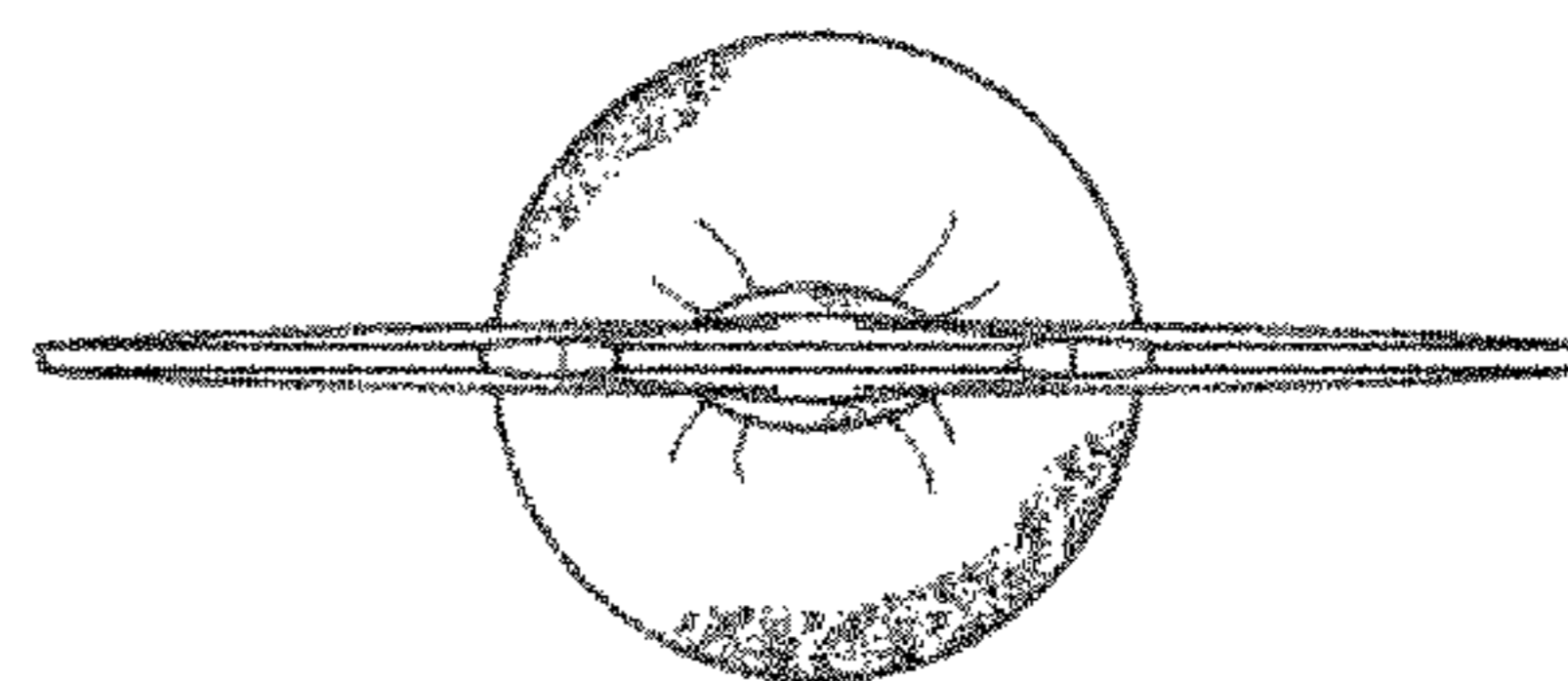
