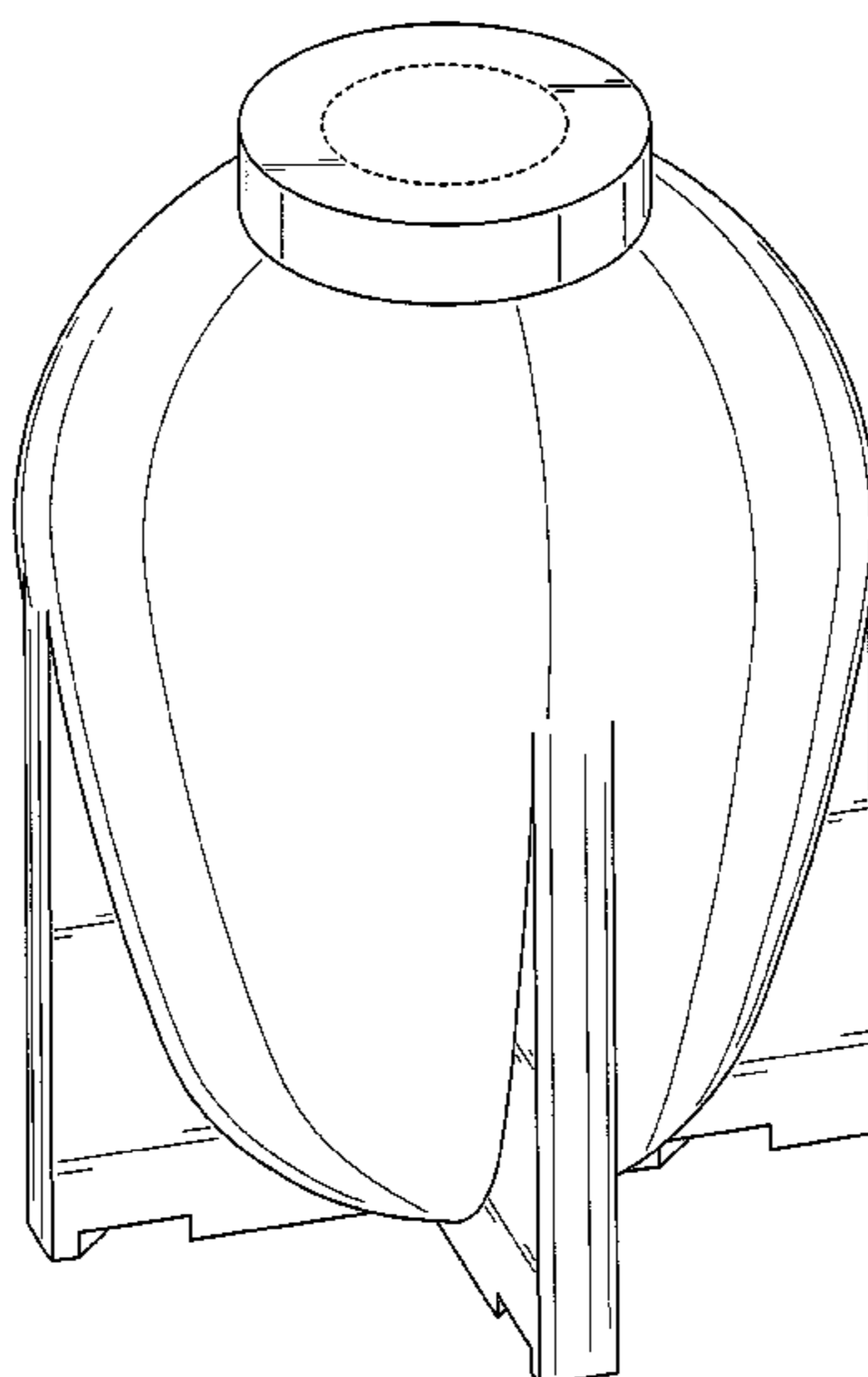
(57) **CLAIM**

The ornamental design for a wine vat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a front and top of a wine vat showing my new design according to a first embodiment; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image thereof; FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 6 is a perspective view of a front and bottom thereof; FIG. 7 is a perspective view of a front and top of a wine vat showing my new design according to a second embodiment; FIG. 8 is a bottom plan view thereof; FIG. 9 is a top plan view thereof; FIG. 10 is a front elevational view thereof, the rear elevational view being a mirror image thereof; FIG. 11 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 12 is a perspective view of a front and bottom thereof; FIG. 13 is a perspective view of a front and top of a wine vat showing my new design according to a third embodiment; FIG. 14 is a bottom plan view thereof; FIG. 15 is a top plan view thereof; FIG. 16 is a front elevational view thereof, the rear elevational view being a mirror image thereof; FIG. 17 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 18 is a perspective view of a front and bottom thereof; FIG. 19 is a perspective view of a front and top of a wine vat showing my new design according to a fourth embodiment; FIG. 20 is a bottom plan view thereof; FIG. 21 is a top plan view thereof; FIG. 22 is a front elevational view thereof, the rear elevational view being a mirror image thereof; FIG. 23 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; and, FIG. 24 is a perspective view of a front and bottom thereof. The broken line showing of a circle in FIGS. 1, 3, 7, 9, 13, 15, 19, and 21 is included for the purpose of illustrating elements of the wine vat and forms no part of the claimed design.

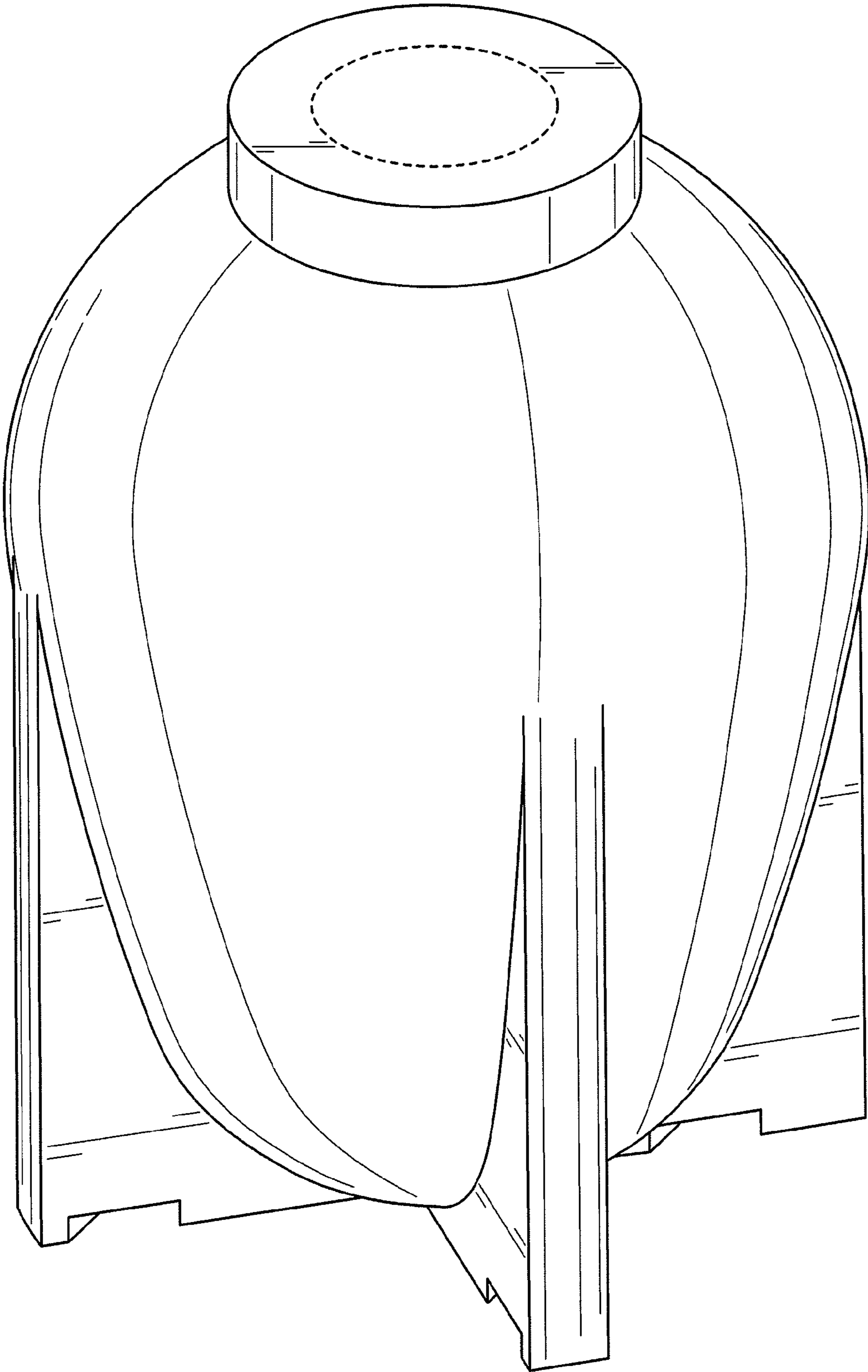

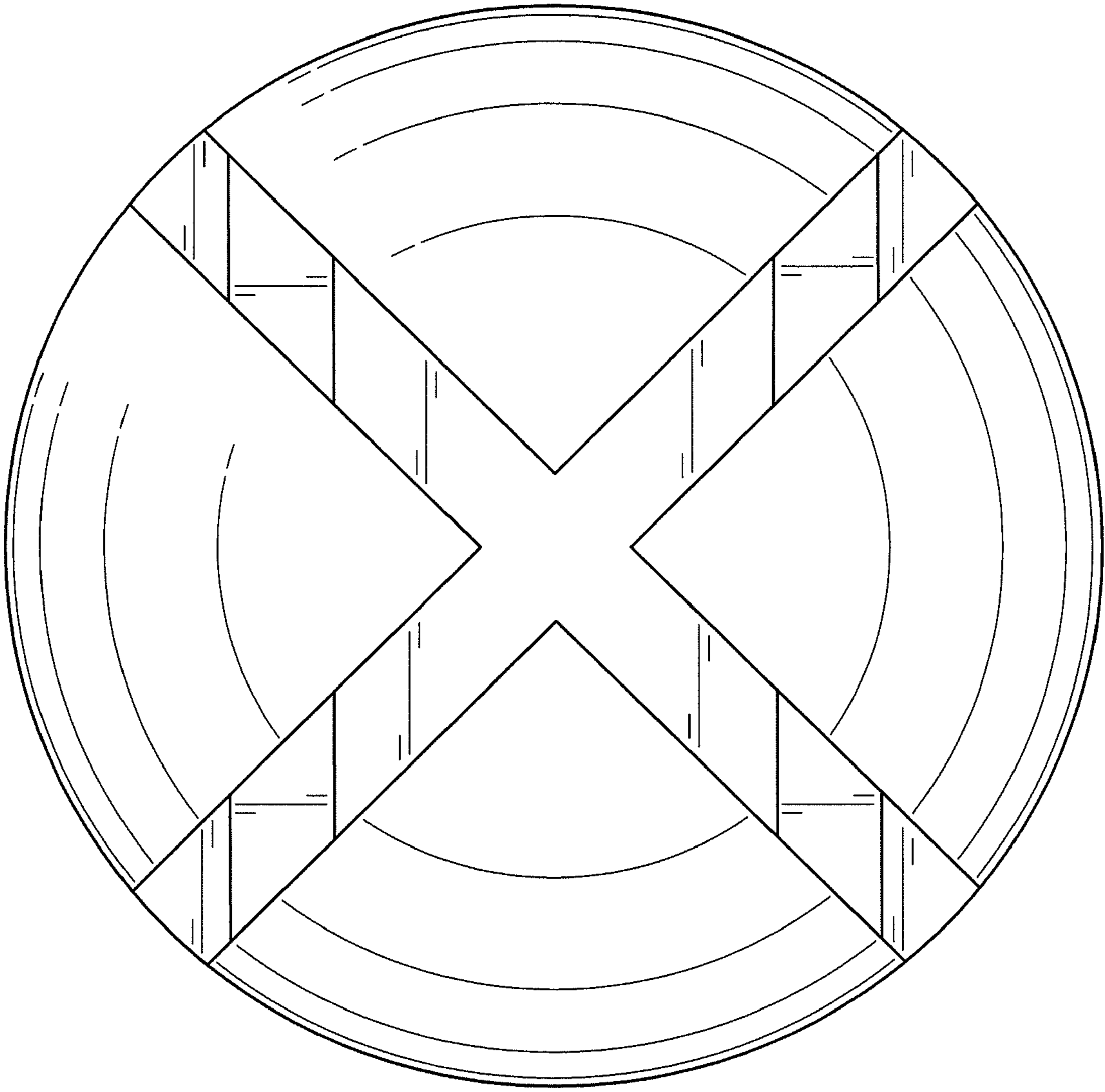

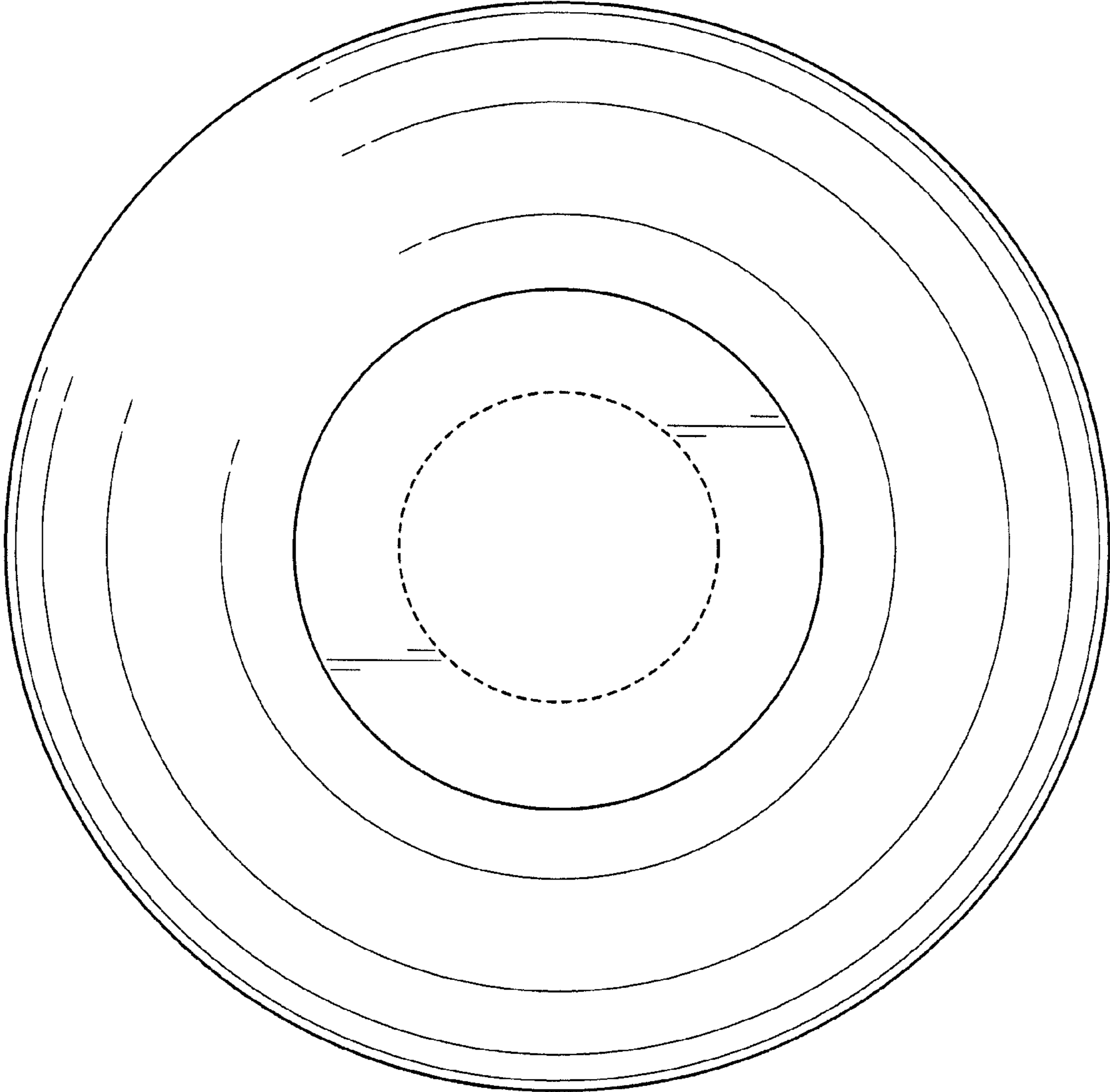

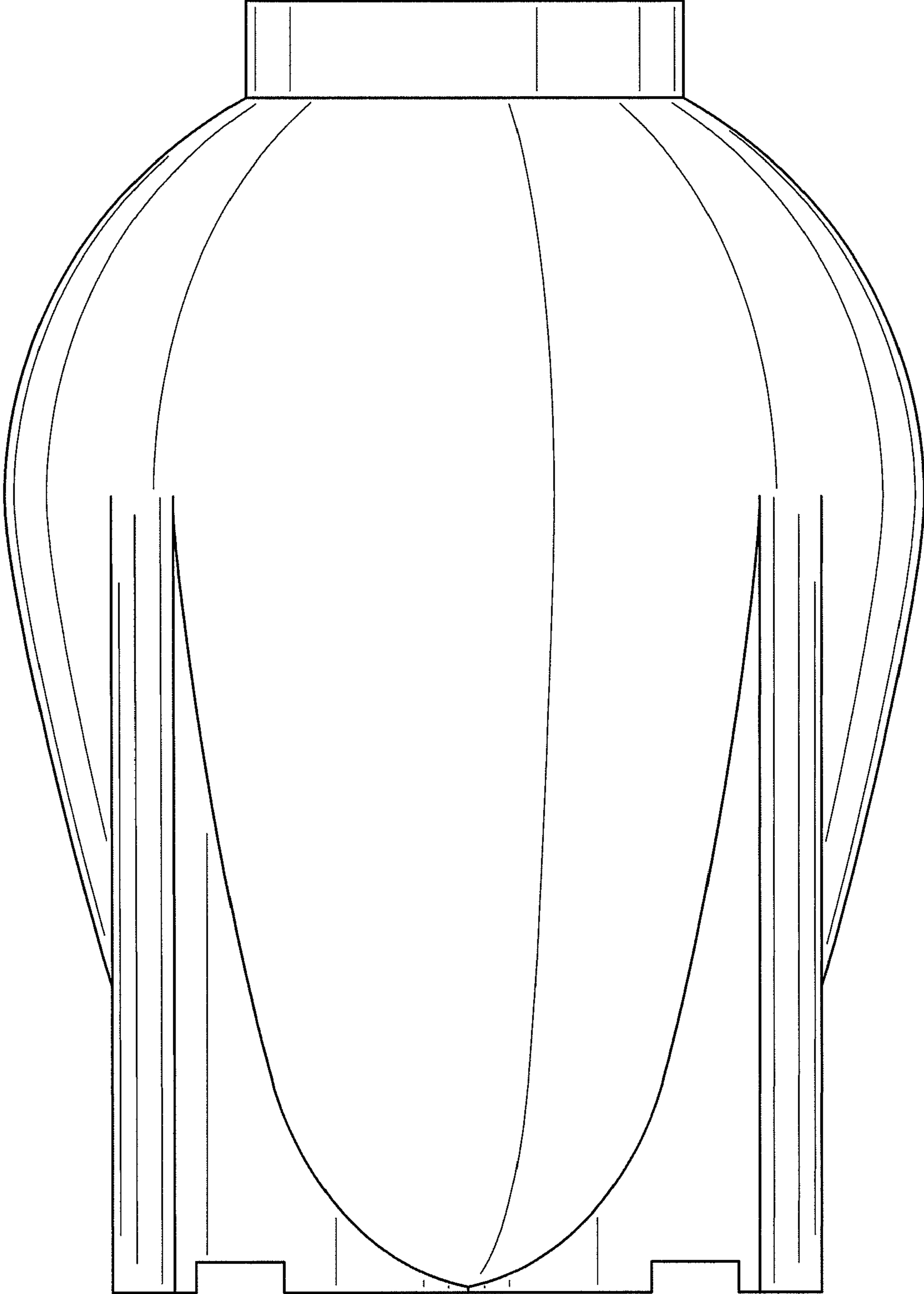

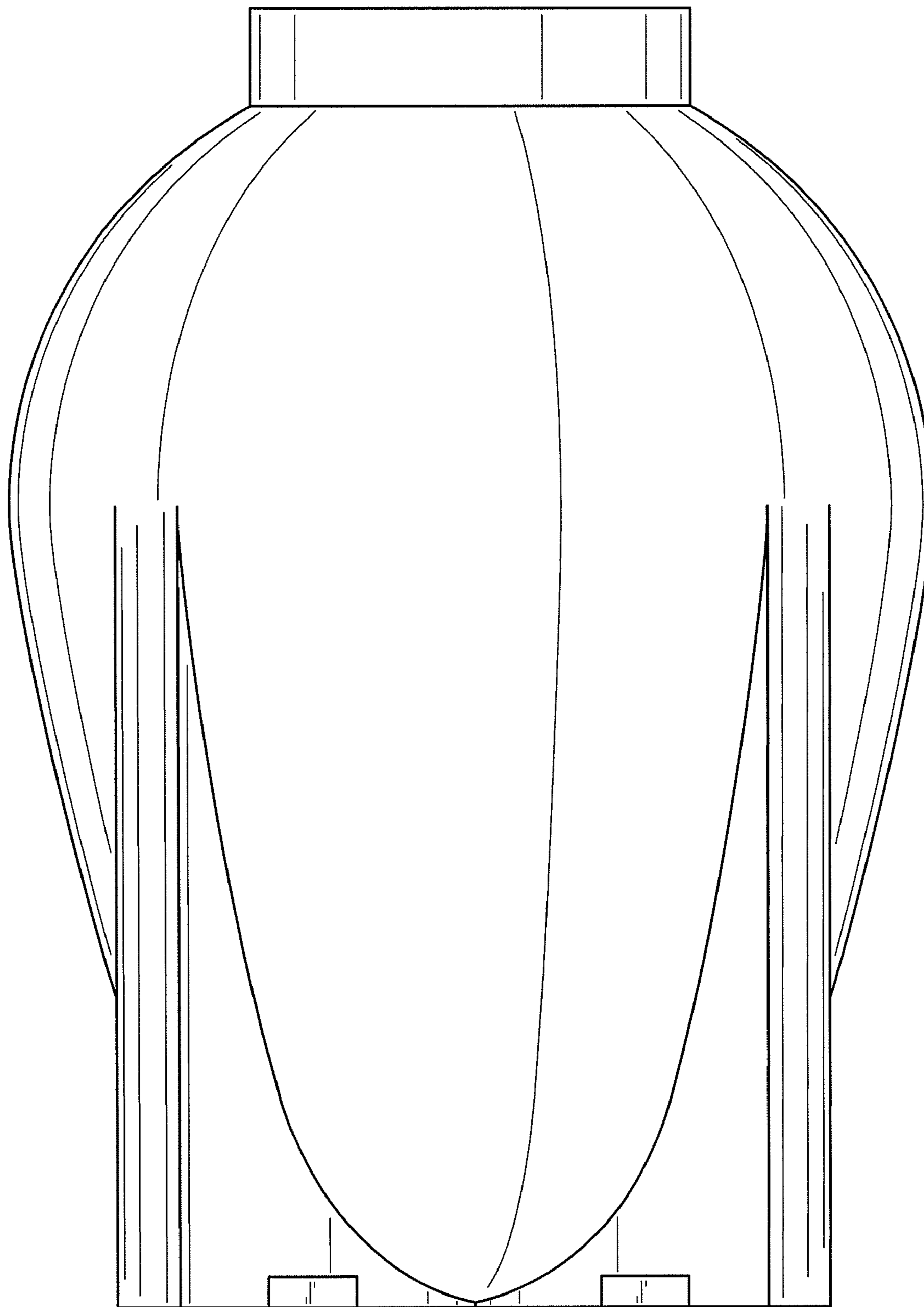

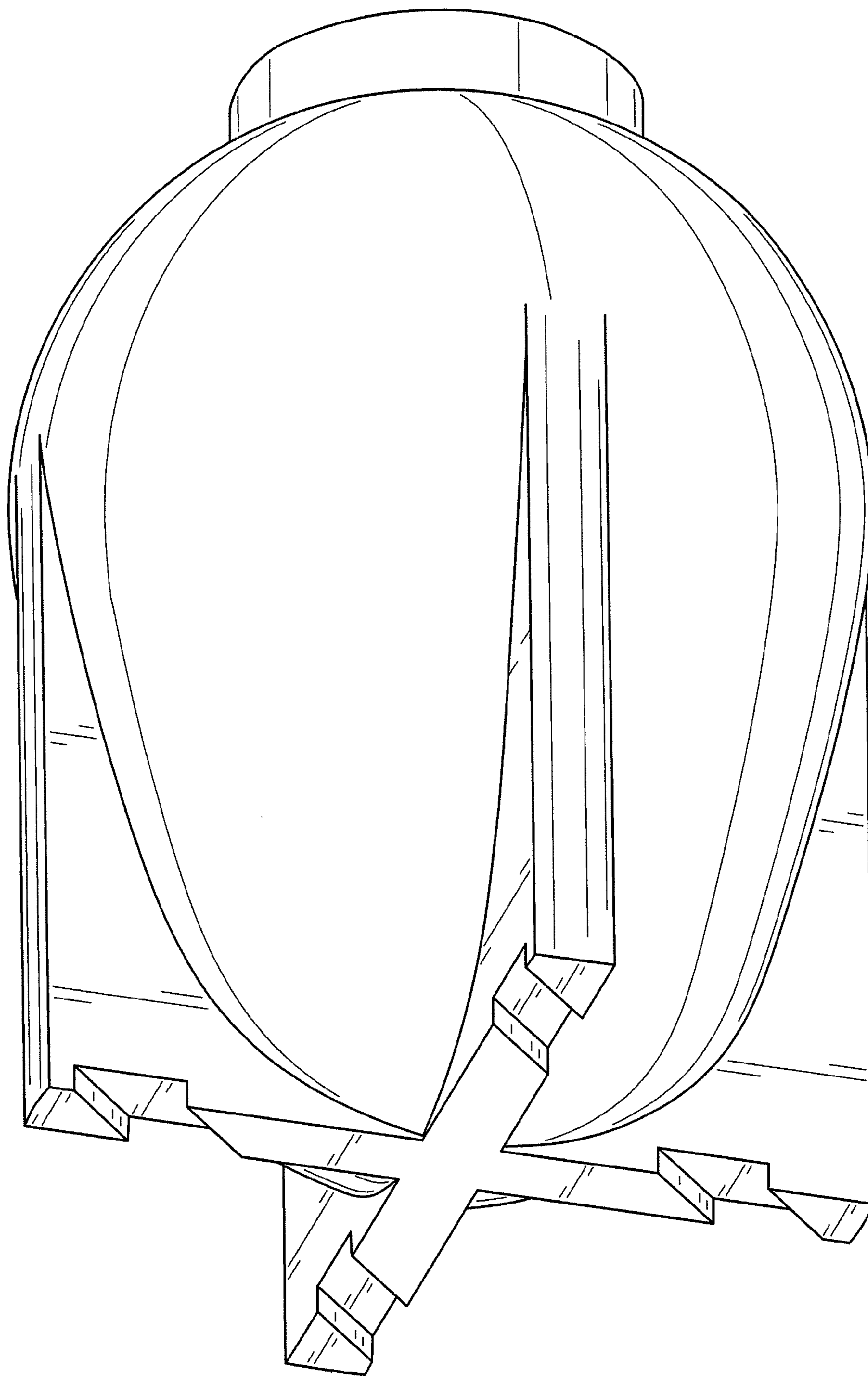

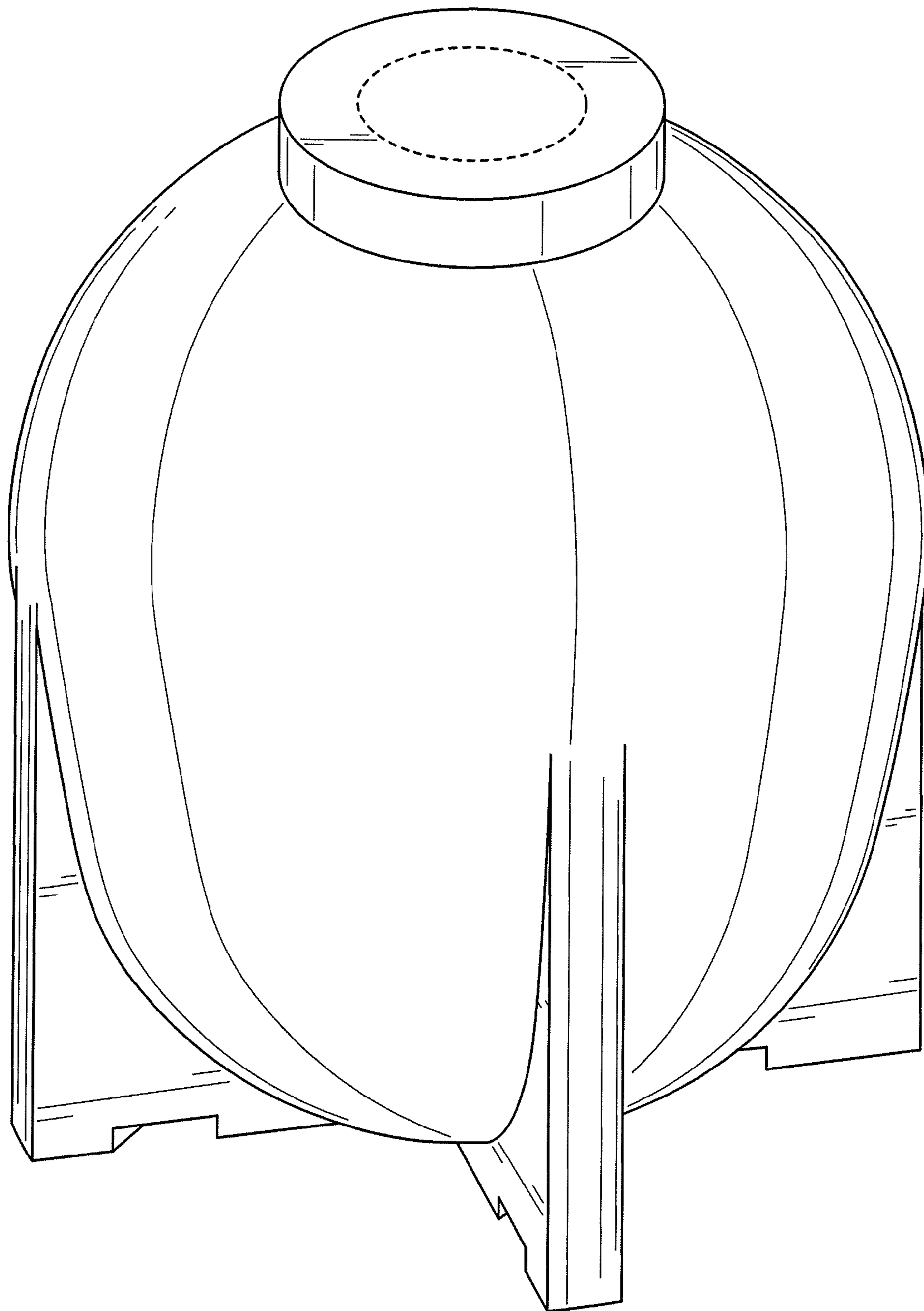

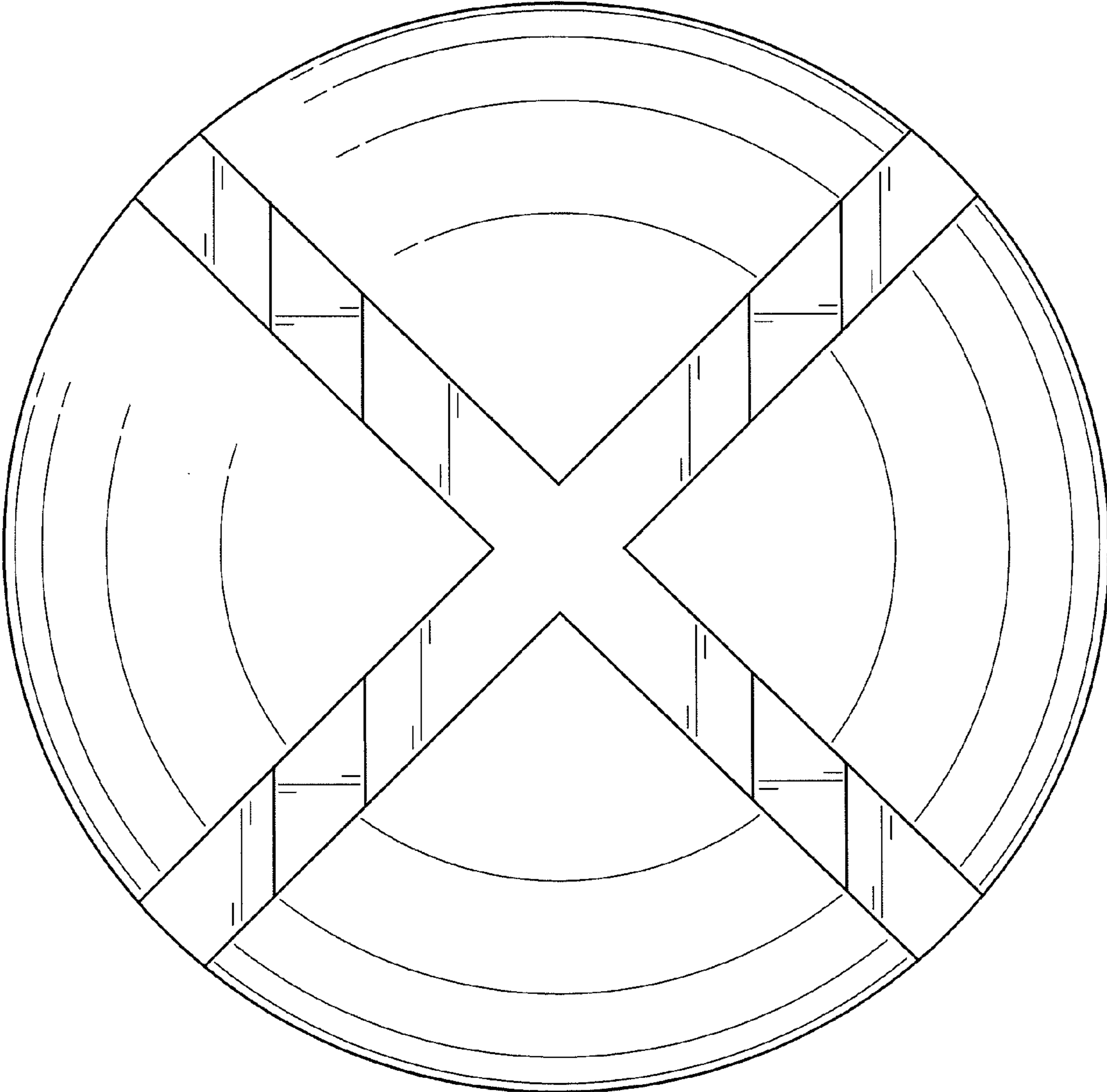

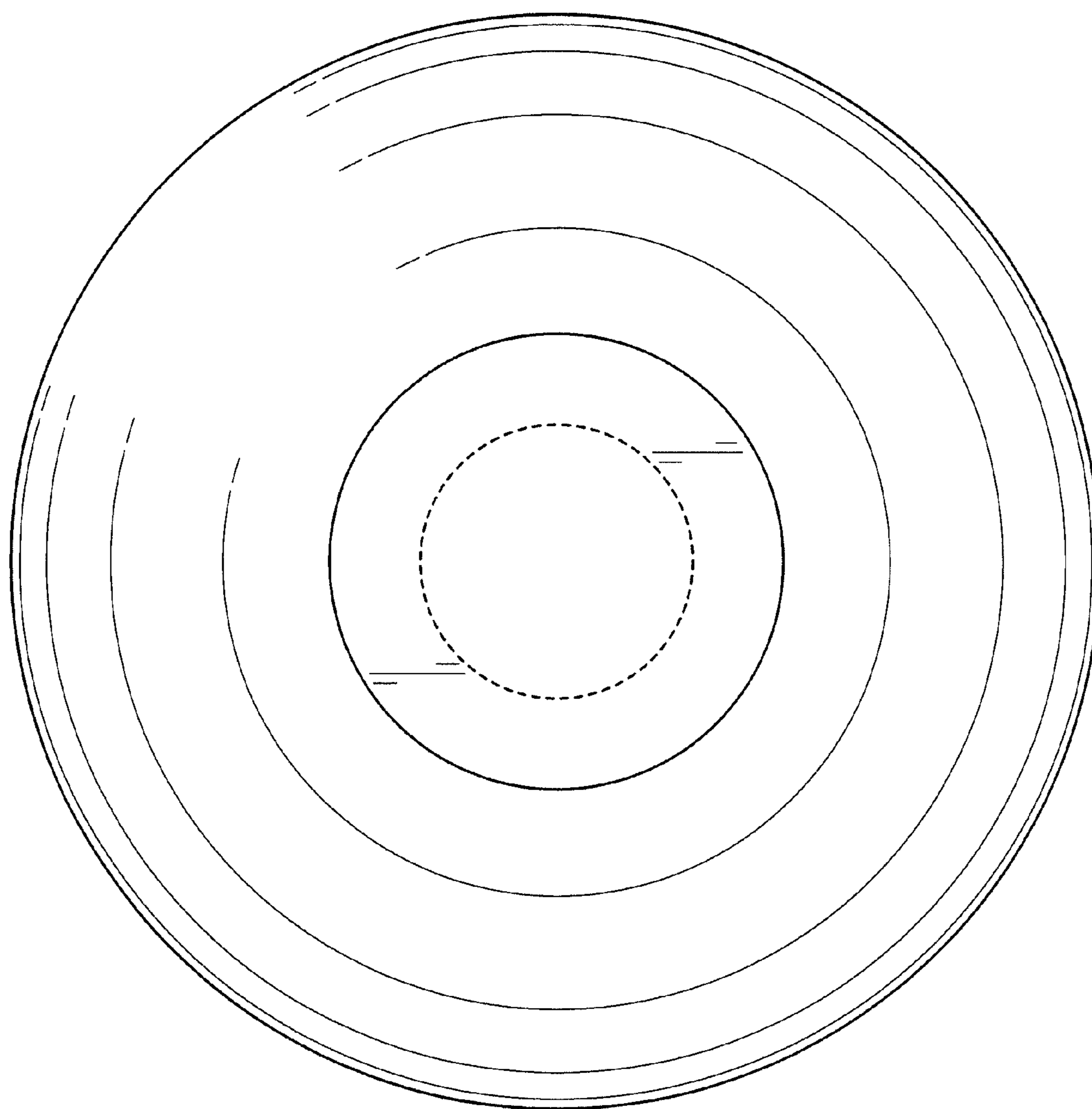

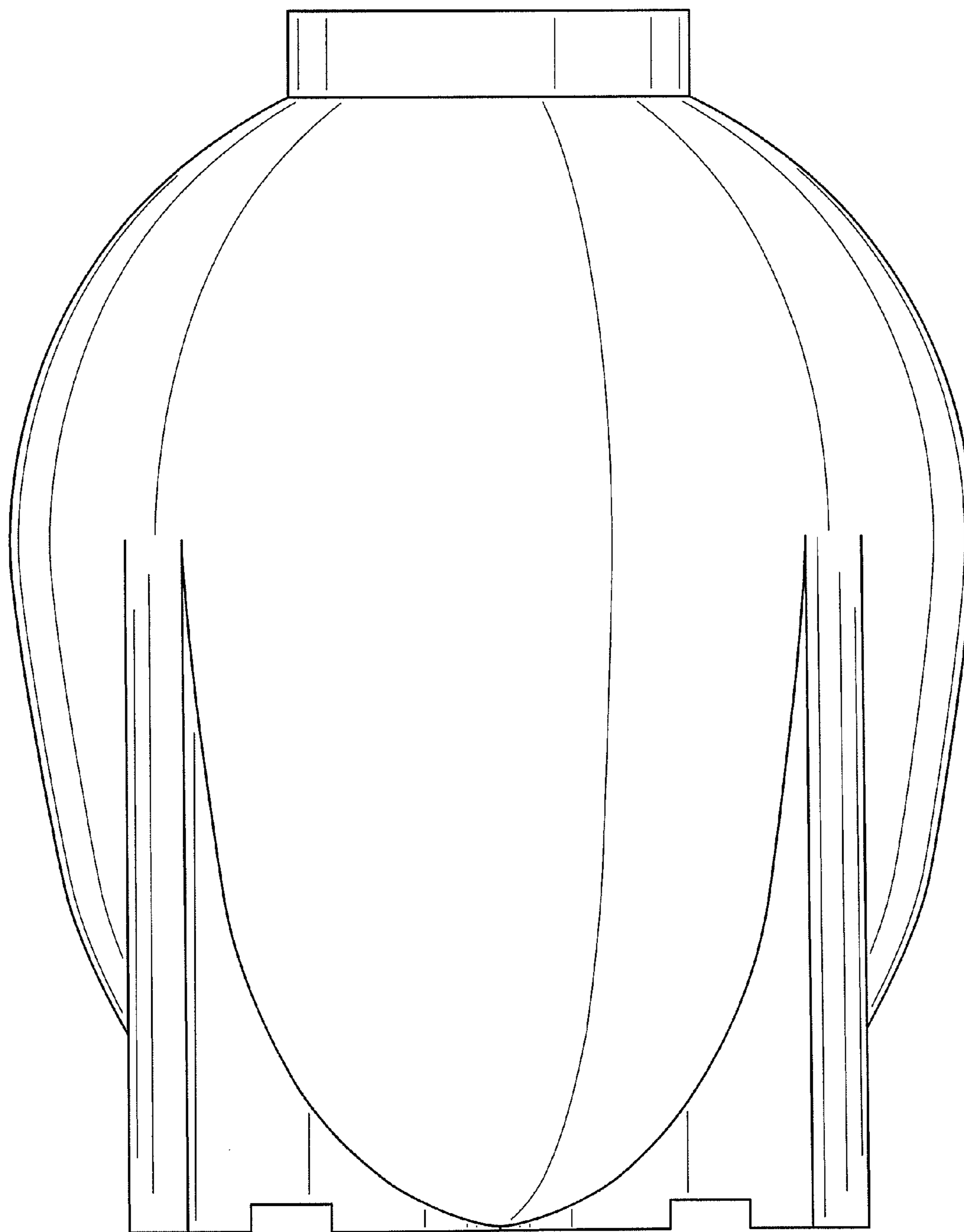

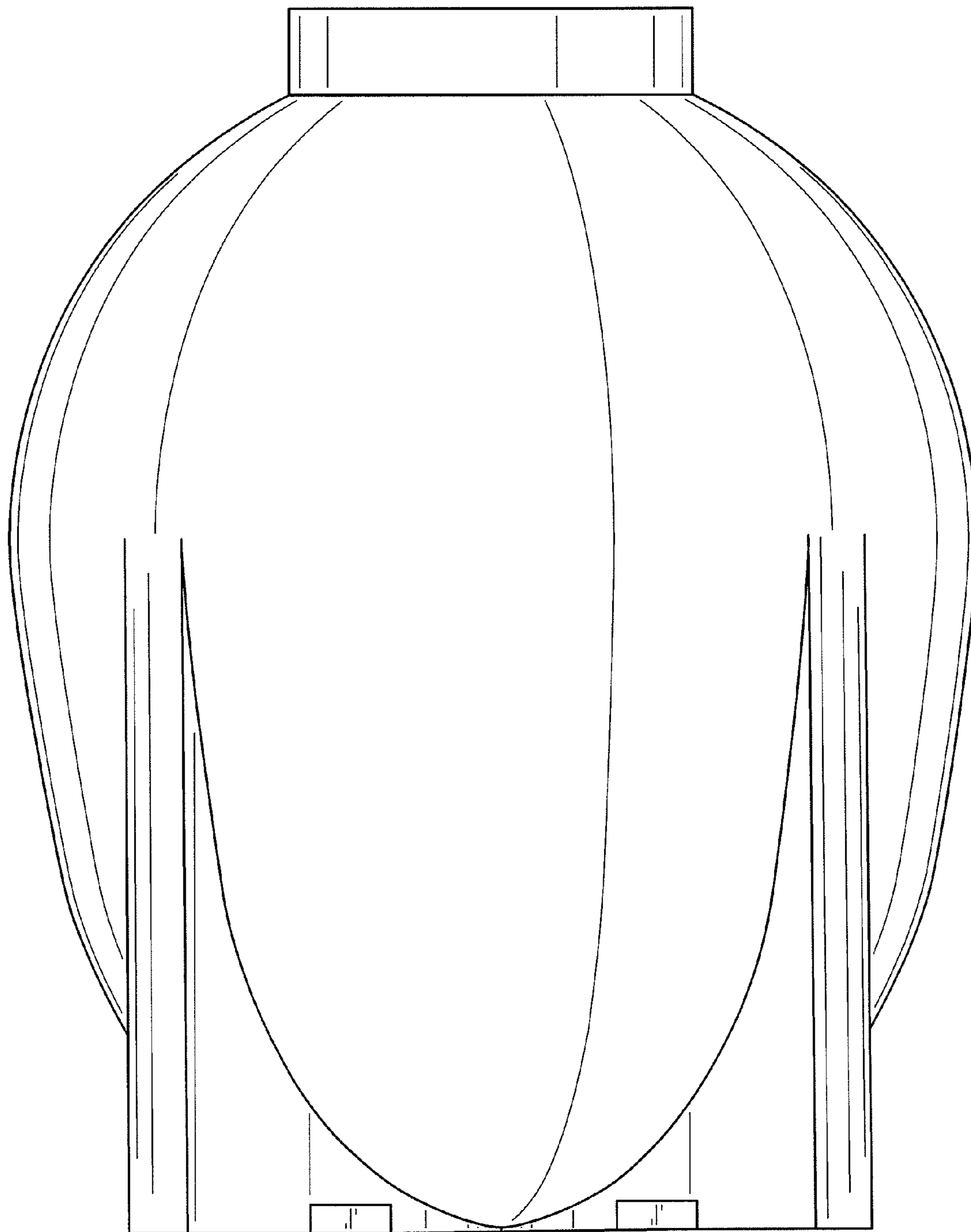

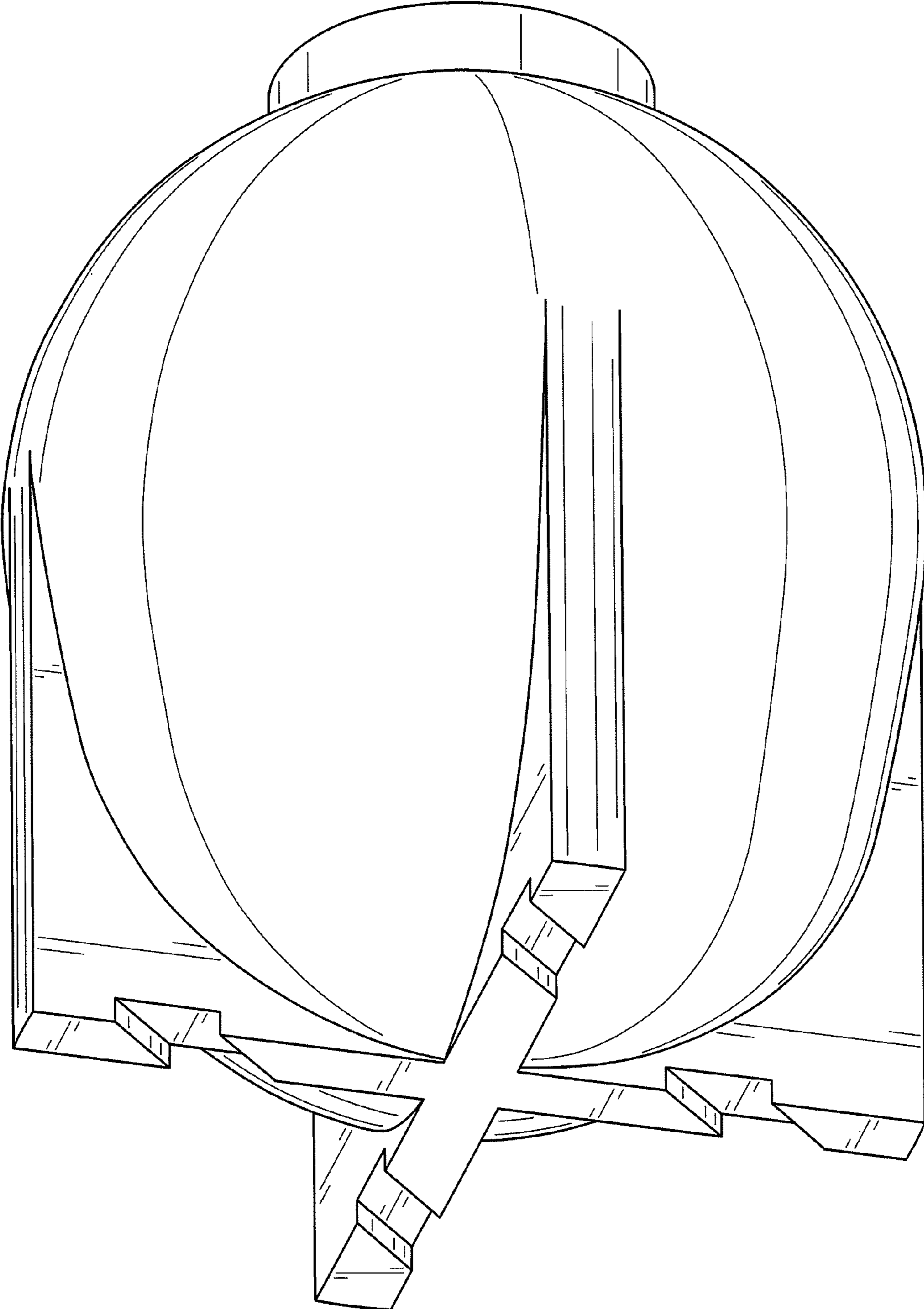

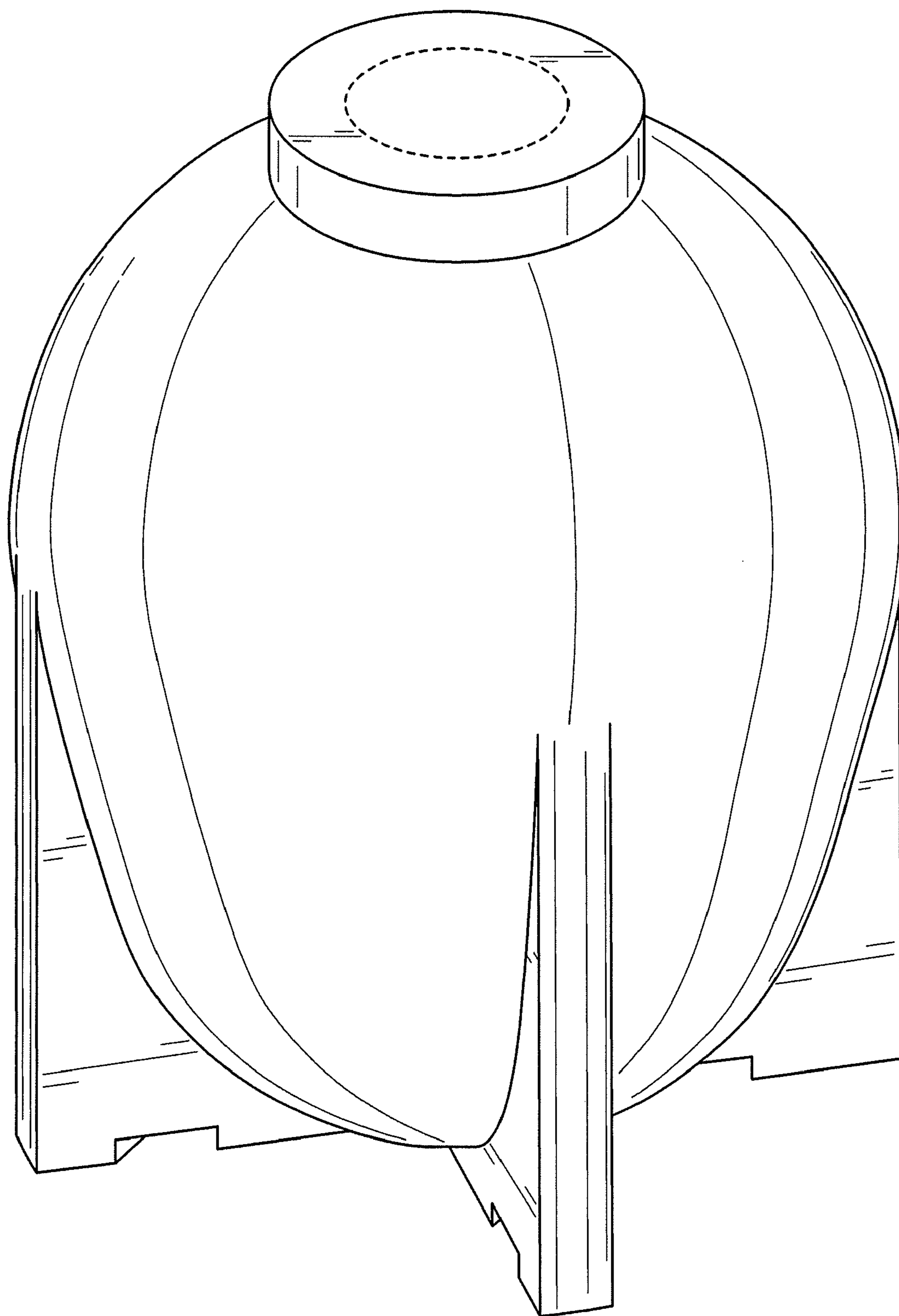

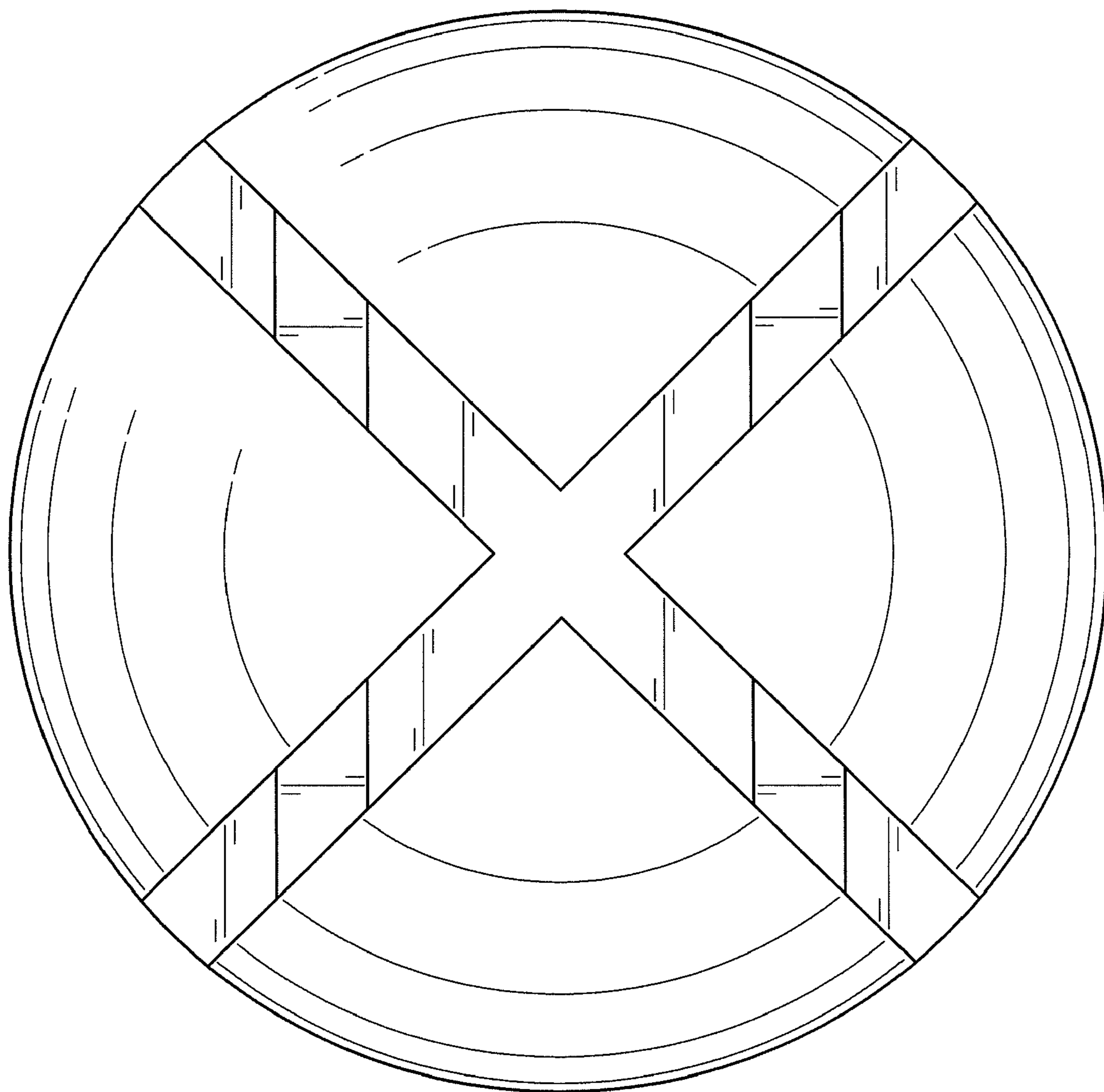

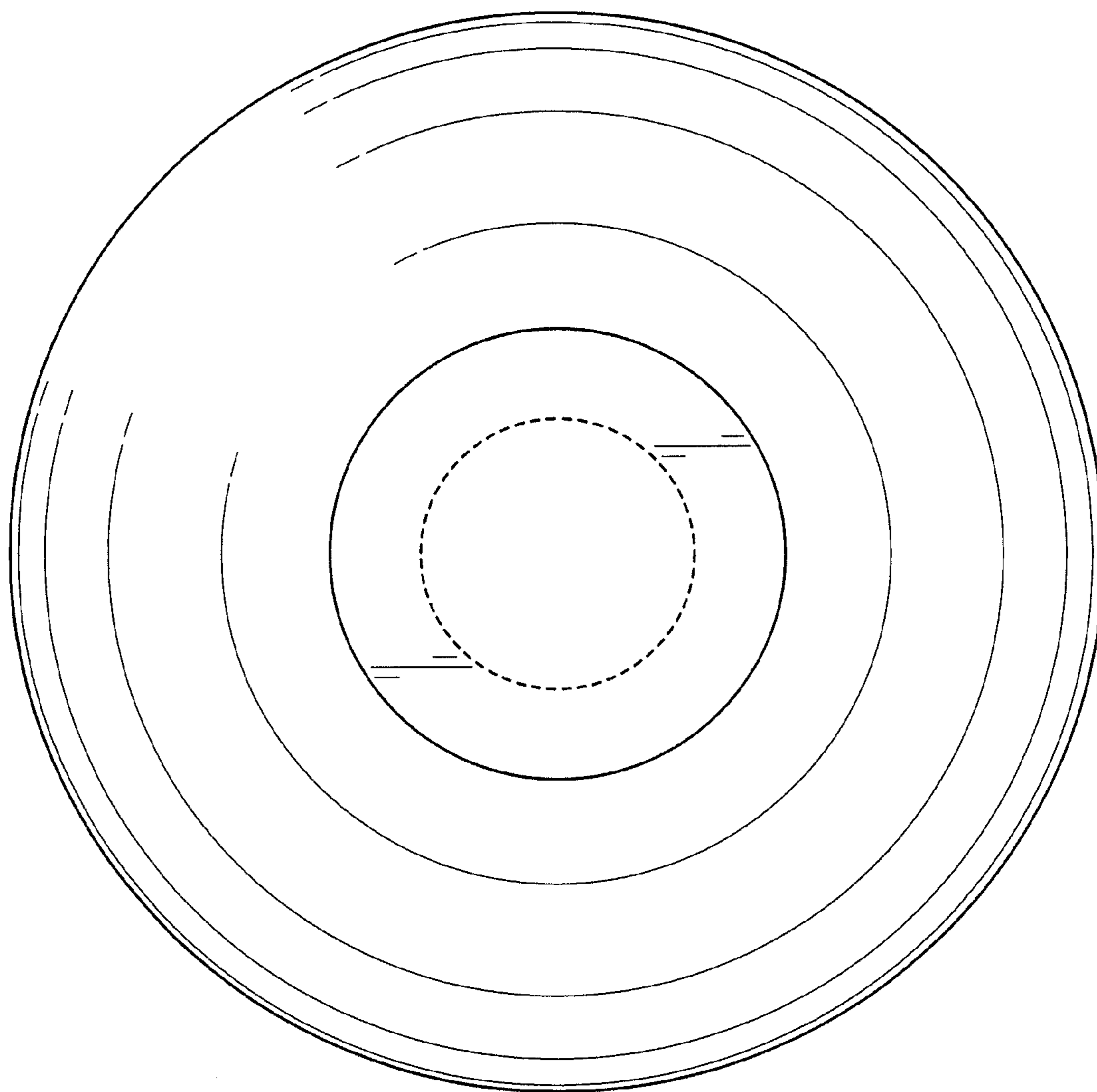

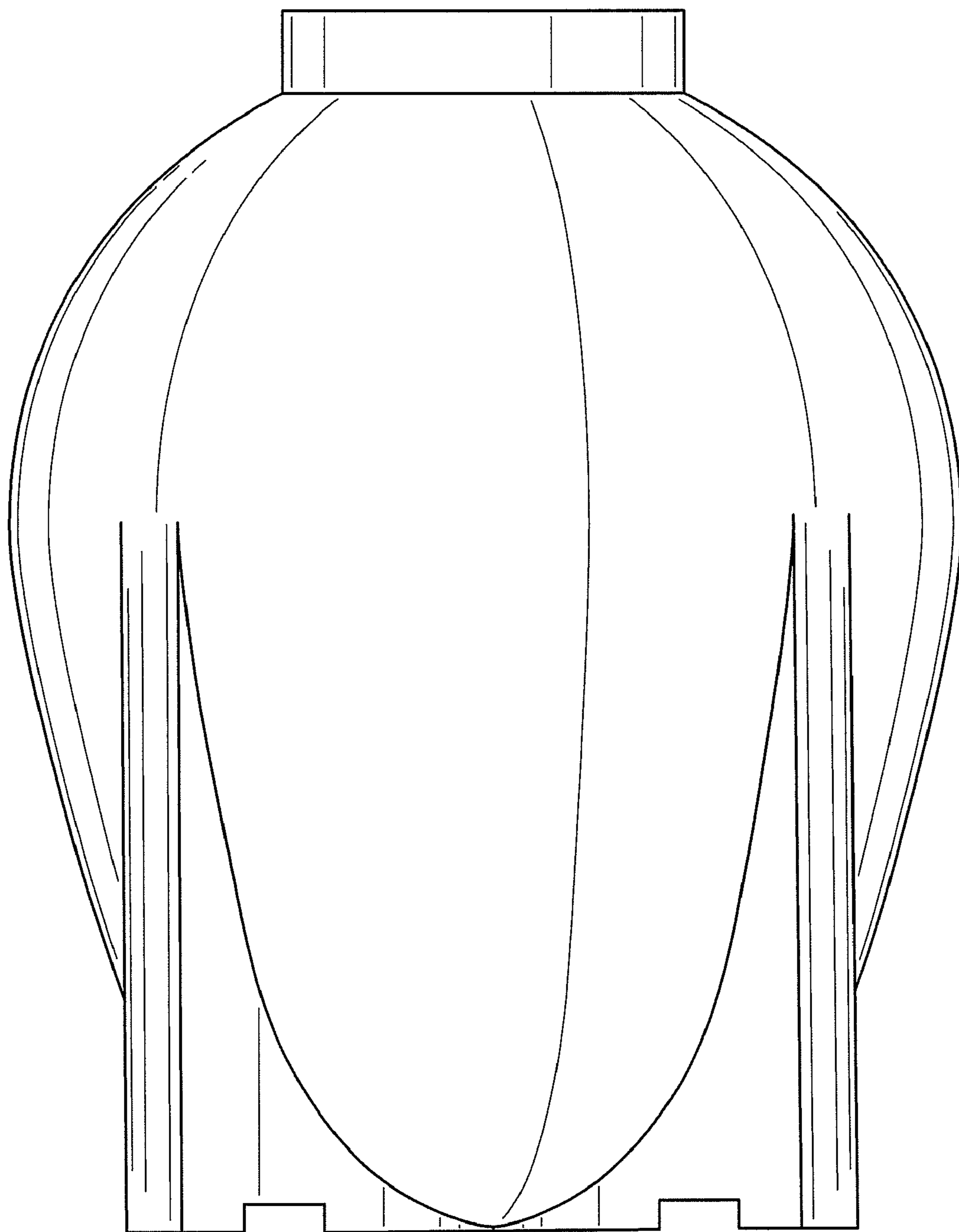

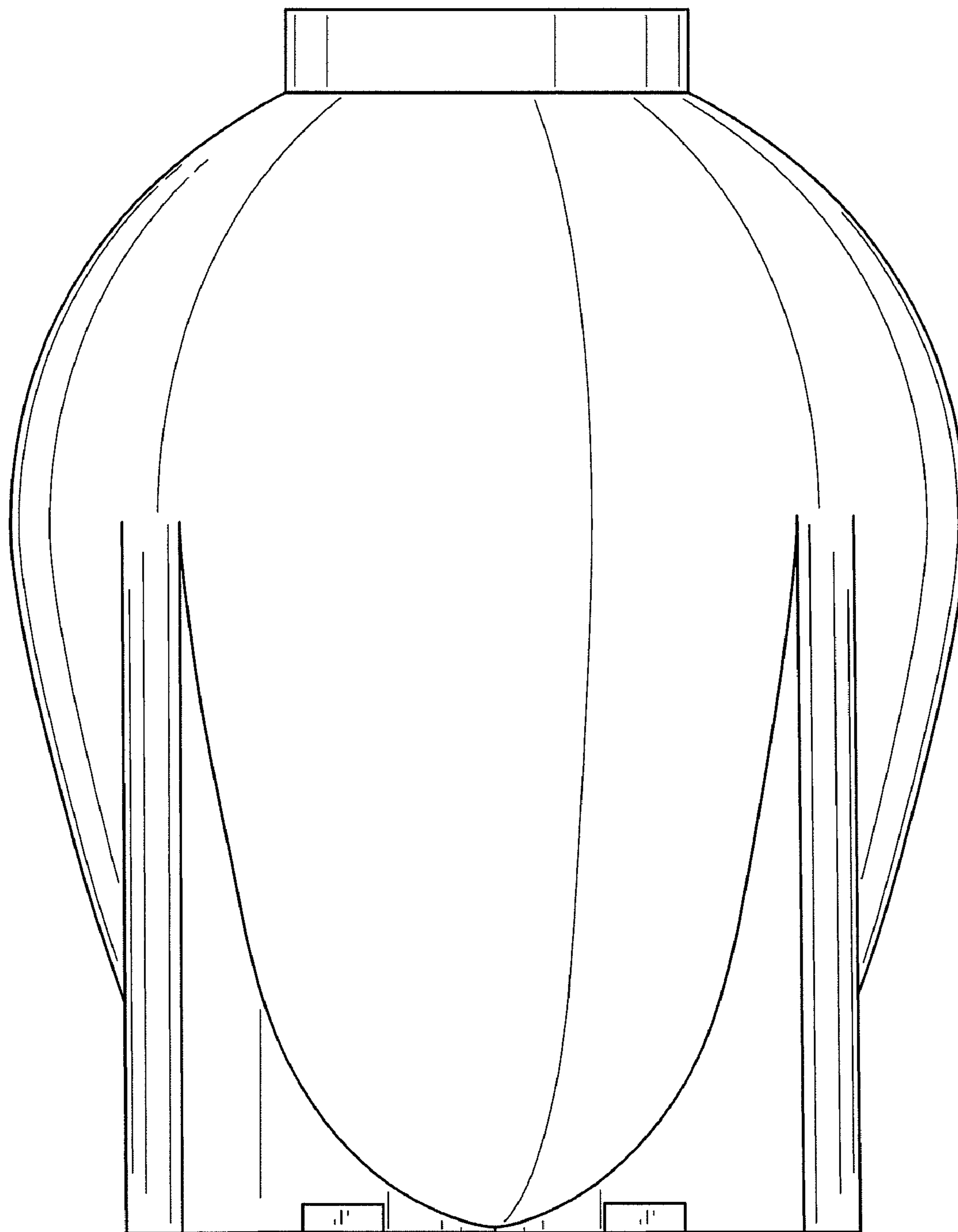

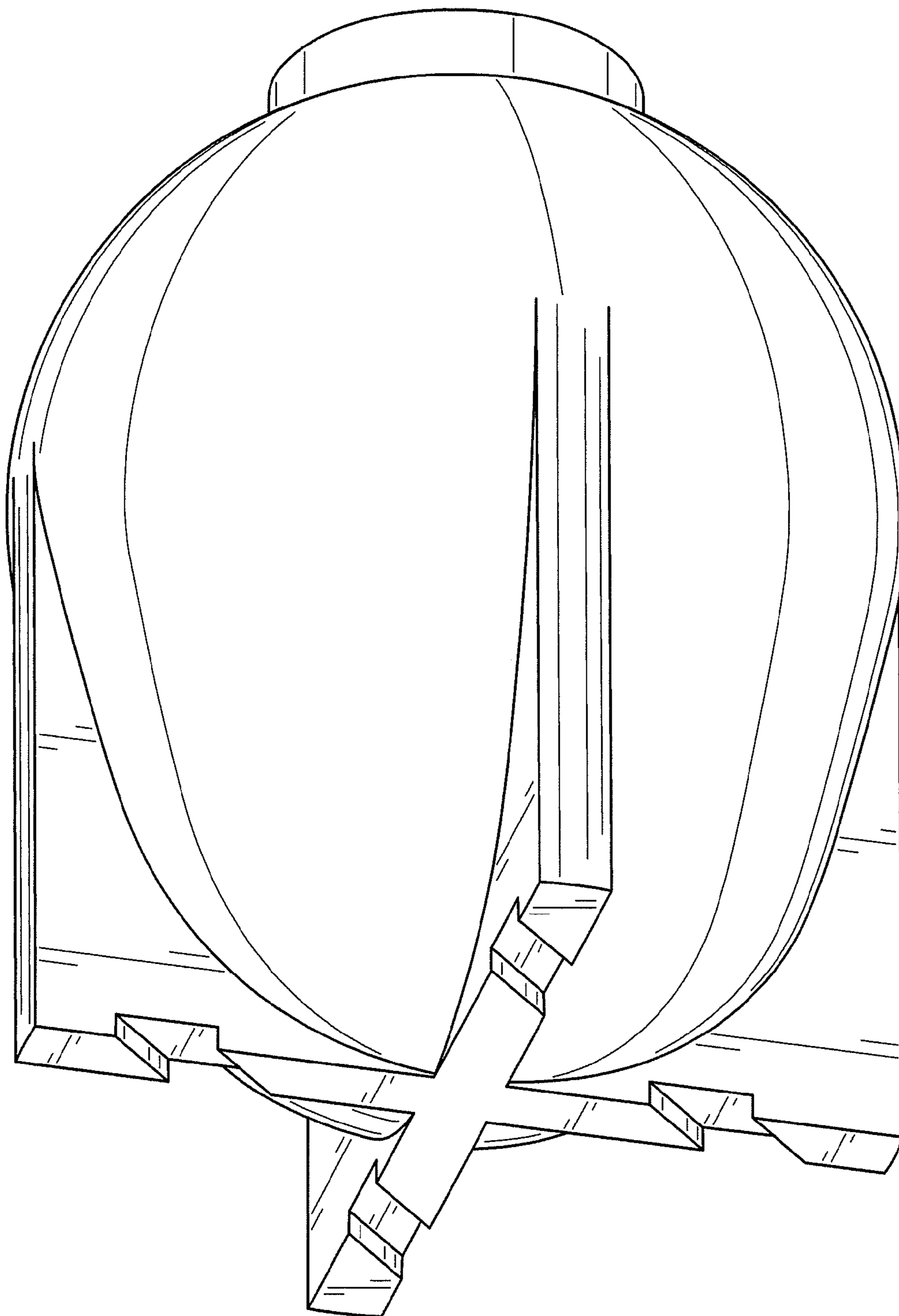

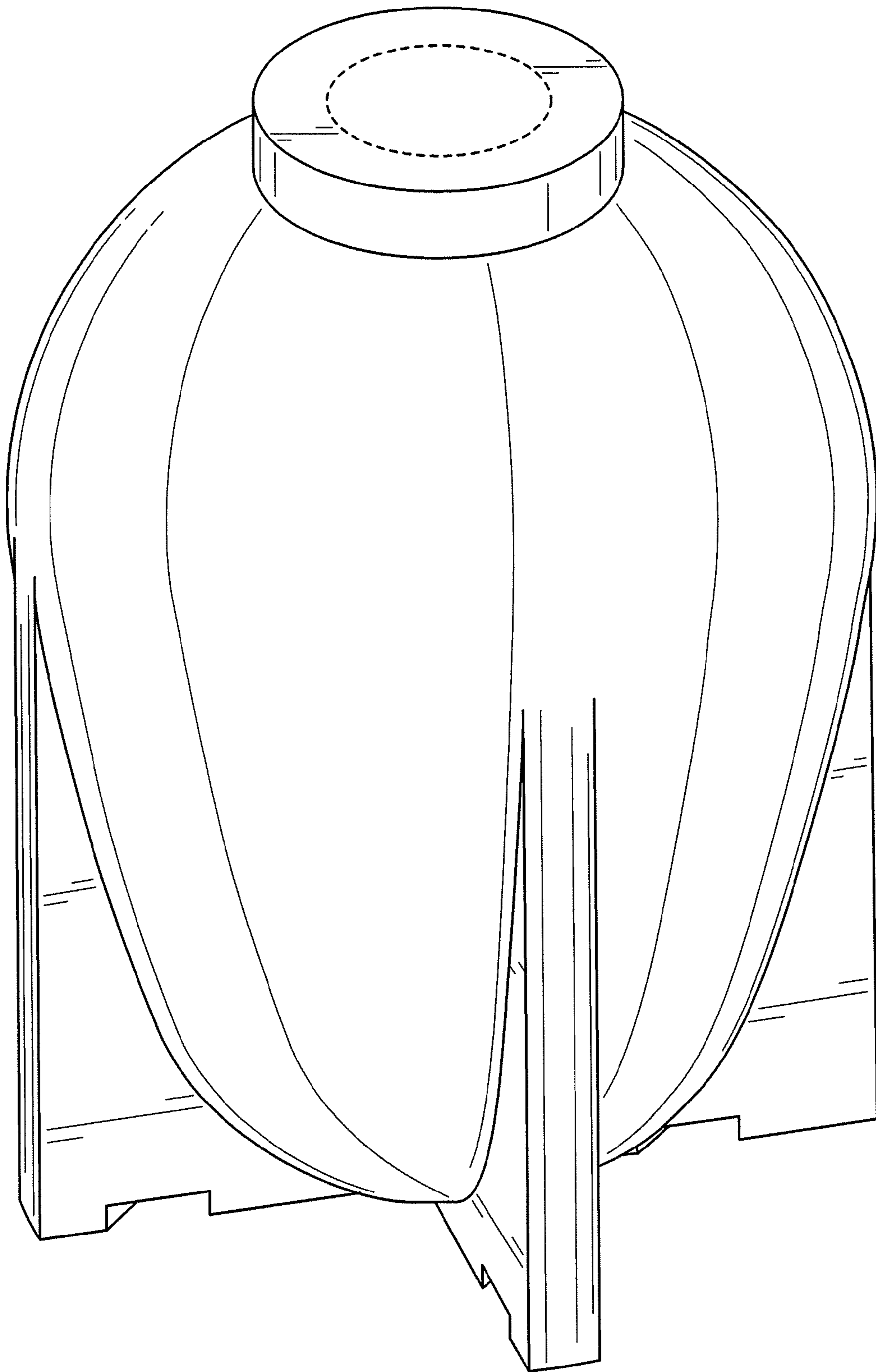

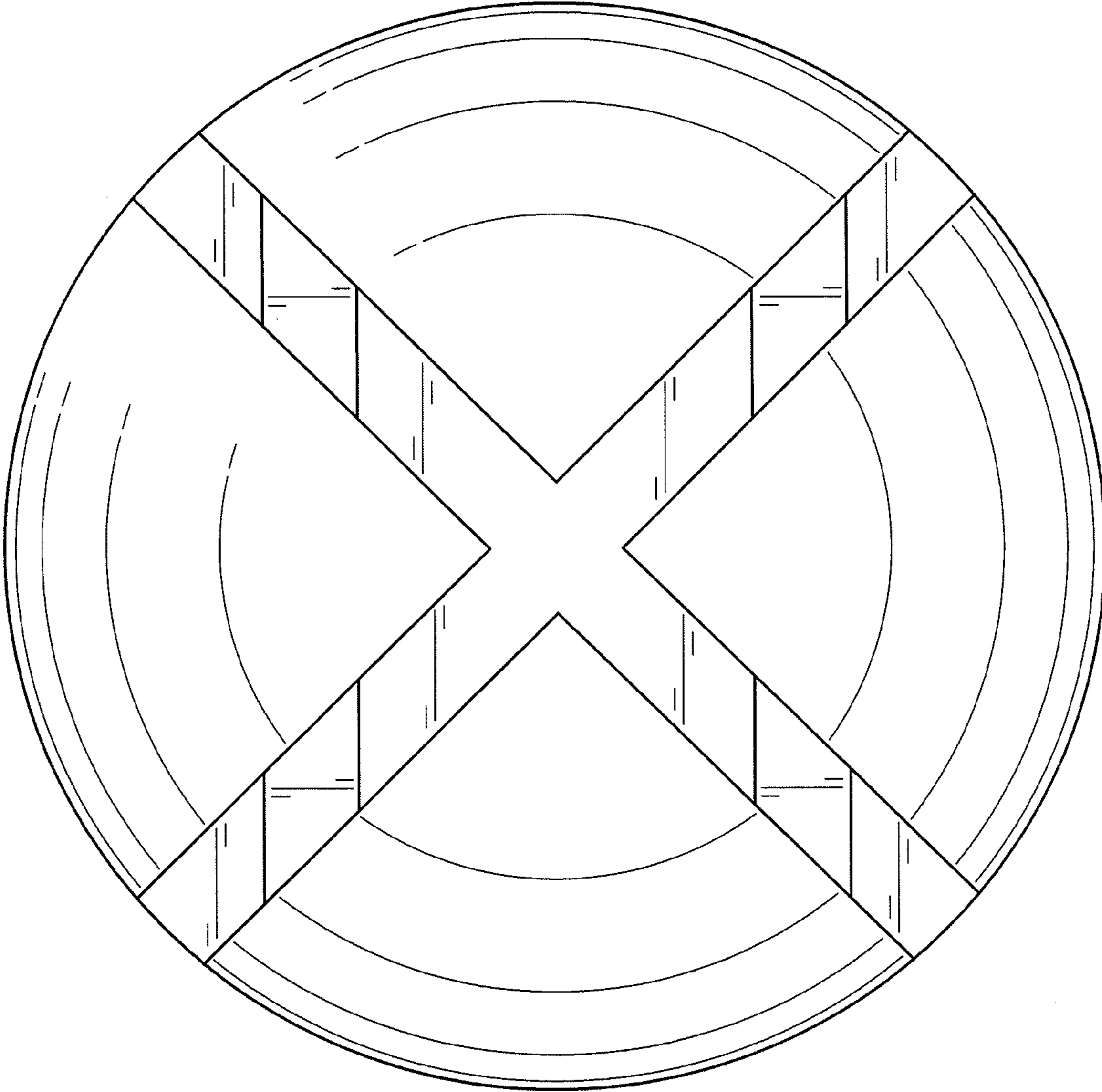

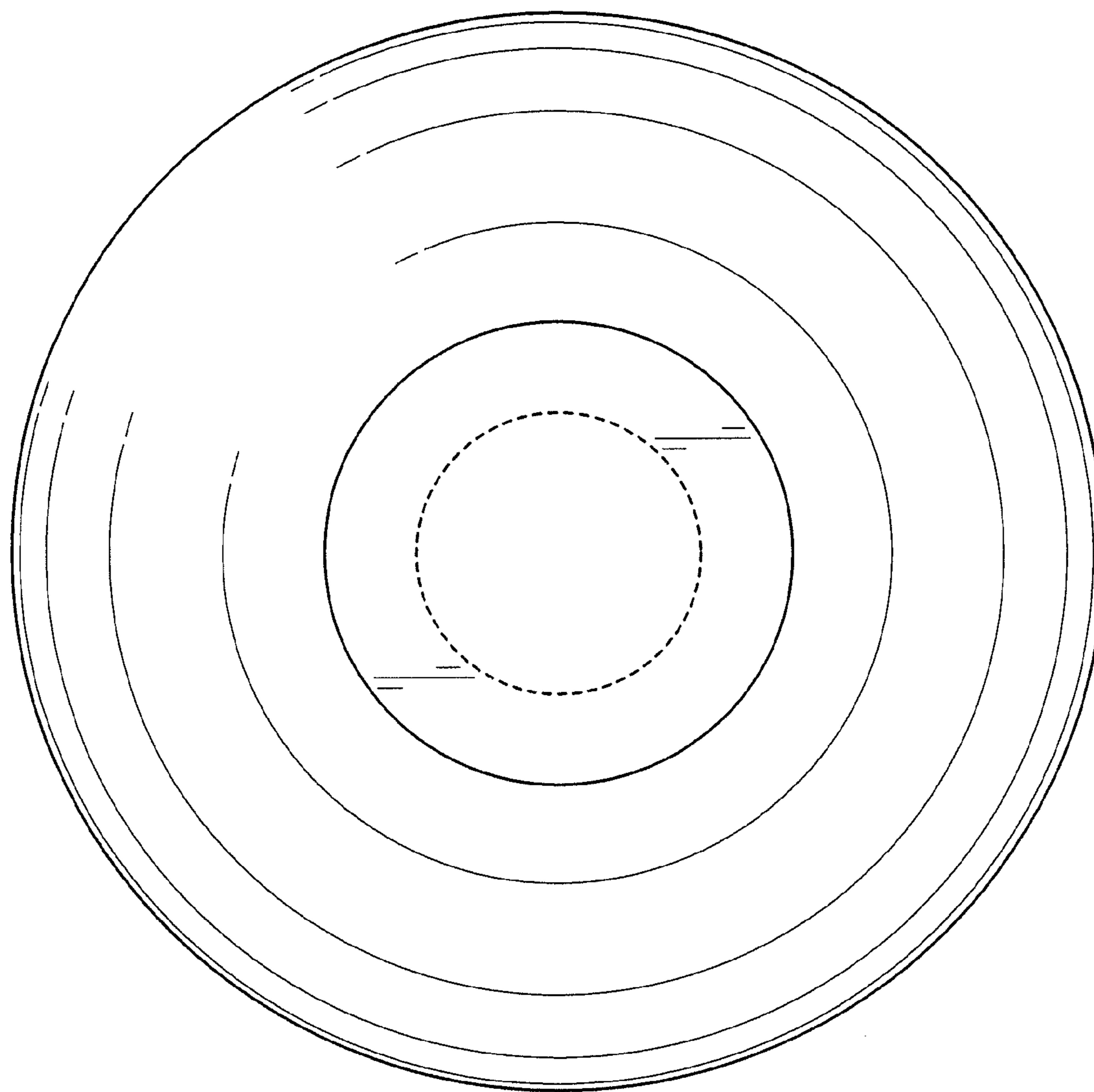

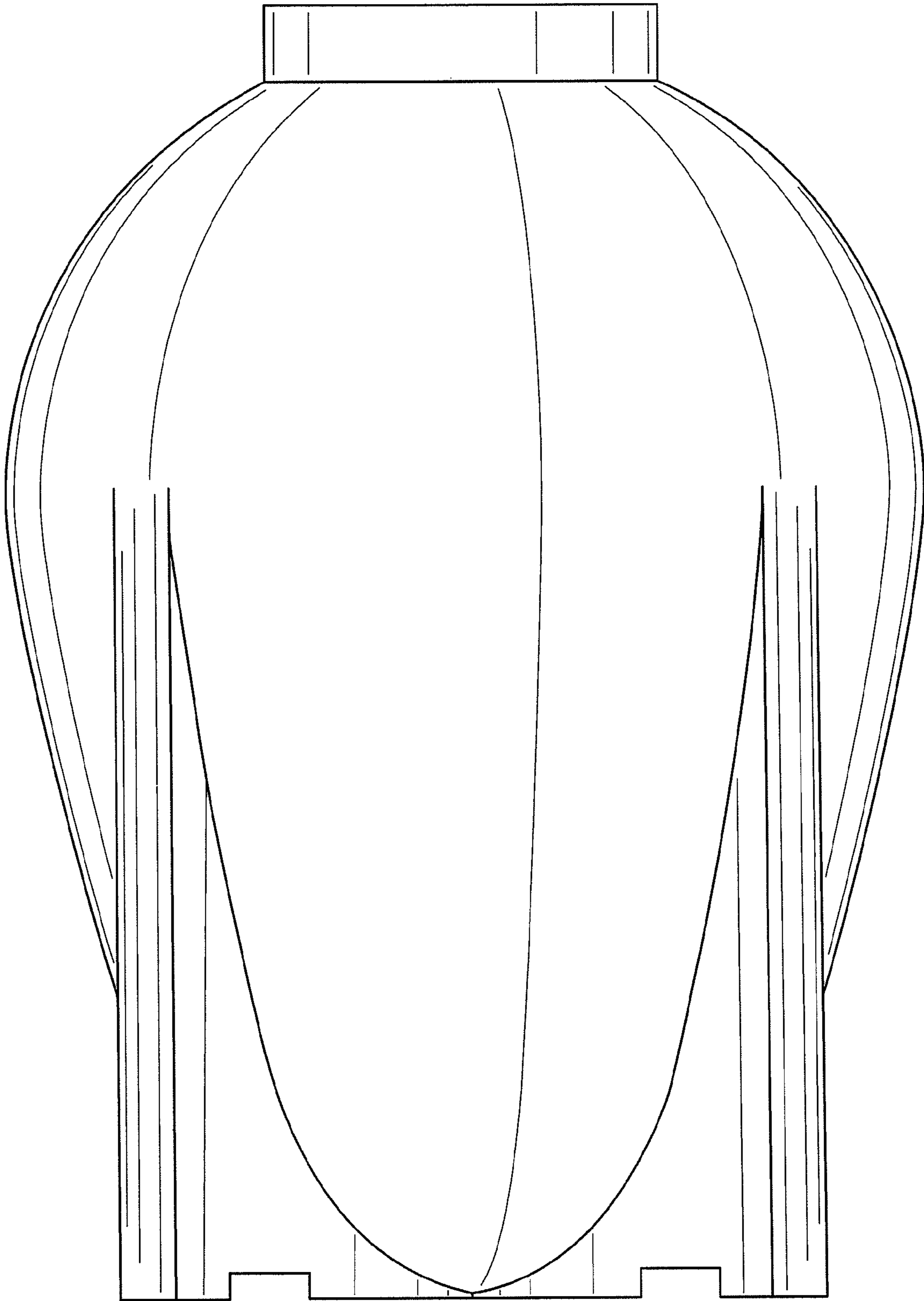

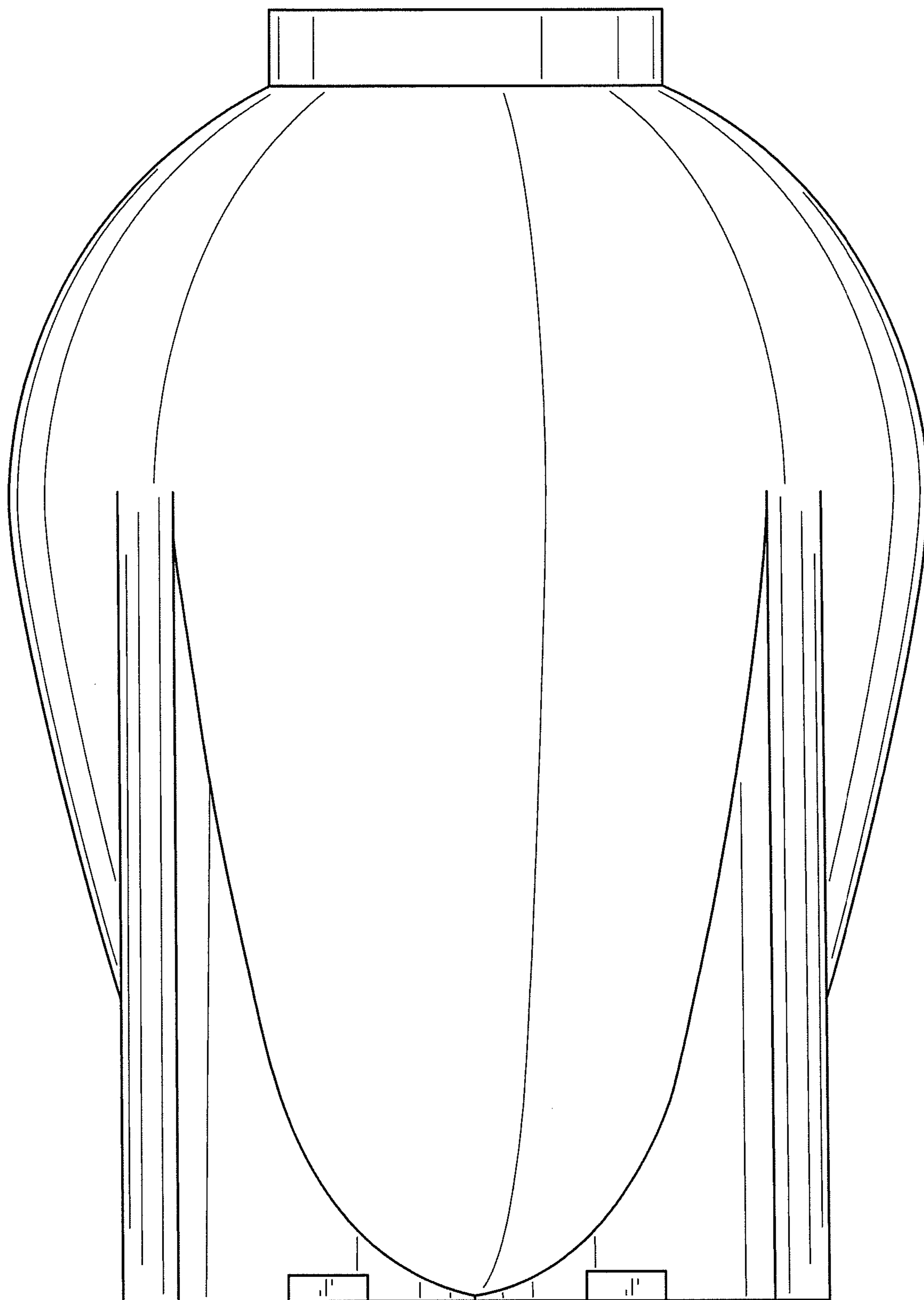

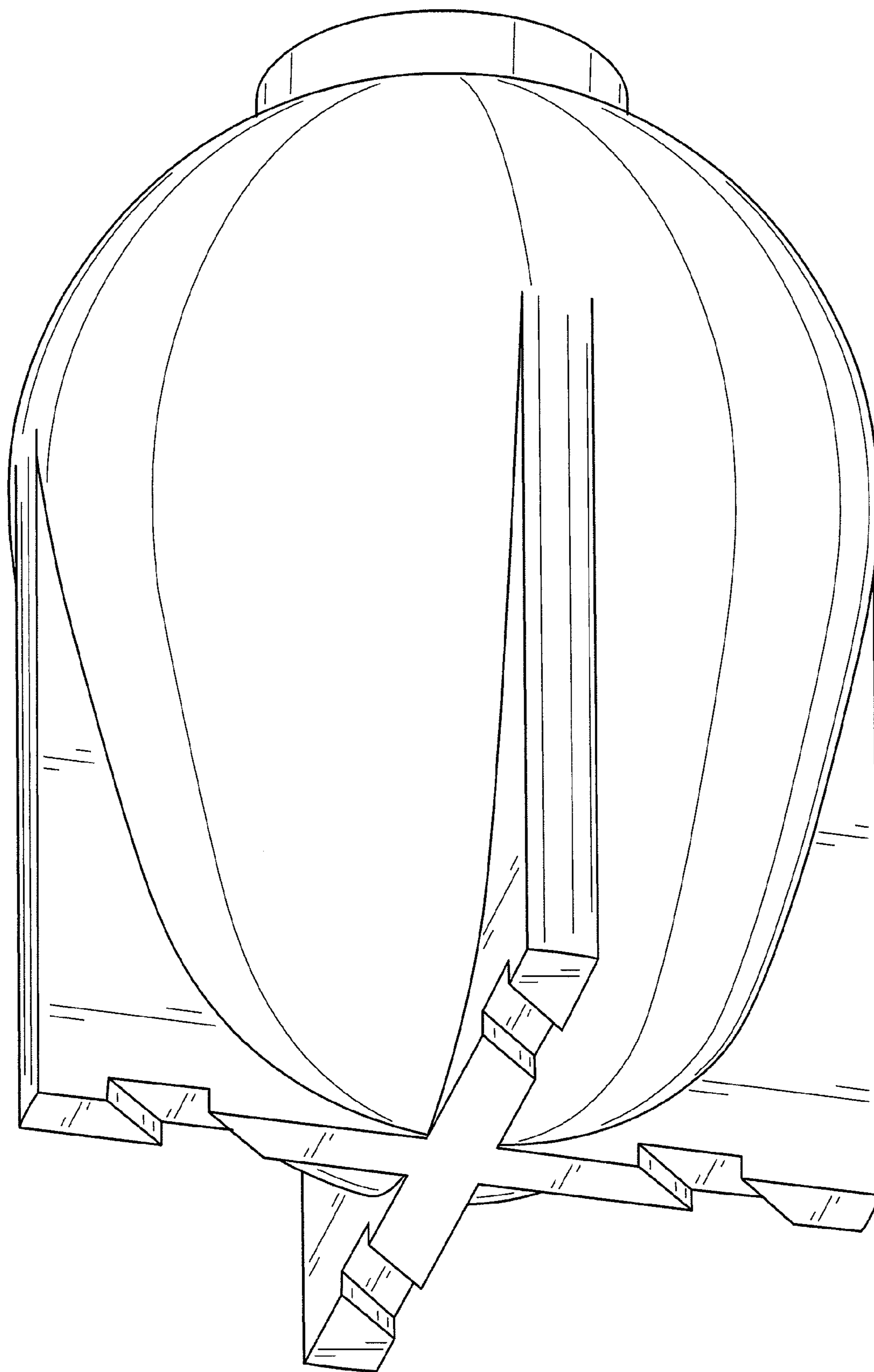
