(57) **CLAIM**

The ornamental design for decorative butterflies and the placement of the decorative butterflies on a pair of shoes, as shown and described.

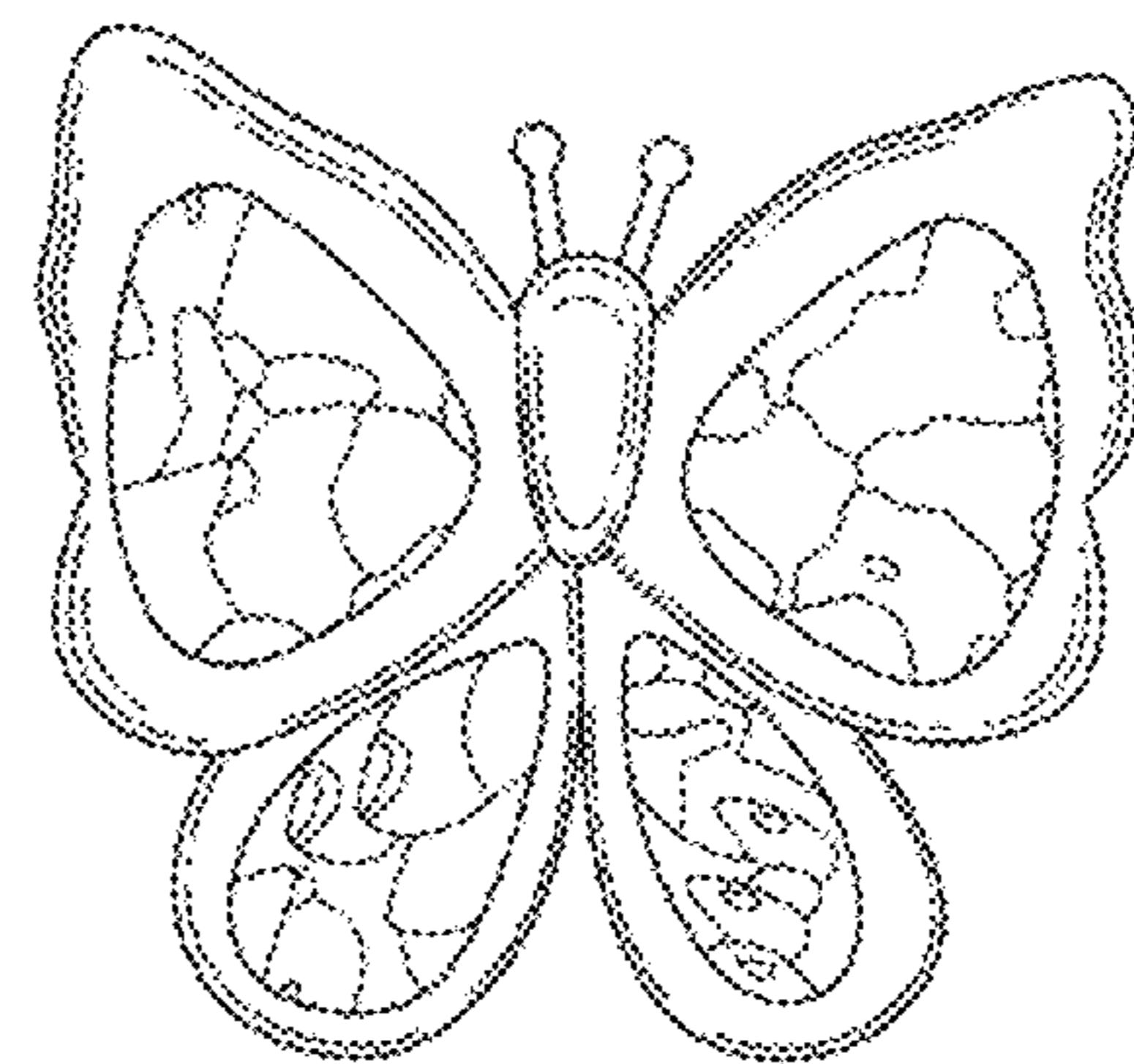
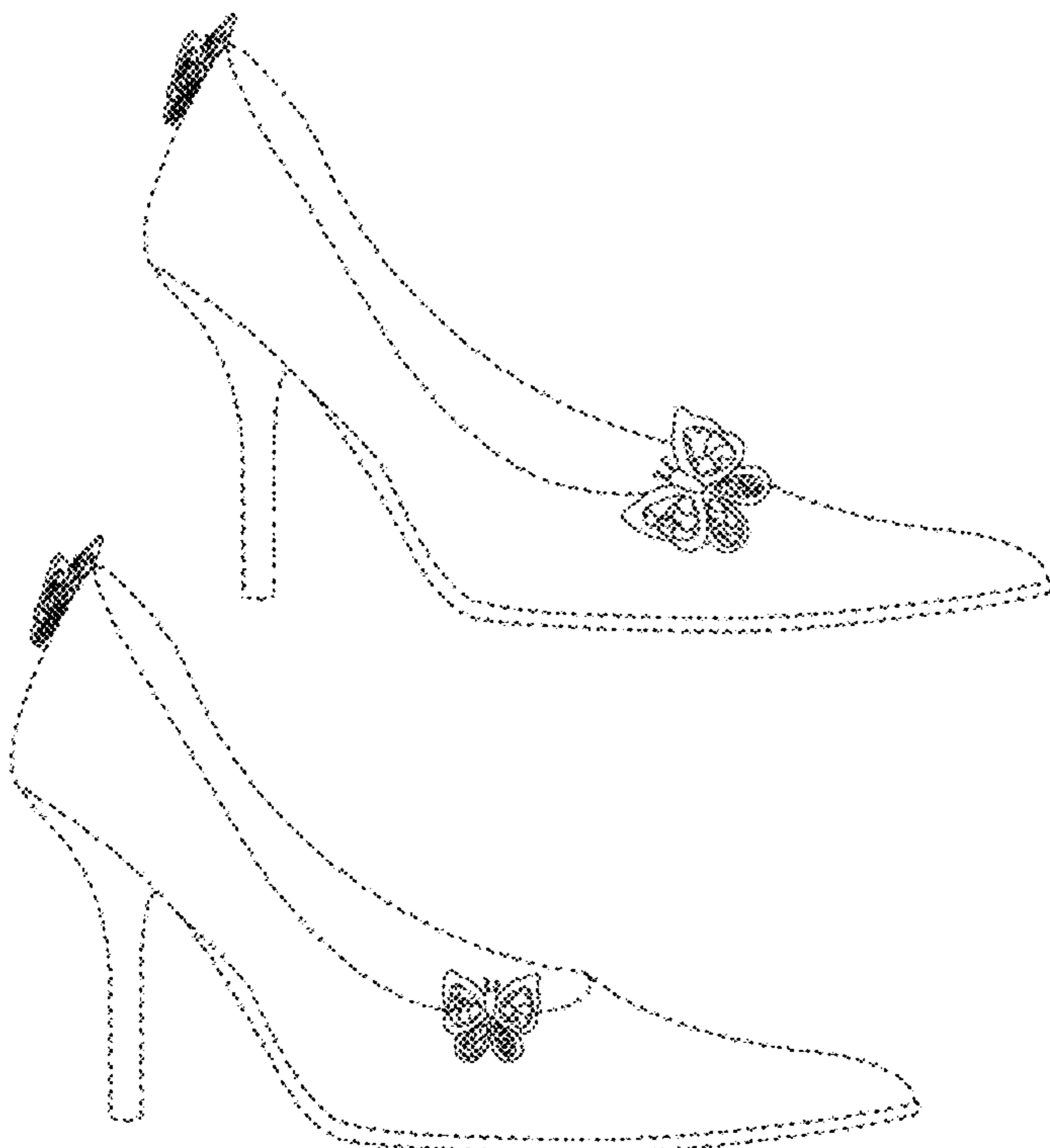

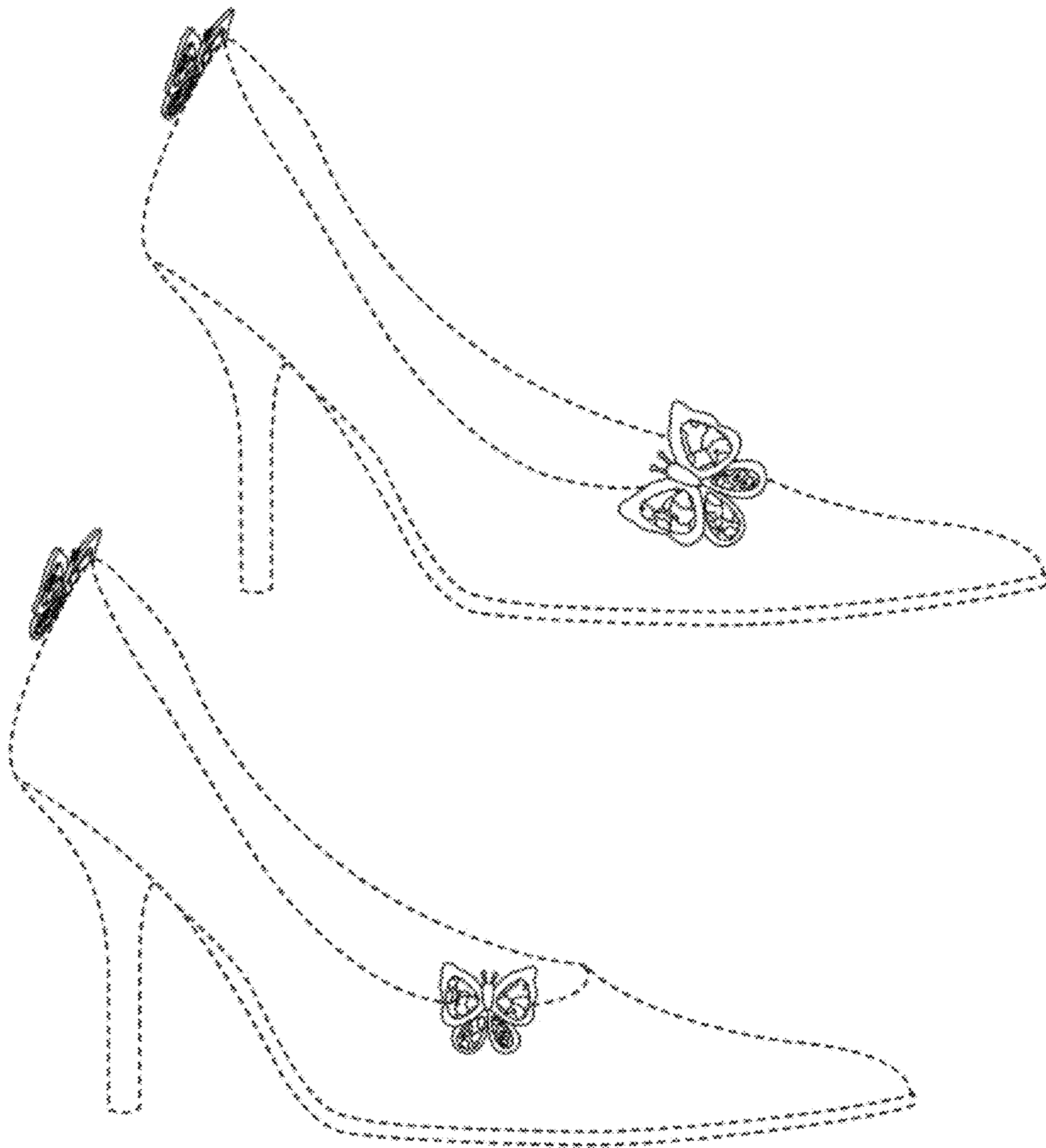

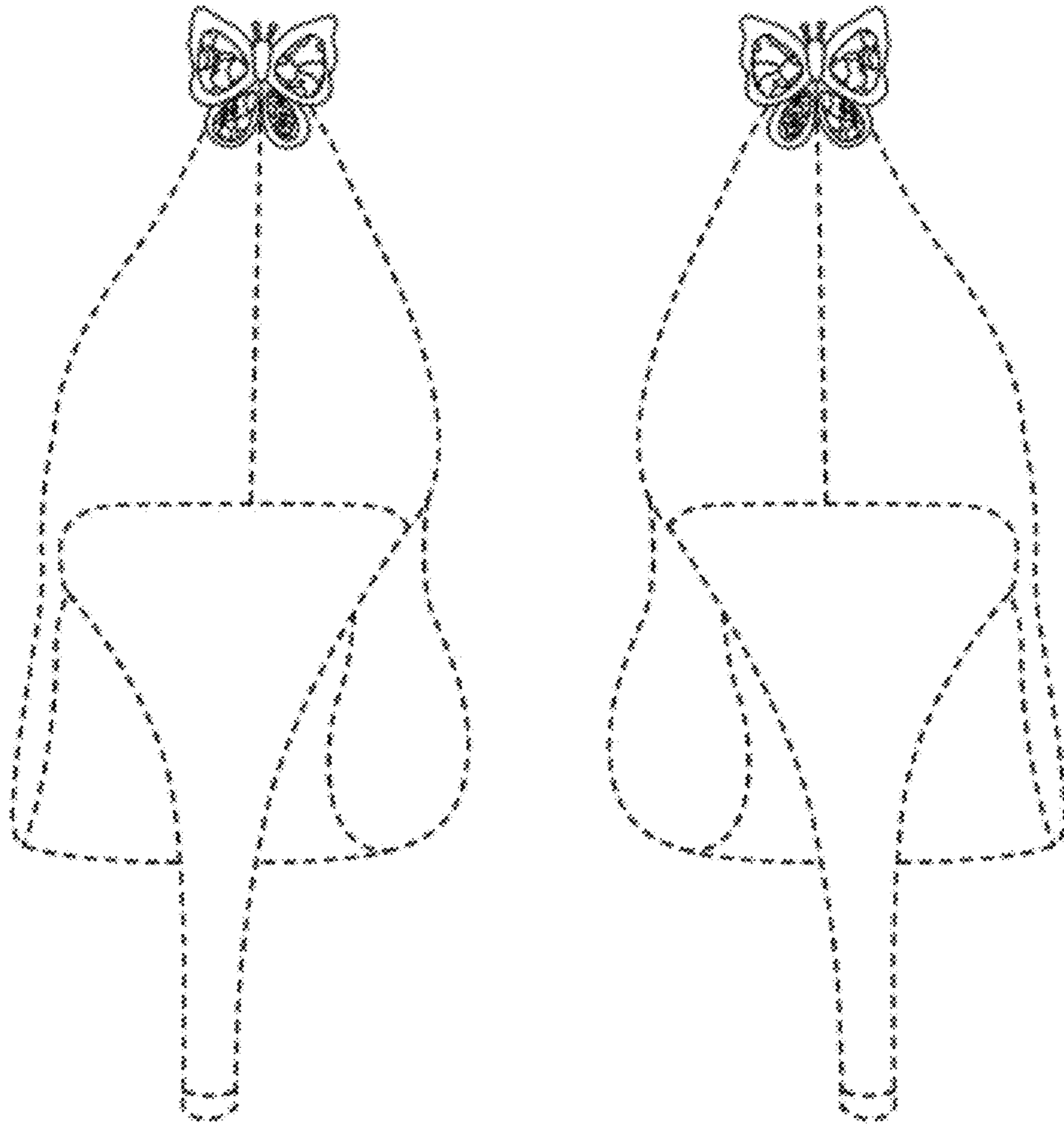

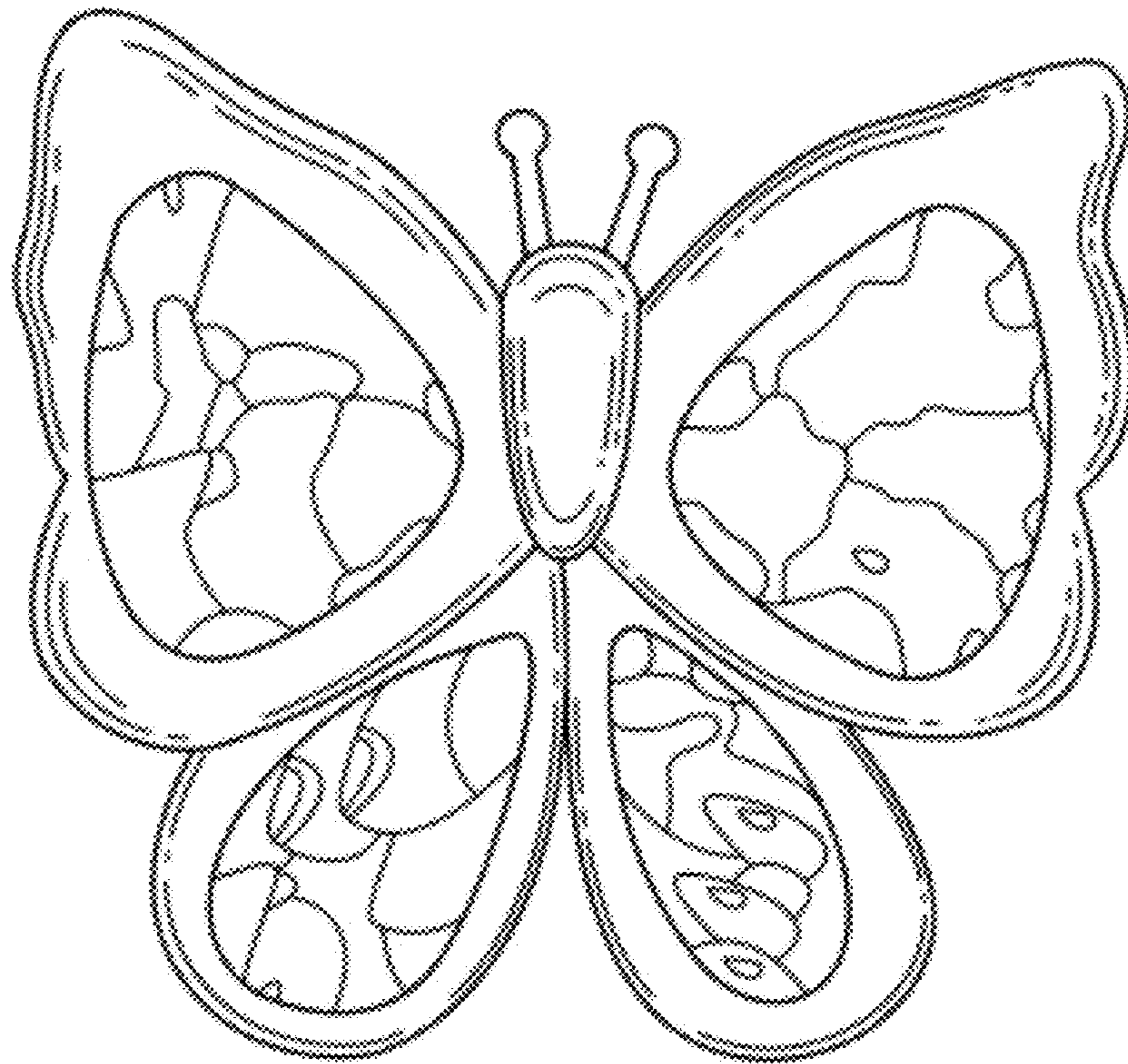
