DESCRIPTION

FIG. 1 is a front perspective view of a seat, showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a side elevation view thereof taken from the right side of FIG. 3;
FIG. 5 is an opposite side elevation view thereof taken from the left side of FIG. 3;

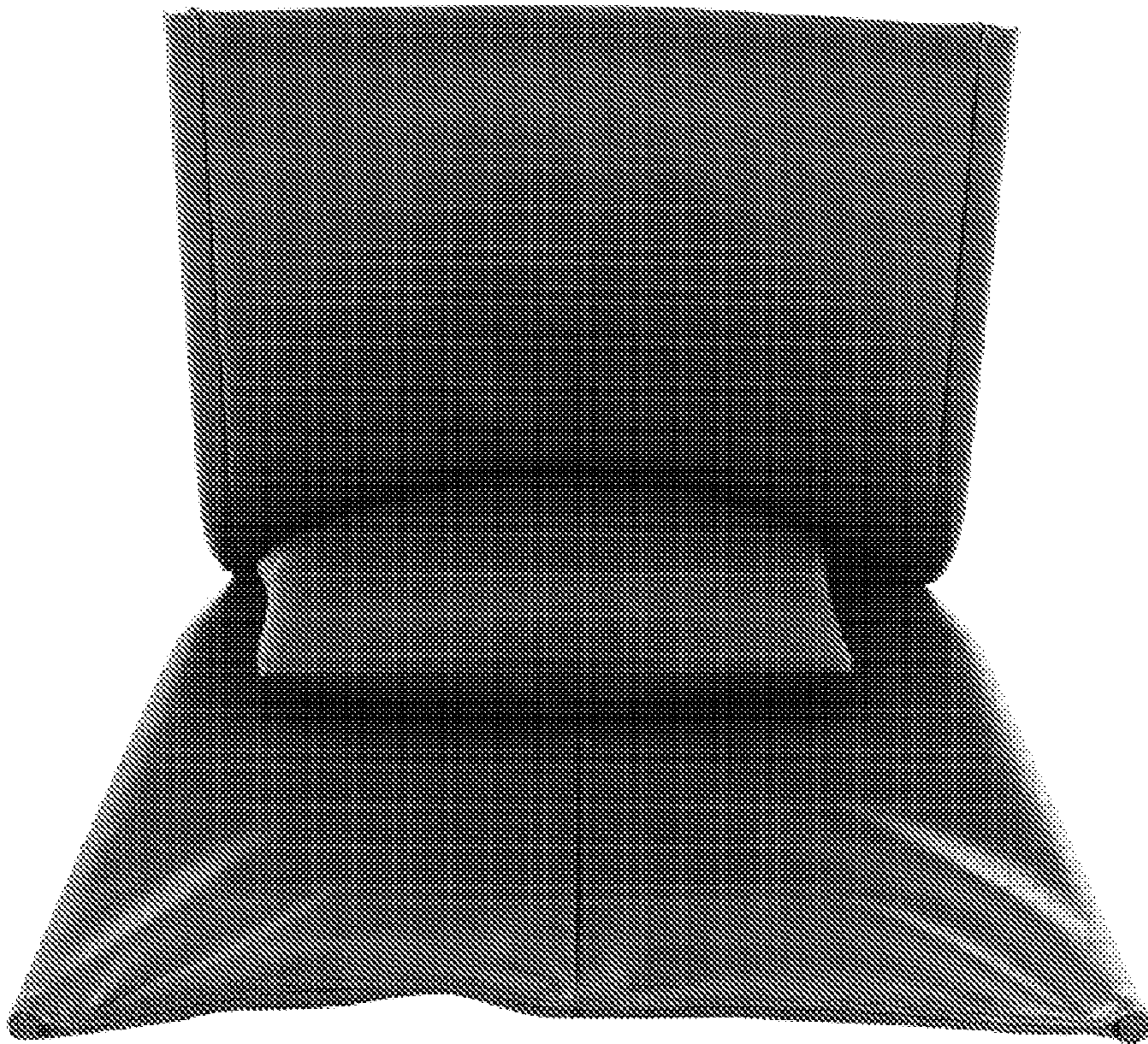
