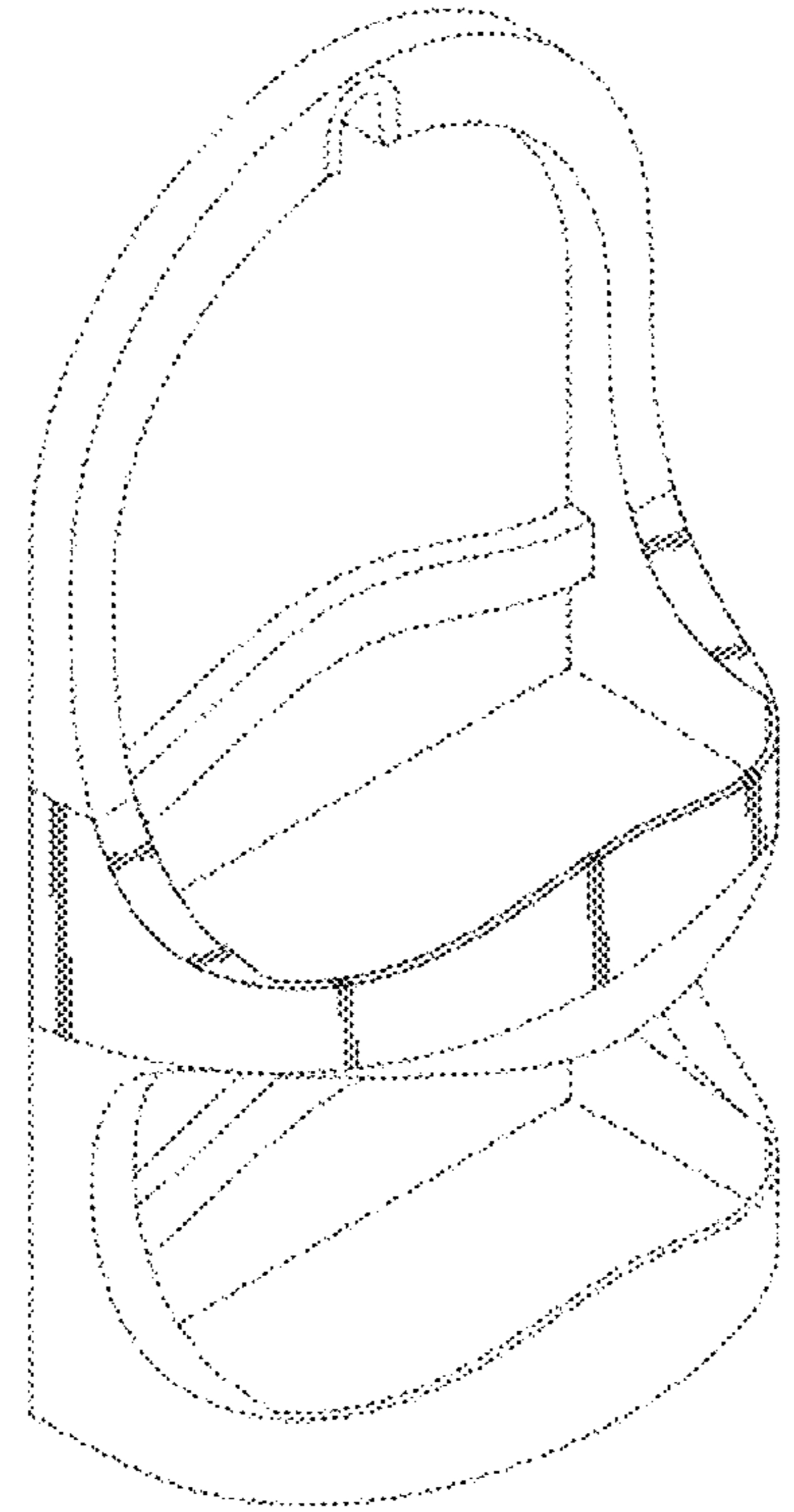
(57) **CLAIM**
The ornamental design for a shower caddy portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shower caddy portion of the new design;
FIG. 2 is a front elevational view of the shower caddy portion of the new design;
FIG. 3 is a left side elevational view of the shower caddy portion of the new design, the right side elevational view being a mirror image thereof; and,
FIG. 4 is a top plan view of the shower caddy portion of the new design.

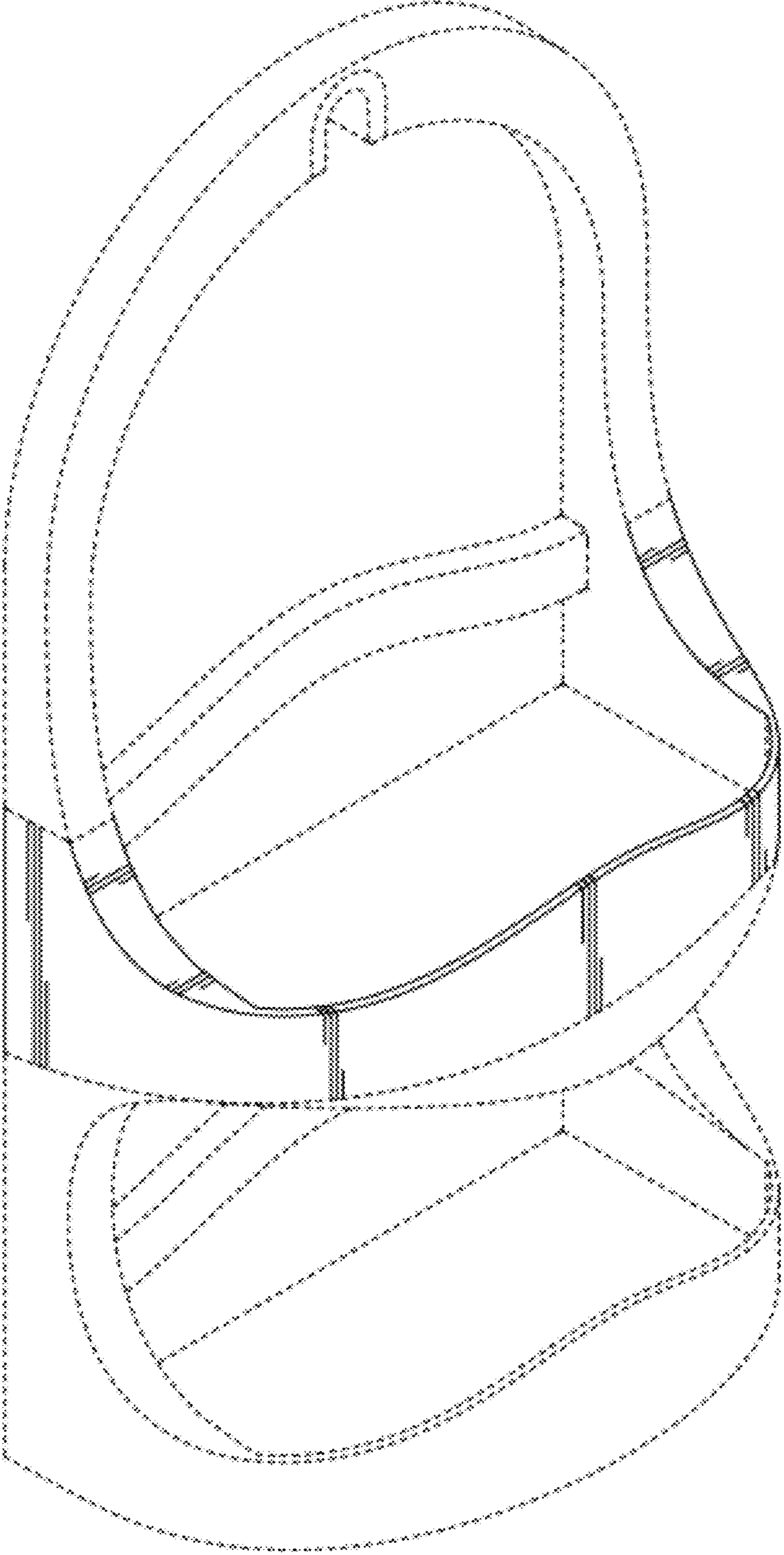

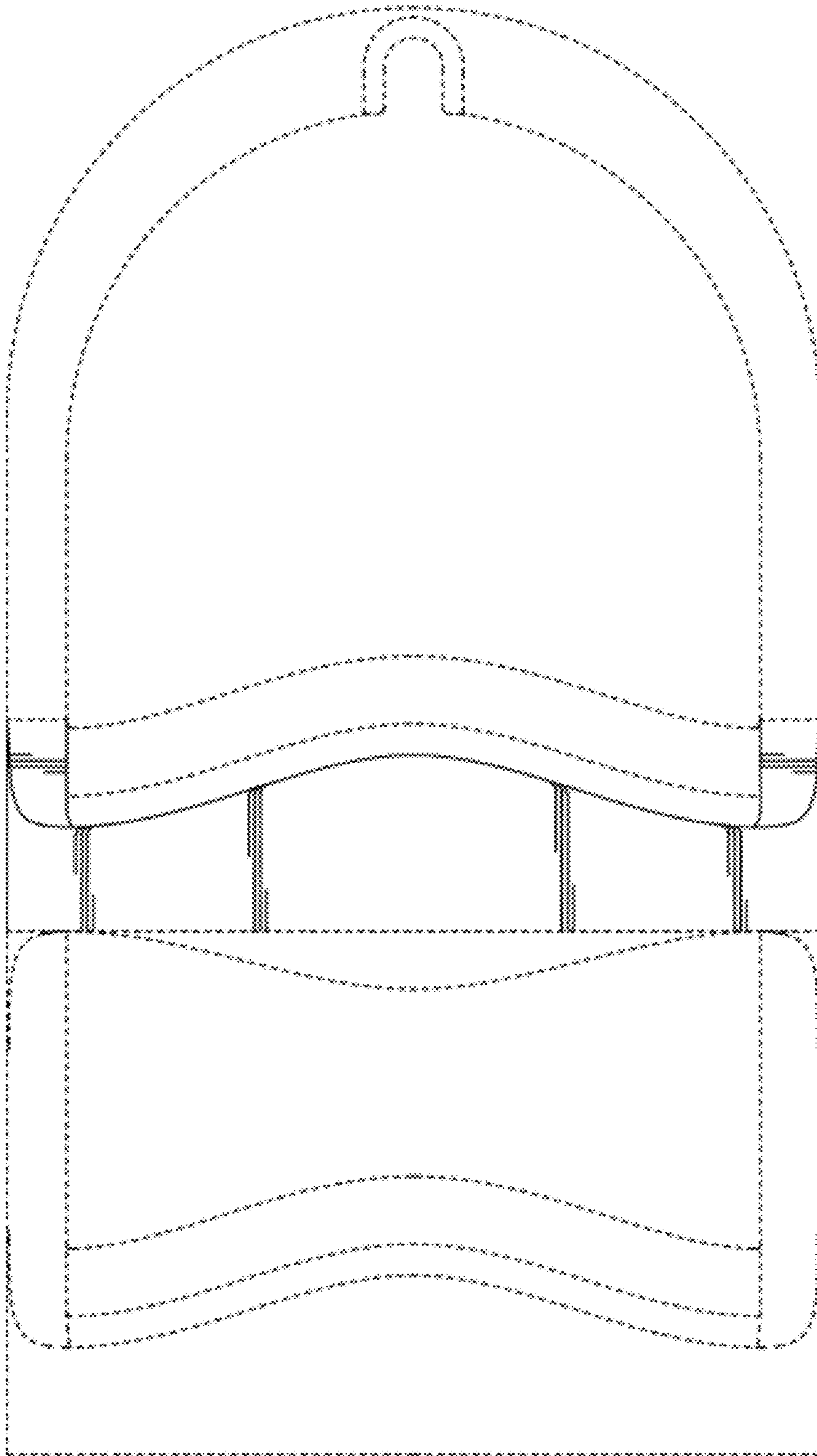

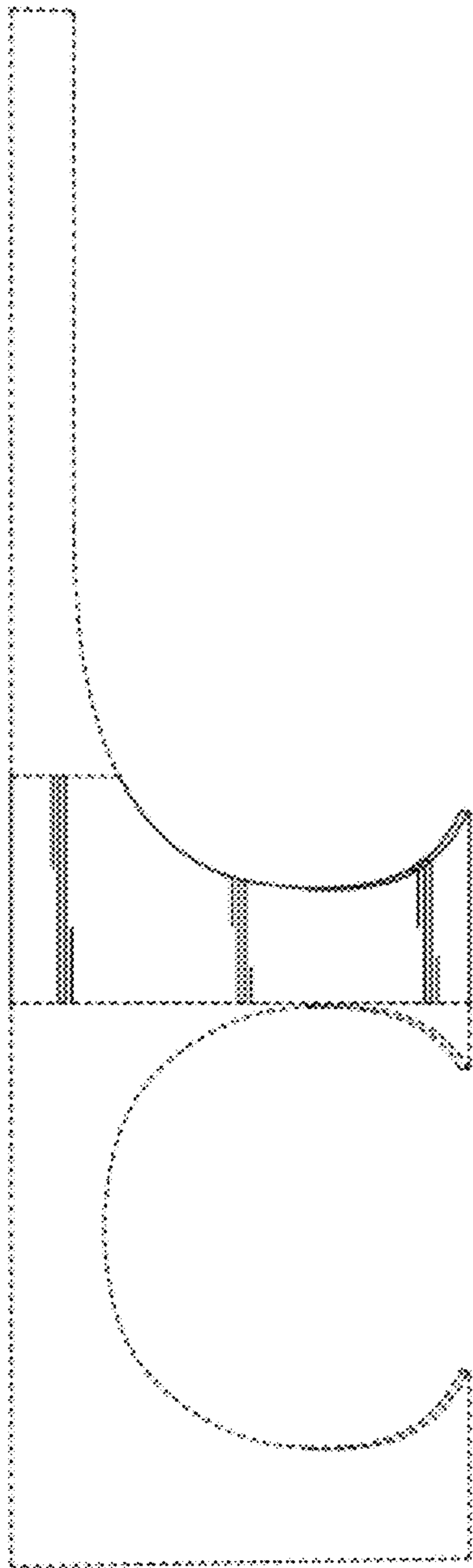

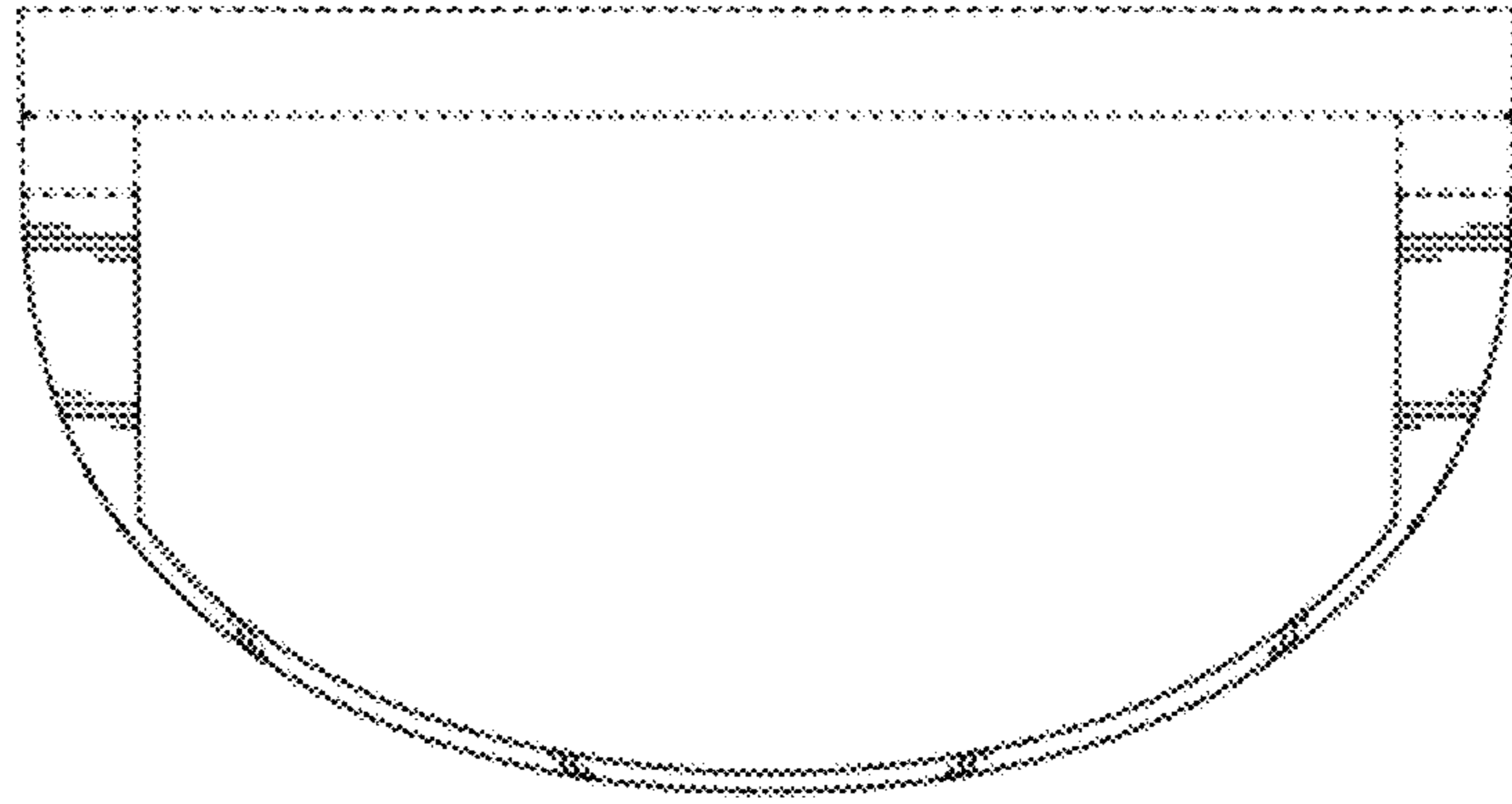
