FIG. 2 is a top plan view thereof;

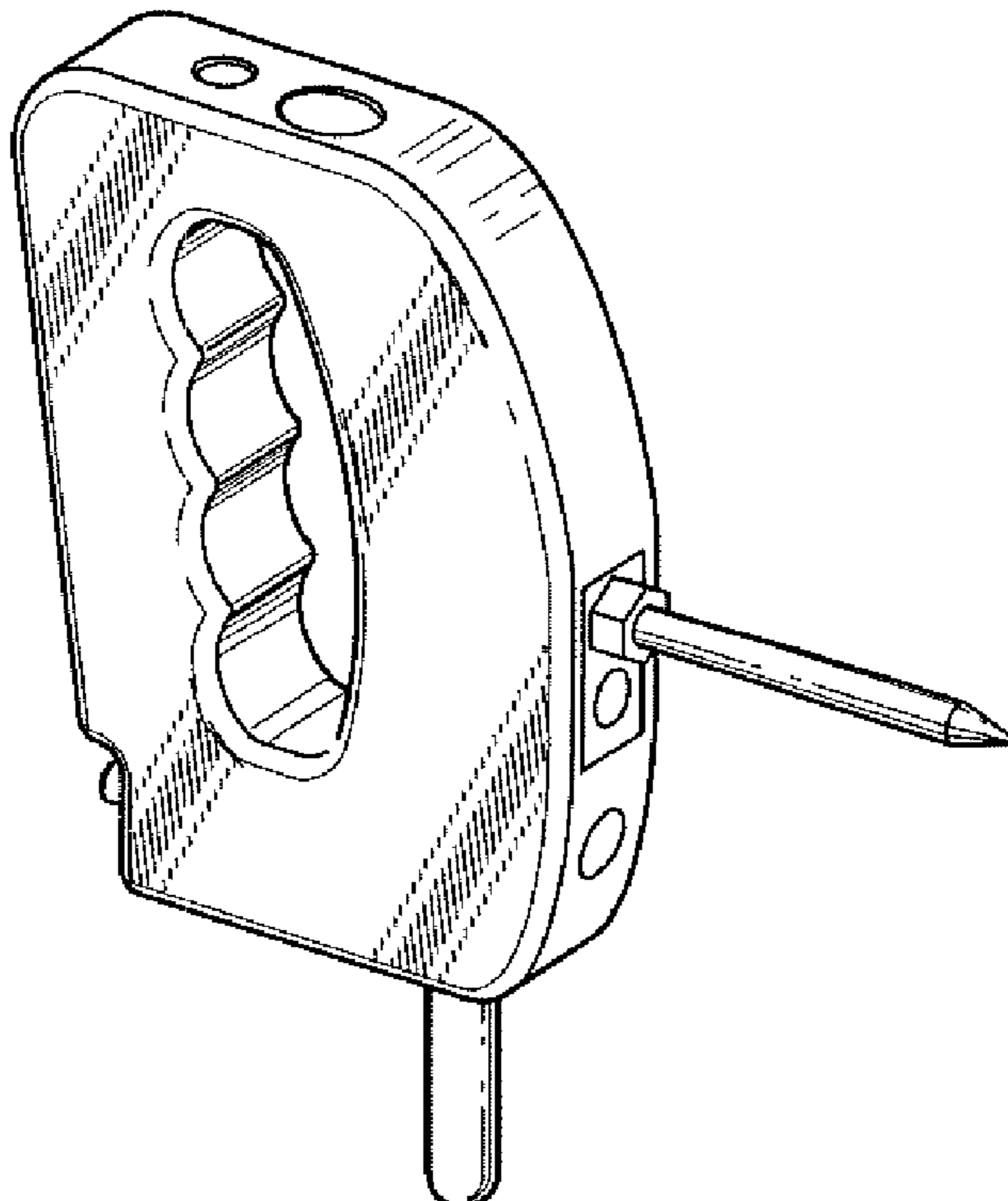
FIG. 3 is a right side view thereof, the left side being a mirror image thereof;

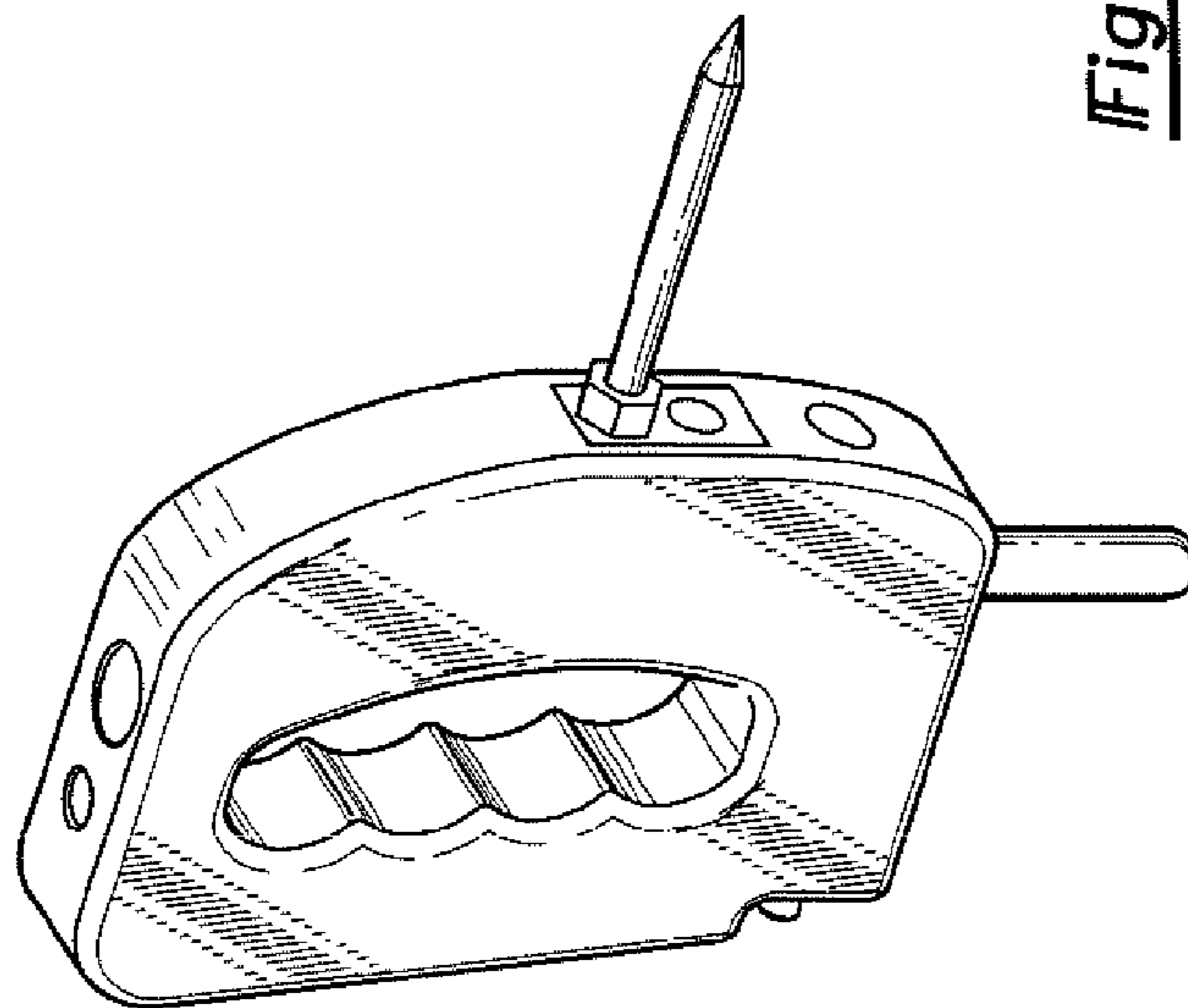

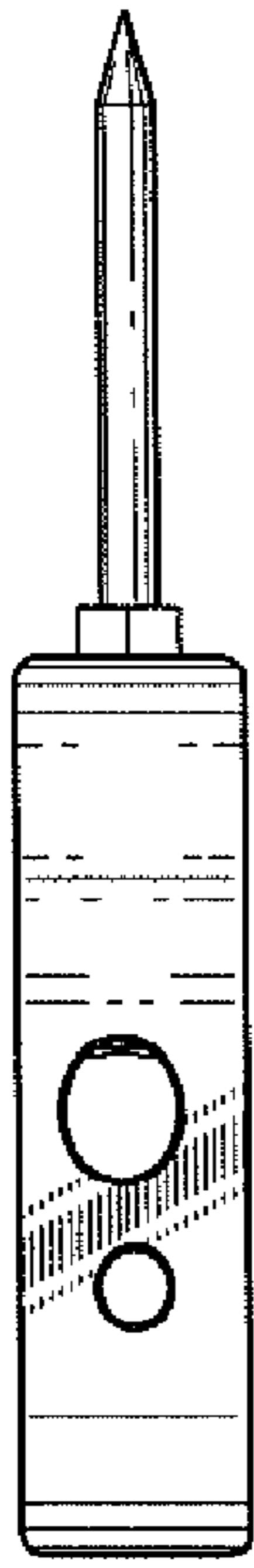

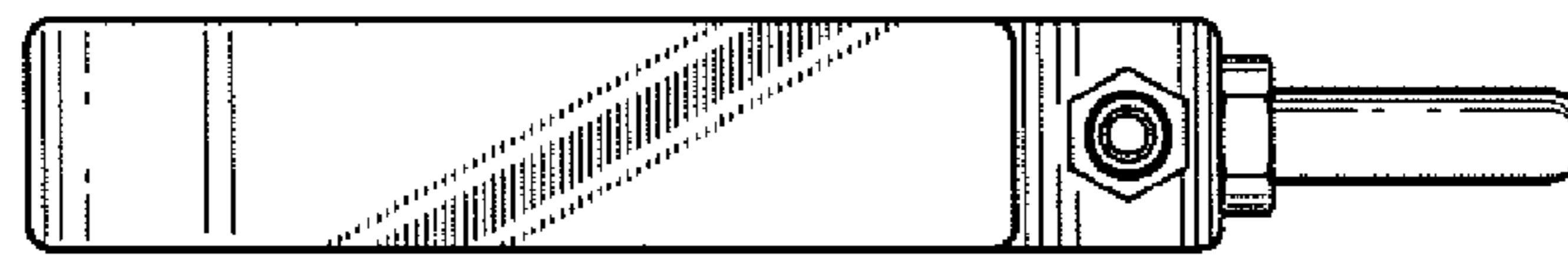

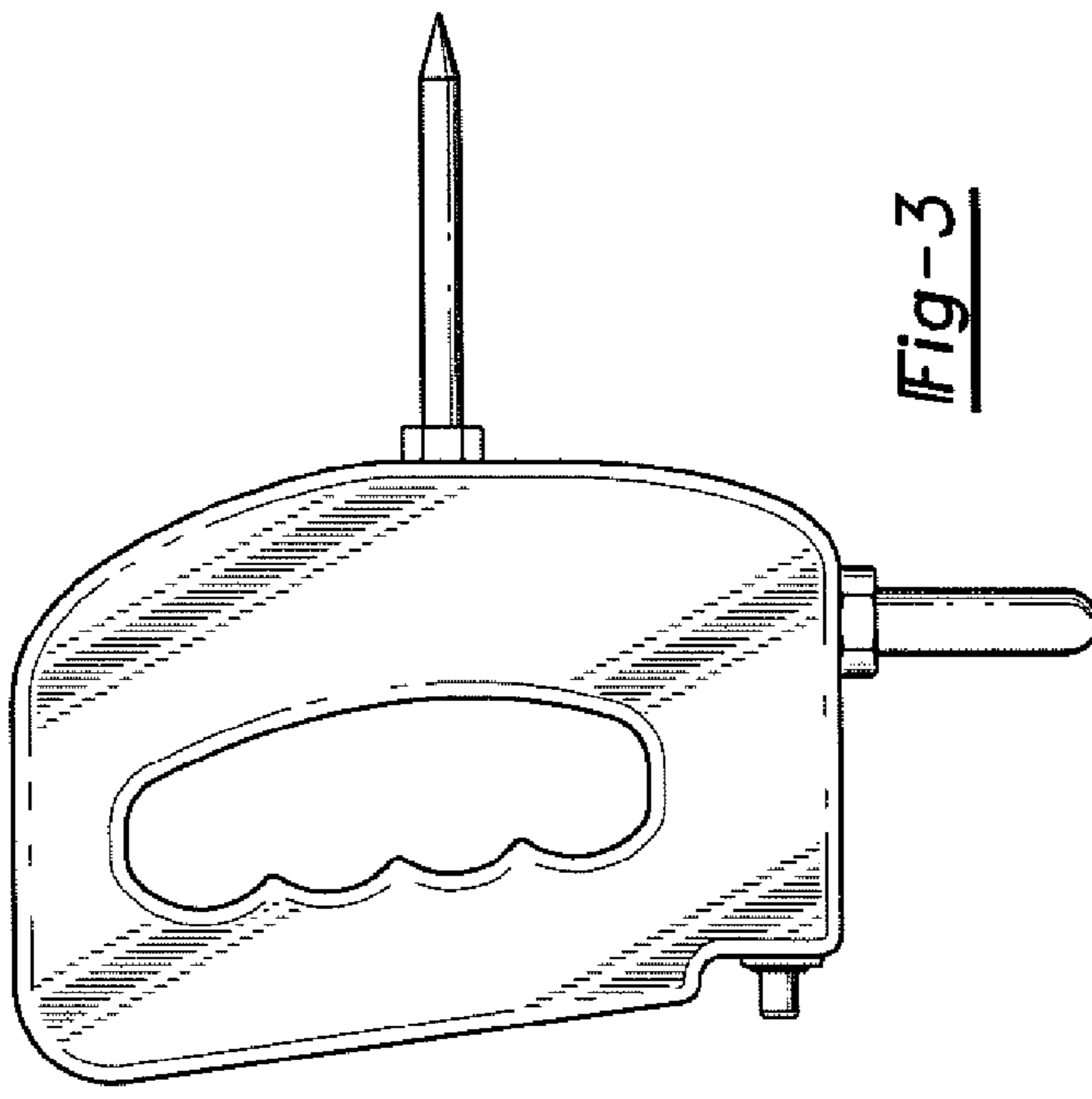

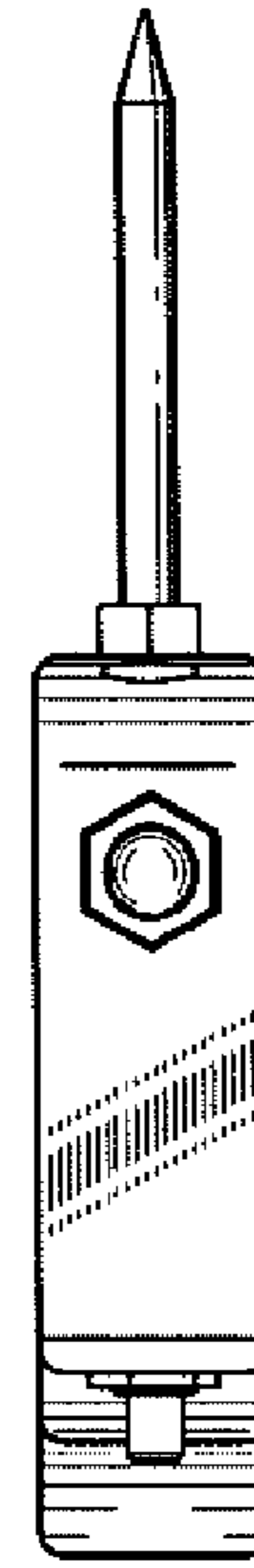

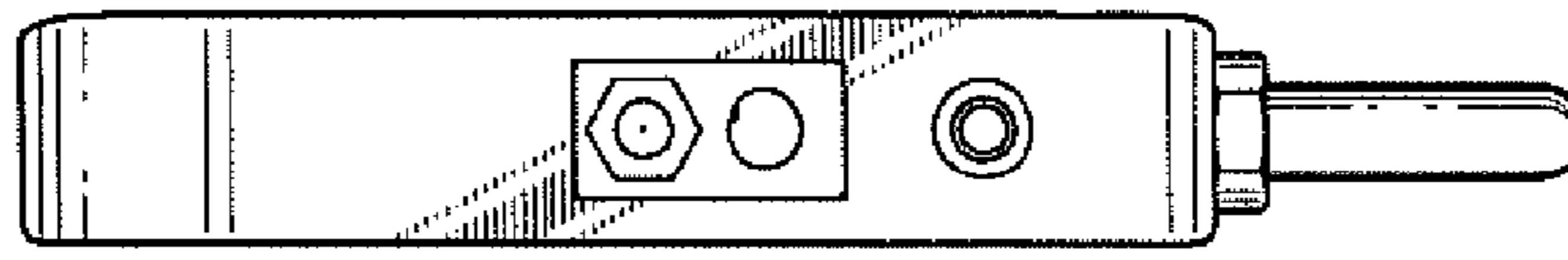
