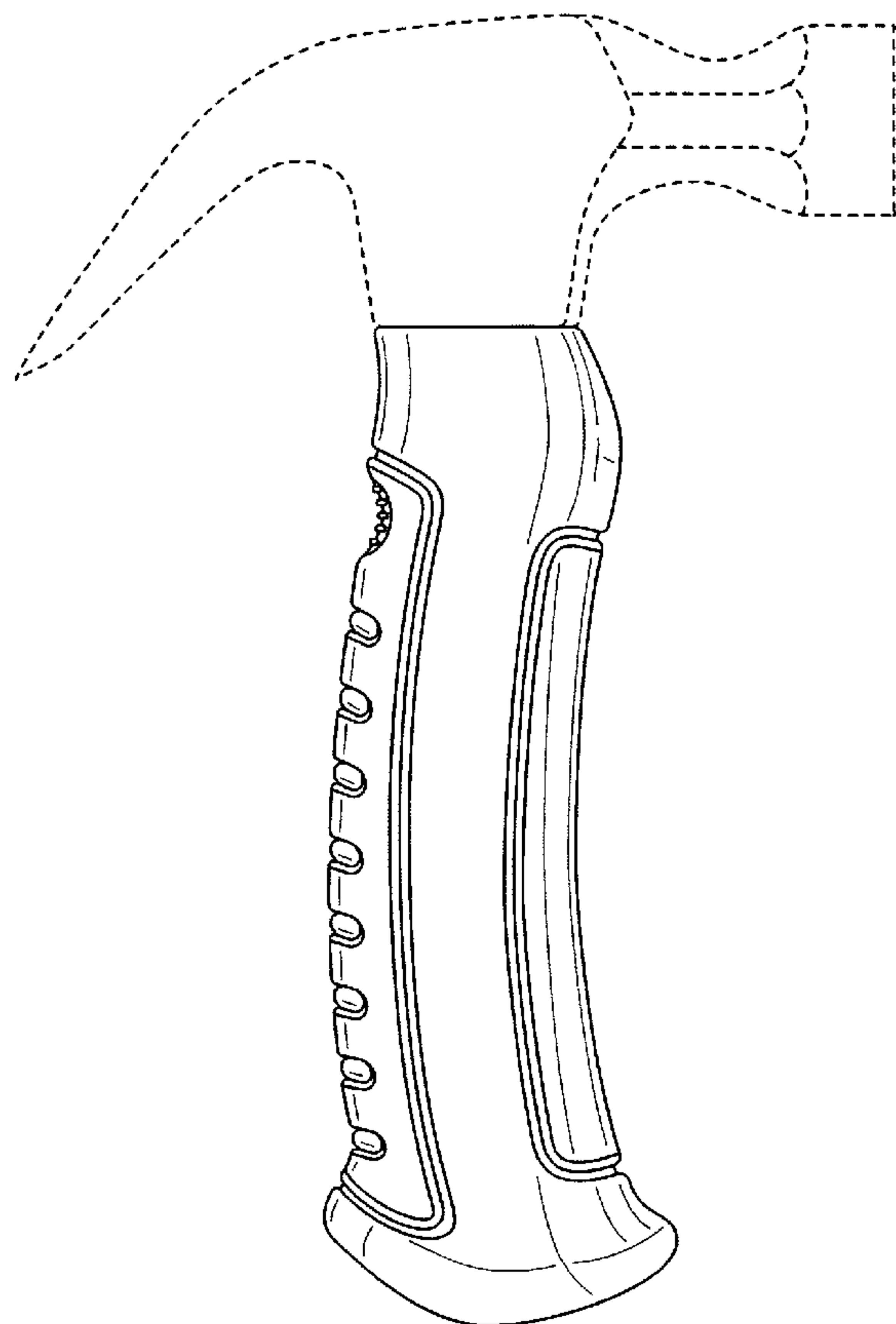
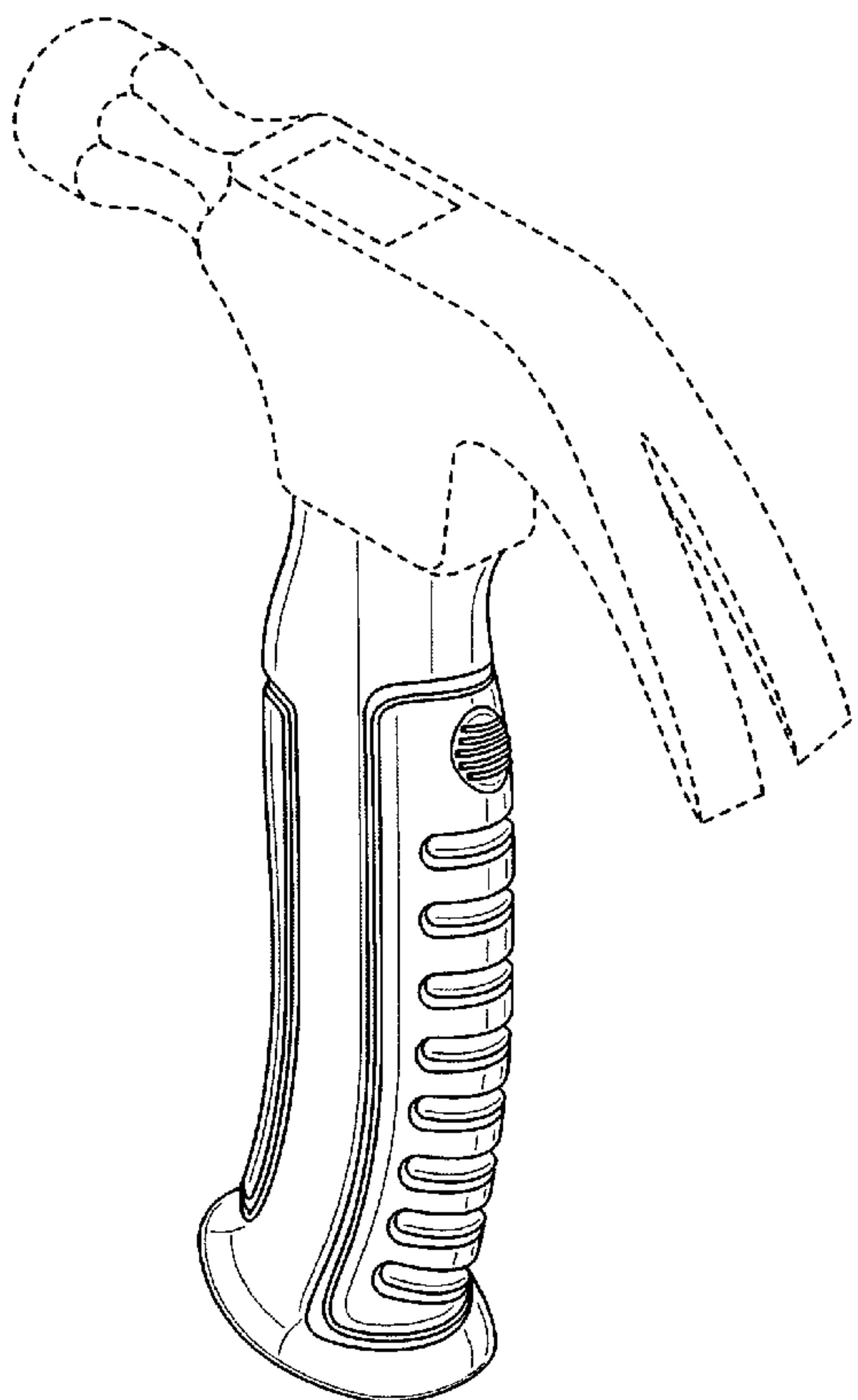
(57) **CLAIM**

The ornamental design for a stubby hammer handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the stubby hammer handle of the present invention showing my new design; FIG. 2 is a back perspective view thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is another side elevational view thereof; FIG. 5 is a front side elevational view thereof; FIG. 6 is a back side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines in the drawings are directed to the hammer head and form no part of the claim.

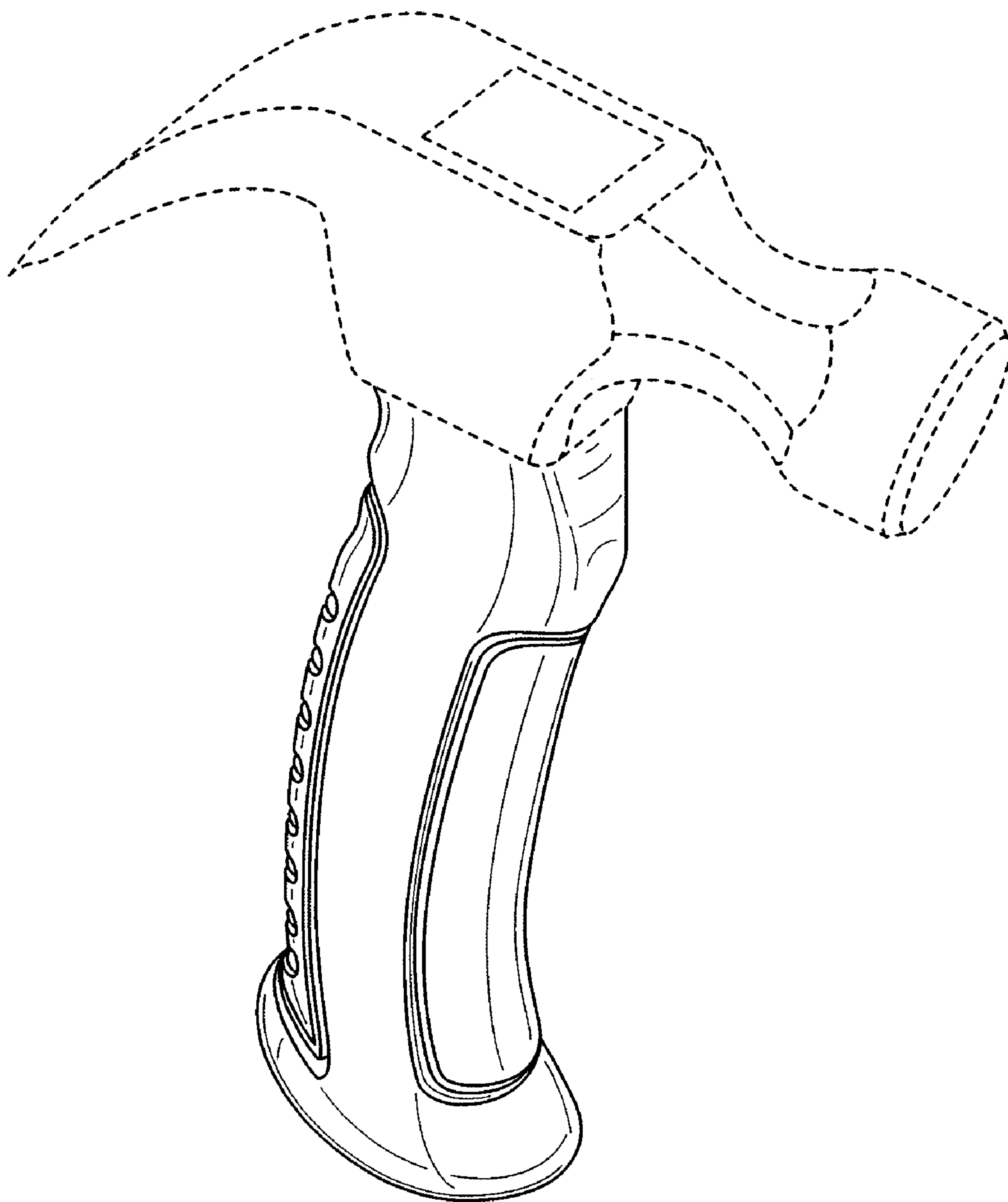

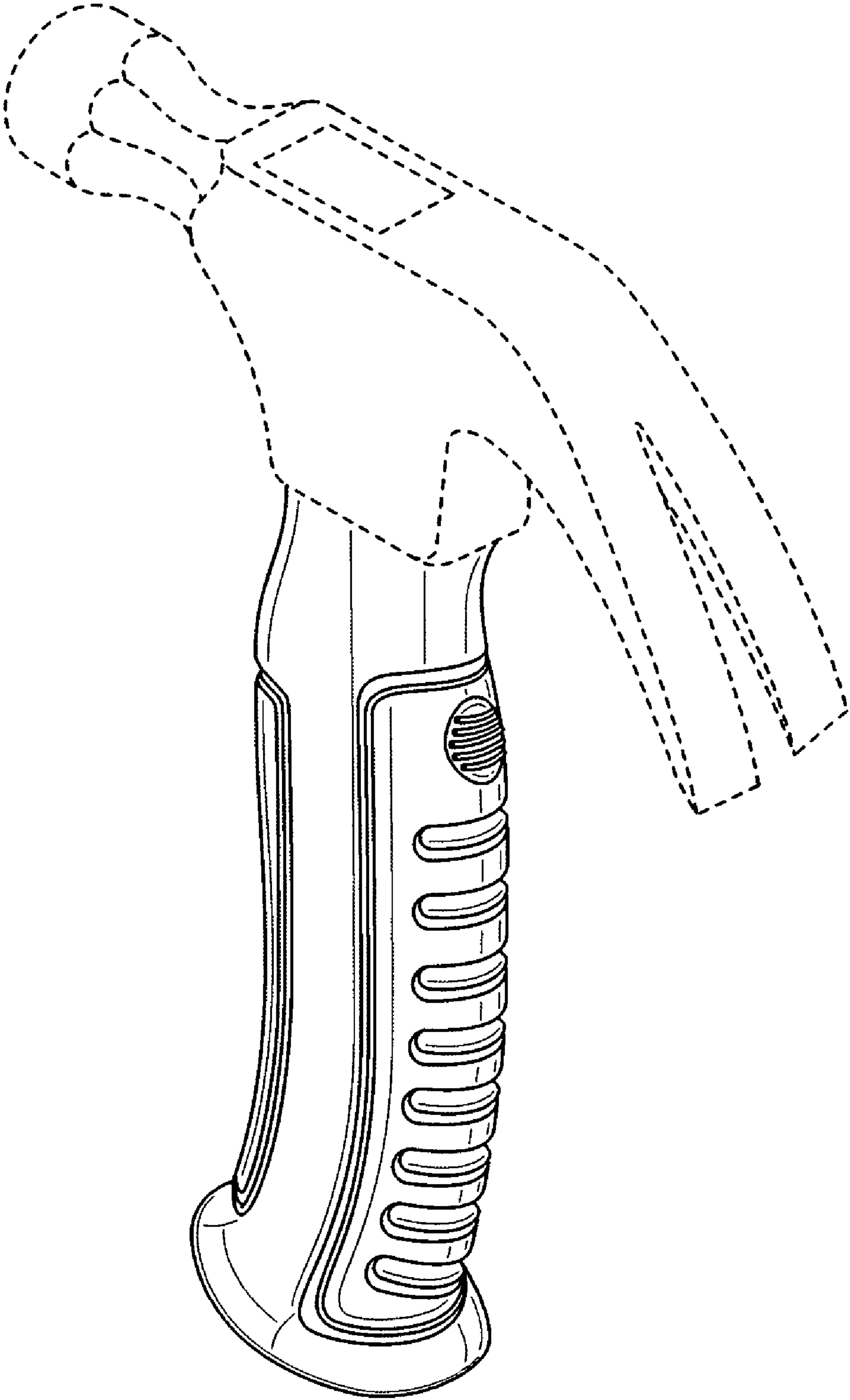

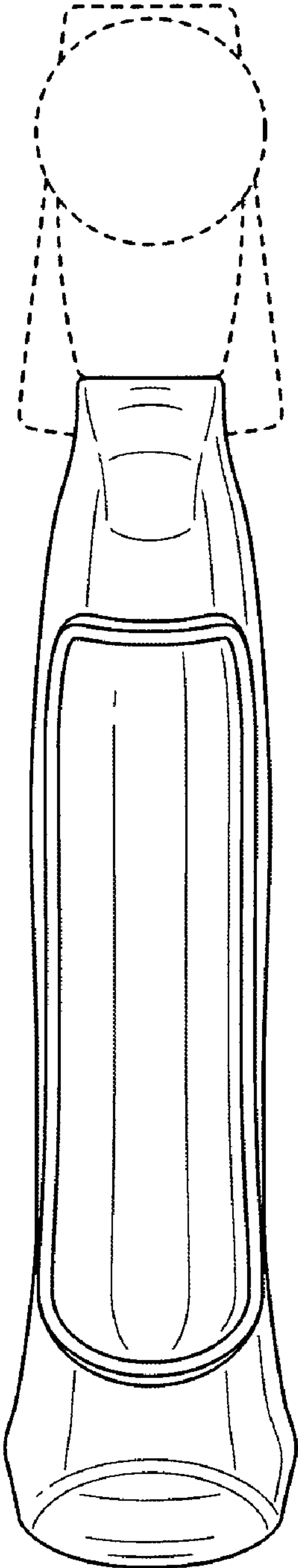

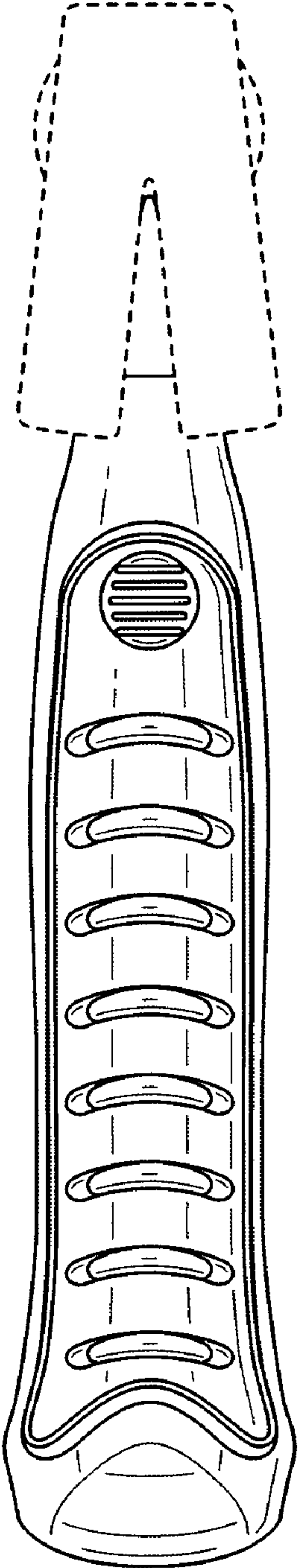

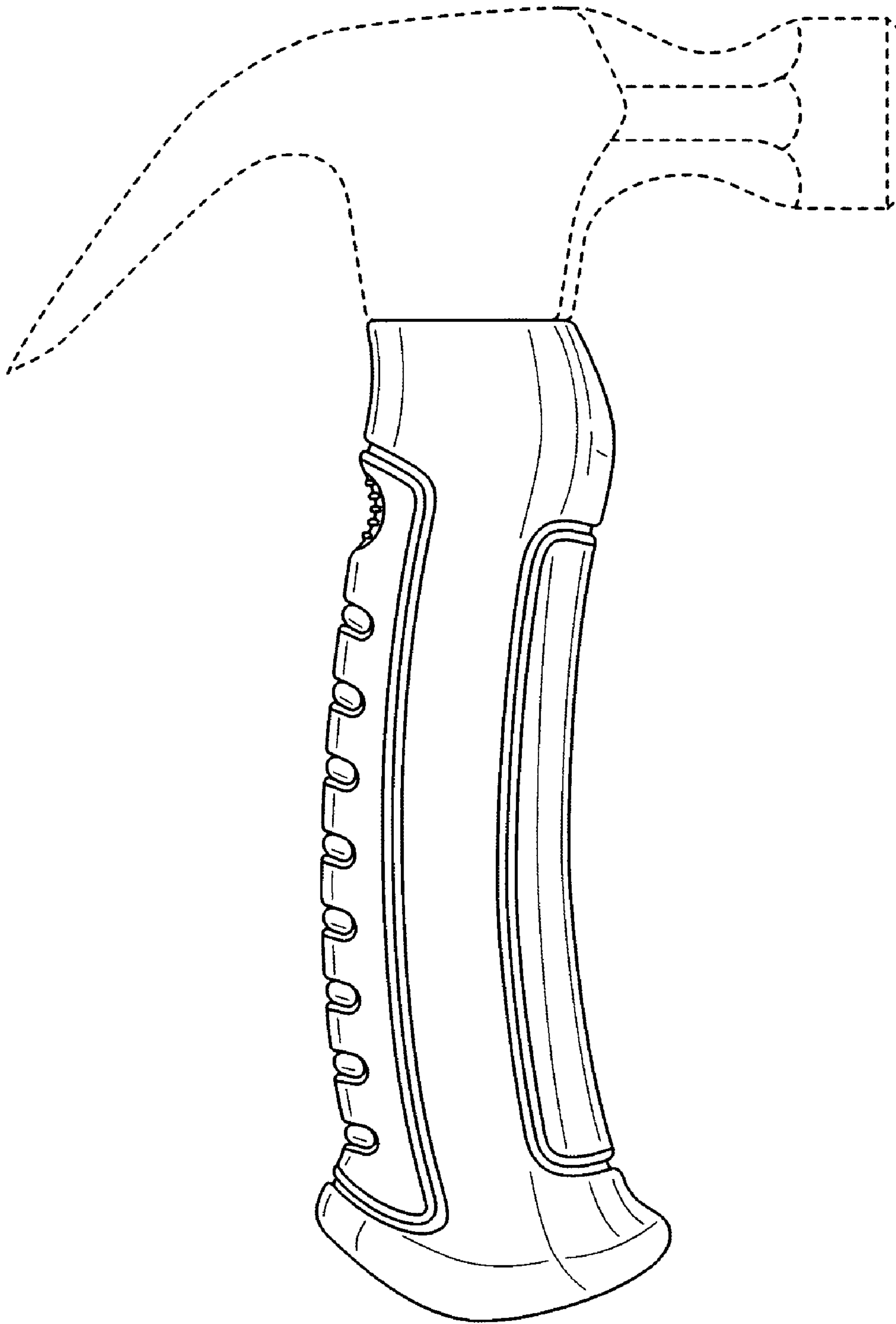

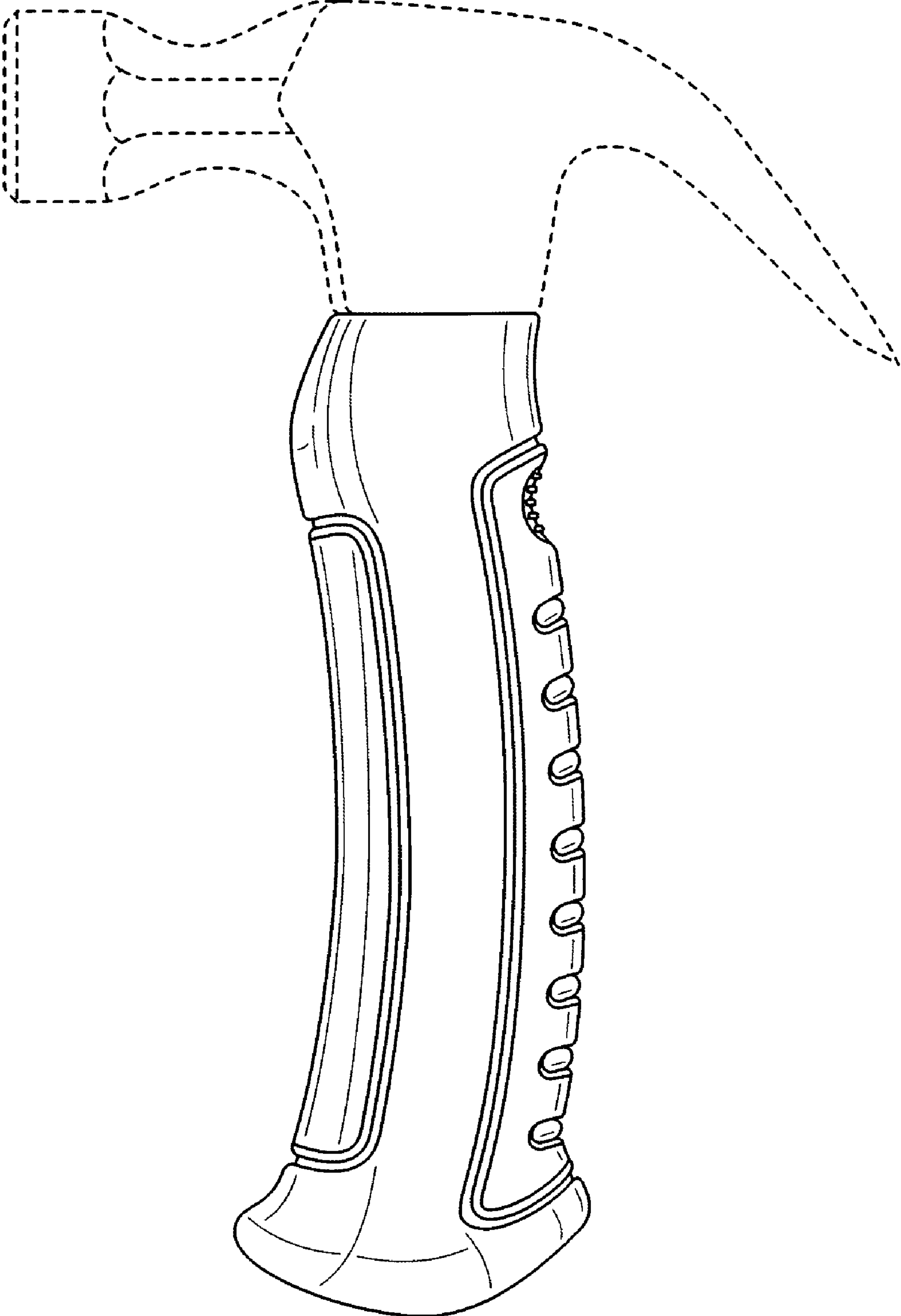

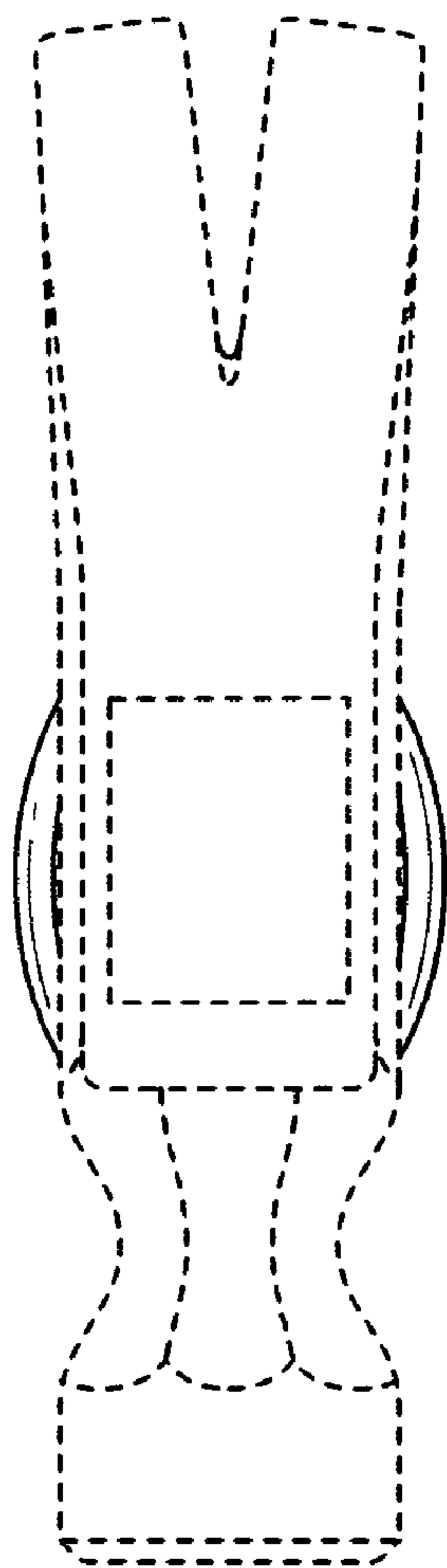

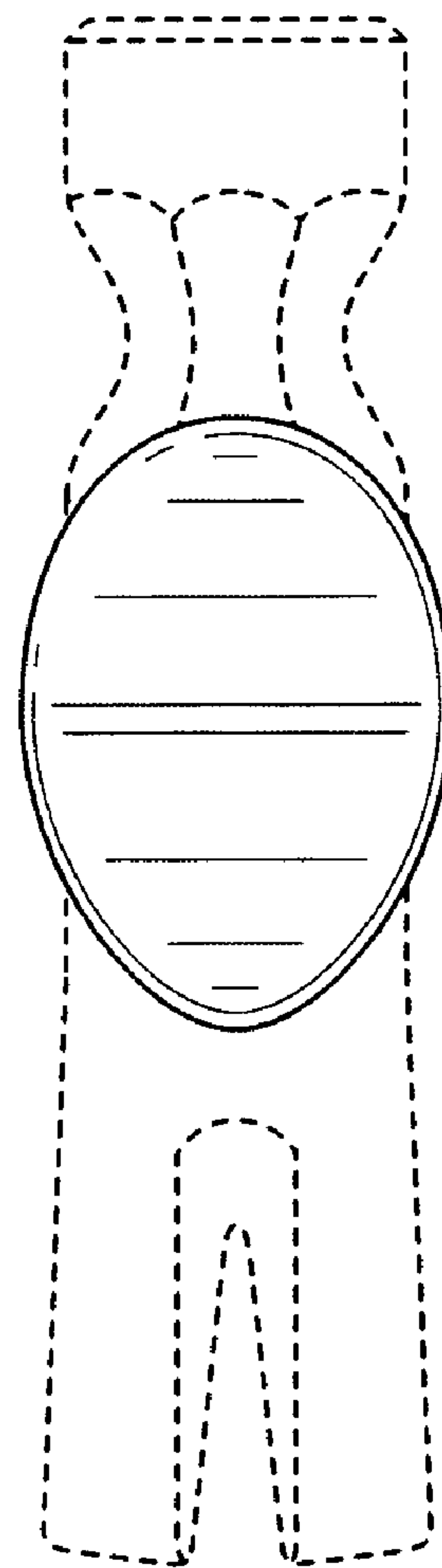
