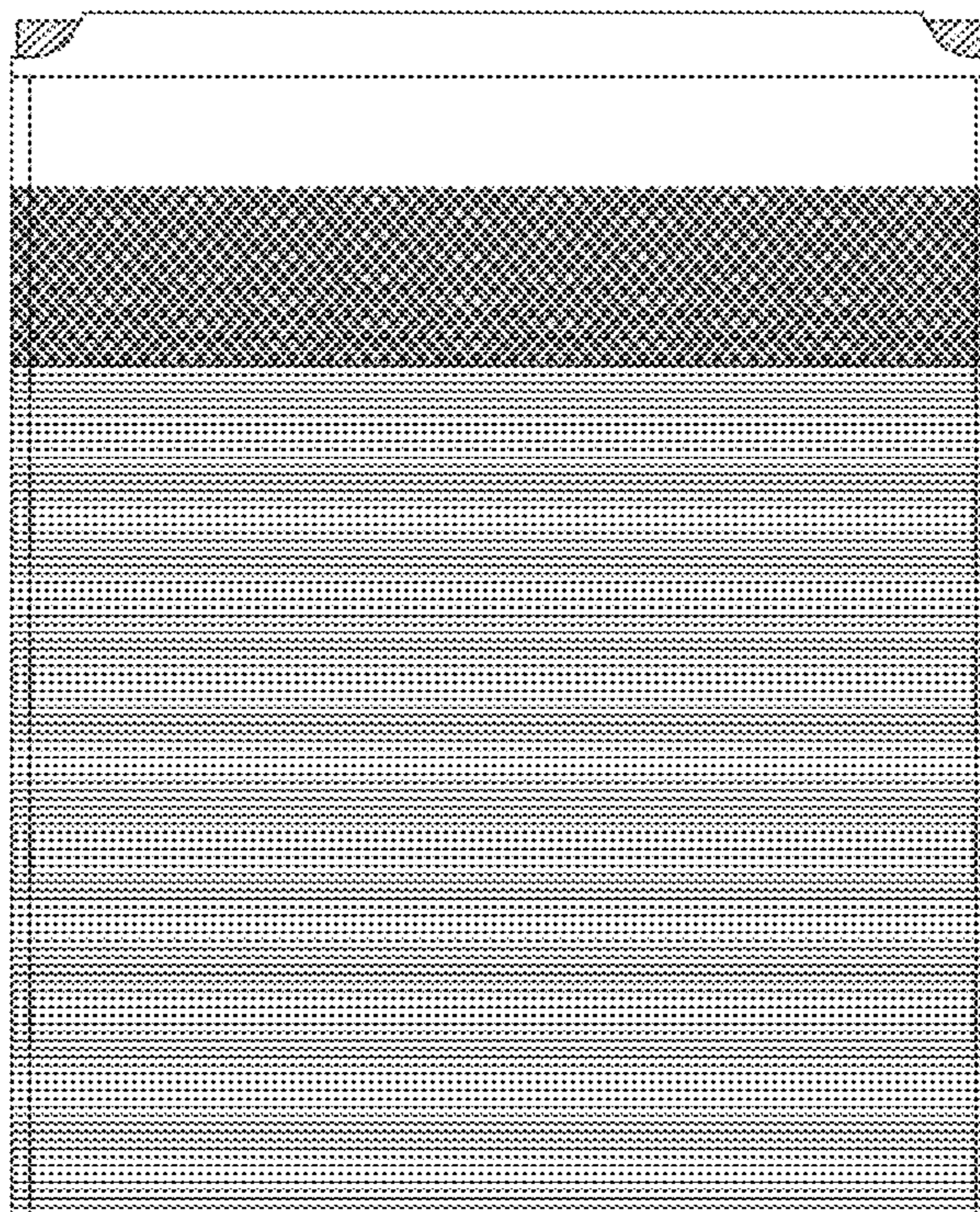

diamond patterns showing our new design;

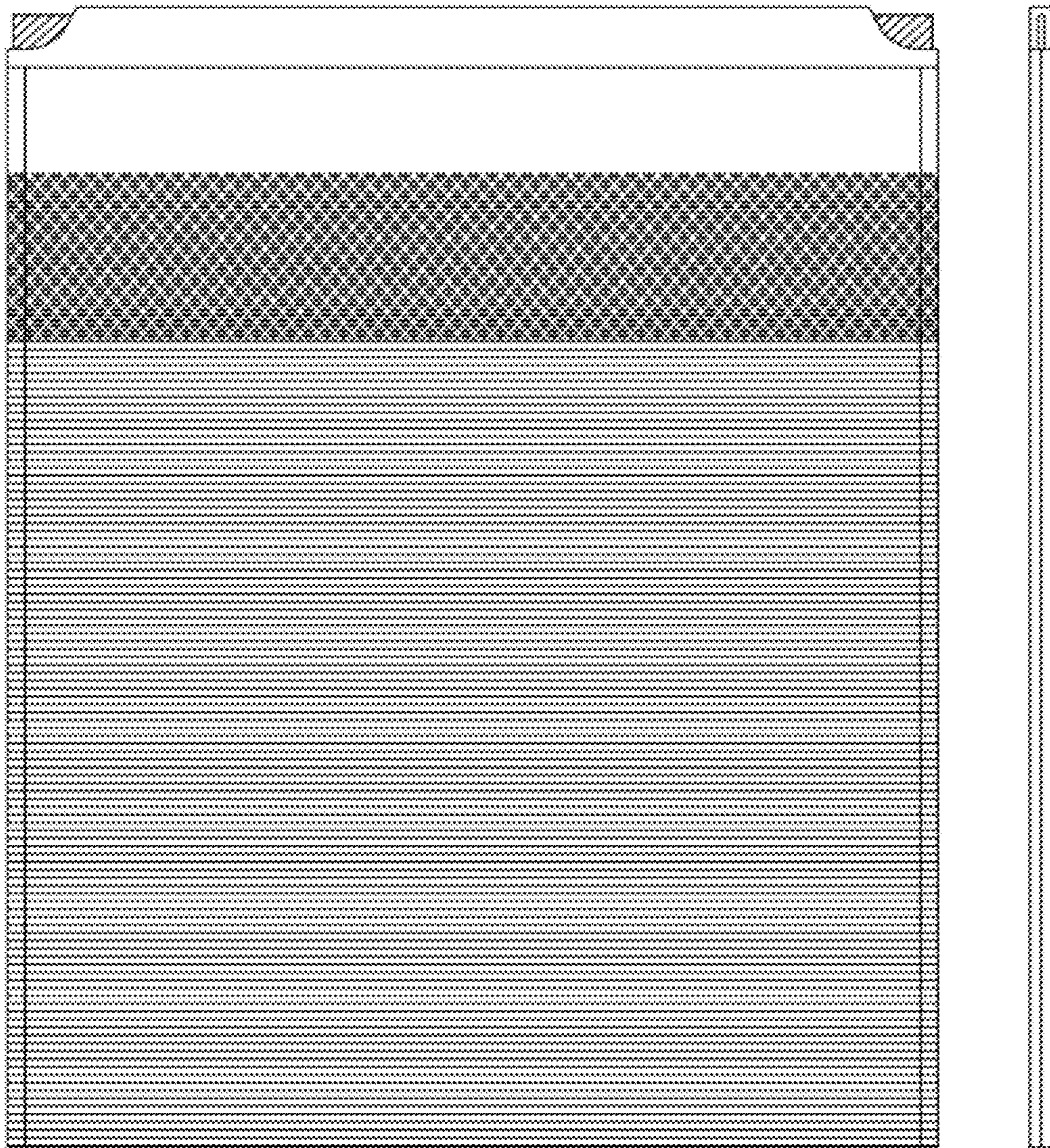

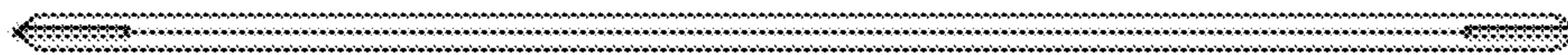

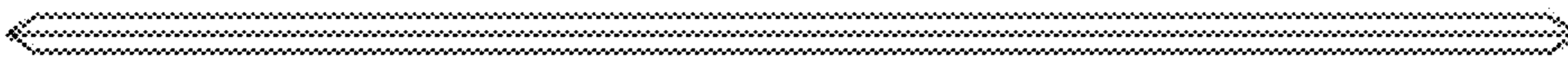
