FIG. 15 is a right side elevation view of the third embodiment, the left side elevation view being a mirror image of the right side.

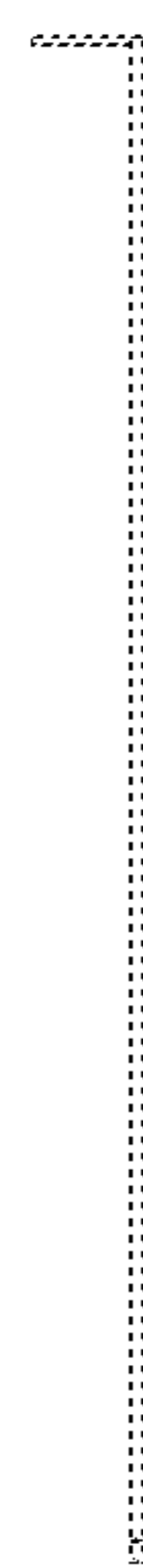
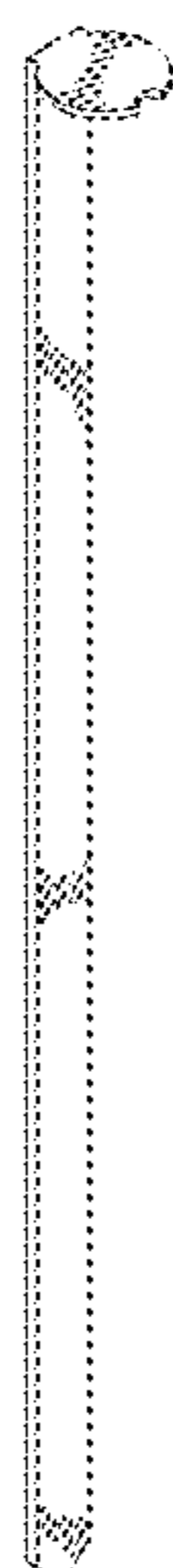
FIG. 16 is a back elevation view of the third embodiment.

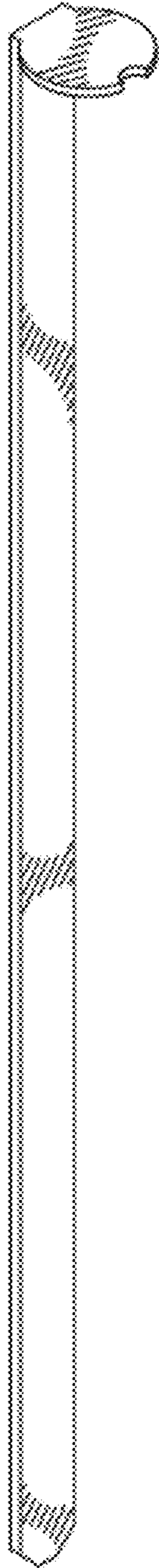

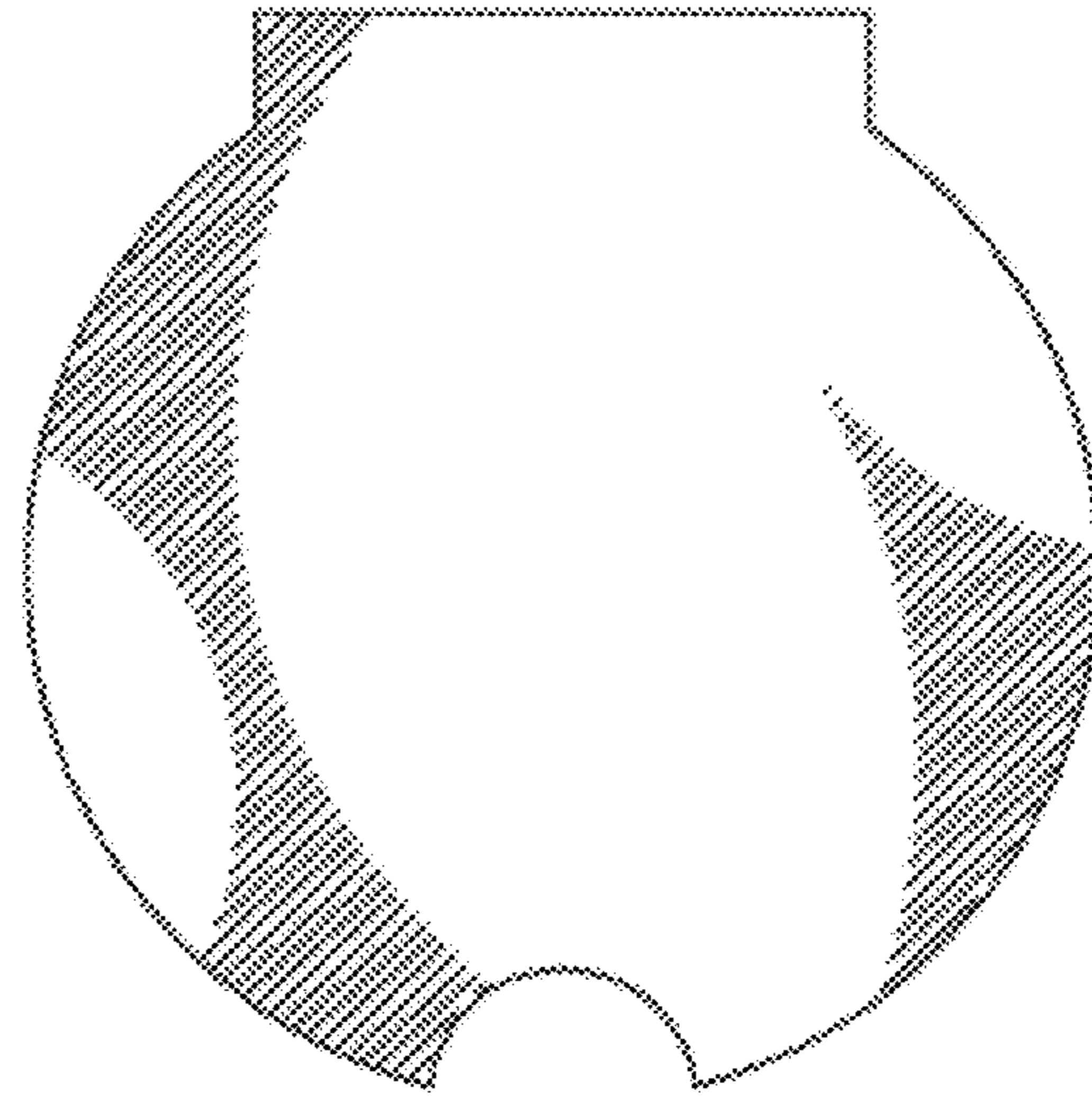

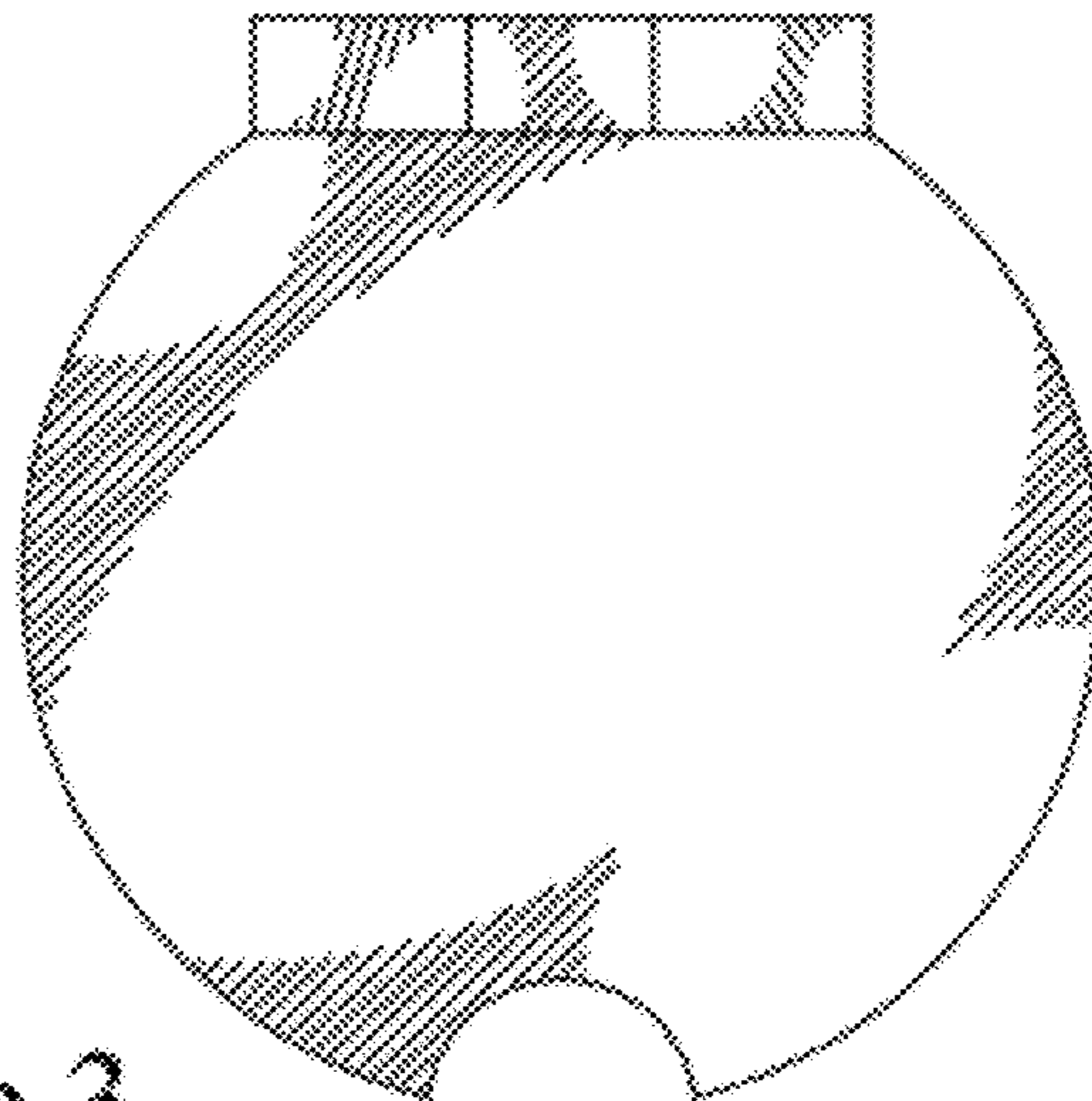

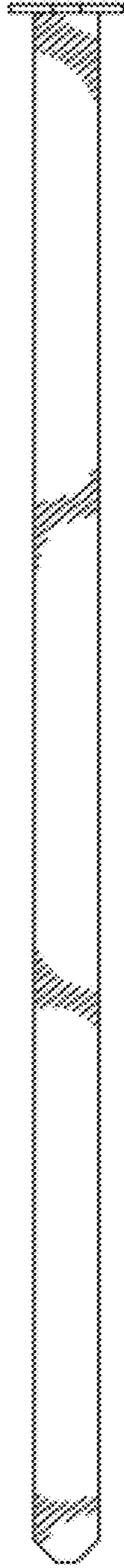

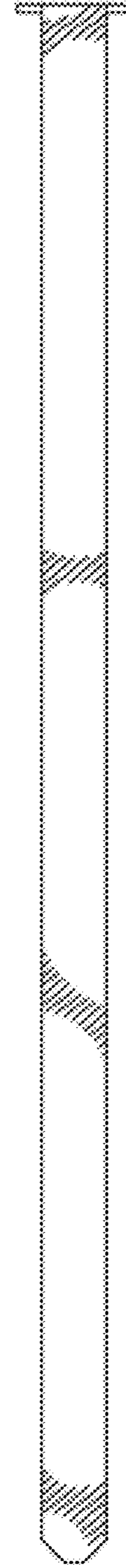

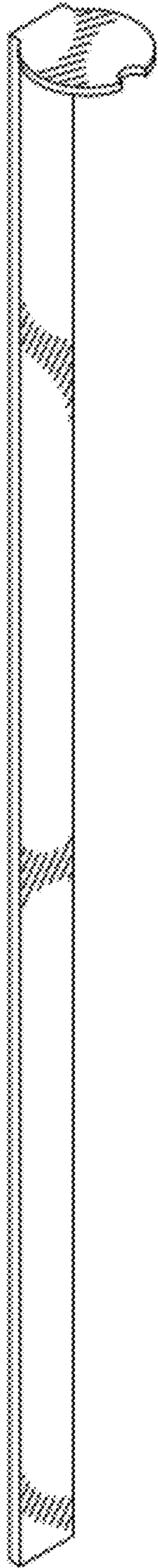

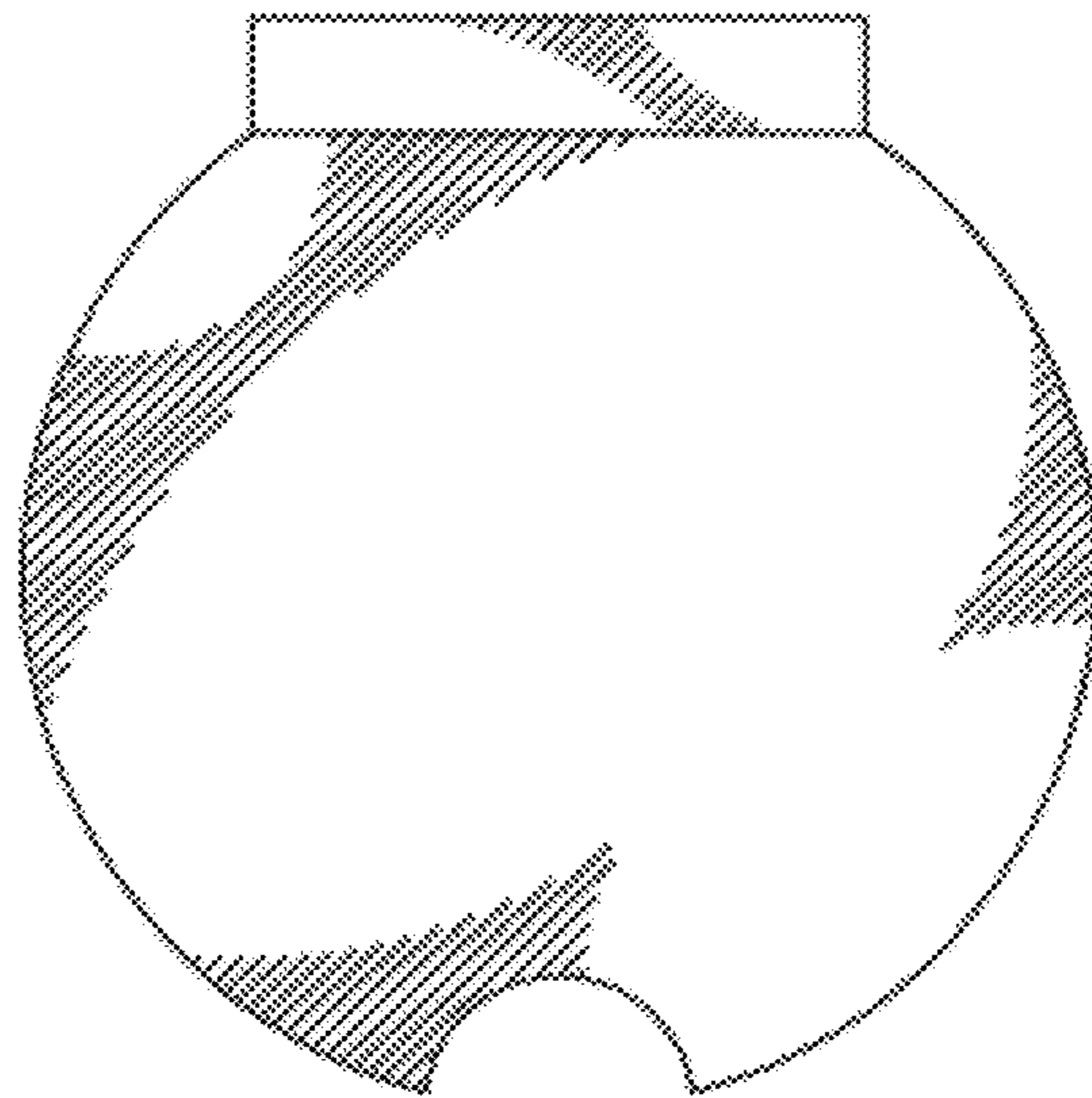

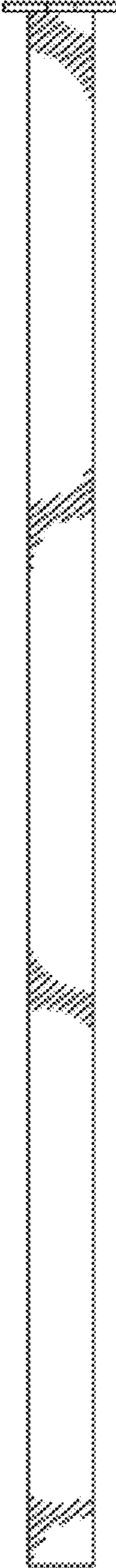

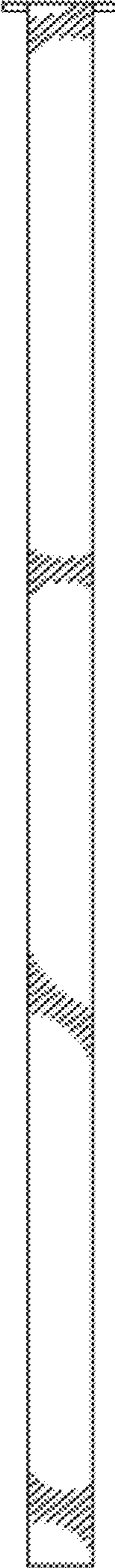

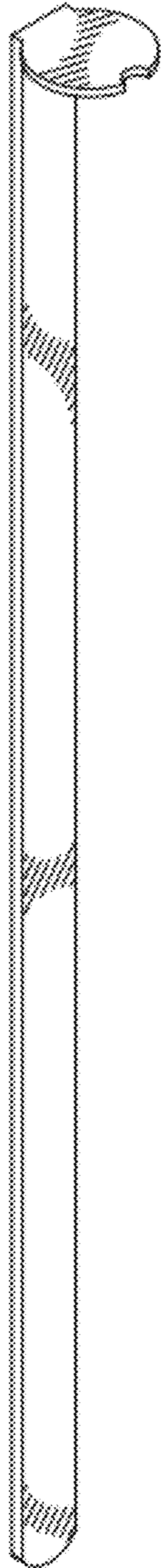

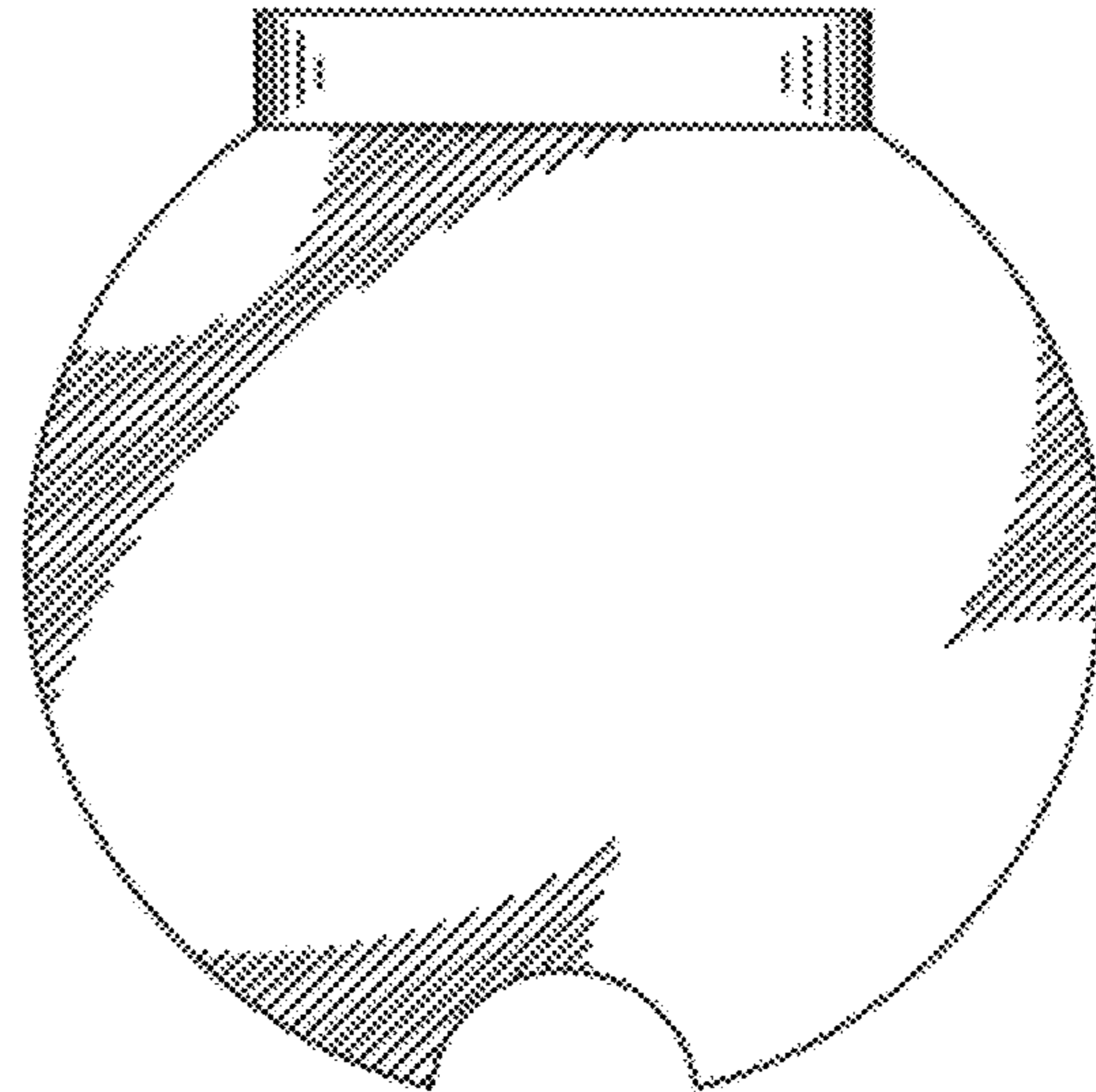

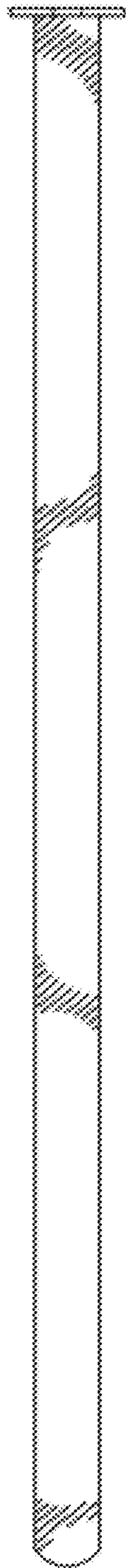

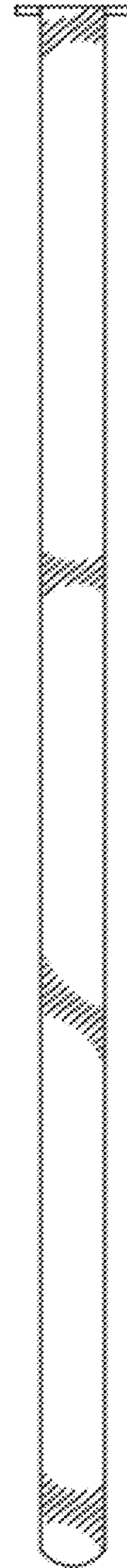

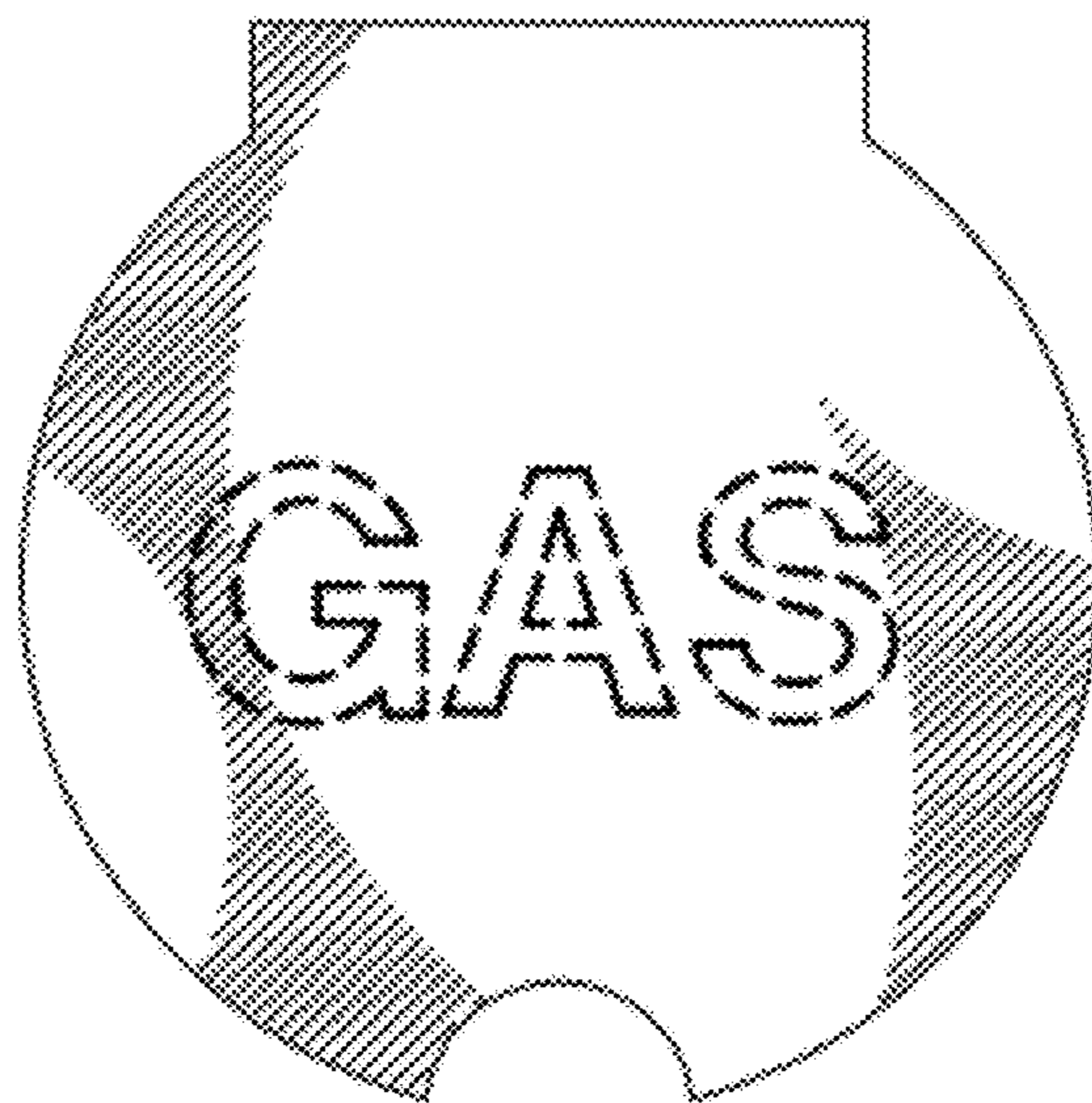

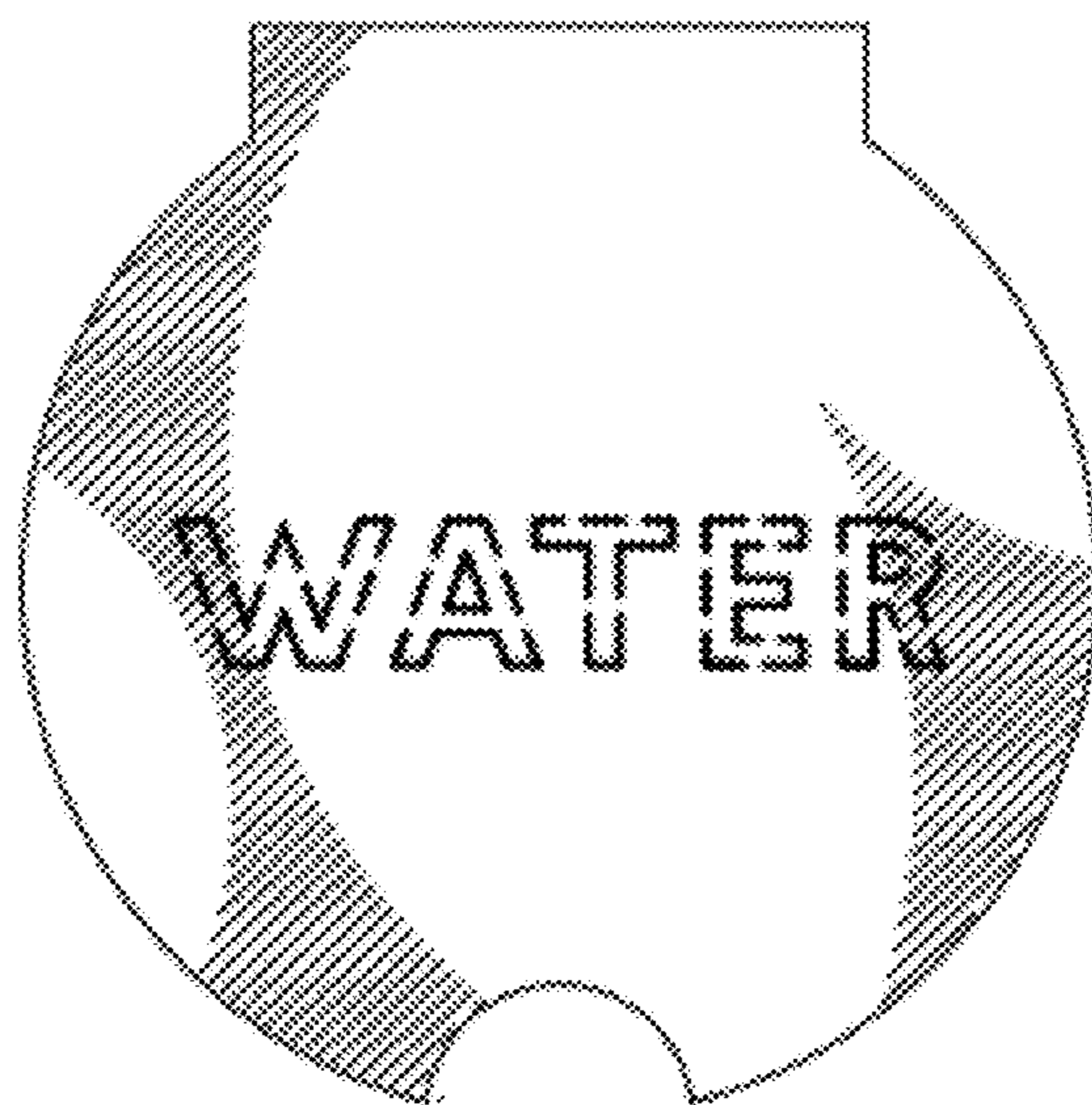

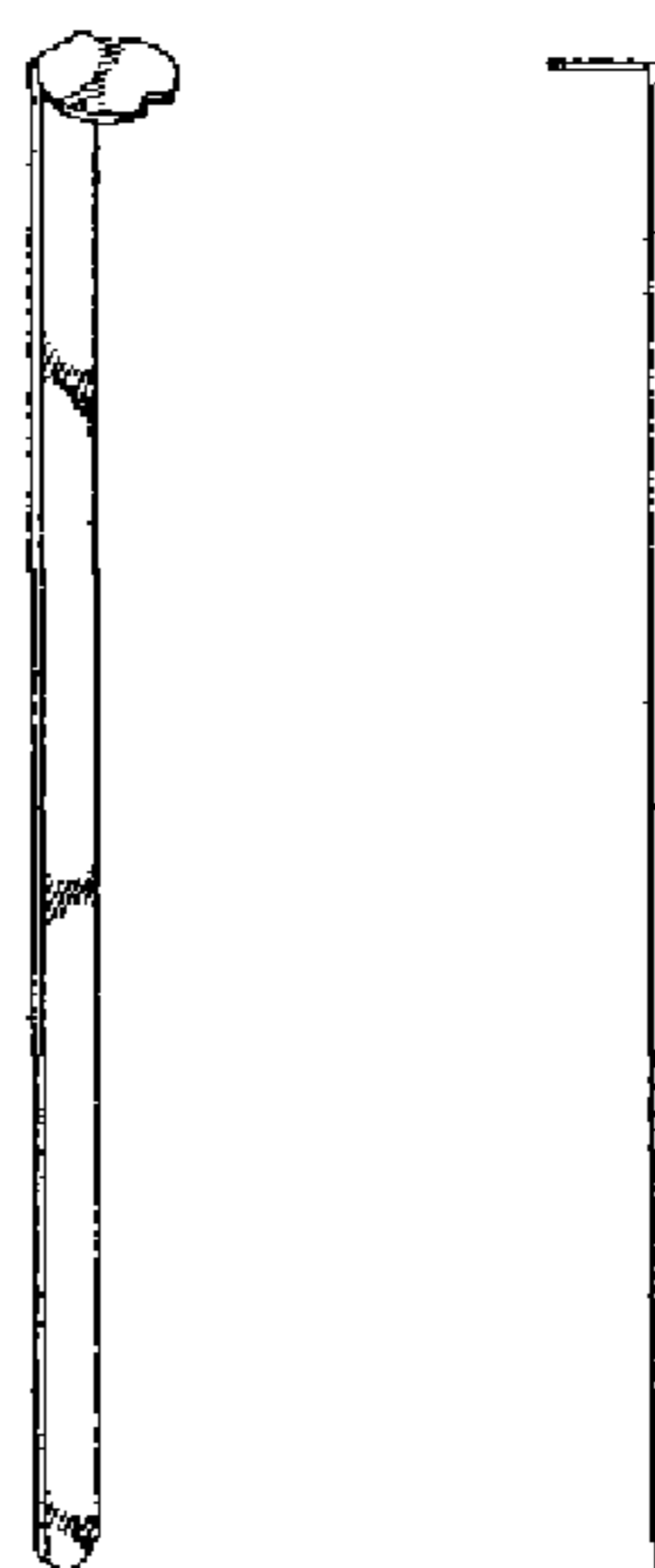

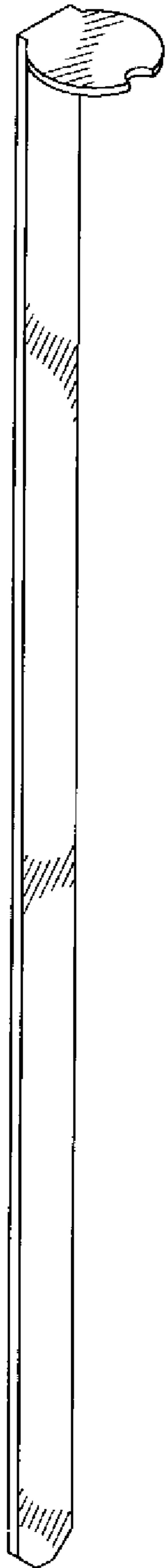

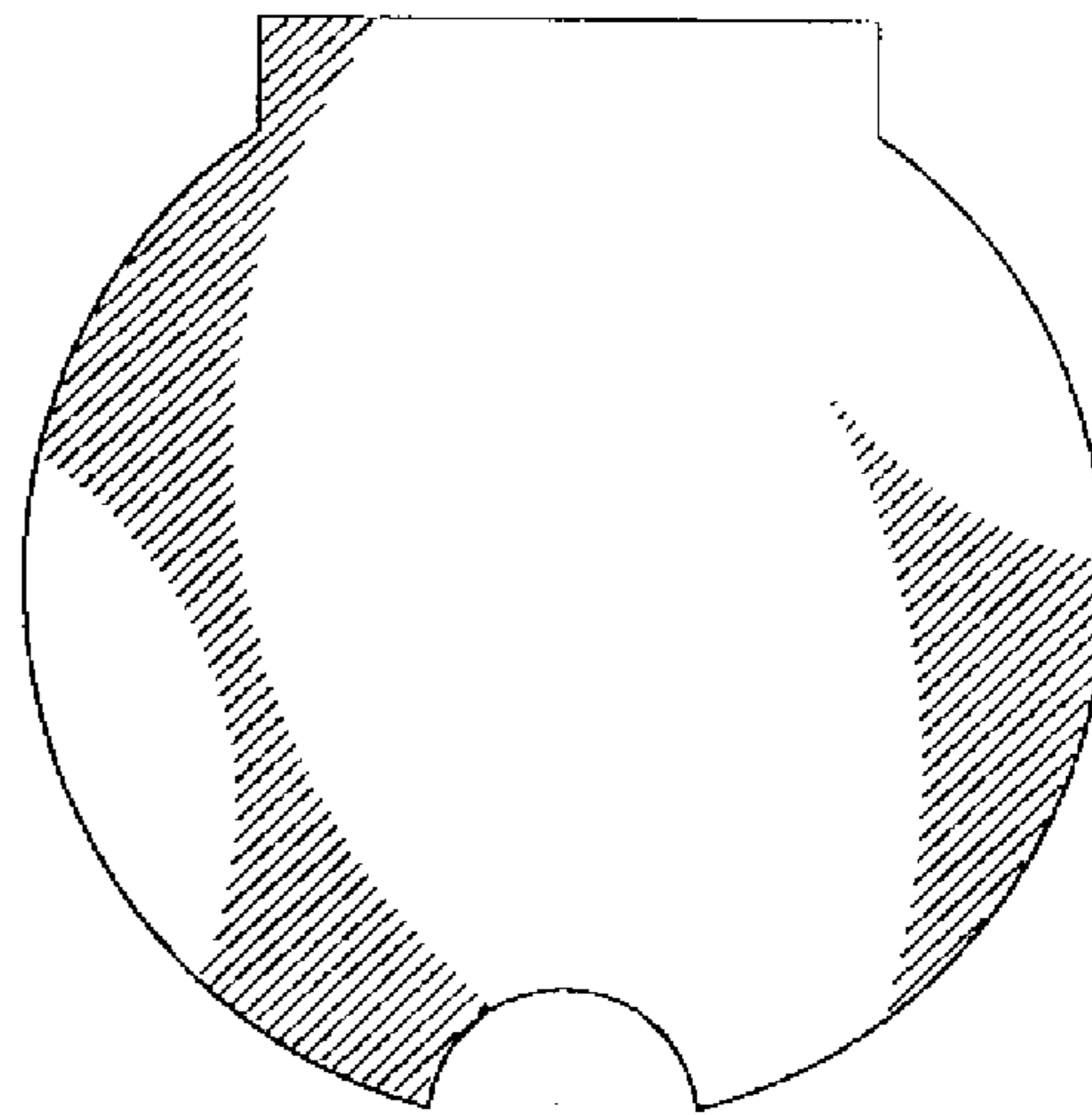

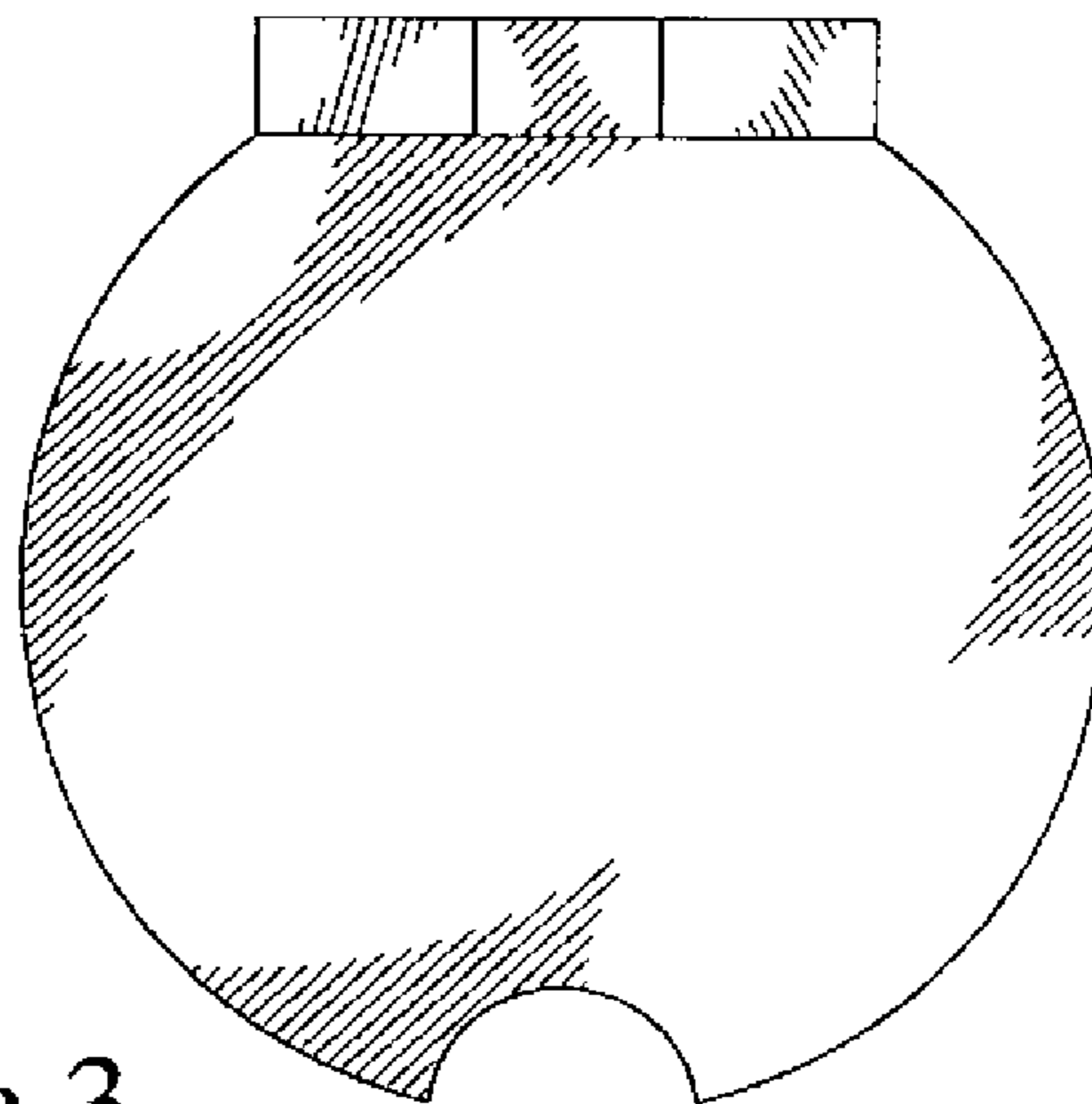

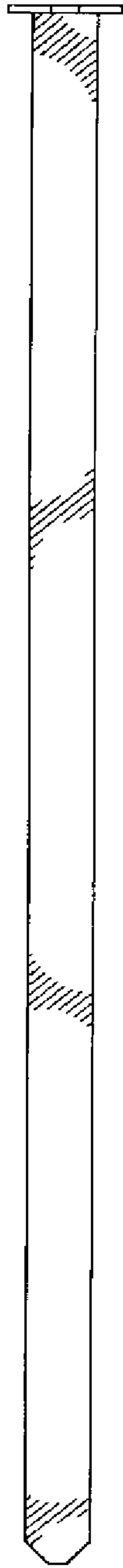

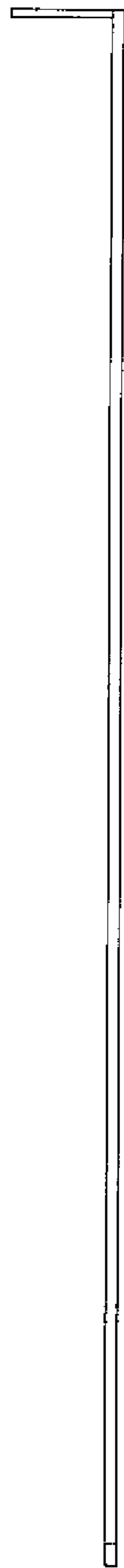

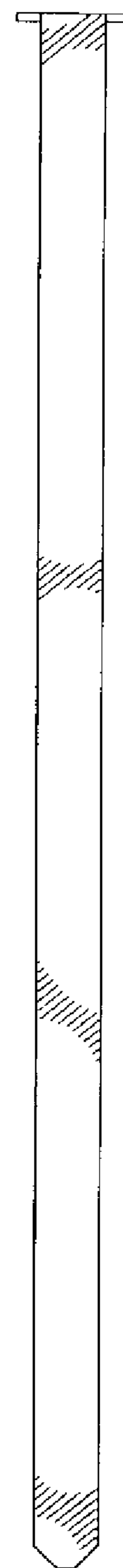

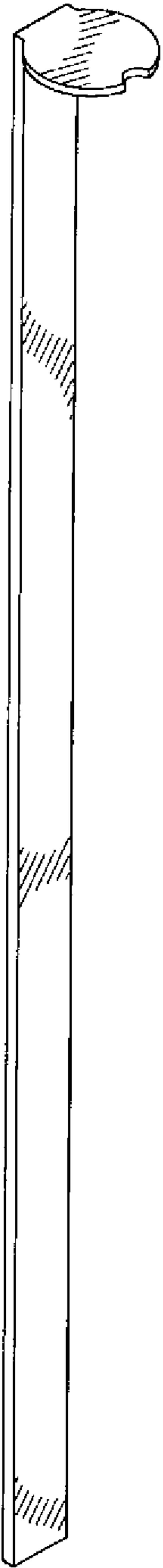

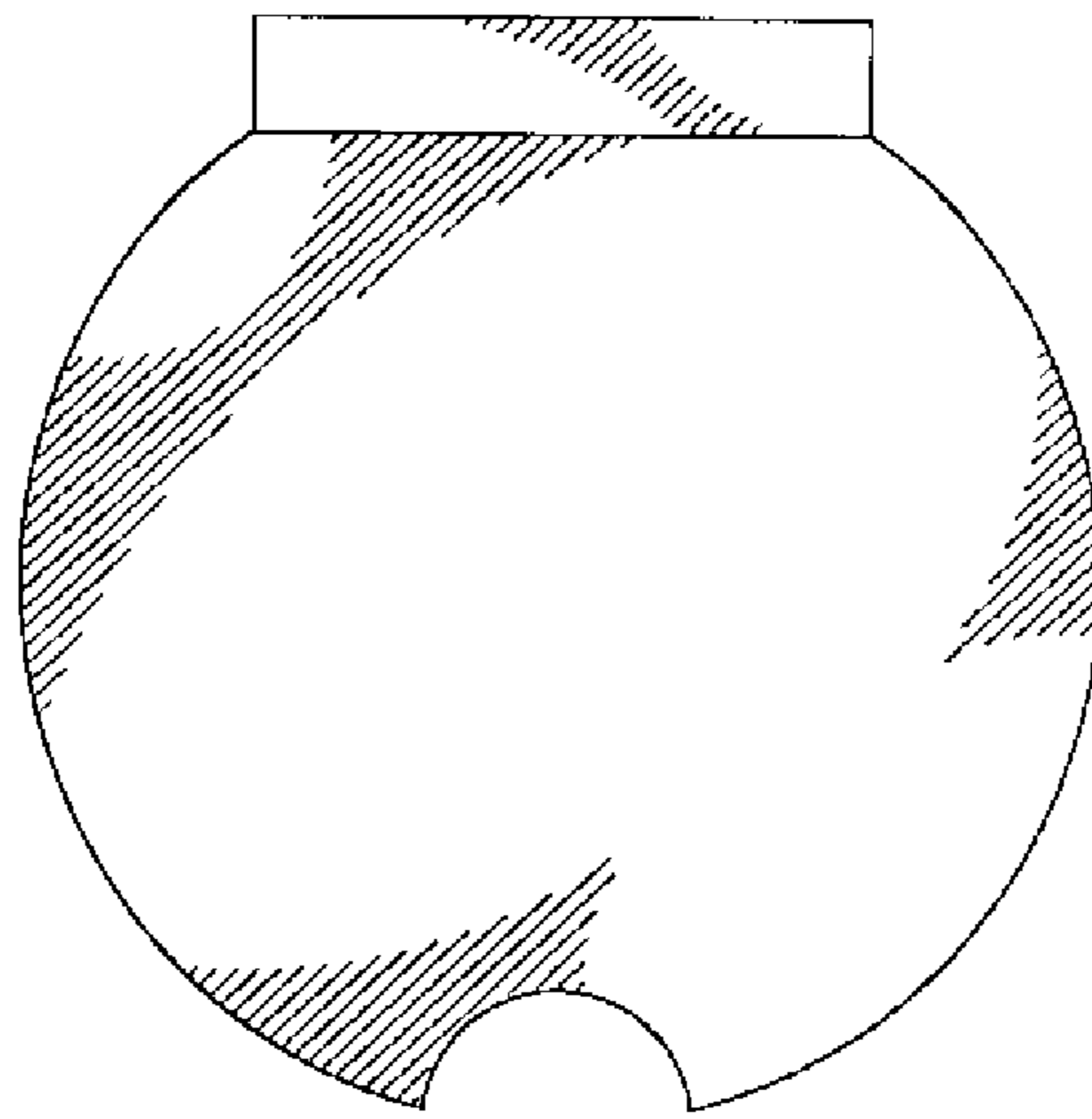

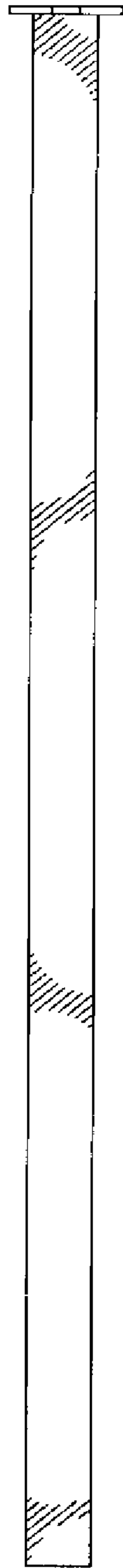

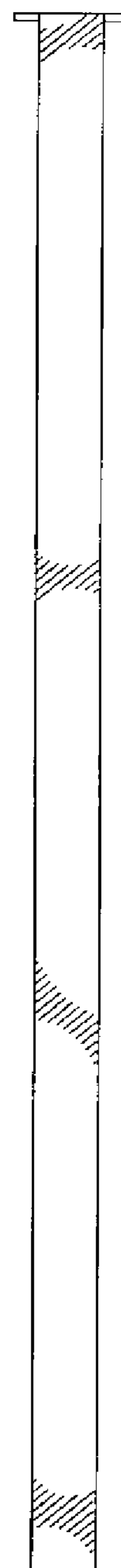

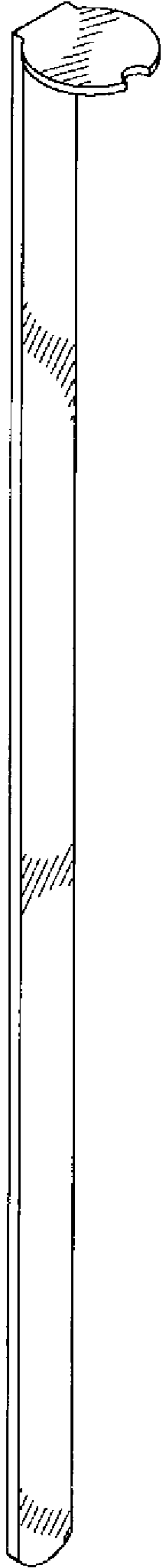

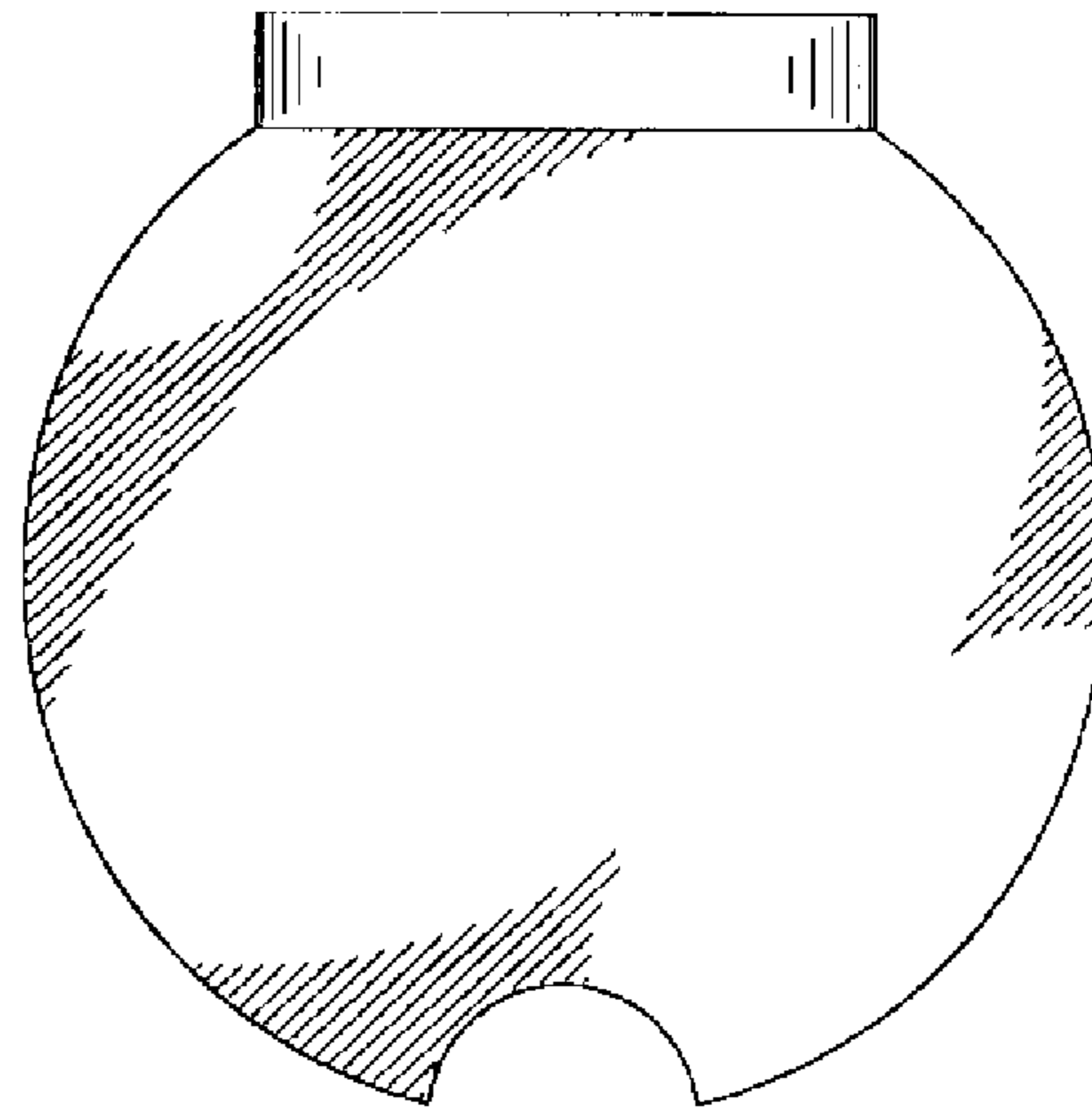

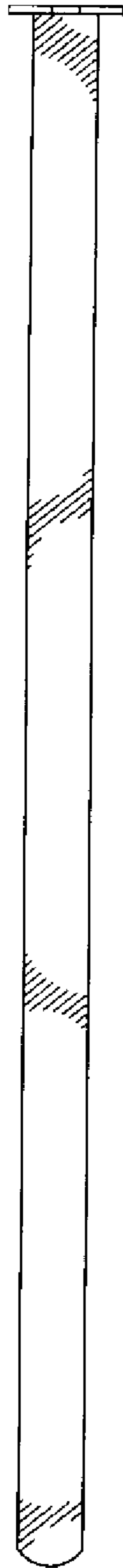

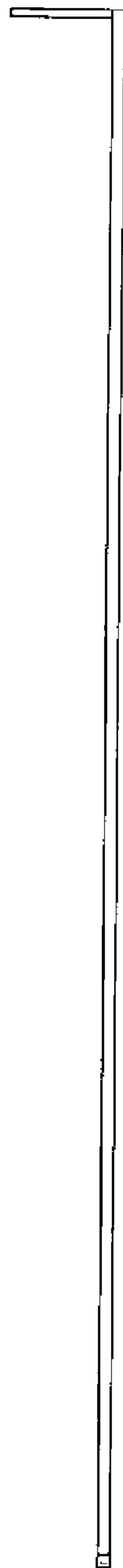

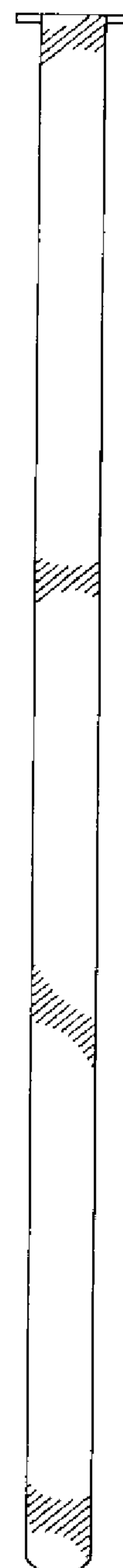

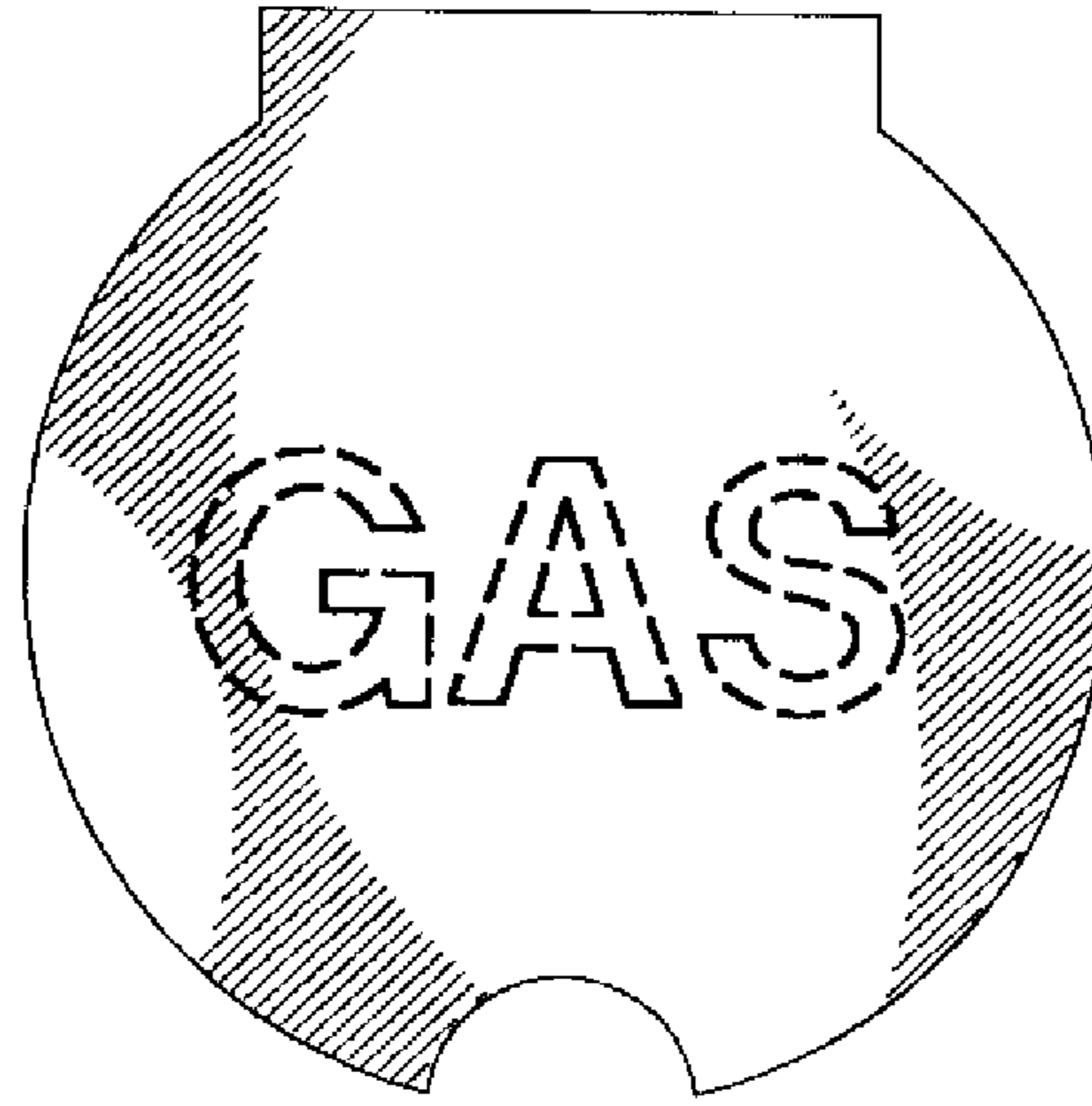

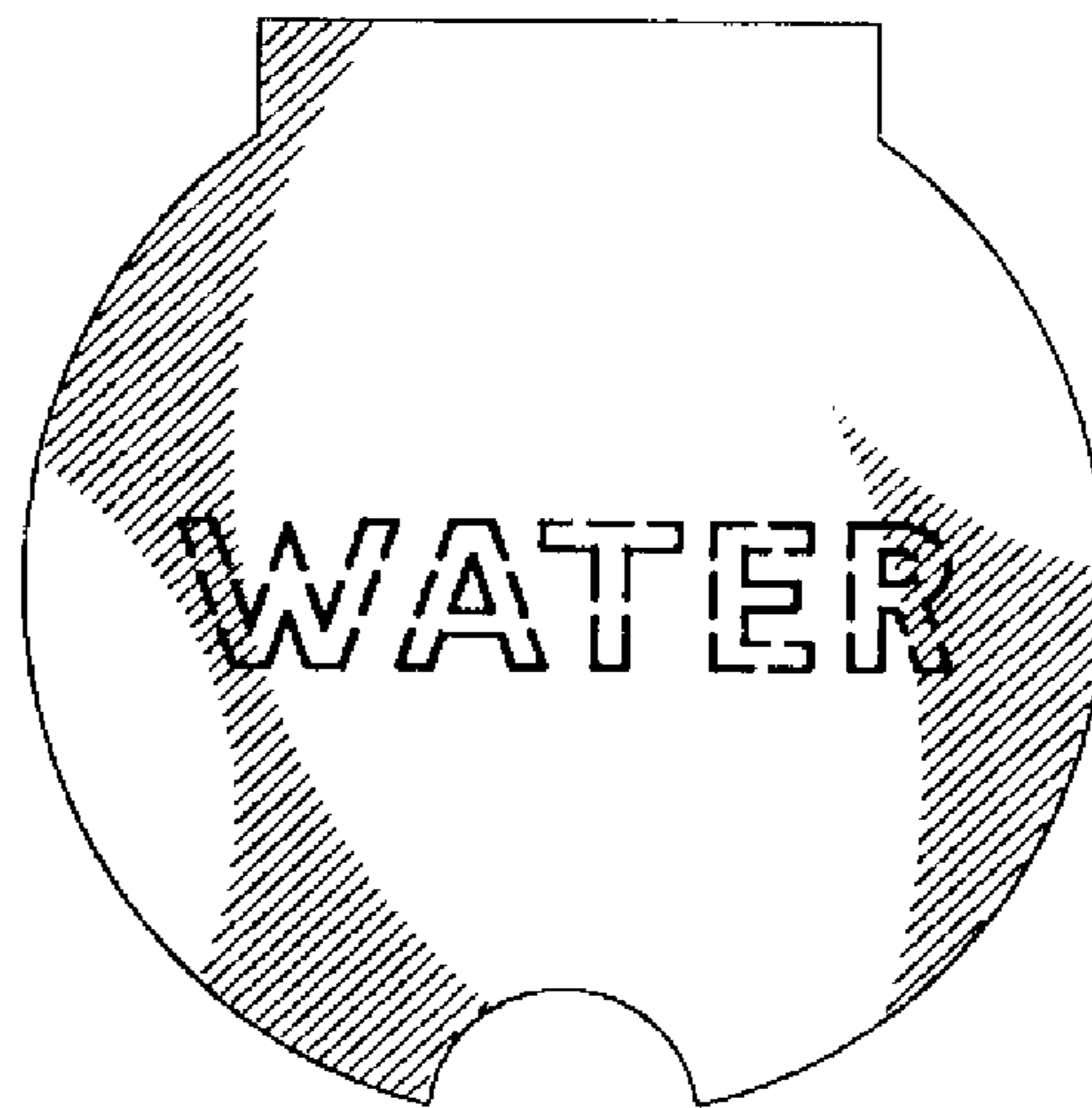
