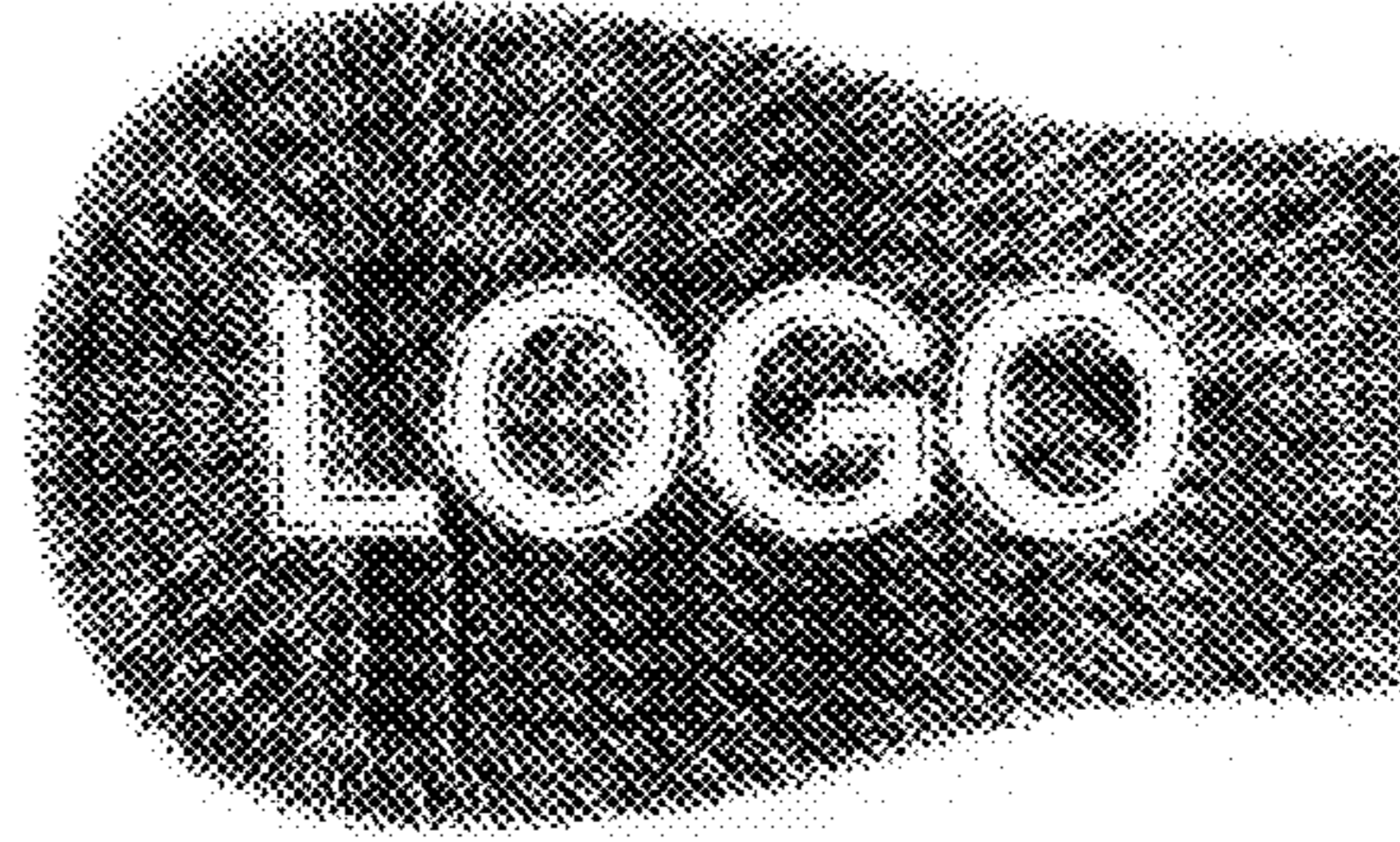
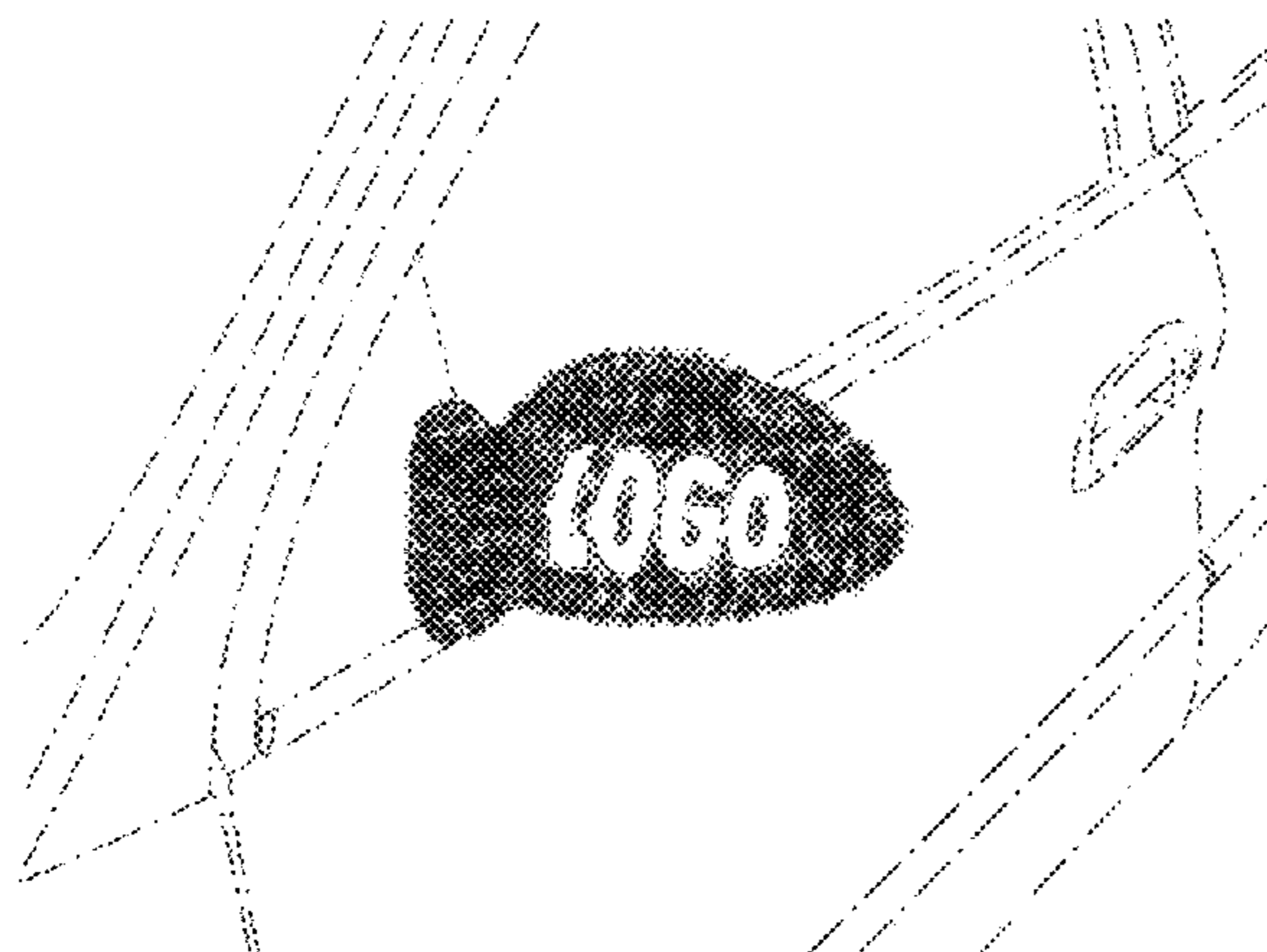
(57) **CLAIM**

The ornamental design for a fuzzy vehicle mirror cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a fuzzy vehicle mirror cover showing my new design mounted on a vehicle;  
FIG. 2 is a back elevational view of the cover shown in FIG. 1;  
FIG. 3 is a top view with the cover in a flatted arrangement, the bottom view being the same;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a back elevational view thereof;  
FIG. 6 is a right elevational view thereof; and,  
FIG. 7 is a front elevational view thereof.  
In the drawings, the broken lines depict a vehicle and portions of the fuzzy vehicle mirror cover that form no part of the claim.

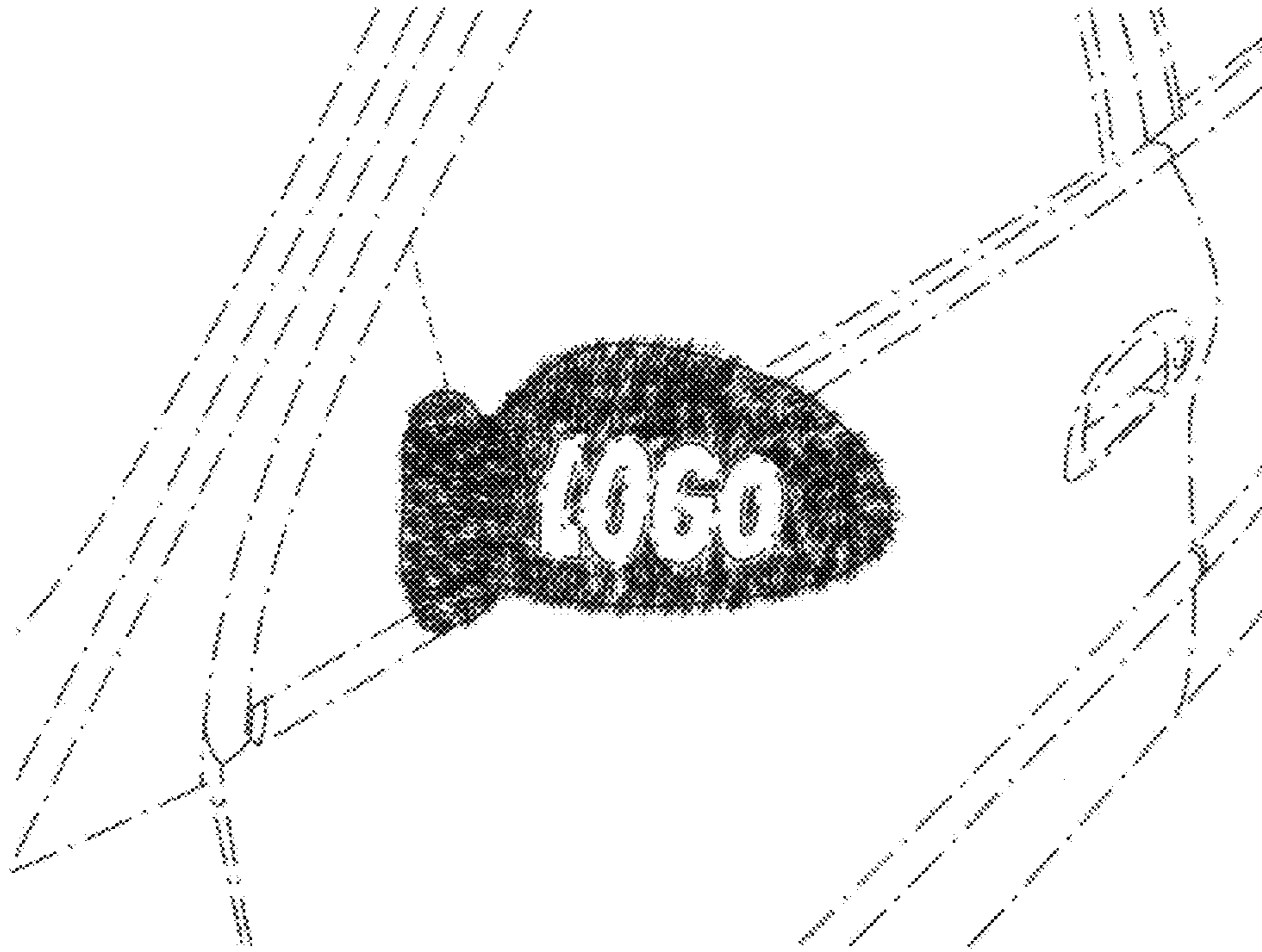

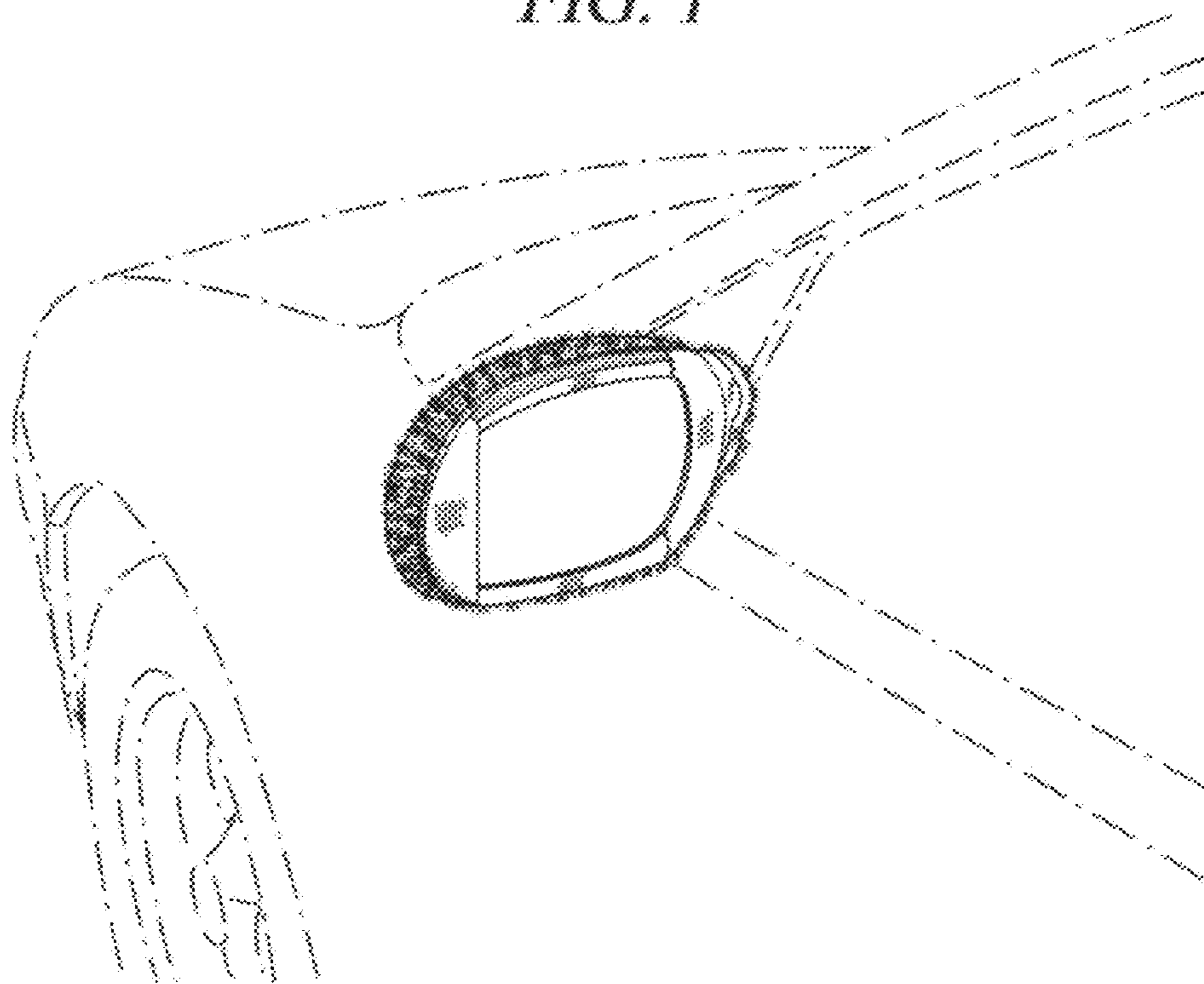

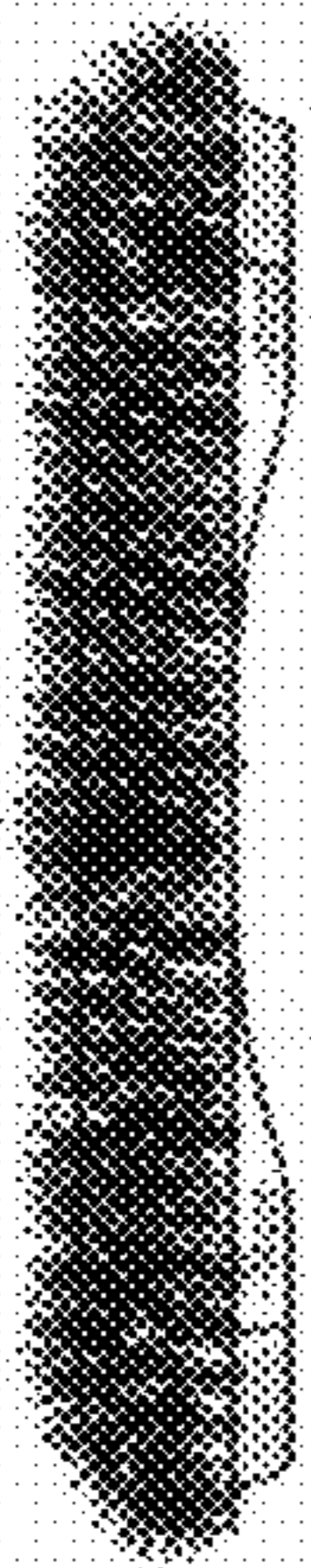

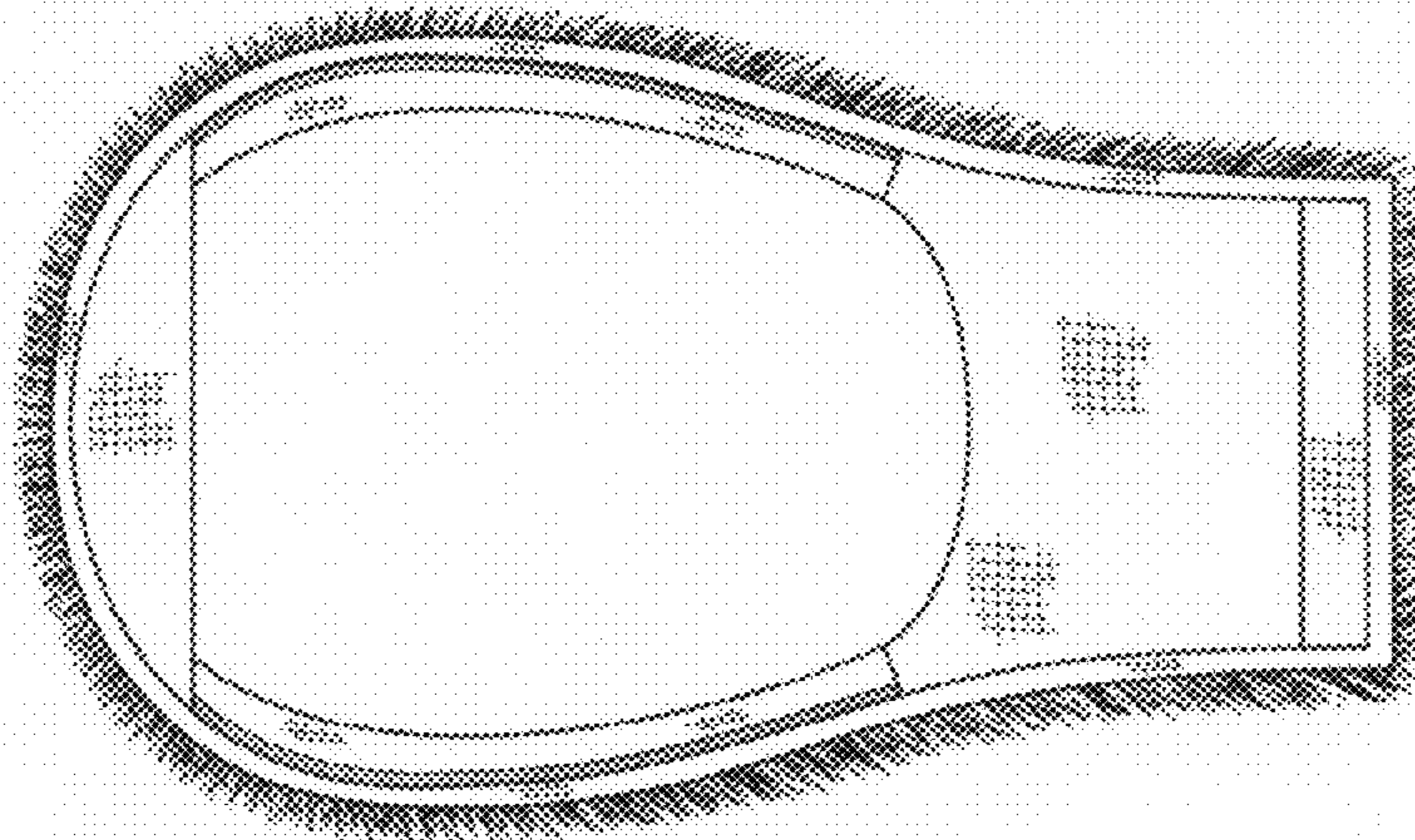

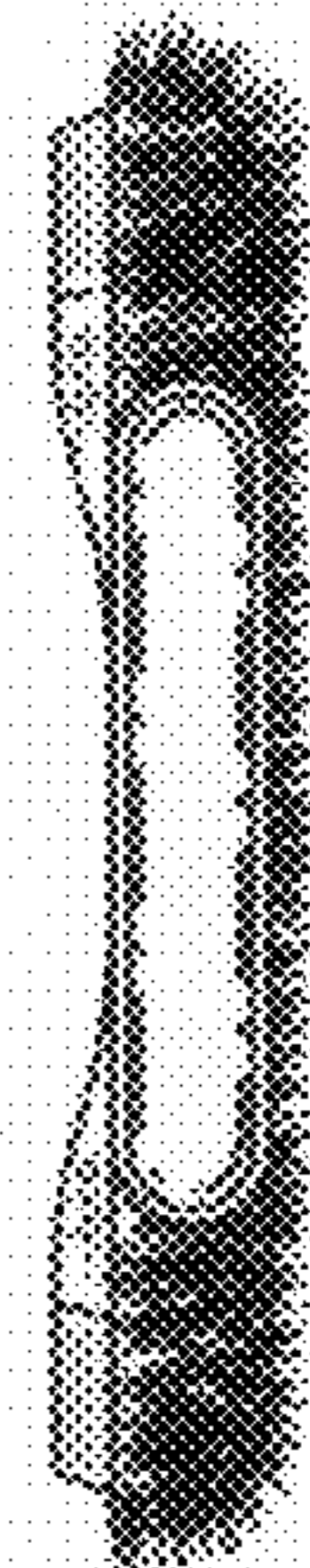

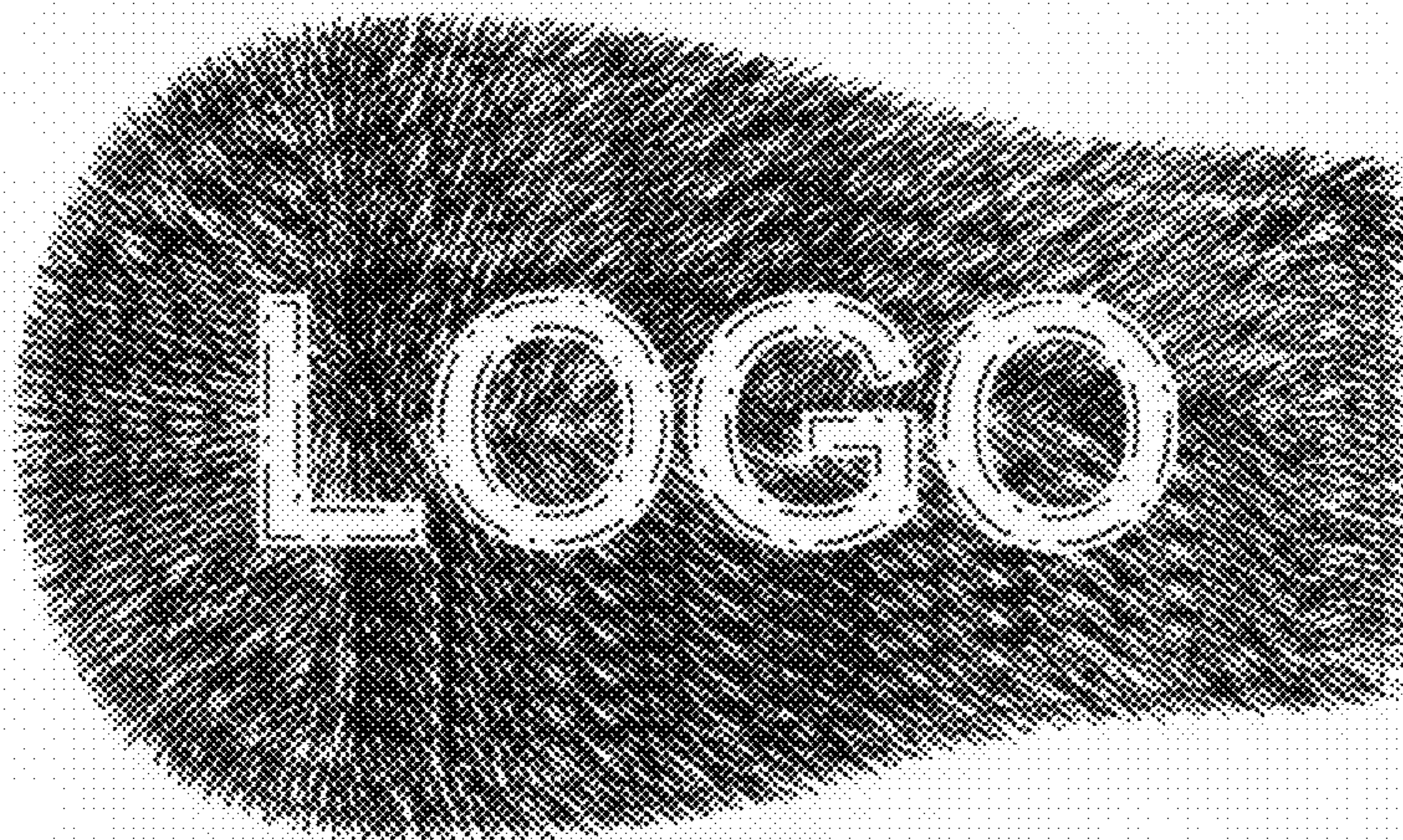
