(57) **CLAIM**

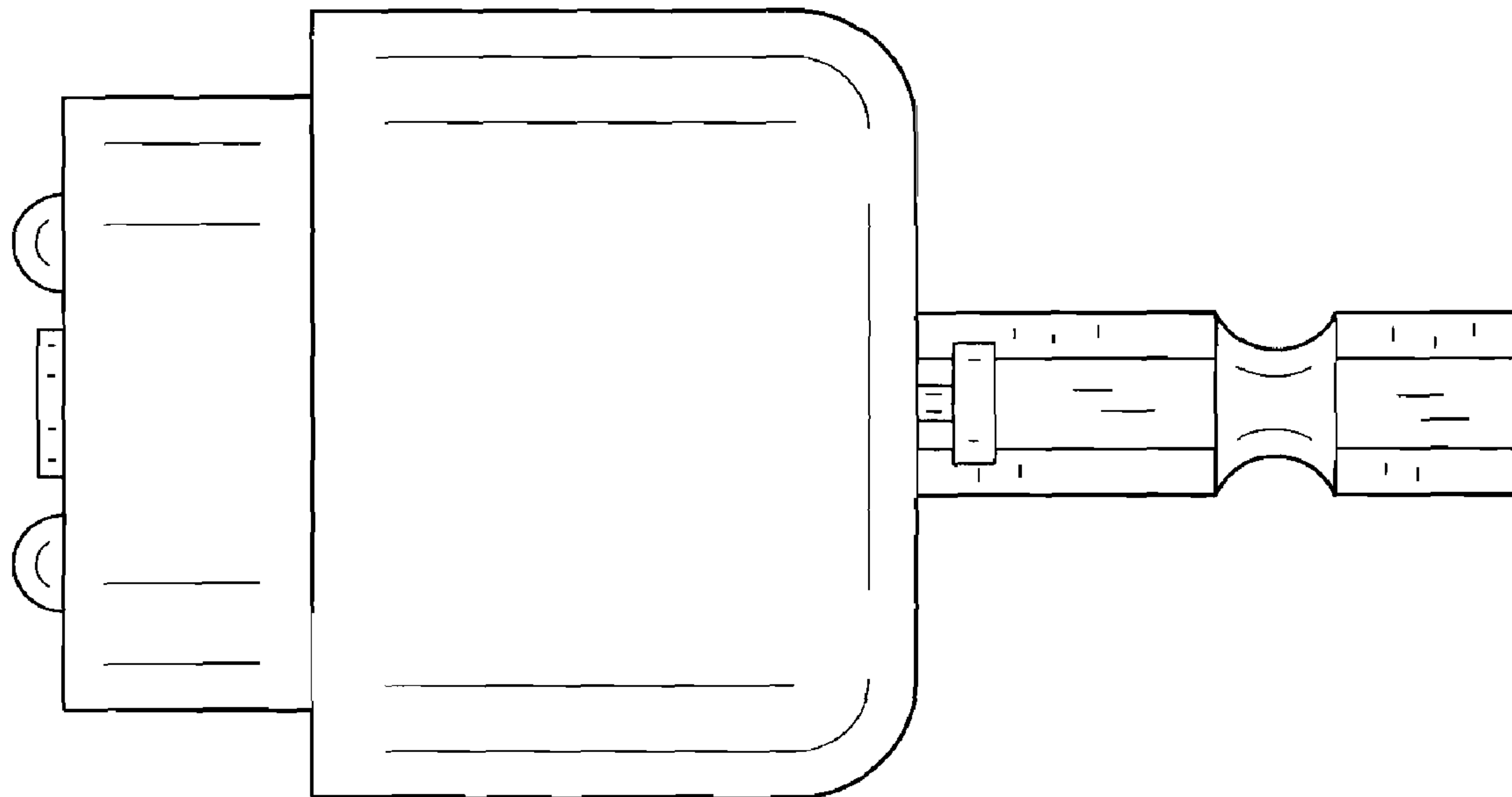
The ornamental design for a light emitting tool chuck, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom plan view of a light emitting tool chuck showing my new design; FIG. 2 is a top plan view of the light emitting tool chuck; FIG. 3 is a front elevation view of the light emitting tool chuck; FIG. 4 is a rear elevation view of the light emitting tool chuck; FIG. 5 is a left side elevation view of the light emitting tool chuck; and, FIG. 6 is a right side elevation view of the light emitting tool chuck.

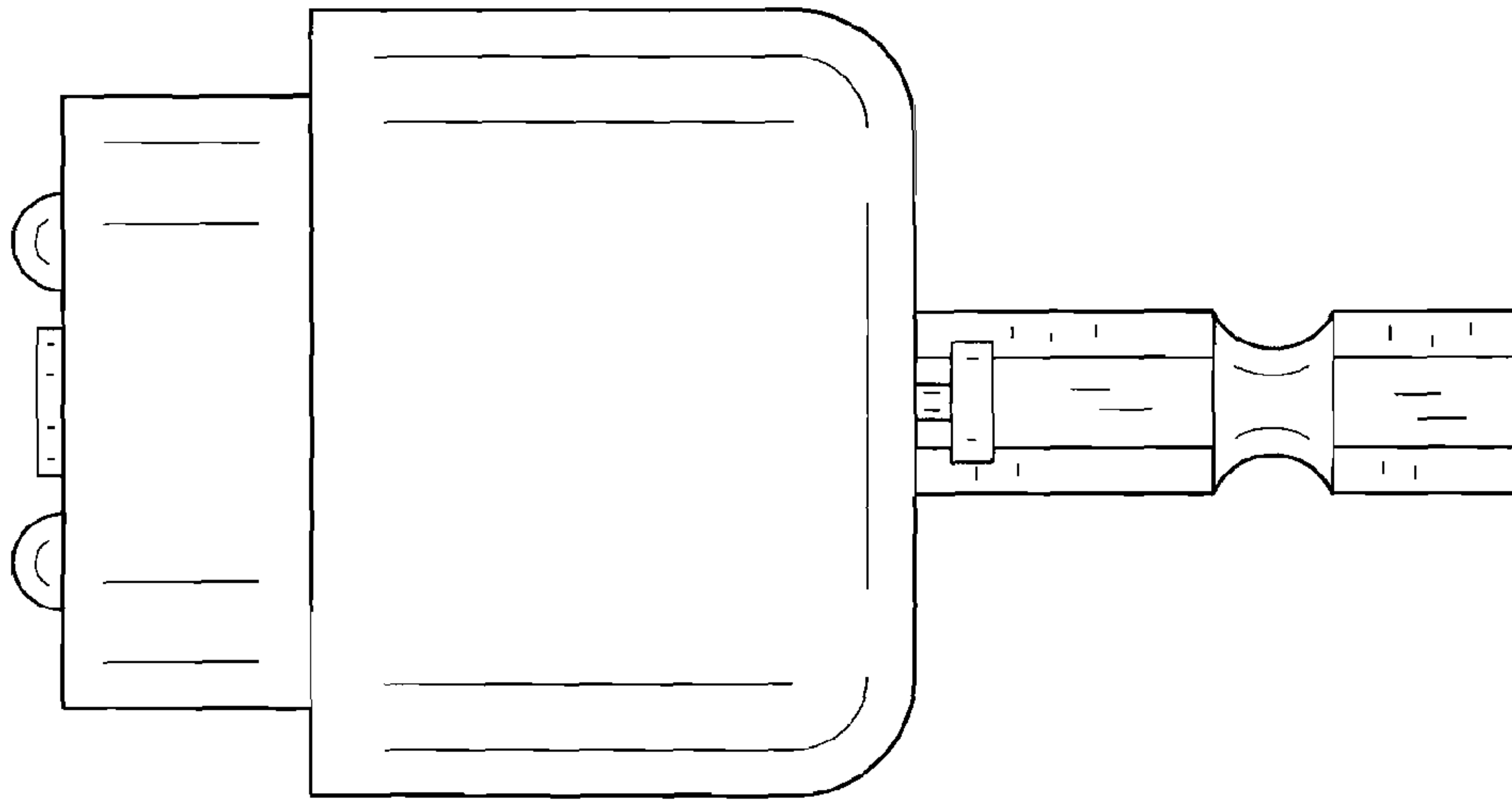

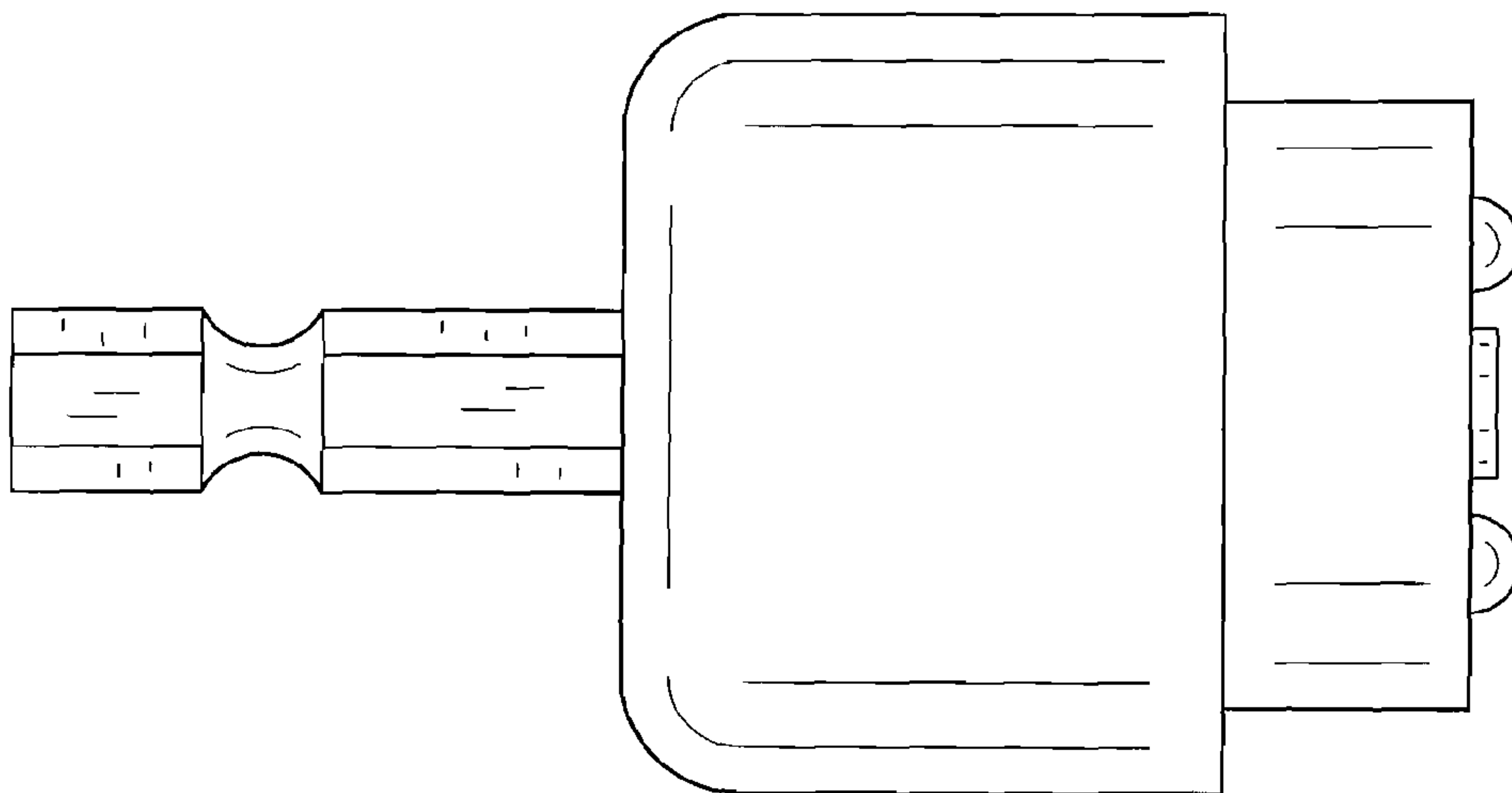

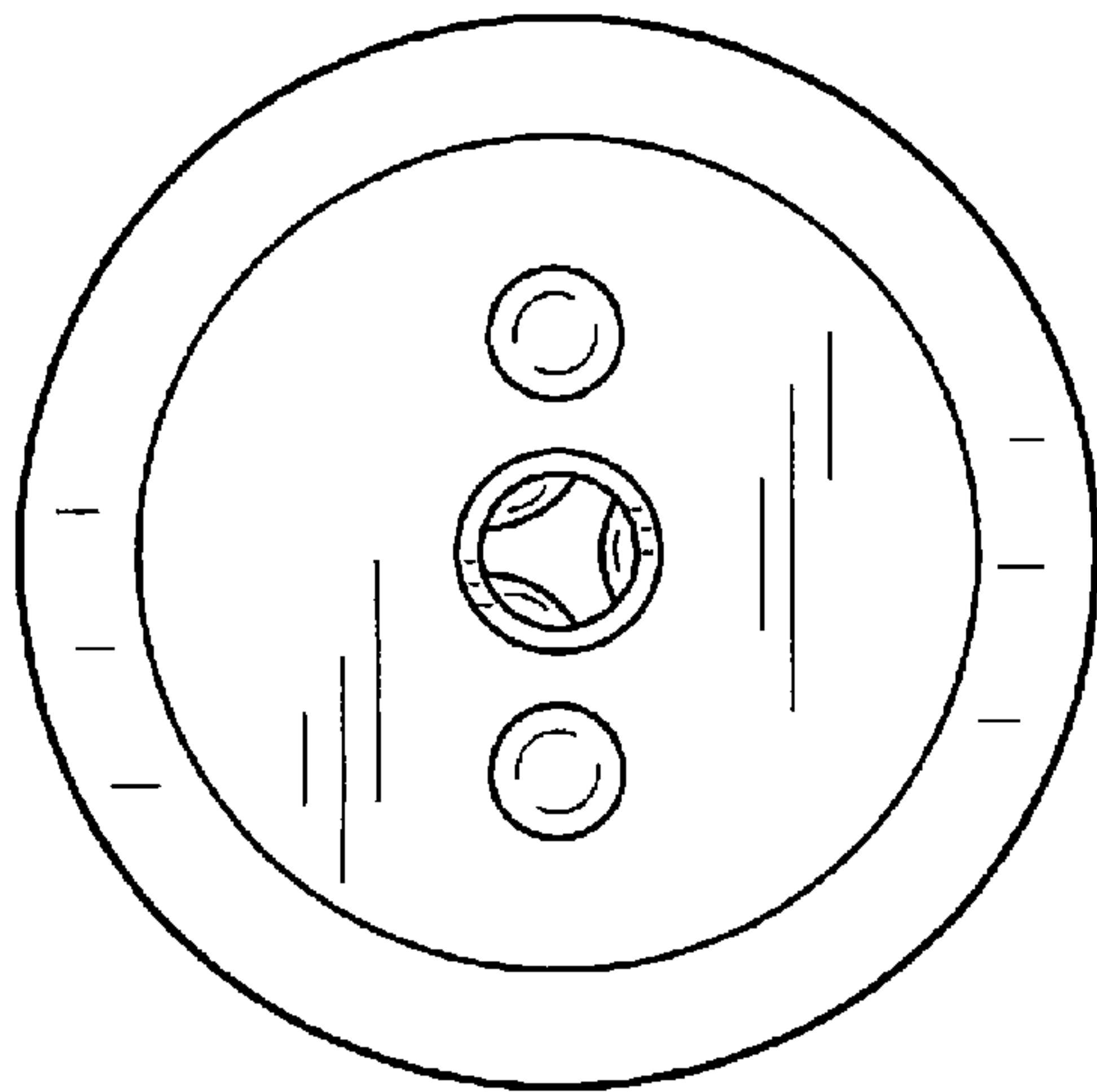

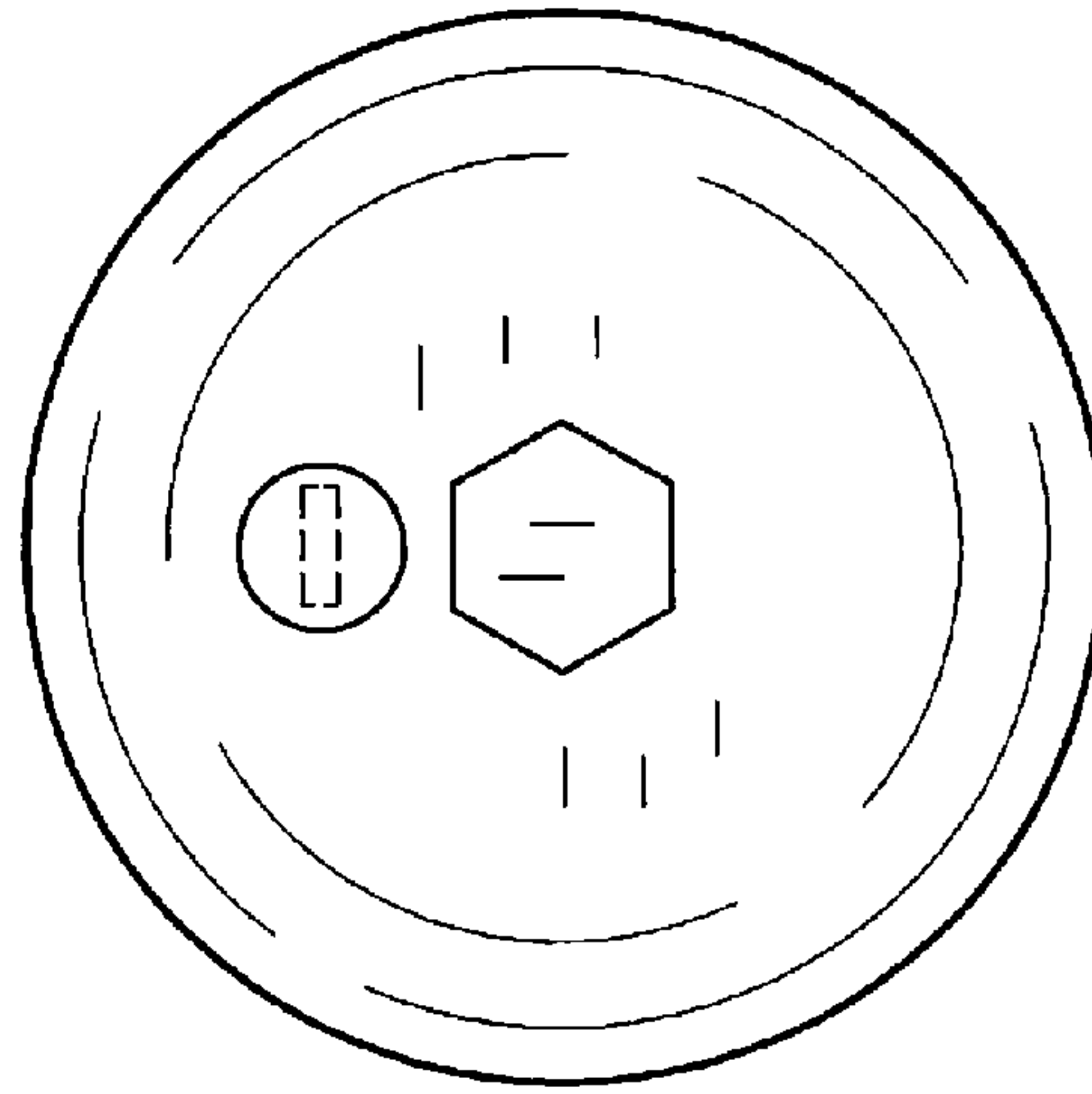

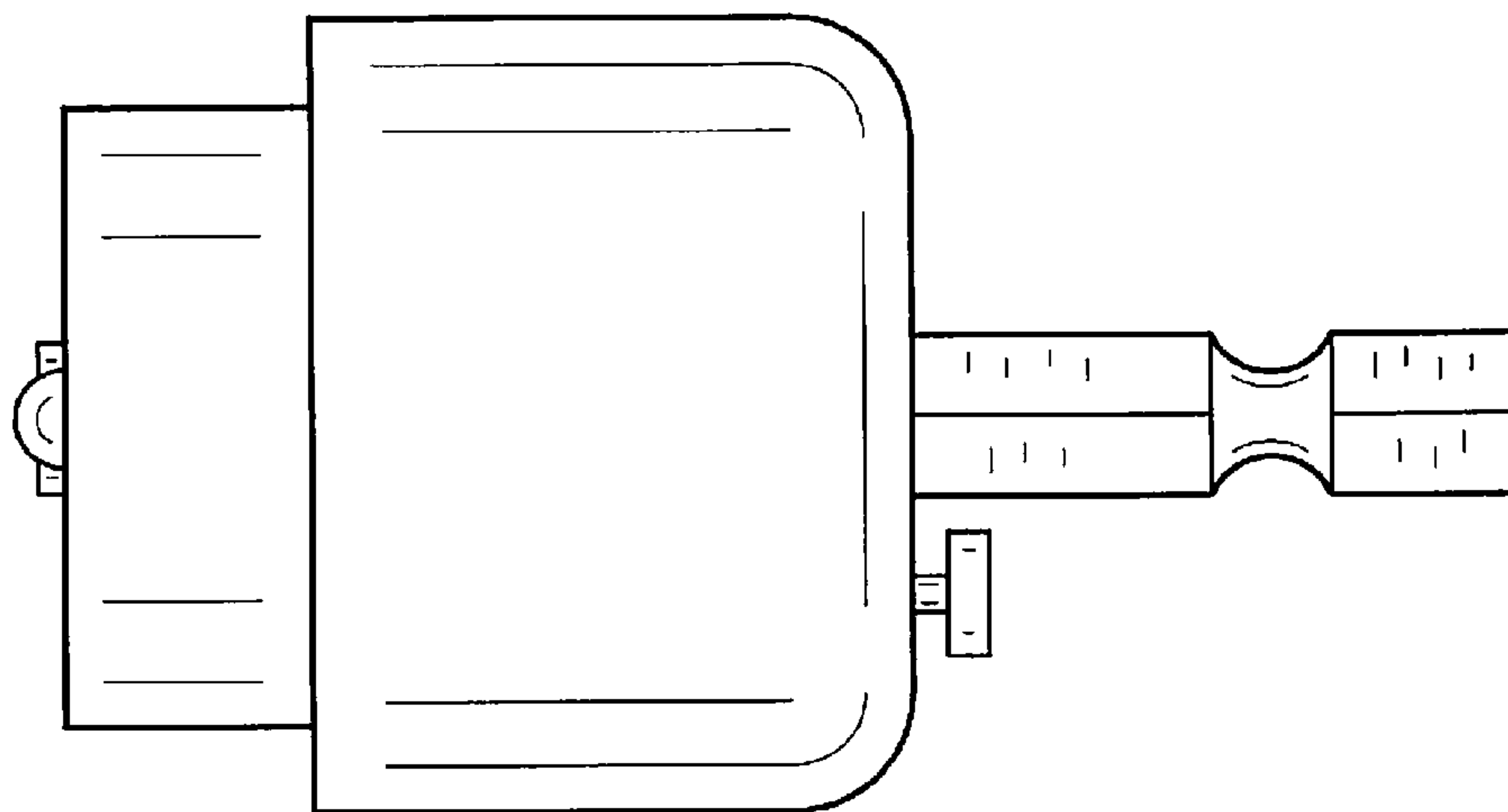

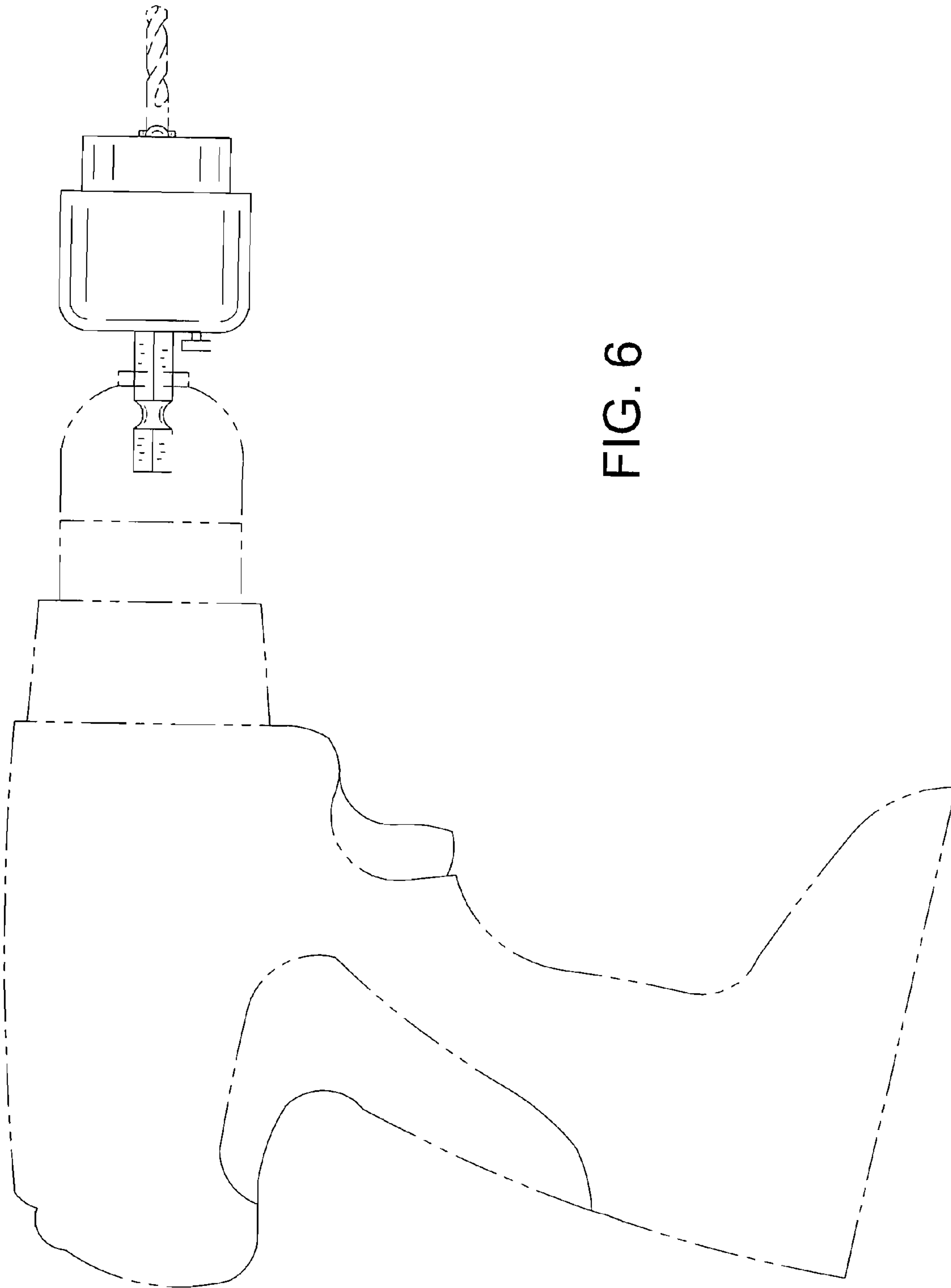
