FIG. 2 illustrates another tilted side view of the sink faucet in FIG. 1.

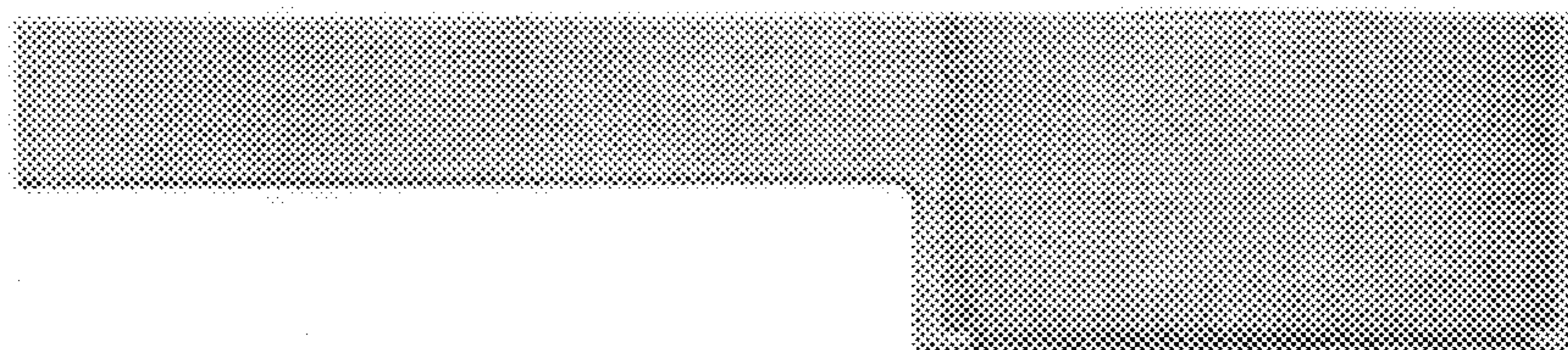
FIG. 3 illustrates a front view of the sink faucet in FIG. 1.

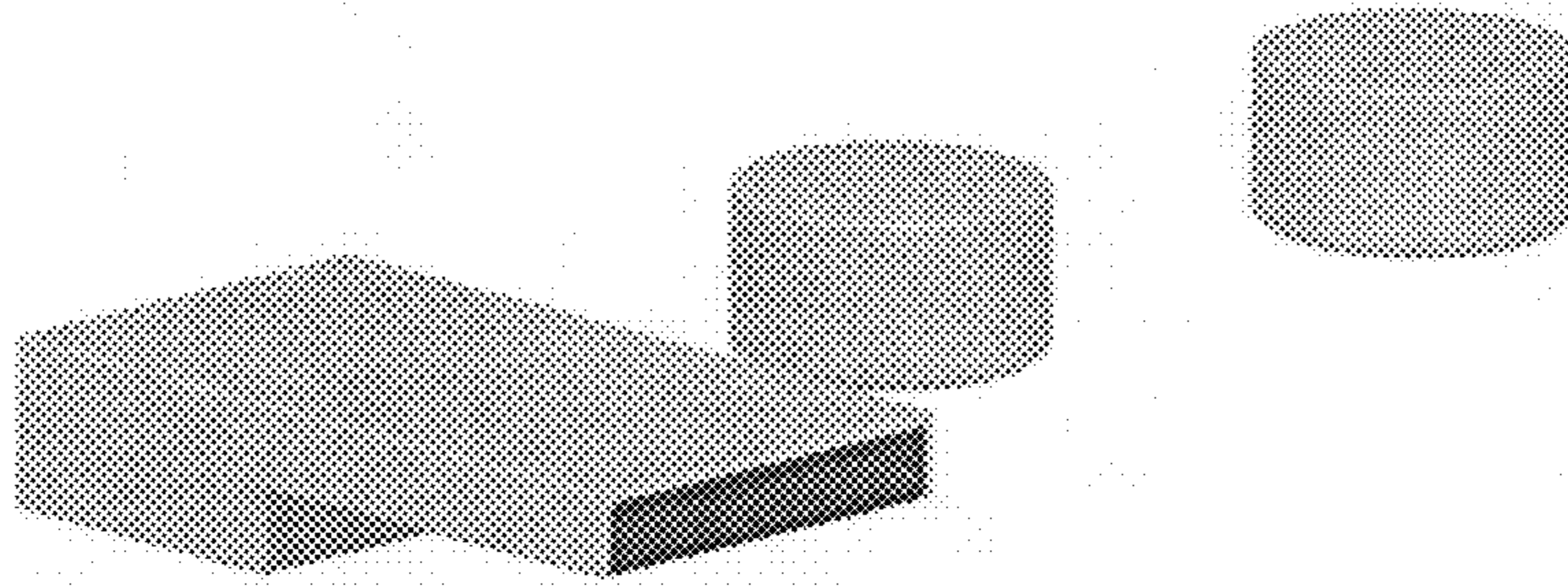

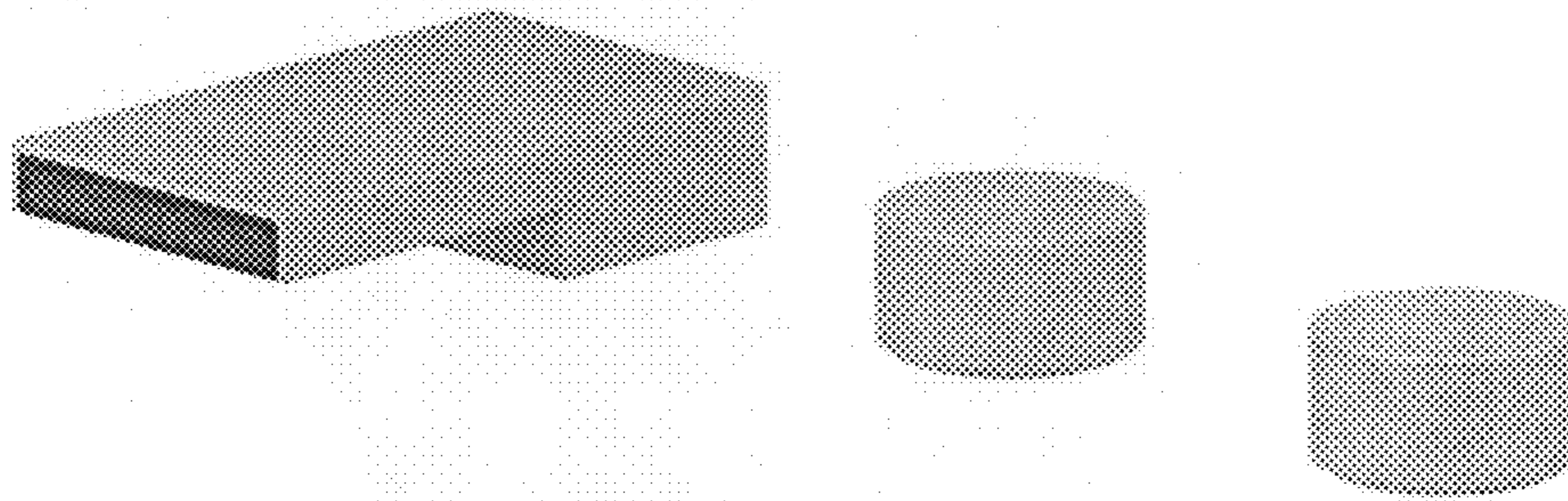

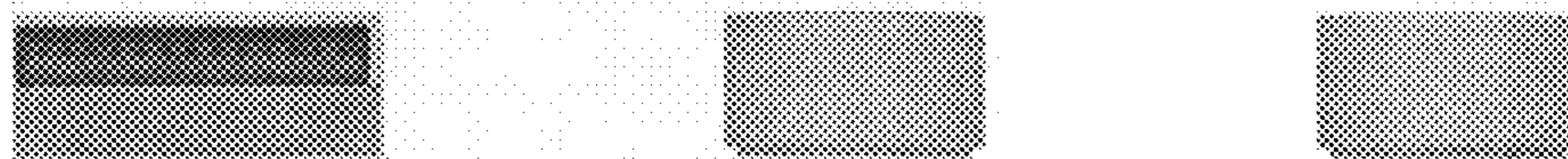

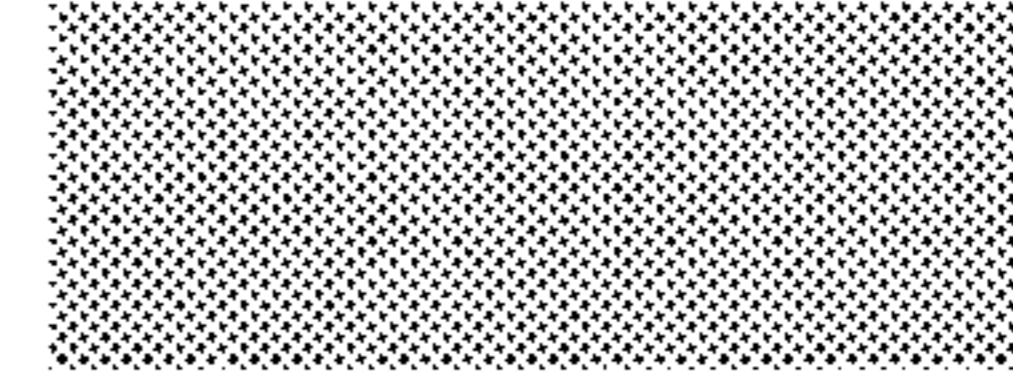
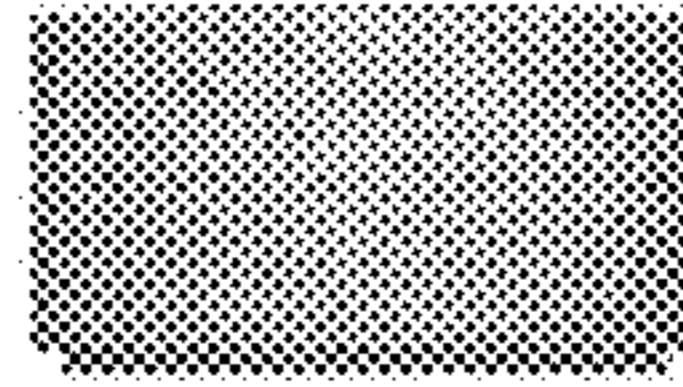
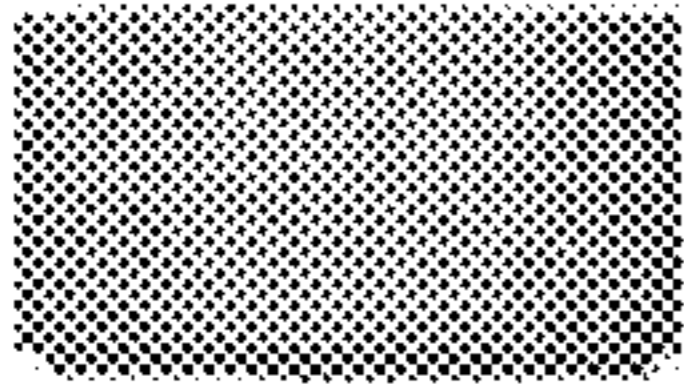

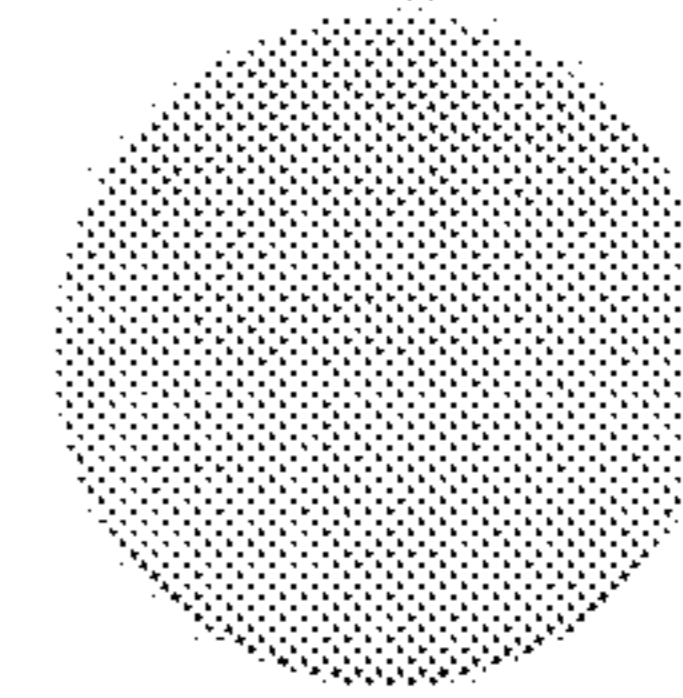
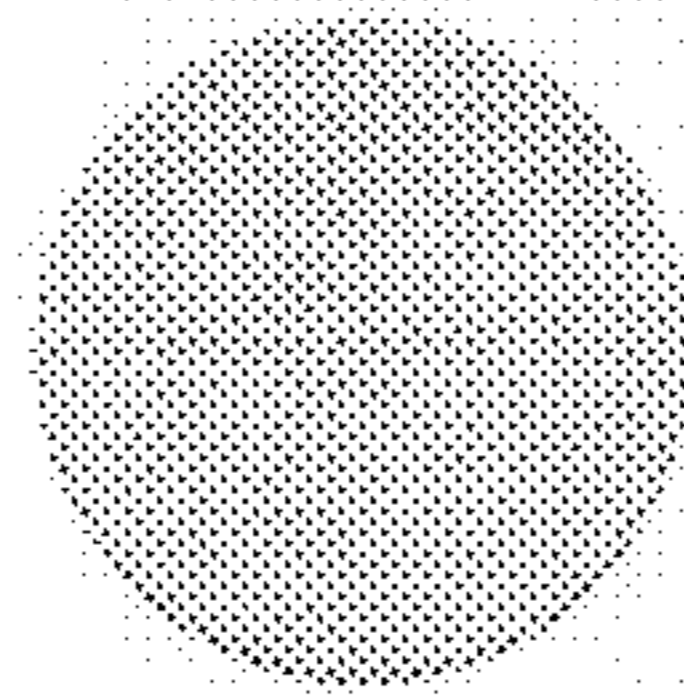
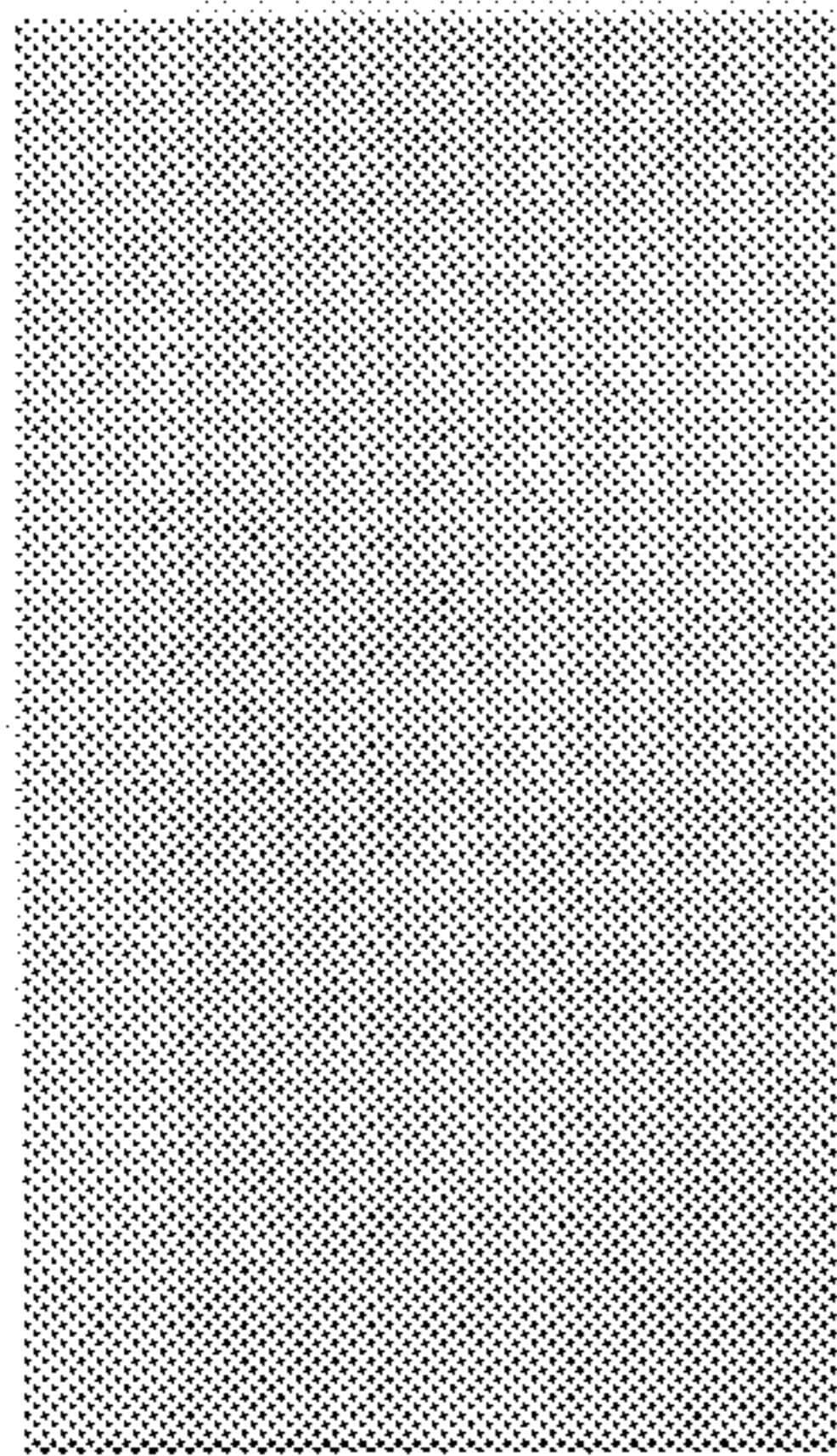
