The ornamental design for an LED desk light, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front and right side of the LED desk light.

FIG. 2 is a right side view thereof.

FIG. 3 is a left side view thereof, 180 degrees from FIG. 2.

FIG. 4 is a front view thereof.

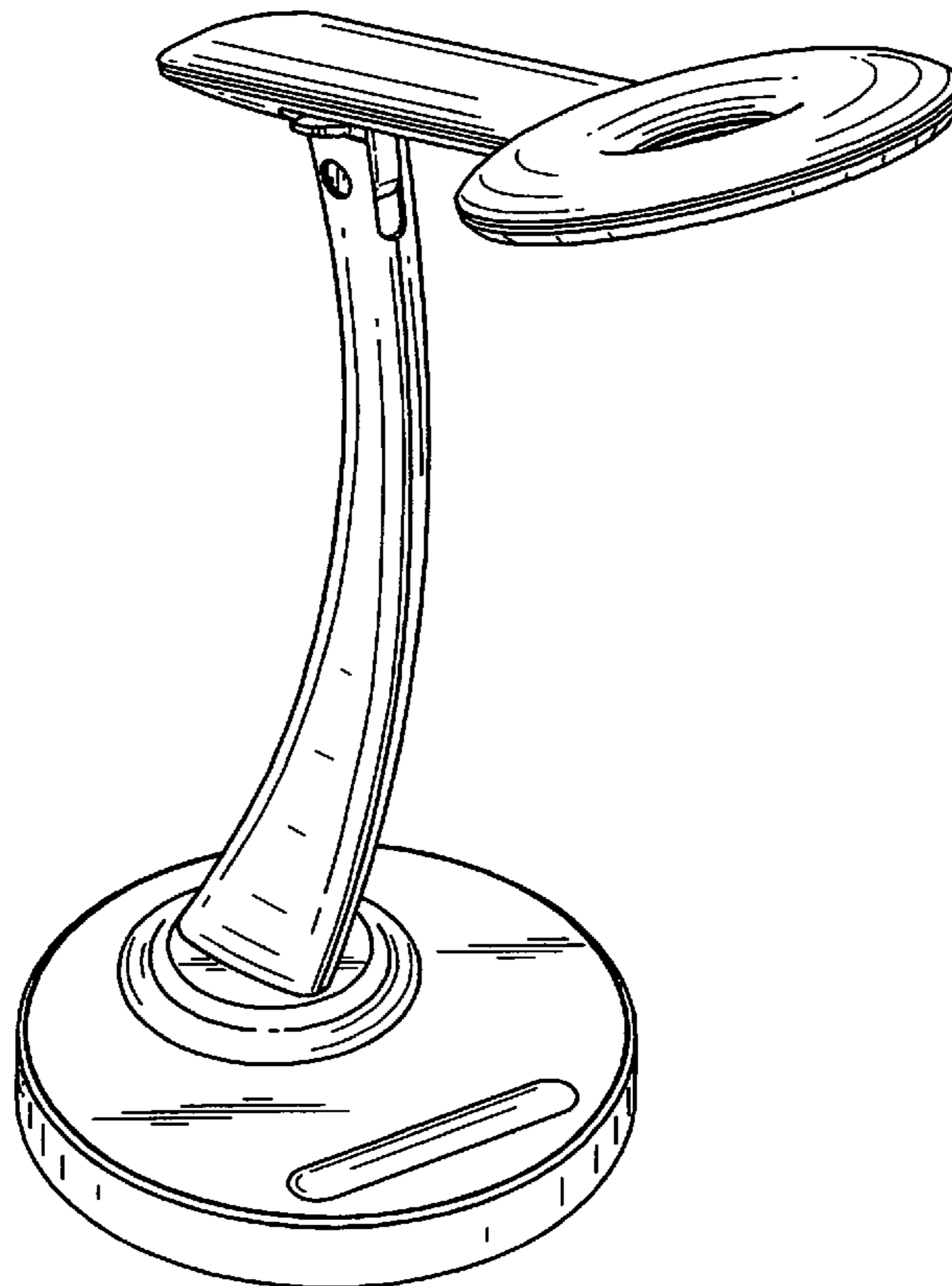
FIG. 5 is a rear view thereof.

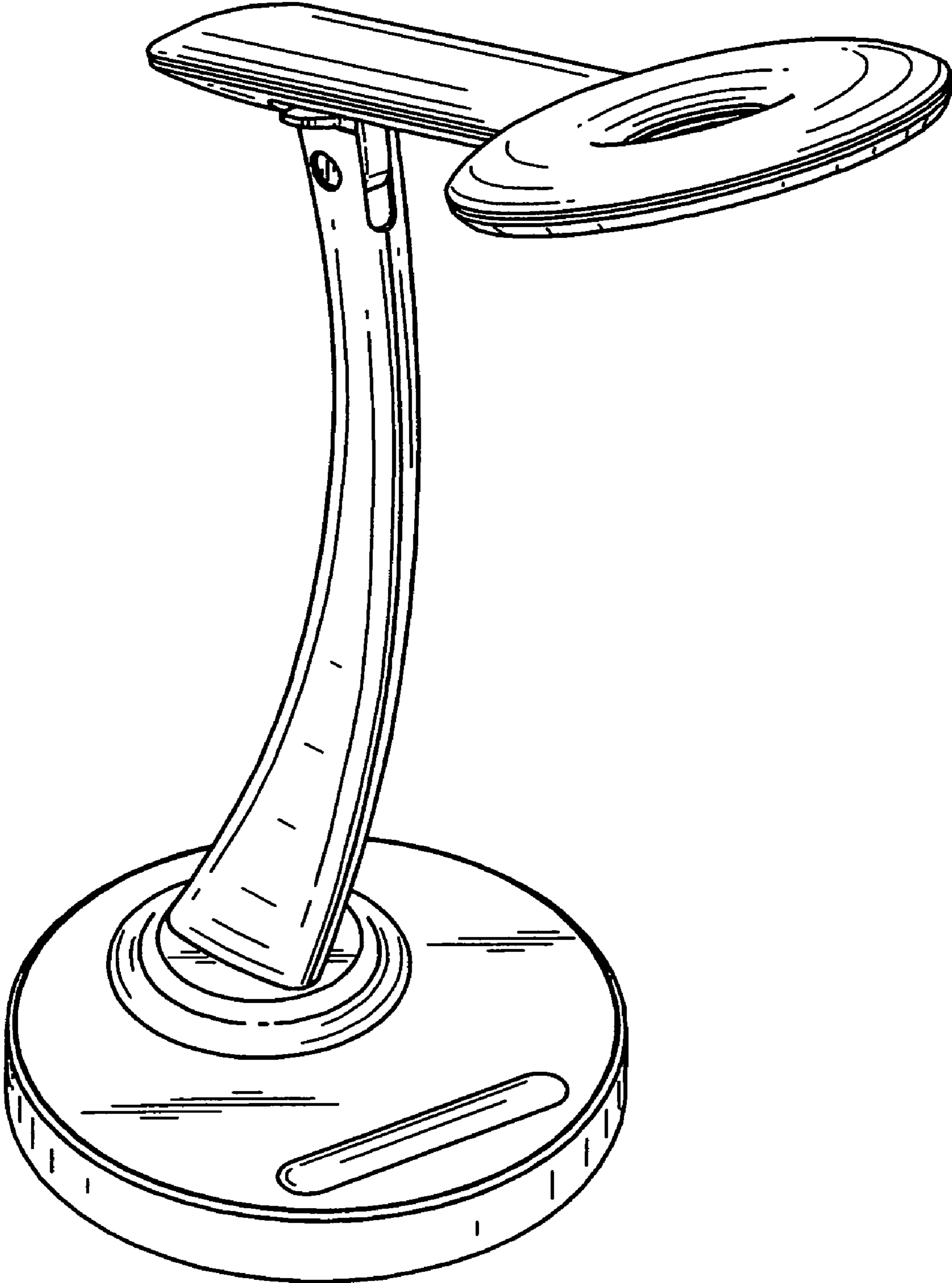

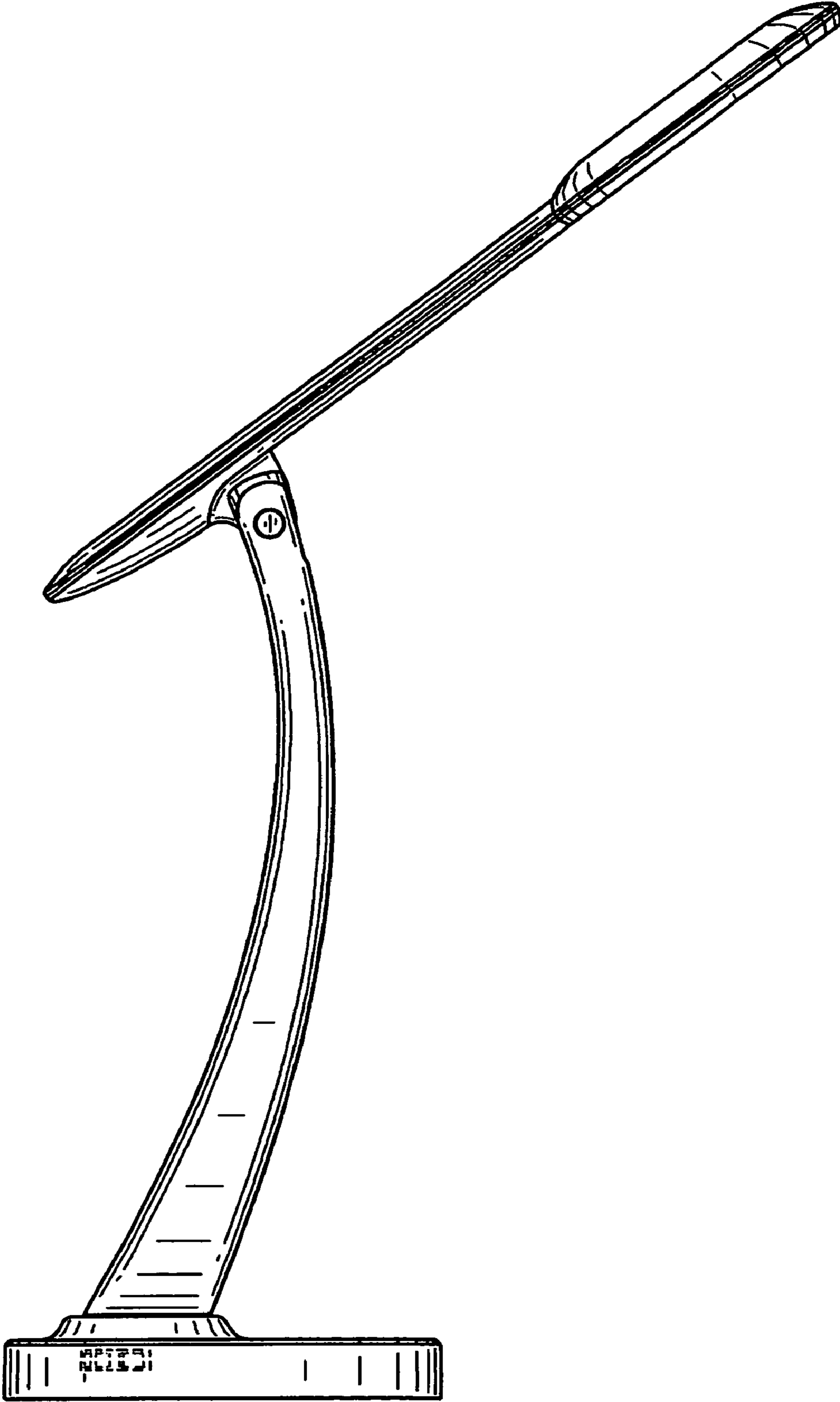

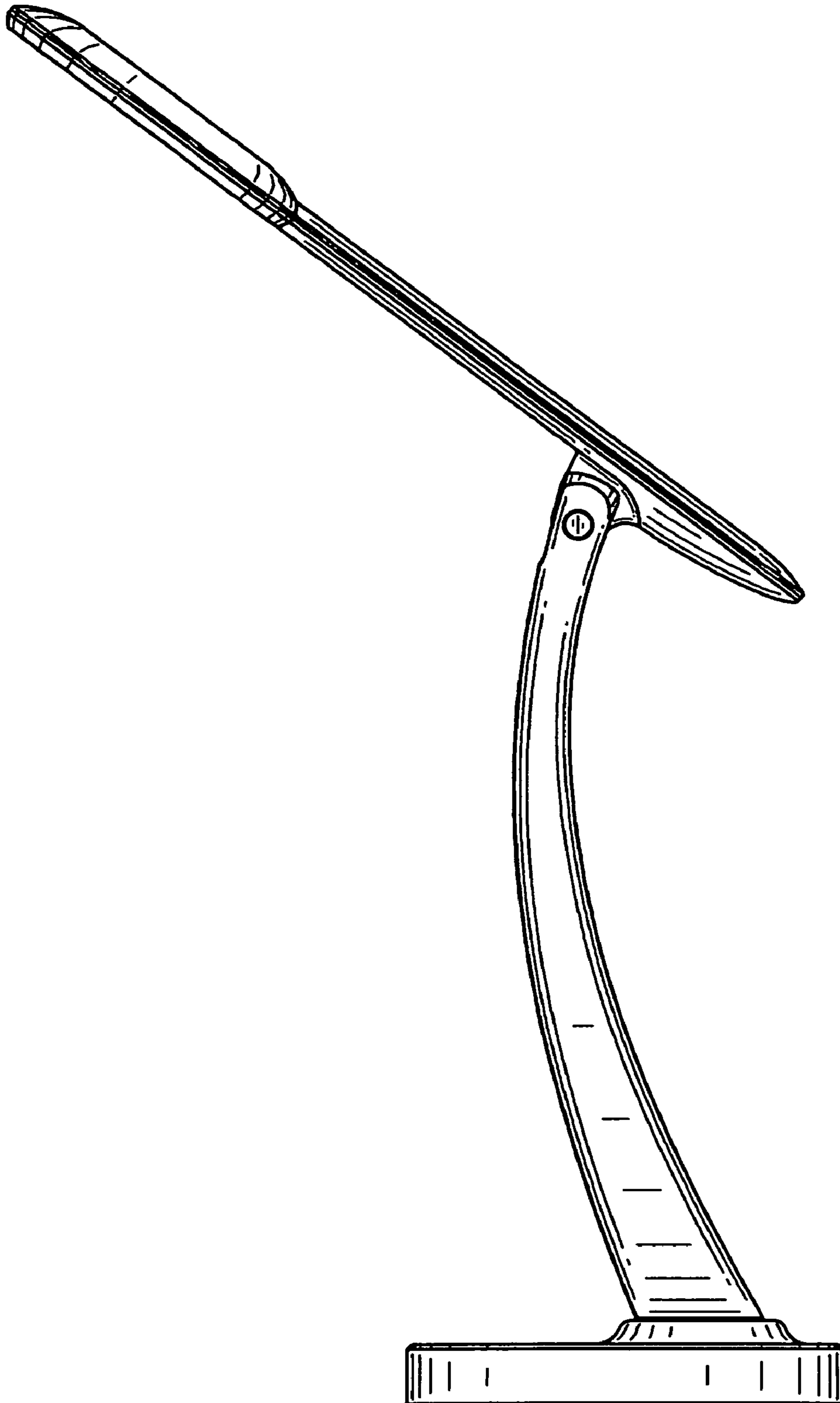

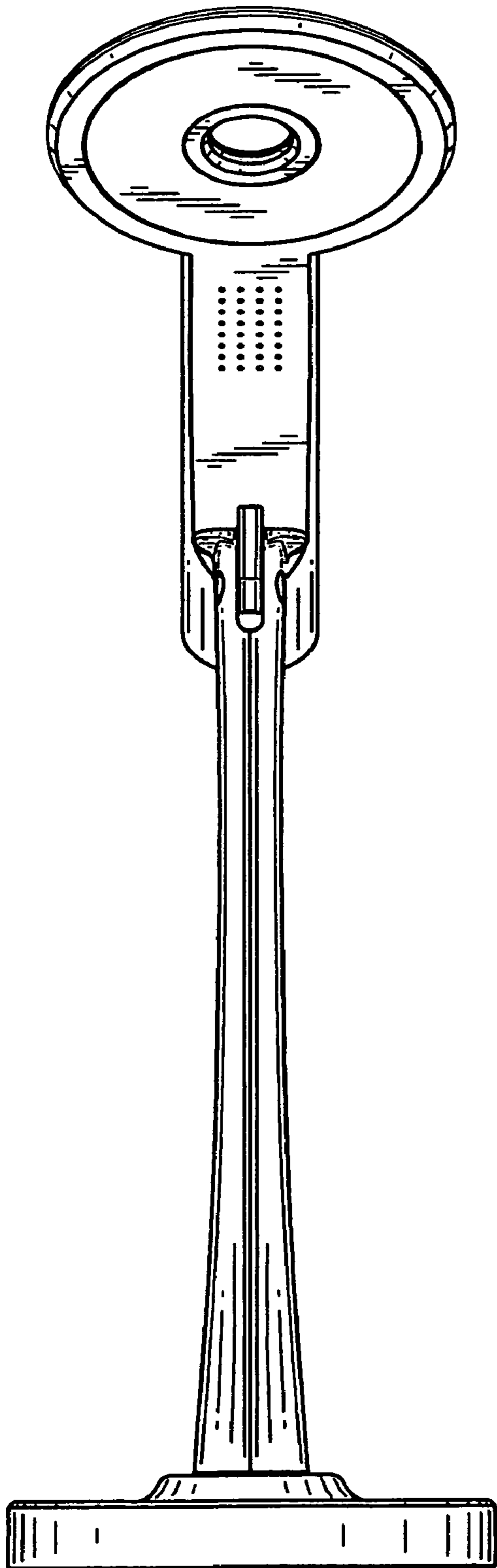

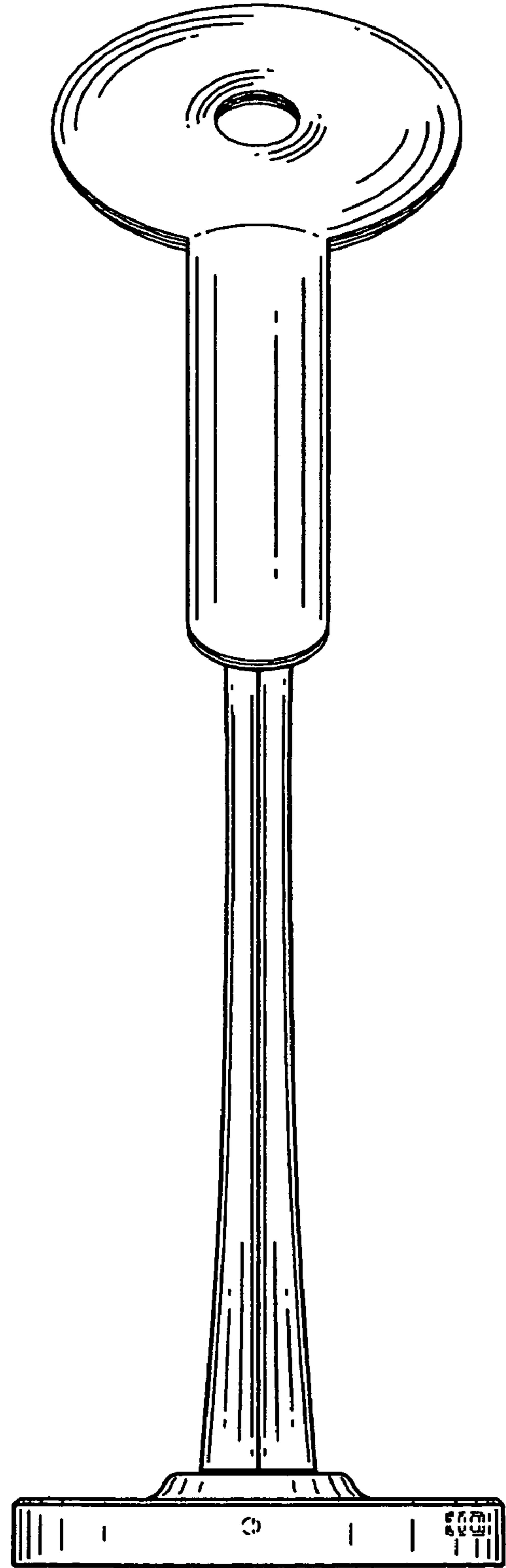

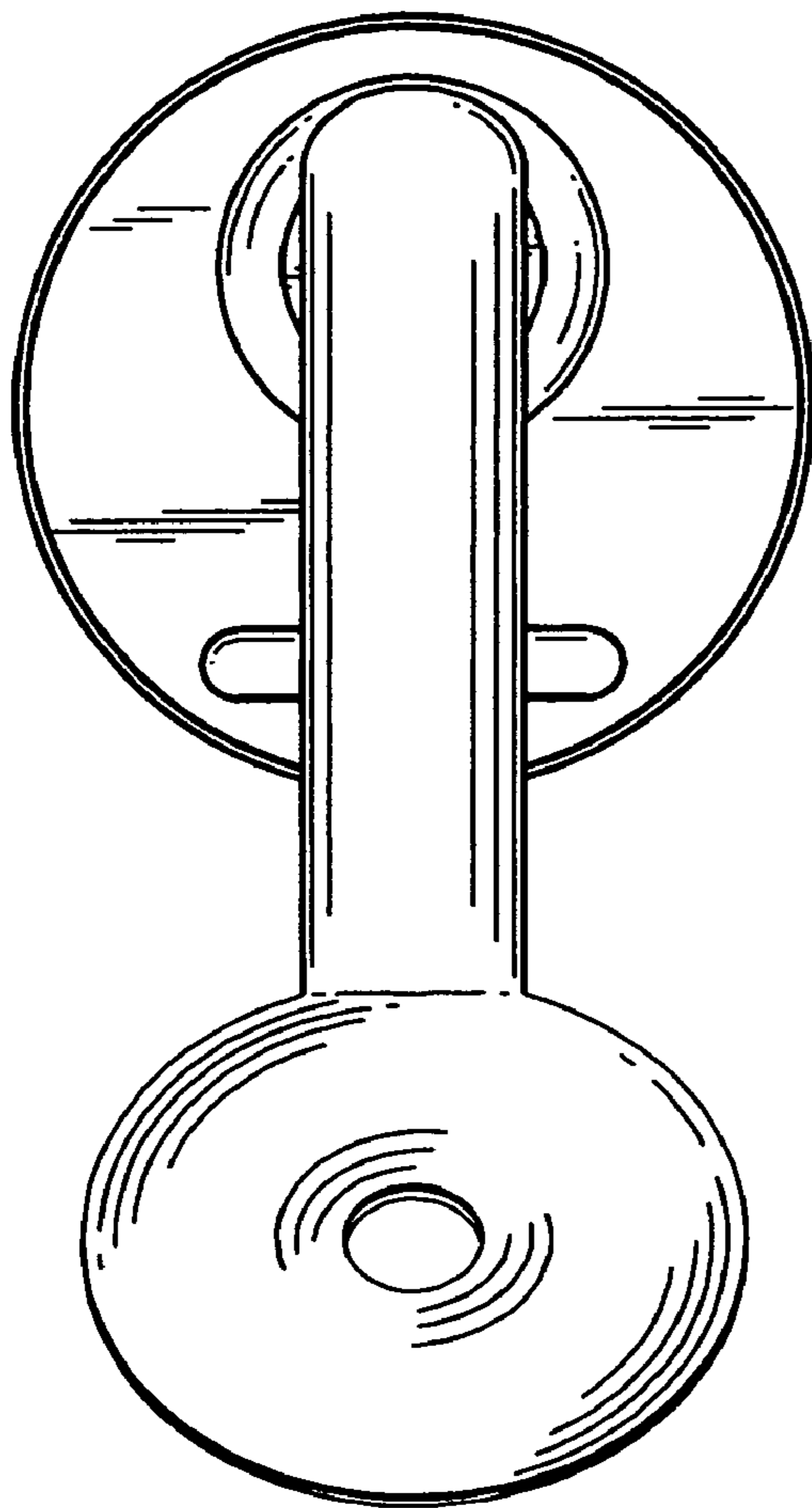

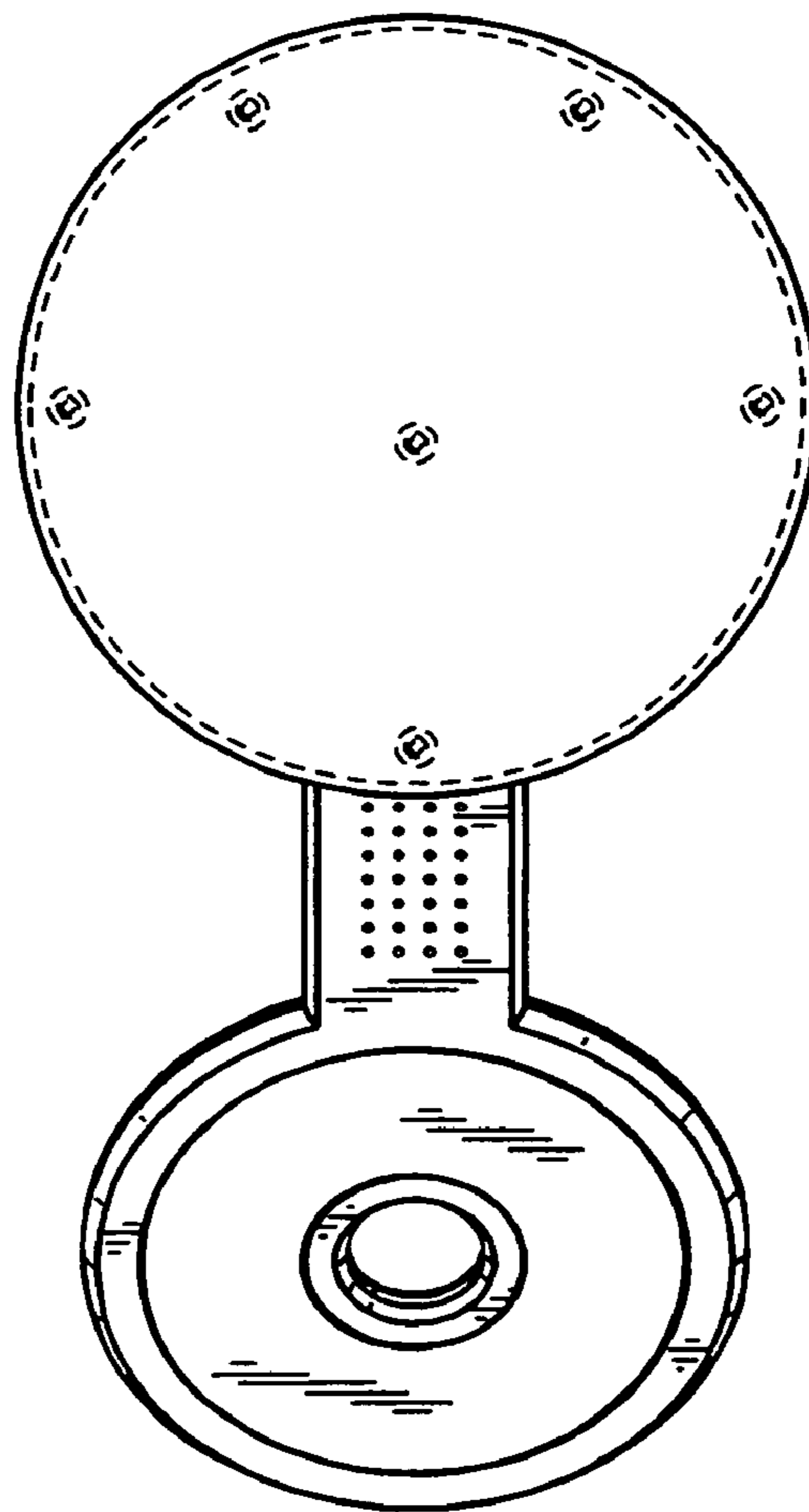
