The ornamental design for a jacket, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a jacket according to a first embodiment;

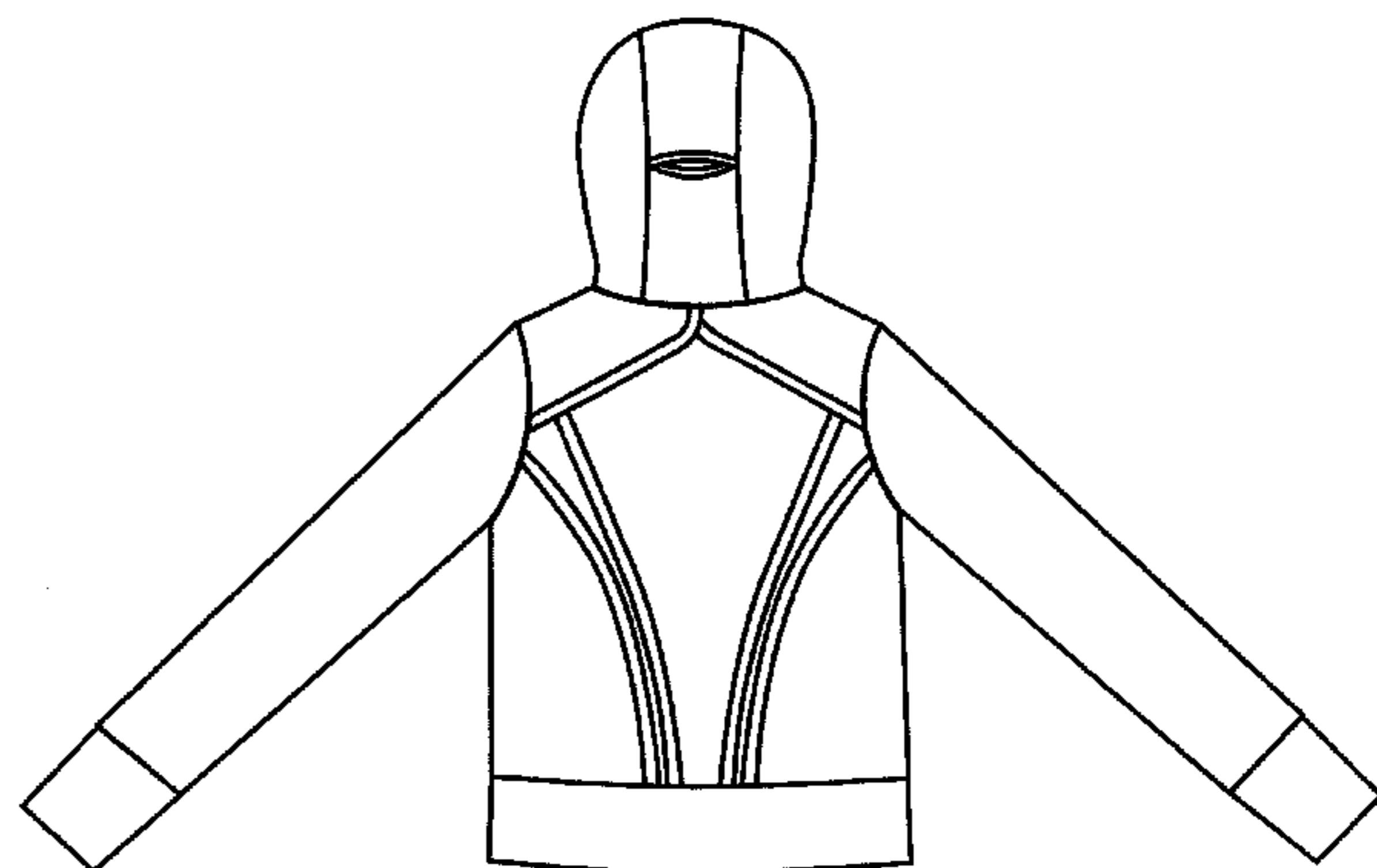
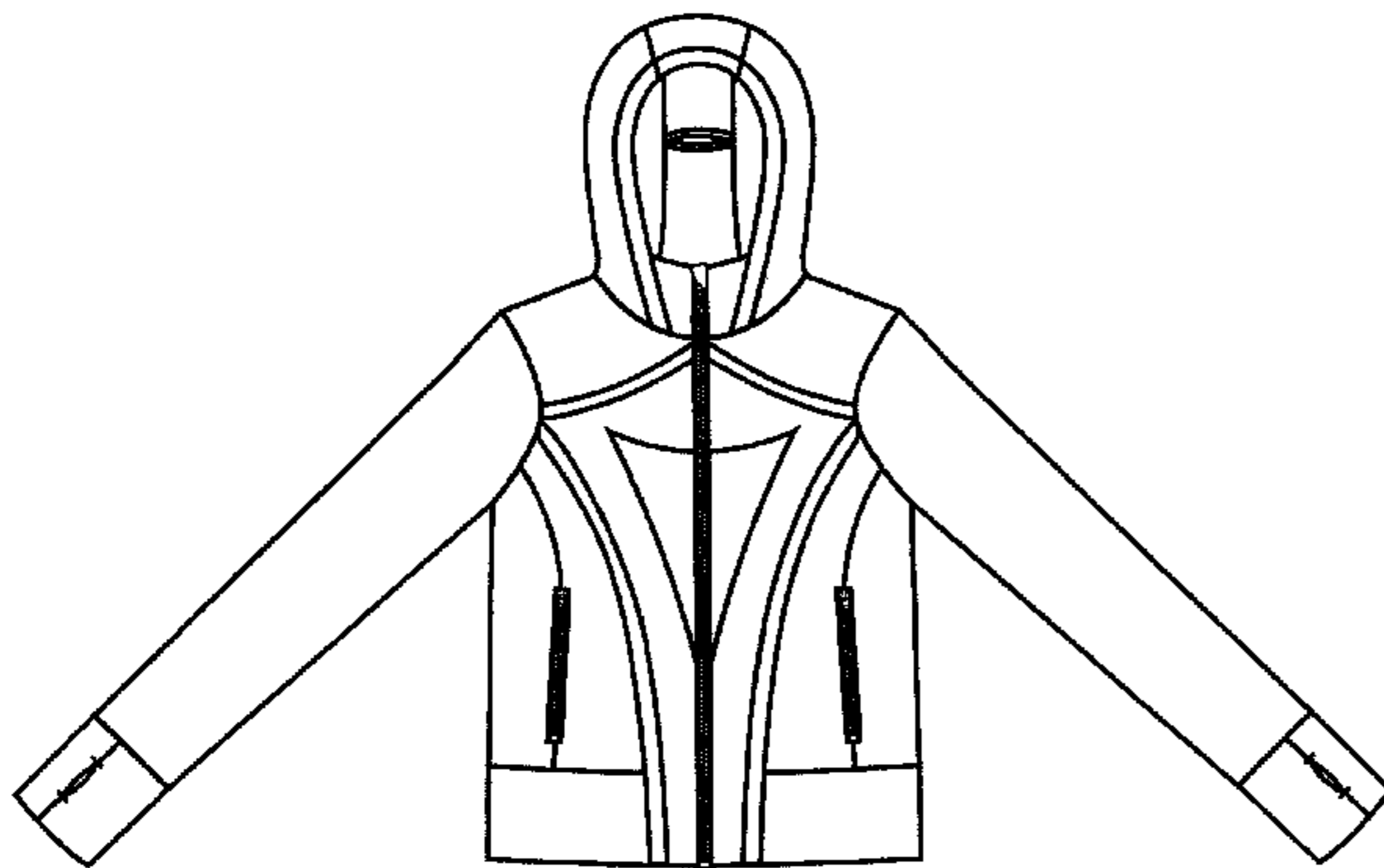

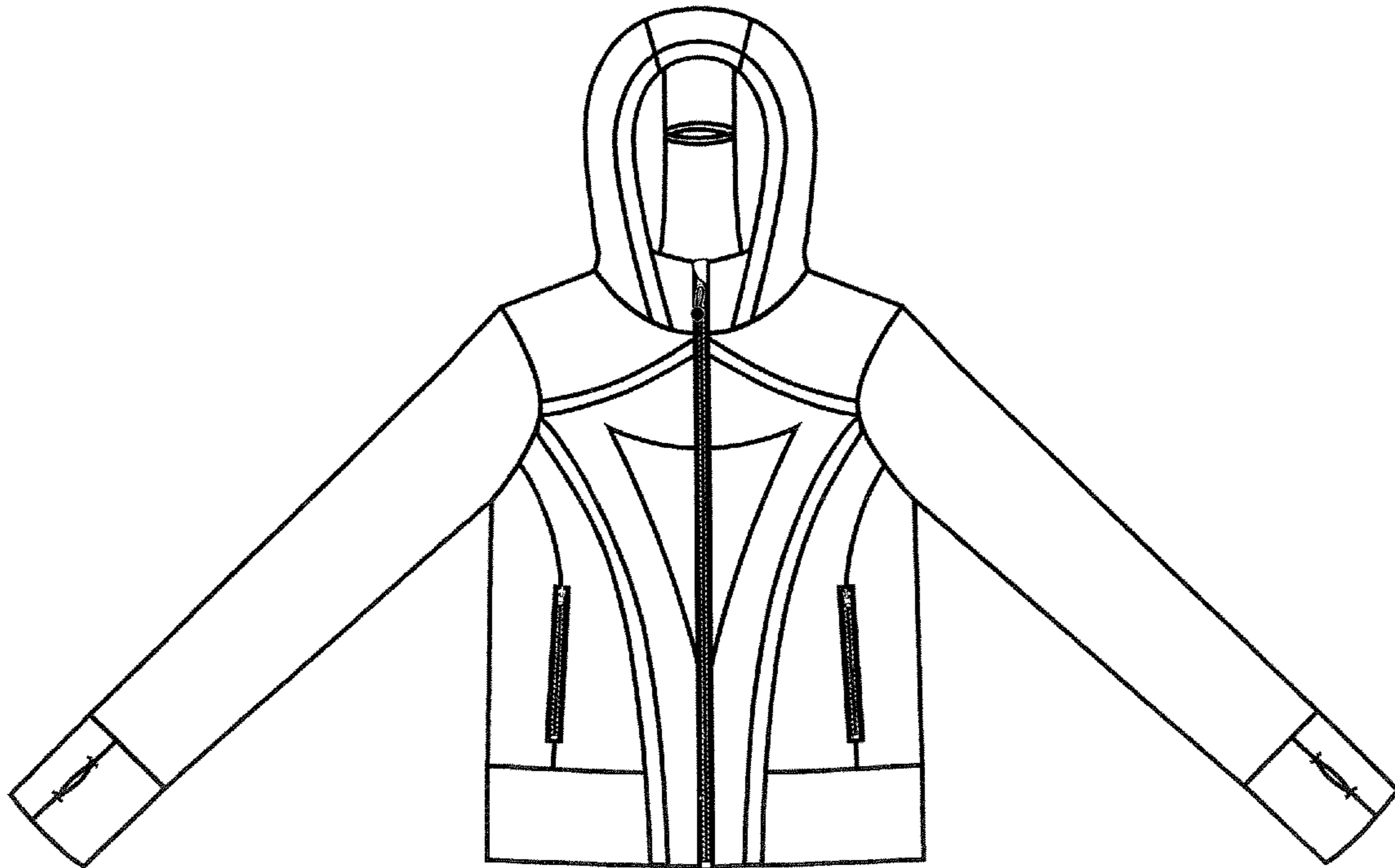

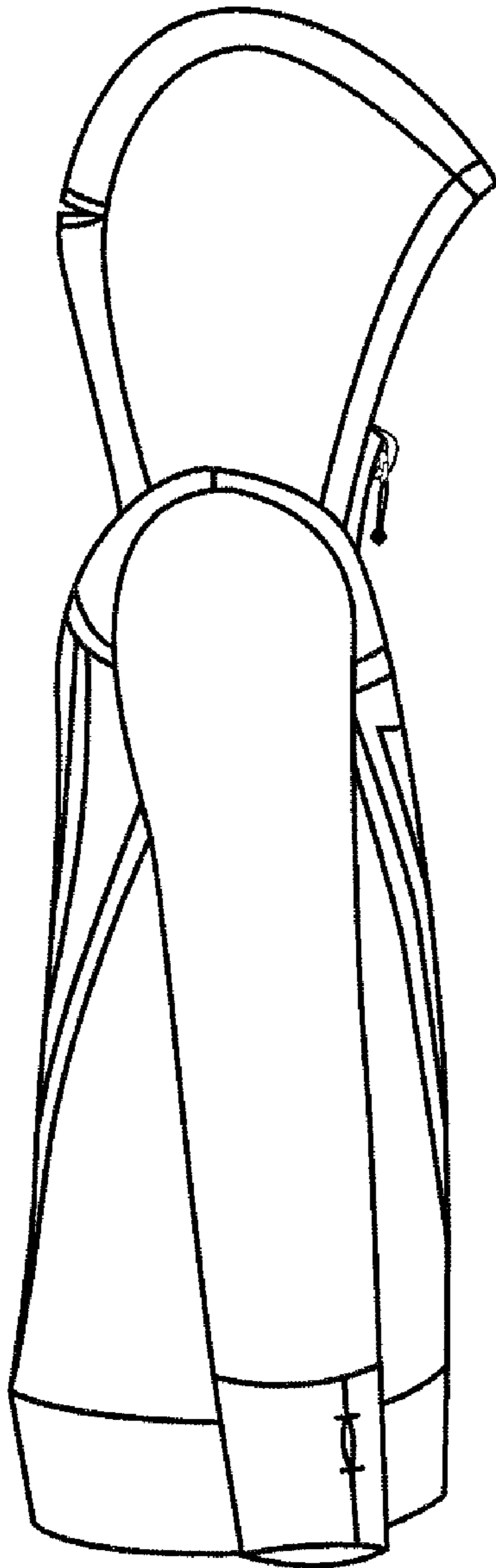

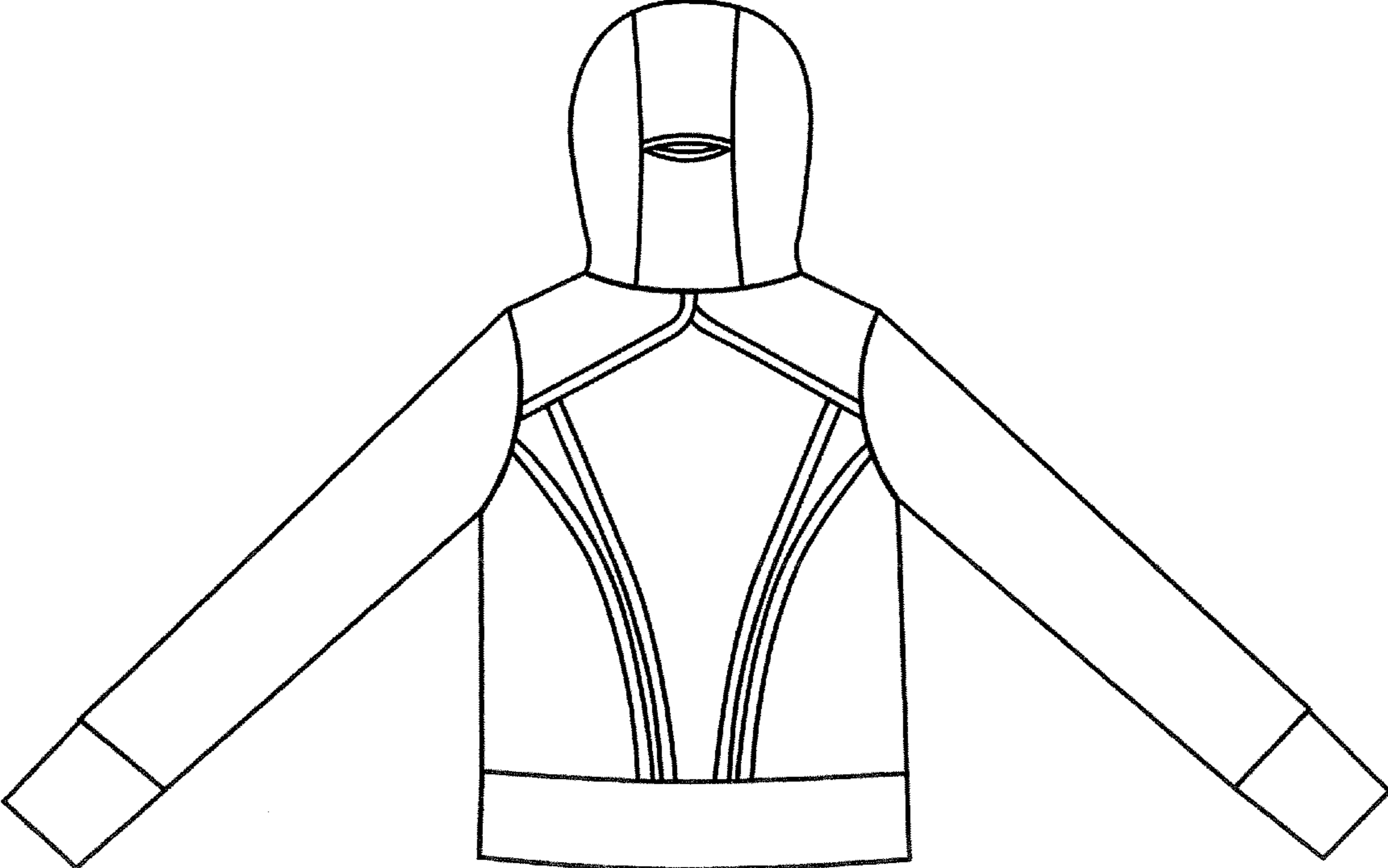

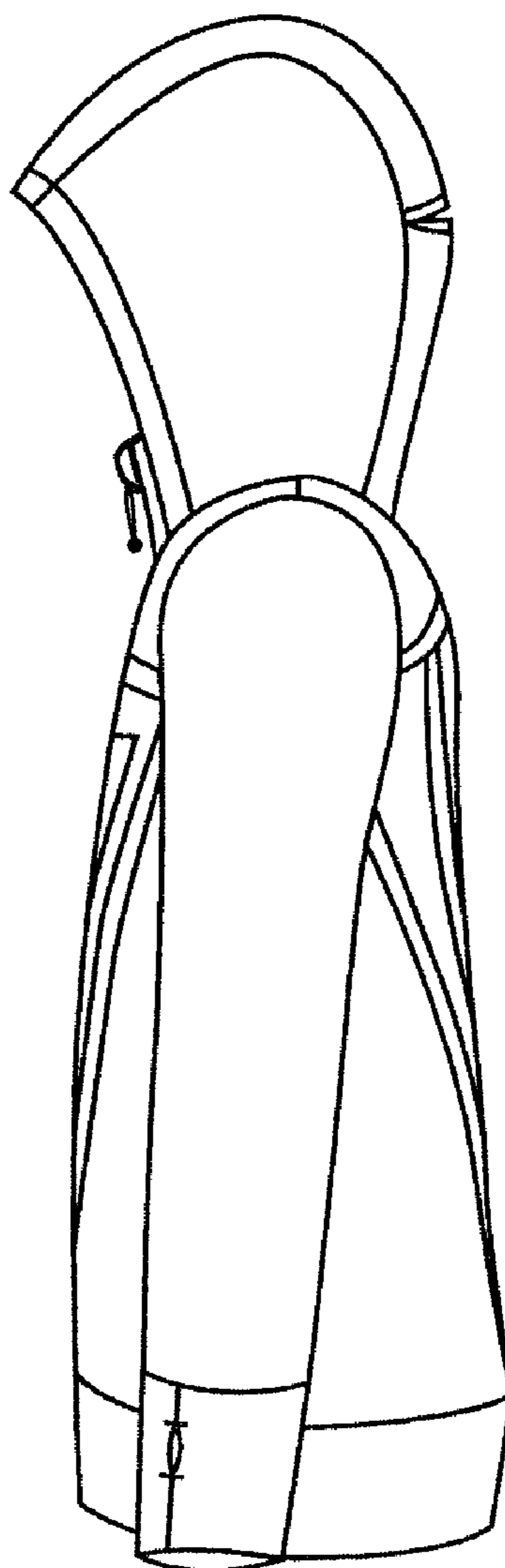

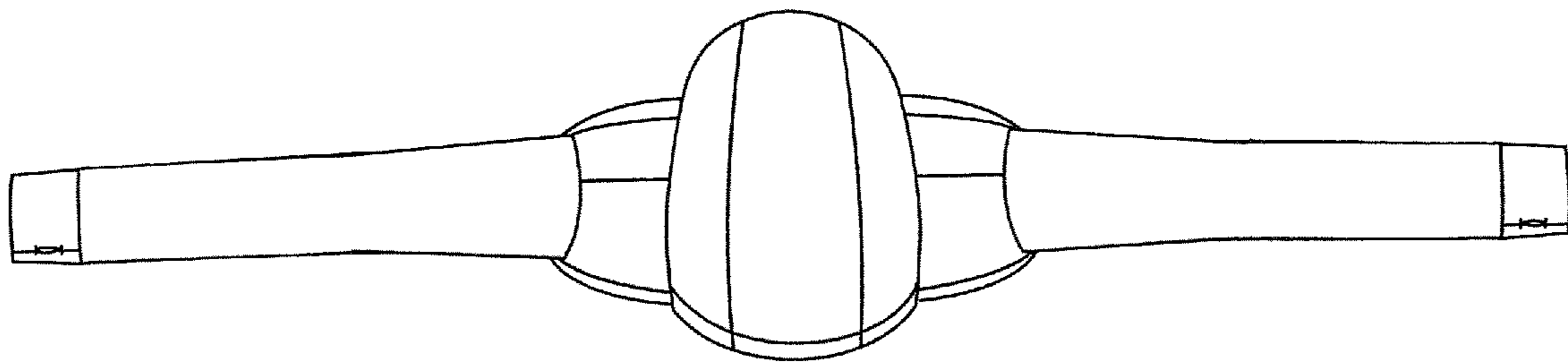

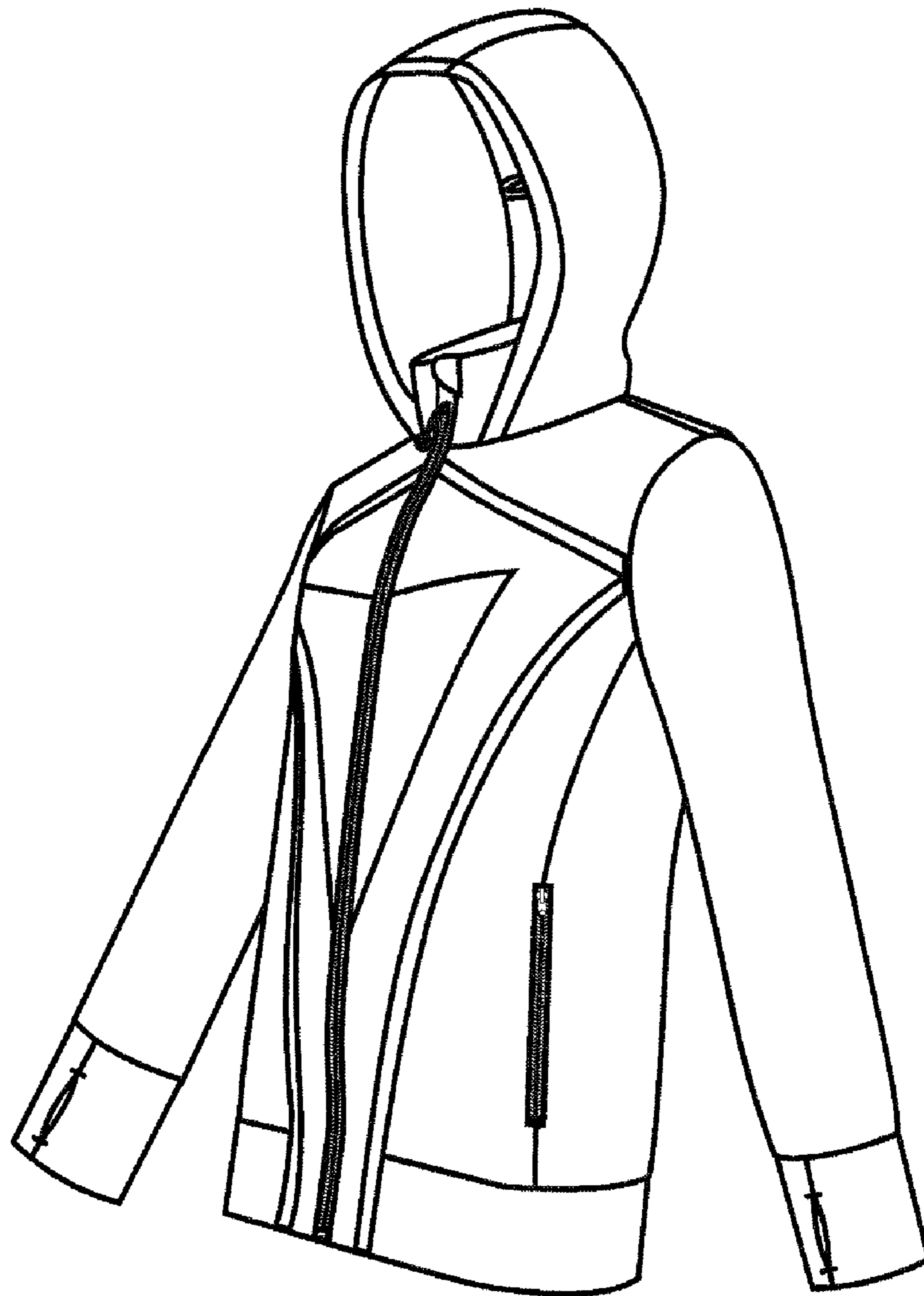

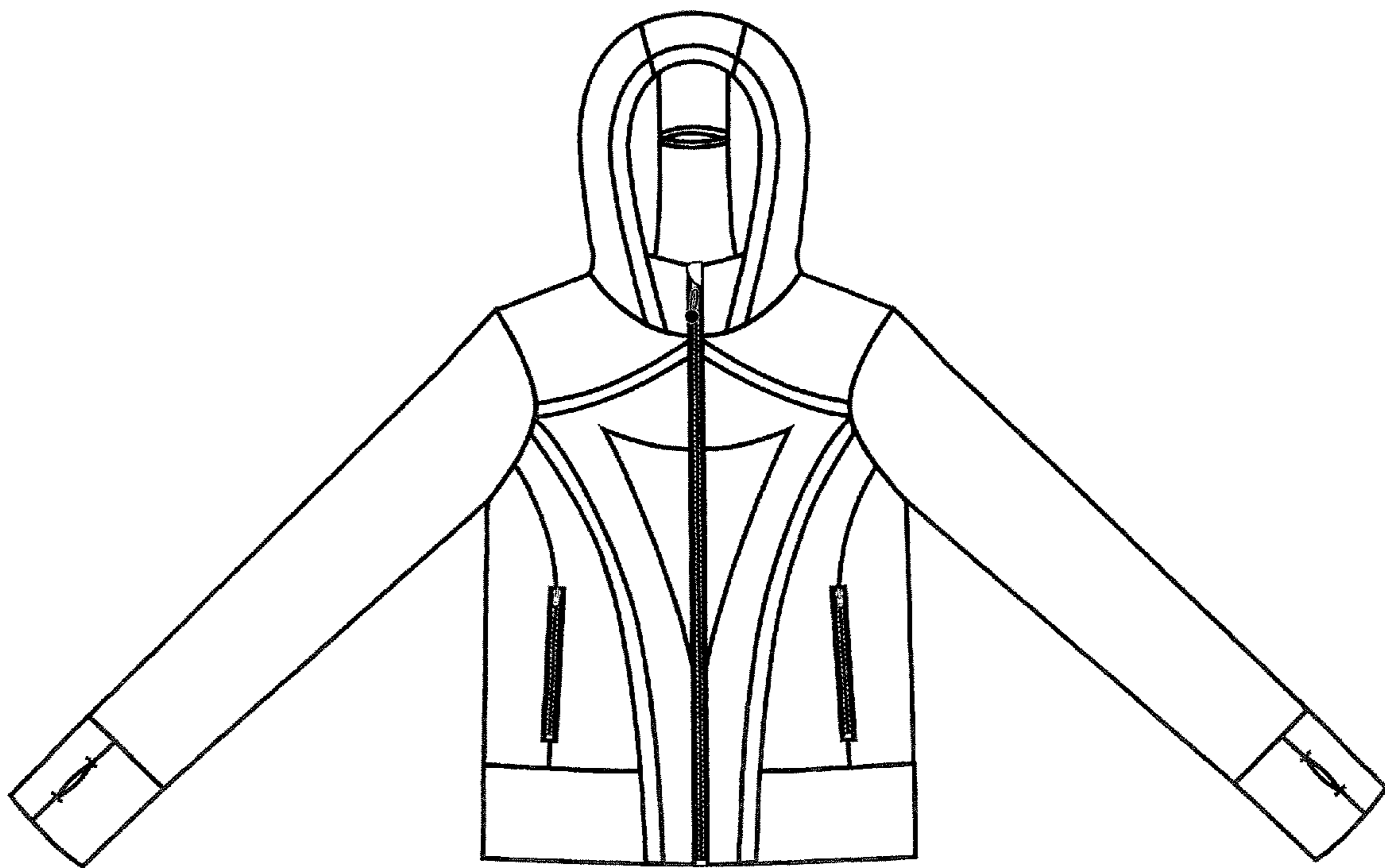

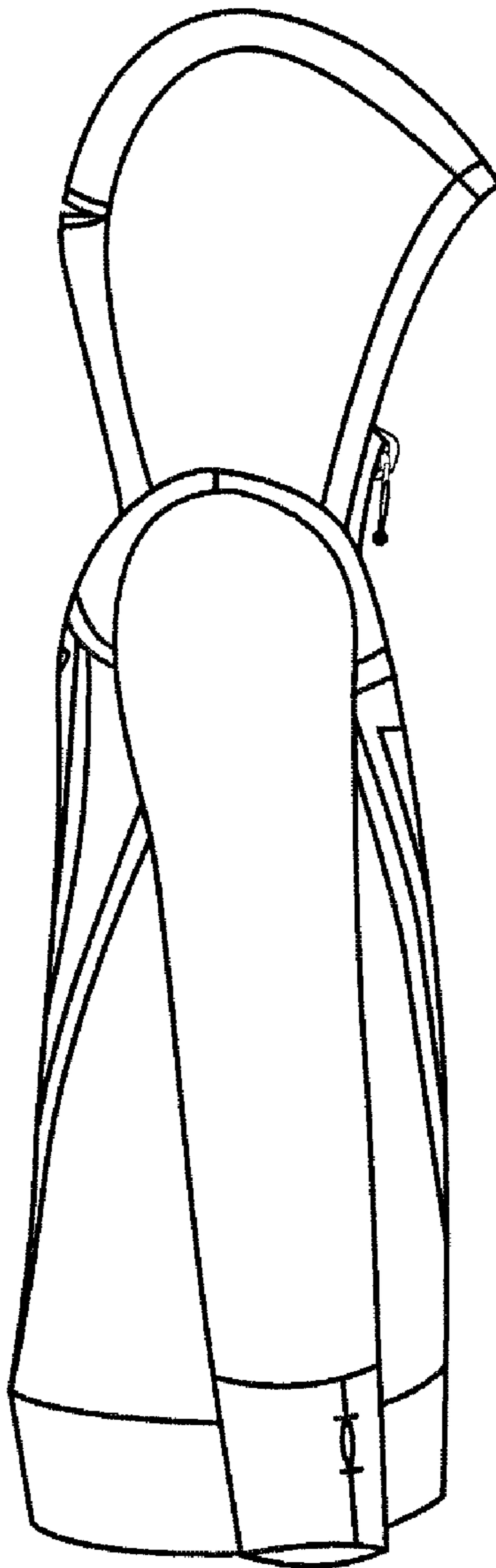

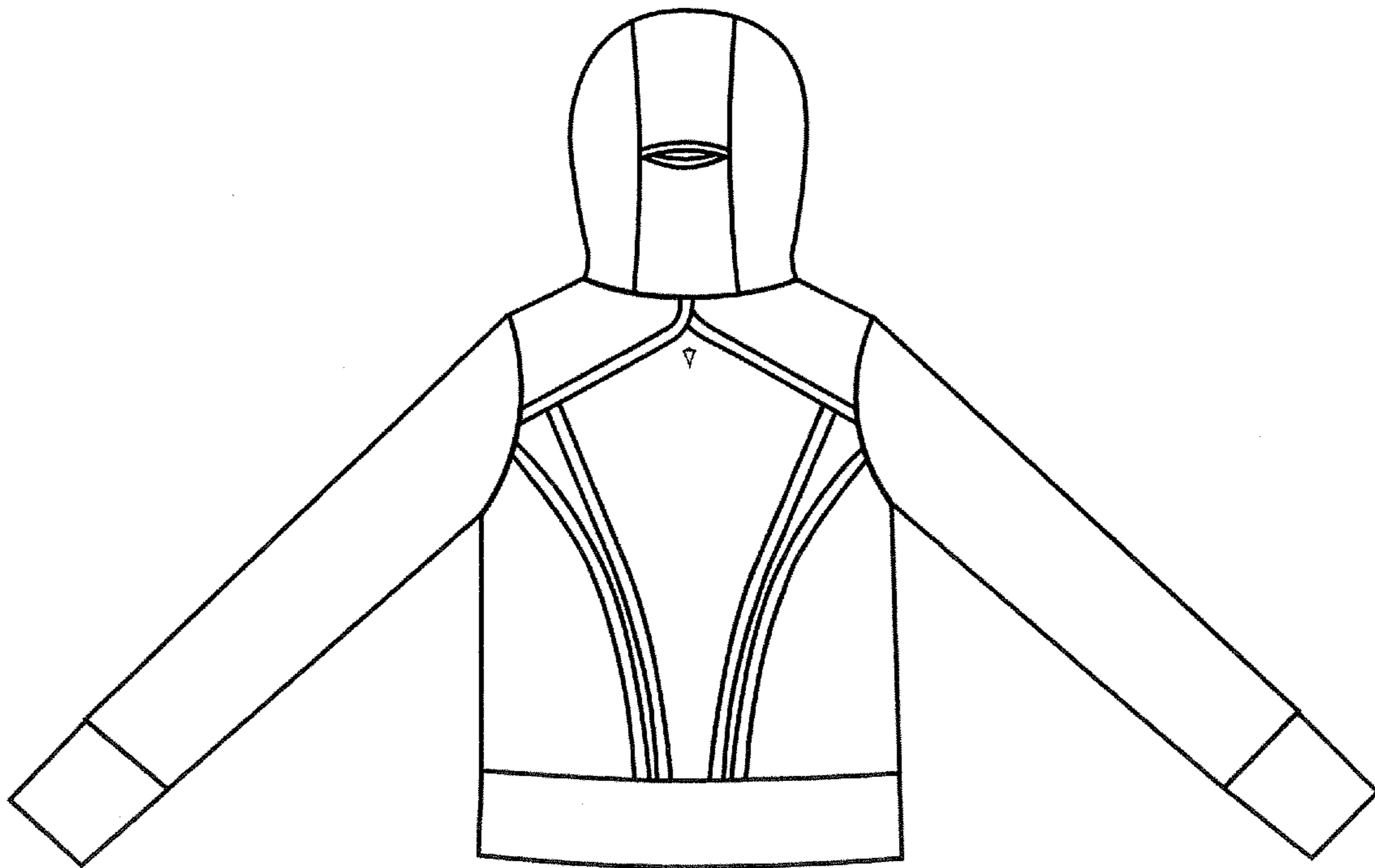

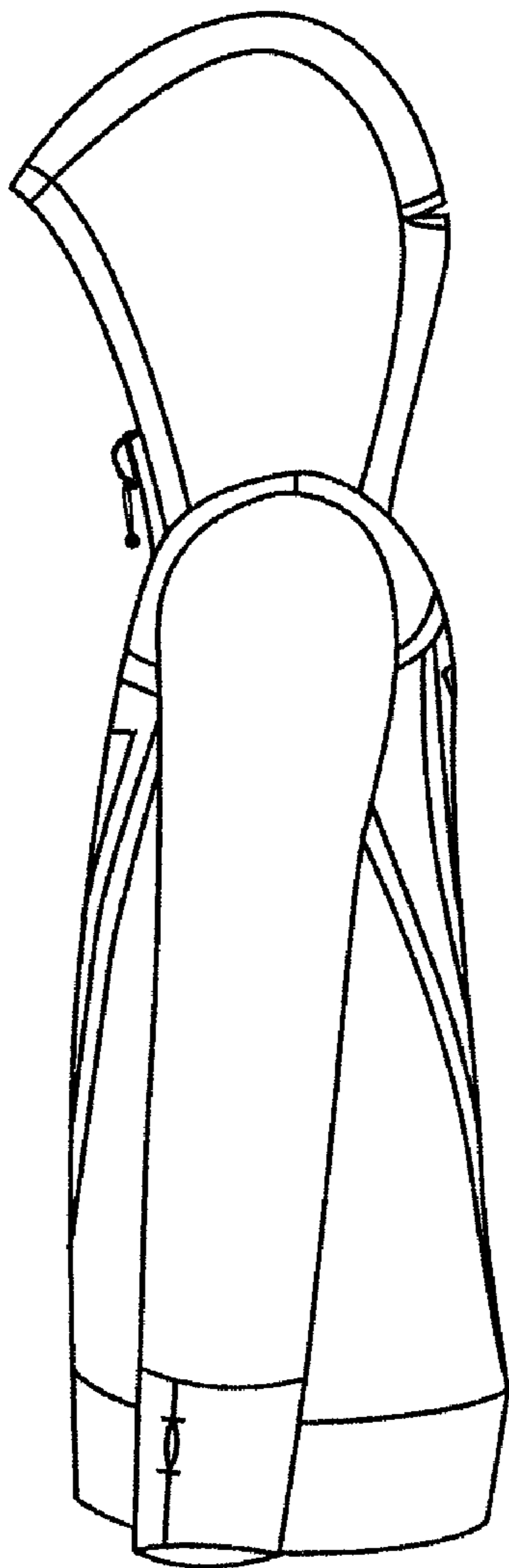

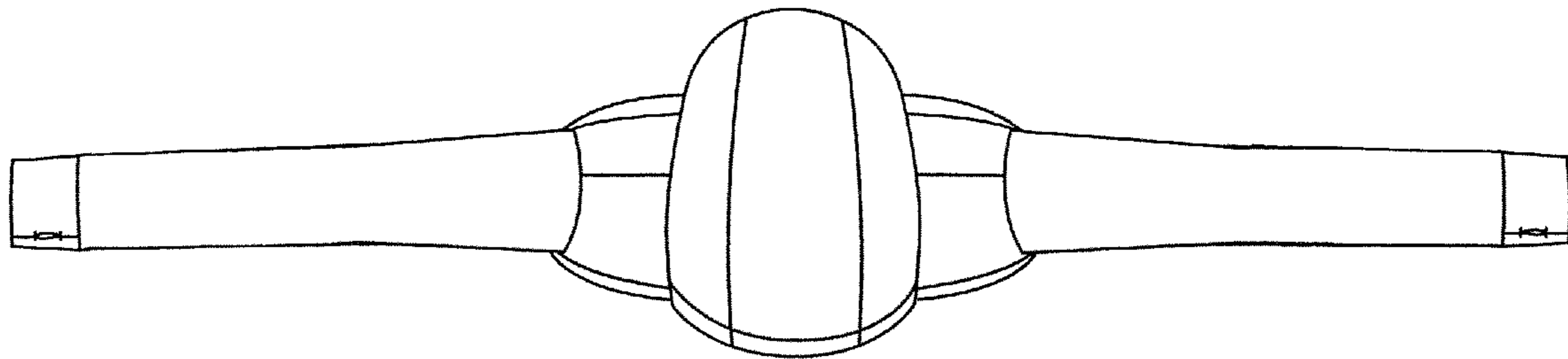
