**DESCRIPTION**

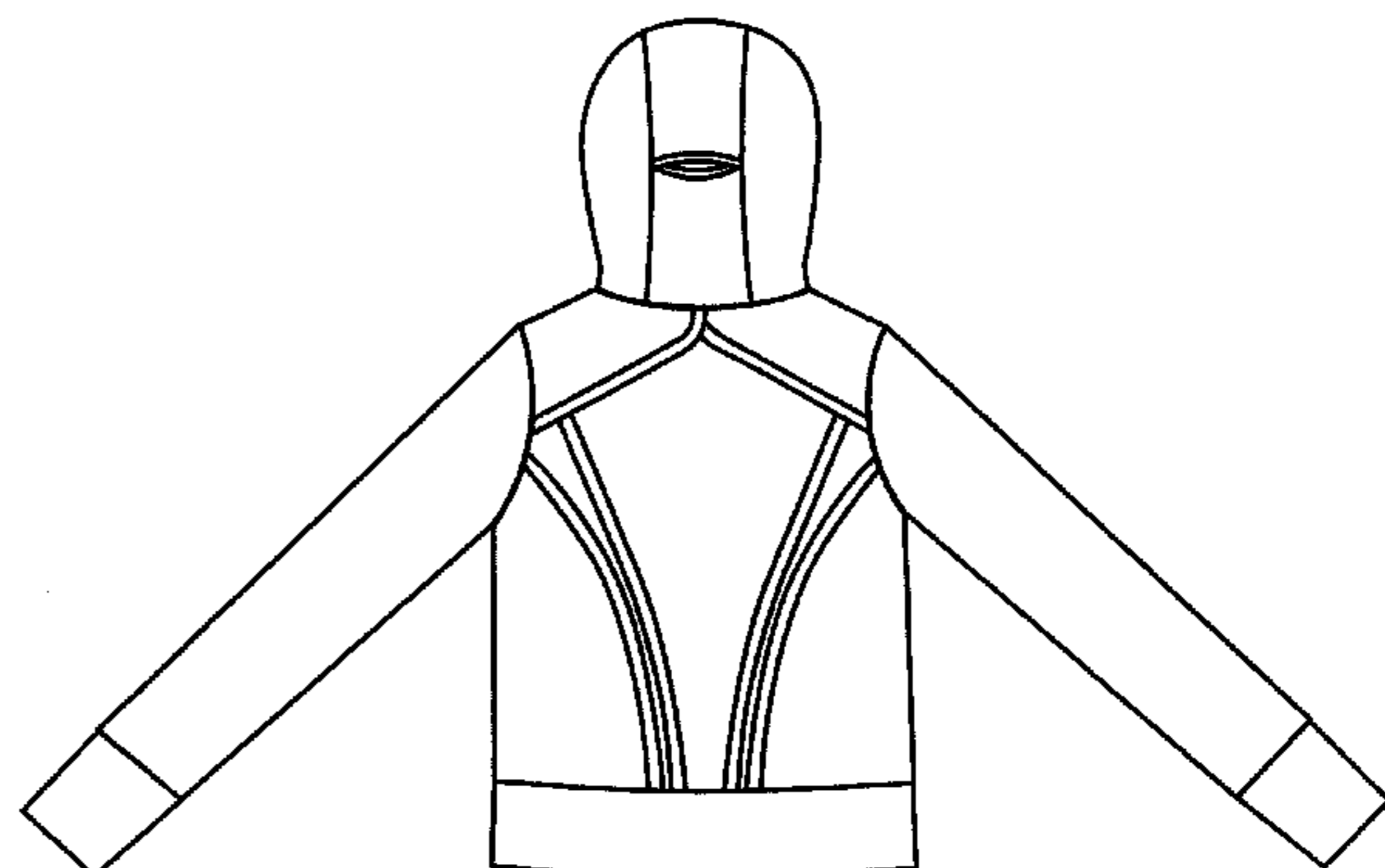
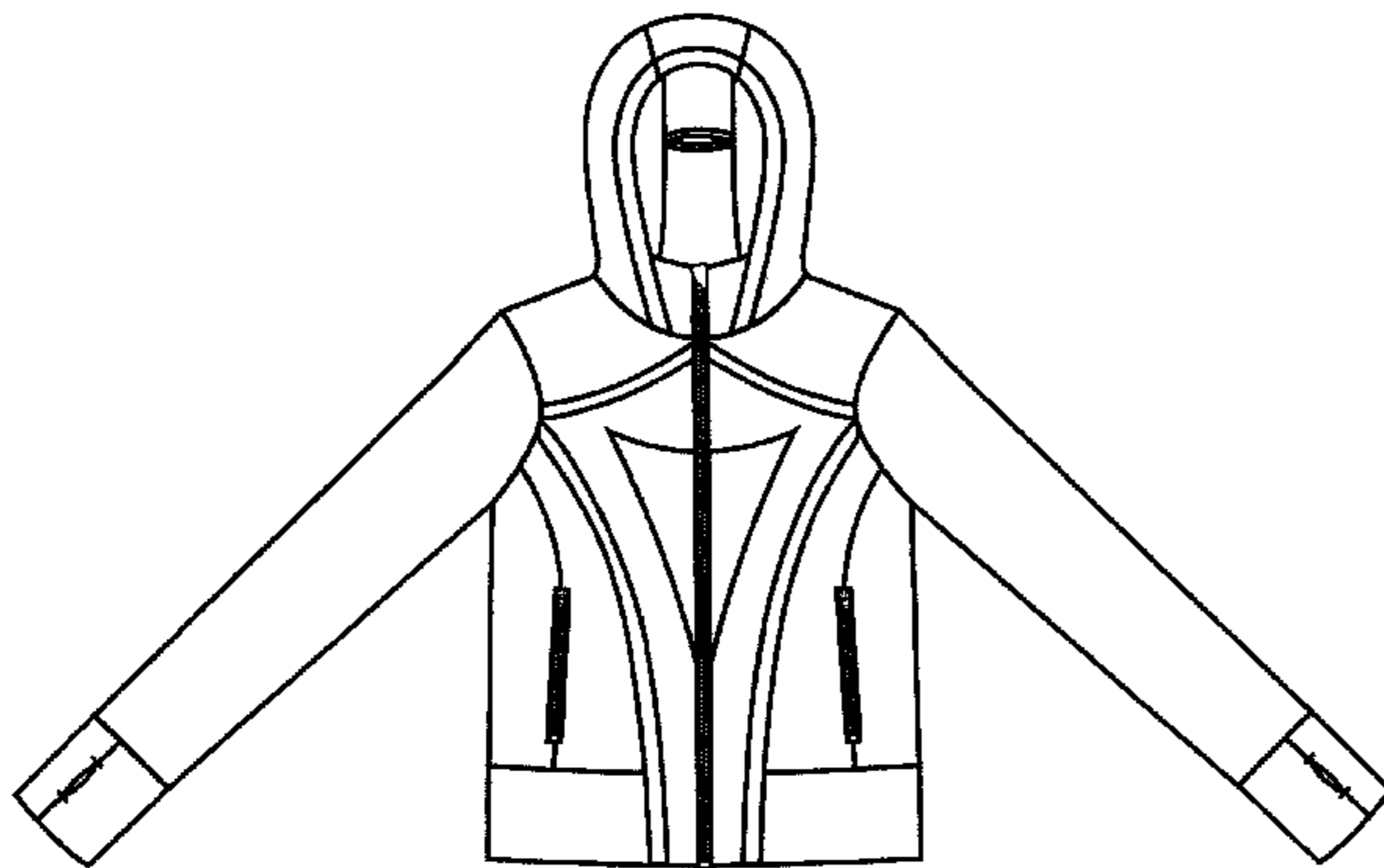

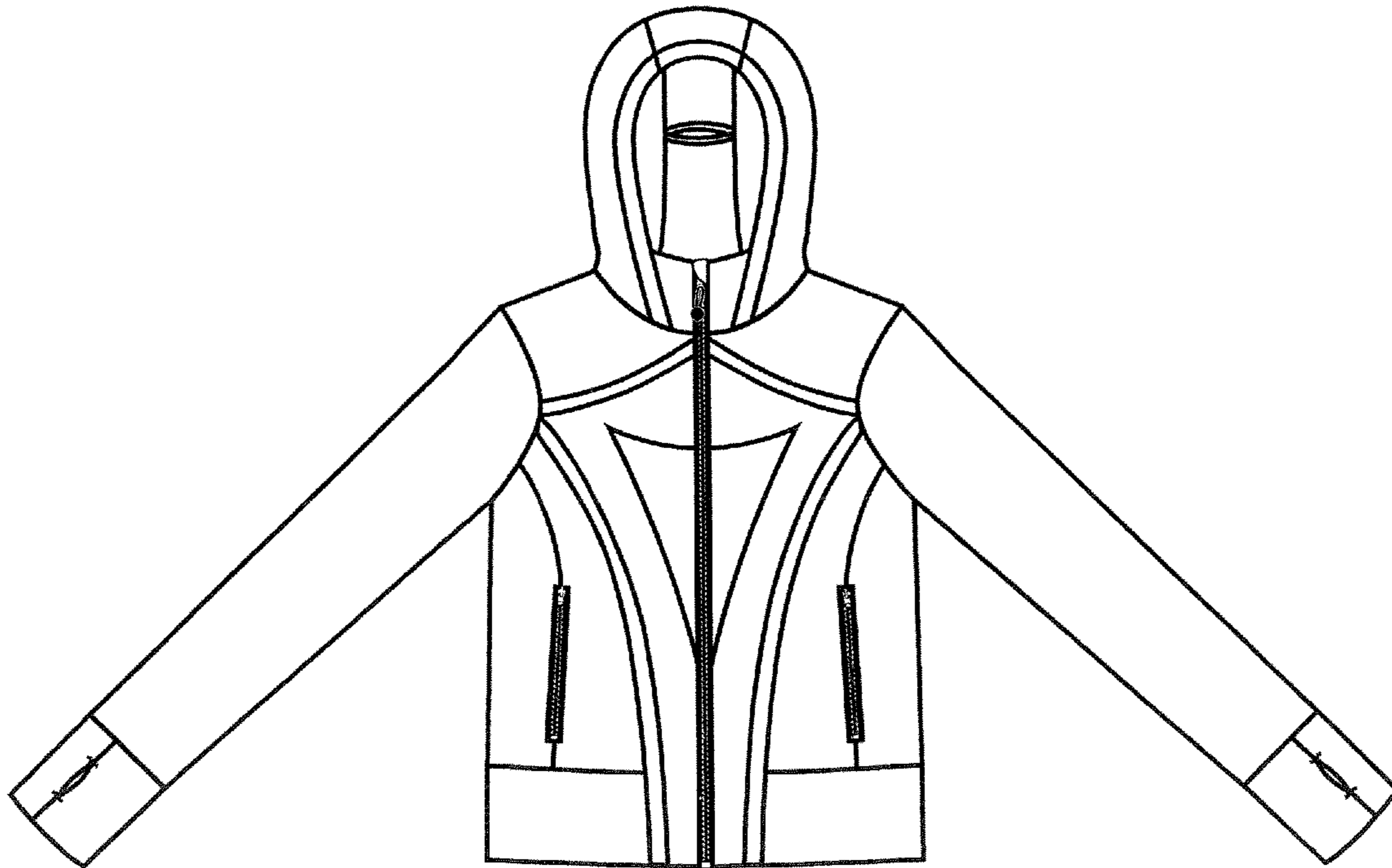

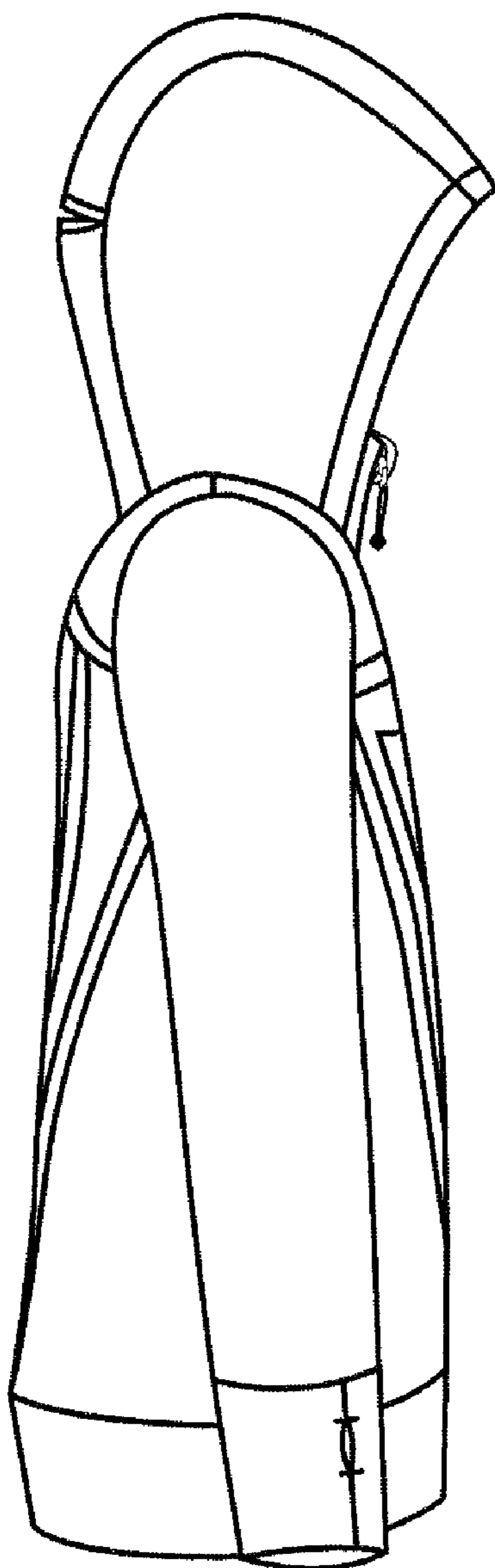

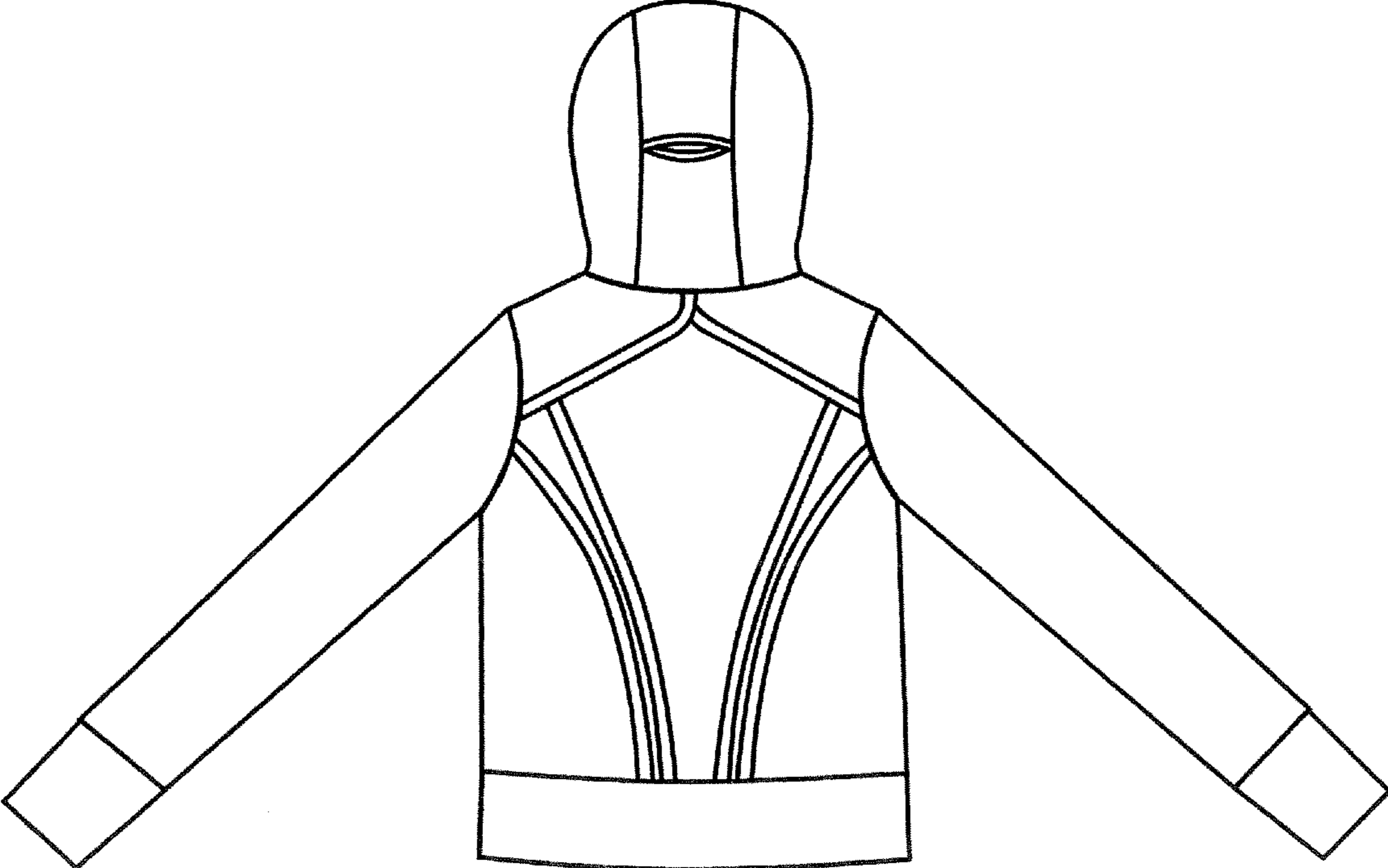

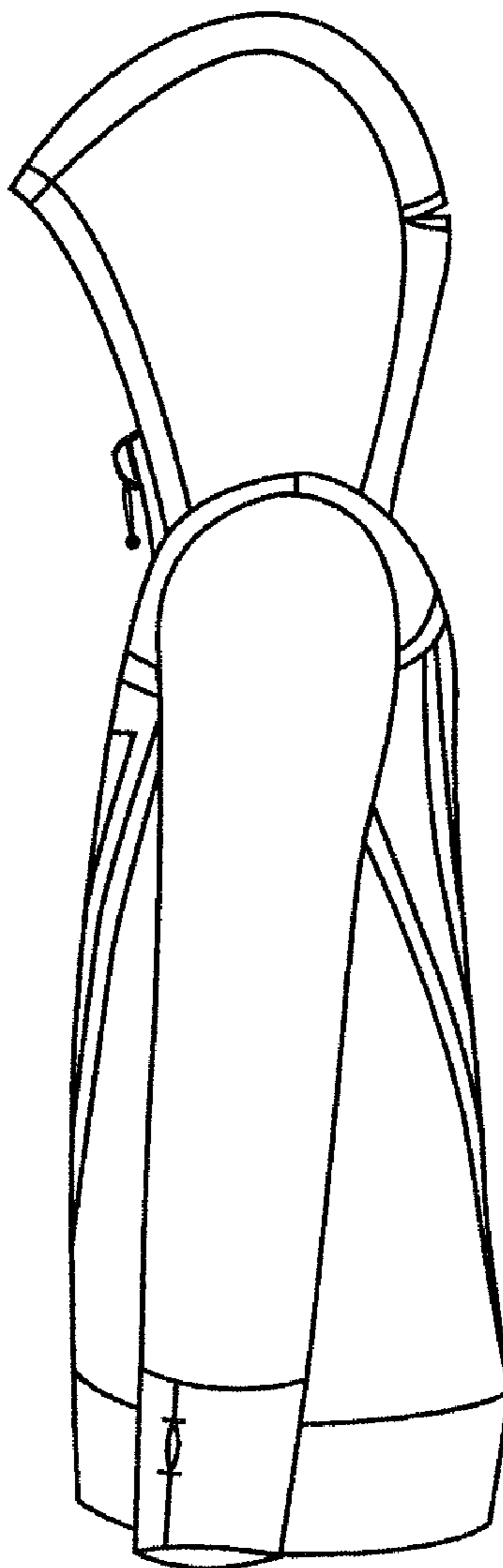

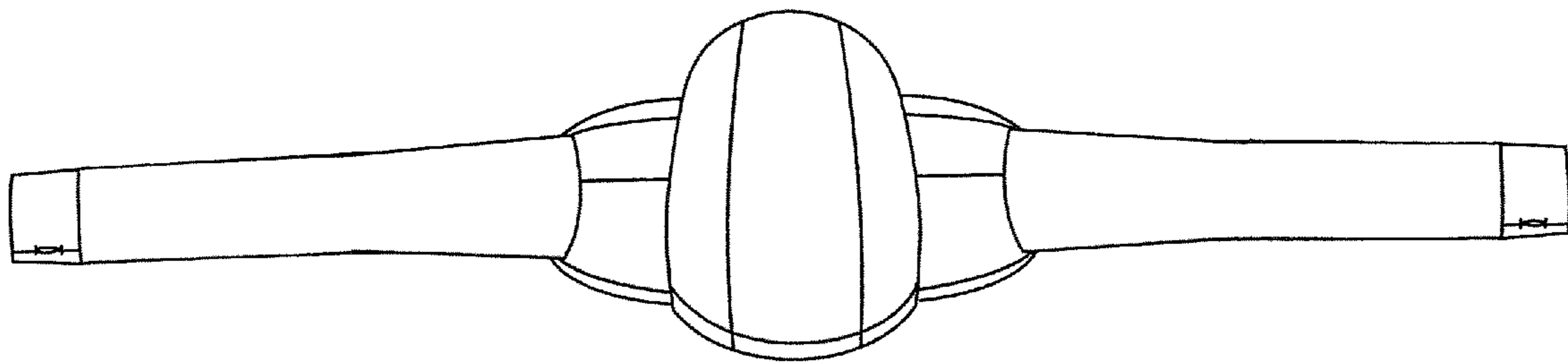

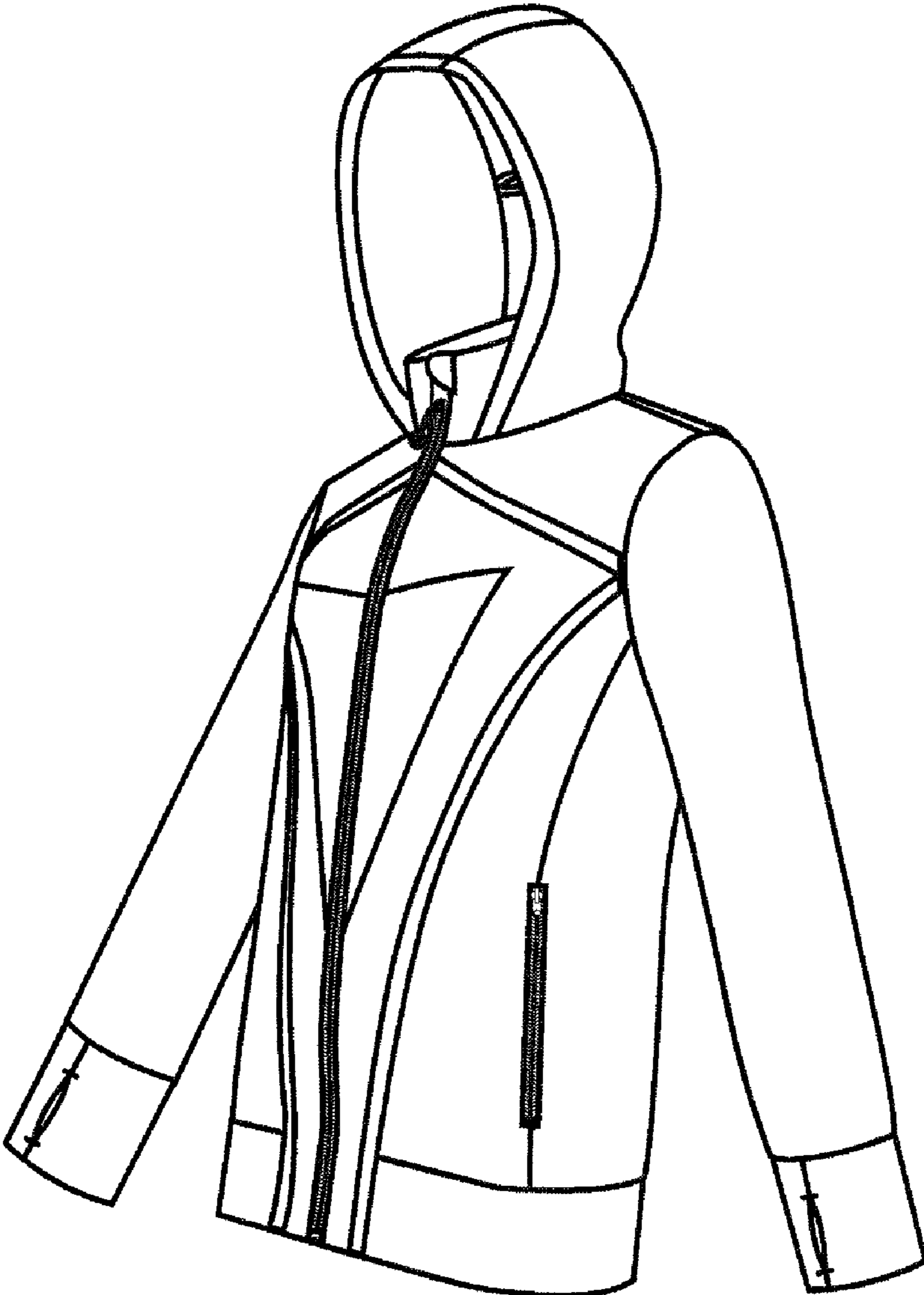

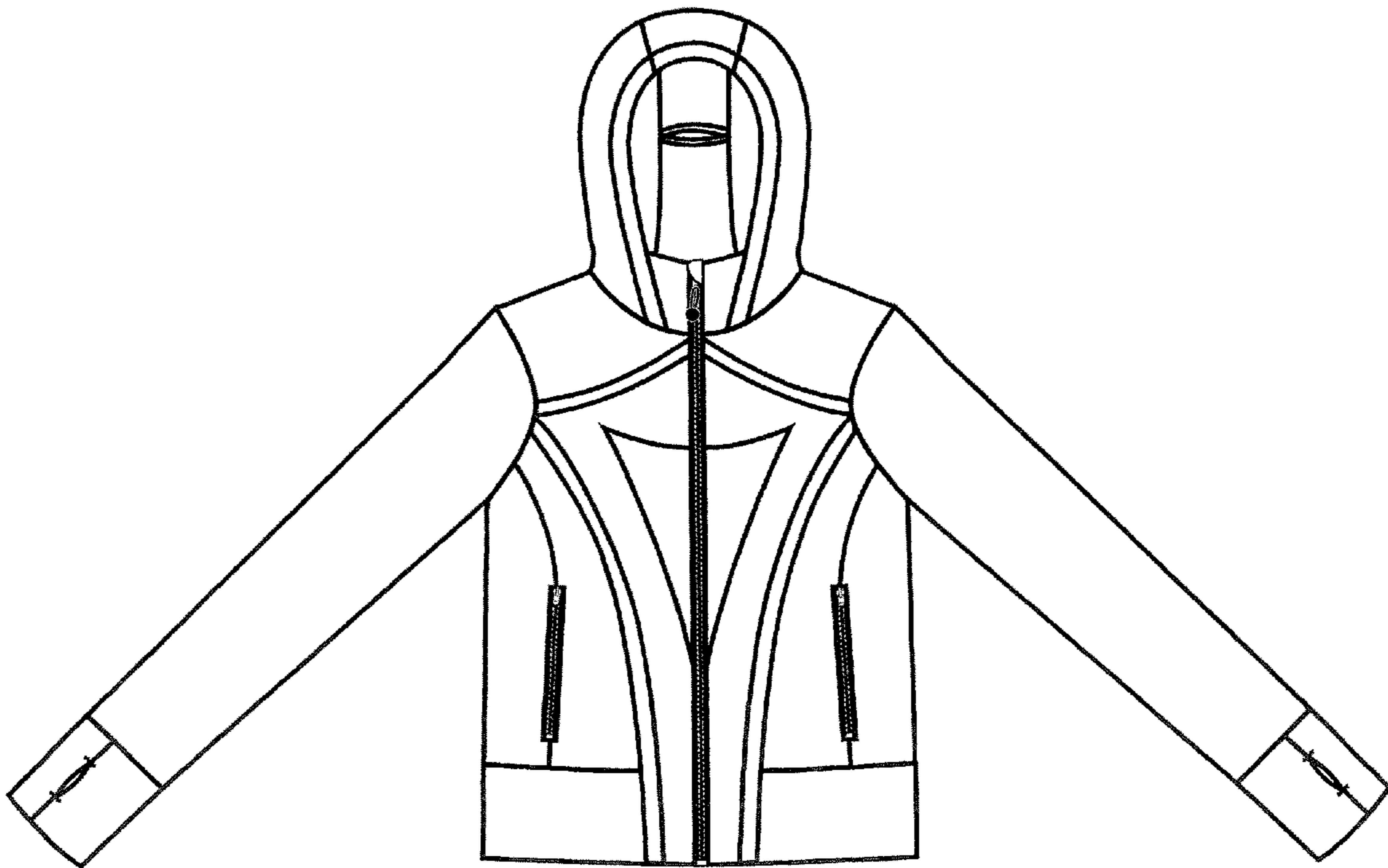

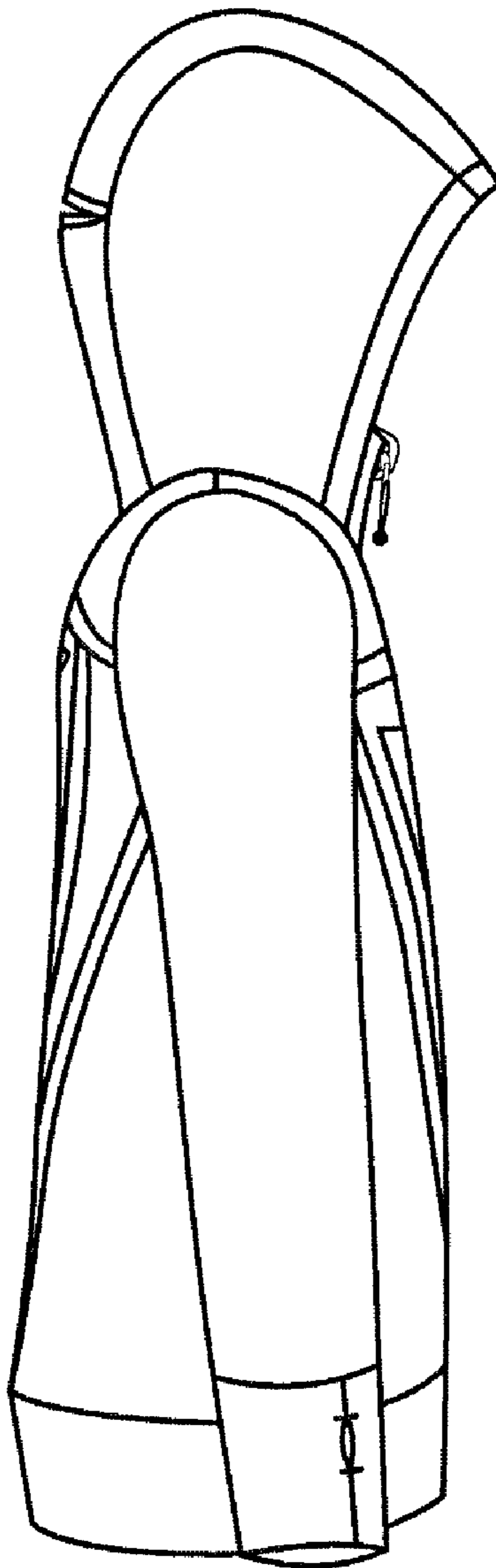
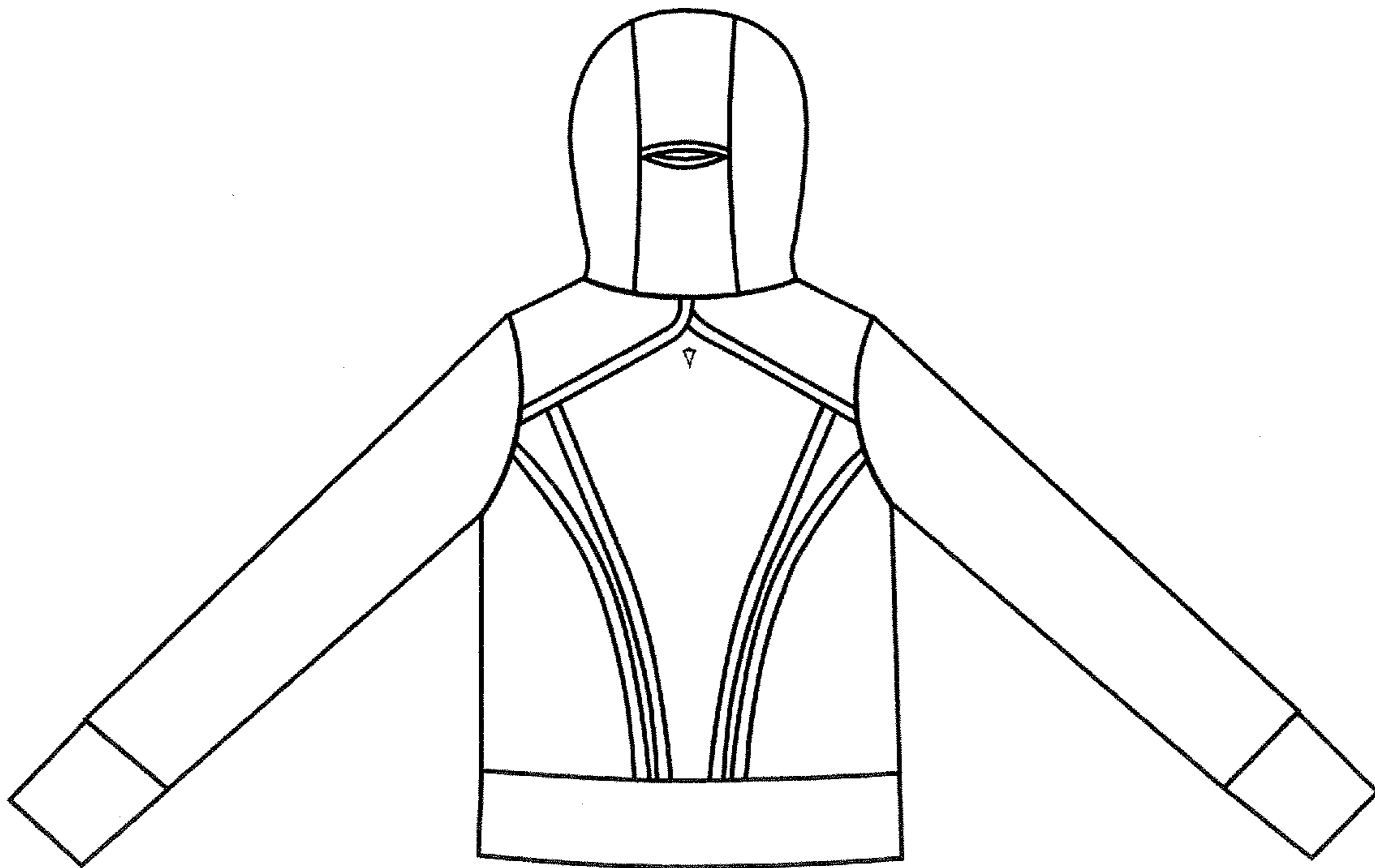

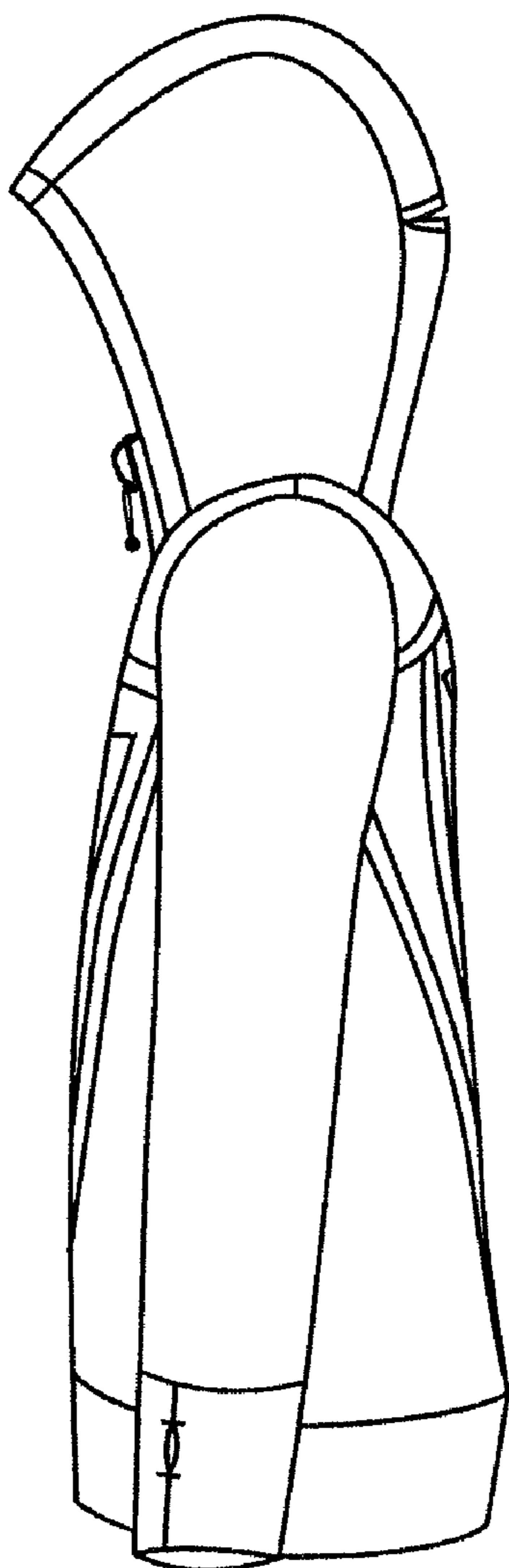

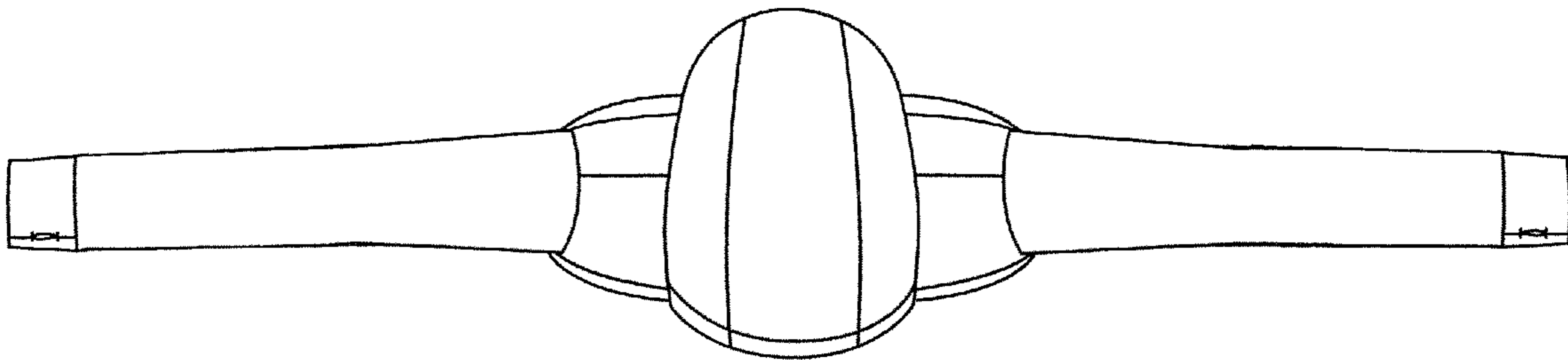
