(57) **CLAIM**

We claim the ornamental design for a garment, as shown and described.

DESCRIPTION

The FIGURE is a front view of a garment shown with a colored, circle-shaped, semi-transparent center surrounded by a colored, circle-shaped border with a logo near the border but outside the center.

The hatched markings show garment material in the FIGURE, are included for the purpose of illustrating environmental structure, and form no part of the claimed design. The evenly-spaced dashed line along the perimeter of the FIGURE is included for the purpose of illustrating environmental structure and forms no part of the claimed design. The patterned portions shown in a portion of the colored, circle-shaped, semi-transparent center illustrate a color code, wherein the color extends across the entire colored, circle-shaped, semi-transparent center and forms a part of the claimed design.
