(57) **CLAIM**

The ornamental design for a self-adhesive bib, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a self-adhesive bib showing my new design, the opposite side being a mirror image of the shown;

FIG. 2 is a right side elevation view thereof, the opposite side being a mirror image of the shown;

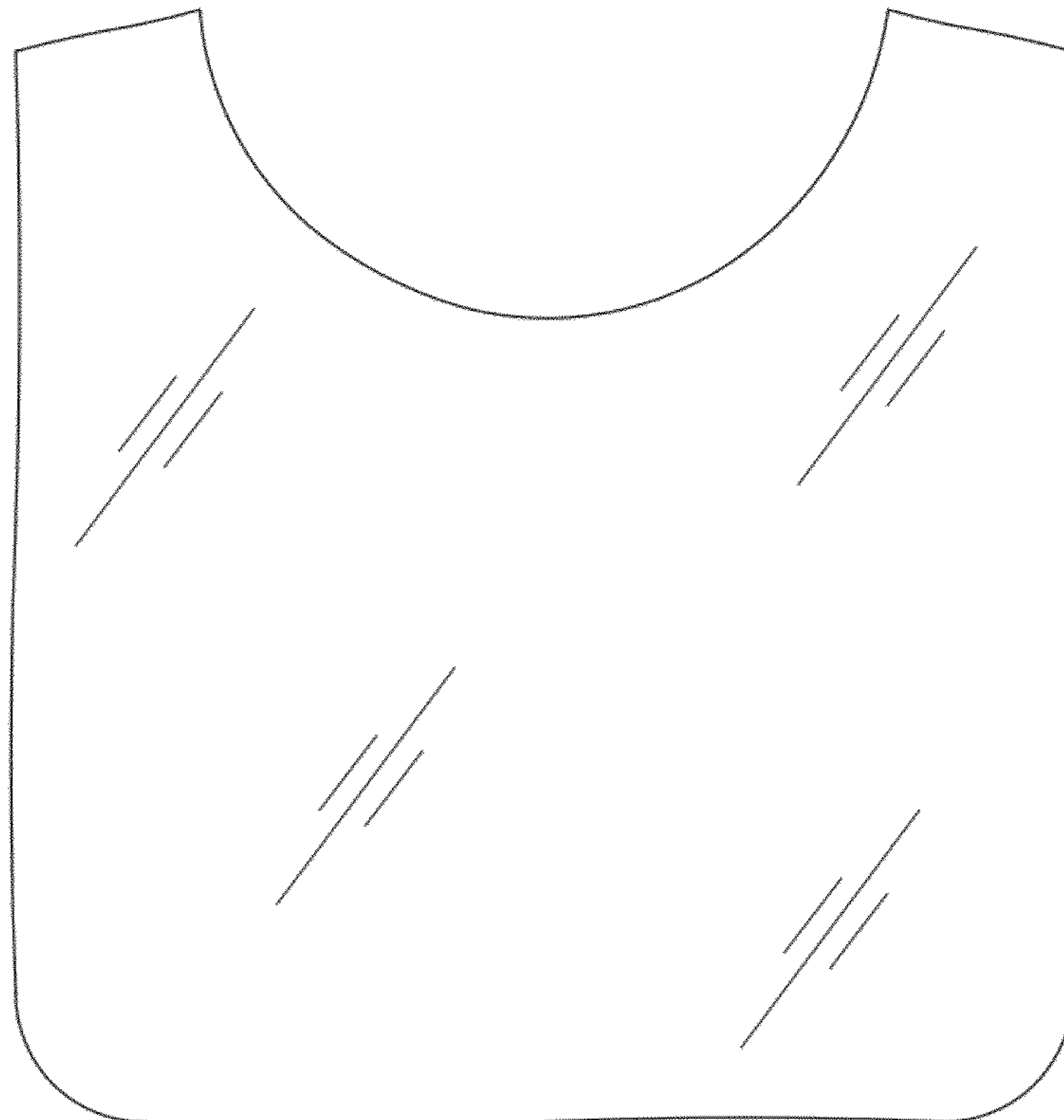
FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof; and,

FIG. 5 is an isometric view thereof; showing the adhesive bib in use.

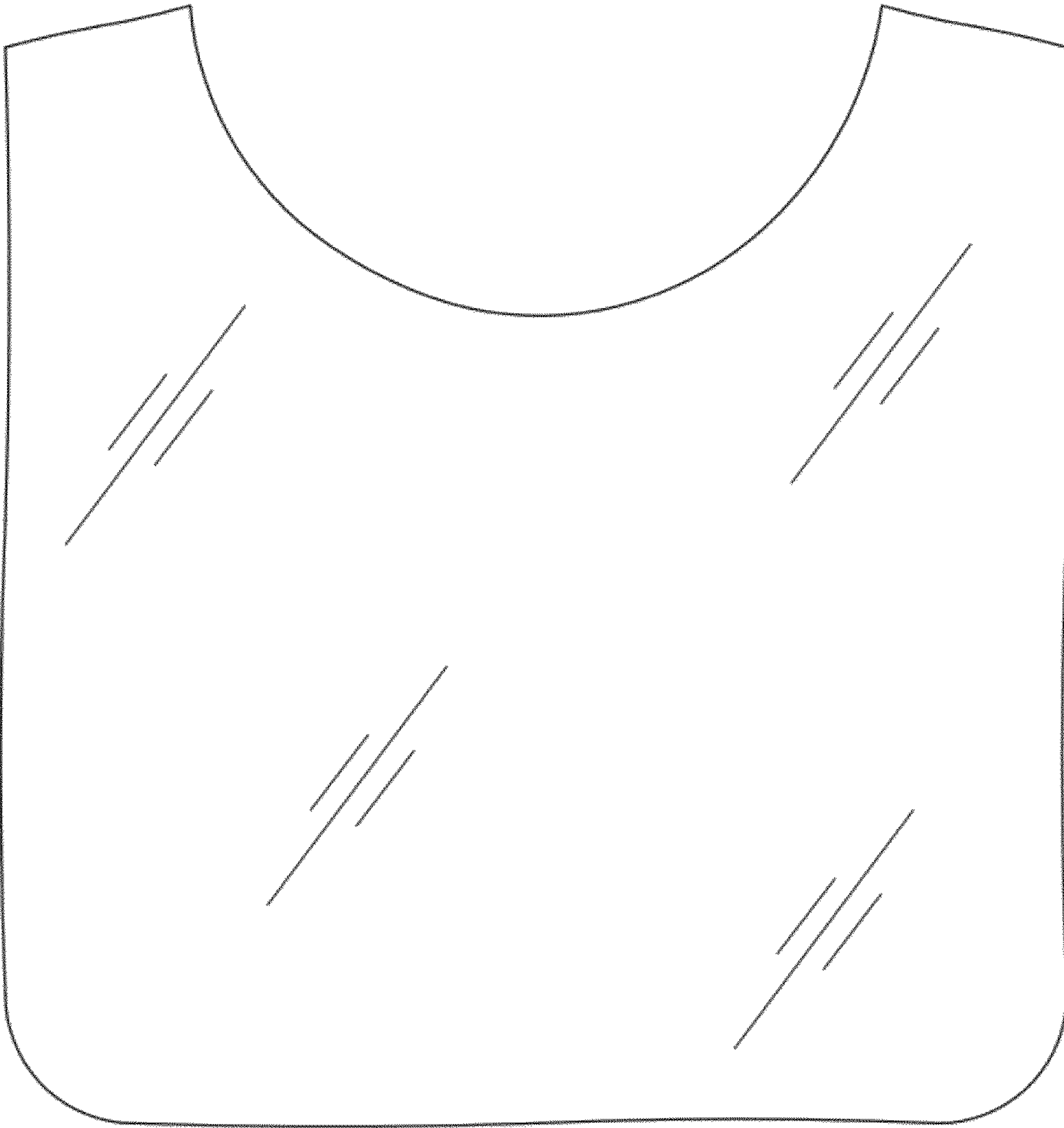

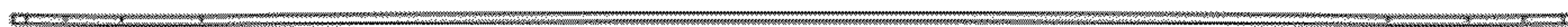

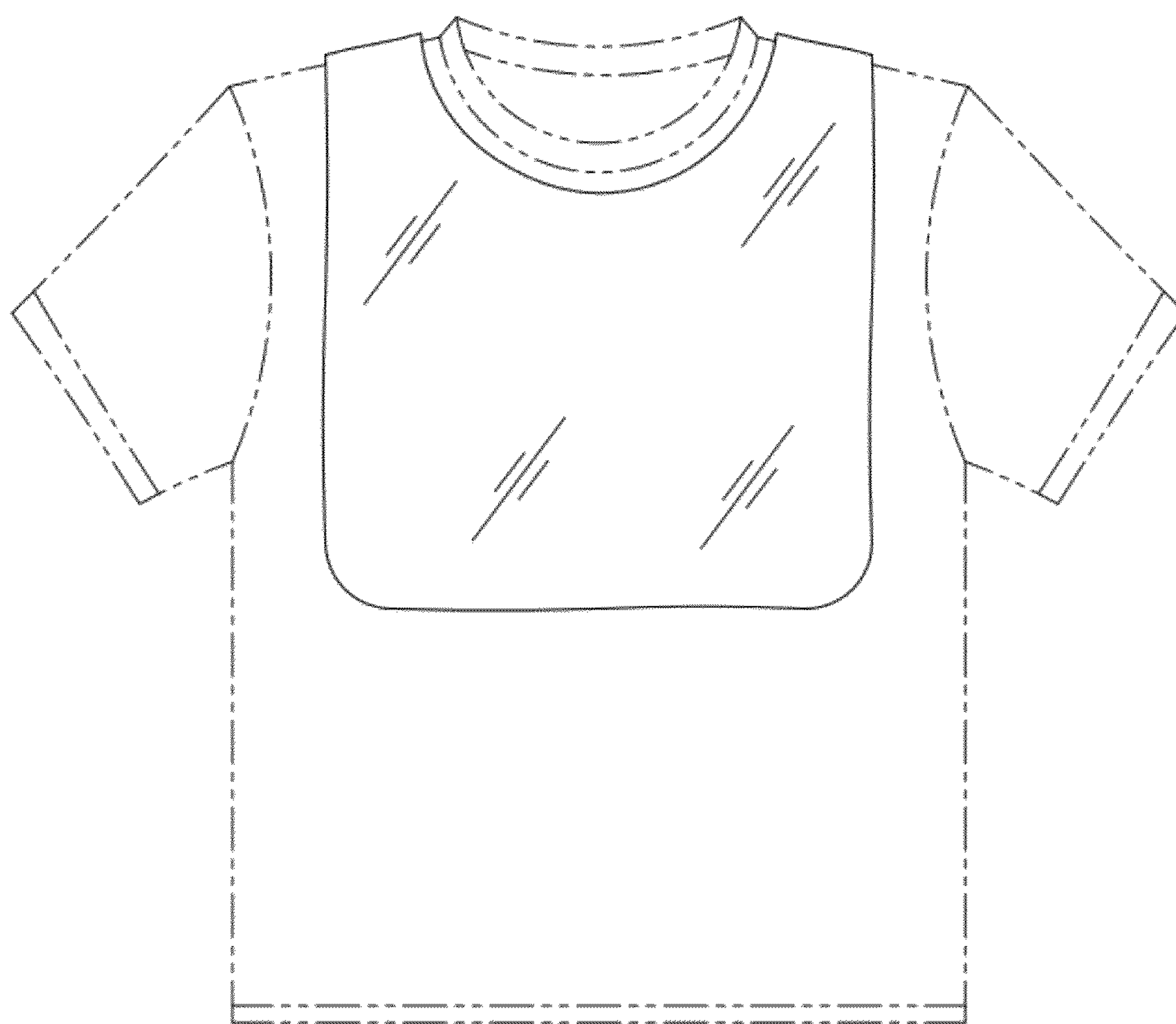
