DESCRIPTION

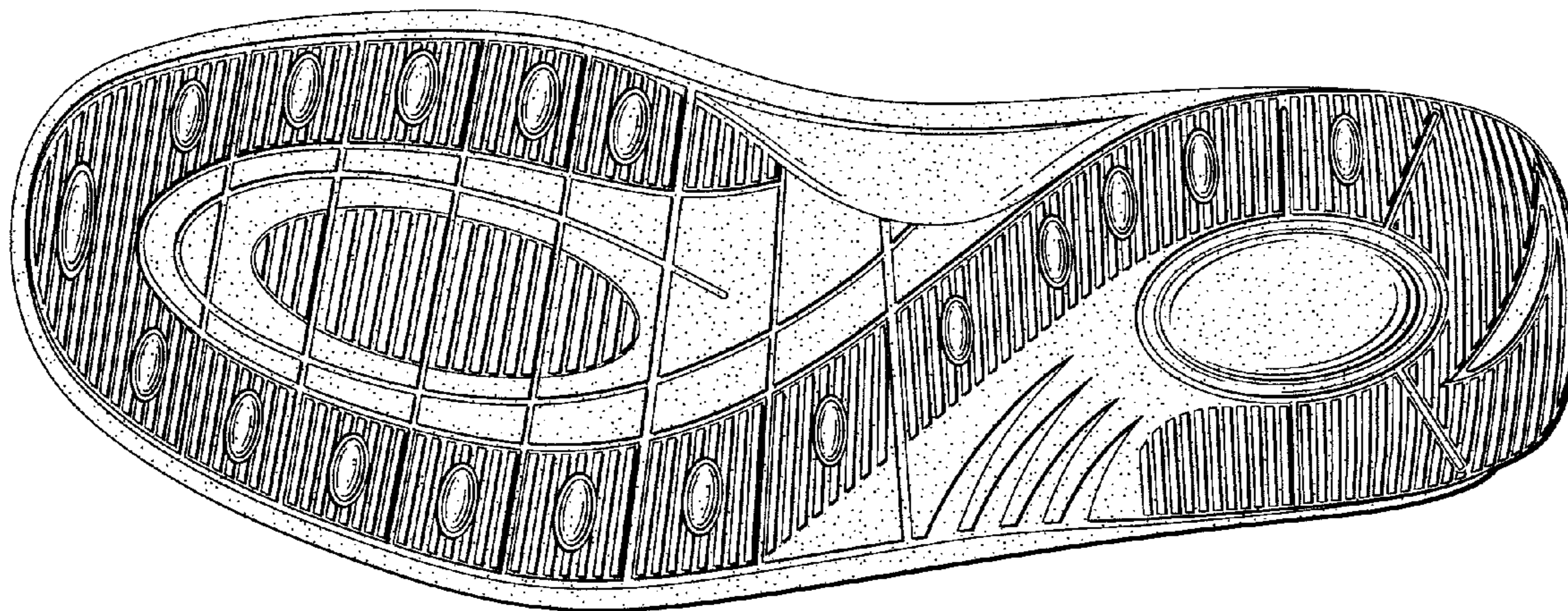
FIG. 1 is a plan view of the bottom of the shoe embodying the invention;

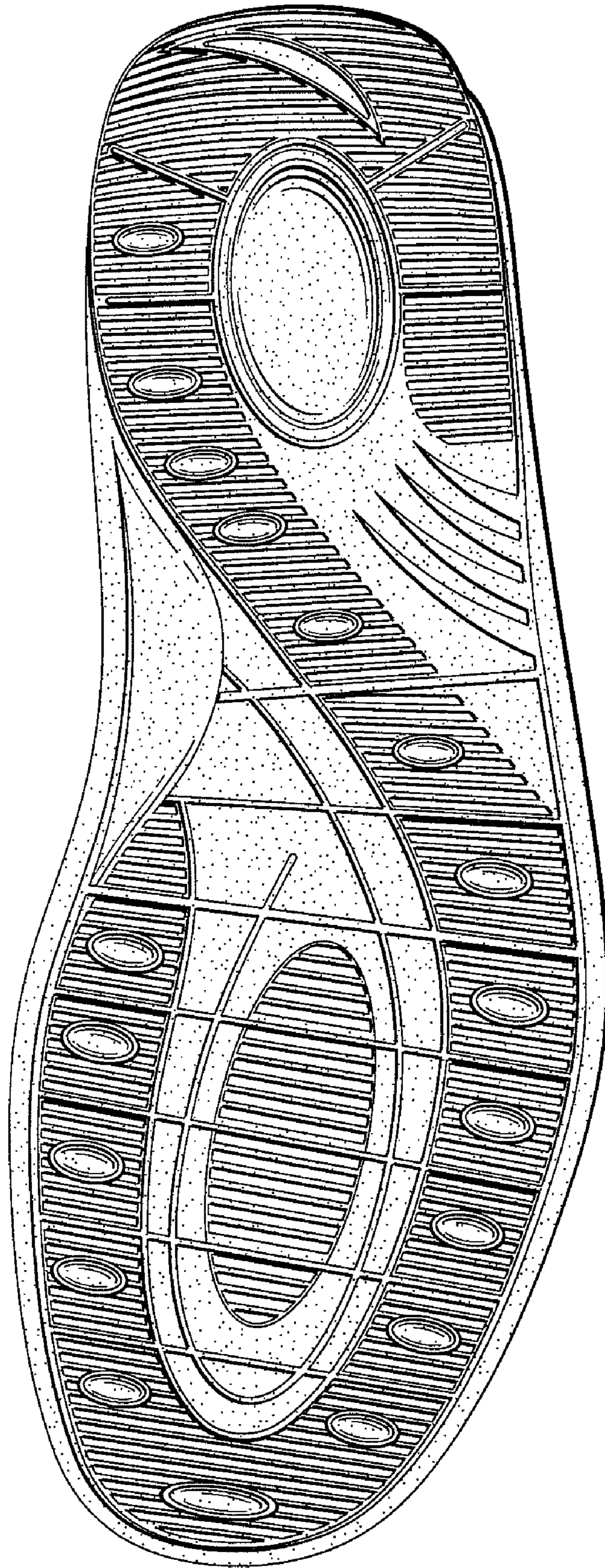

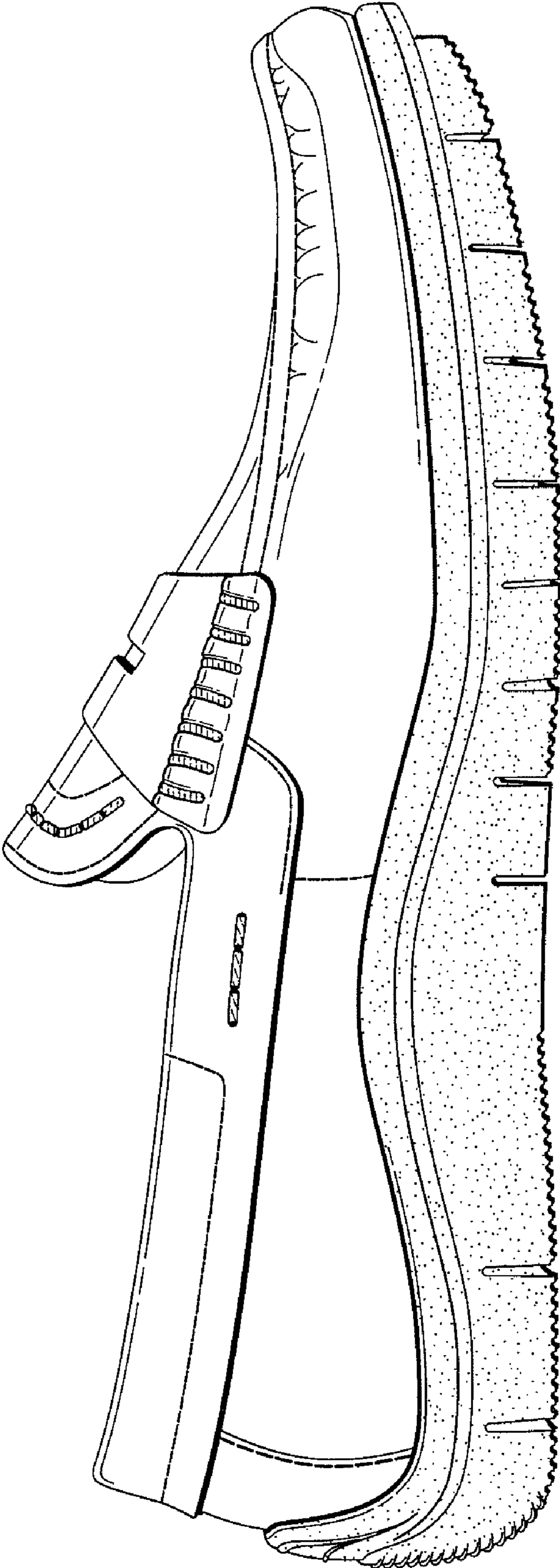

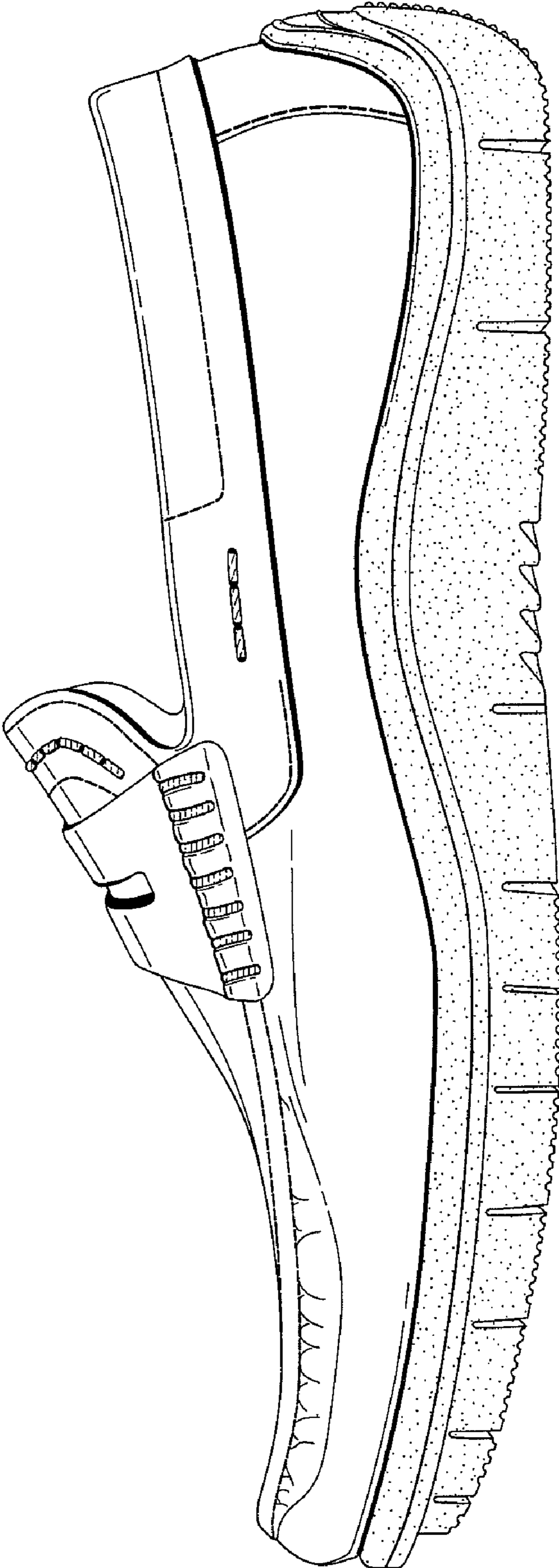

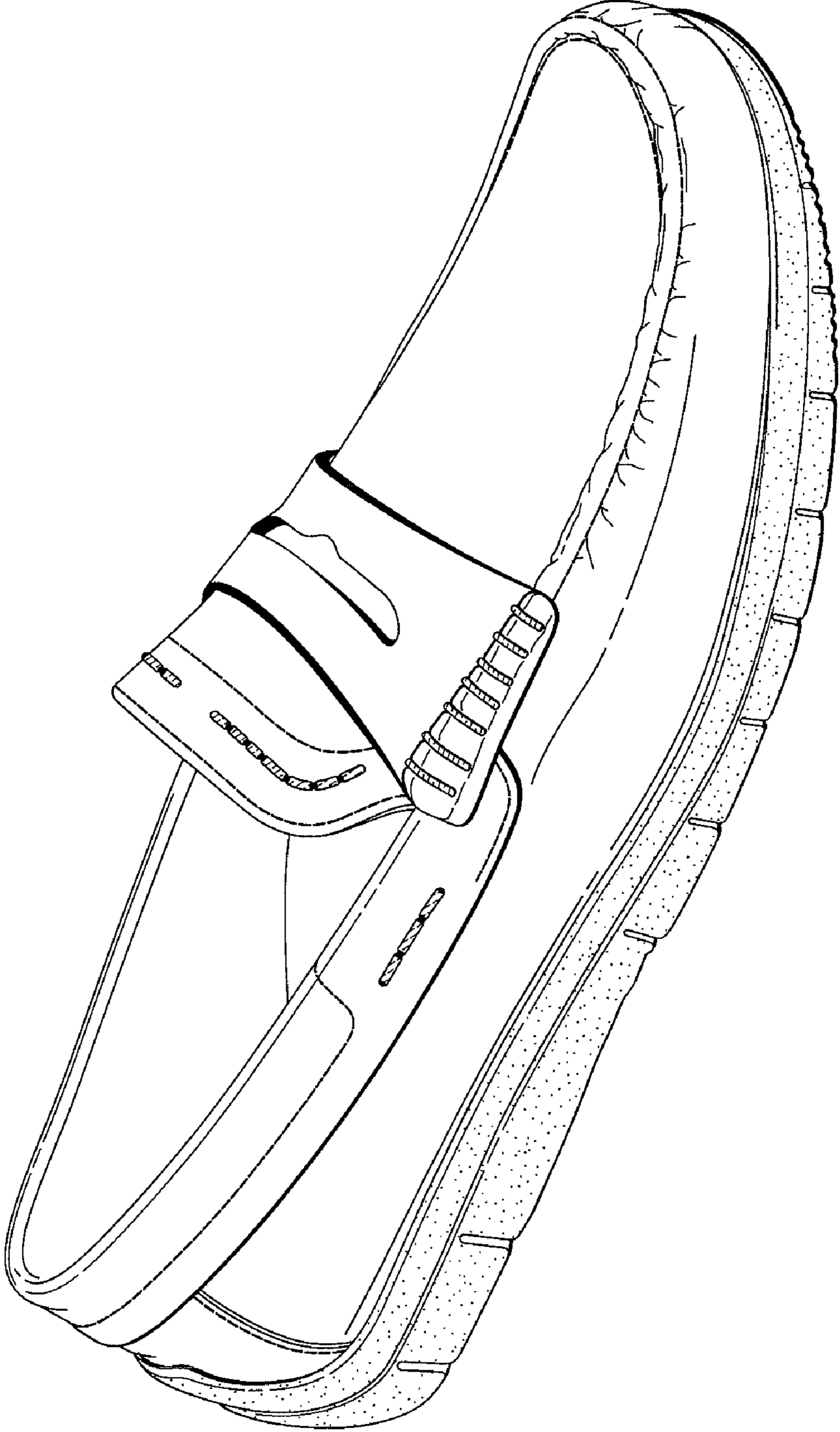
