 FIG. 5 is a front view thereof.

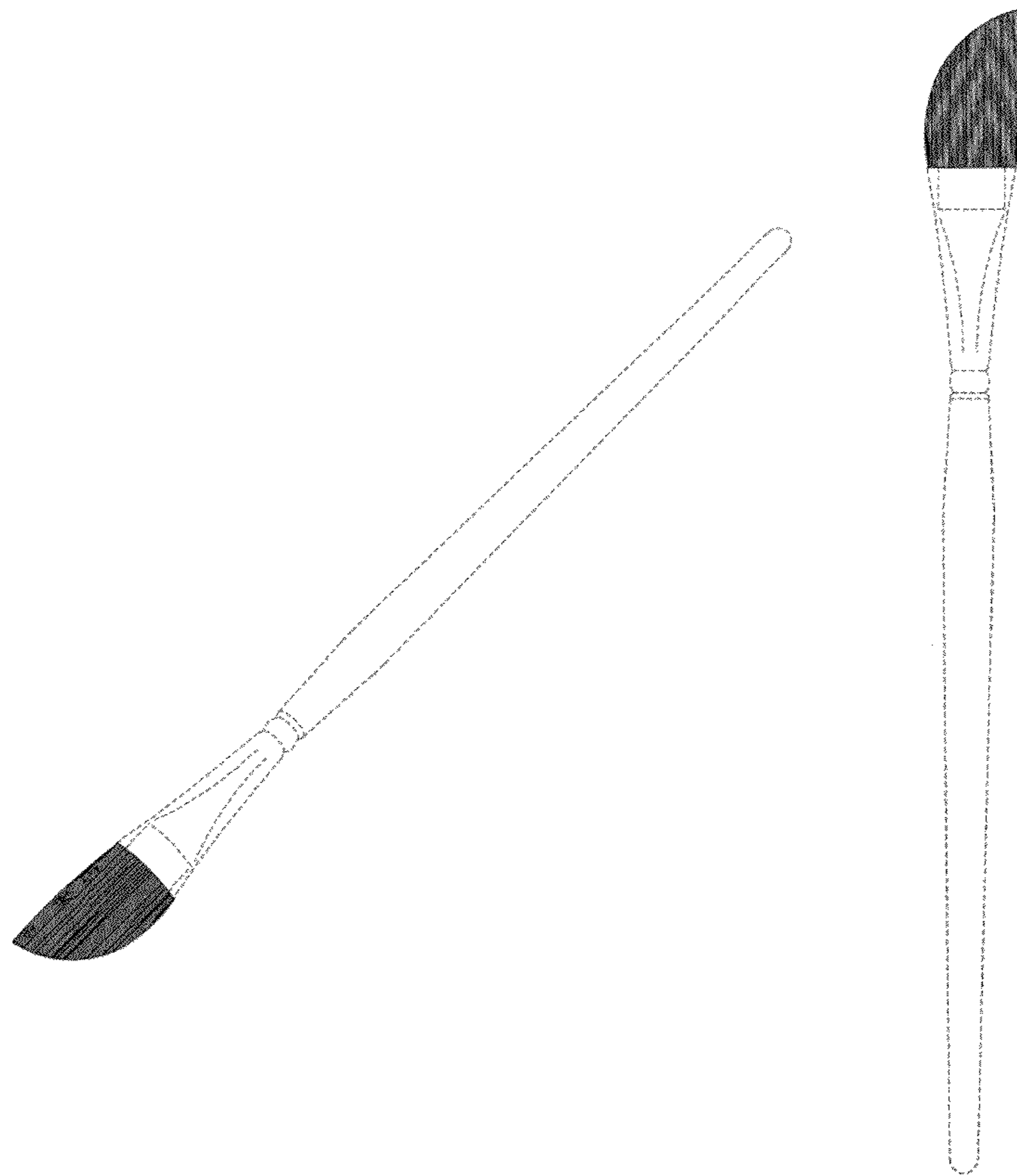

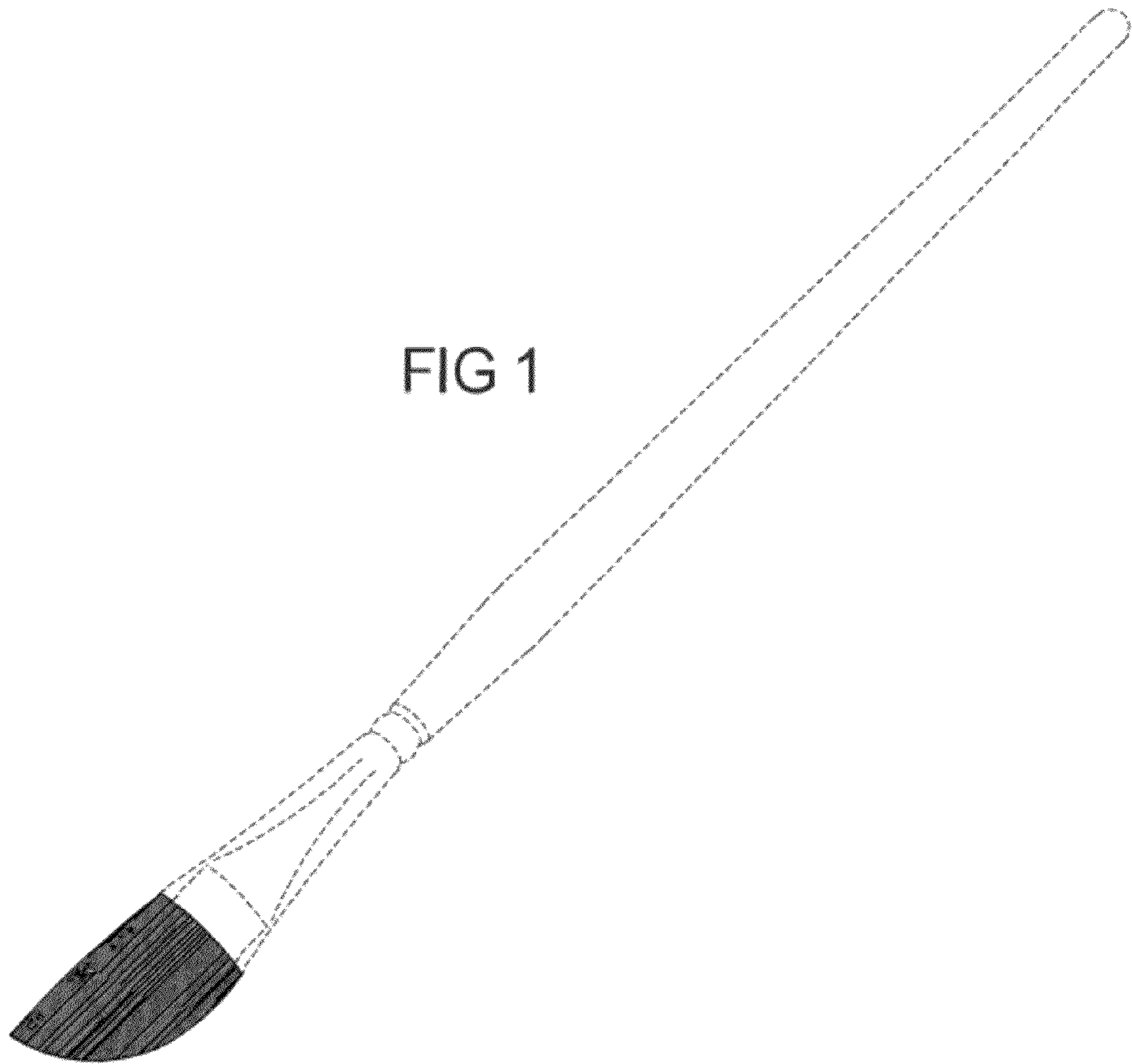

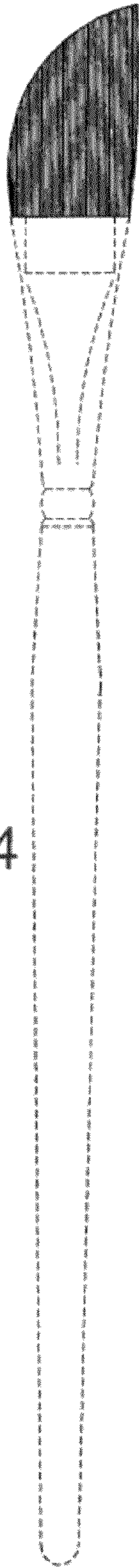
