(57) **CLAIM**

The ornamental design for a pedicure spa chair arms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front-exterior side view of the pedicure spa right chair arms. One chair arm is shown separately for ease of illustration.

FIG. 2 is a perspective front-interior side view of the pedicure spa right chair arms.

FIG. 3 is an exterior side view of the pedicure spa right chair arms.

FIG. 4 is an interior left-side view of the pedicure spa right chair arms.

FIG. 5 is a top view of the pedicure spa right chair arms.

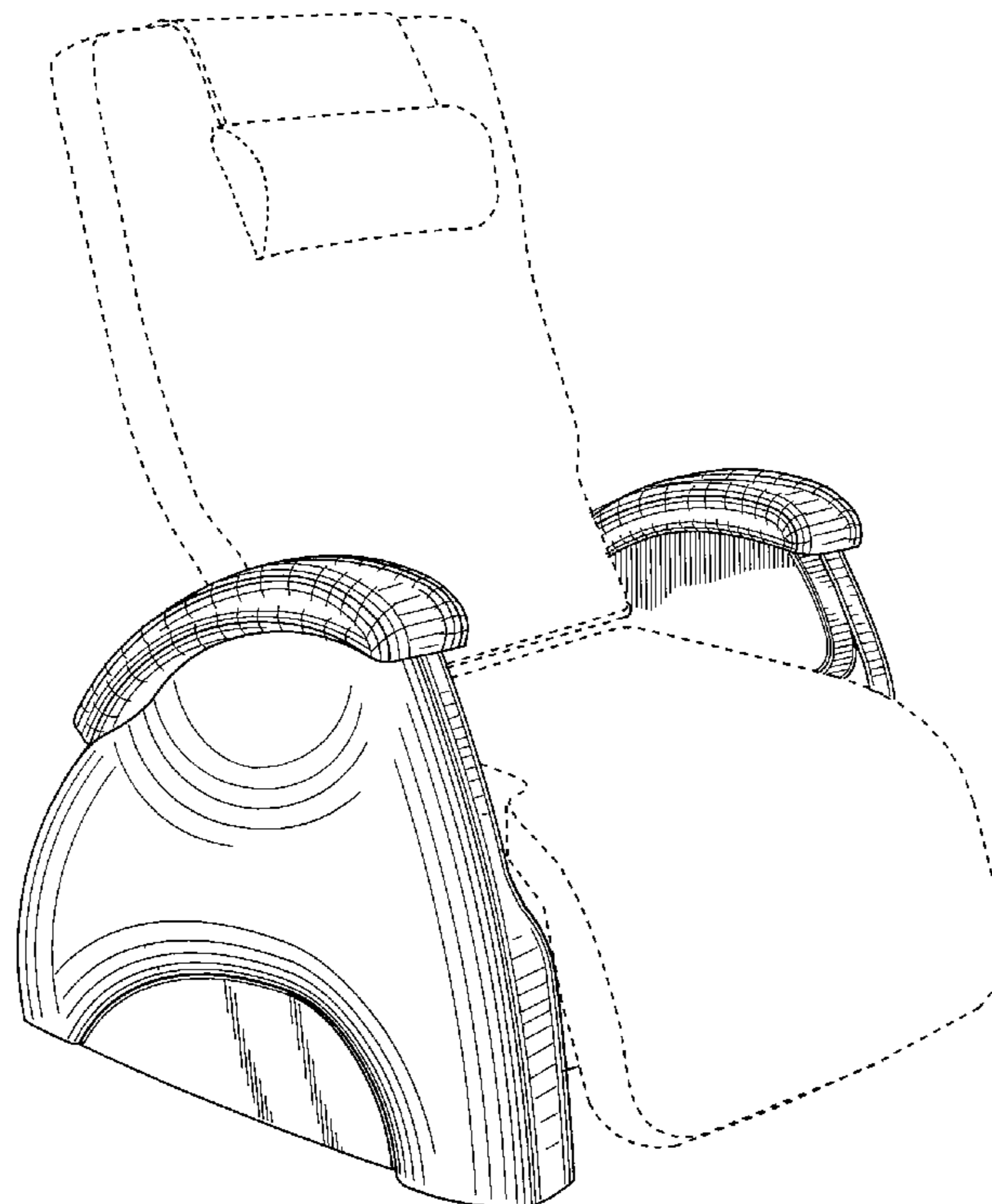
FIG. 6 is a bottom view of the pedicure spa right chair arms.

FIG. 7 is a front view of the pedicure spa right chair arms.

FIG. 8 is a rear view of the pedicure spa right chair arms; and, FIG. 9 is a perspective front side view of both the pedicure spa right chair arms and left chair arm, showing the position of the chair back and chair leg support positioned therebetween.

The broken lines in the drawings, particularly those depicting a chair back and chair leg support shown in FIG. 9, are for illustrative purposes only and form no part of the claimed design.

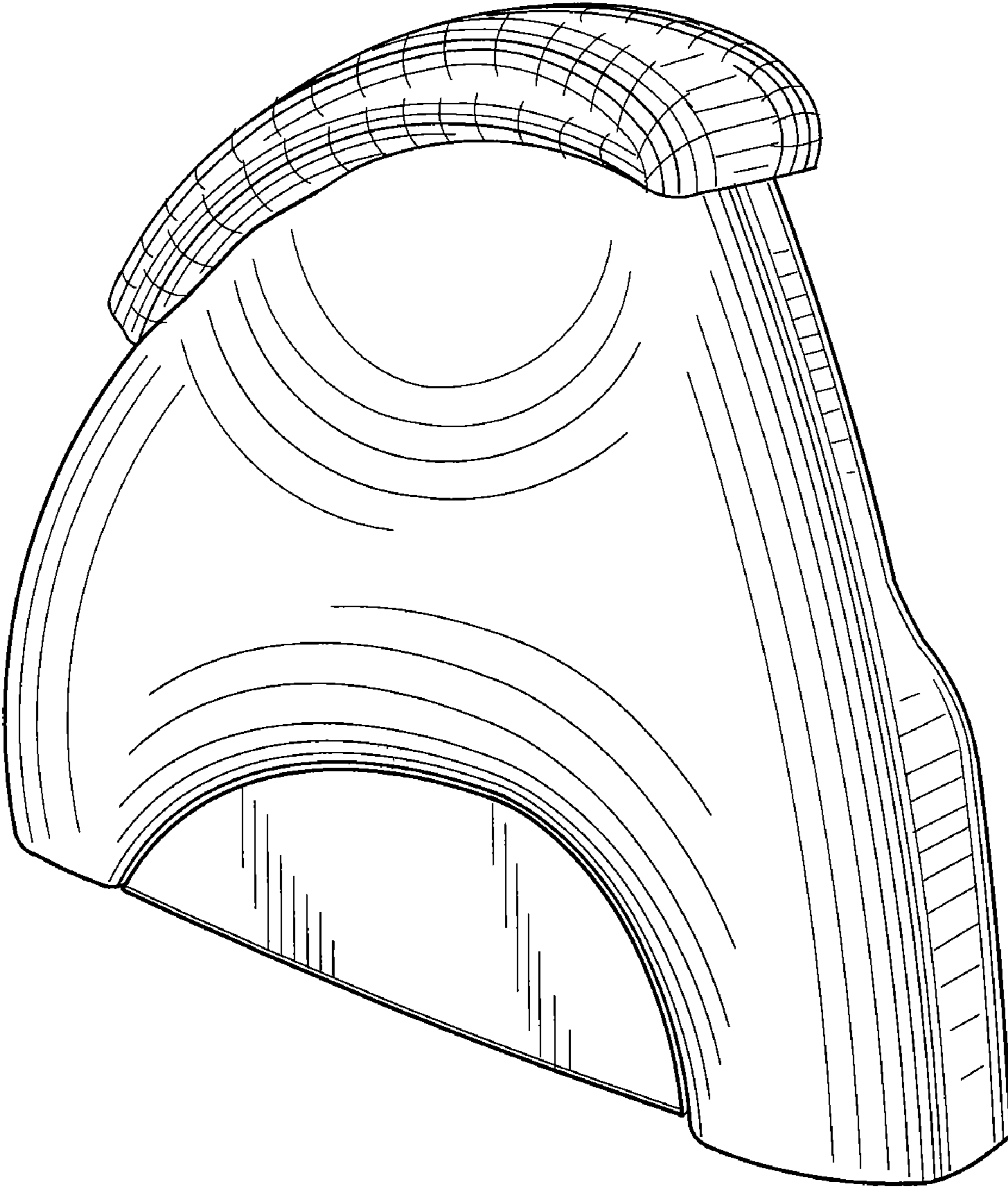

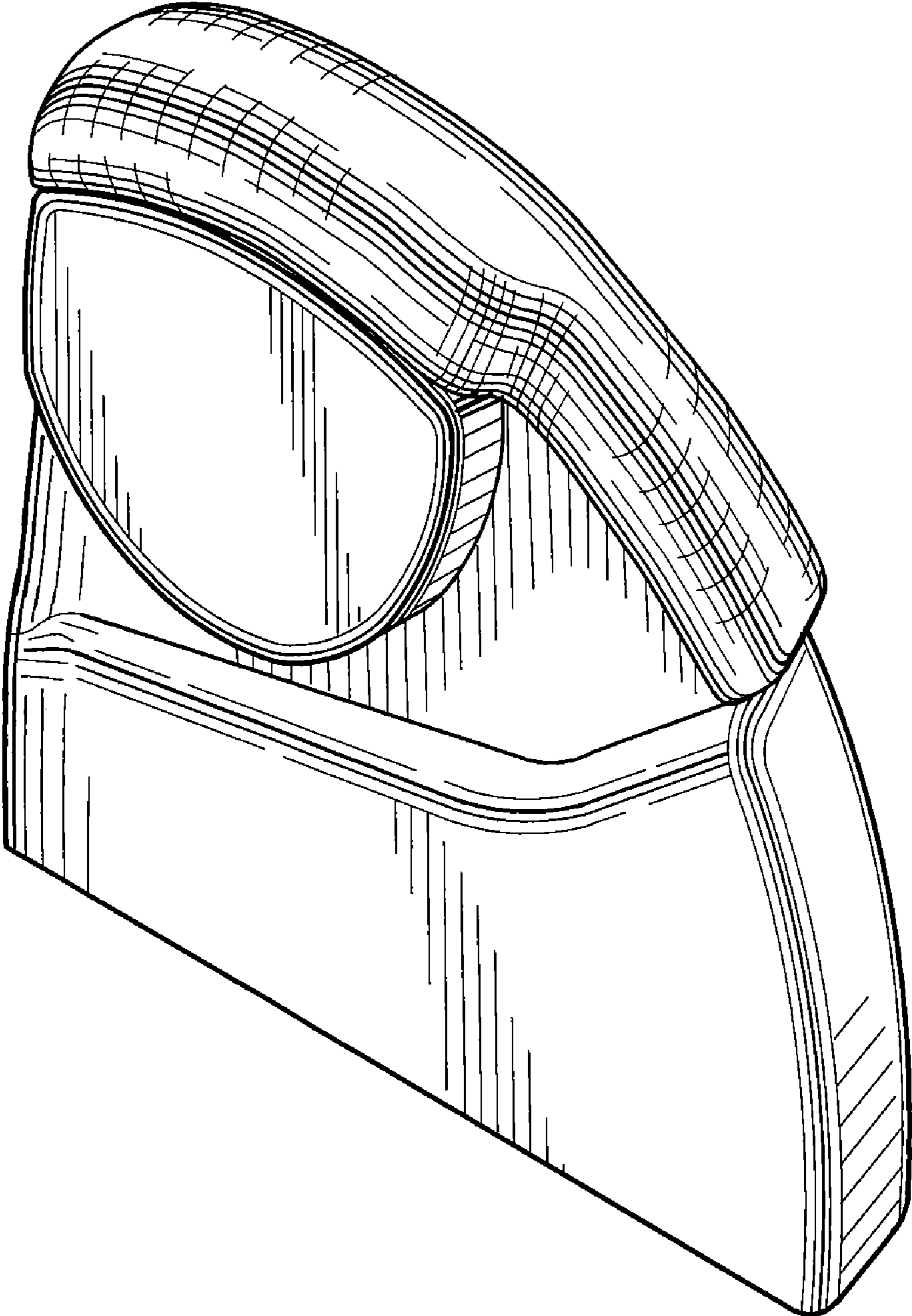

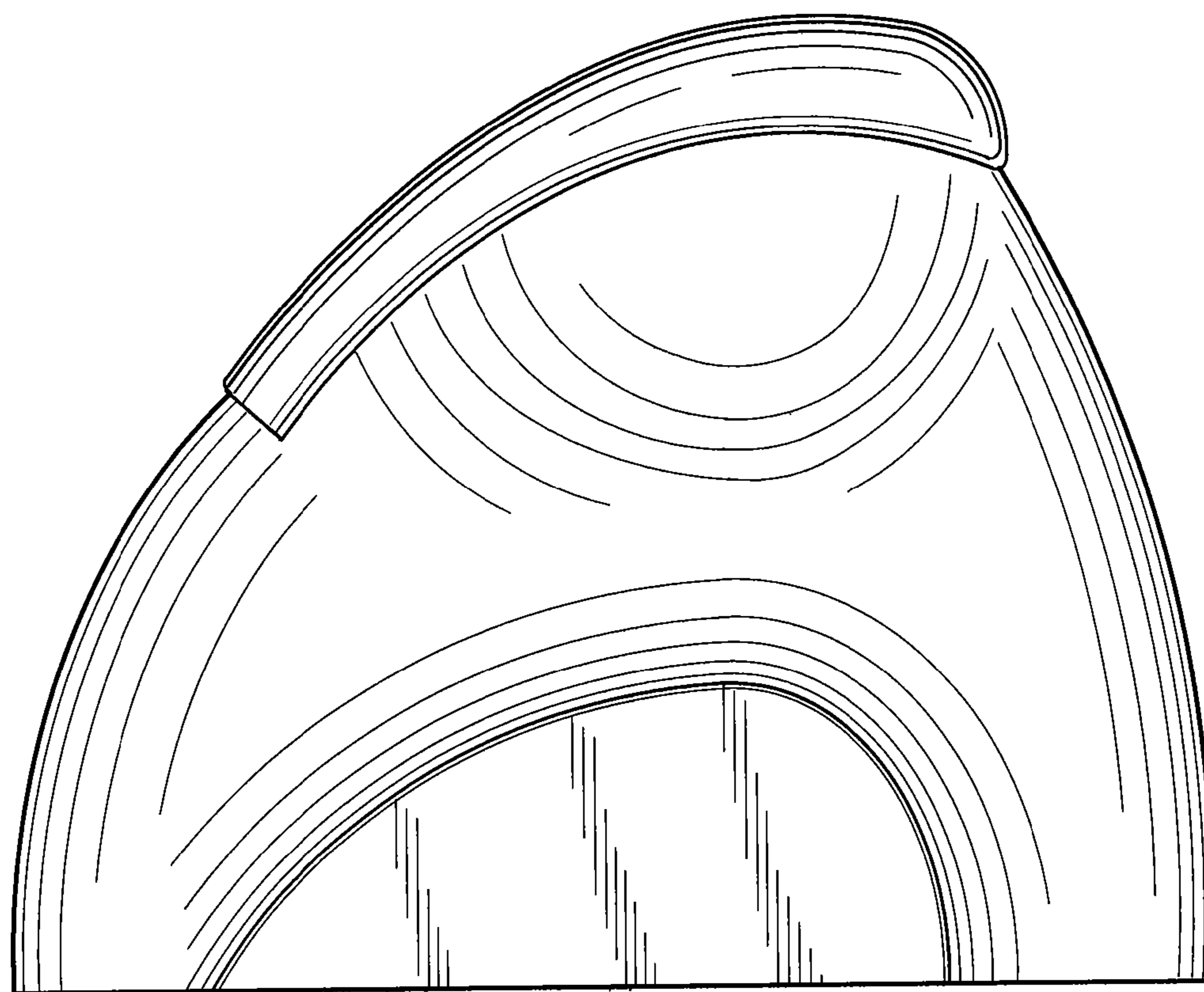

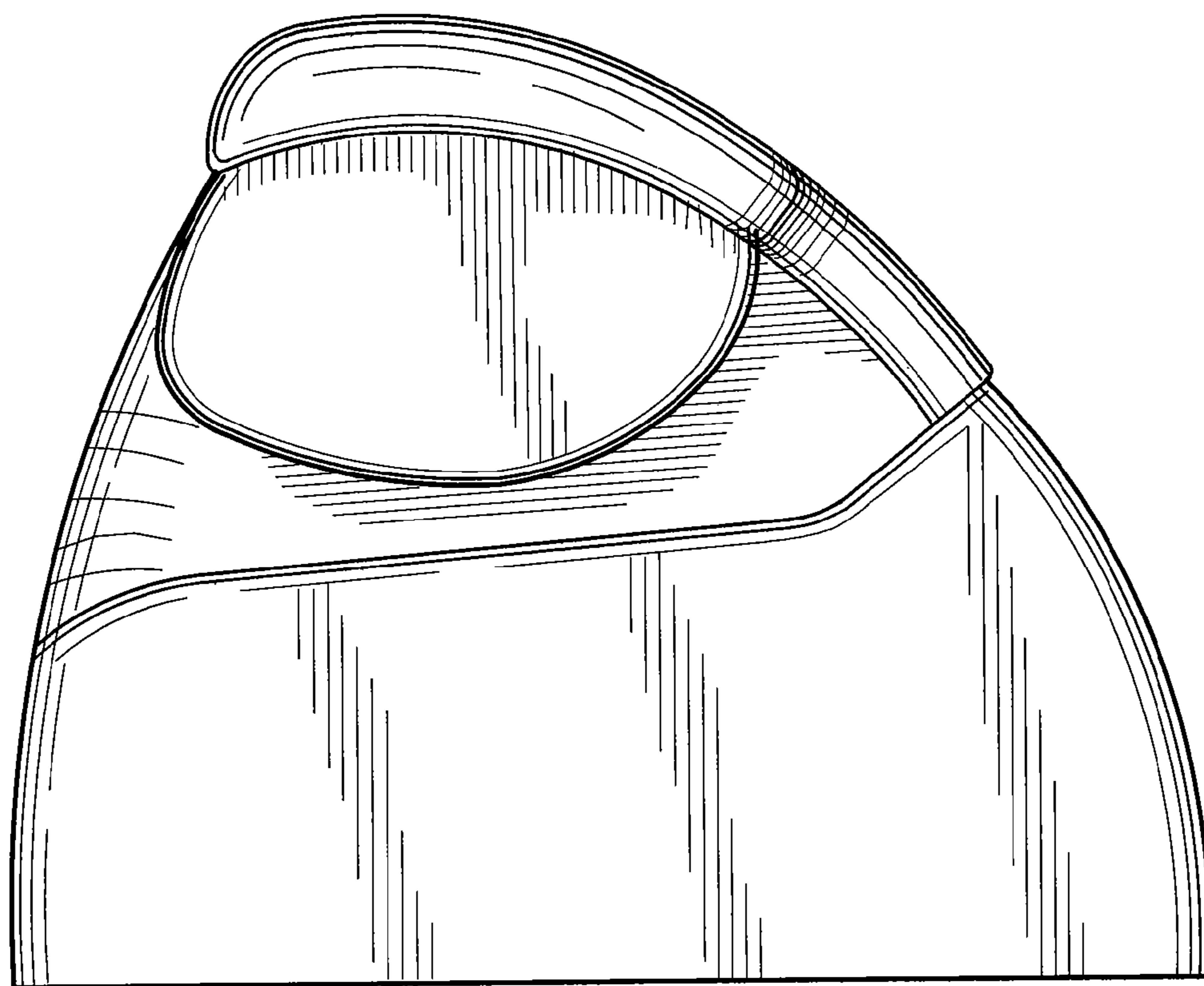

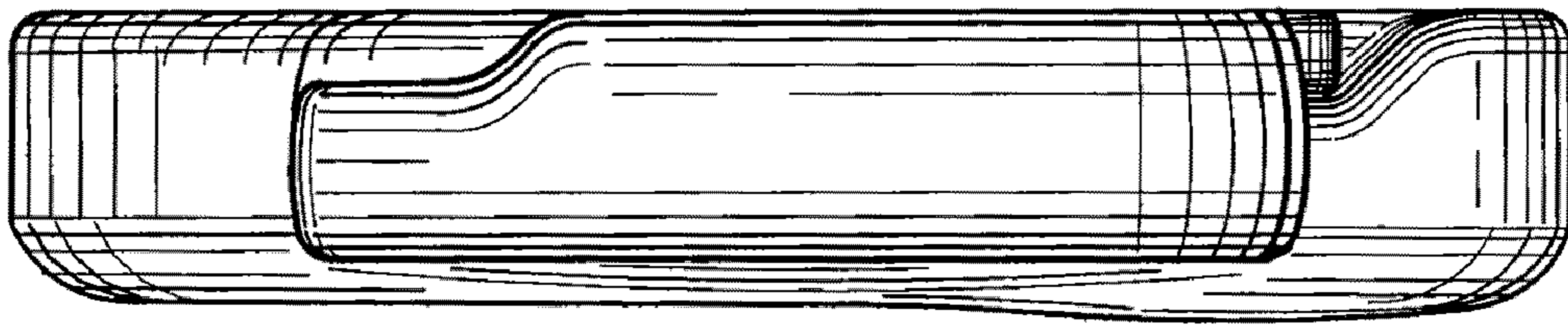

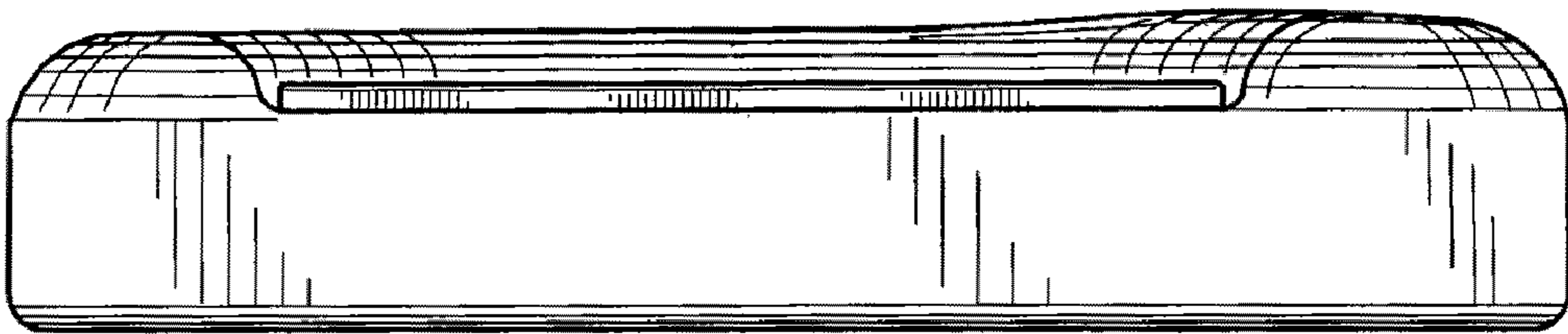

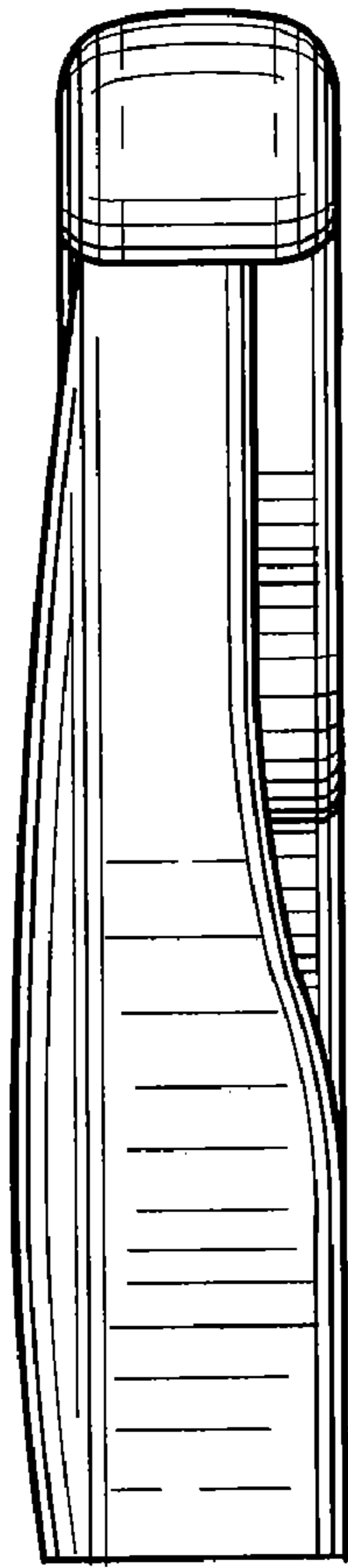

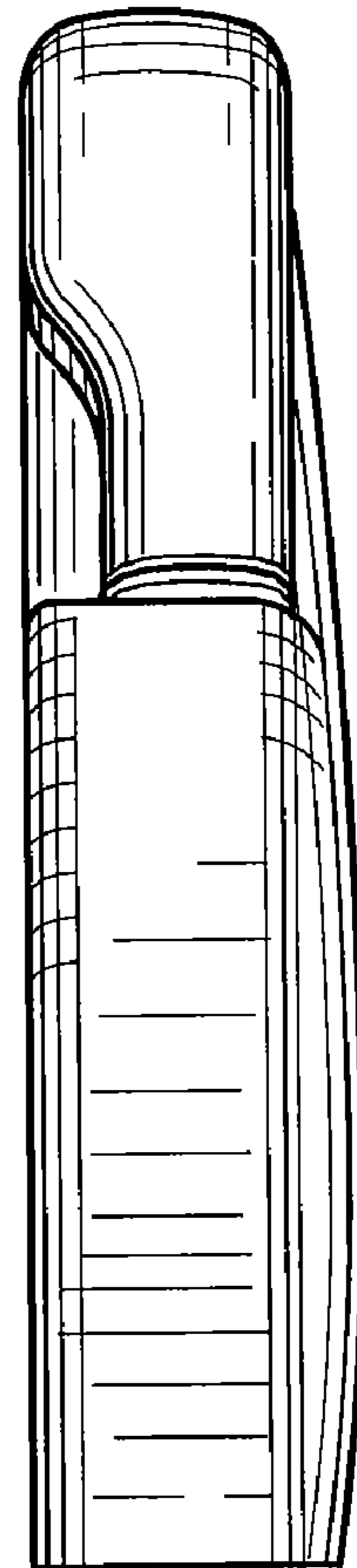

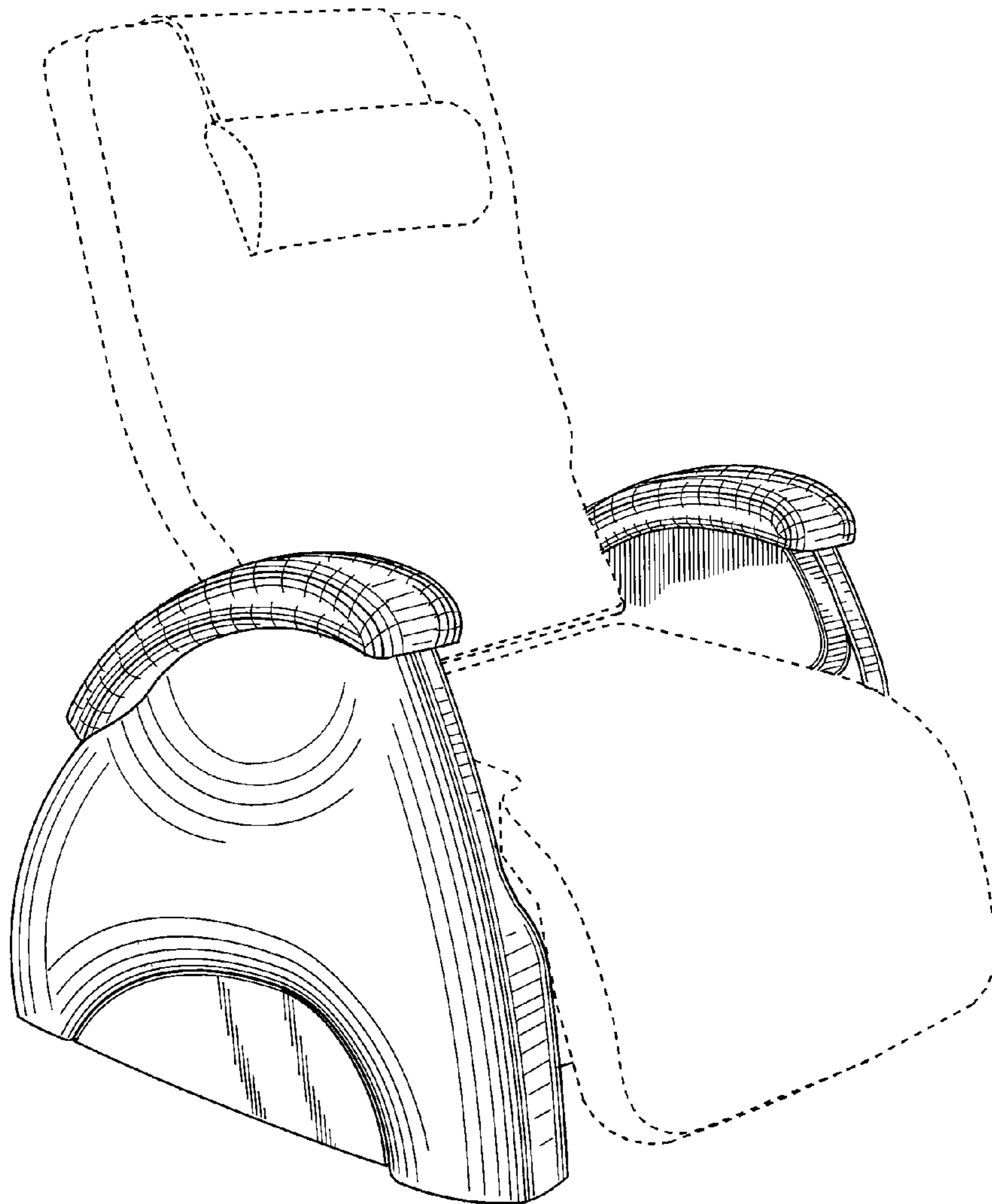
