**DESCRIPTION**

FIG. 1 is a front elevation view of a handle bracket showing my new design.

FIG. 2 is a left side elevation view thereof. The right side is a mirror image of FIG. 2.

FIG. 3 is a top plan view thereof.

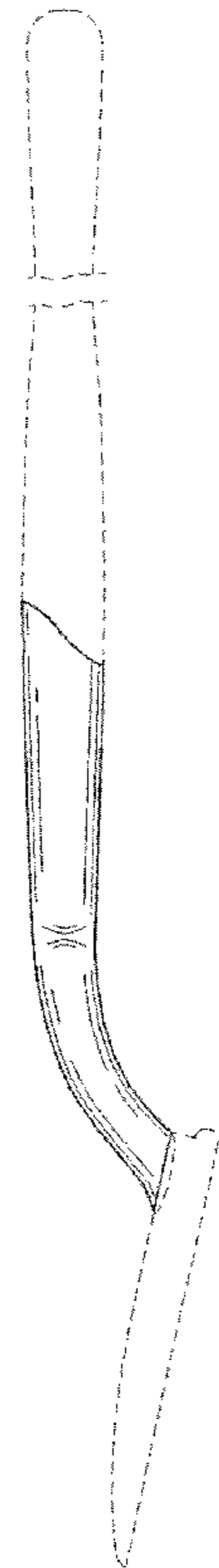
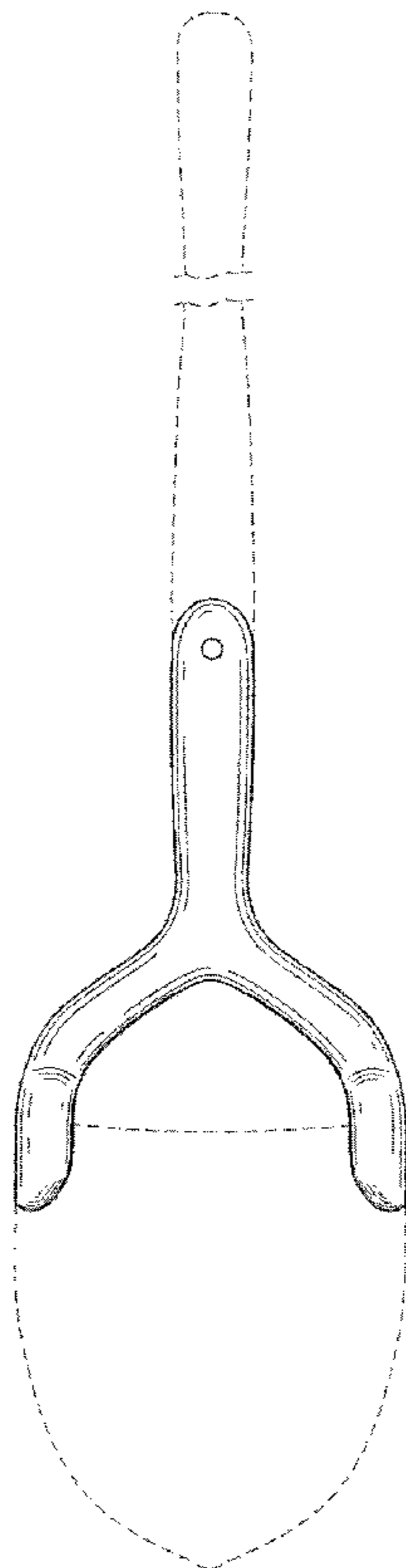

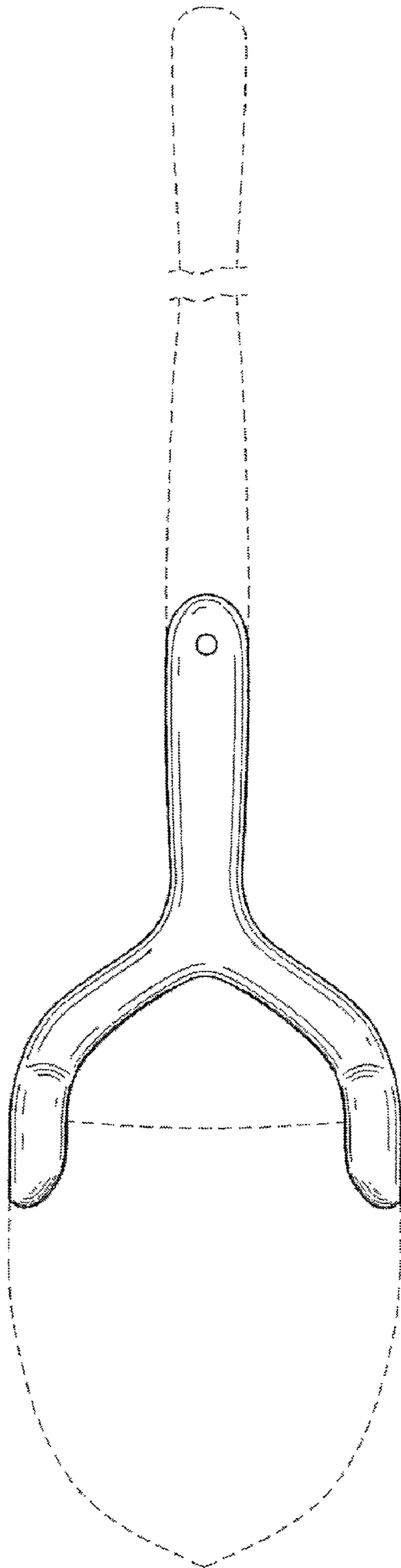

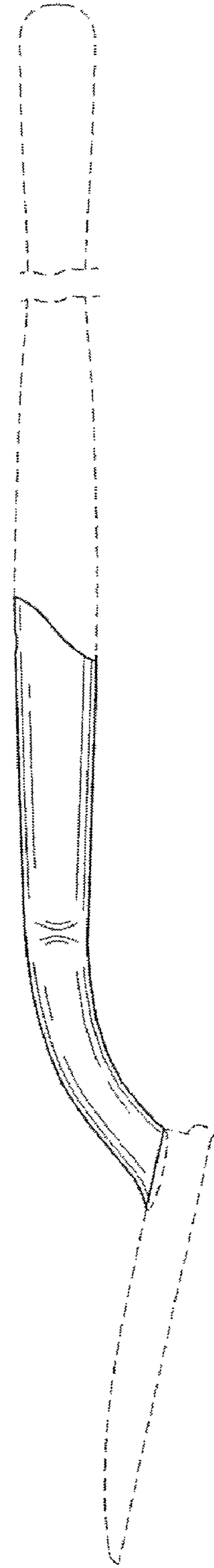

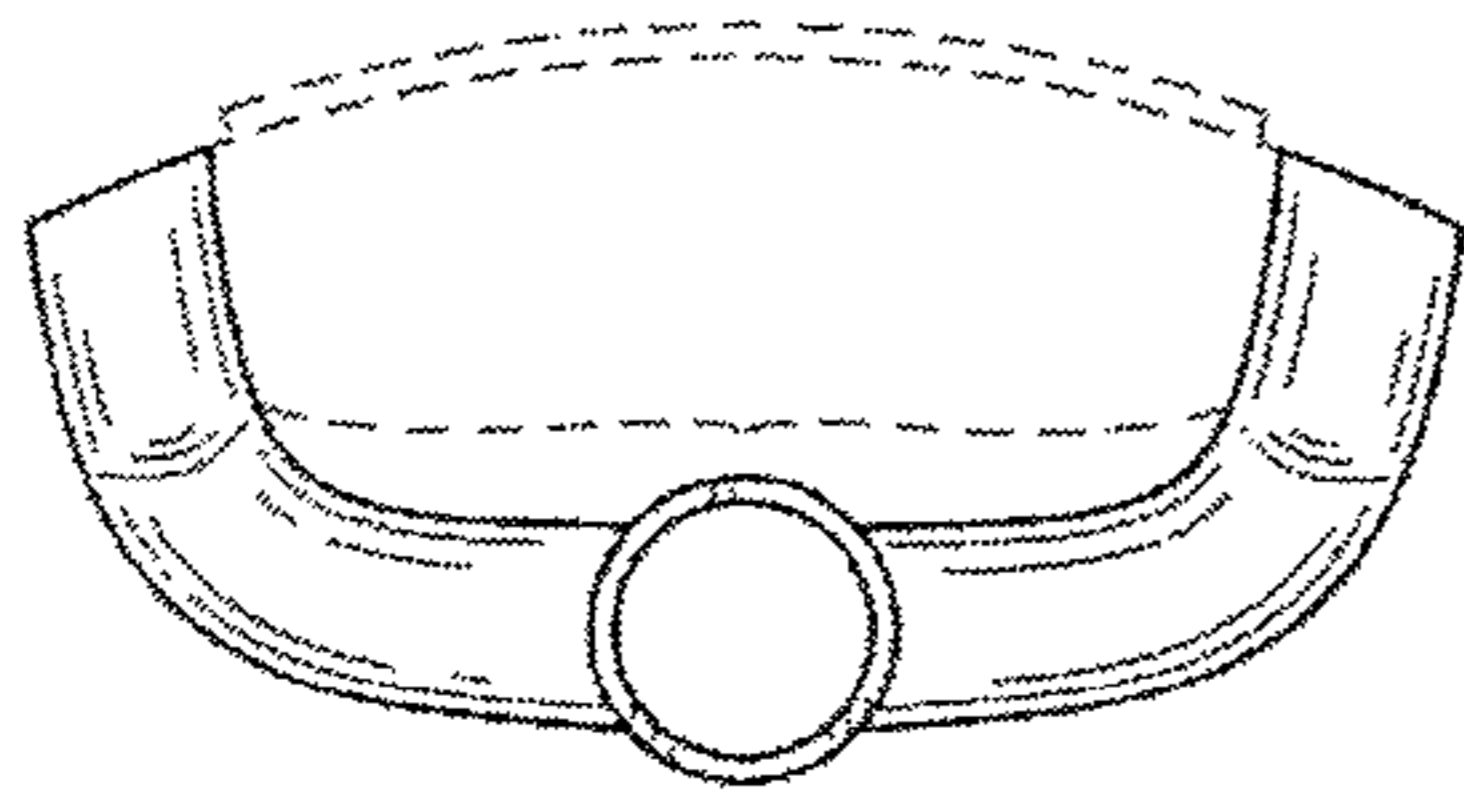

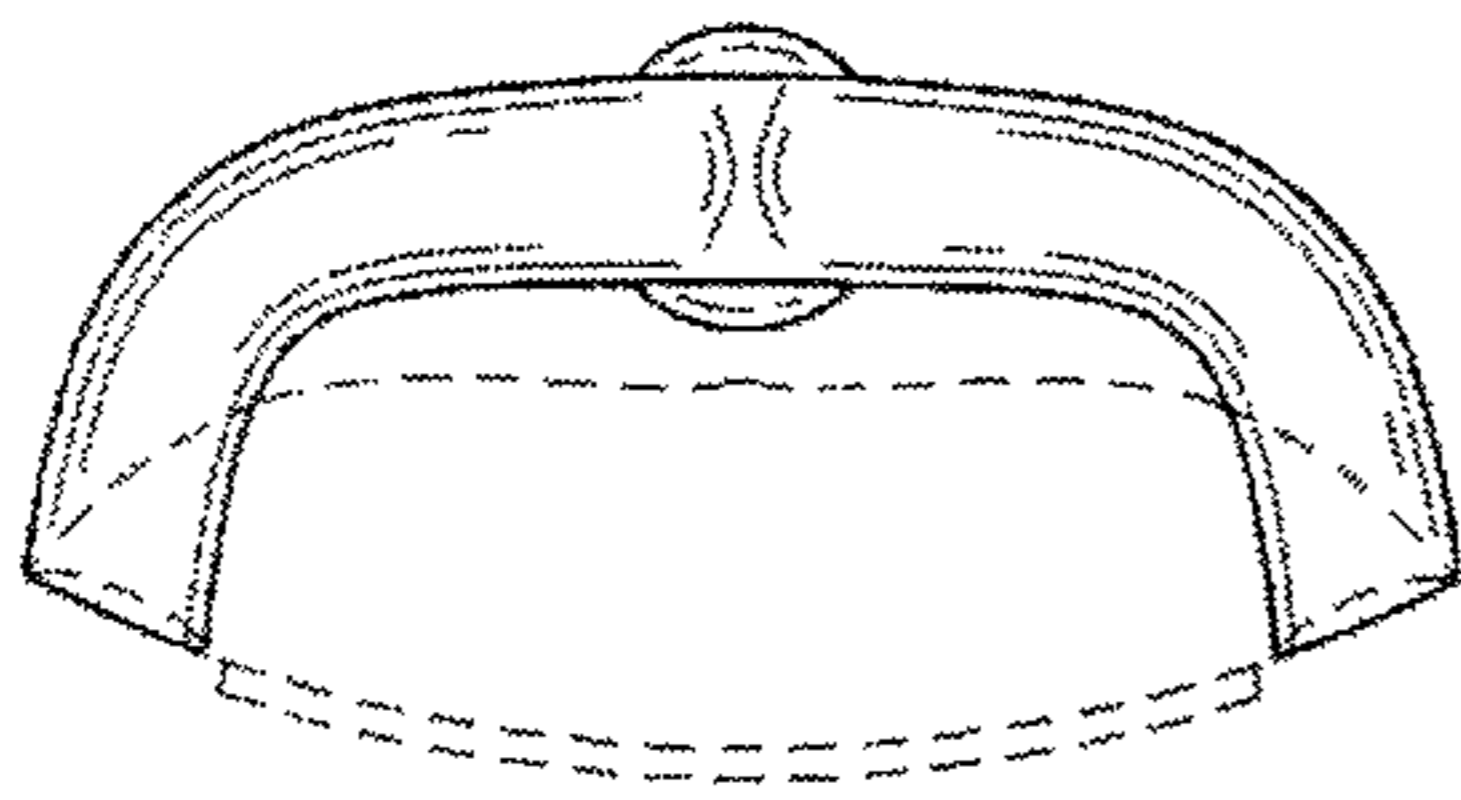
