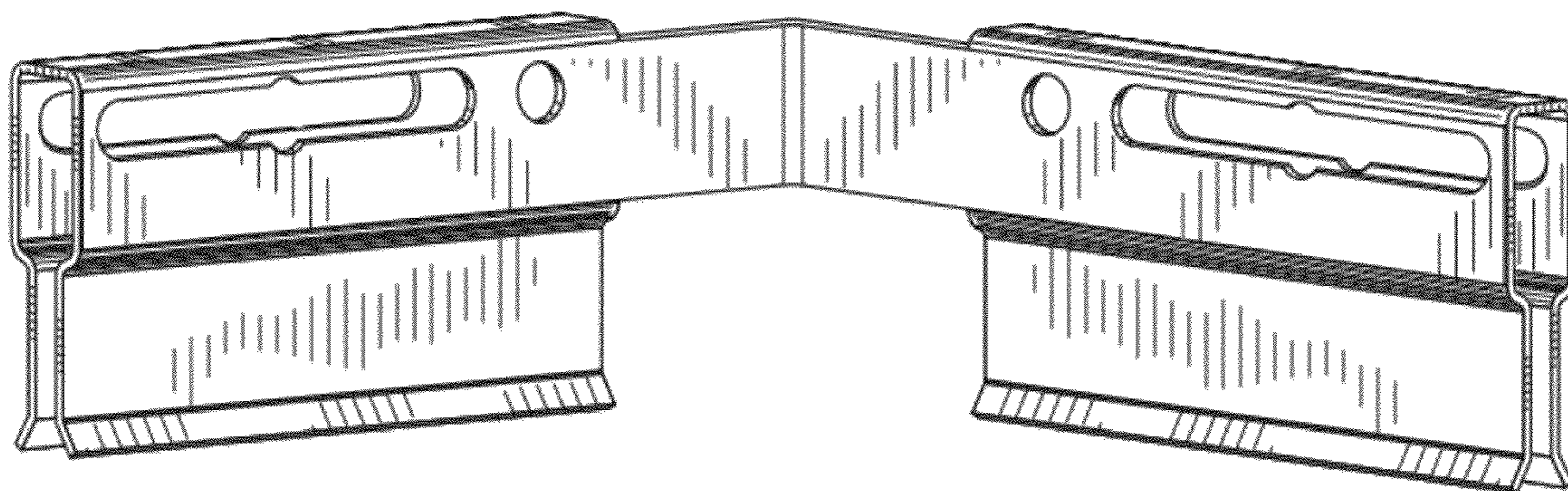

DESCRIPTION

FIG. 1 is an isometric view of a seismic transition joint clip for suspension ceiling system showing my new design. FIGS. 2 and 3 are front and back views of the clip of FIG. 1; FIGS. 4 and 5 are side views of the clip of FIG. 1; and, FIGS. 6 and 7 are top and bottom views of the clip of FIG. 1.

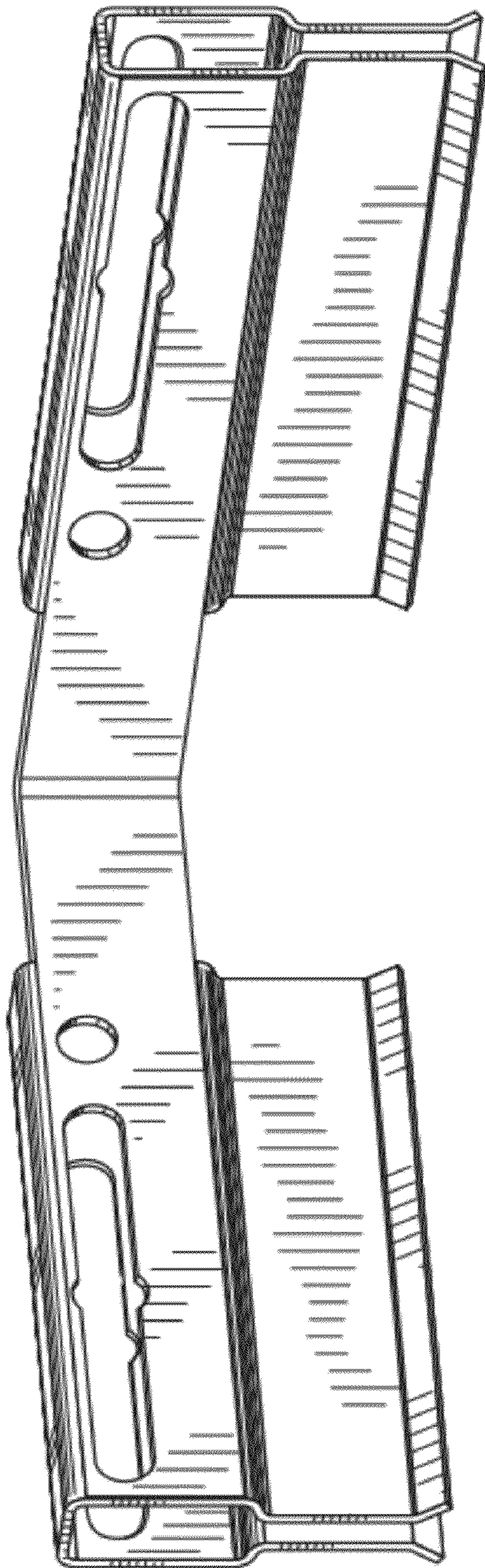

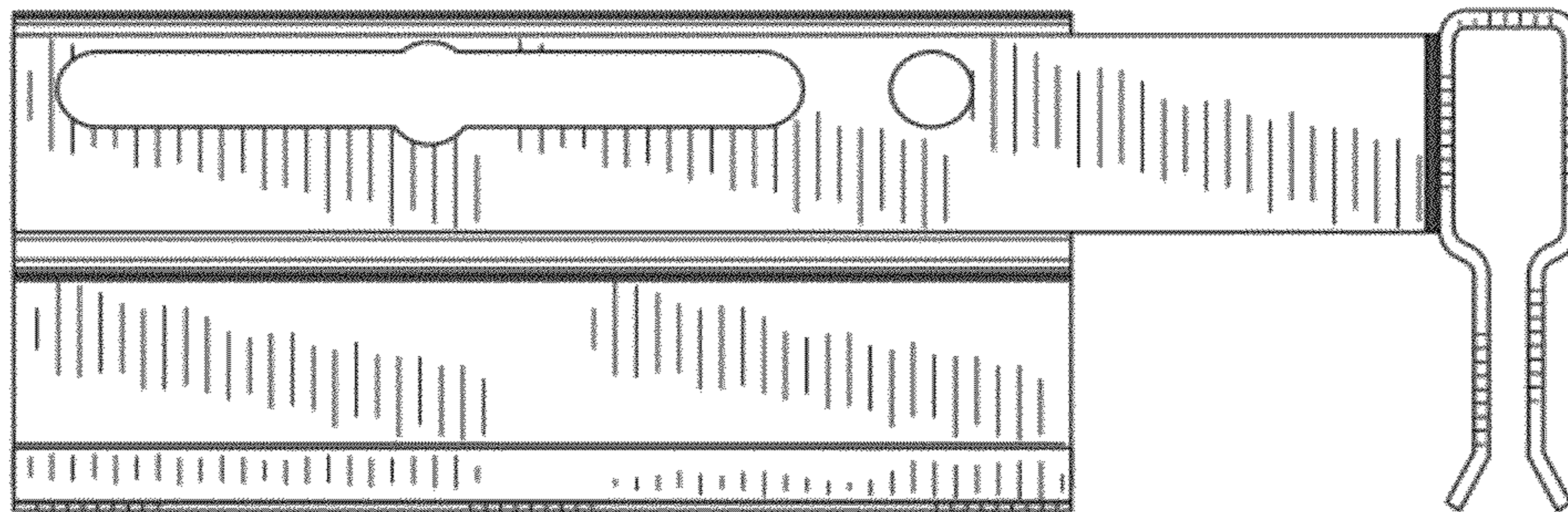

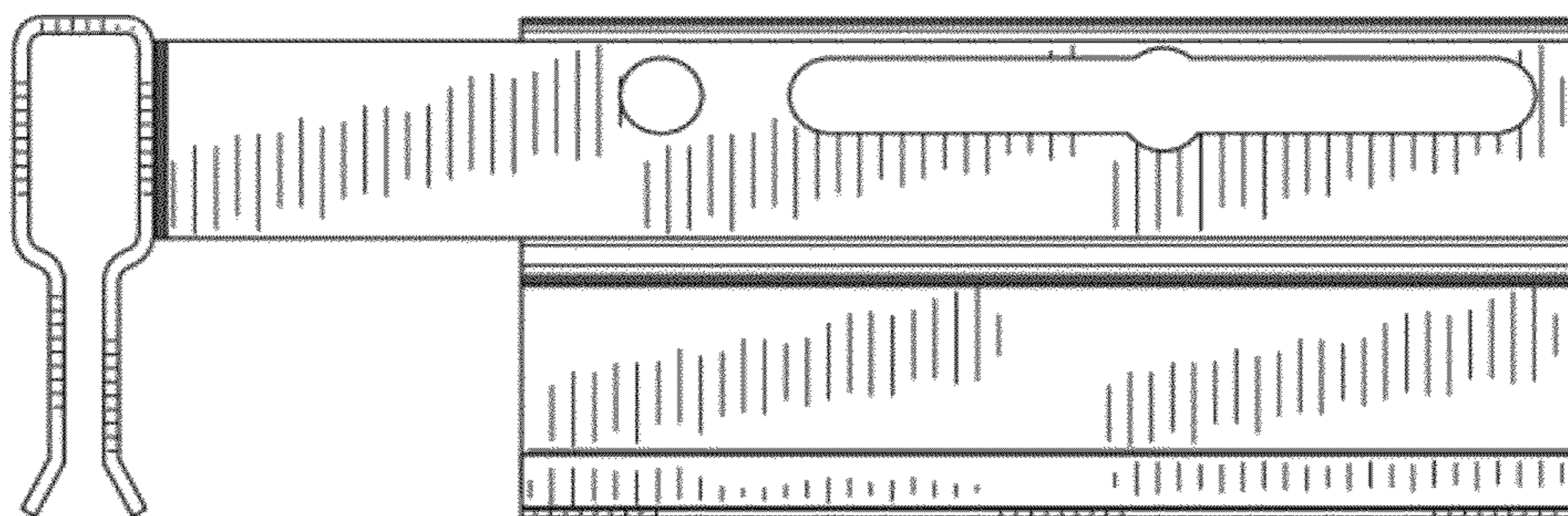

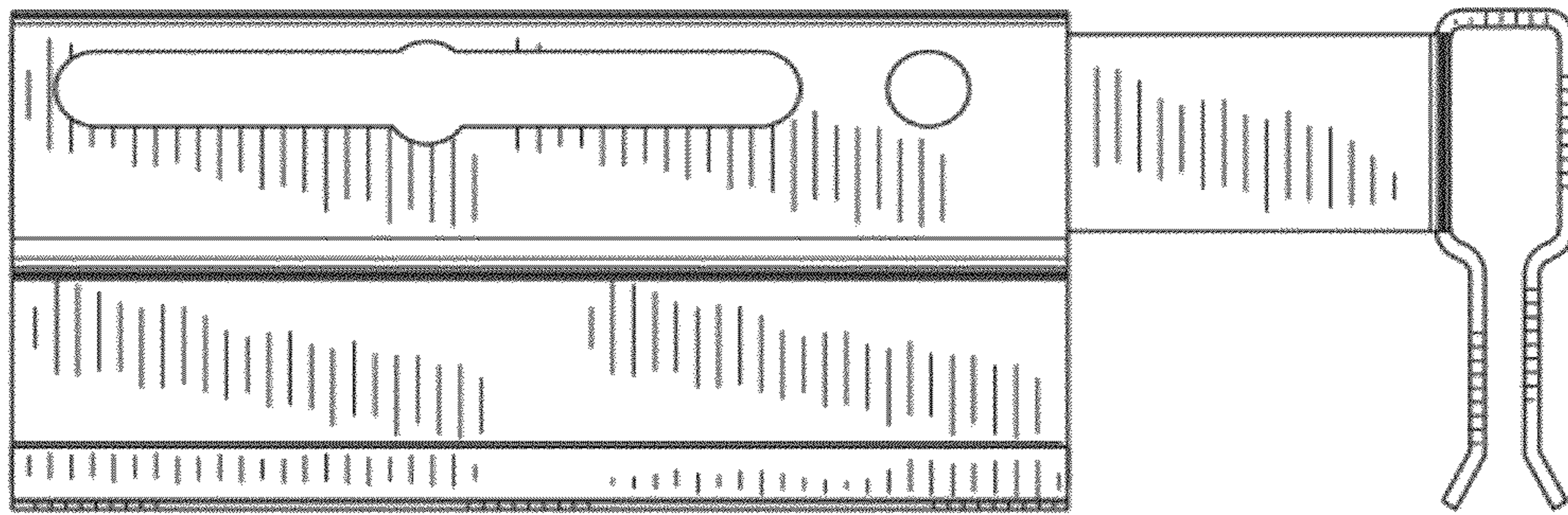

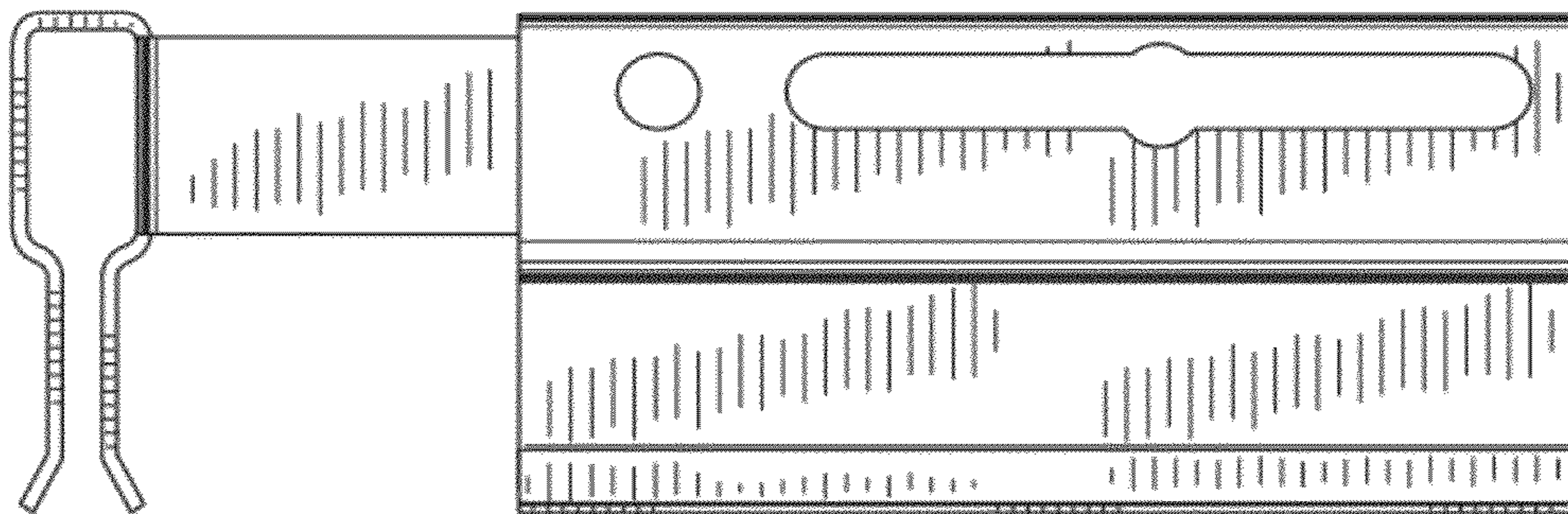

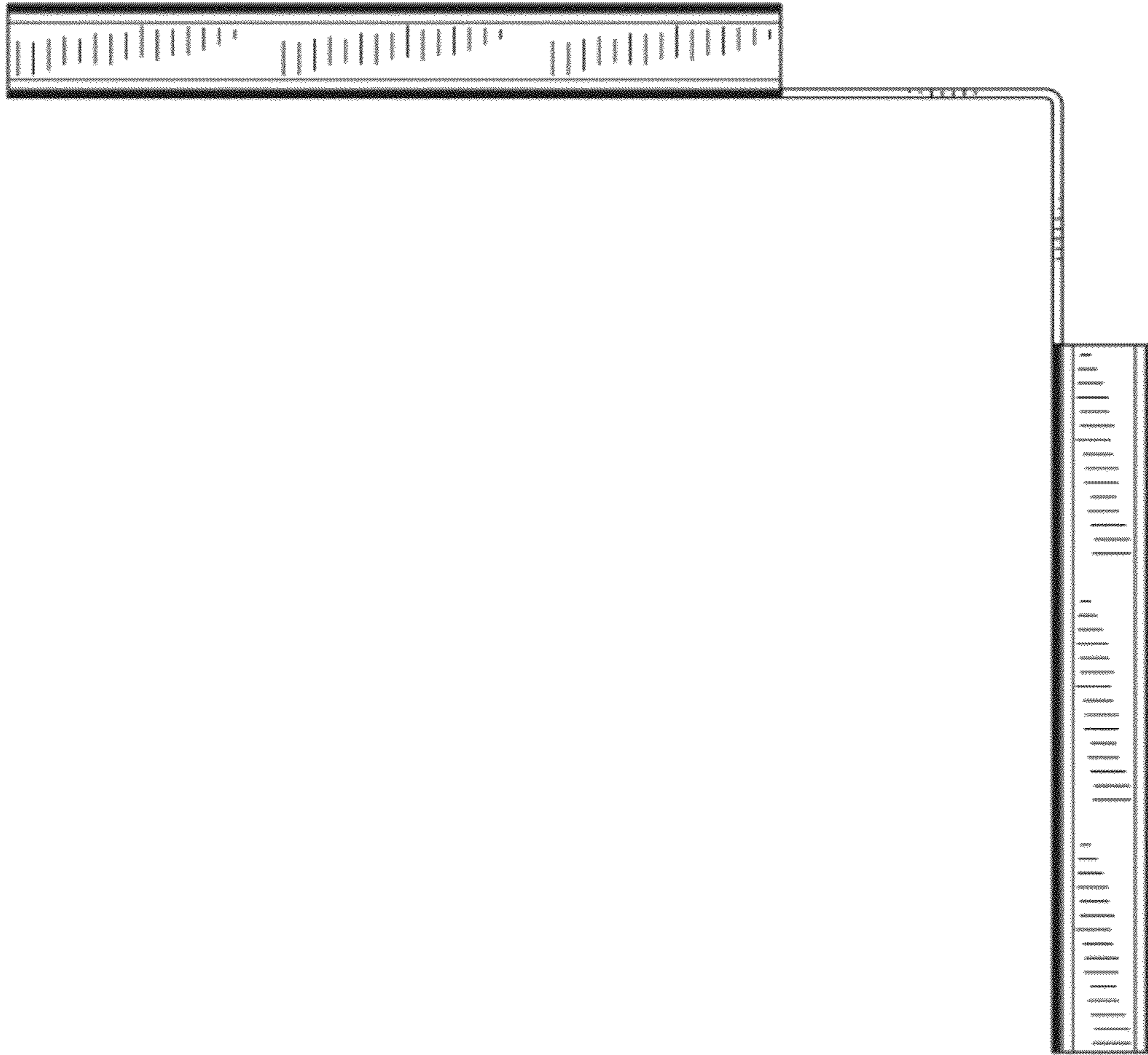

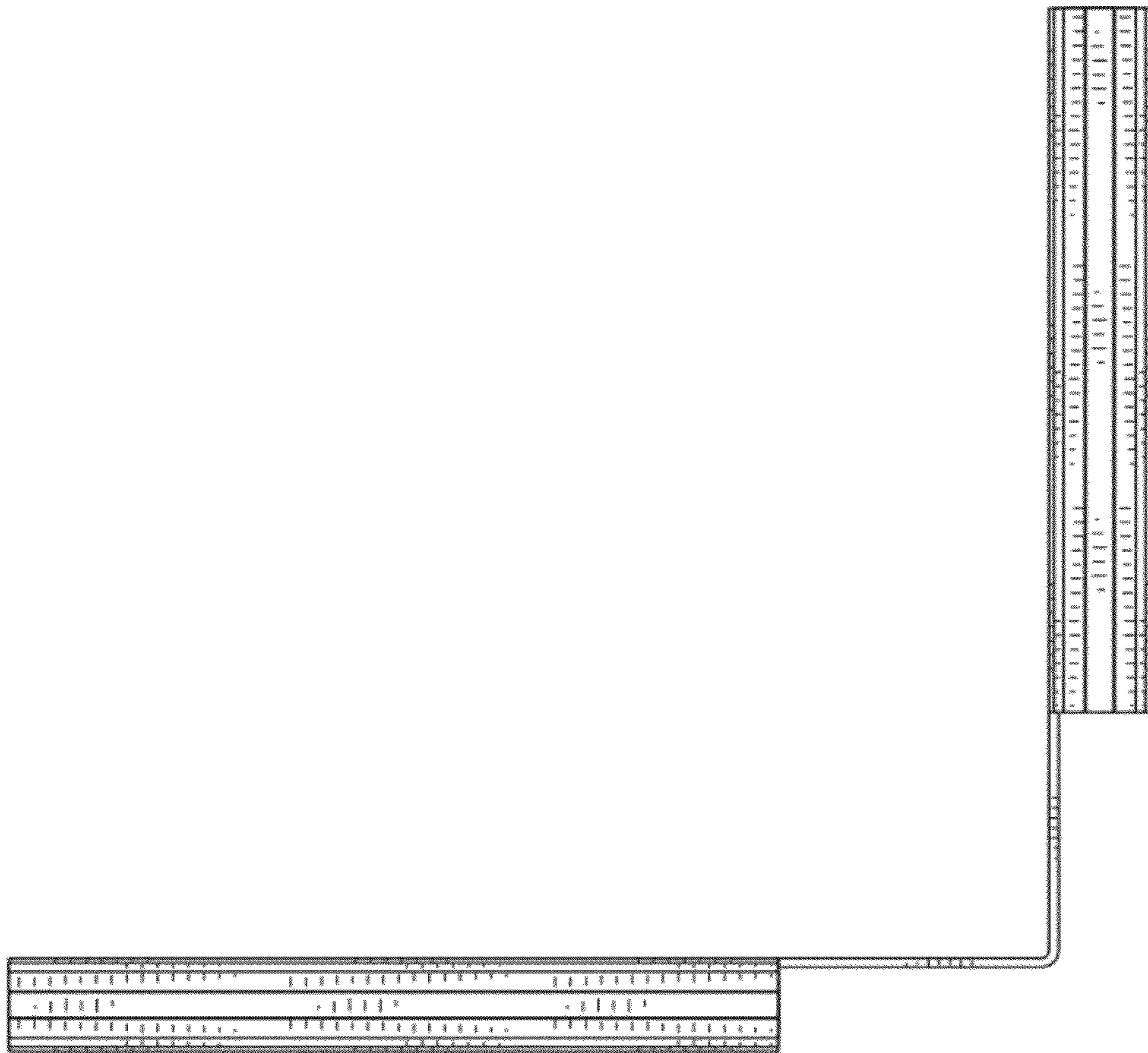
