**DESCRIPTION**

FIG. 1 is a top, front and side perspective view of our design  
for a part of container;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a side elevational view thereof;  
FIG. 5 is an elevational view of the other side thereof;  
FIG. 6 is a top plan view thereof; and,

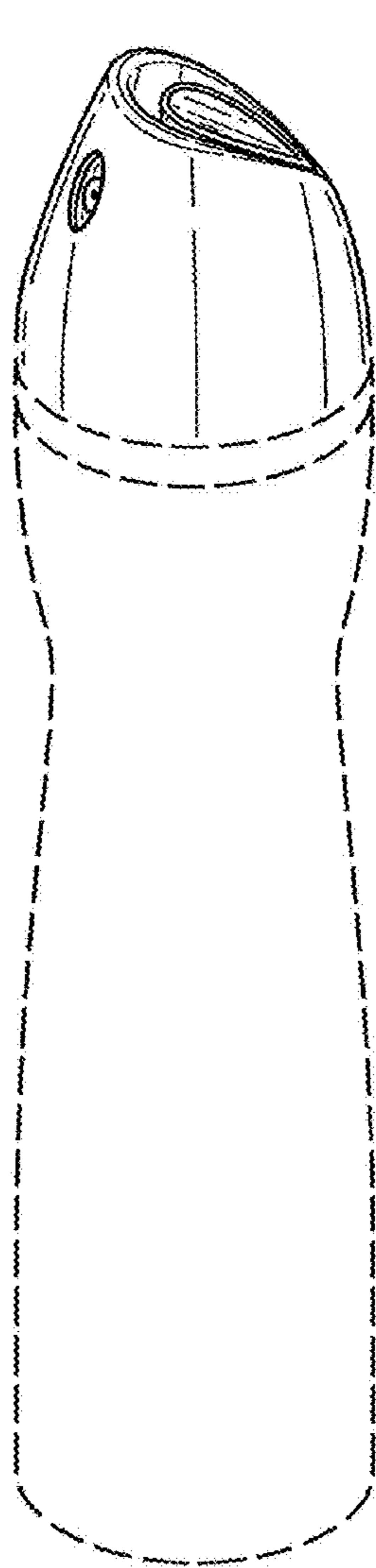

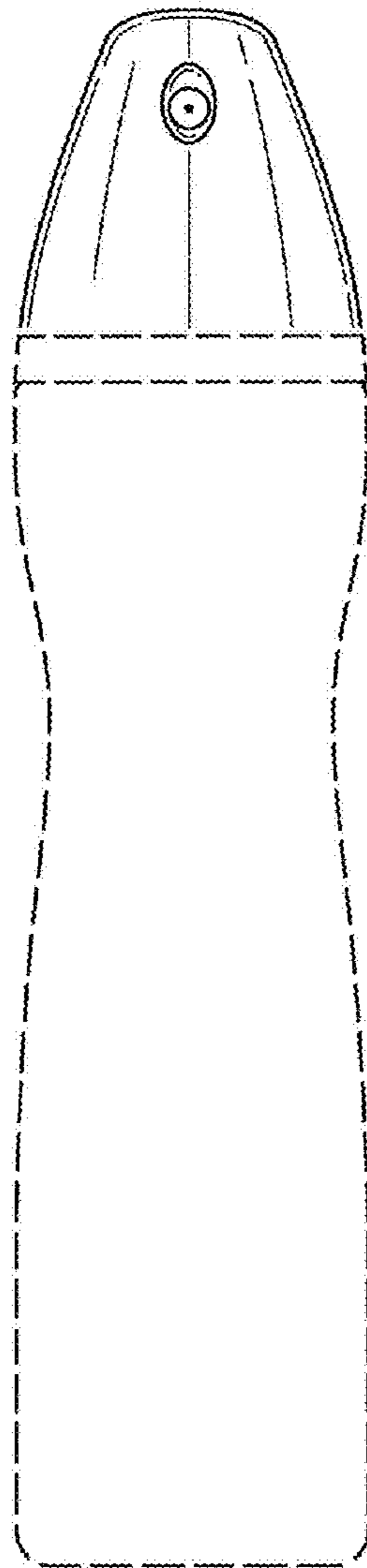

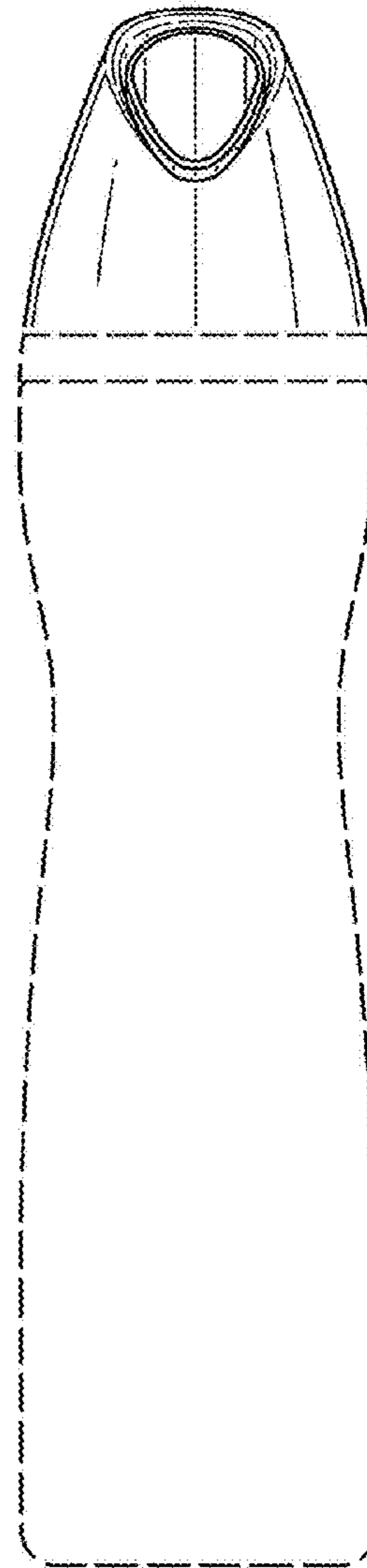

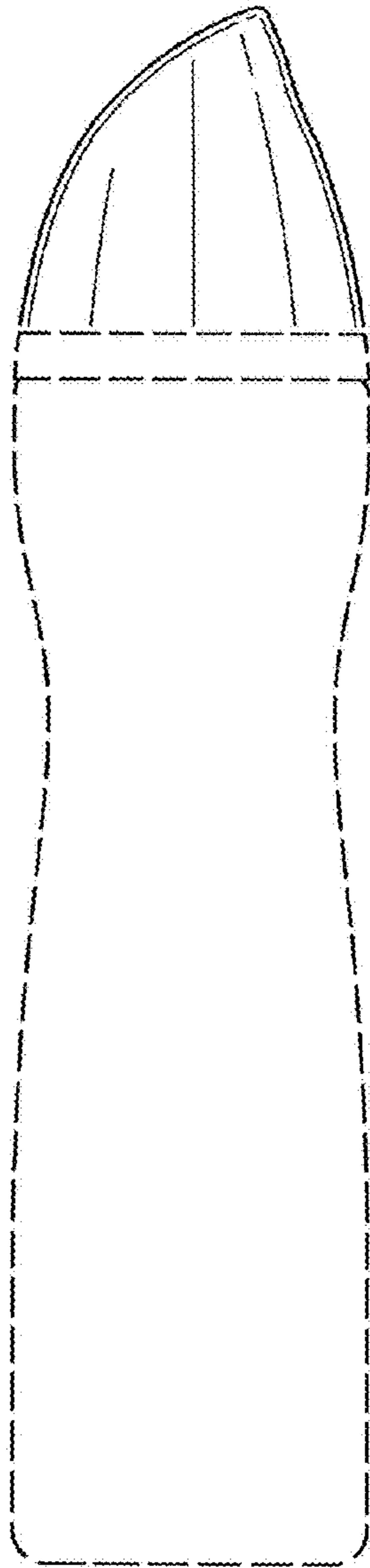

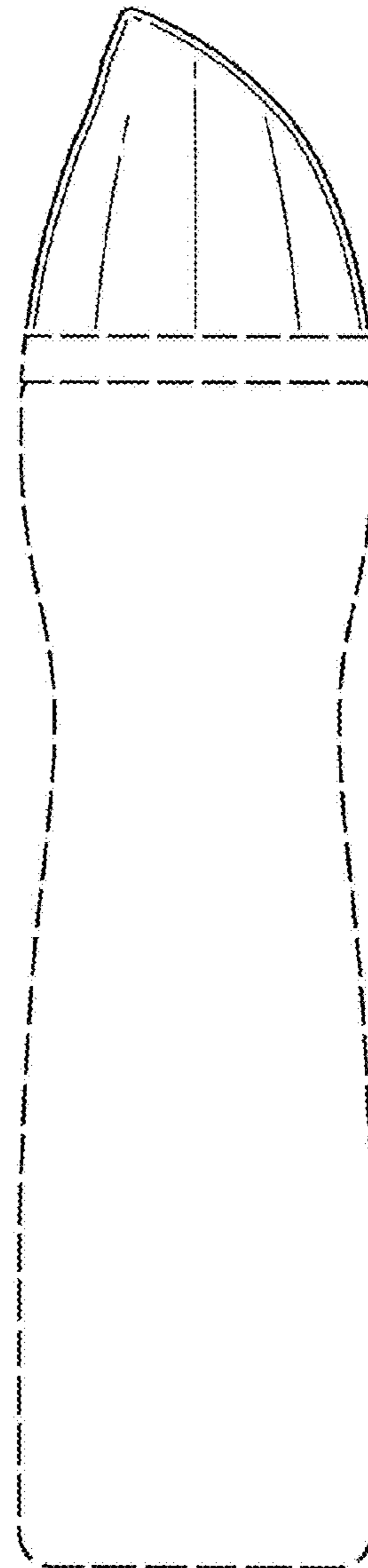

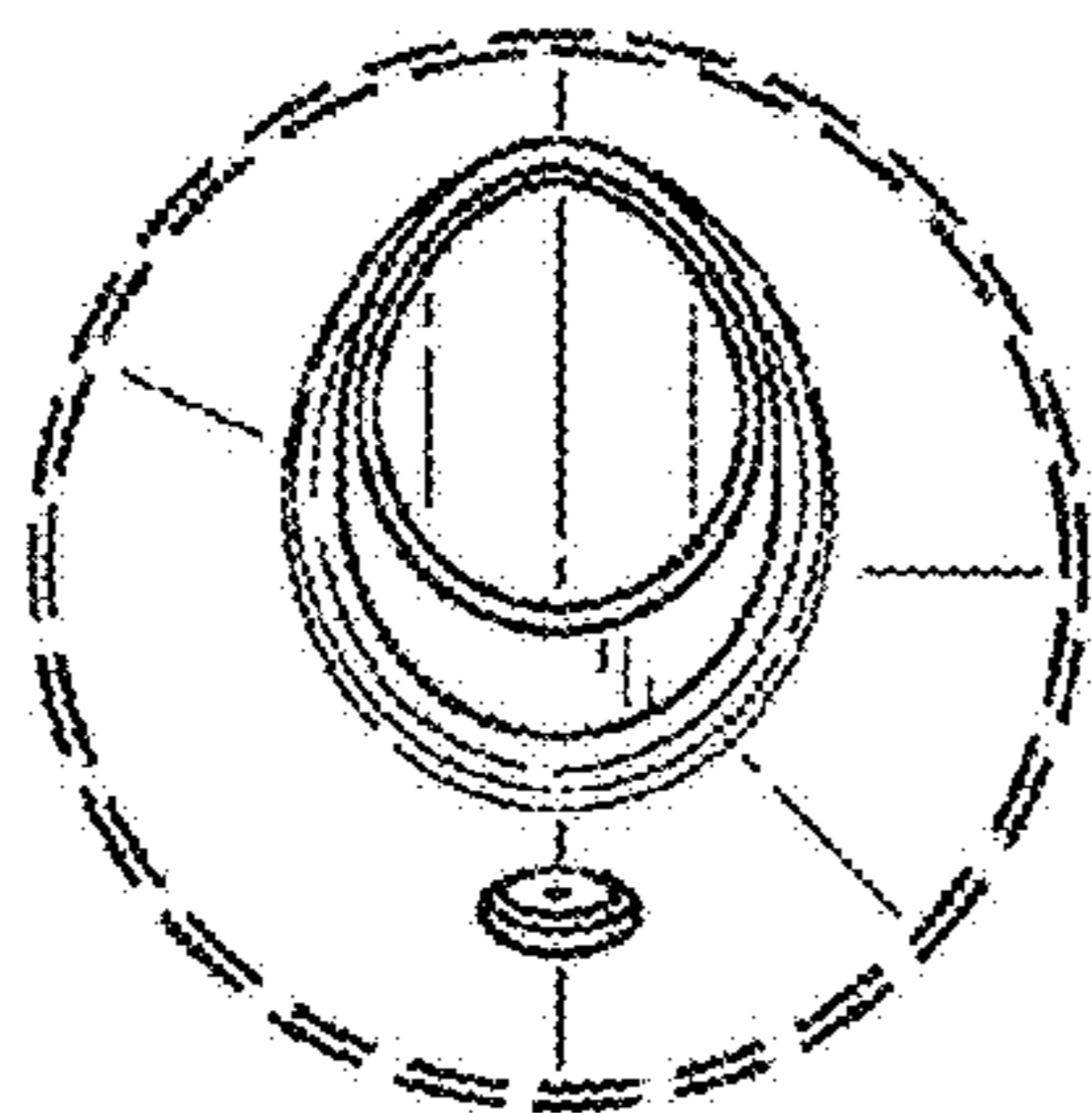

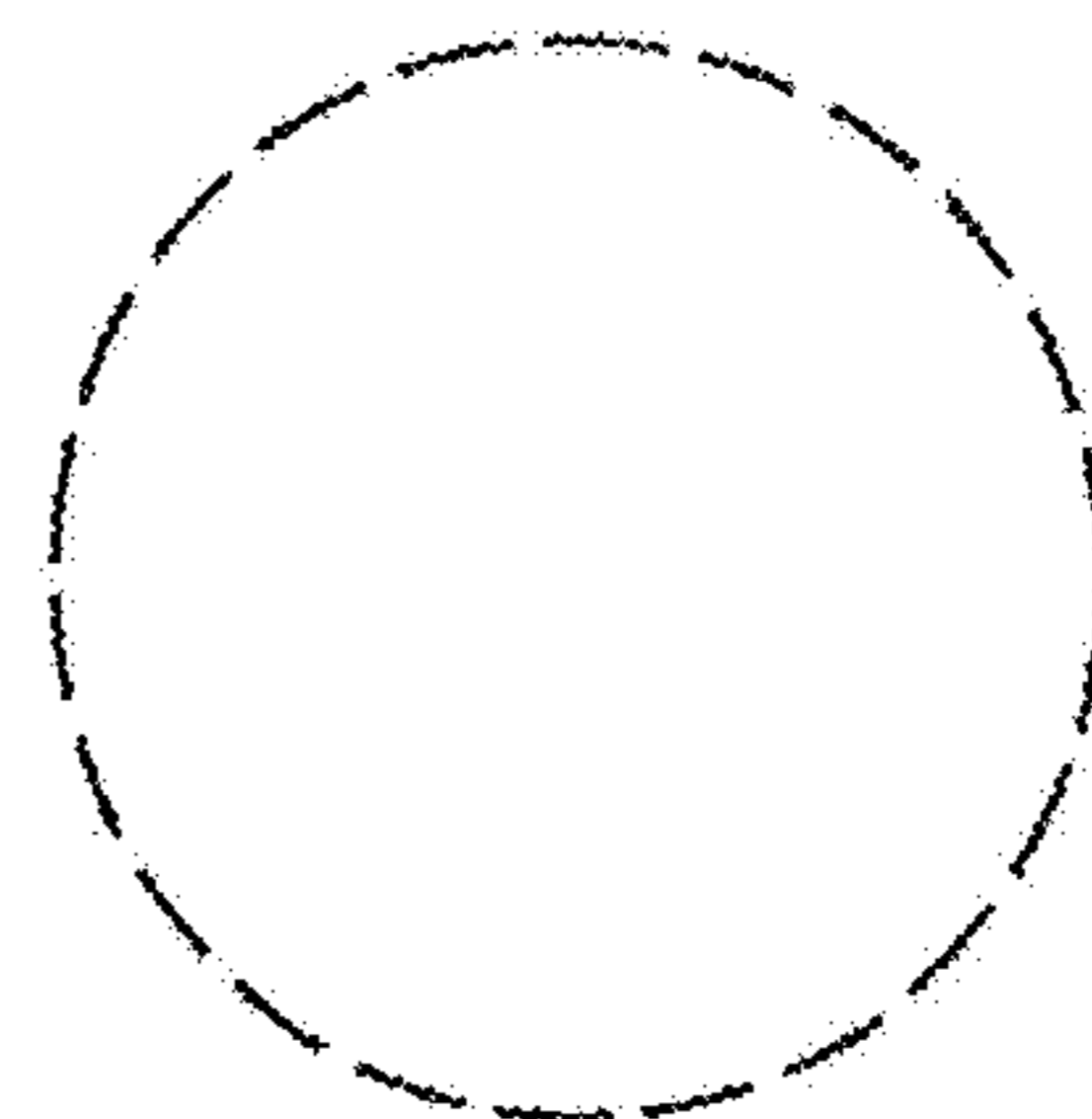
