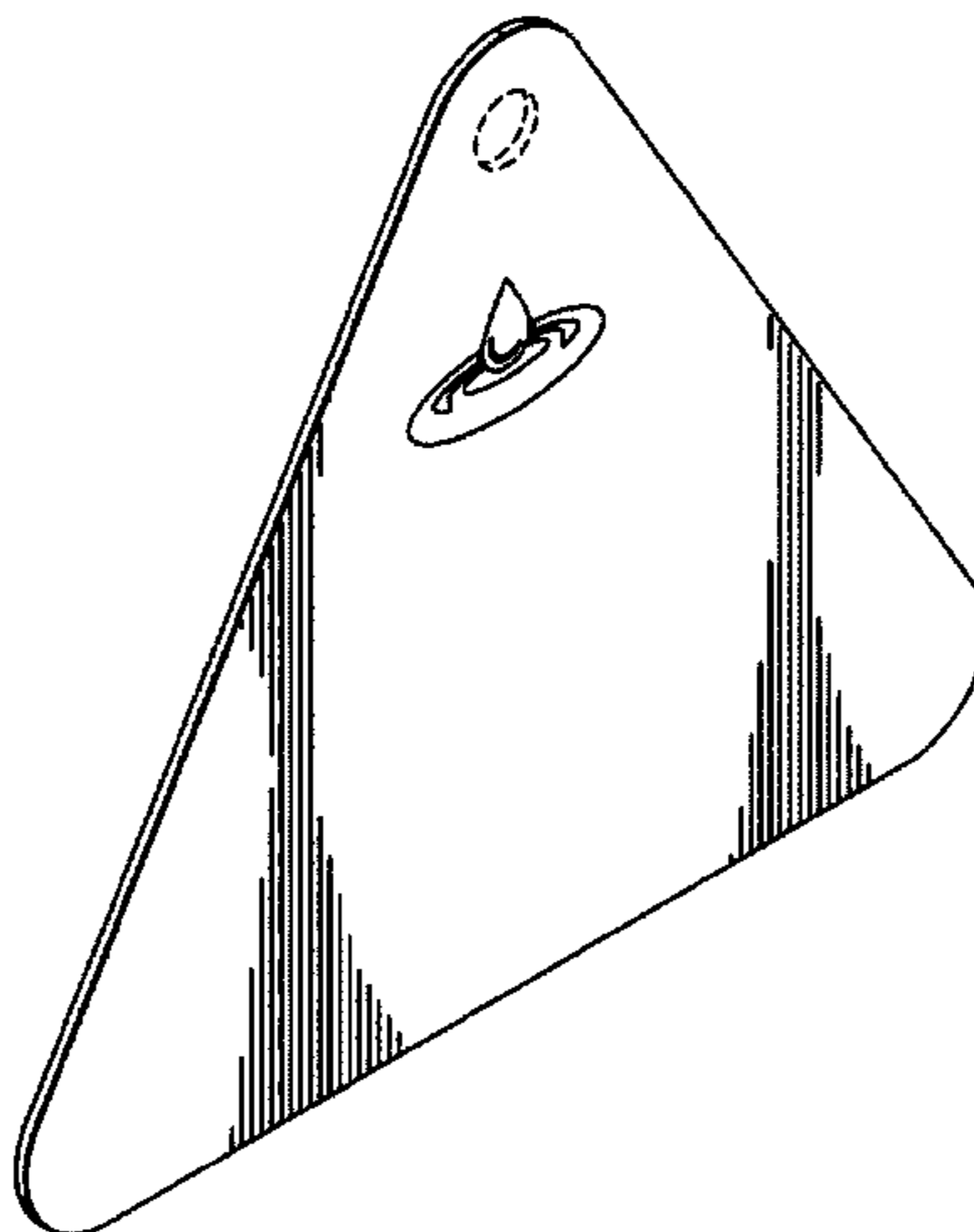
The ornamental design for a package card for a personal care product, as shown and described.

DESCRIPTION

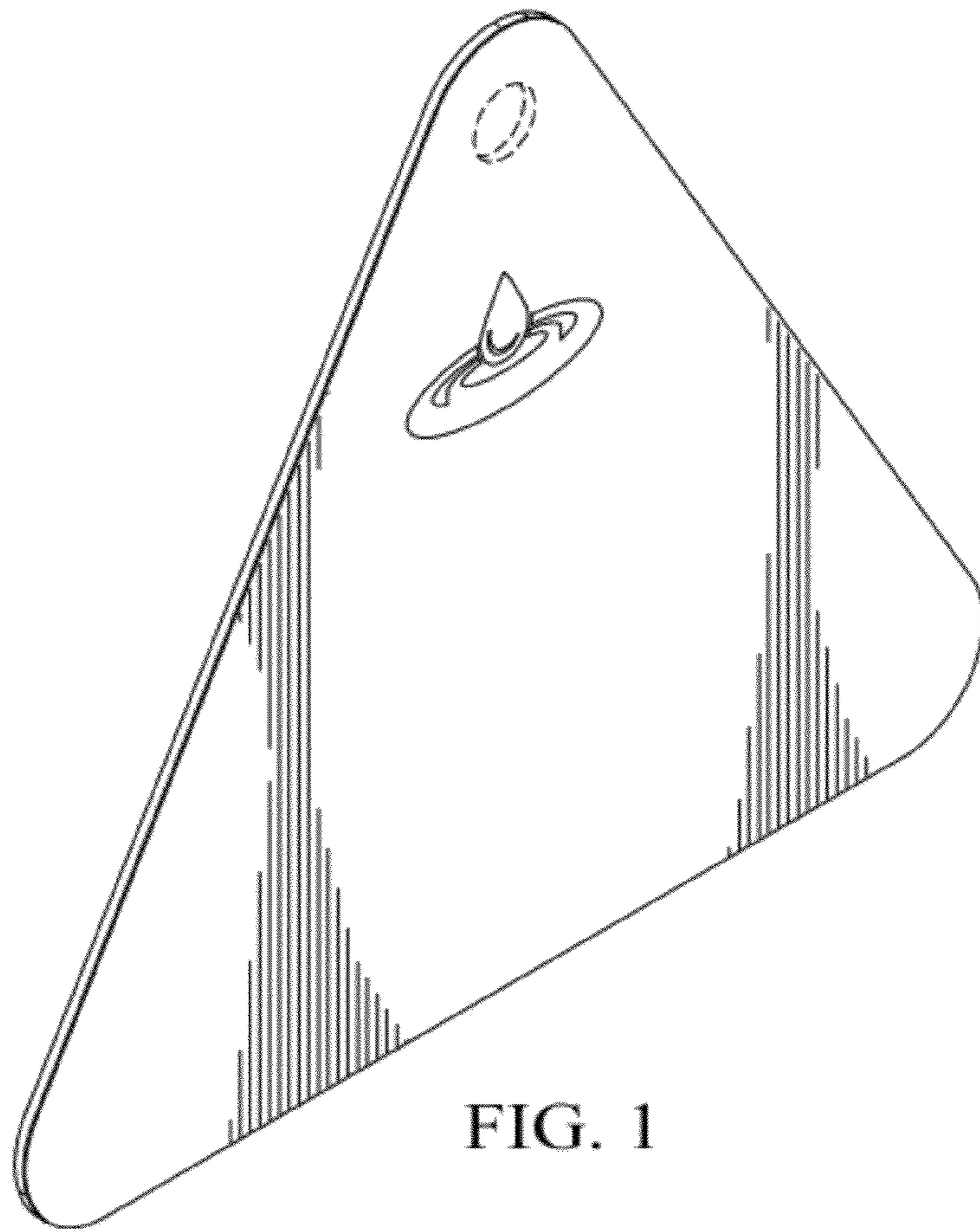

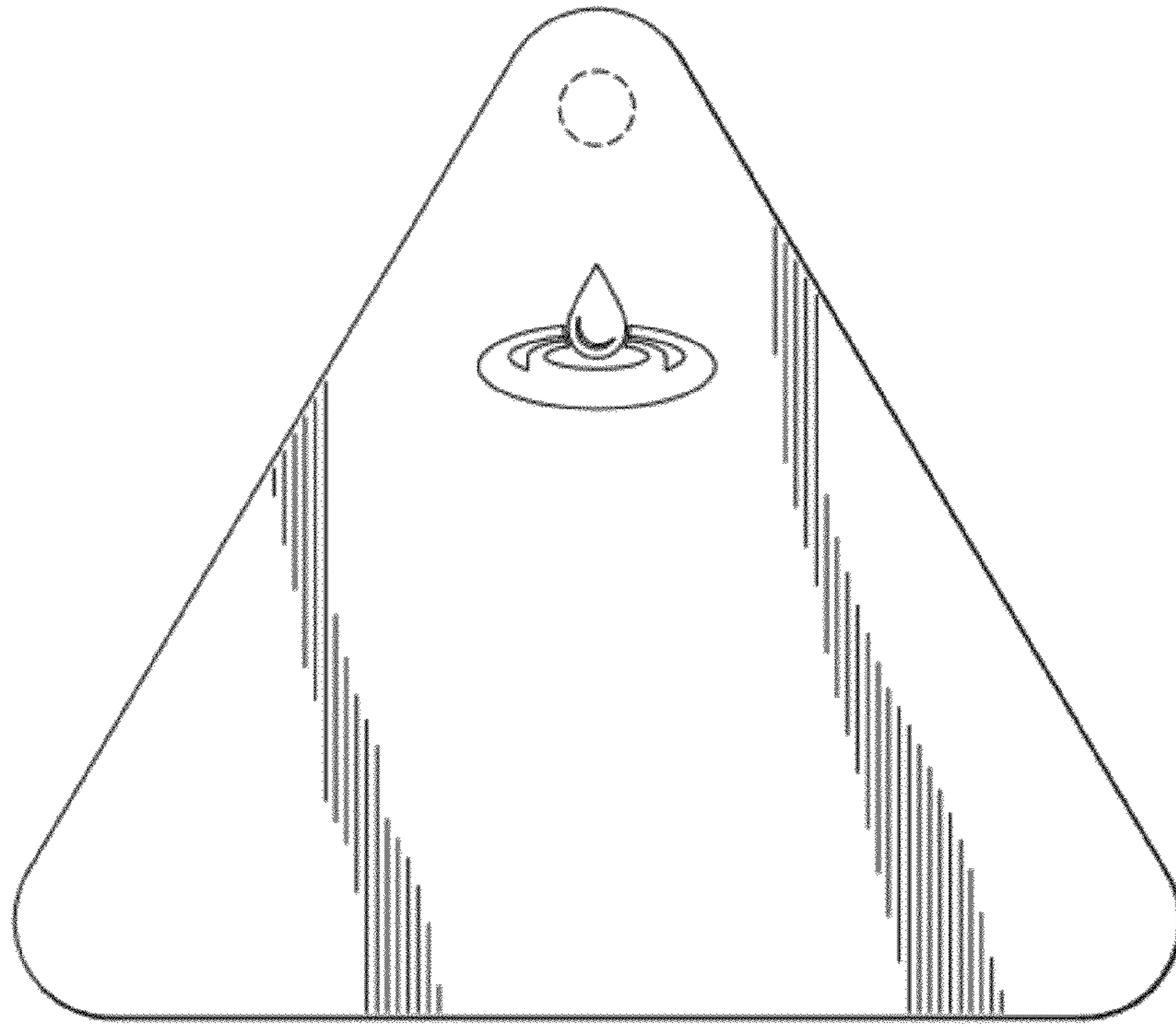

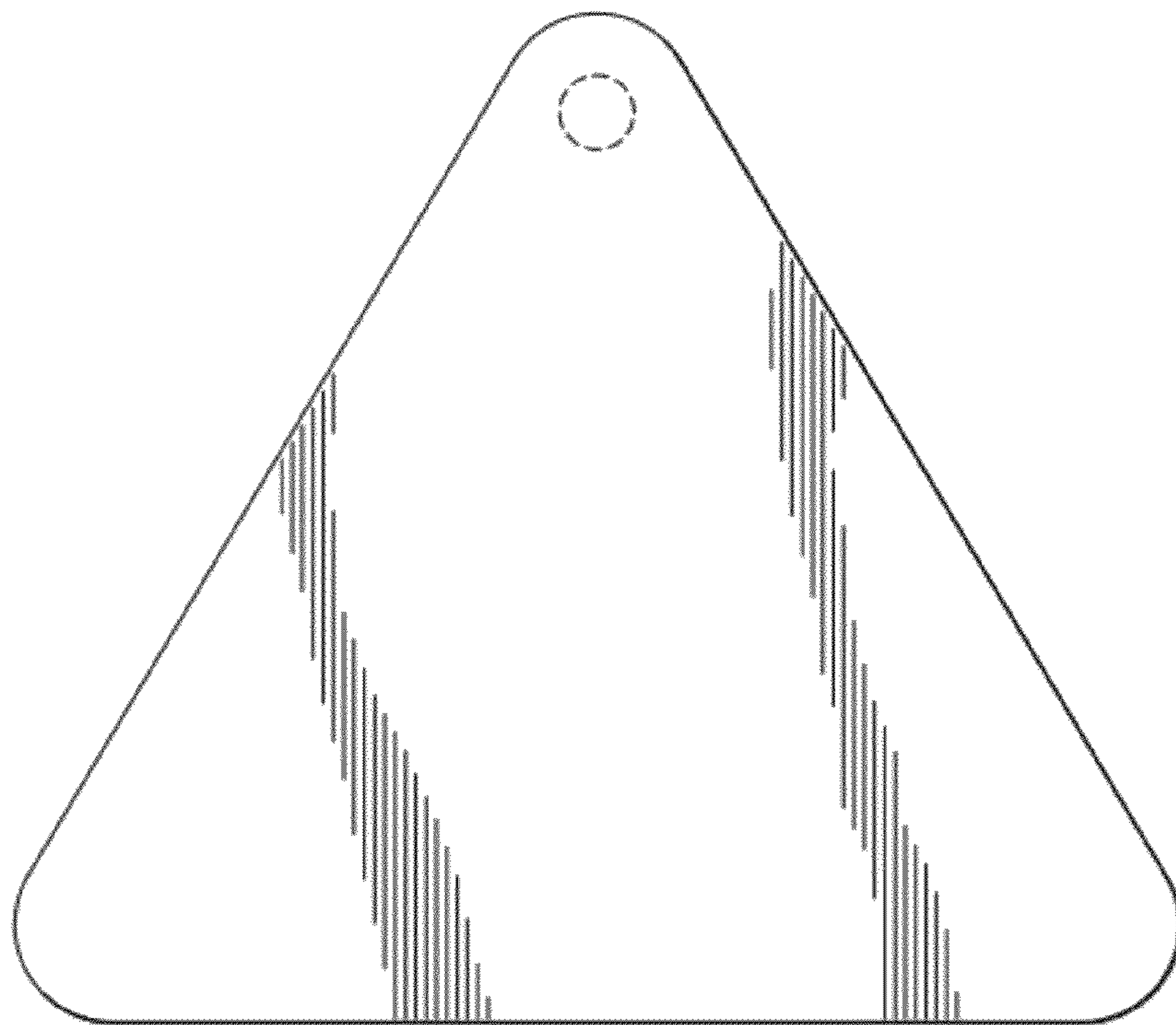
